[57] **CLAIM**

The ornamental design for a dispenser head for manual dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of the dispenser head for a manual dispenser showing my new design, the right side elevational view being a mirror image; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plane view thereof; and, FIG. 5 is a sectional view taken along the line 5—5 of FIG. 1.

The broken lines shown in FIGS. 1–5 area for illustrative purposes only and form no part of the claimed design.

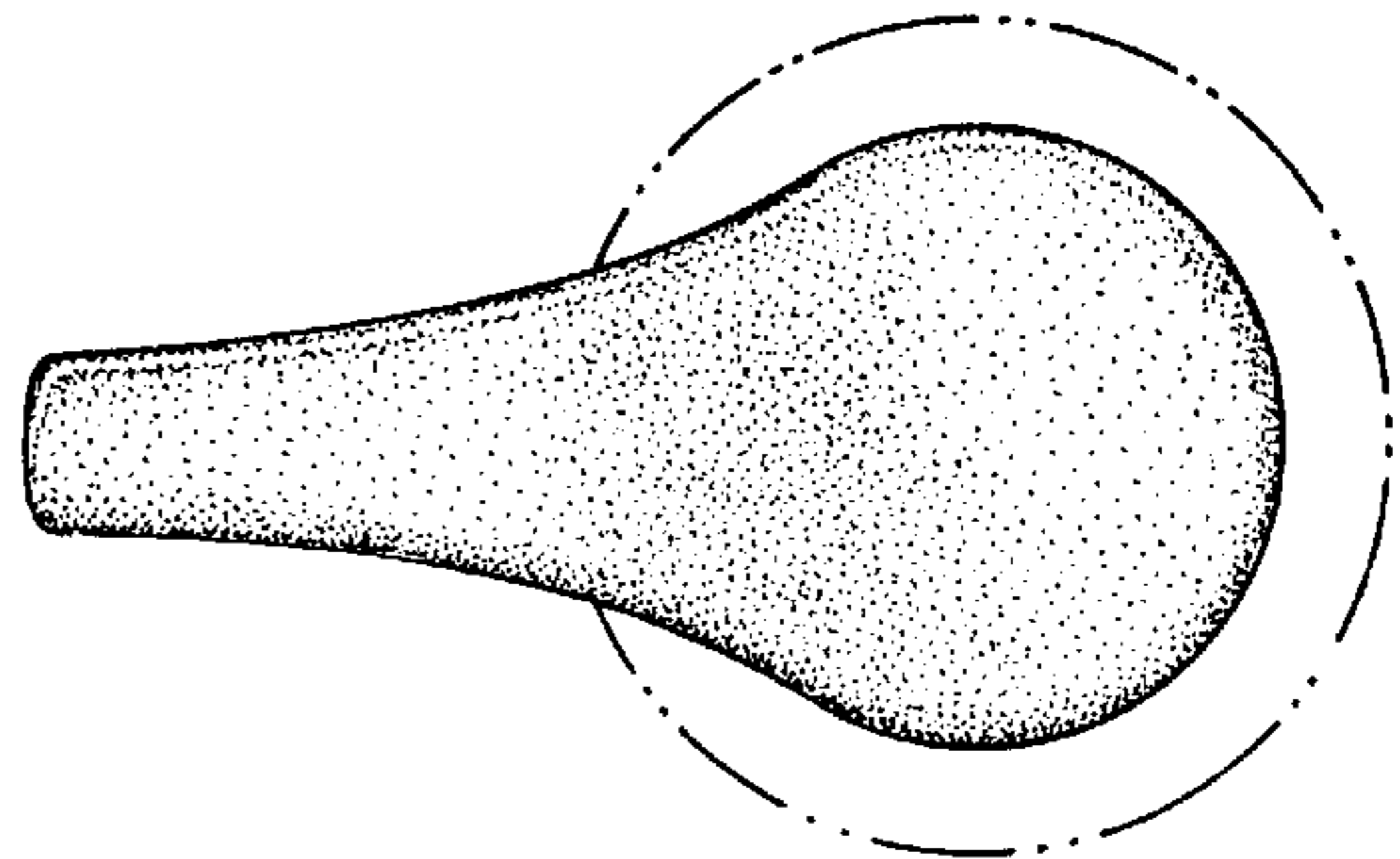
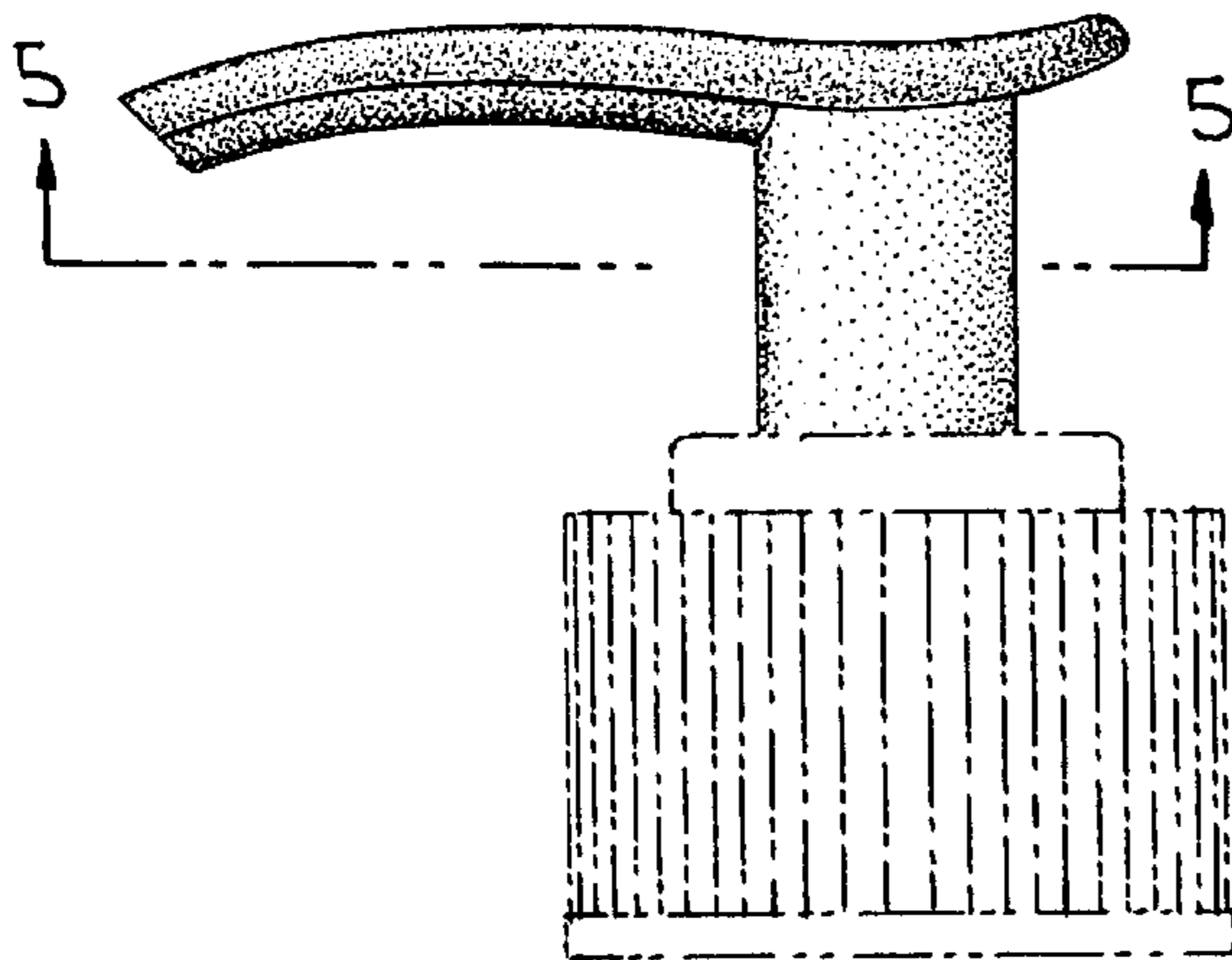

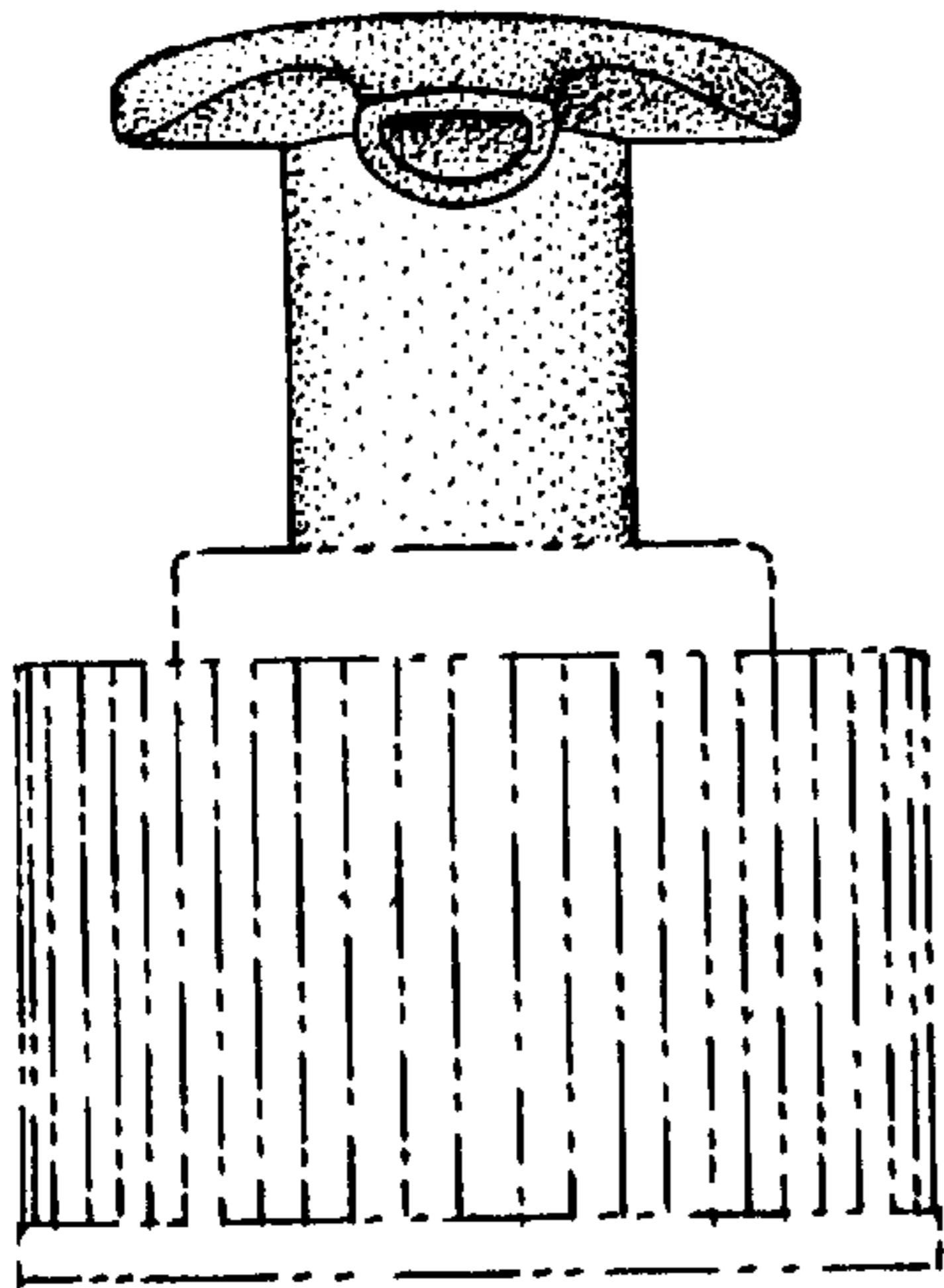

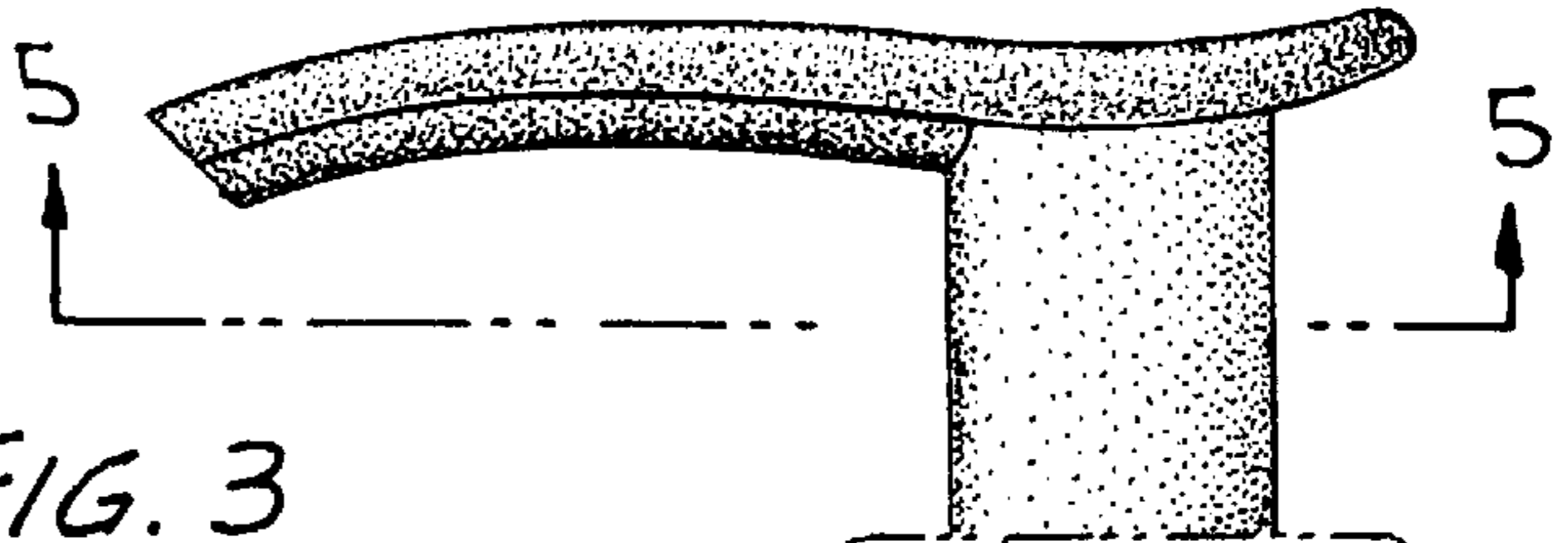

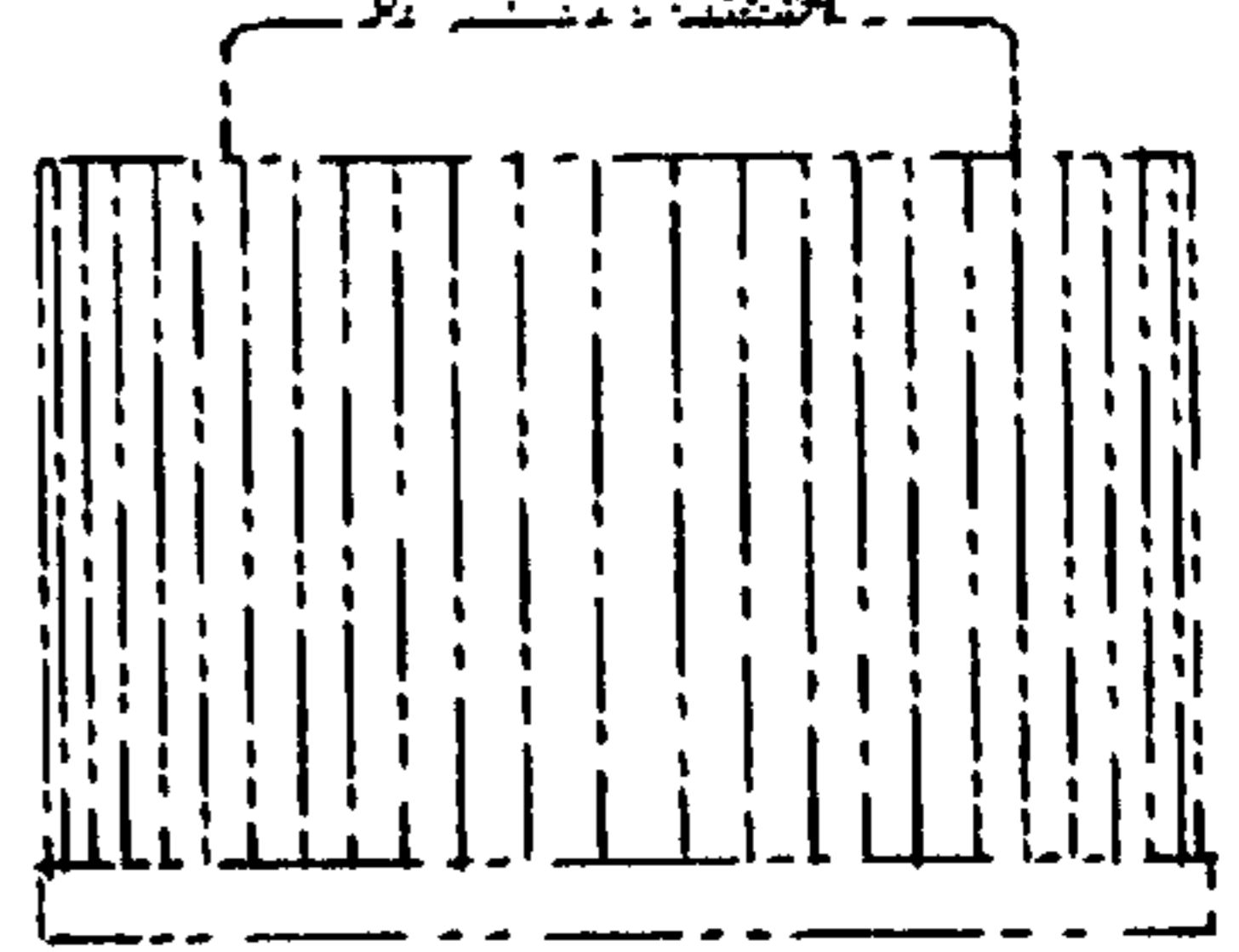
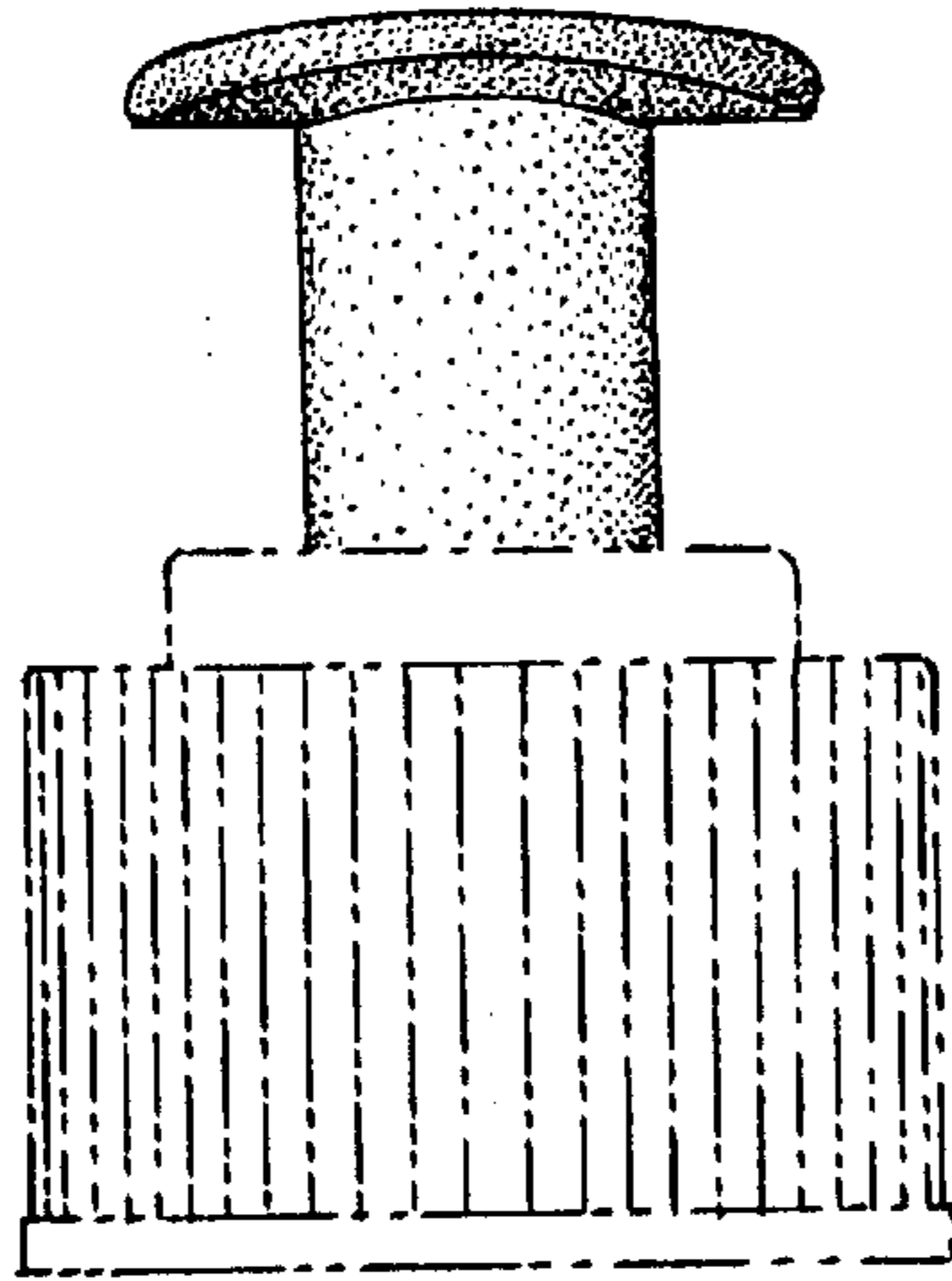

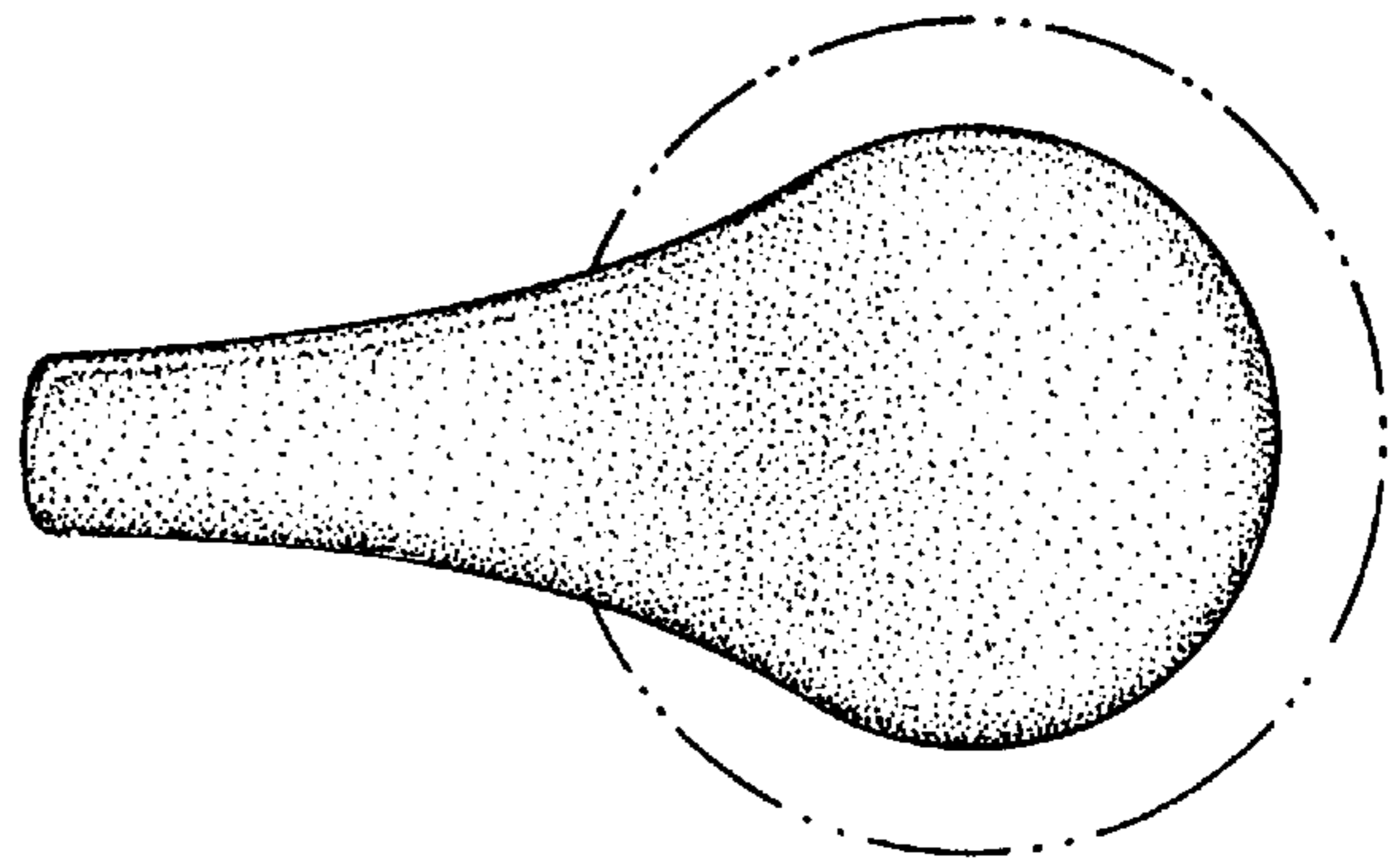
