[57] CLAIM

The ornamental design for a jewelry component, as shown and herein described.

DESCRIPTION

FIG. 1 is a perspective view of a jewelry component shown in a position of use, the broken line showing of the adjoining components is for illustrative purposes only and forms no part of the claimed design;

FIG. 28 is a top plan view;




FIG. 29 is a side elevational view, of which the opposite view is a mirror image;




















































