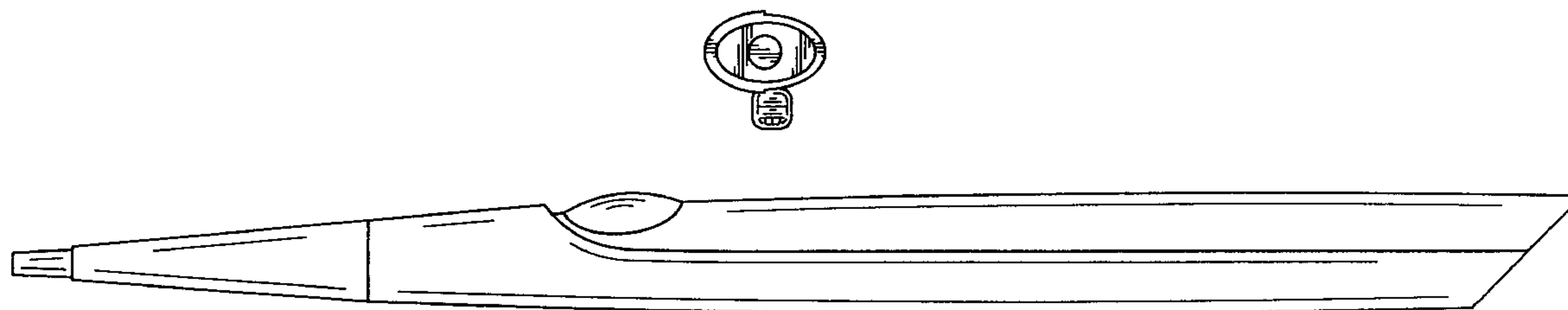
[57] CLAIM

The ornamental design for a spray pen for a surgical sealant, as shown and described.

DESCRIPTION

FIG. 1 is an end elevational view of a spray pen for a surgical sealant showing our new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is an end elevational thereof, opposite that shown in FIG. 1;
FIG. 4 is a top plan view thereof;
FIG. 5 is a side perspective view thereof;
FIG. 6 is a side elevational view thereof, opposite that shown in FIG. 2;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is an end elevational view of a second embodiment of a spray pen for a surgical sealant showing our new design;
FIG. 9 is a side elevational view thereof;
FIG. 10 is an end elevational thereof, opposite that shown in FIG. 1;
FIG. 11 is a top view thereof;
FIG. 12 is a side perspective view thereof;
FIG. 13 is a side elevational view thereof, opposite that shown in FIG. 2; and,
FIG. 14 is a bottom view thereof.

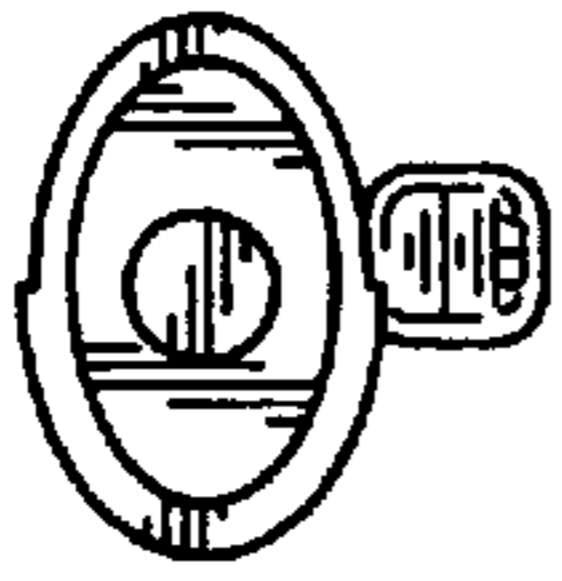

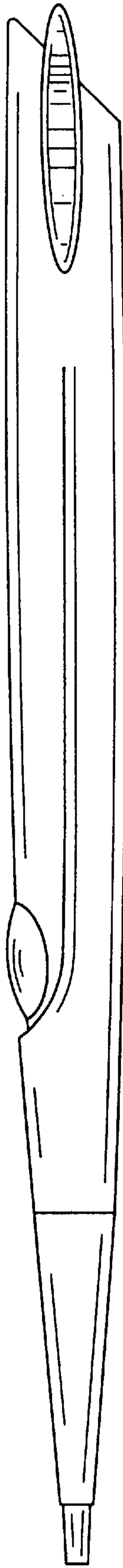

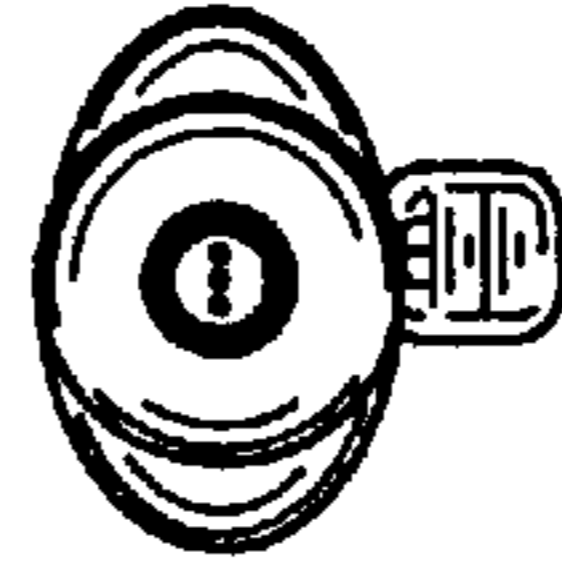

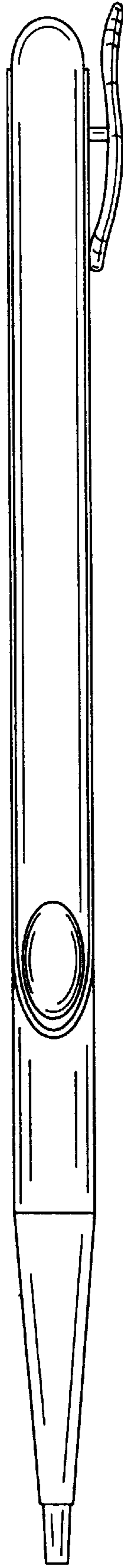

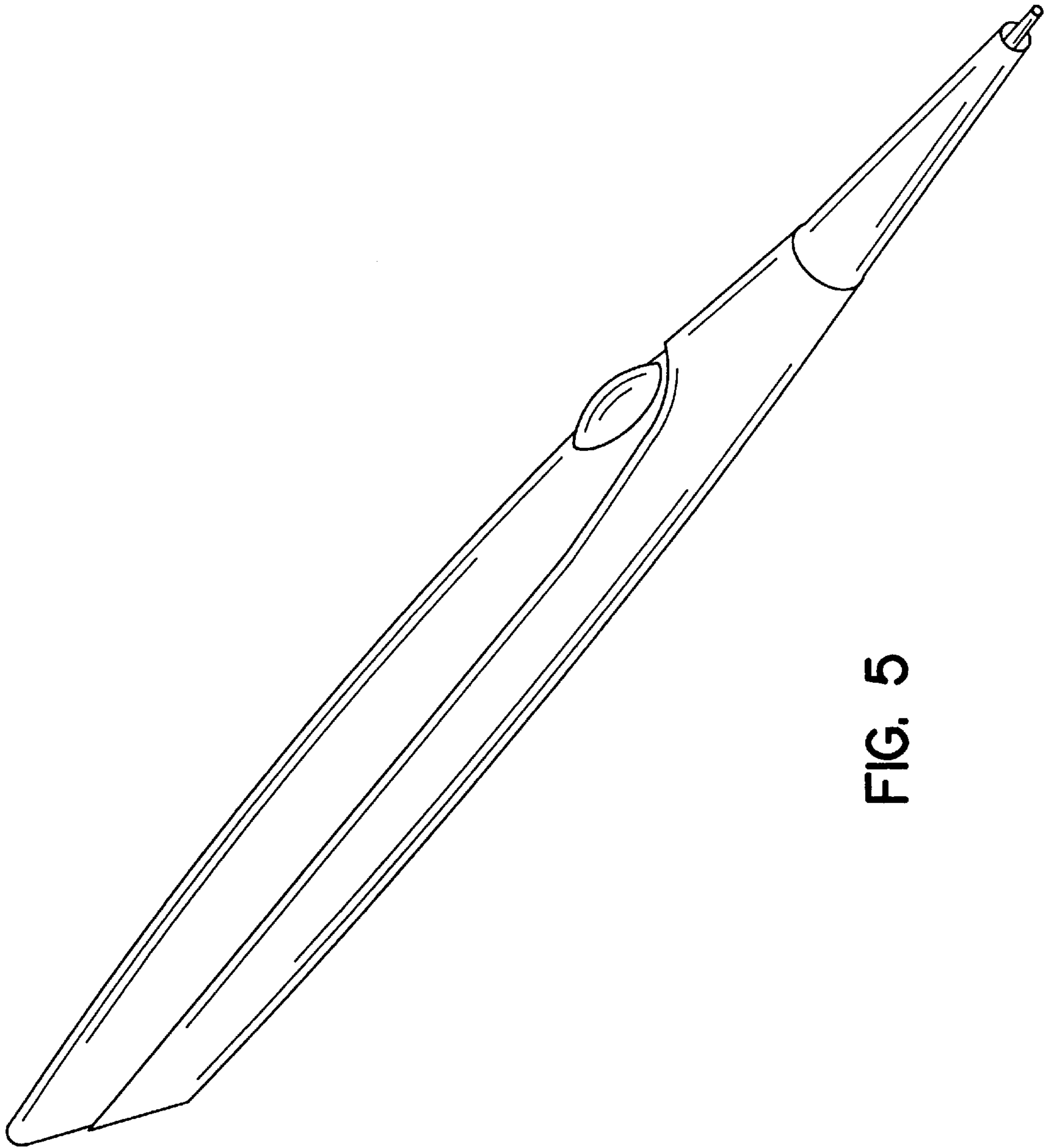

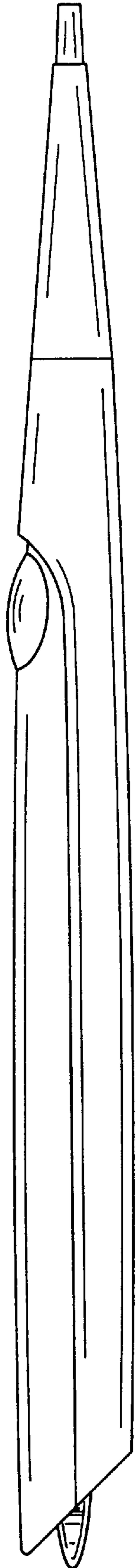

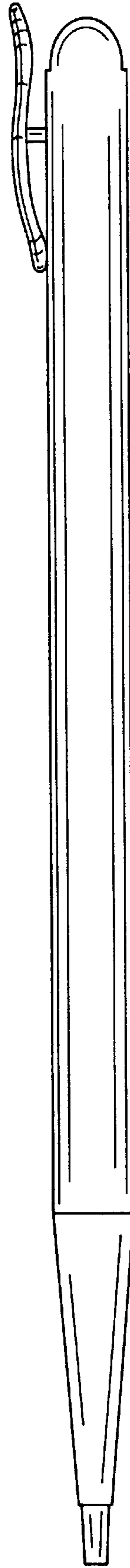

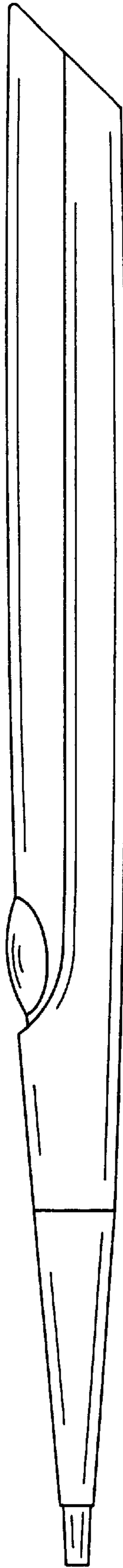

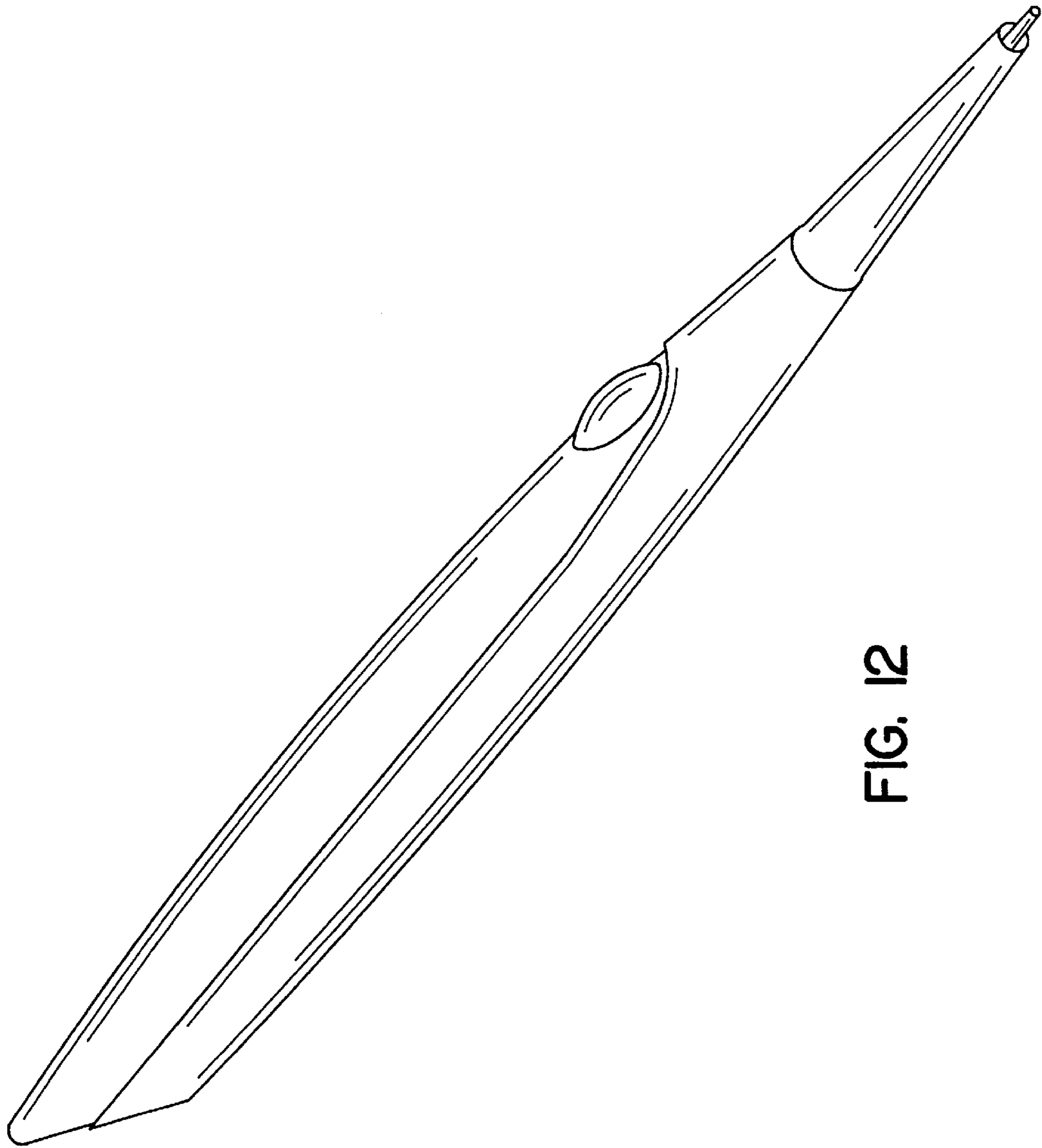

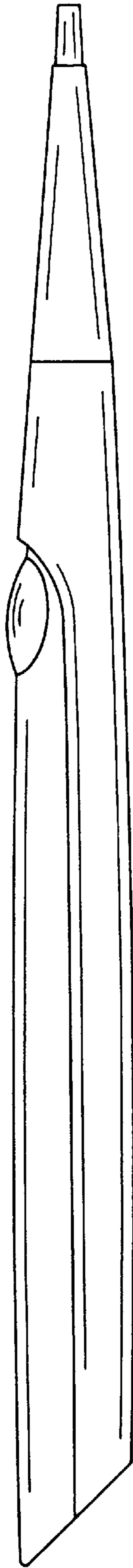
