[57] CLAIM

I claim the ornamental design for an iron with removable water tank, as shown and described.

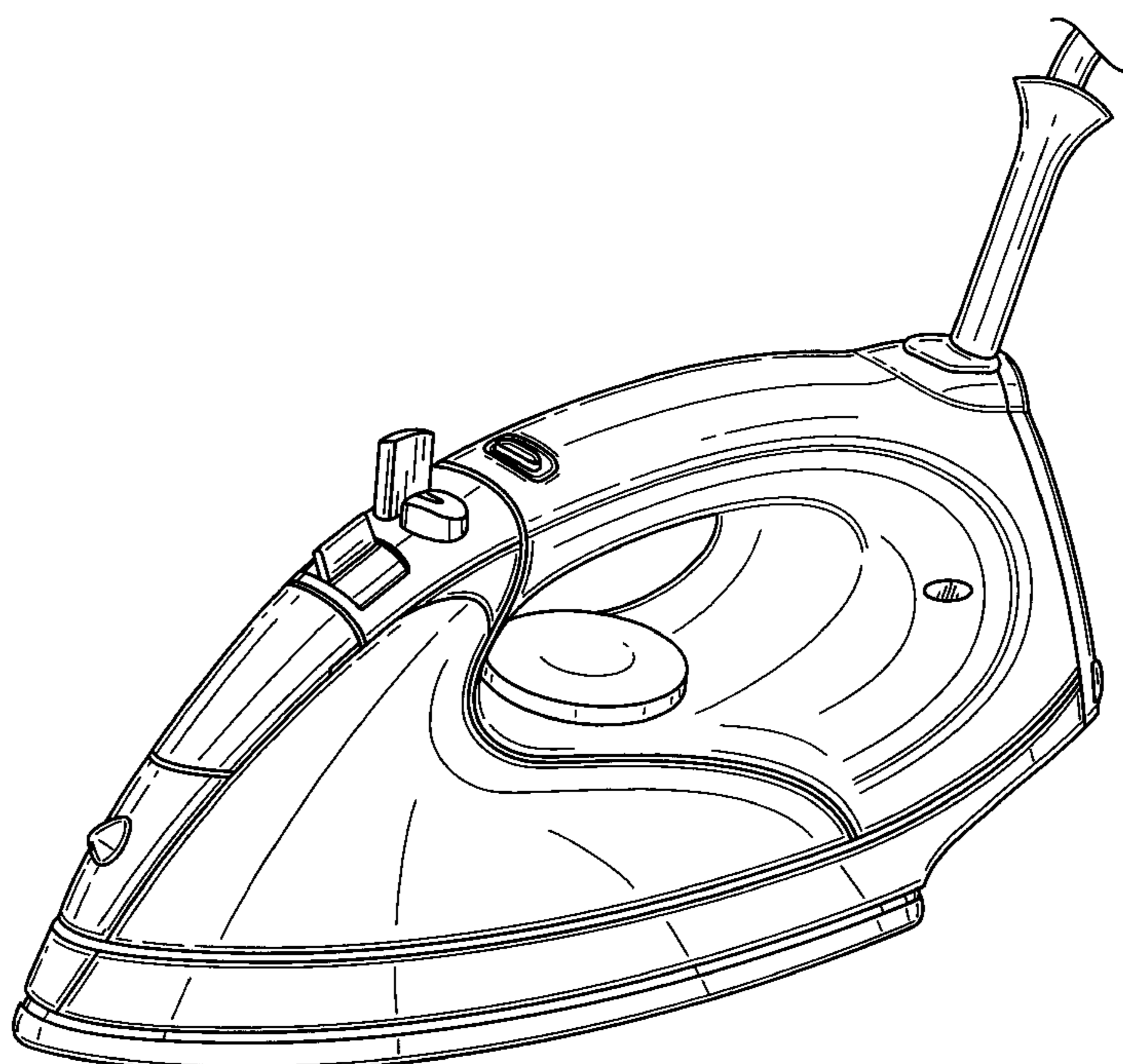
DESCRIPTION

FIG. 1 is a perspective view from the front and left of my new design;
 FIG. 2 is a front elevation view thereof;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a side elevation view from the left of FIG. 2;
 FIG. 5 is a side elevation view from the right of FIG. 2;
 FIG. 6 is a top view thereof;
 FIG. 7 is a bottom view thereof;
 FIG. 8 is a front elevation view thereof, showing two portions of the iron of the design in another position, a forward tank portion being removed from the remainder of the iron;
 FIG. 9 is a top view of the removed tank portion;
 FIG. 10 is a bottom view of the removed tank portion;
 FIG. 11 is a rear elevation view of the removed tank portion;
 FIG. 12 is a front elevation view of the iron, with the tank portion removed; and,
 FIG. 13 is a top view of the iron, with the tank portion removed.

Each of the two laterally opposed buttons shown at the top of the iron can assume, independently, either of upper and lower positions shown in FIGS. 1 and 4.

The body of the iron has been omitted from FIGS. 9 through 11 for convenience of illustration. The water tank is not shown in FIGS. 12 and 13 for convenience of illustration.

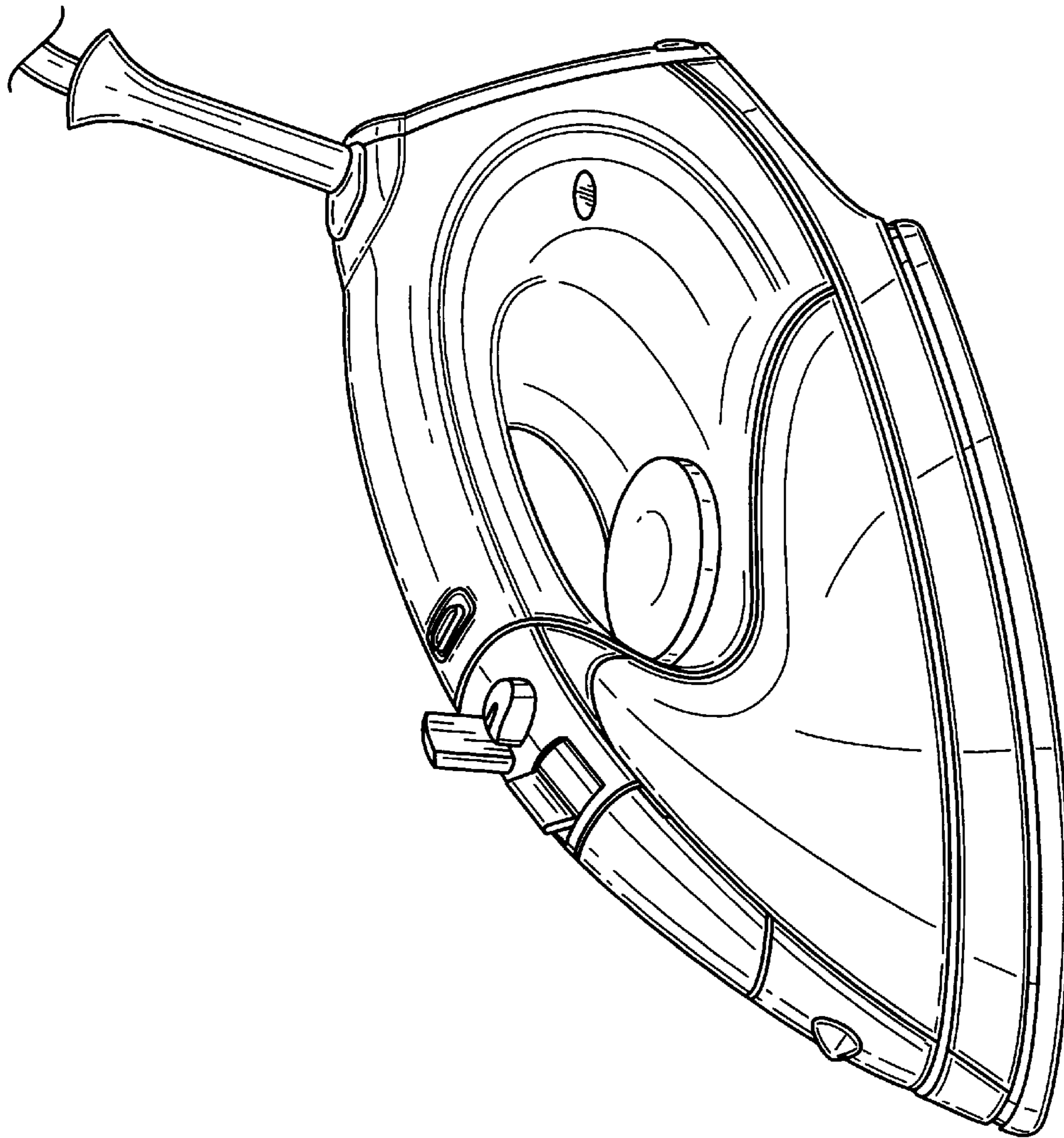

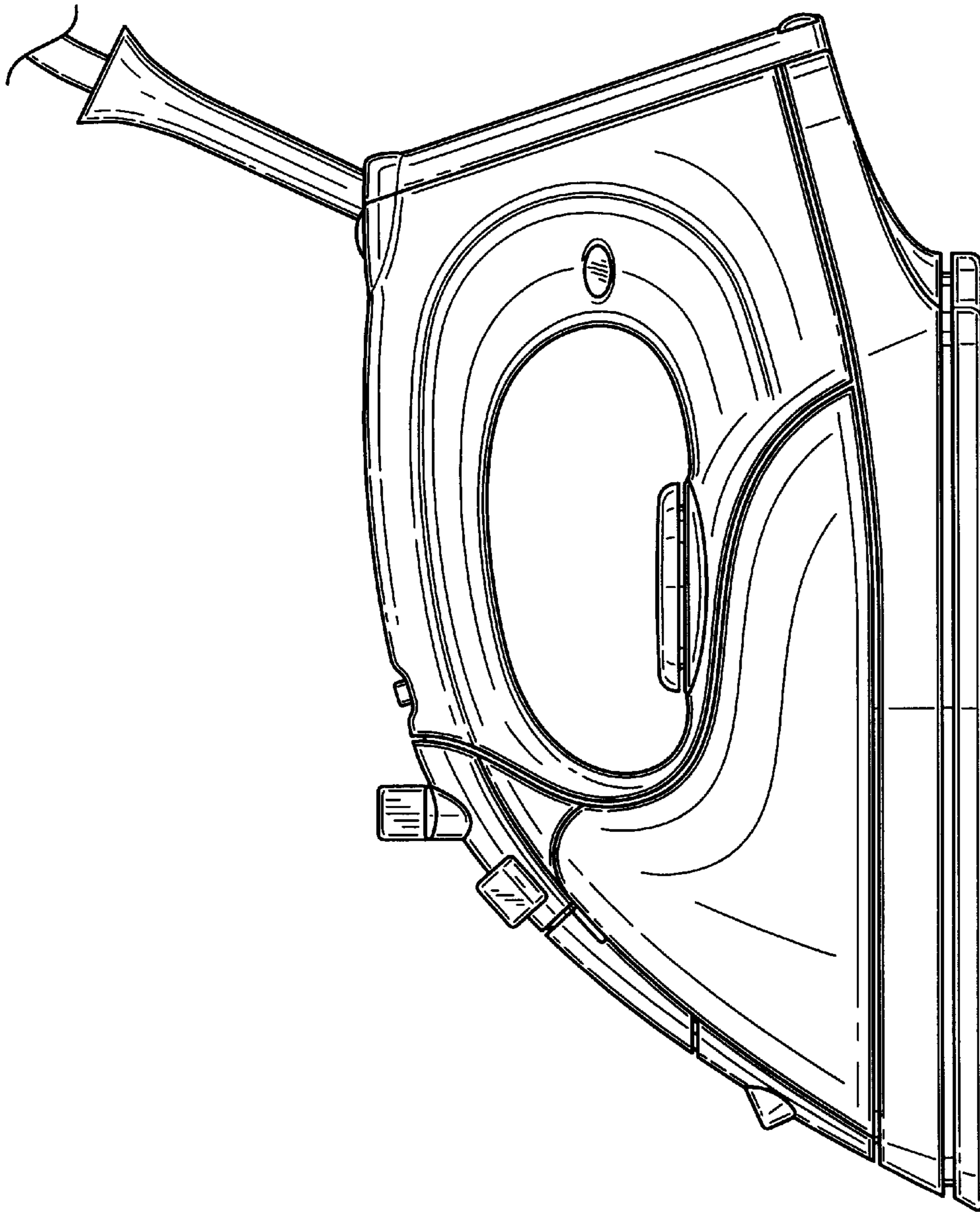

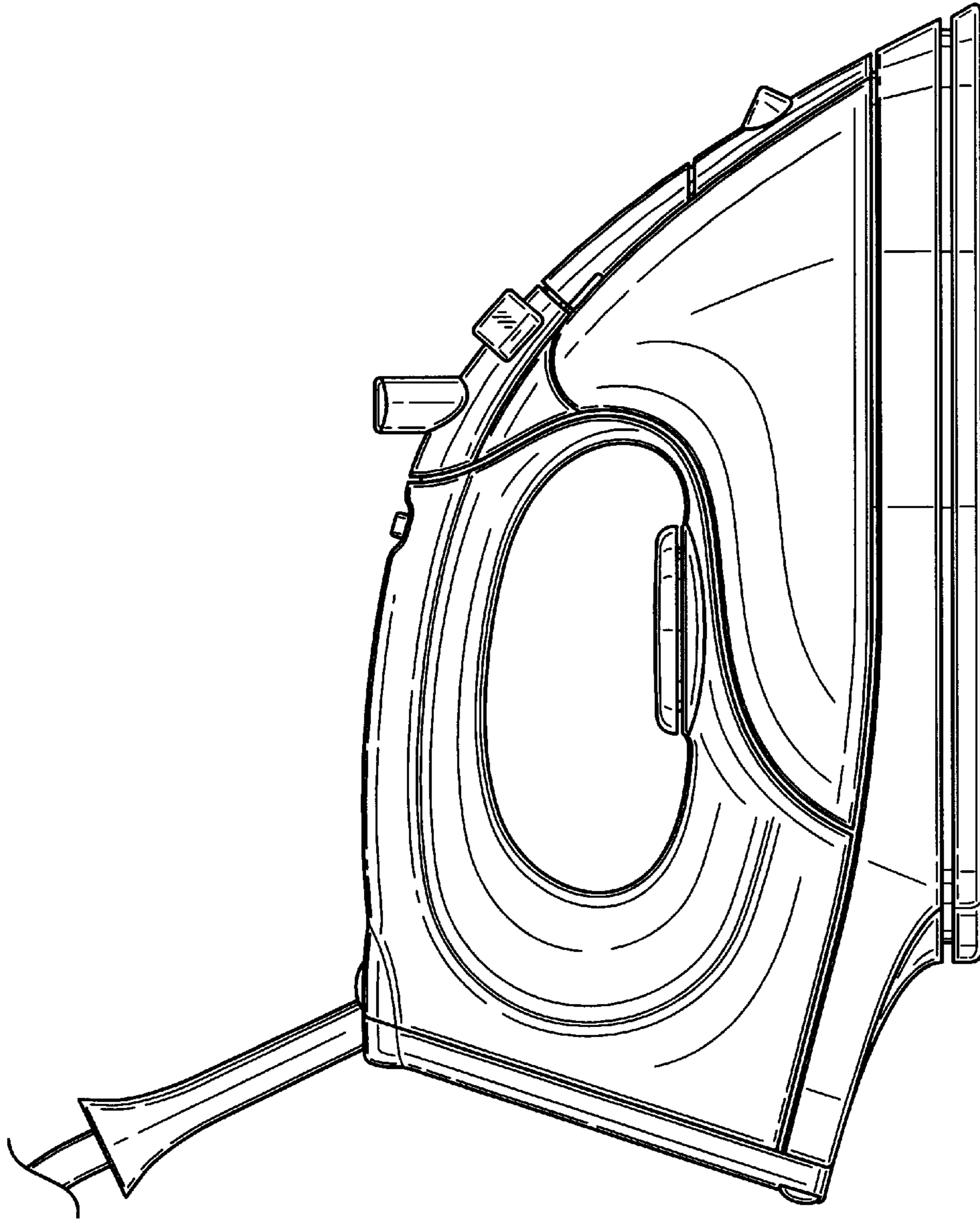

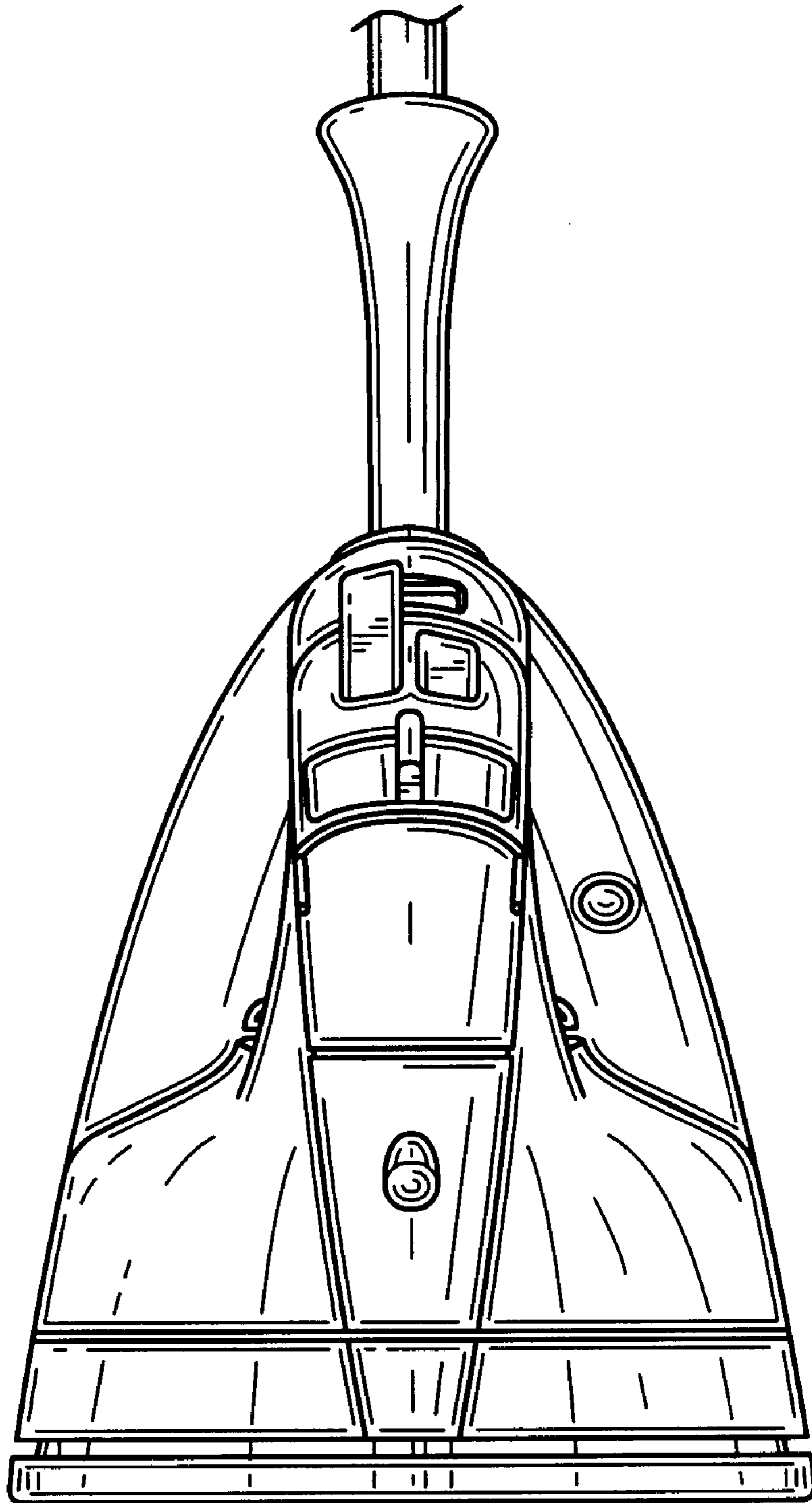

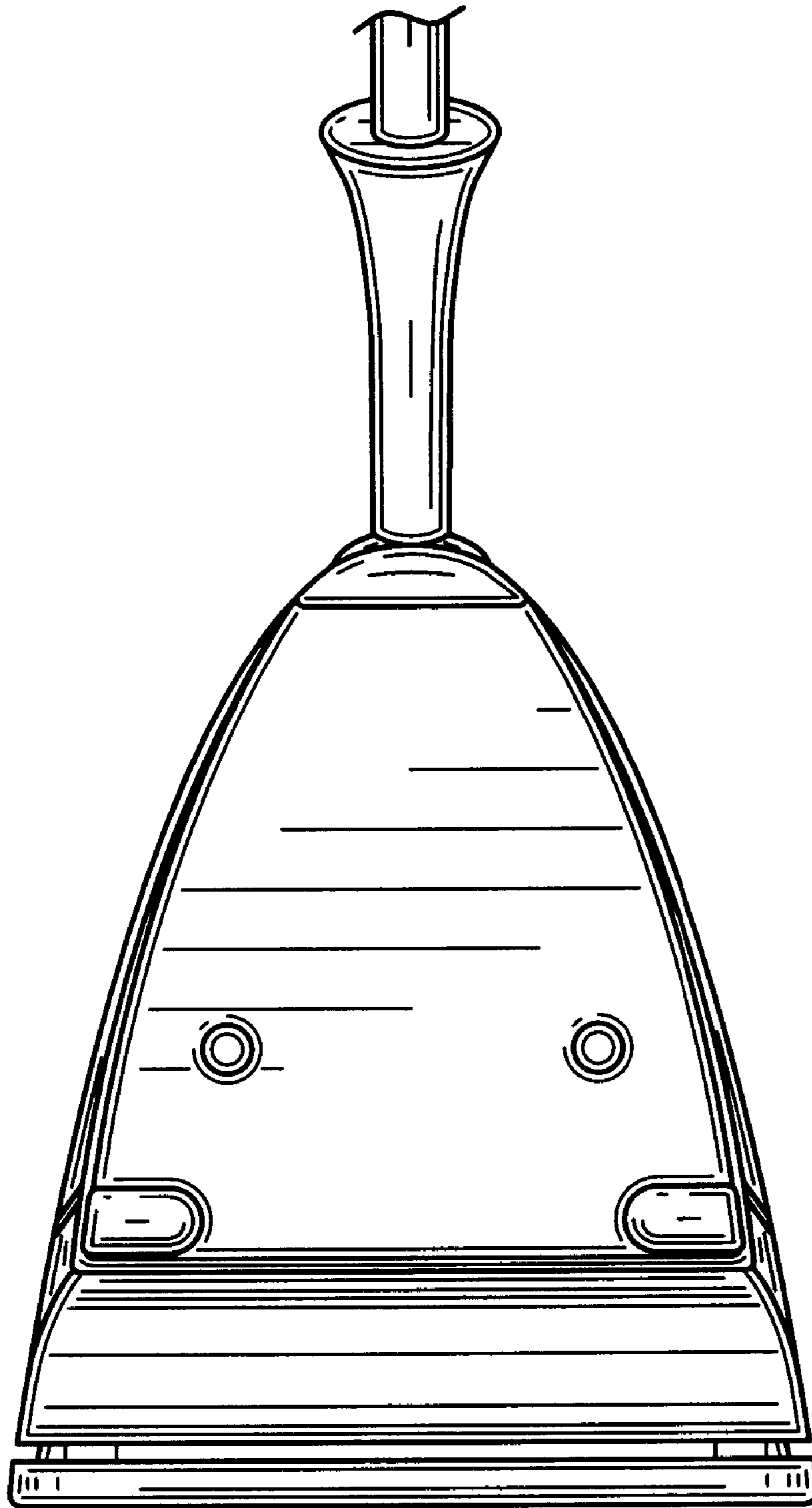

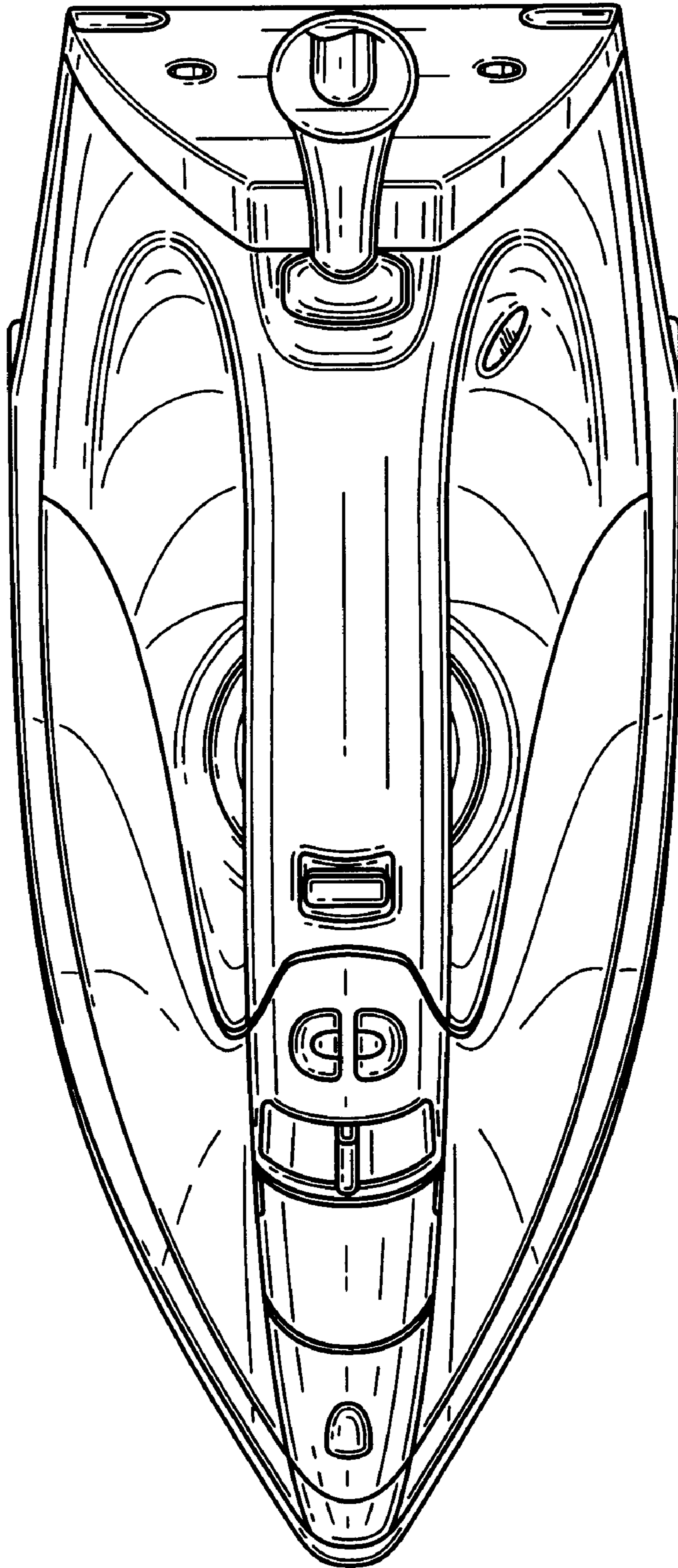

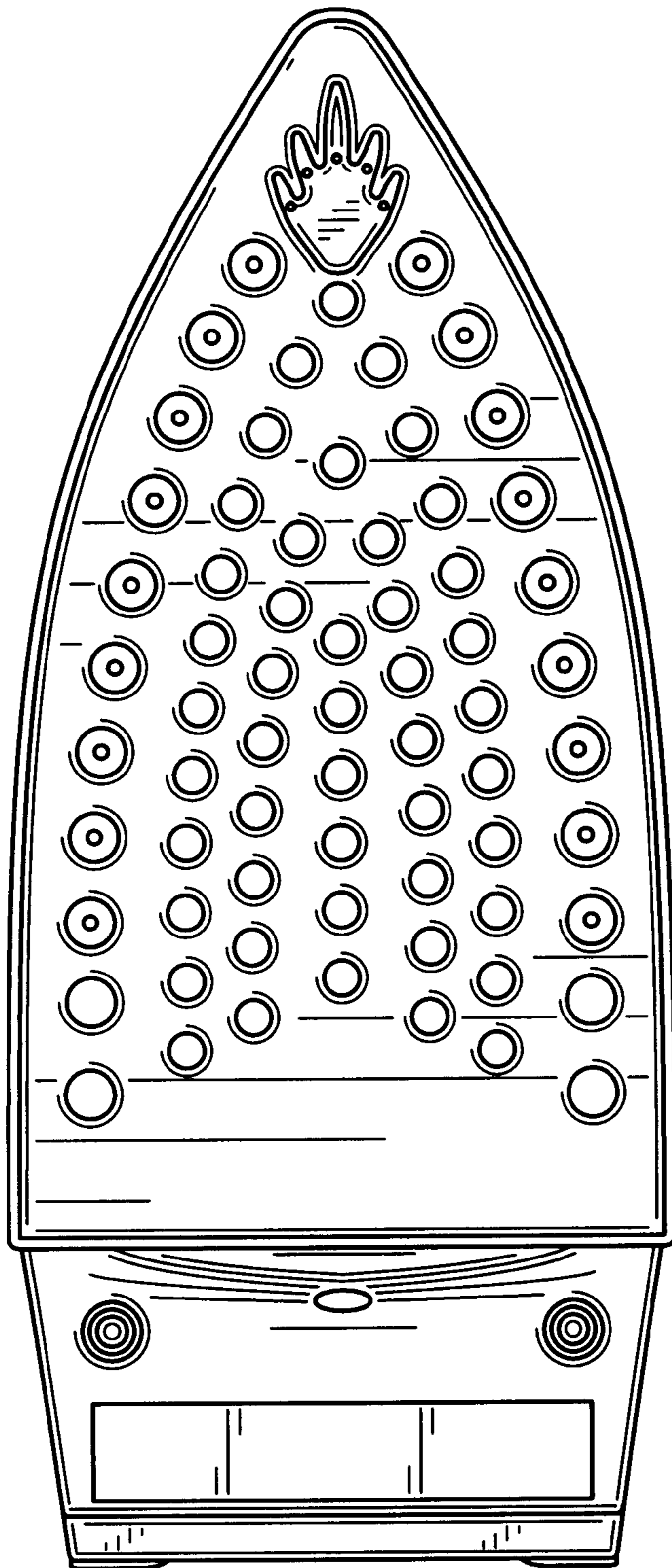

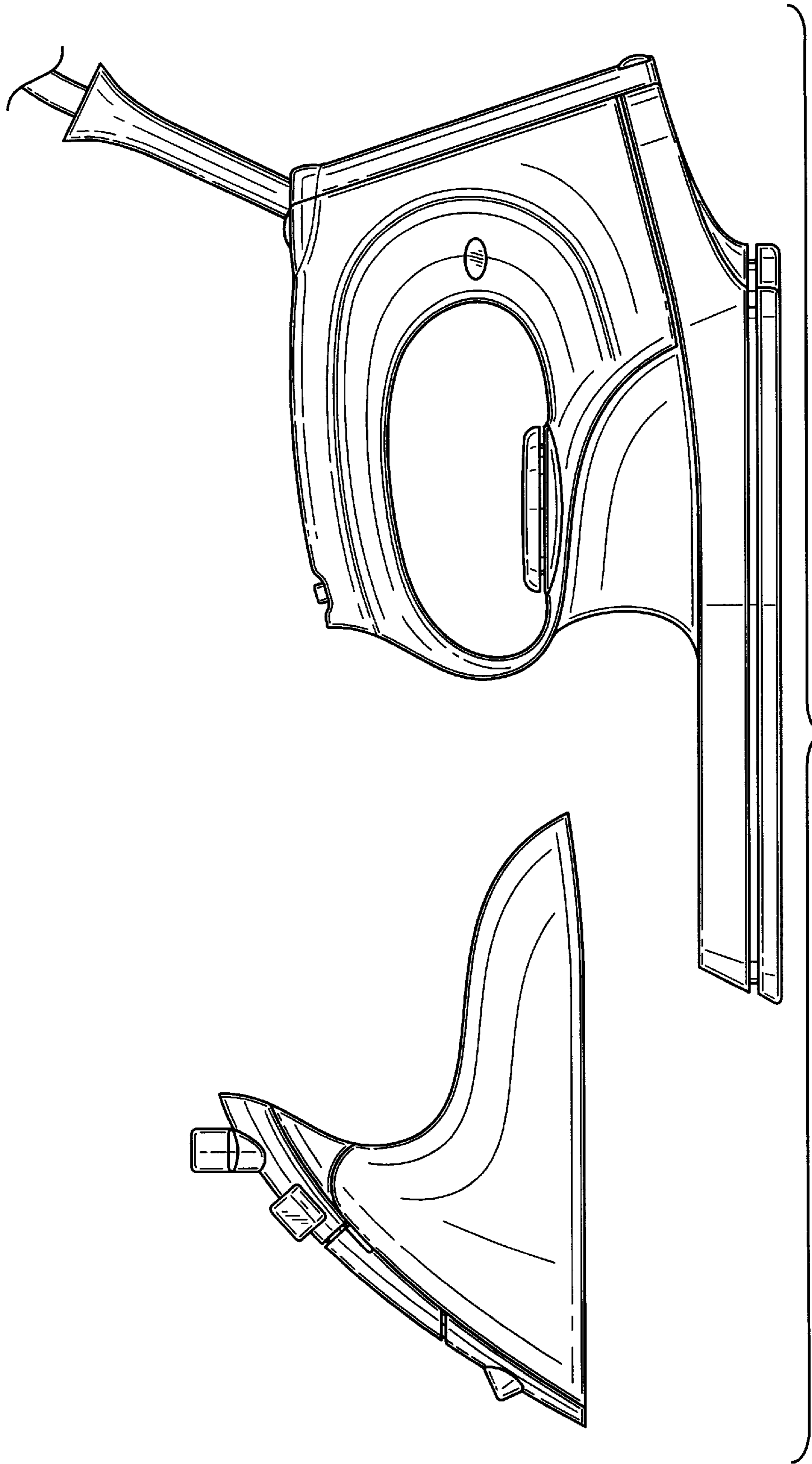

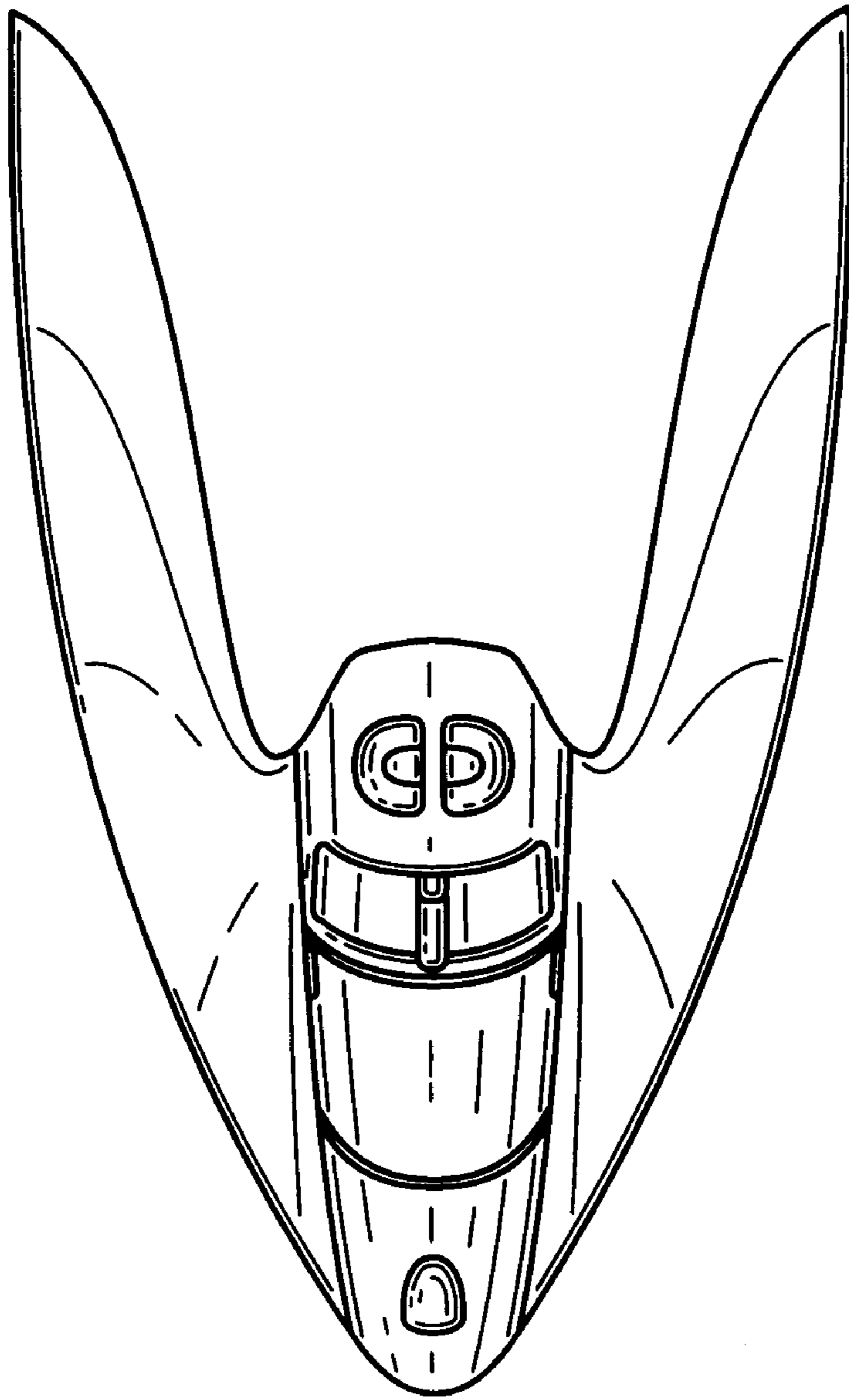

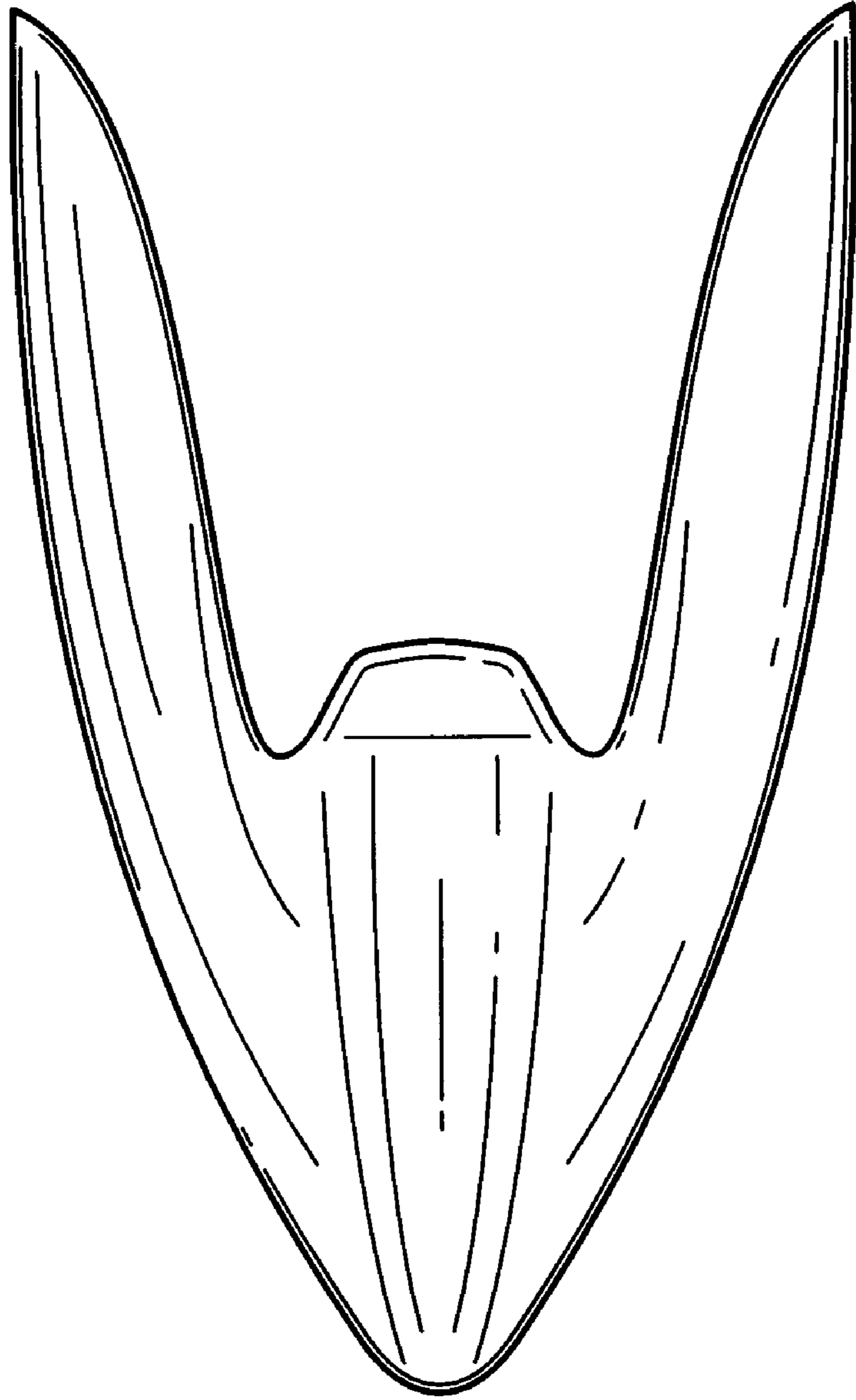

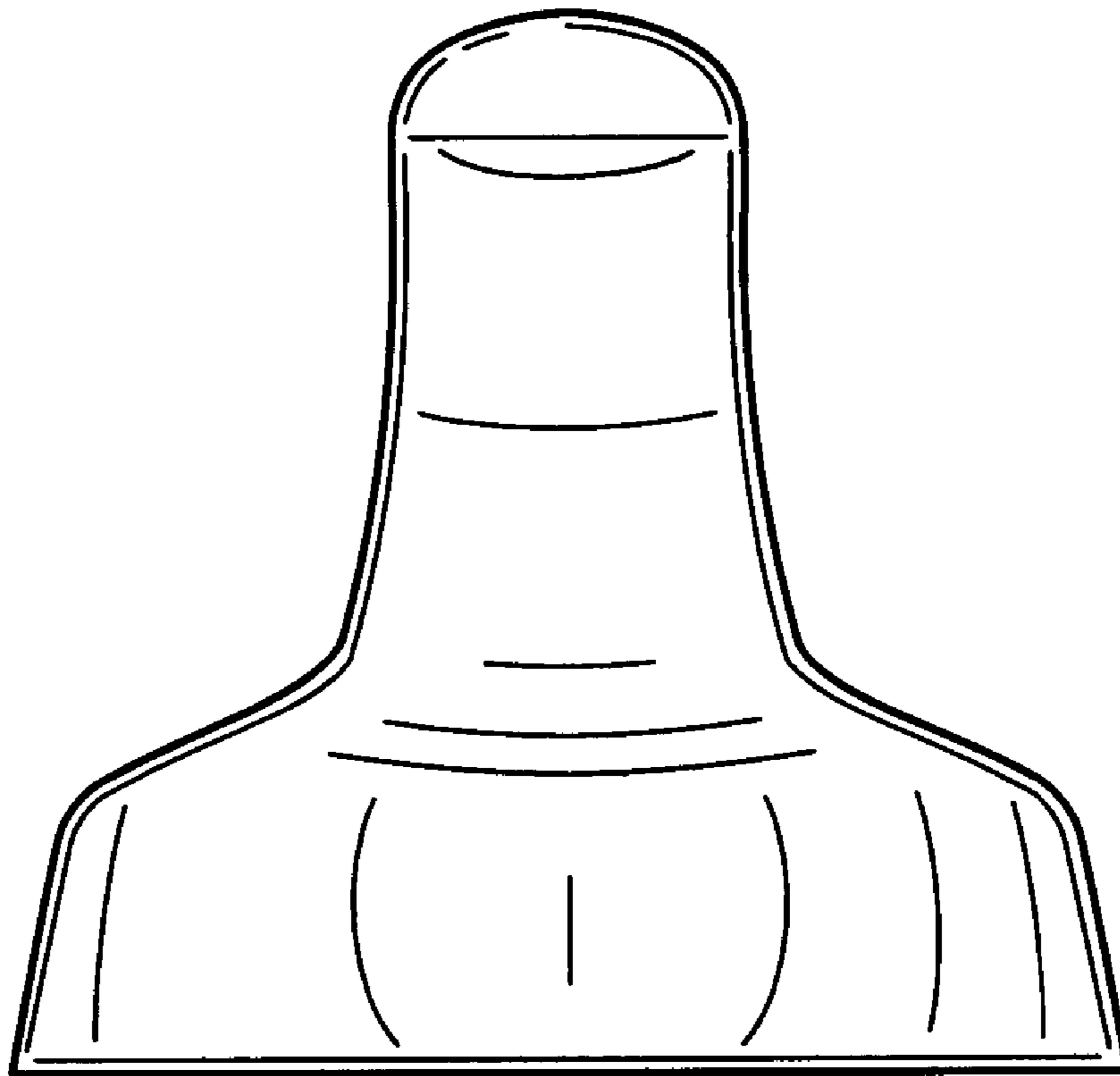

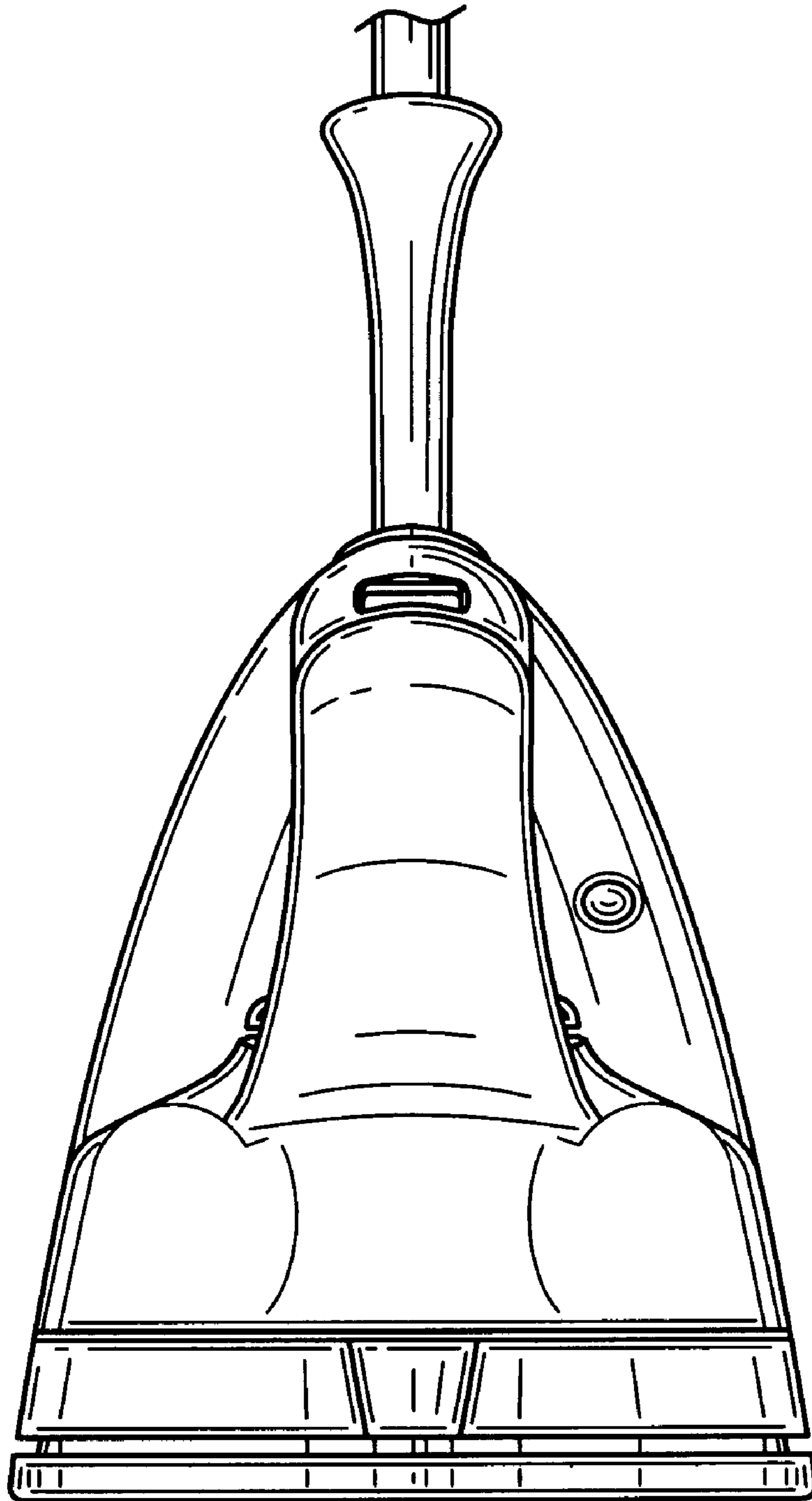

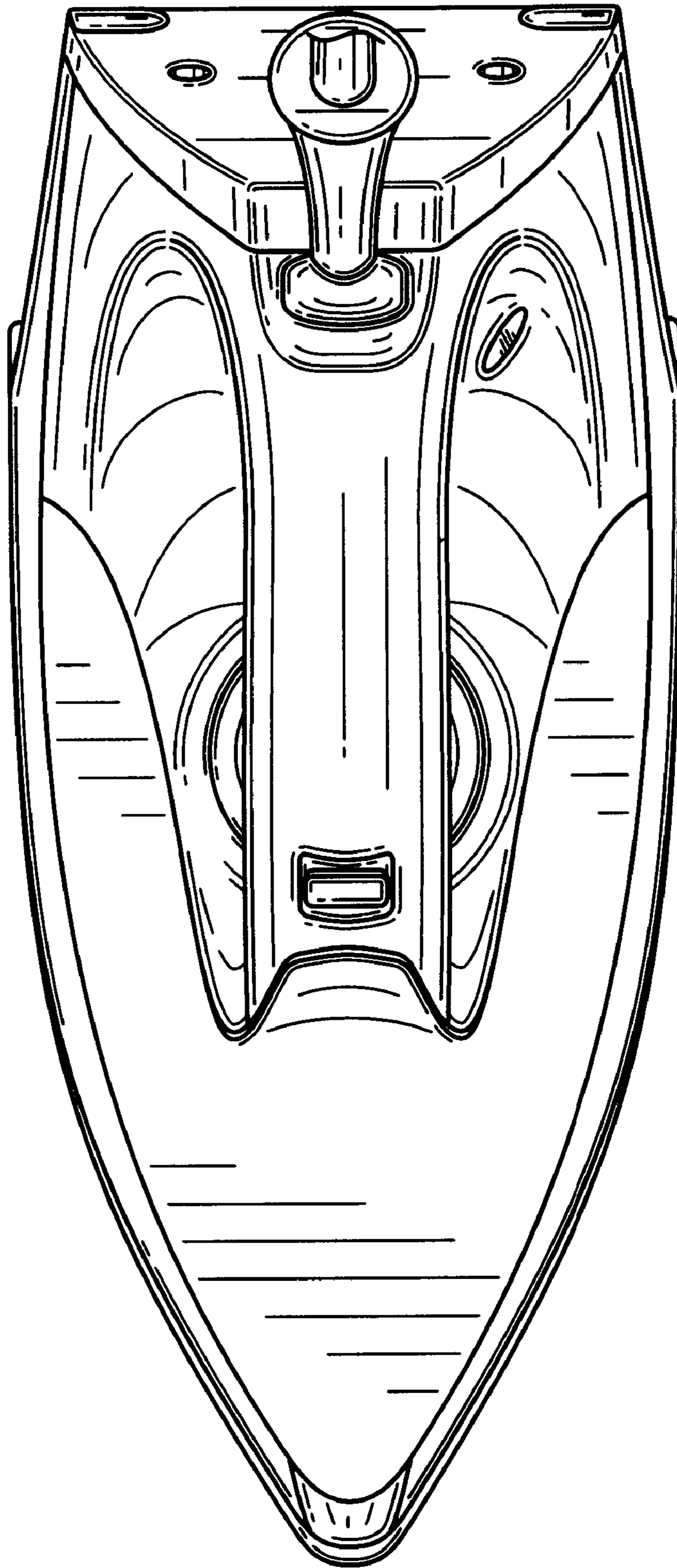
