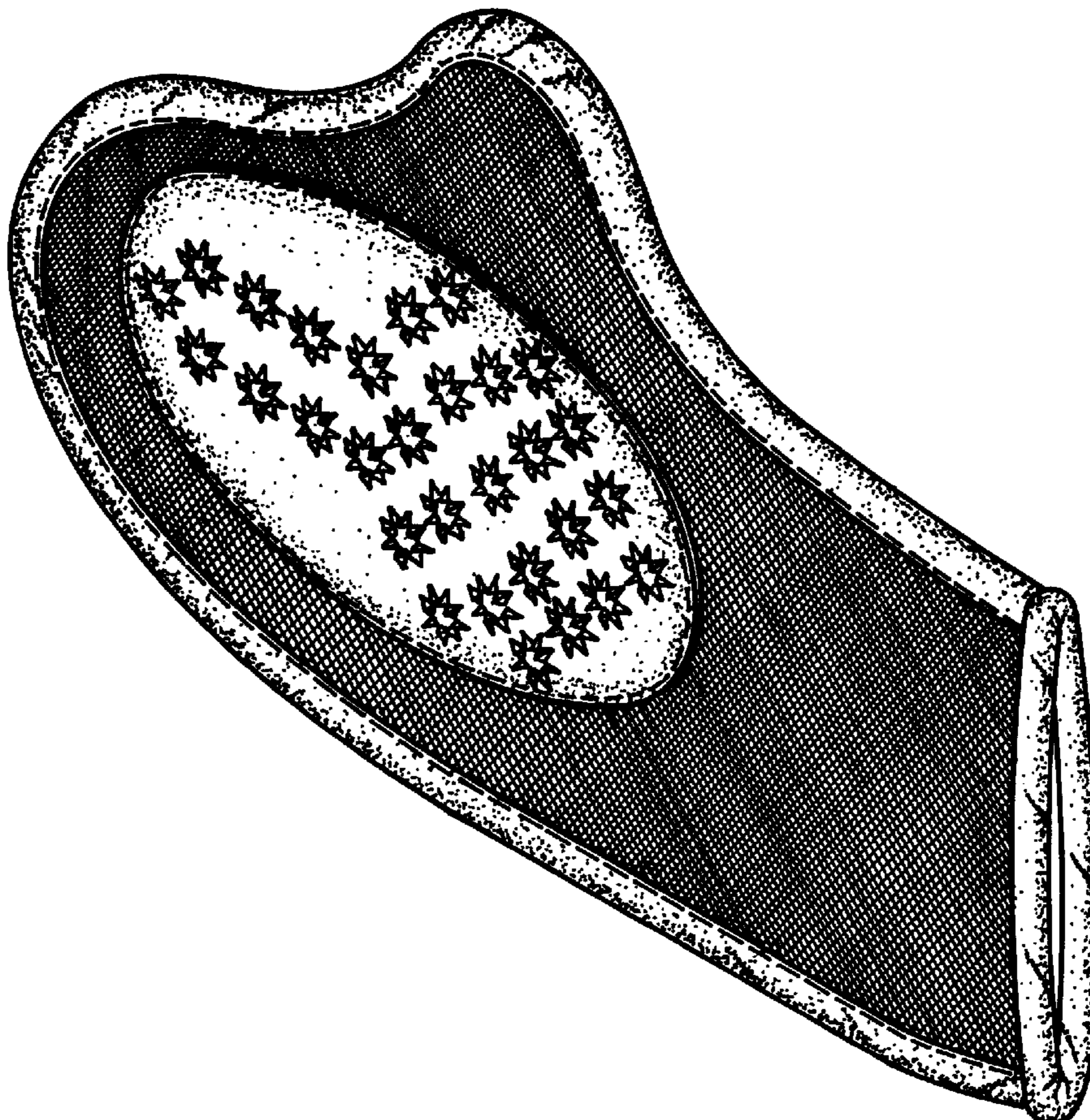
[57] **CLAIM**

The ornamental design for a potato skin stripping mitten, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a potato skin stripping mitten, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a left side elevational view thereof; and,
FIG. 7 is a right side elevational view thereof.
The broken lines shown in FIGS. 1, 4 and 5 represent stitching.

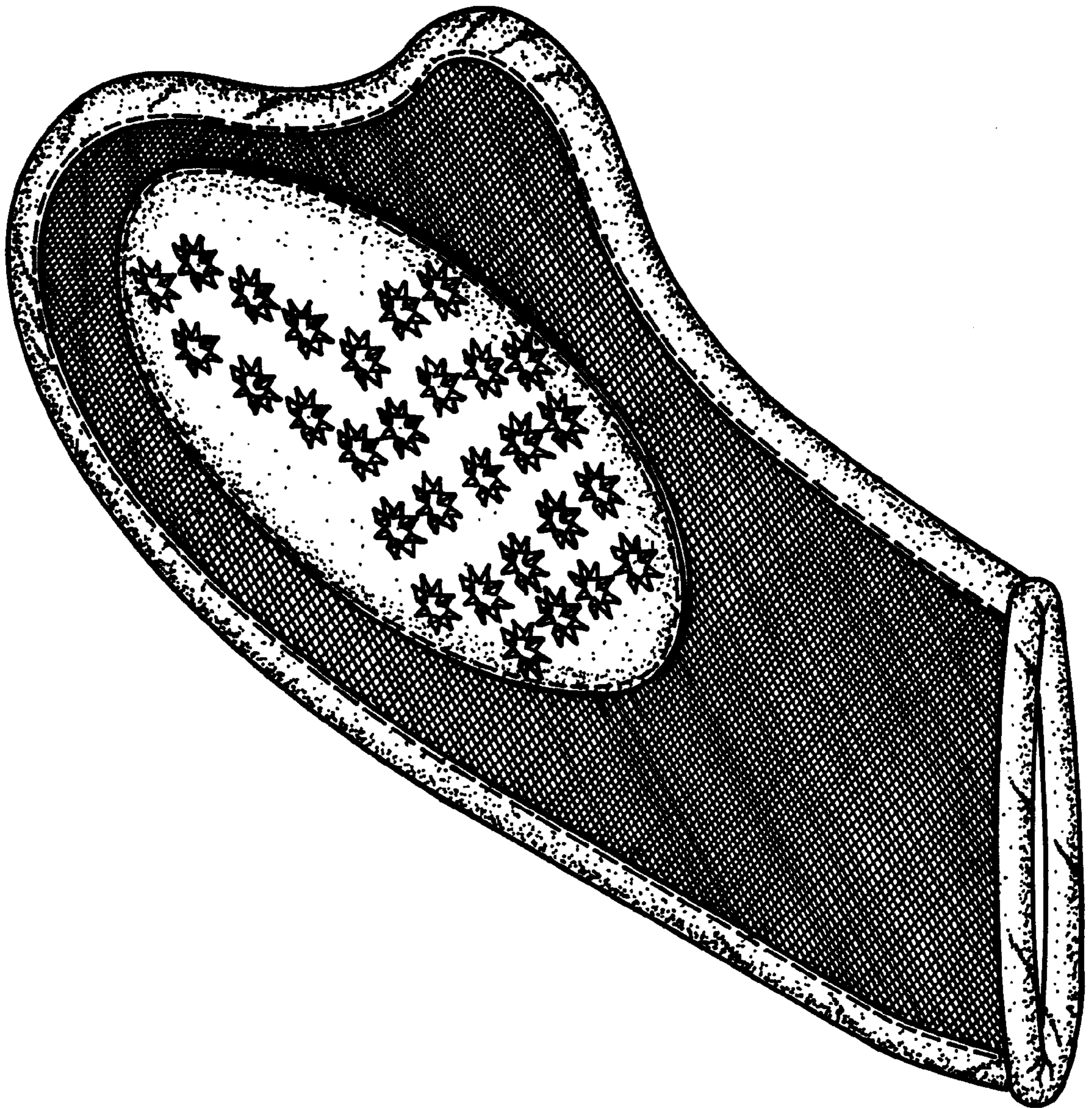

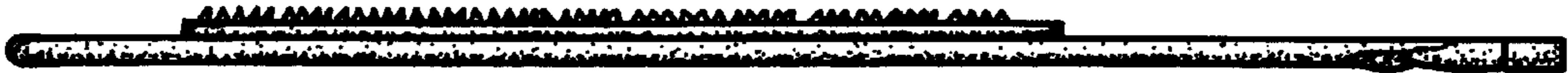

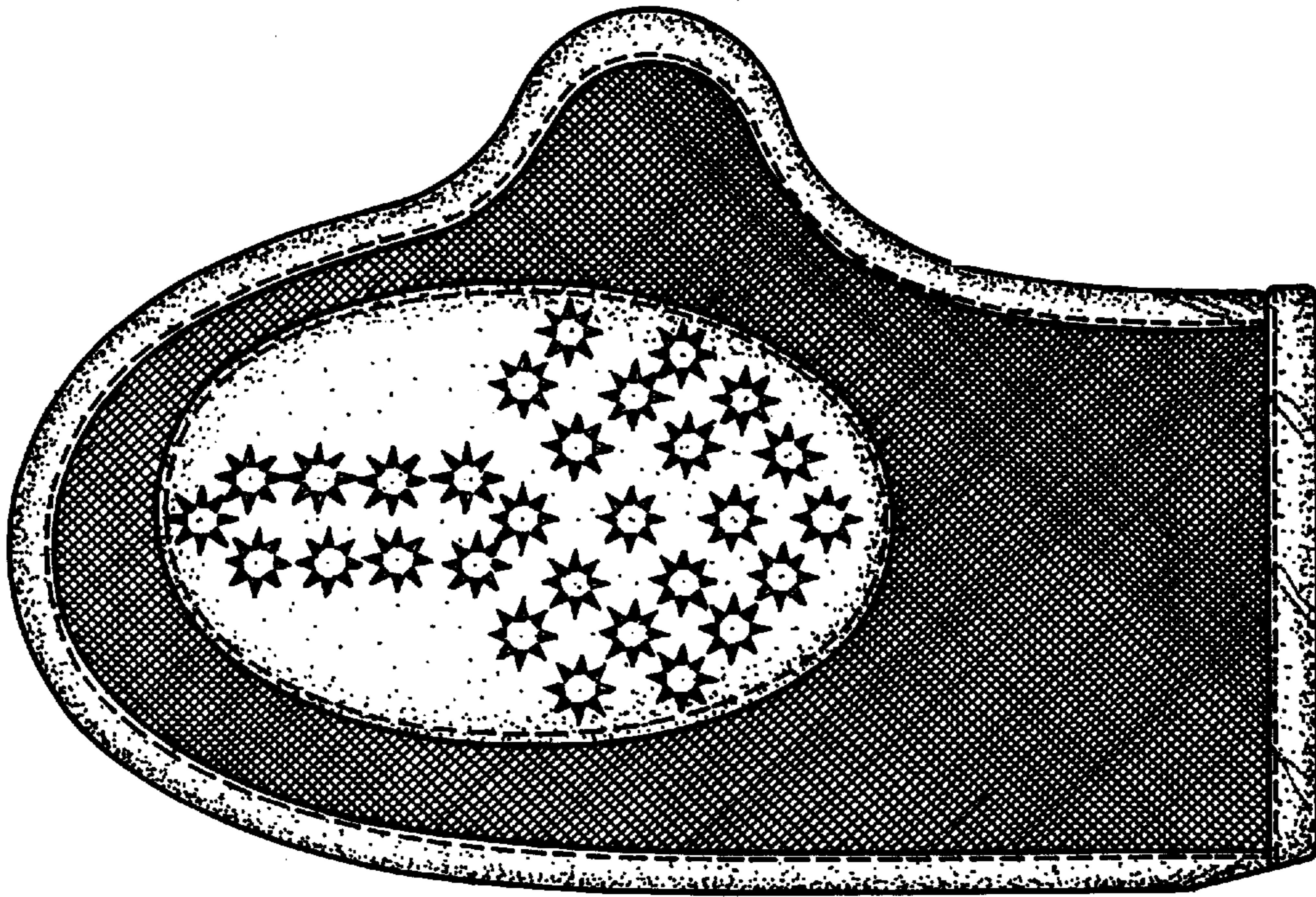

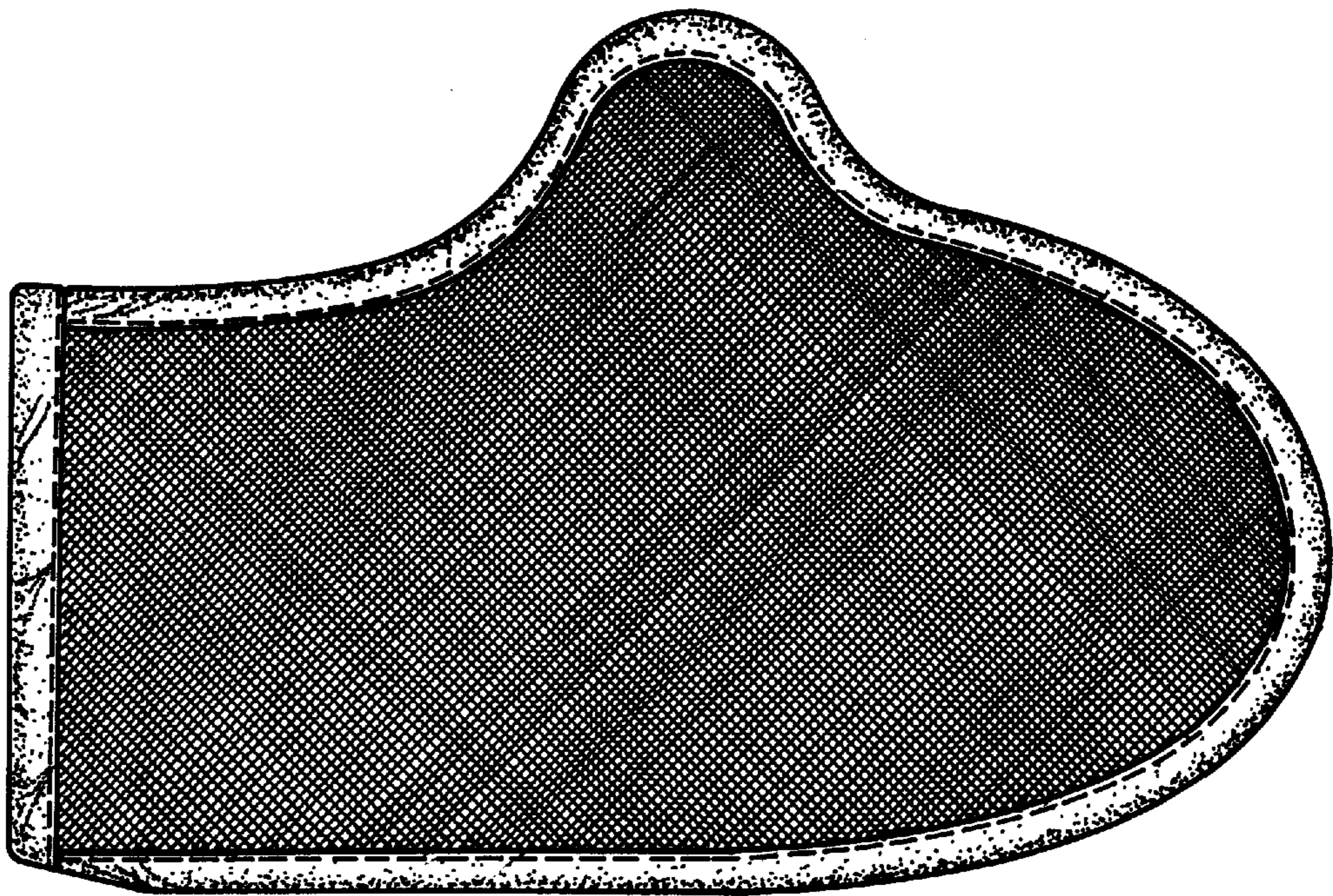
