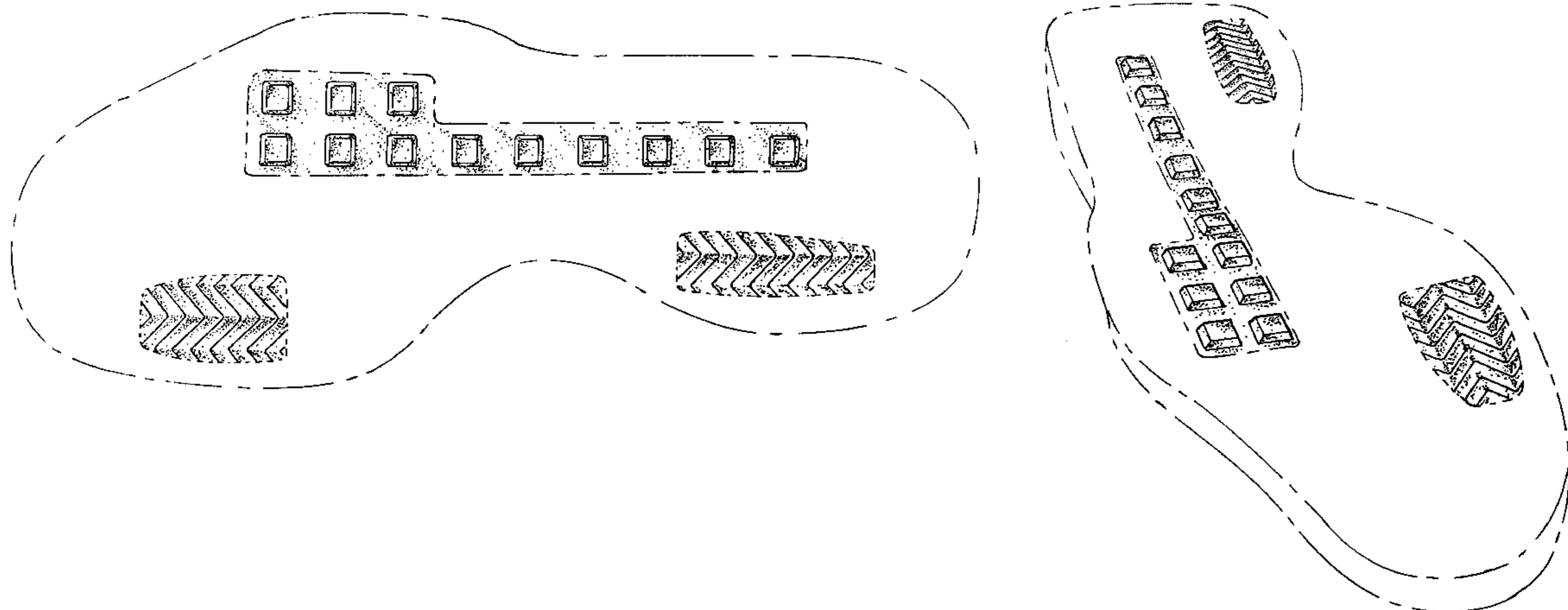
[57] **CLAIM**

The ornamental design for a portion of a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a portion of a shoe outsole showing my new design; FIG. 2 is a front perspective view thereof; and, FIG. 3 is a rear perspective view thereof. The uneven broken line showing of the boundary of the claimed regions and the remainder of the shoe is for illustrative purposes only and forms no part of the claimed design.

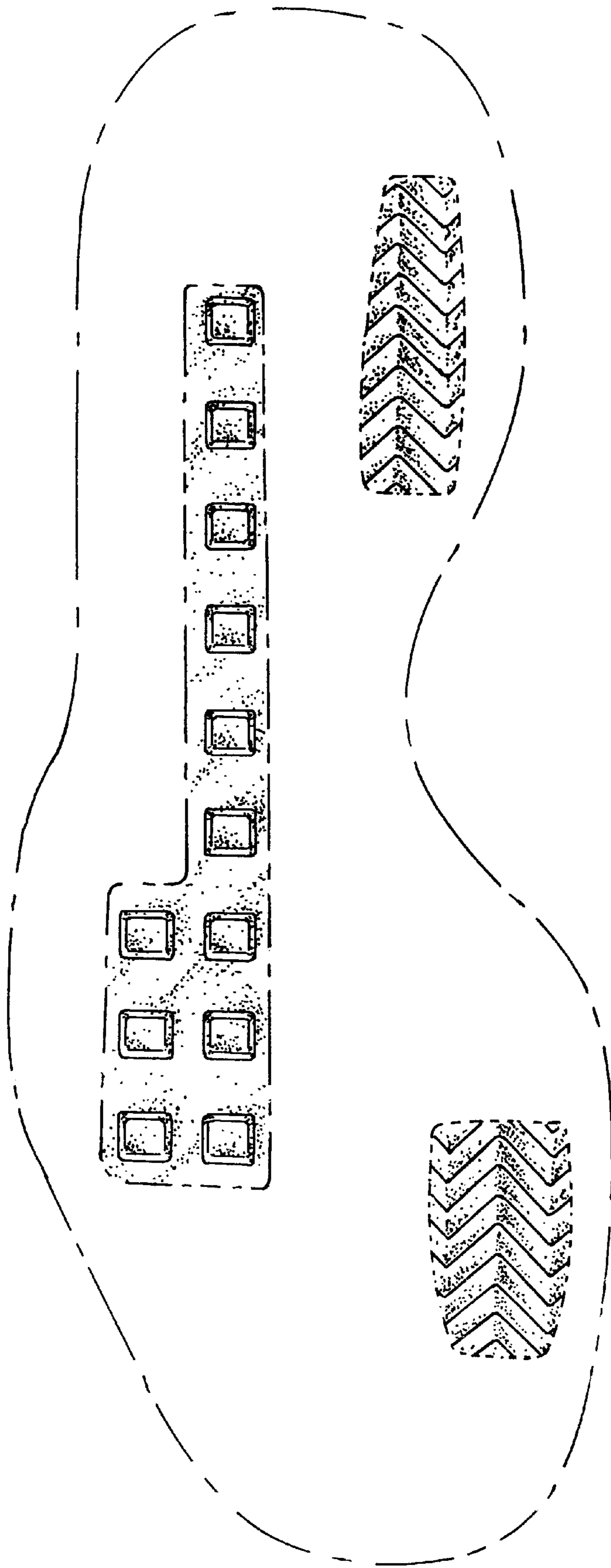

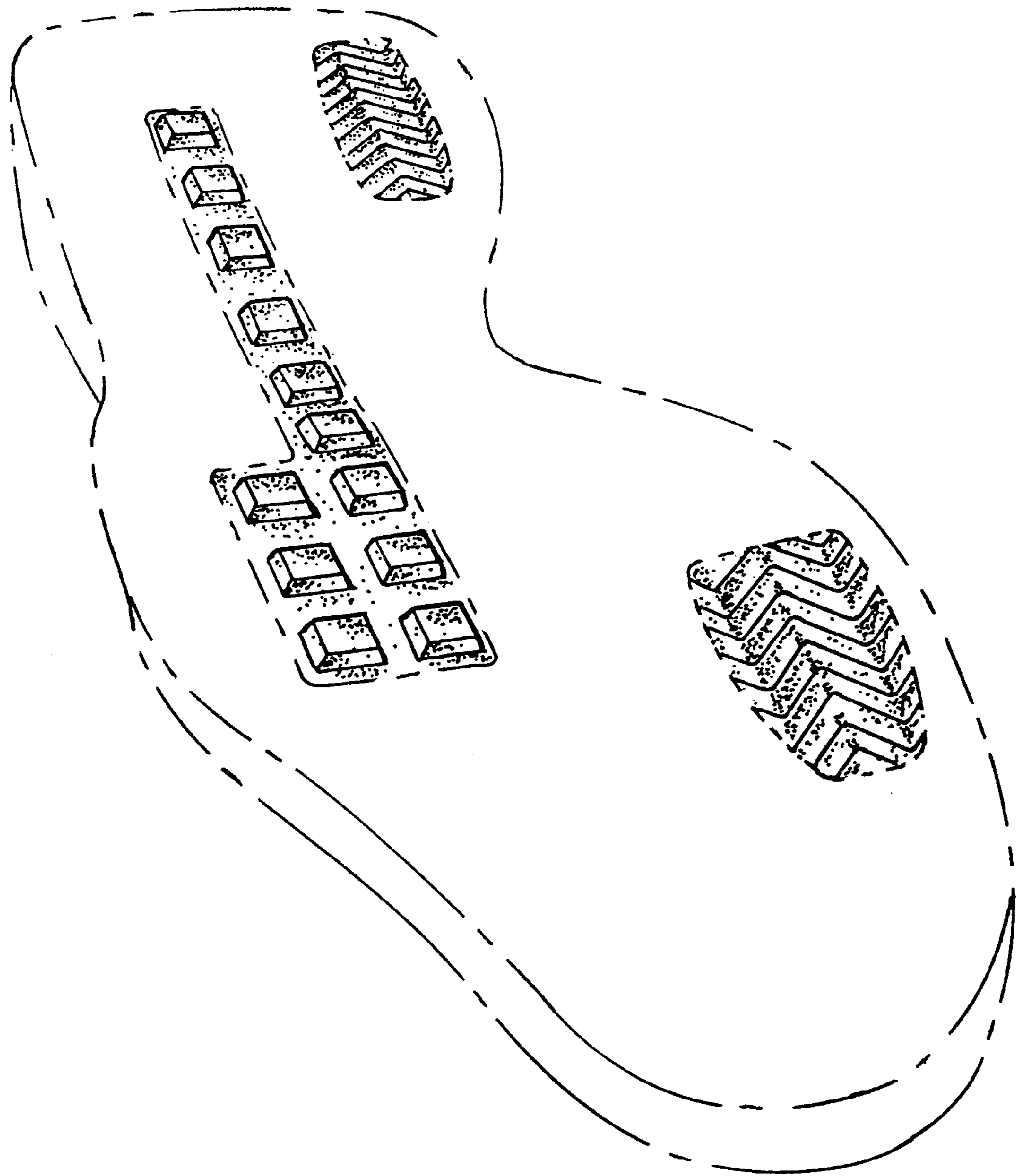

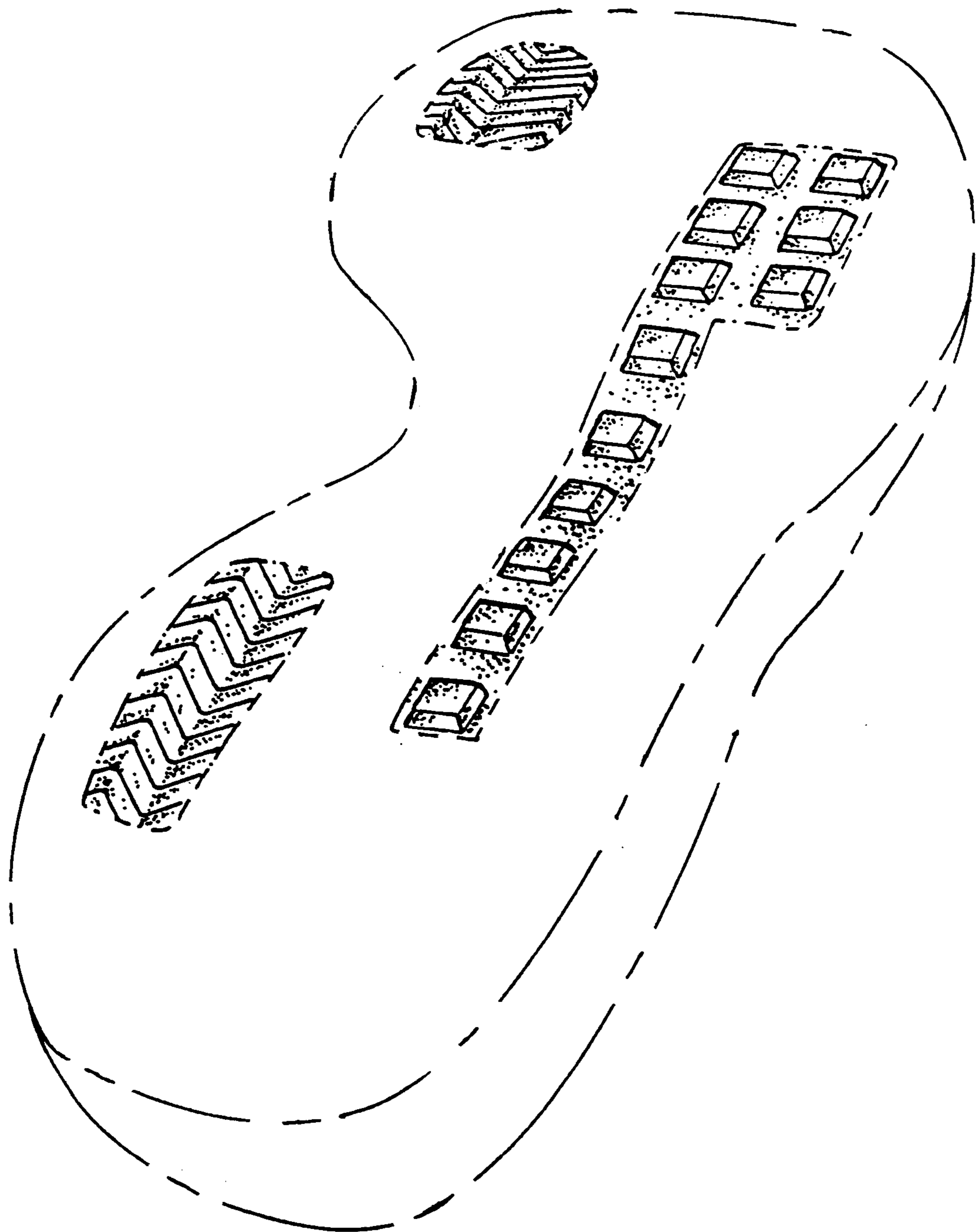
