FIG. 2 is an outside lateral, full side view of the present invention;

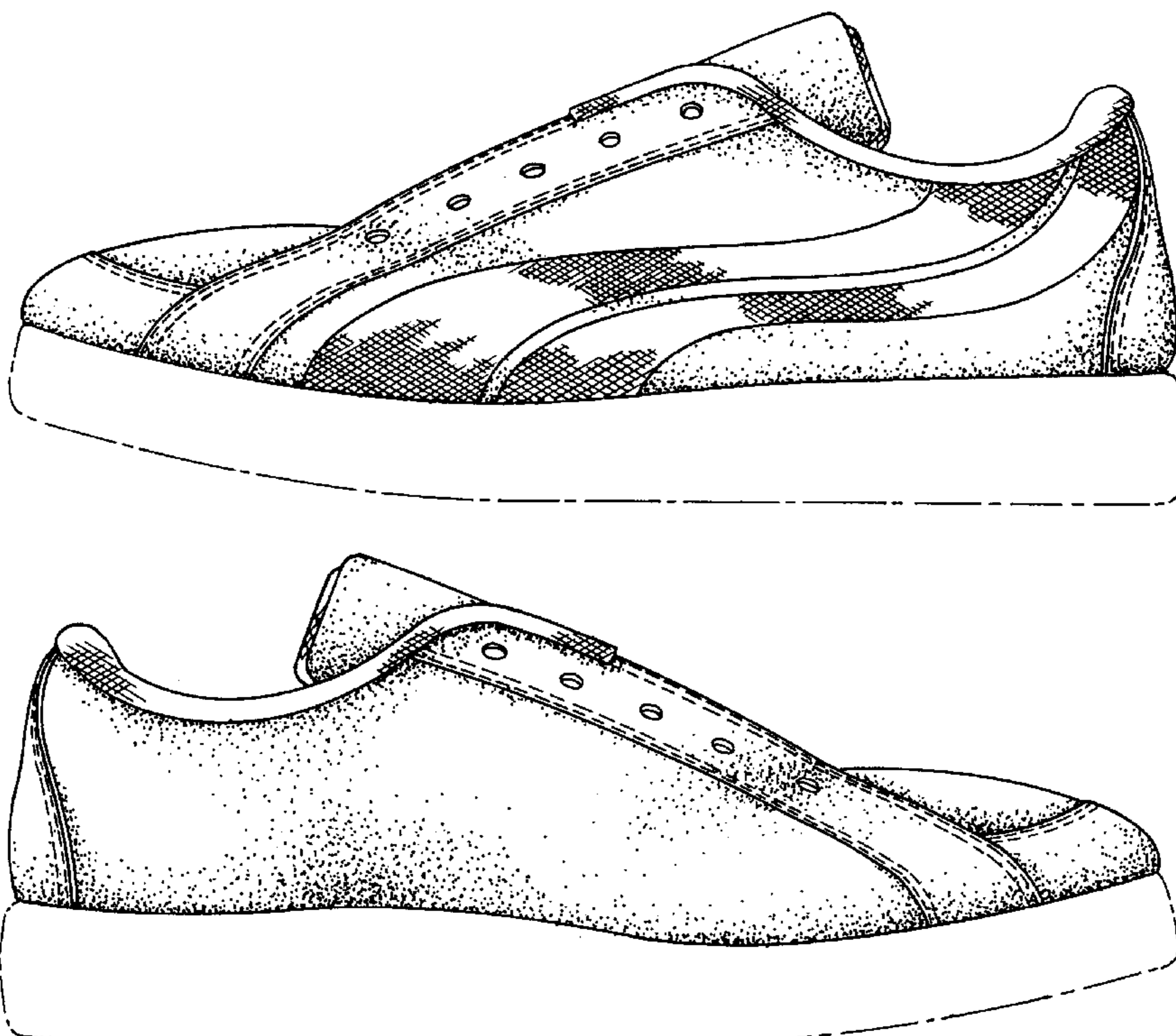
FIG. 3 is a inside, full lateral view thereof;

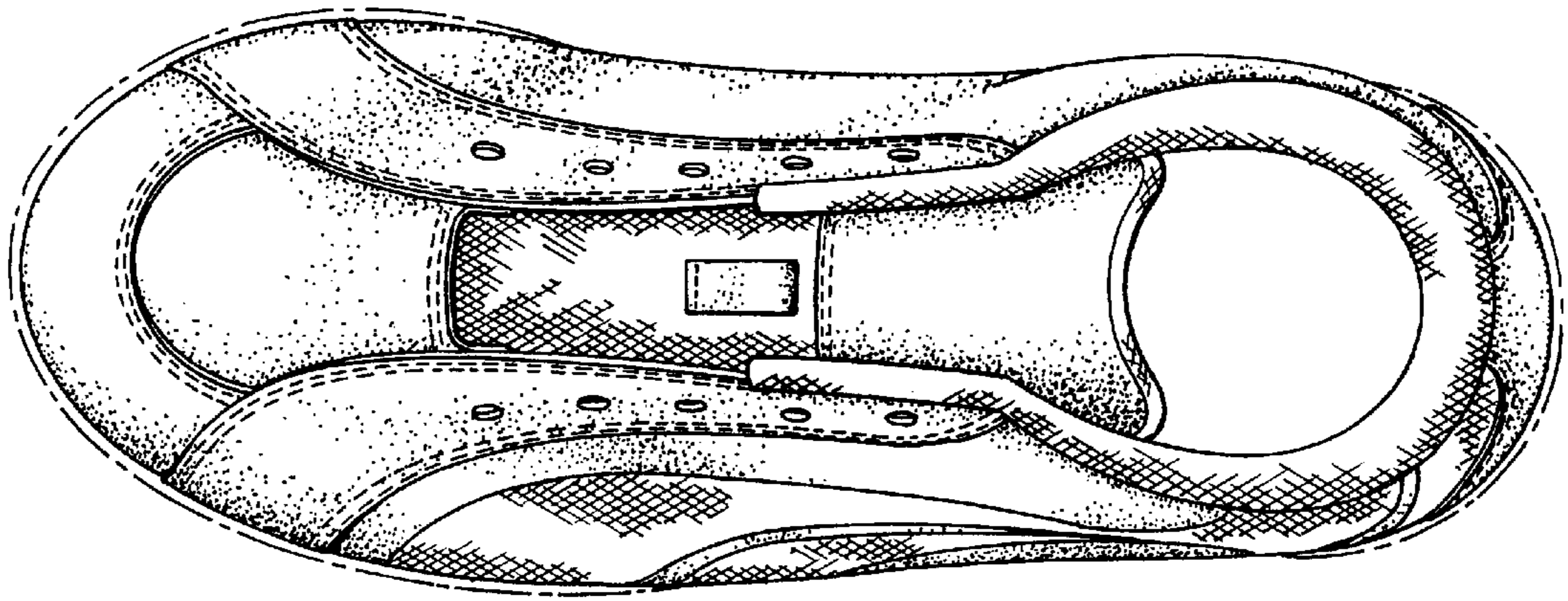

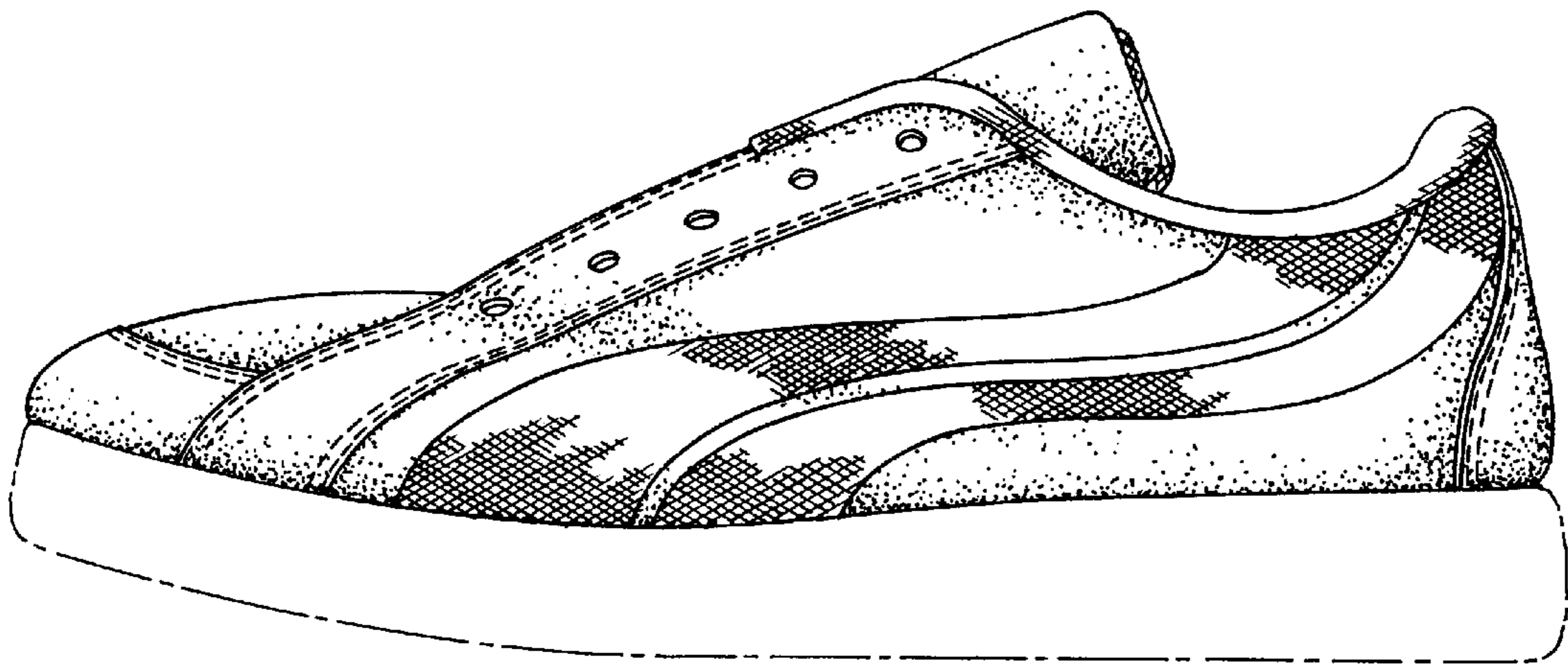

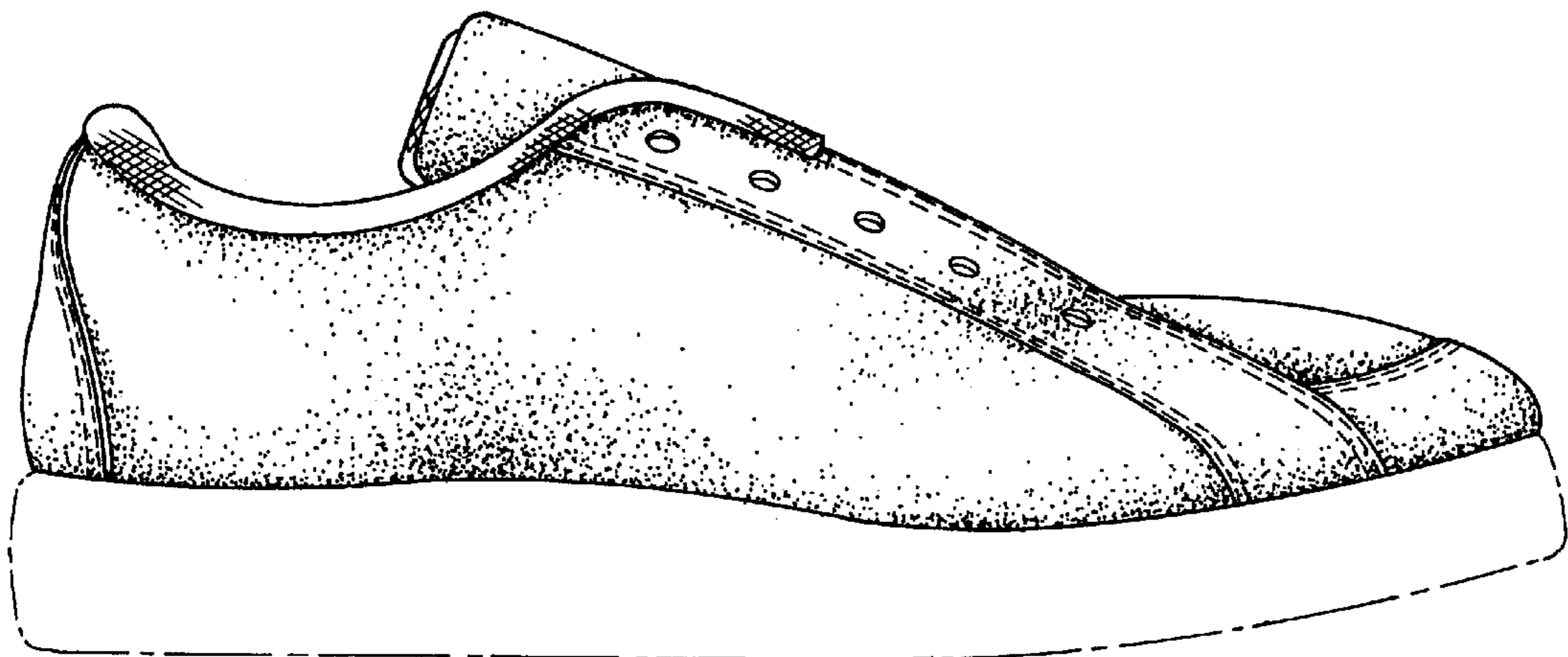

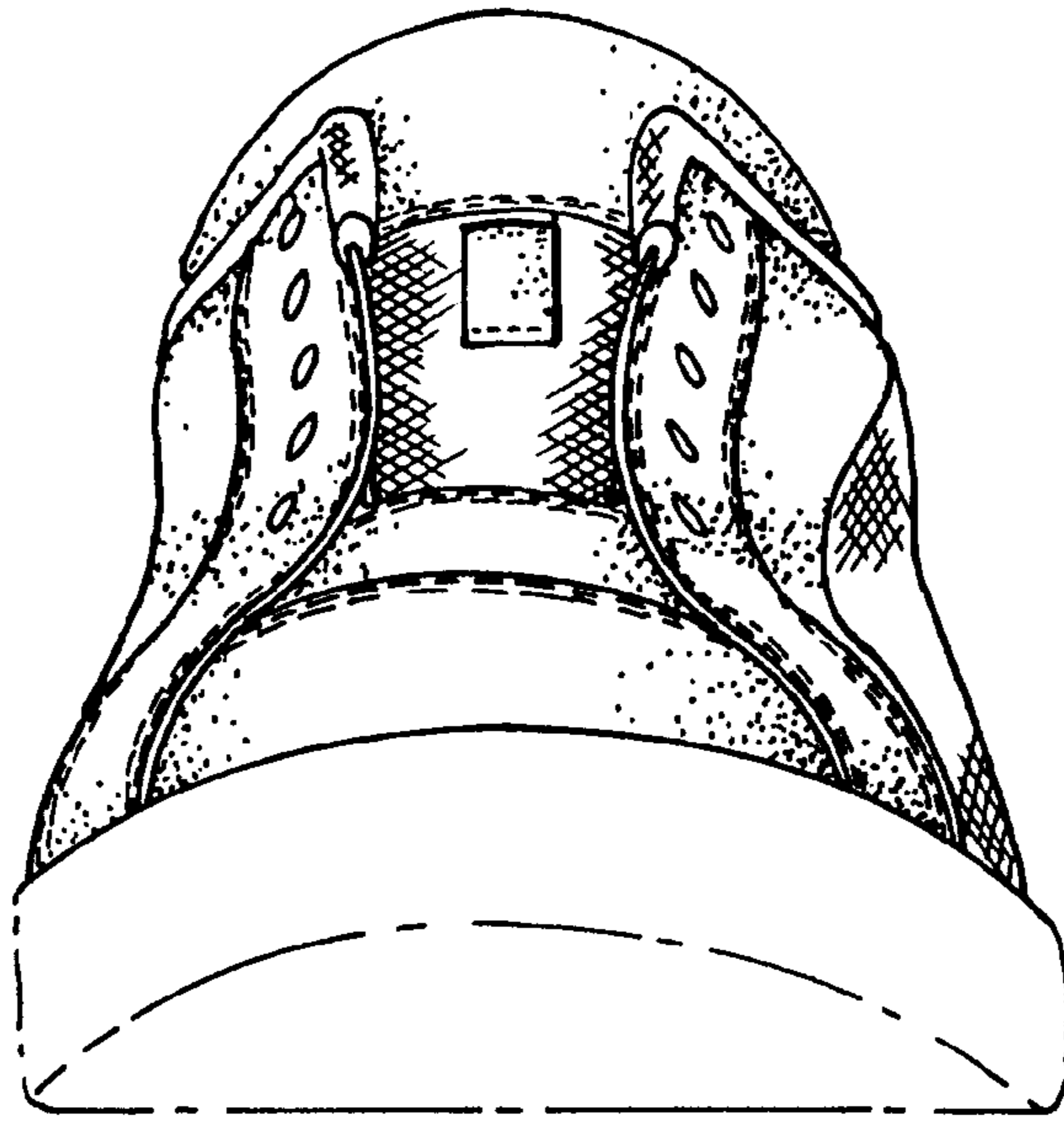

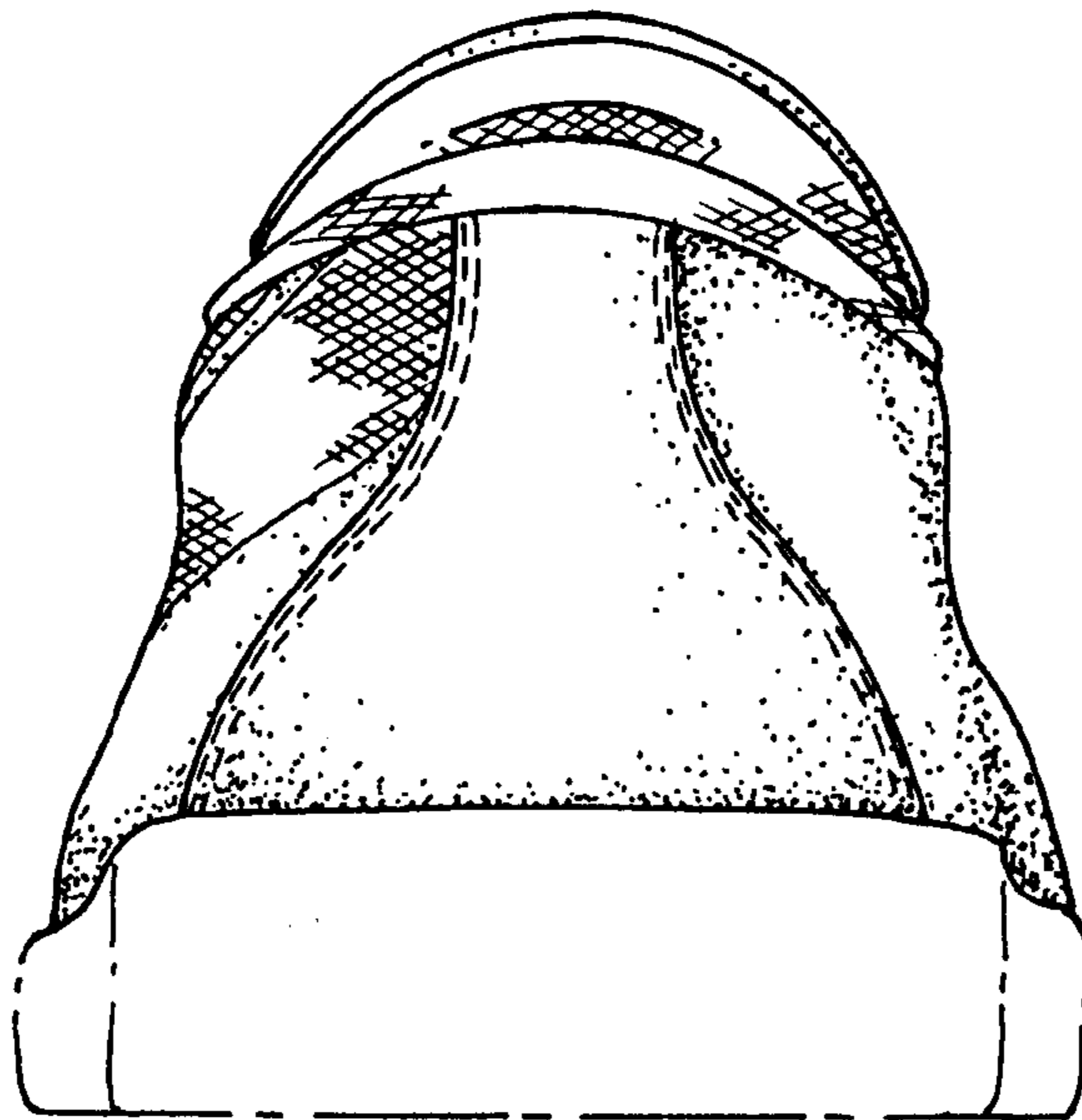
