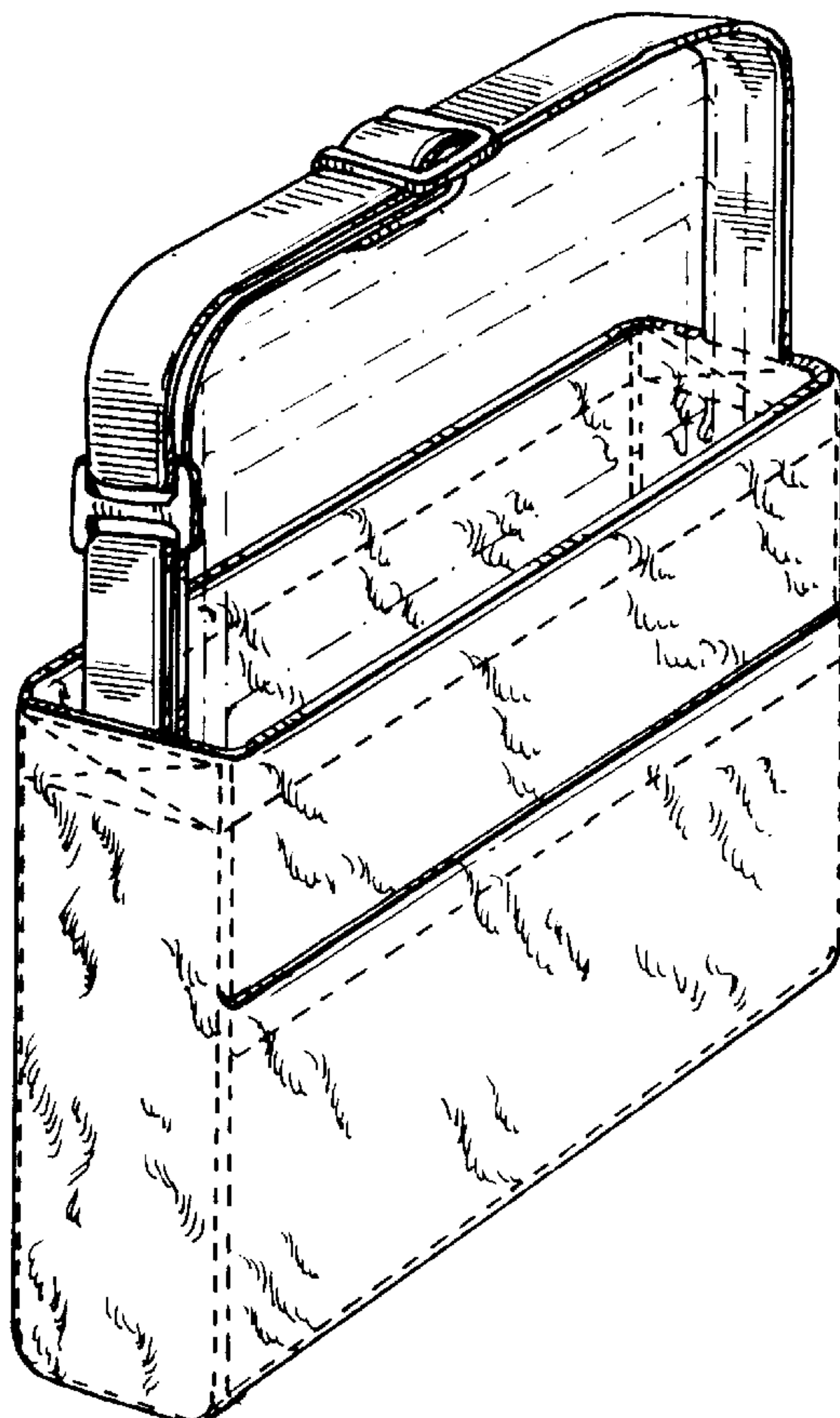
[57] **CLAIM**

The ornamental design for a carrying bag for beach chairs, as shown and described.

DESCRIPTION

FIG. 1 is a left front diagonal view of a carrying bag for beach chairs which embodies my design; FIG. 2 is a rear view of the FIG. 1 design; FIG. 3 is a front view of the FIG. 1 design; FIG. 4 is a left side view of the FIG. 1 design; FIG. 5 is a right side view of the FIG. 1 design; FIG. 6 is a top plan view of the FIG. 1 design; and, FIG. 7 is a bottom plan view of the FIG. 1 design. The broken line showing of chairs in FIG. 1 is for illustrative purposes only and forms no part of the claimed design.

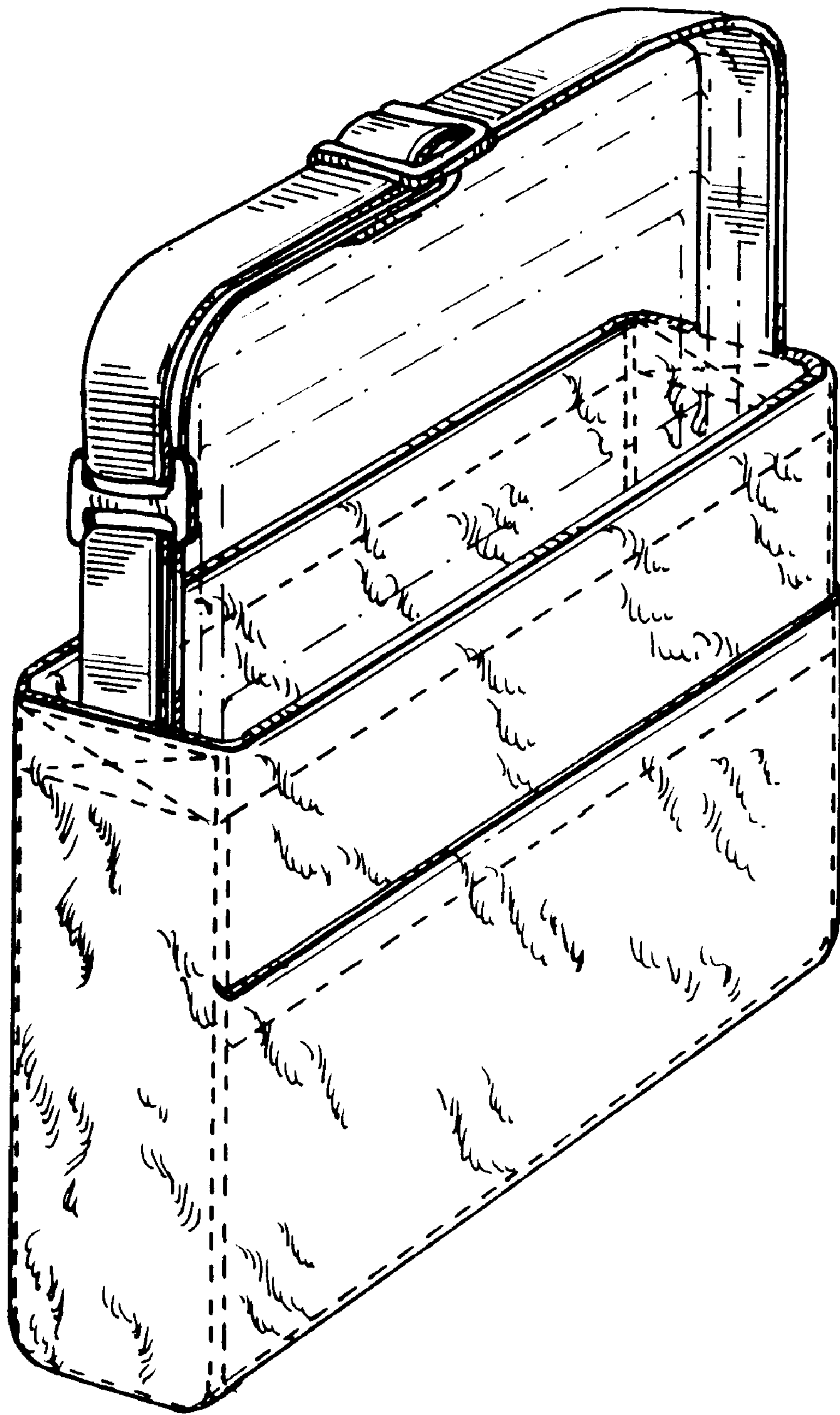

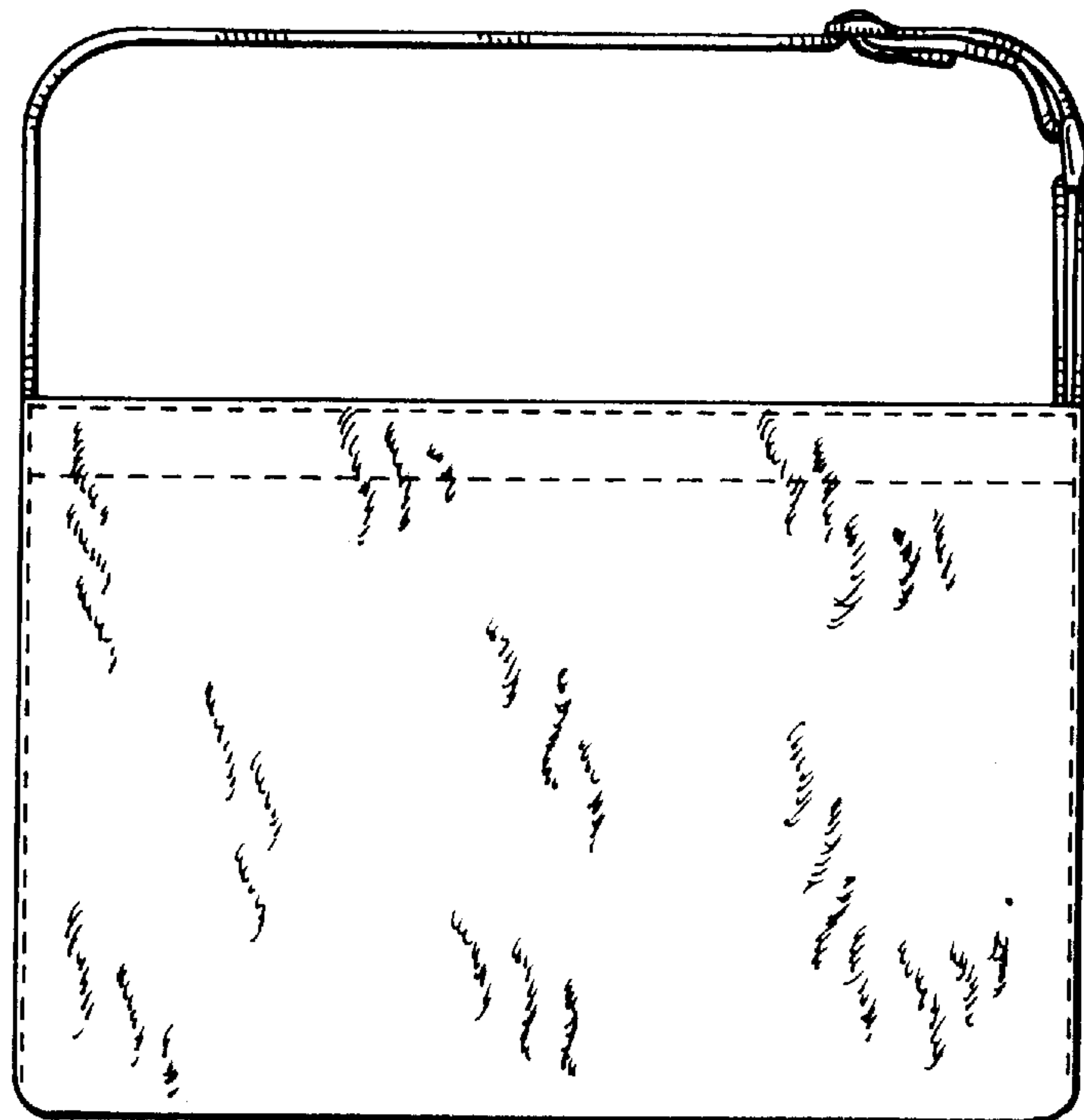

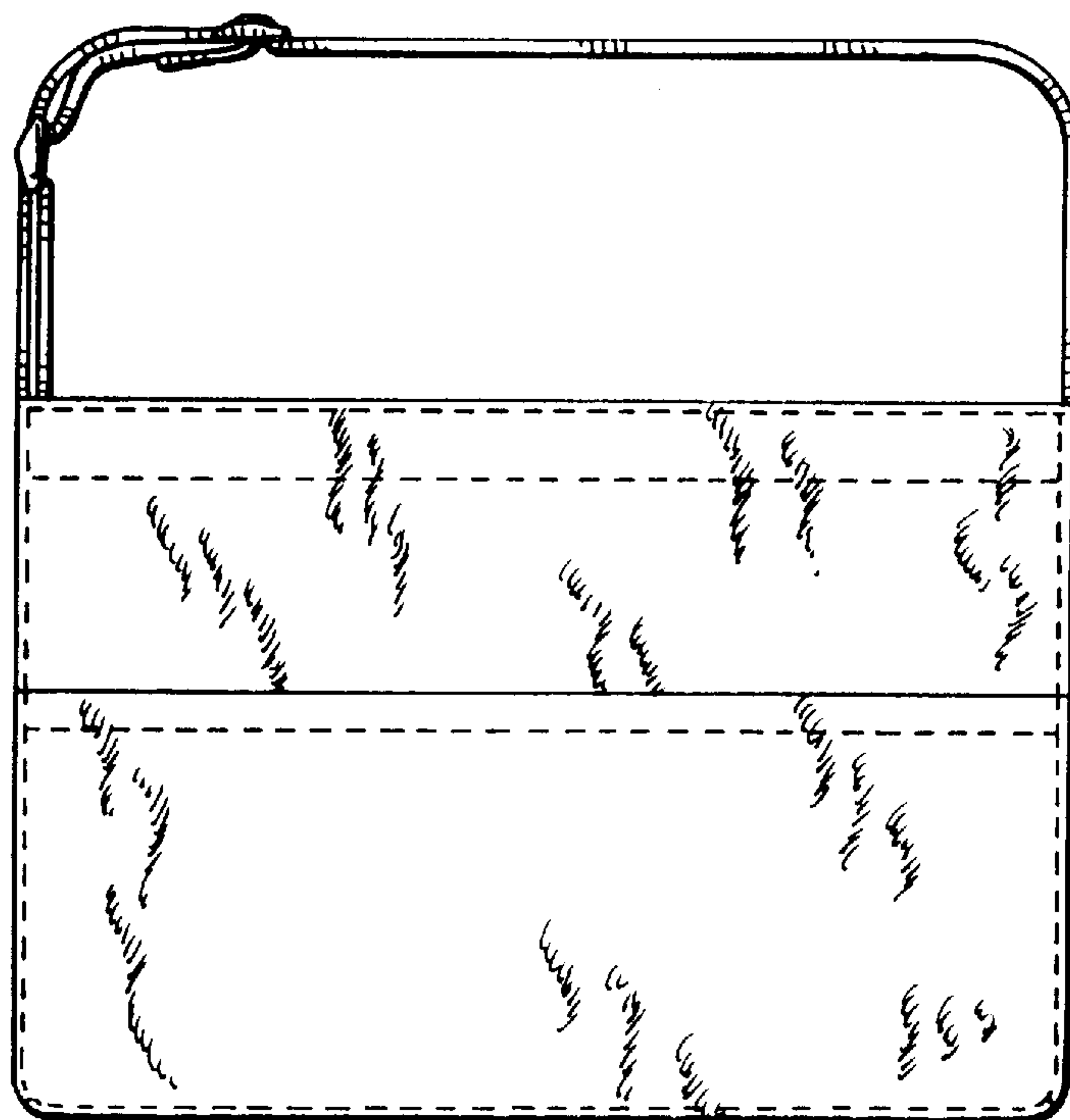

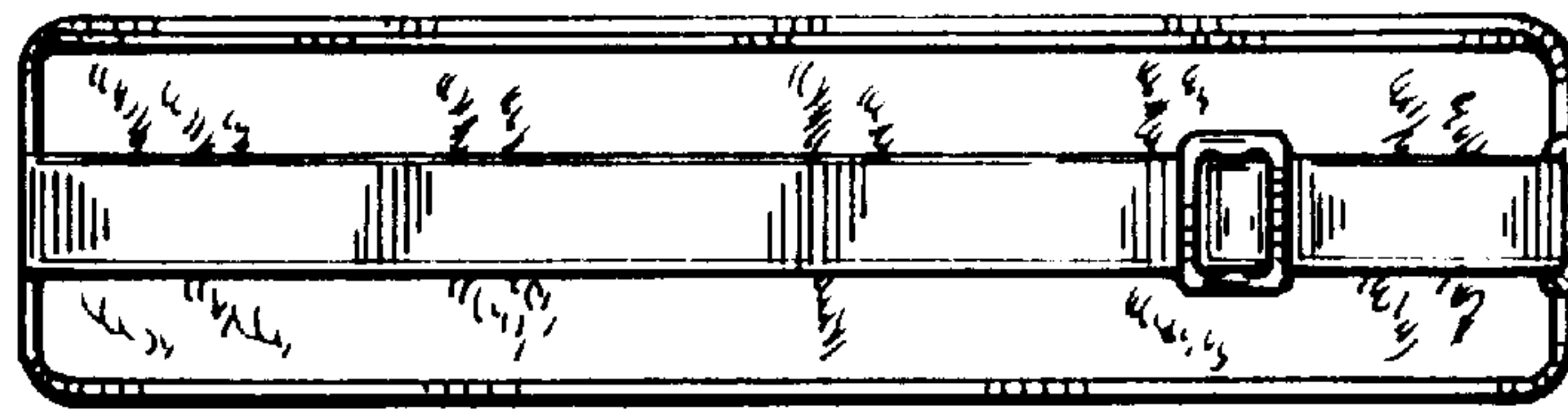

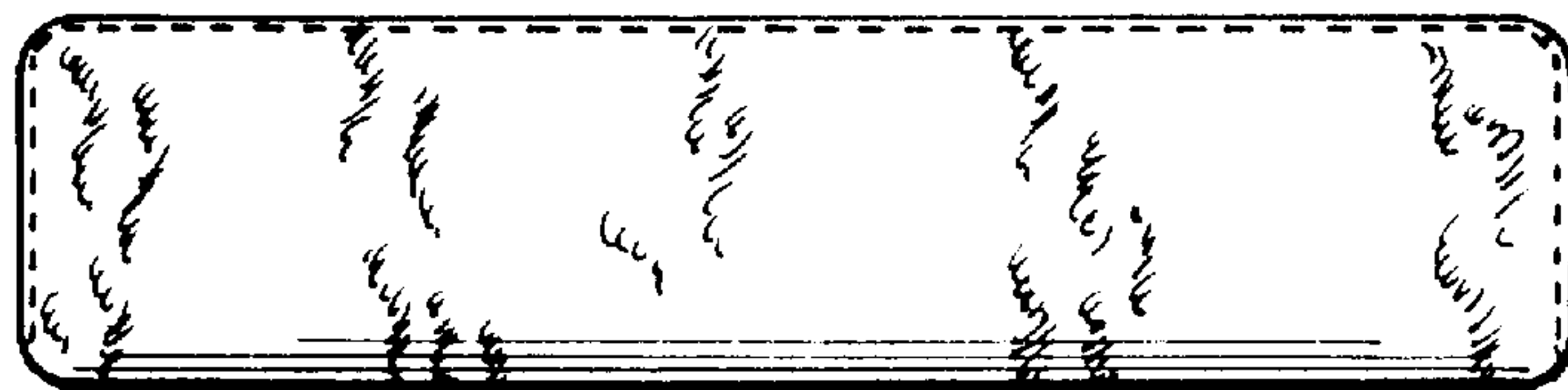
