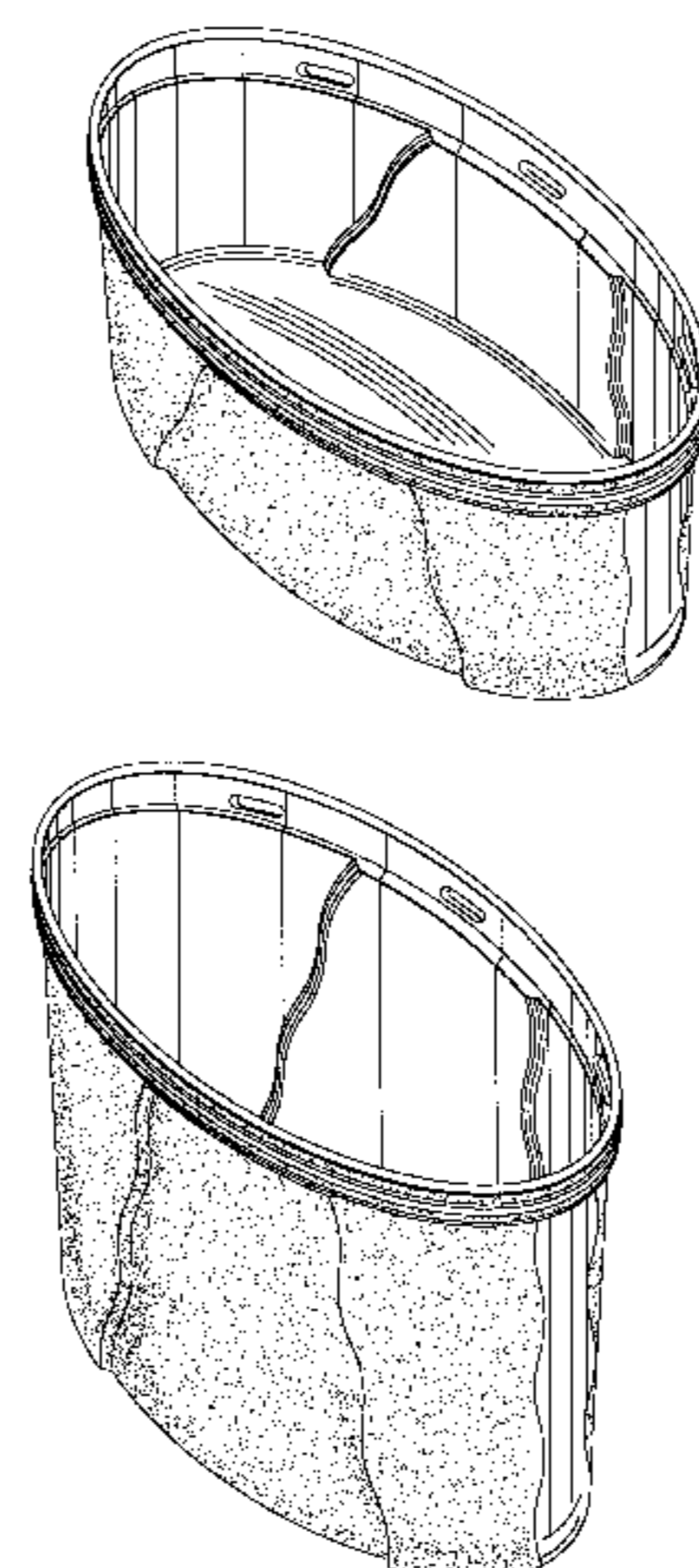
The ornamental design for a storage container, as shown and described.

DESCRIPTION

FIG. 1 is a top, side and front perspective view of a first embodiment of a storage container showing our new design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is rear elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a cross-sectional view thereof along line 8—8 of FIG. 6;

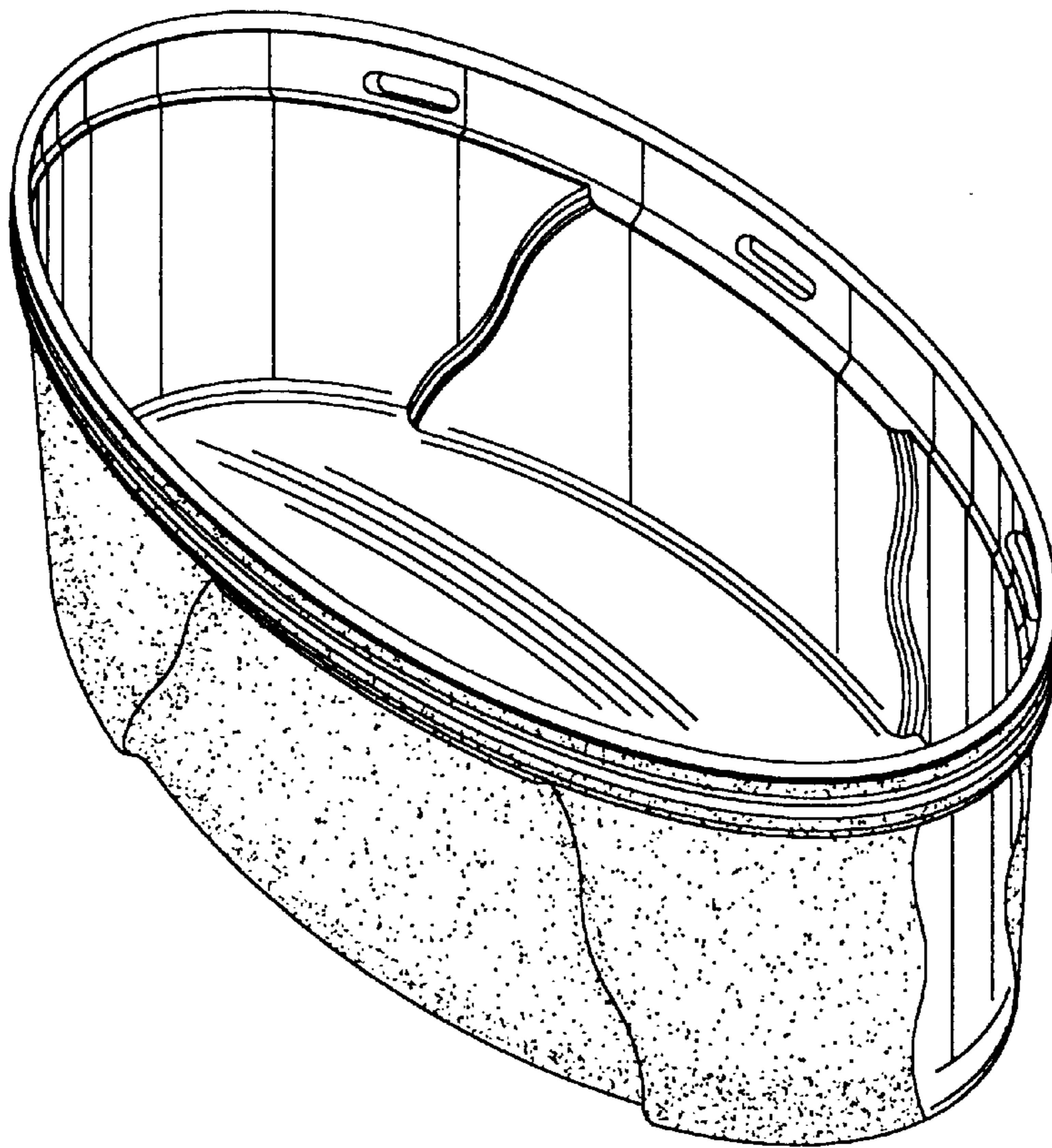

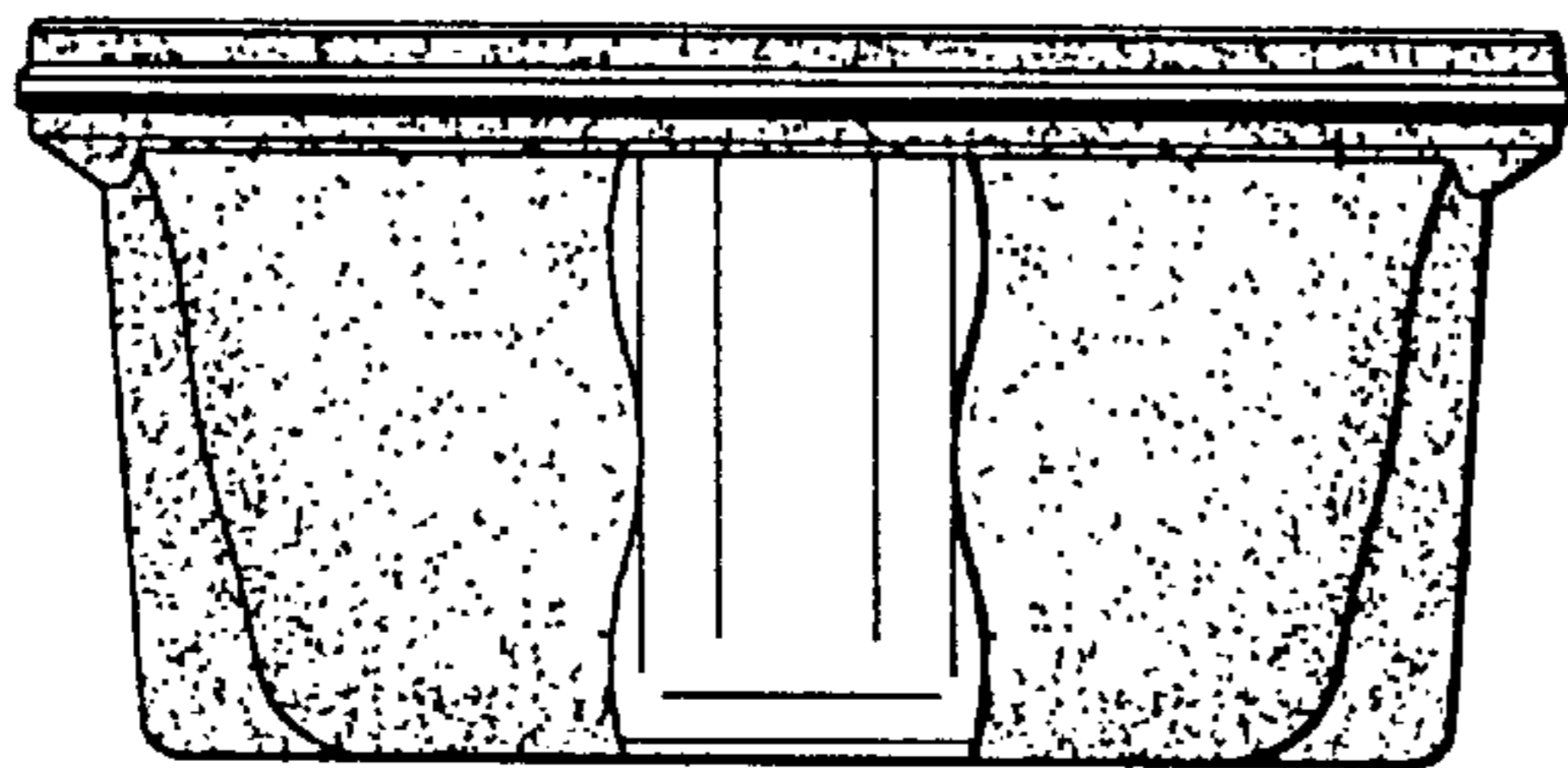

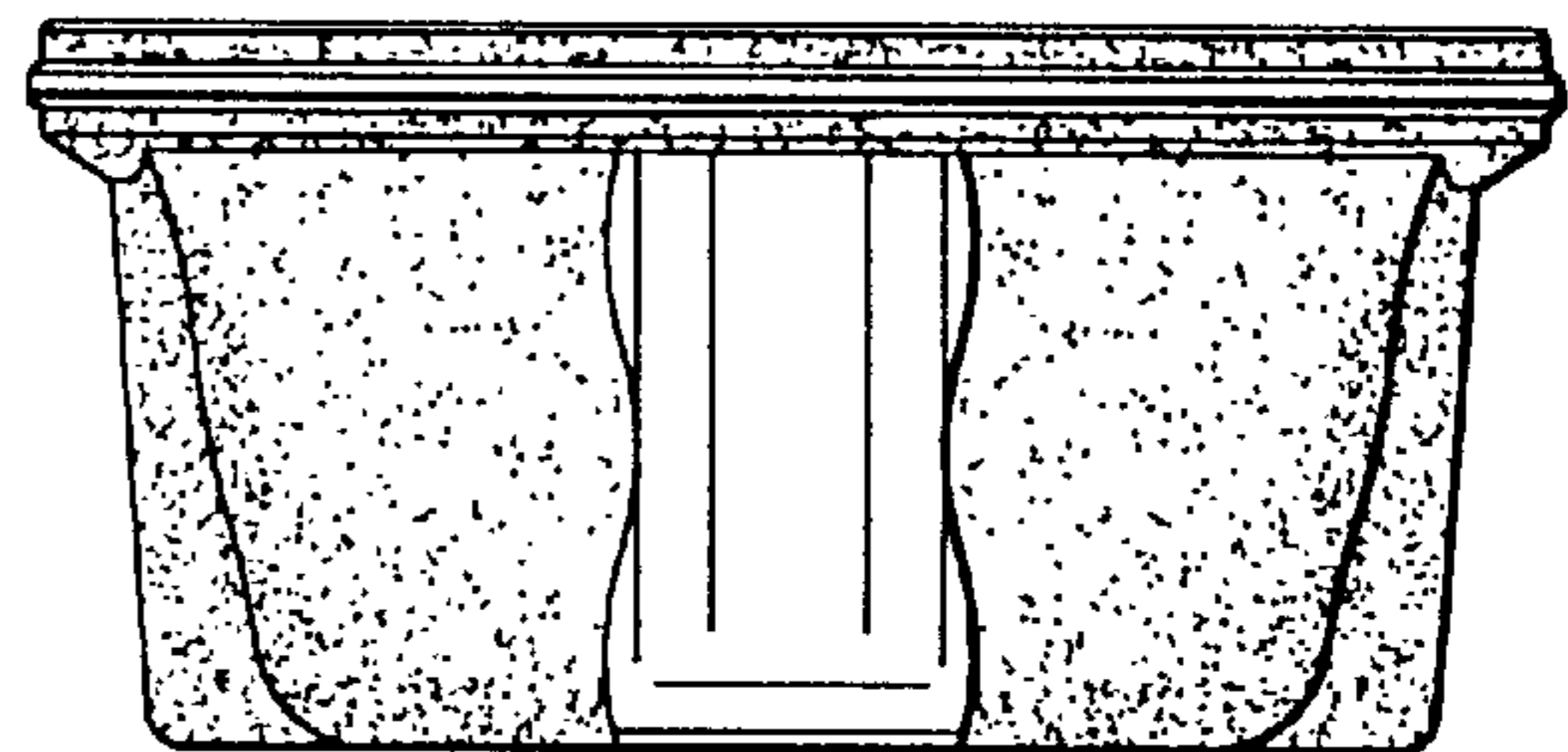

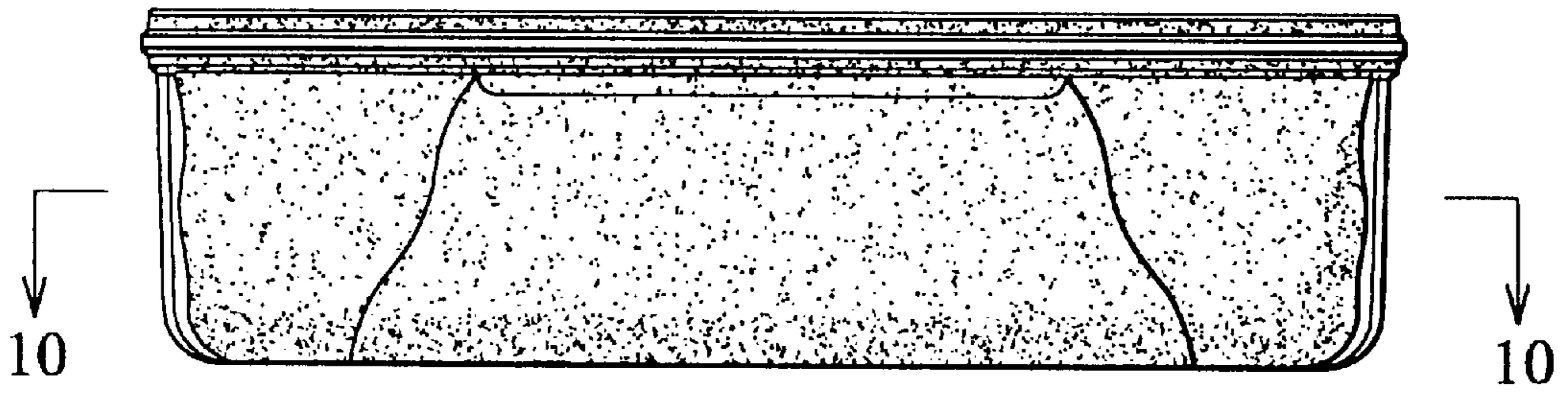

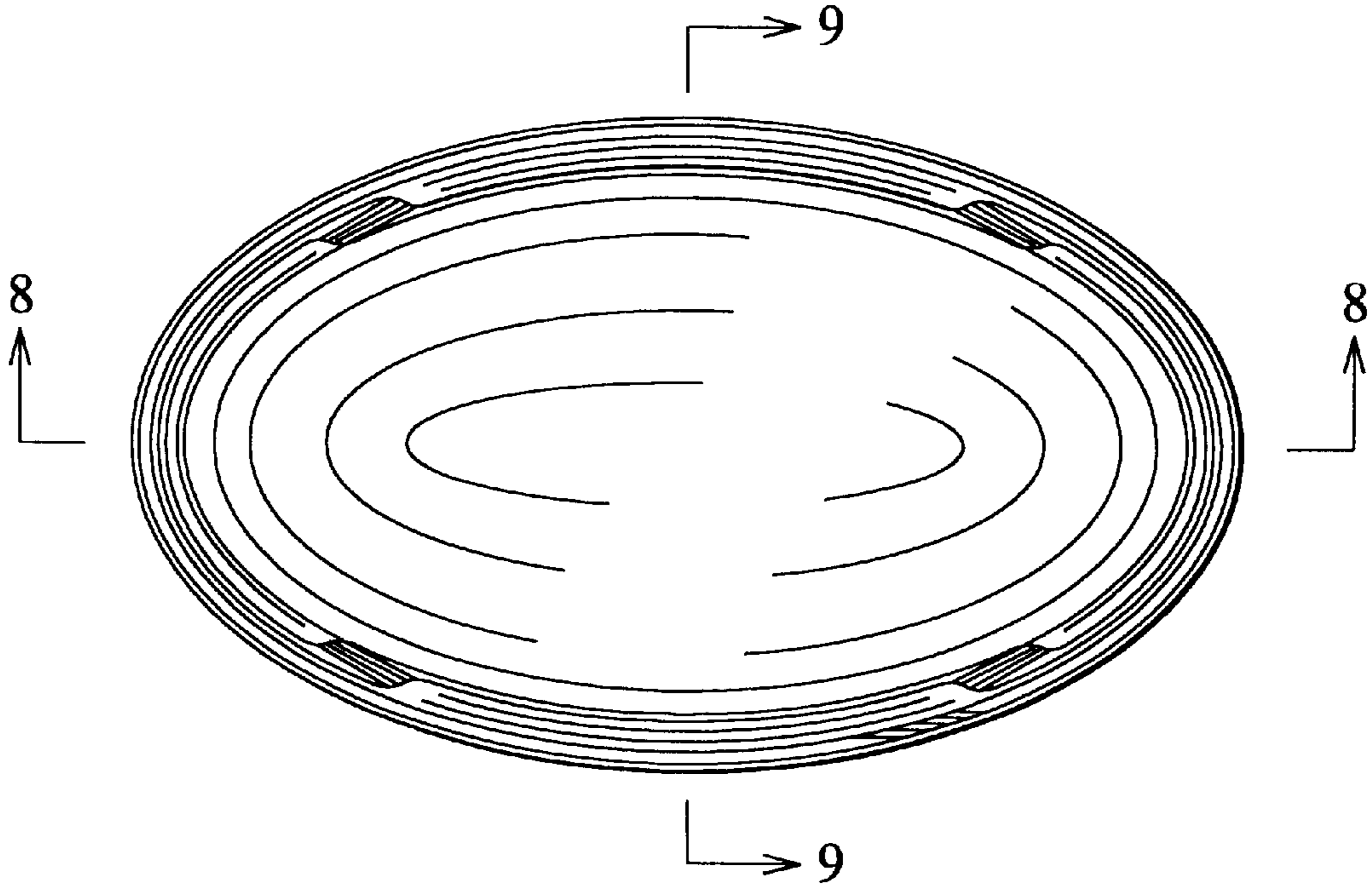

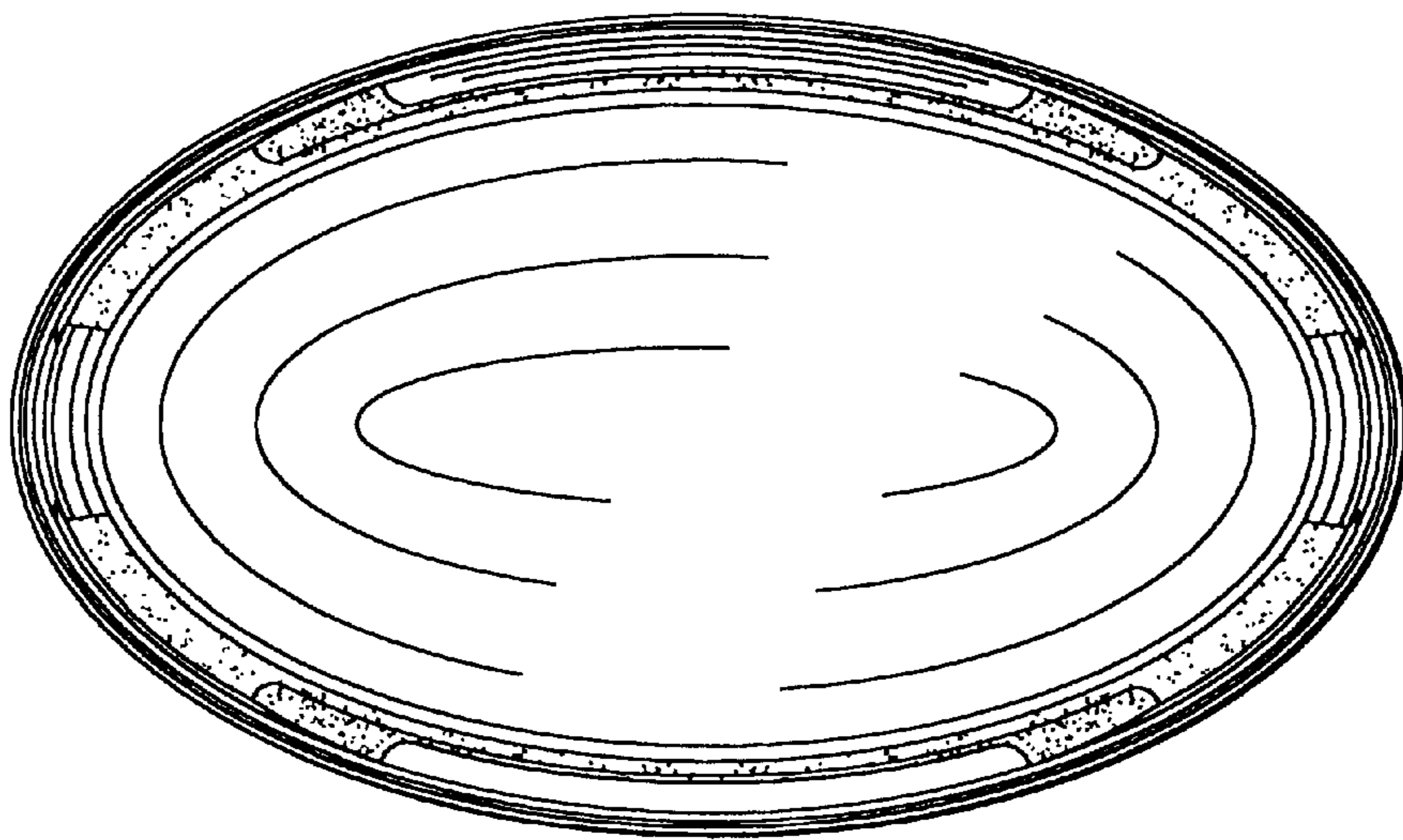

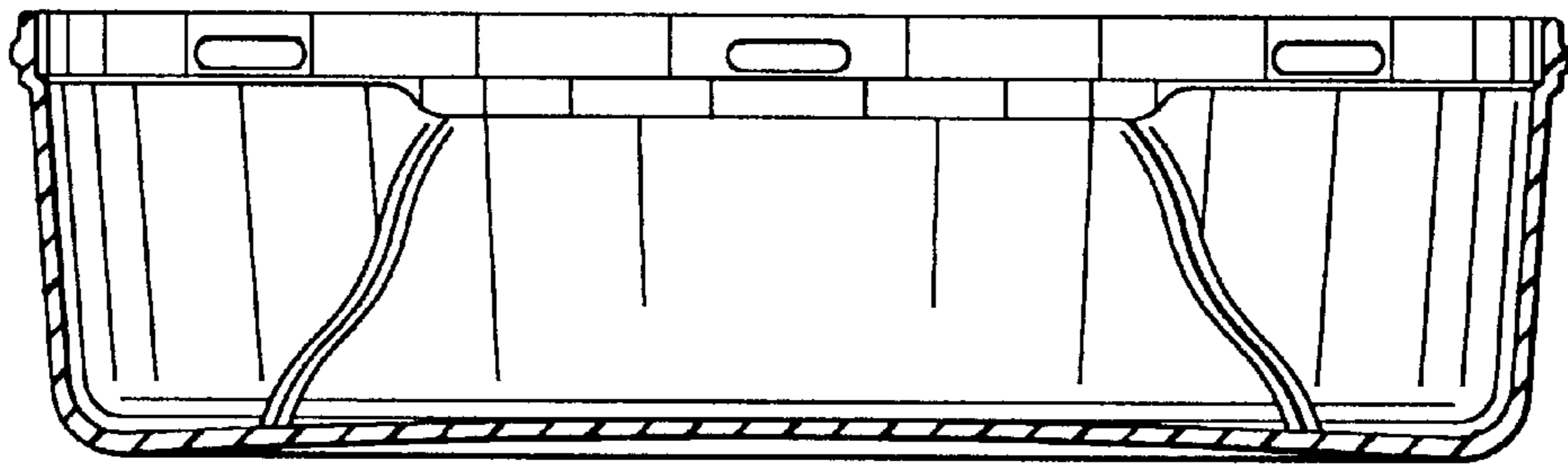

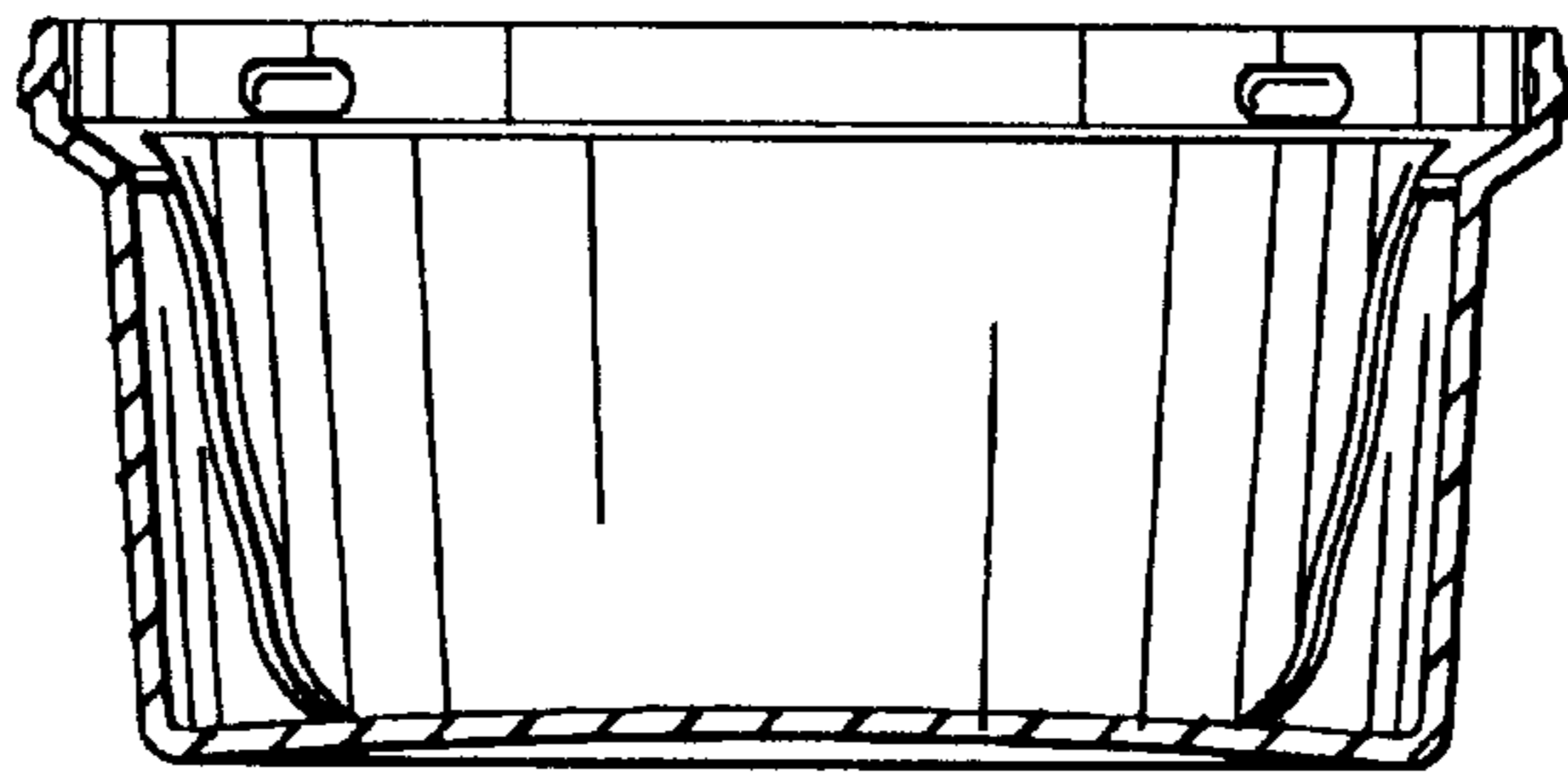

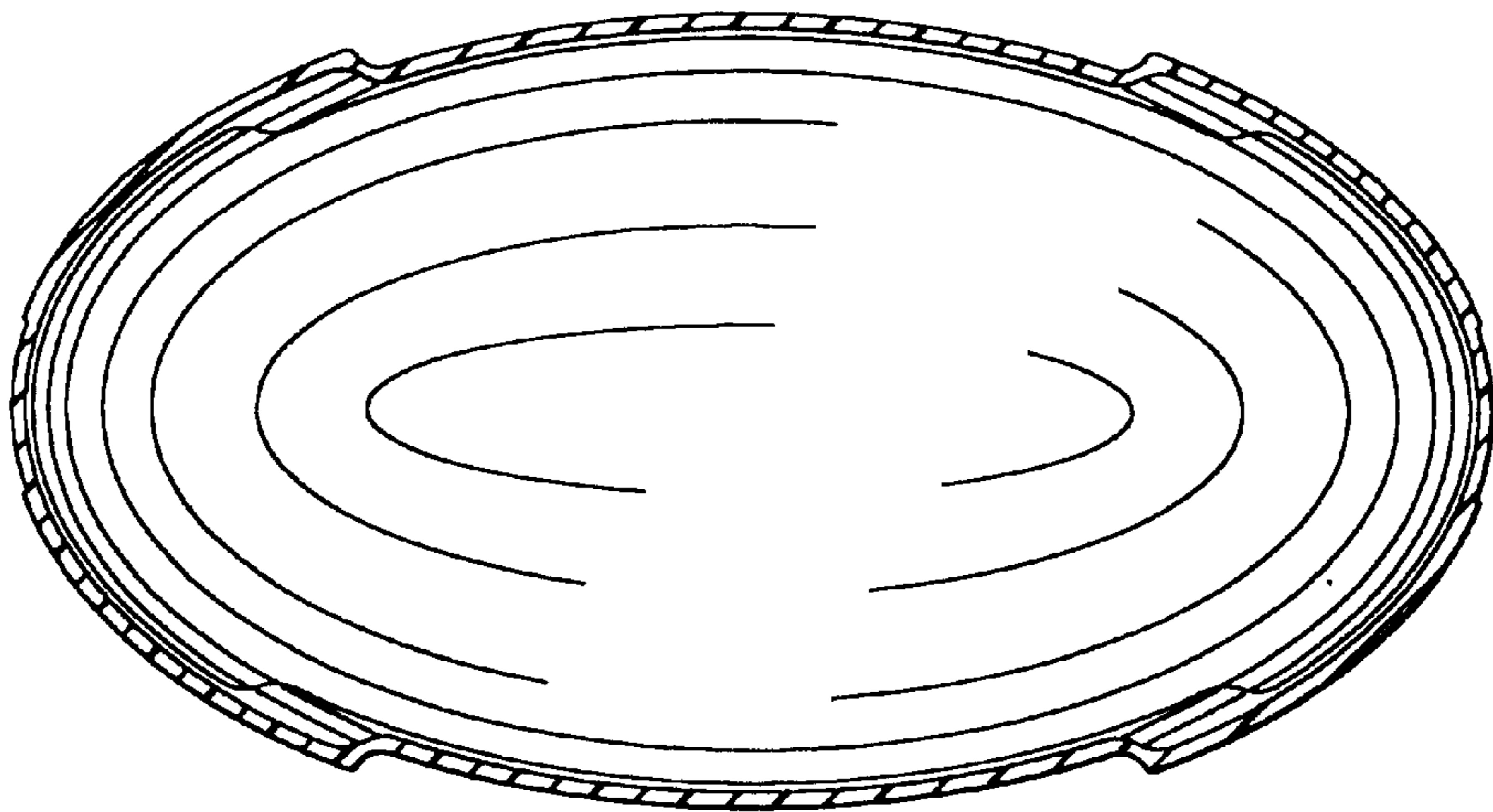

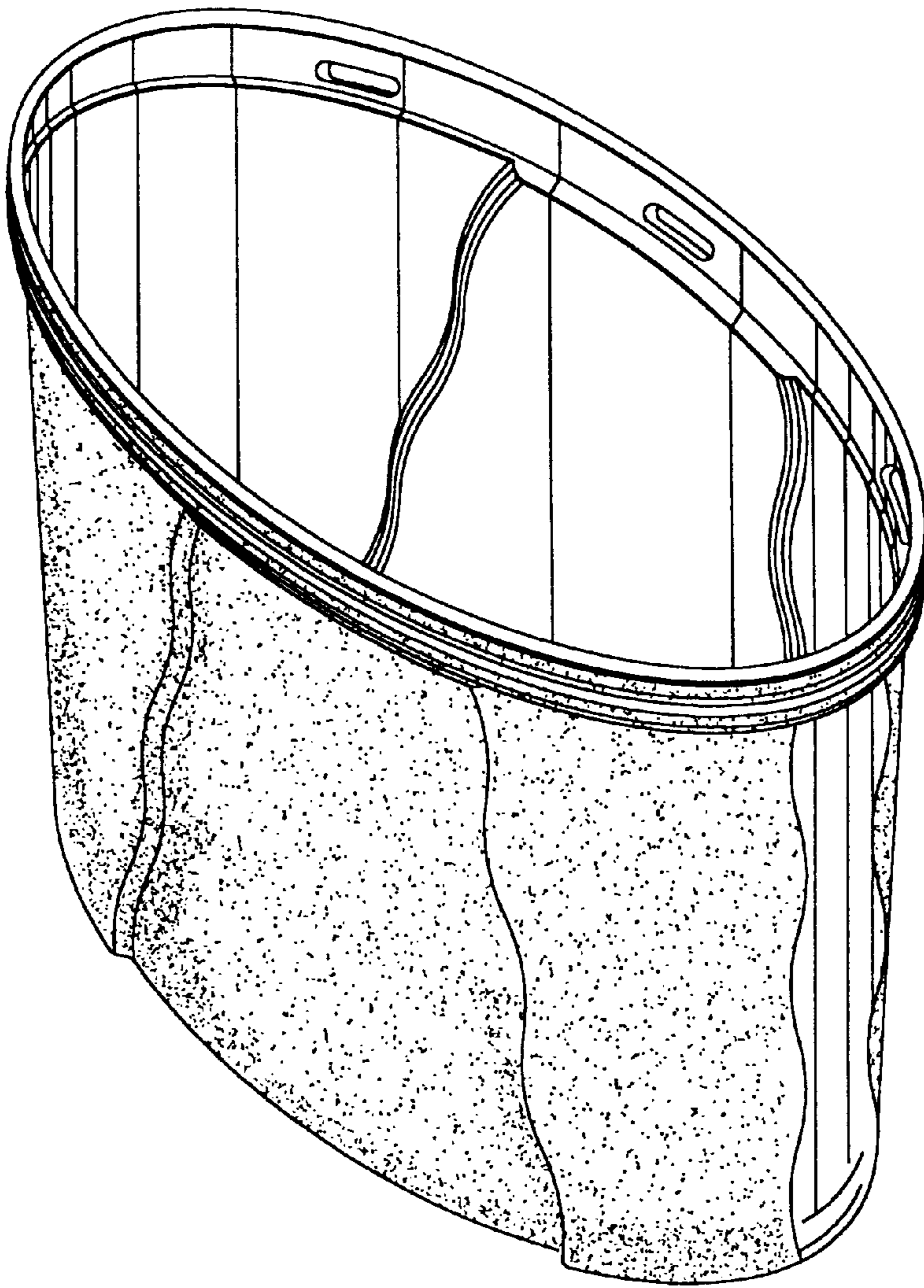

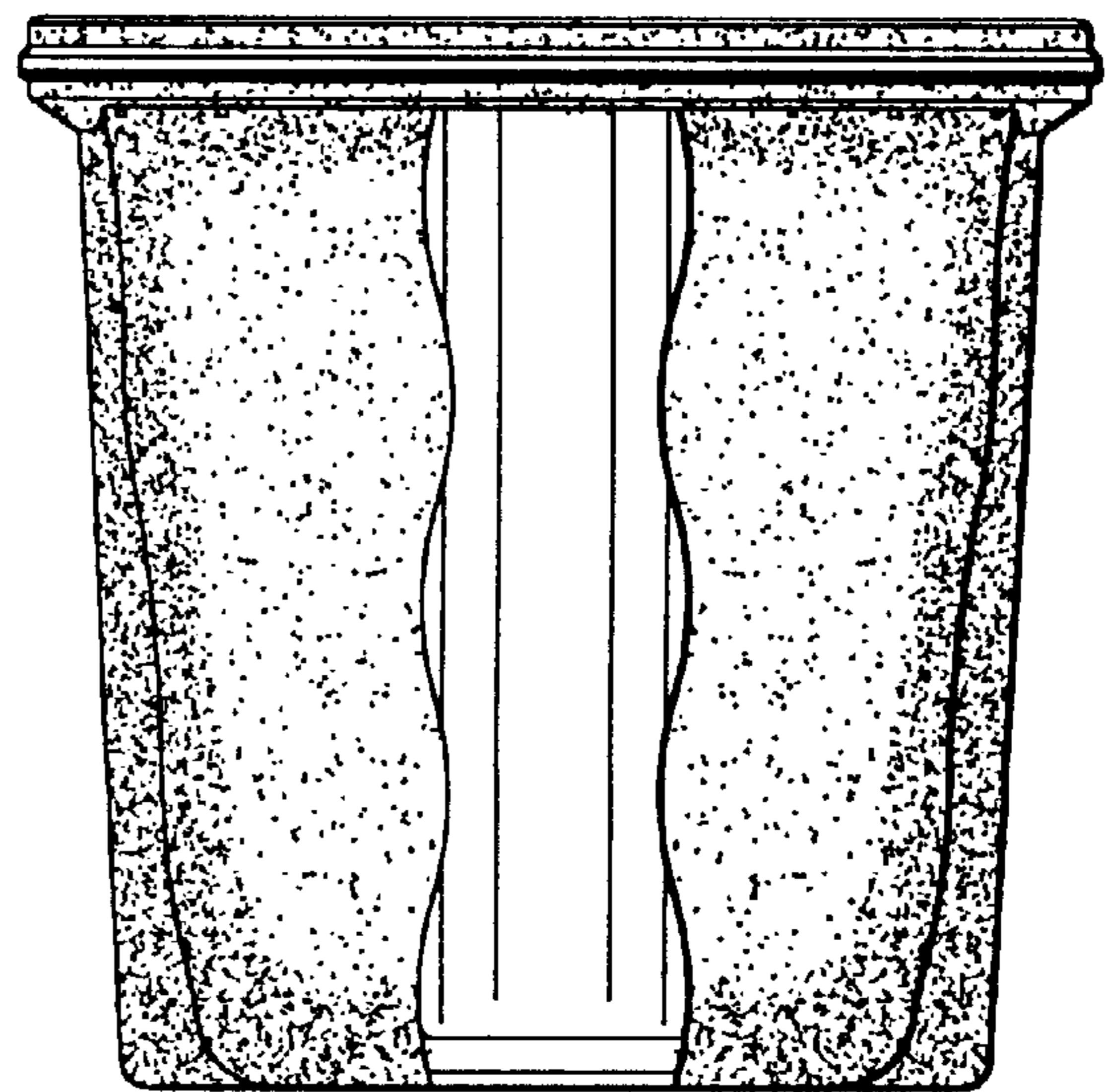

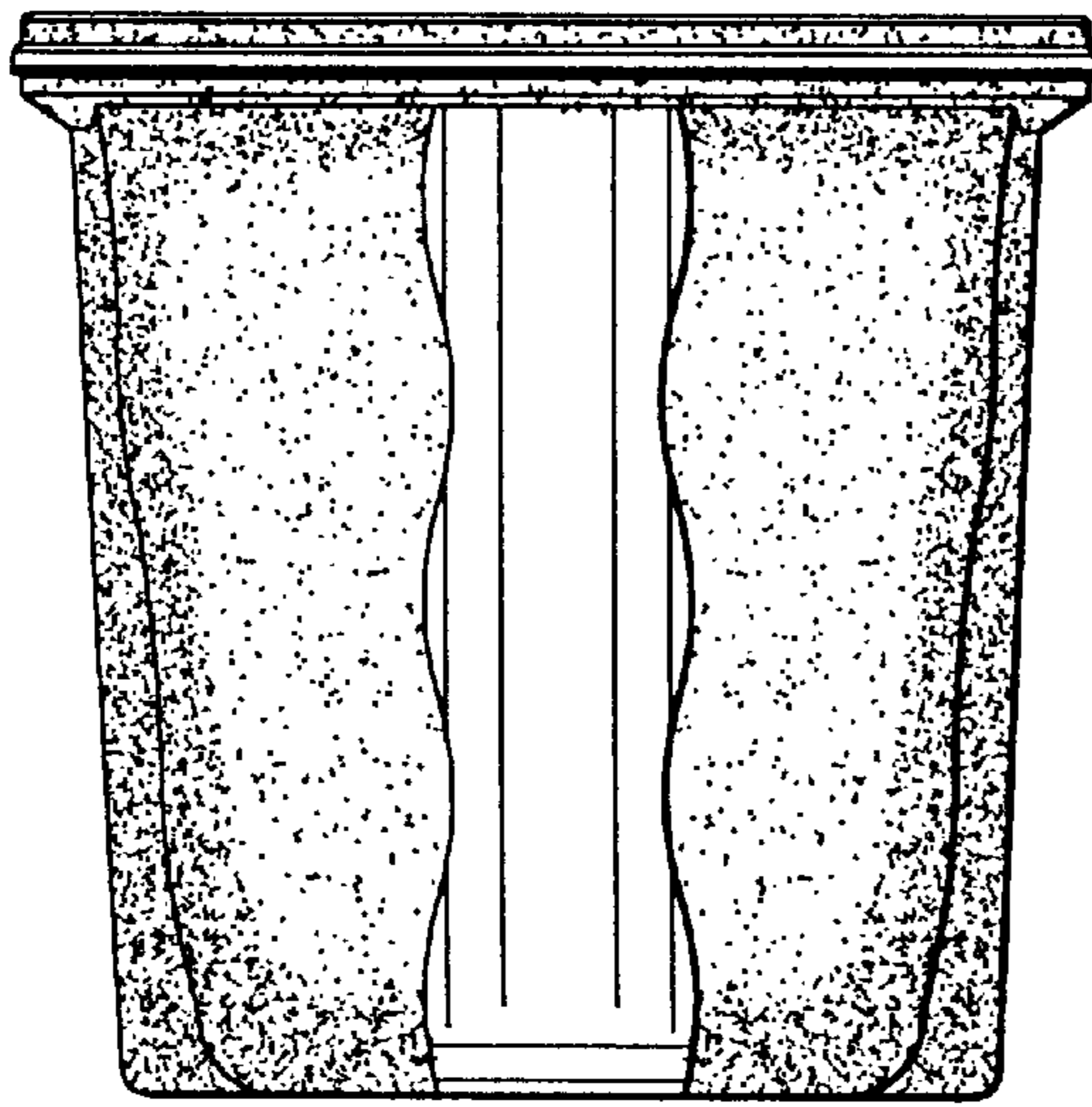

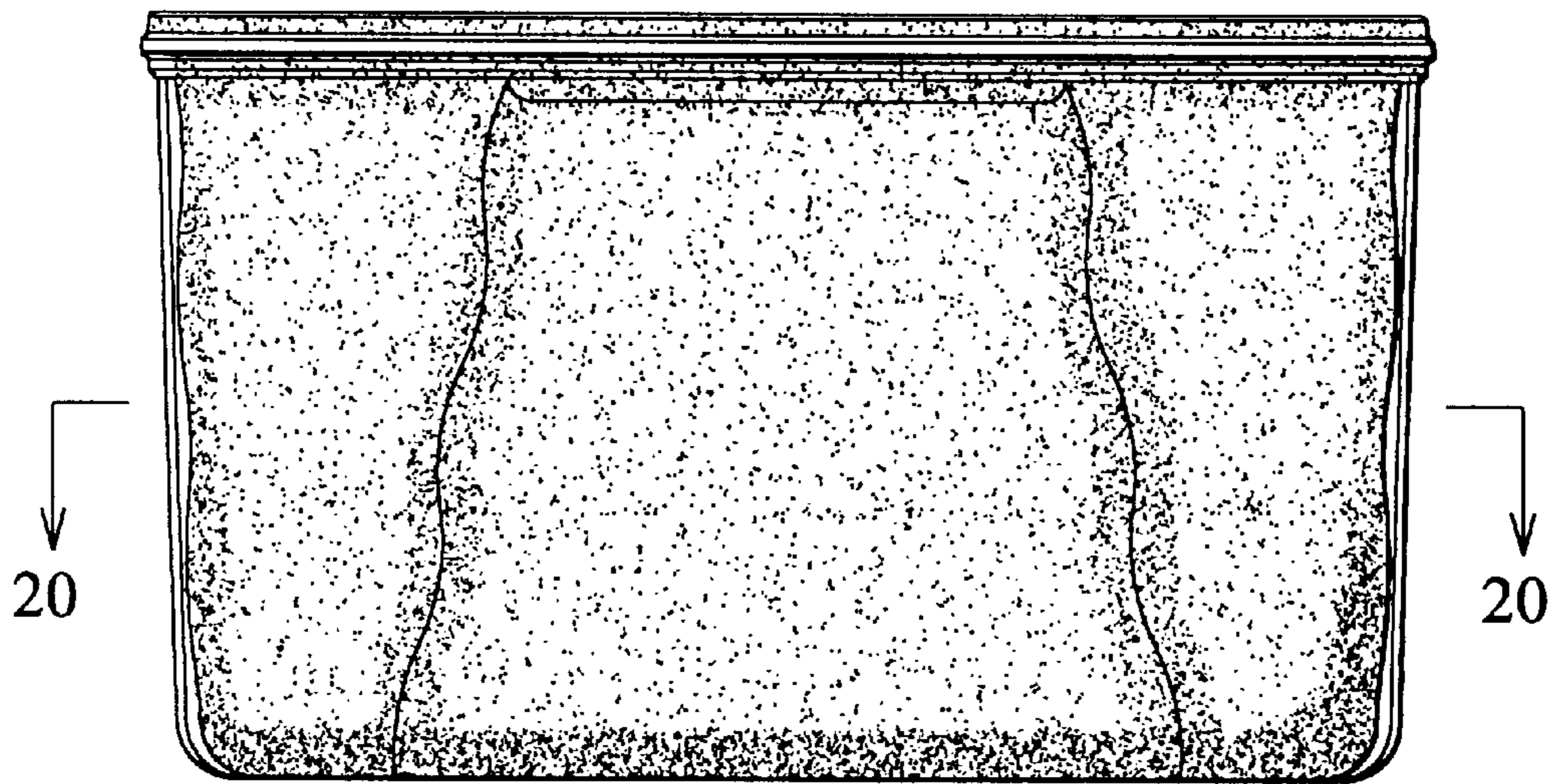

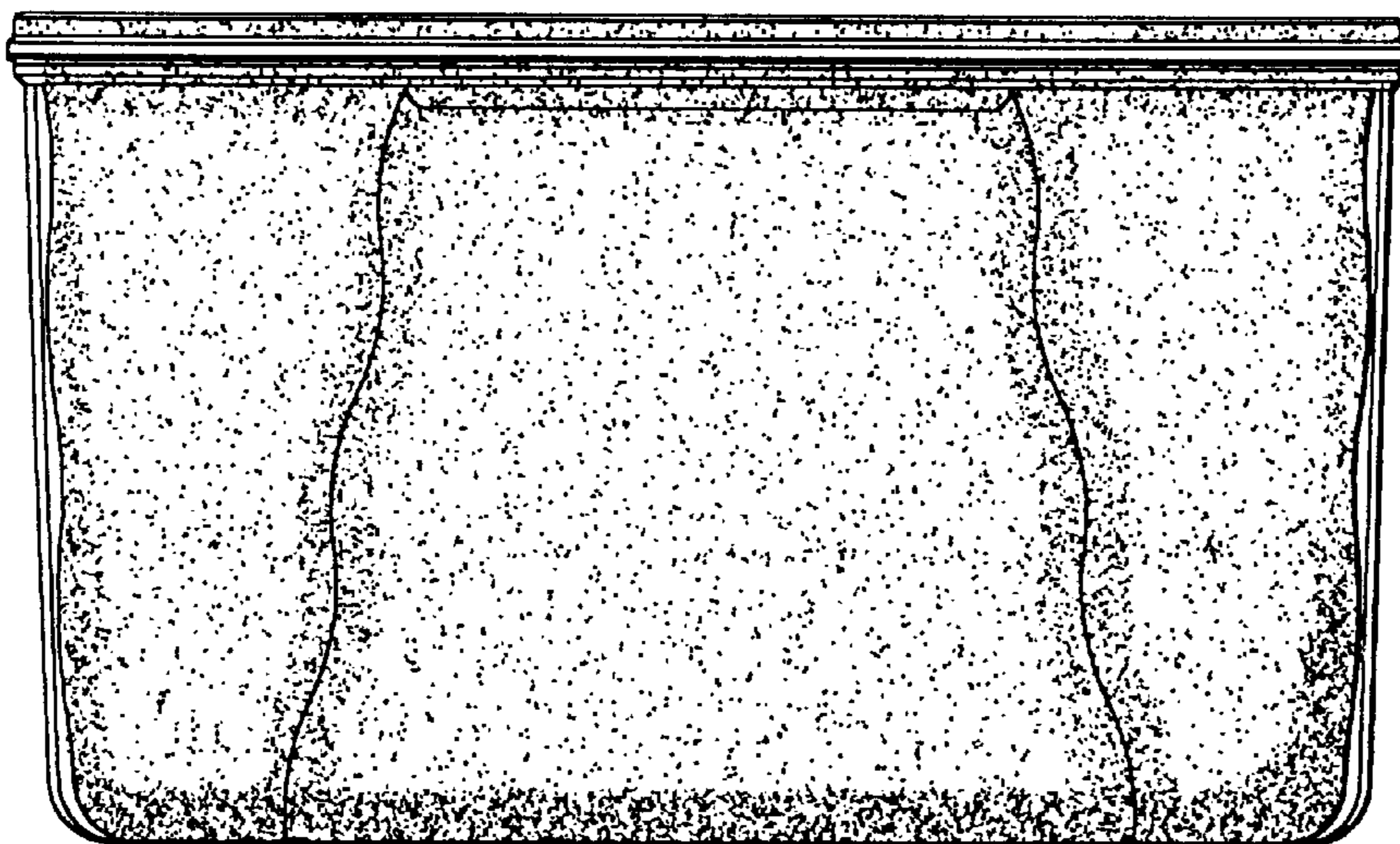

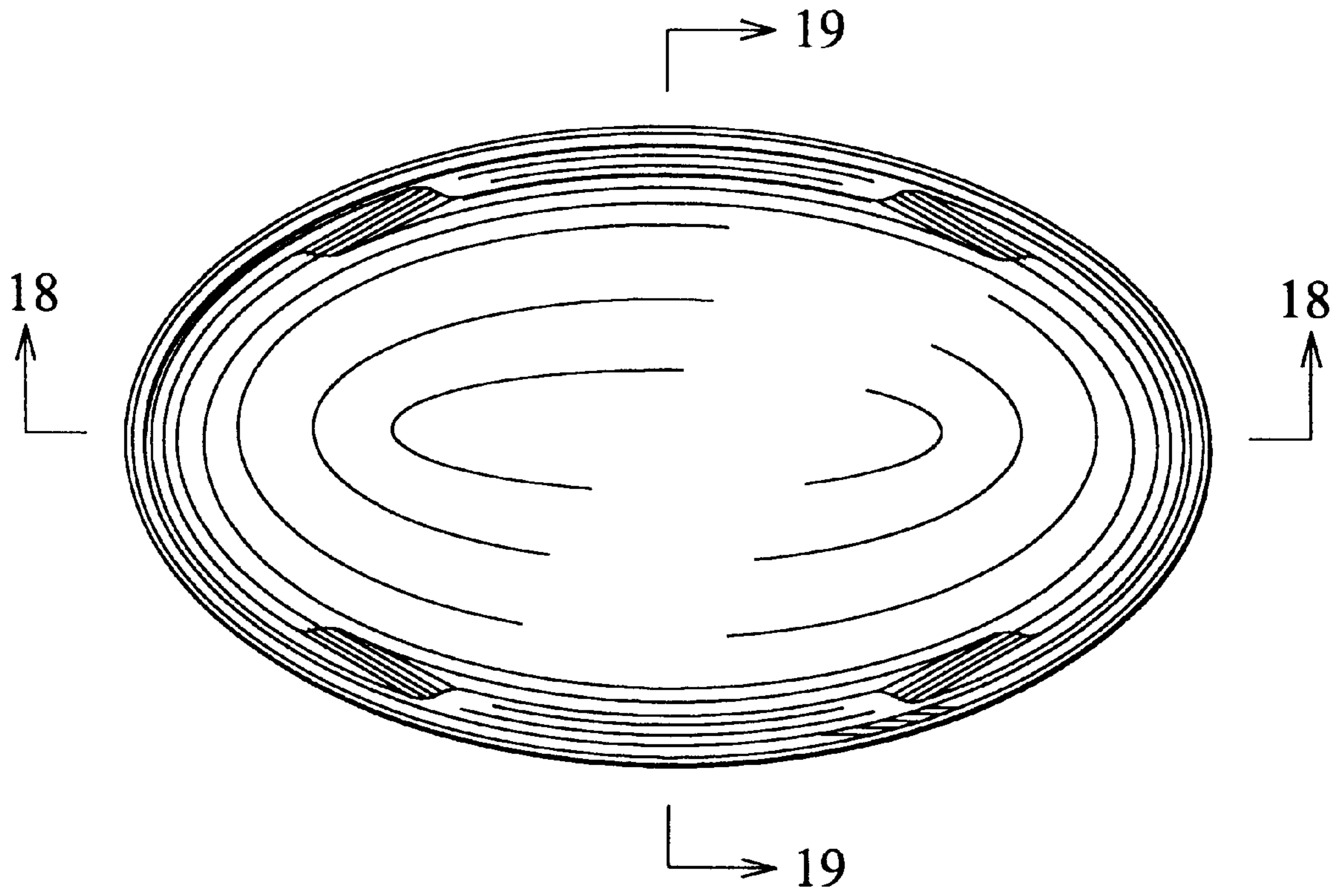

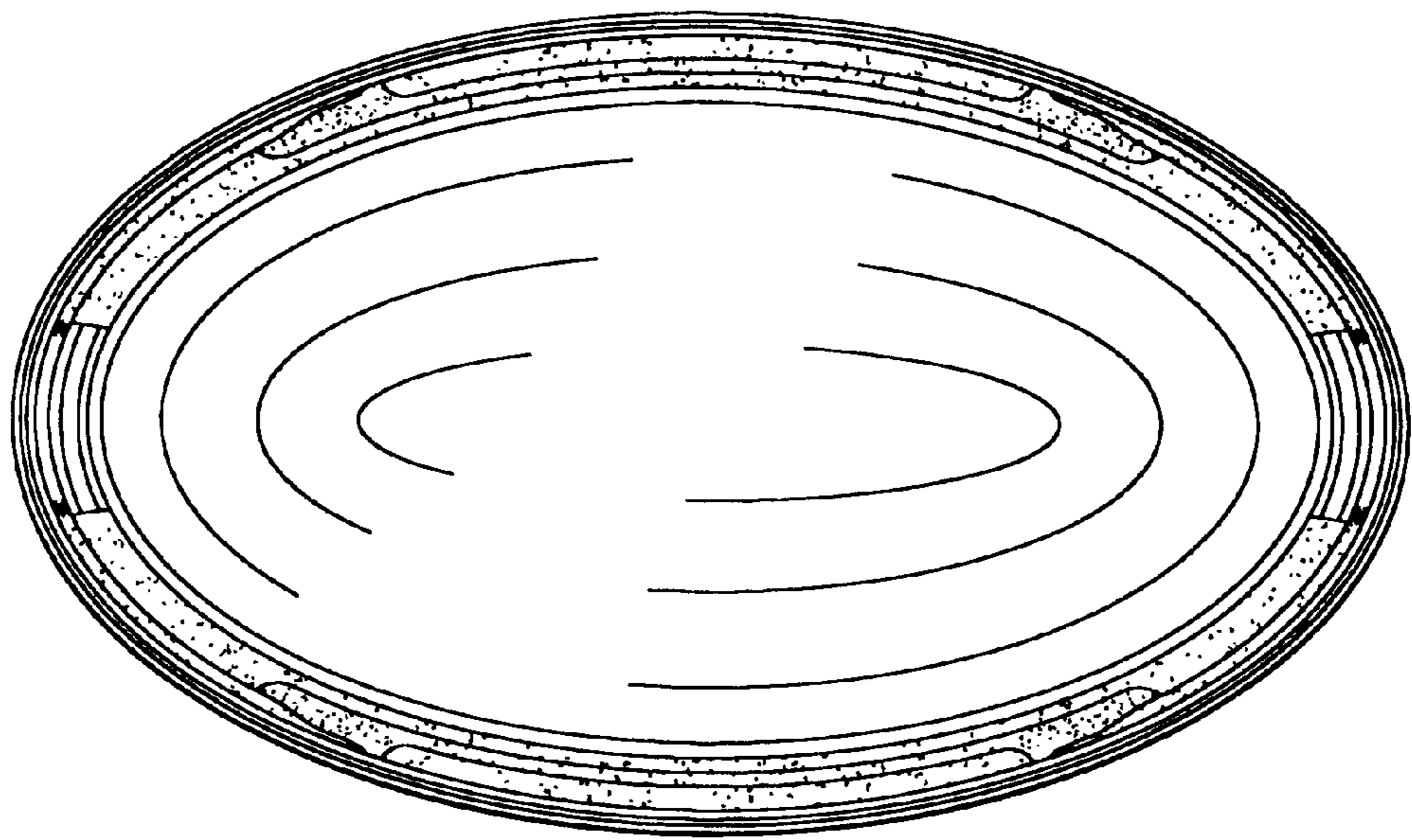

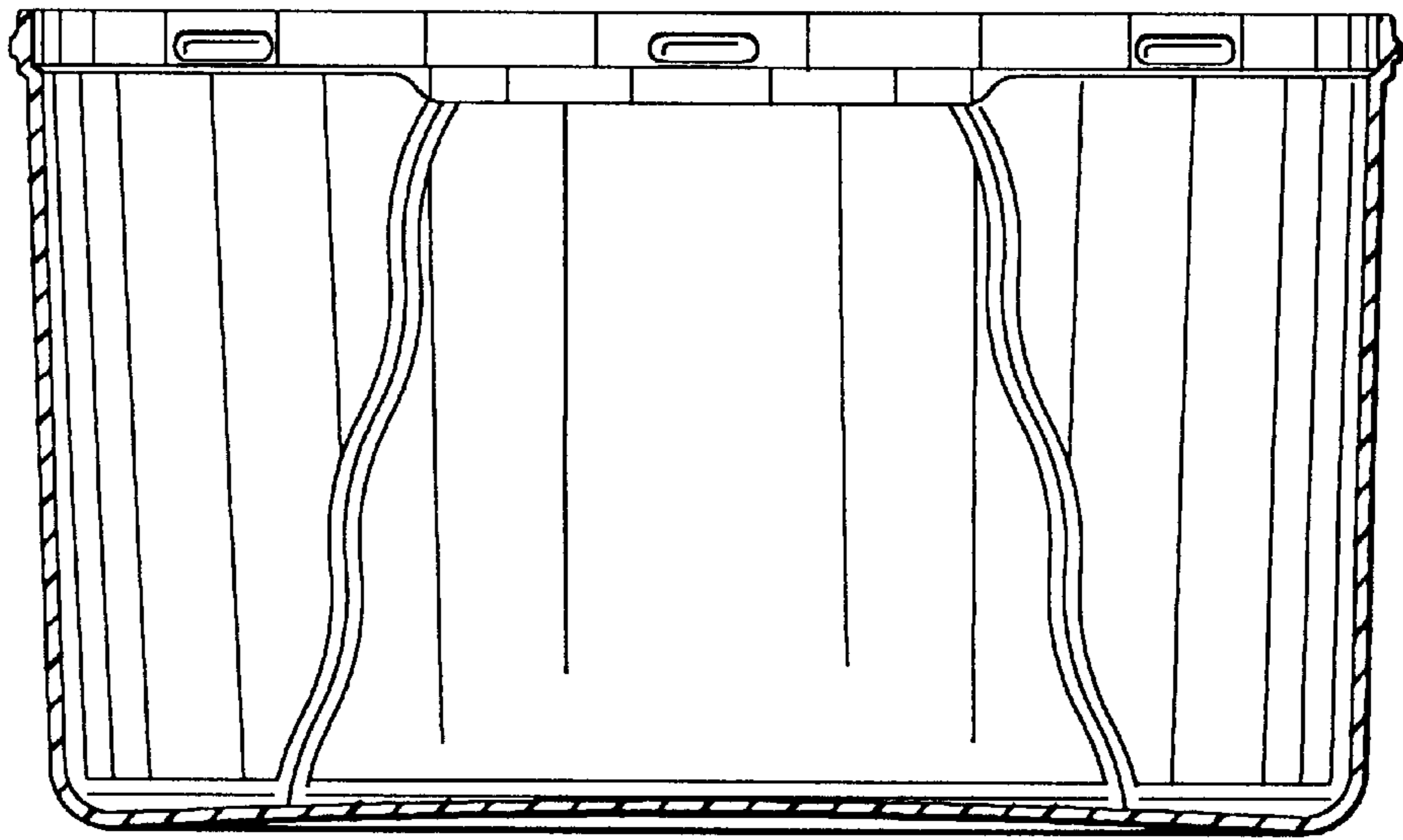

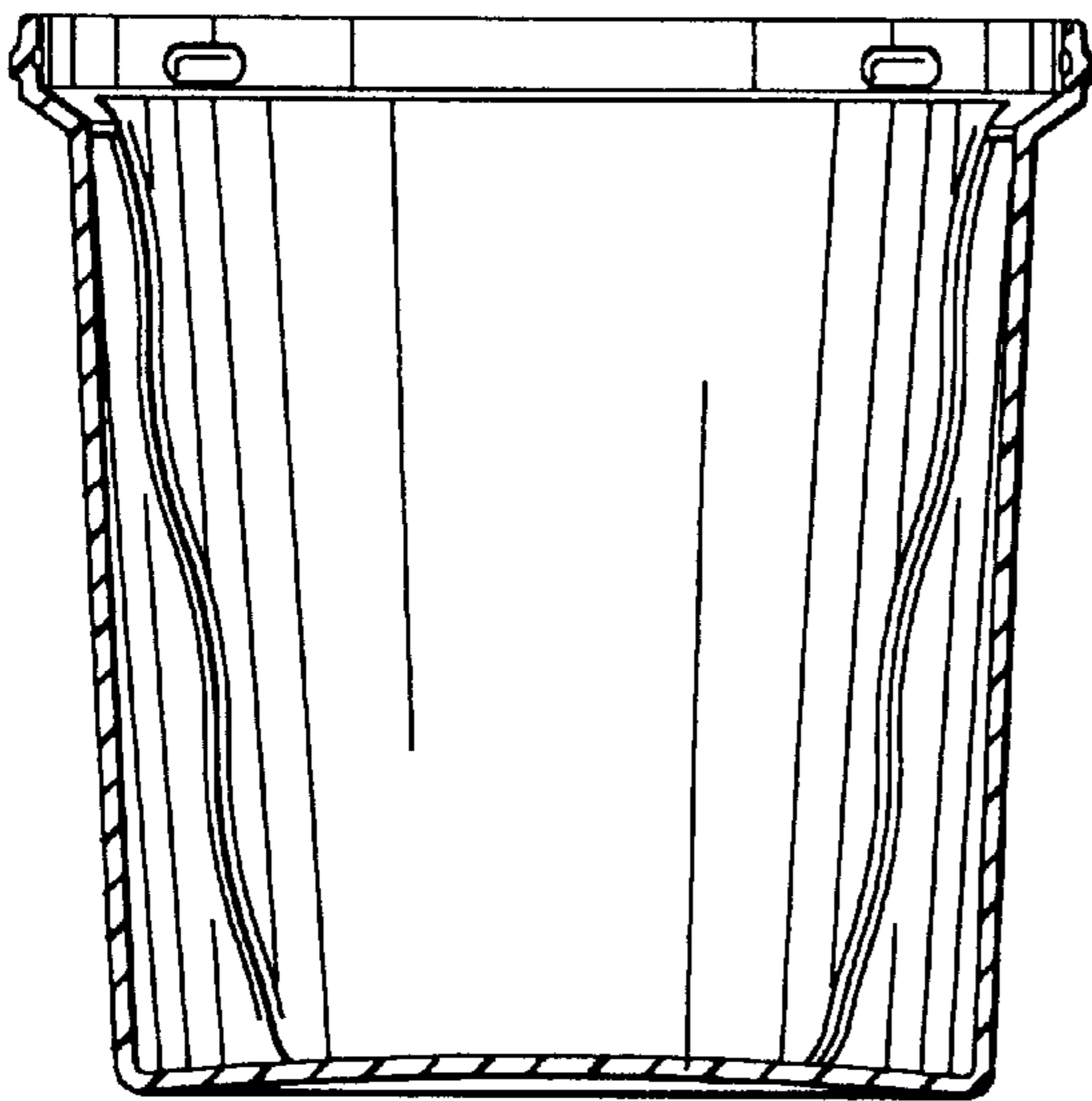

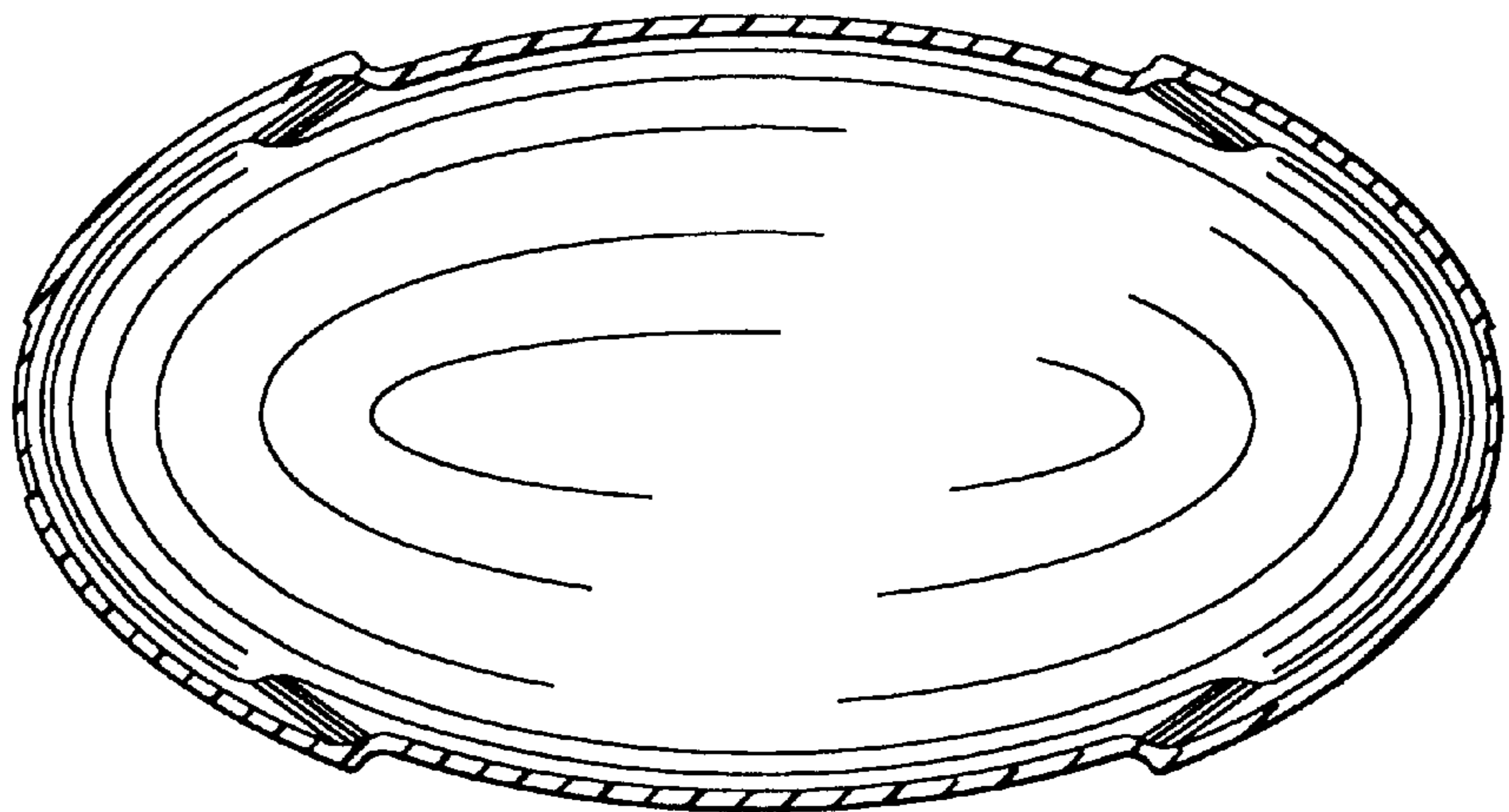

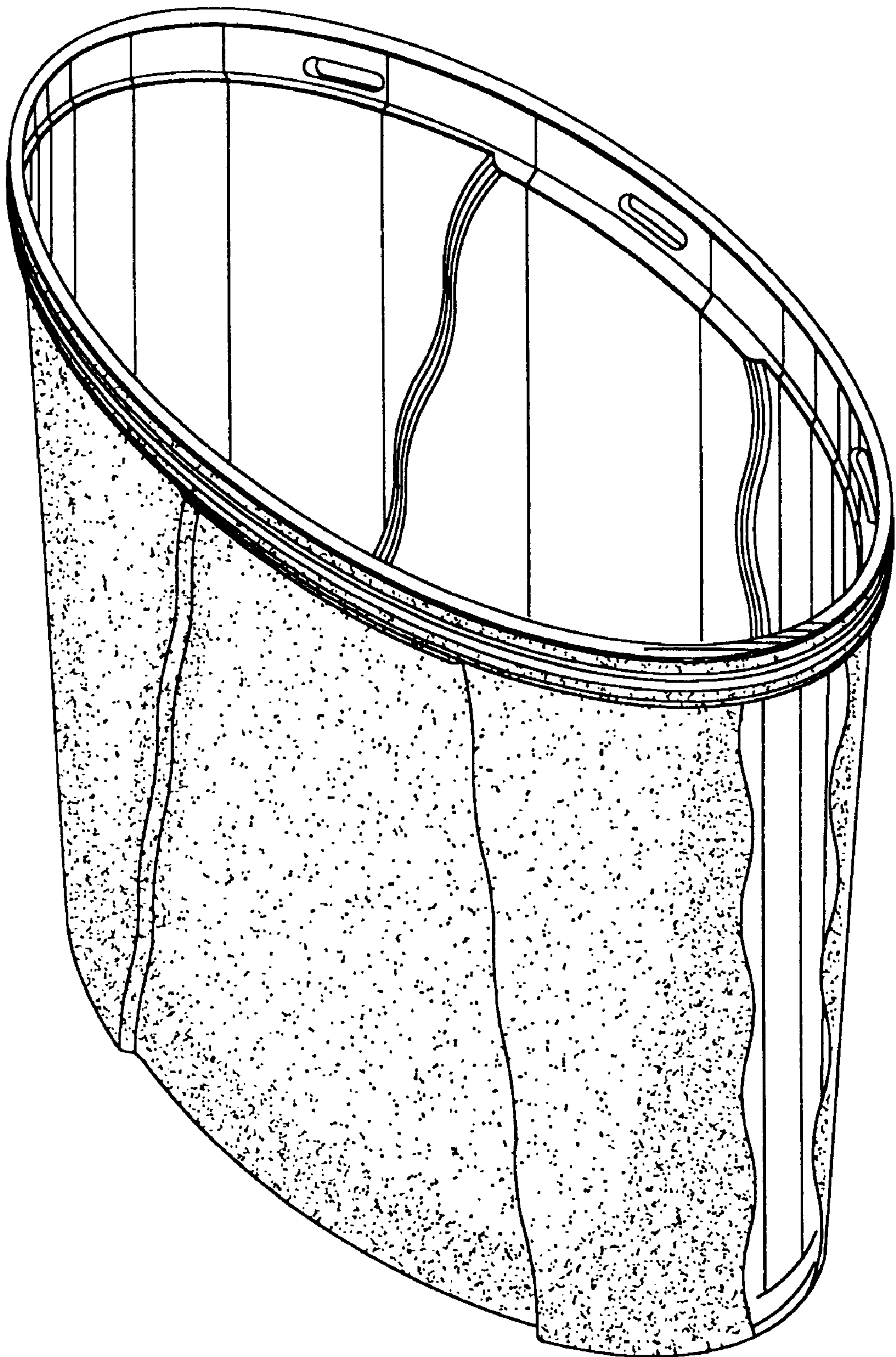

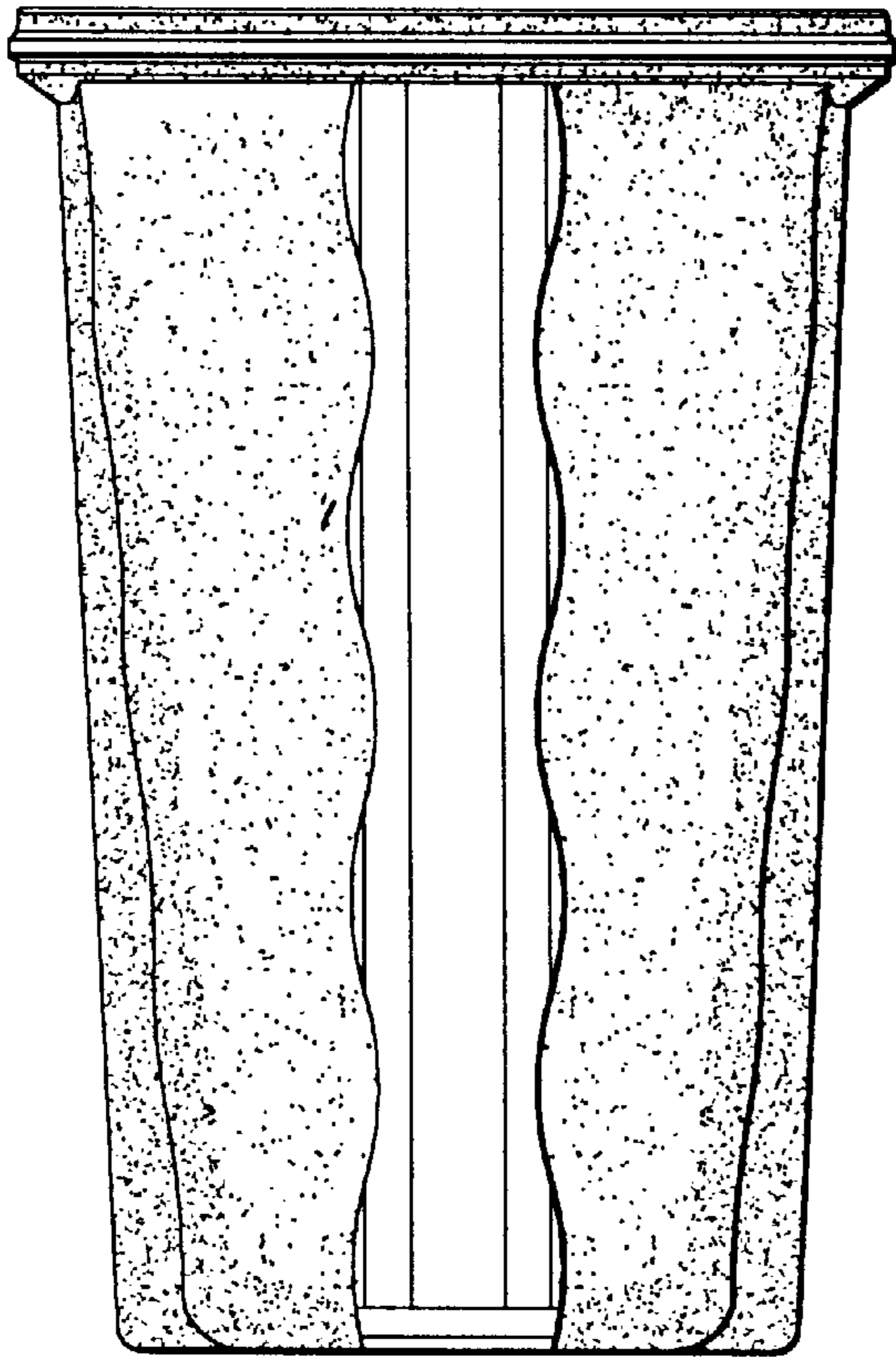

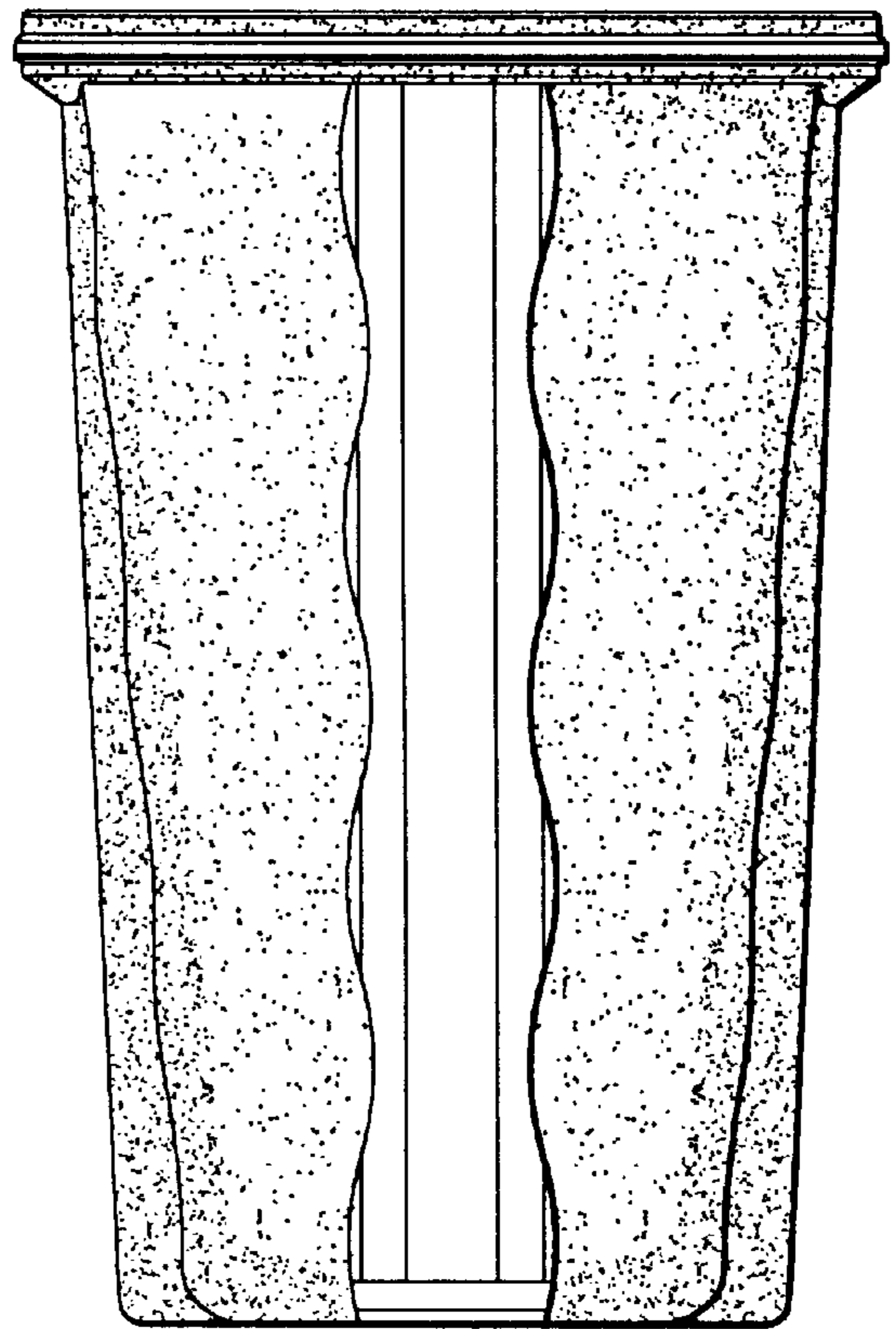

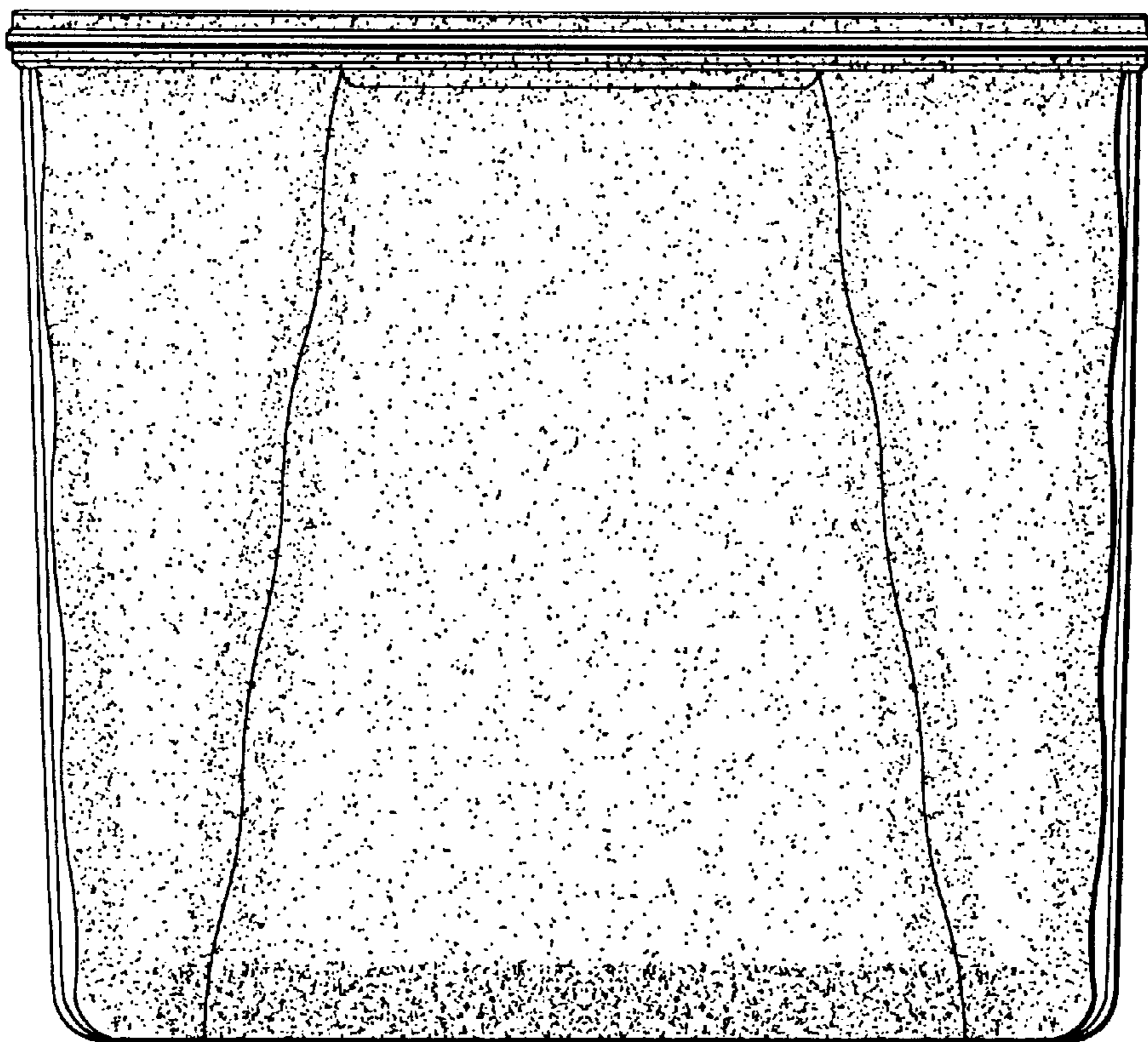

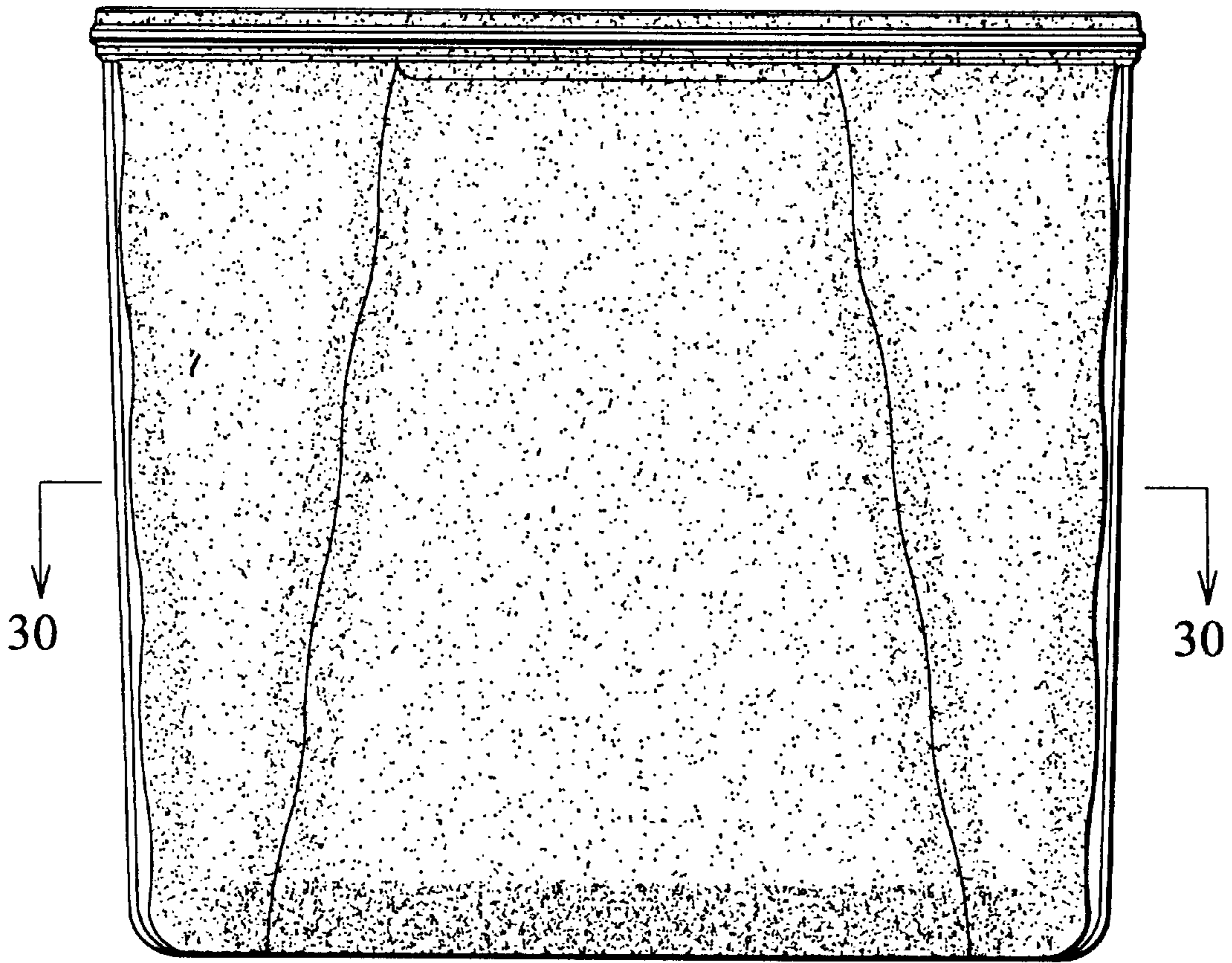

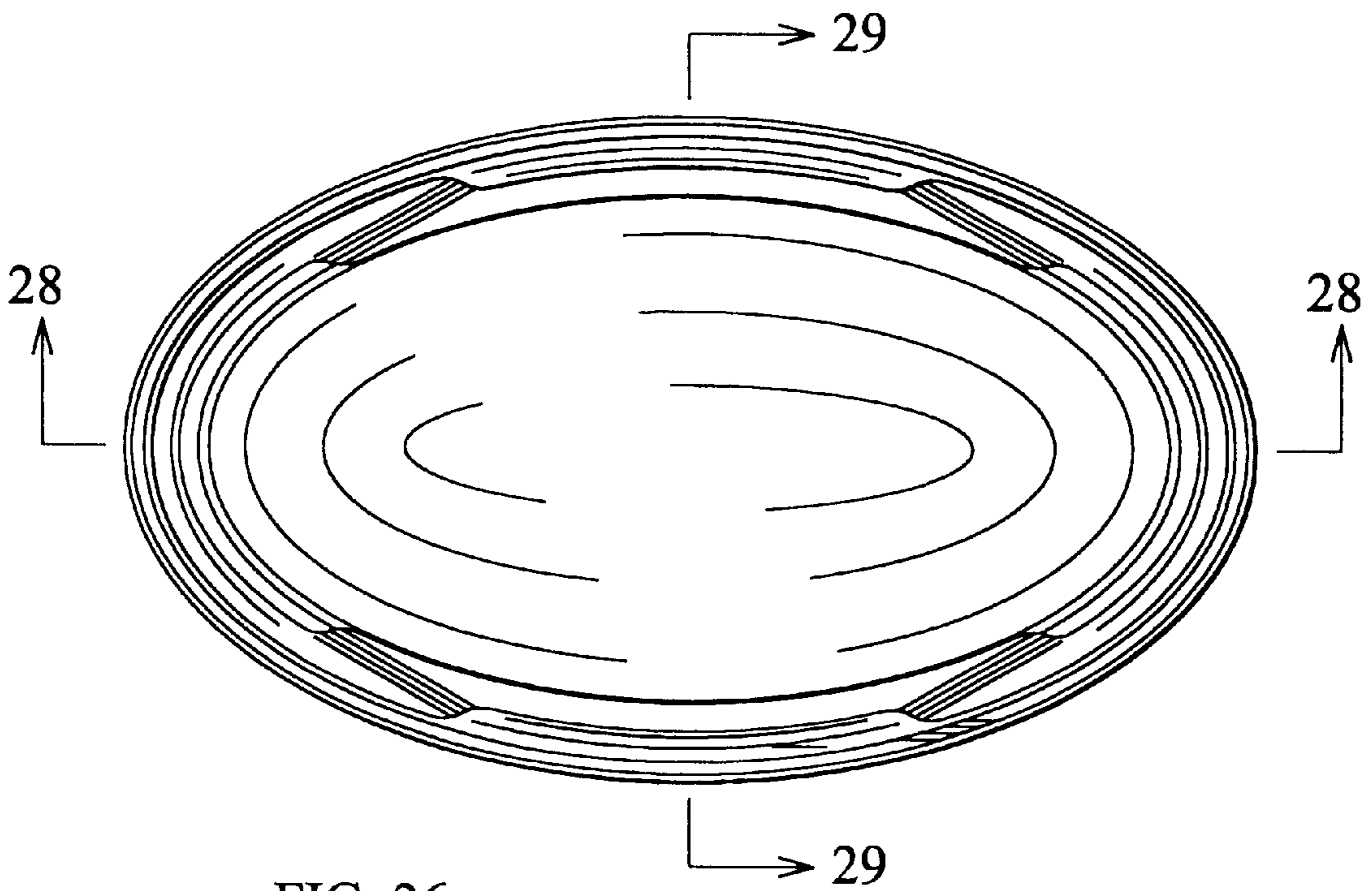

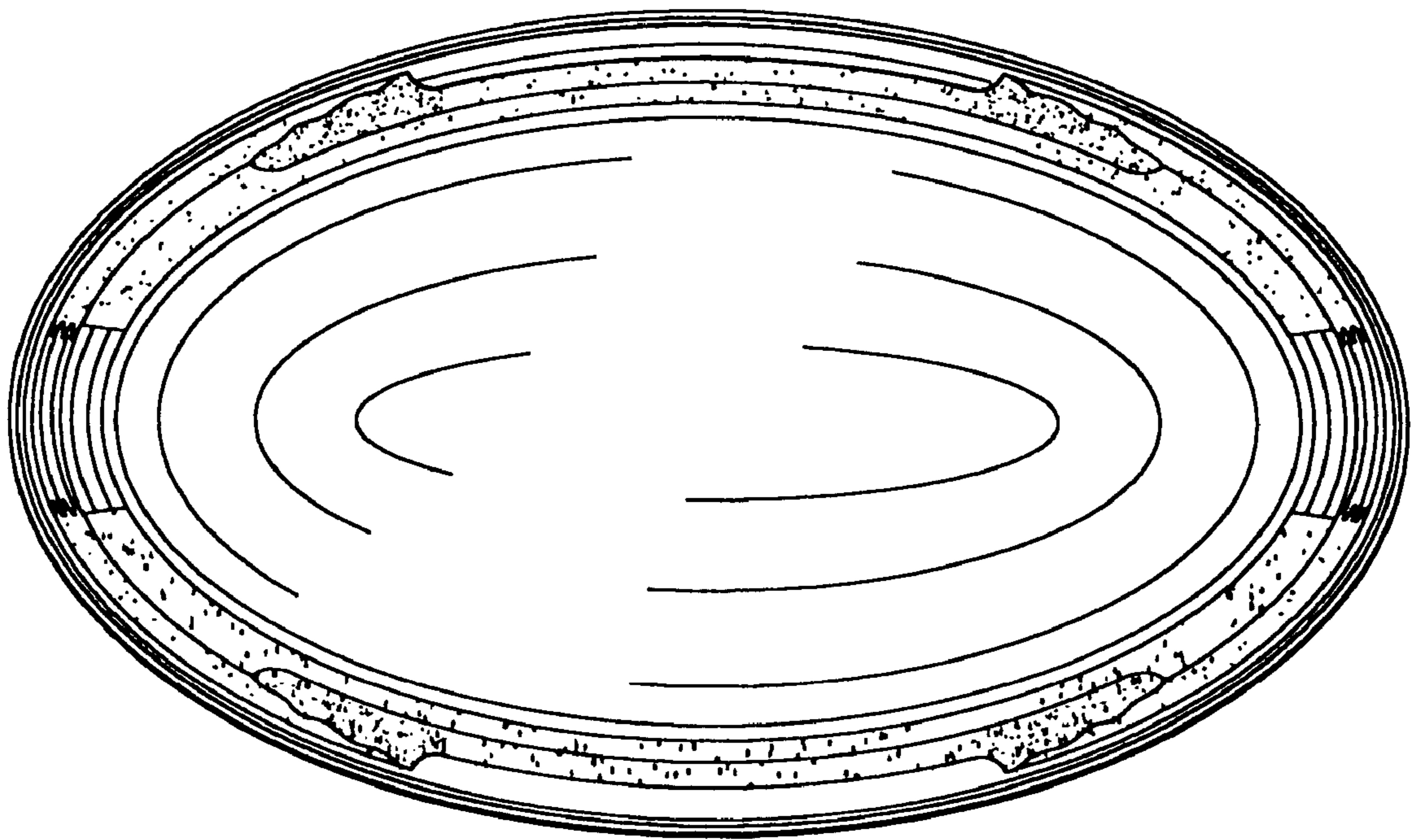

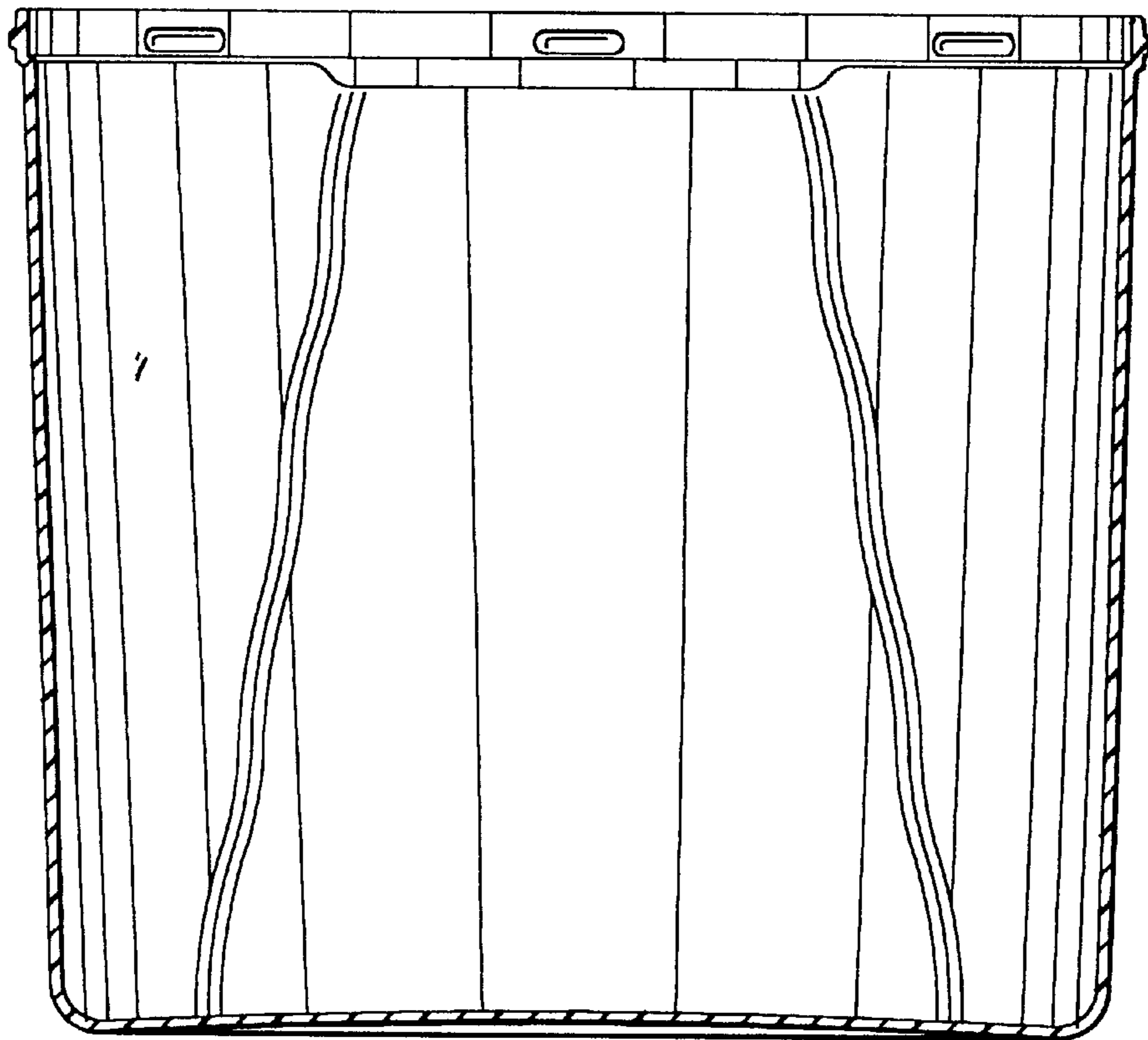

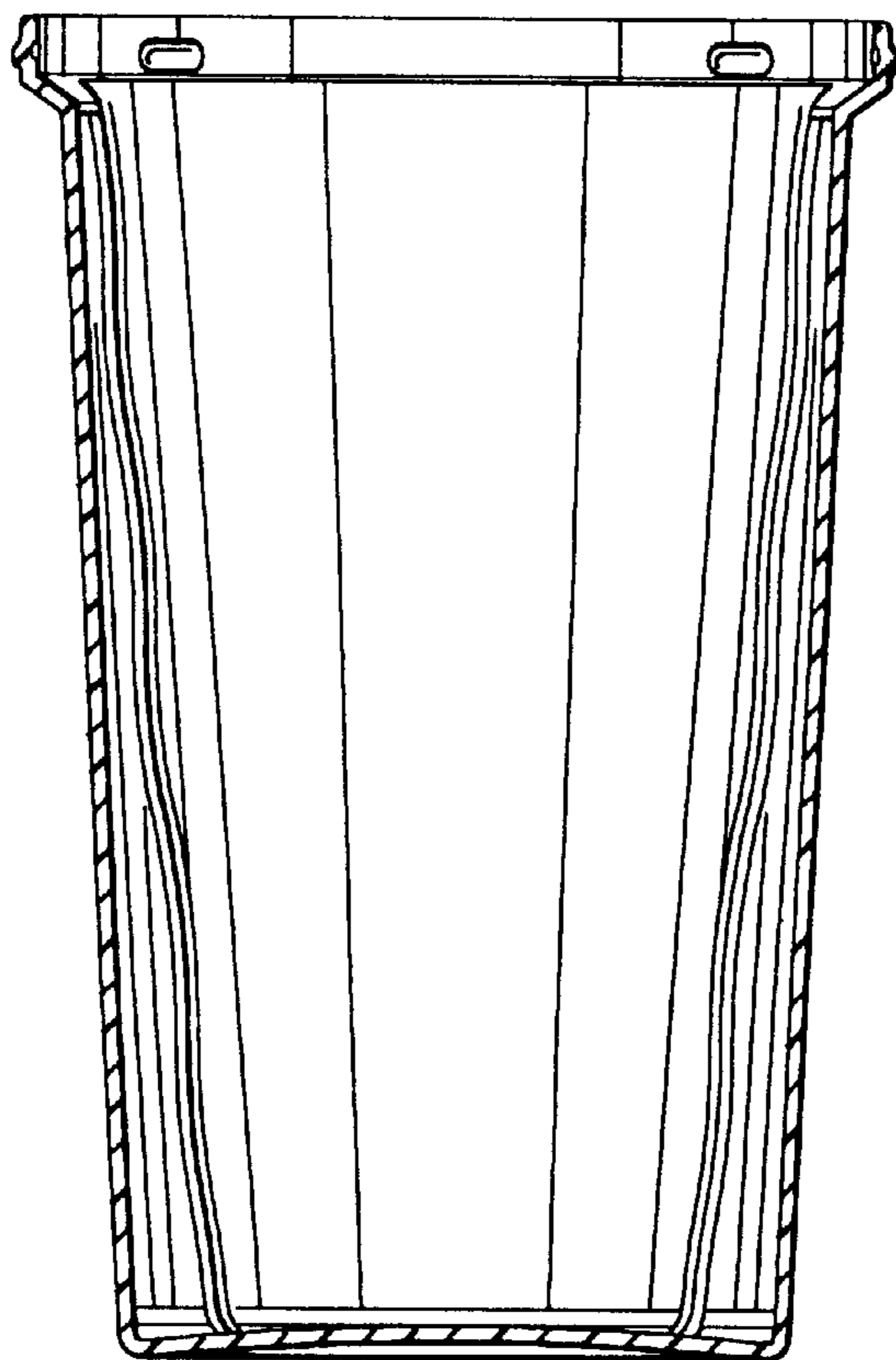

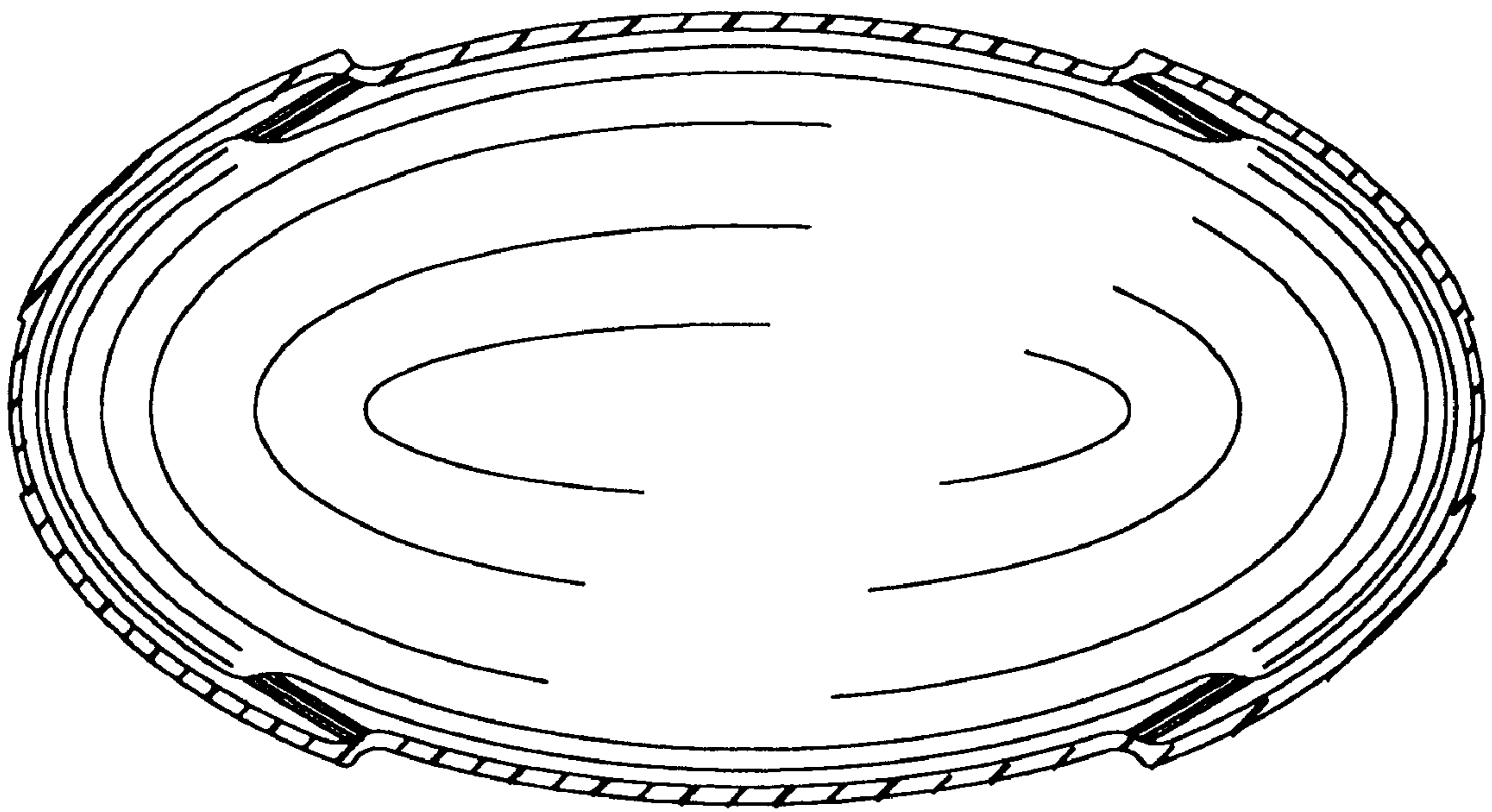

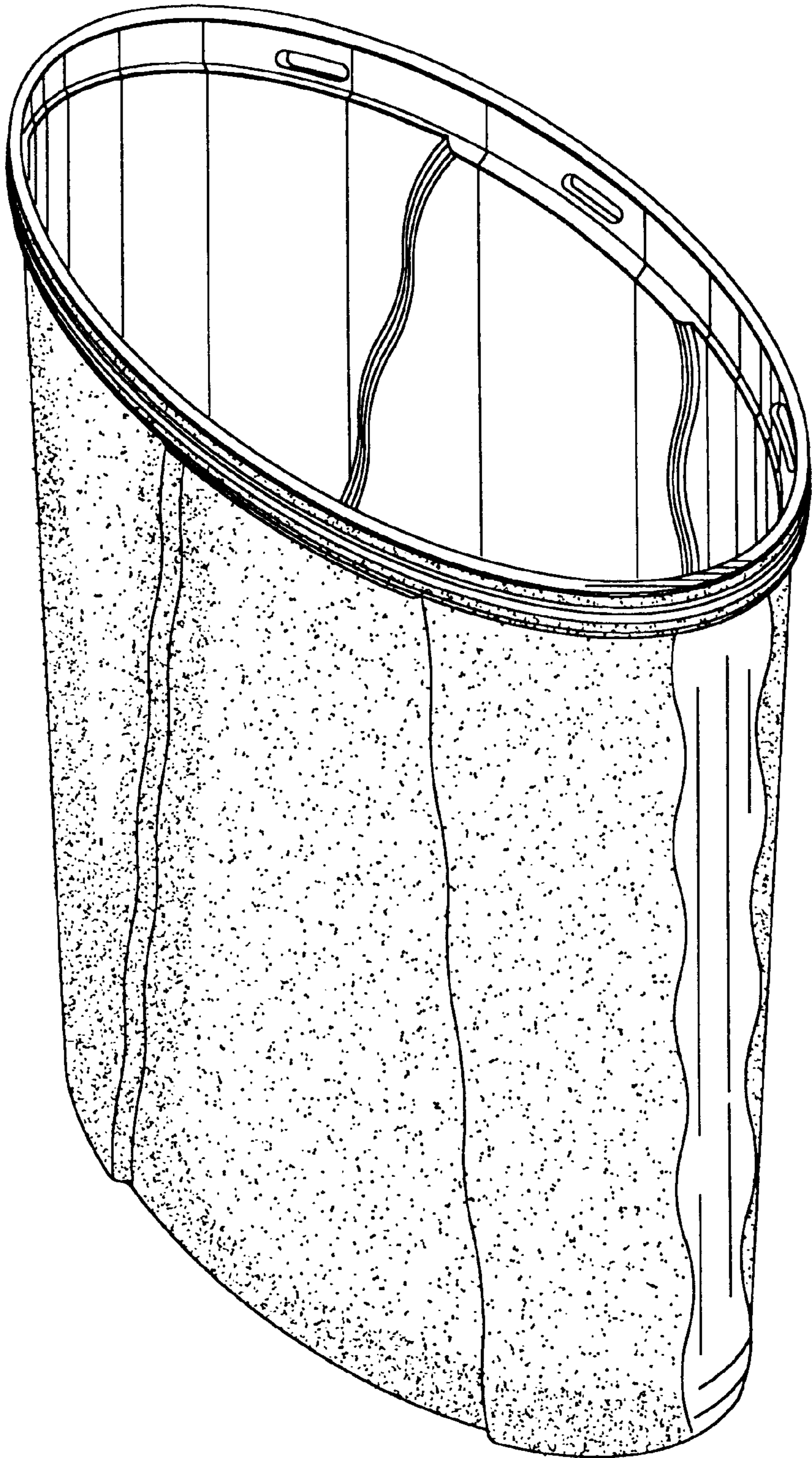

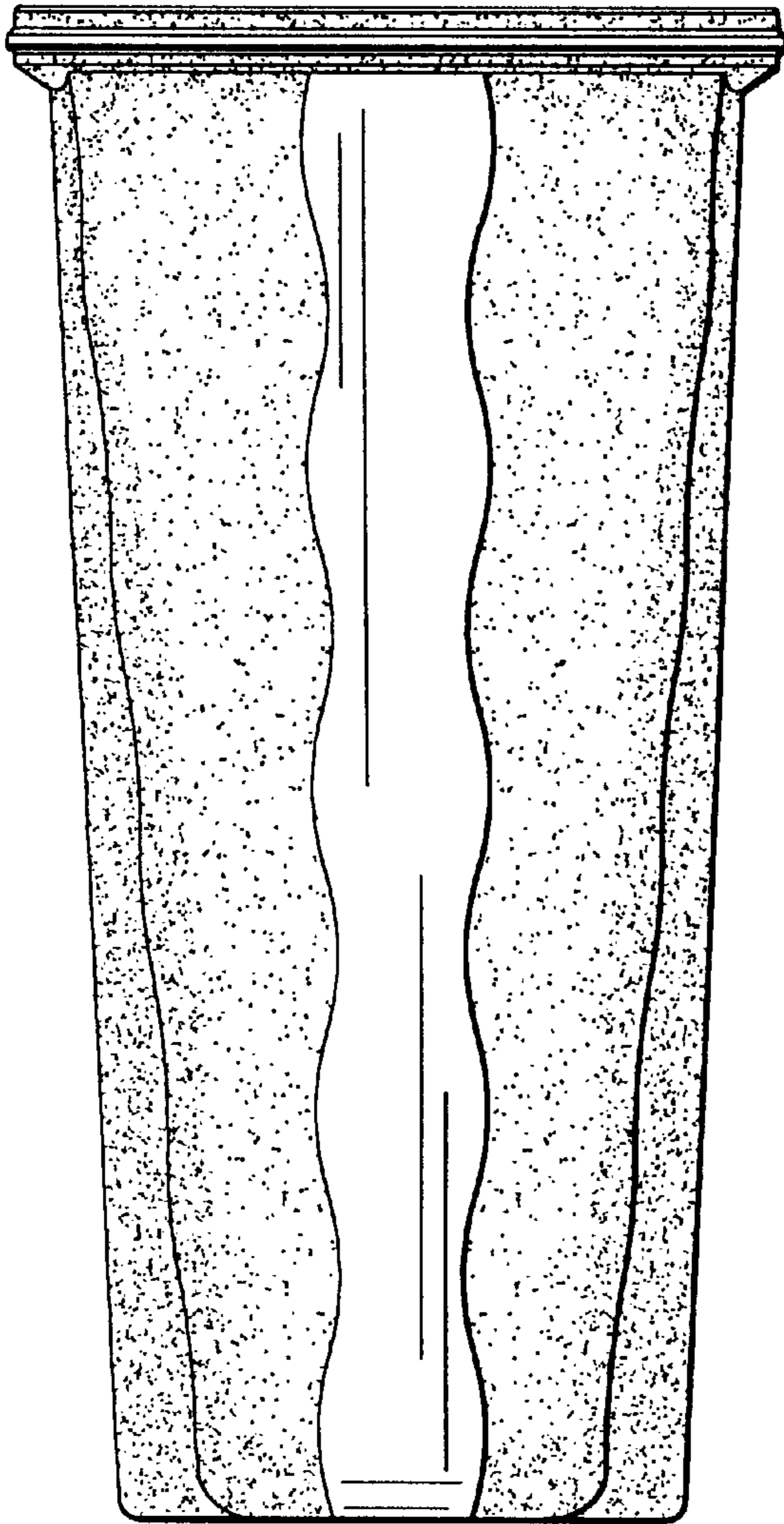

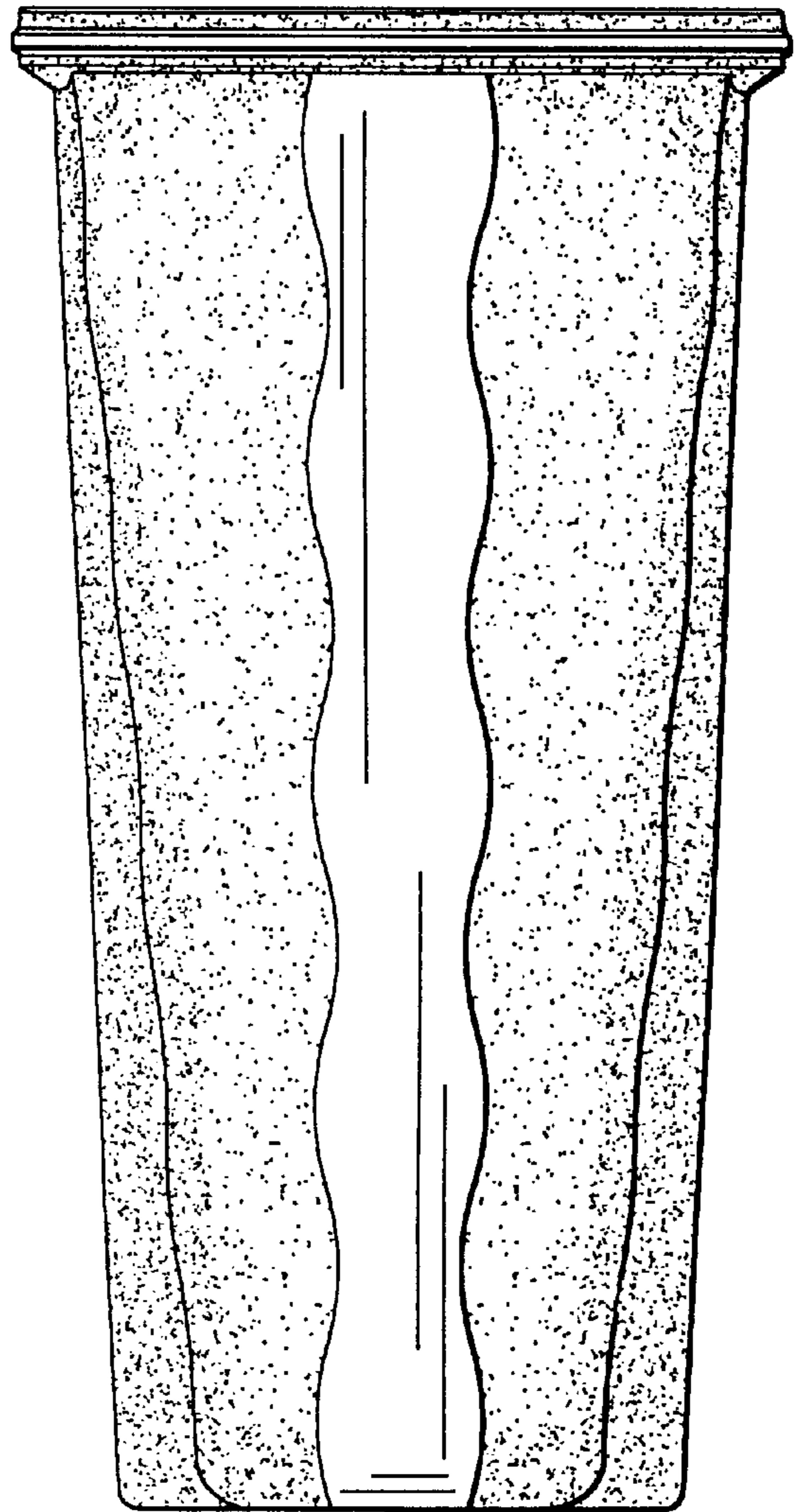

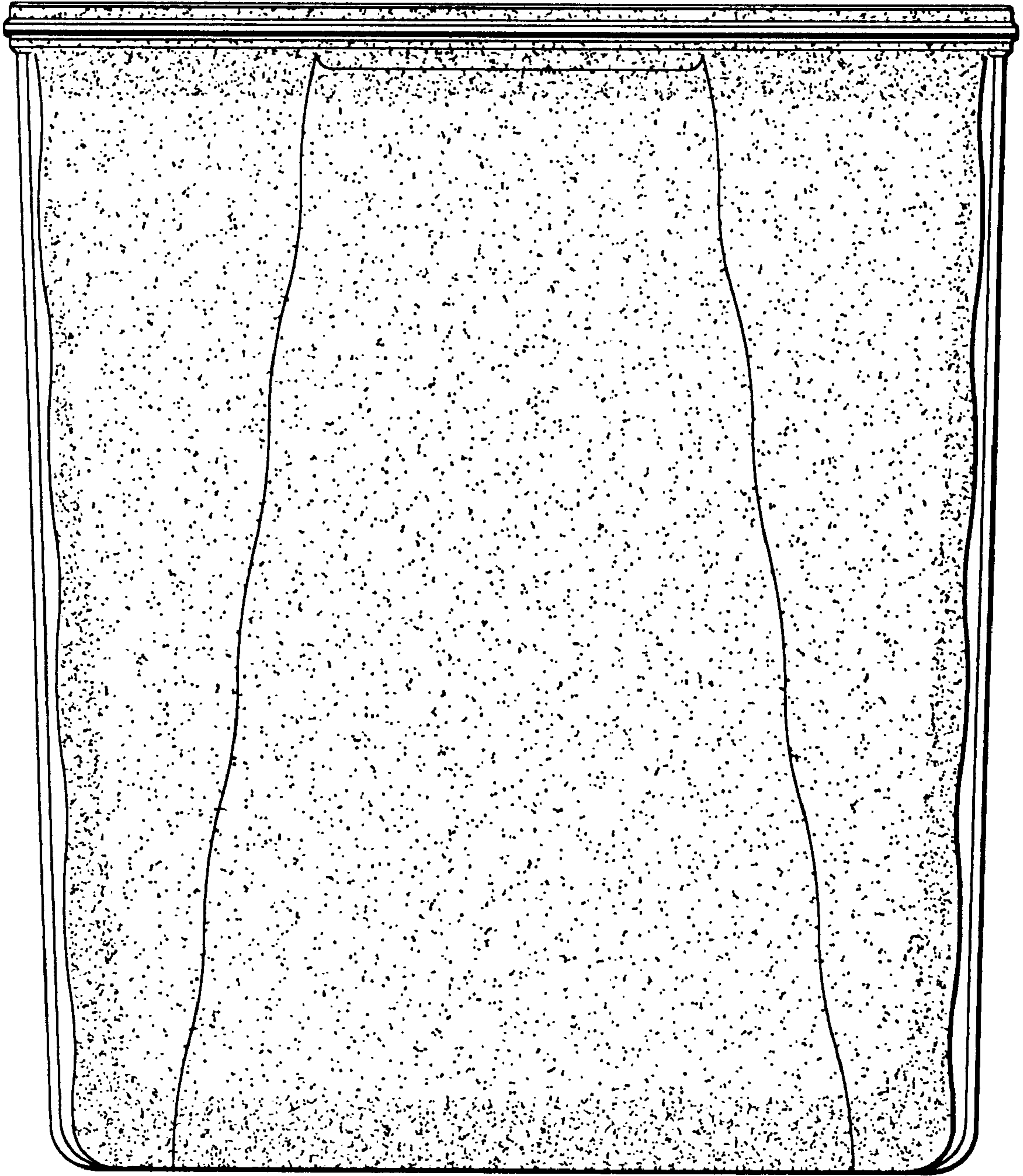

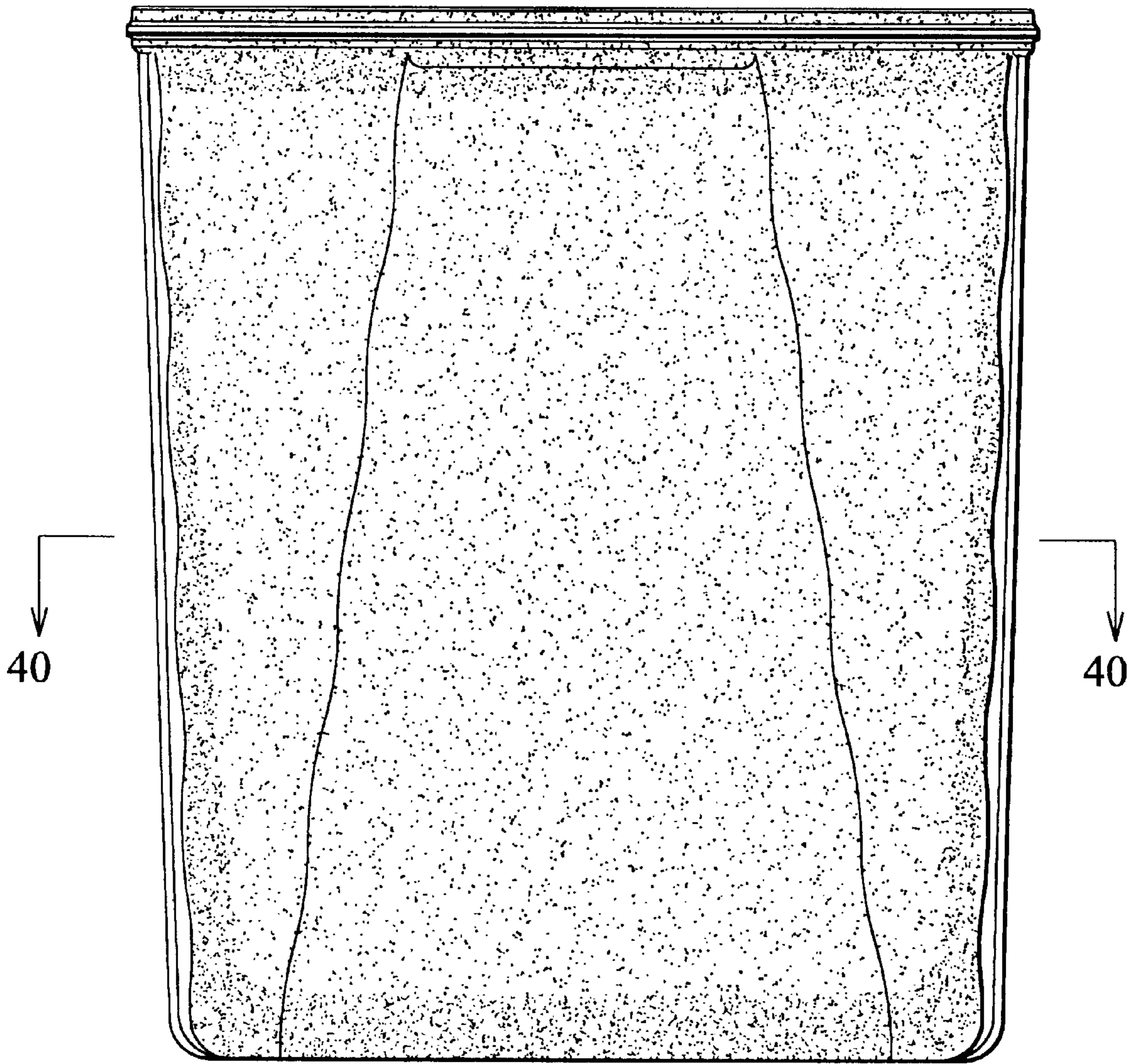

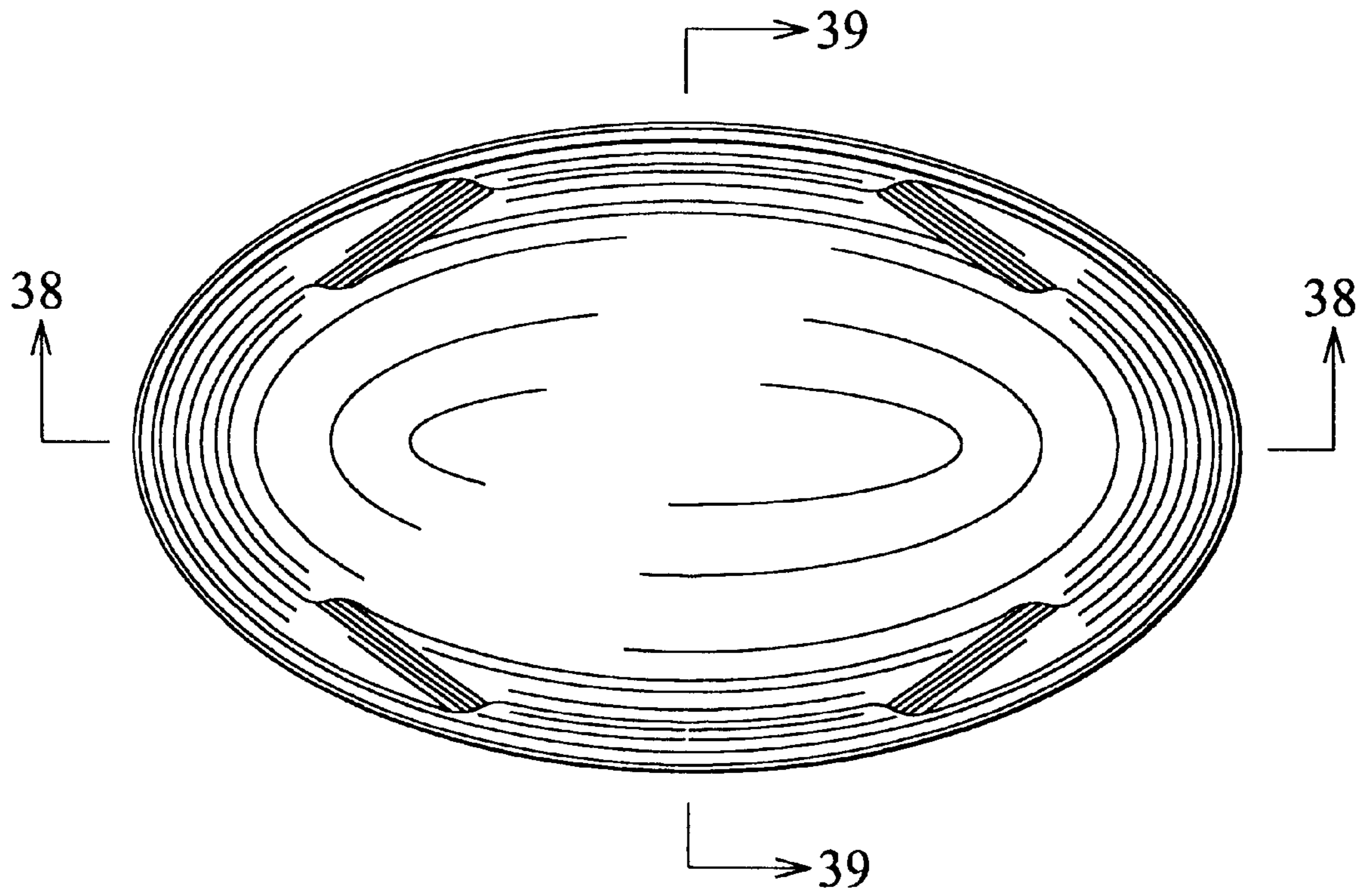

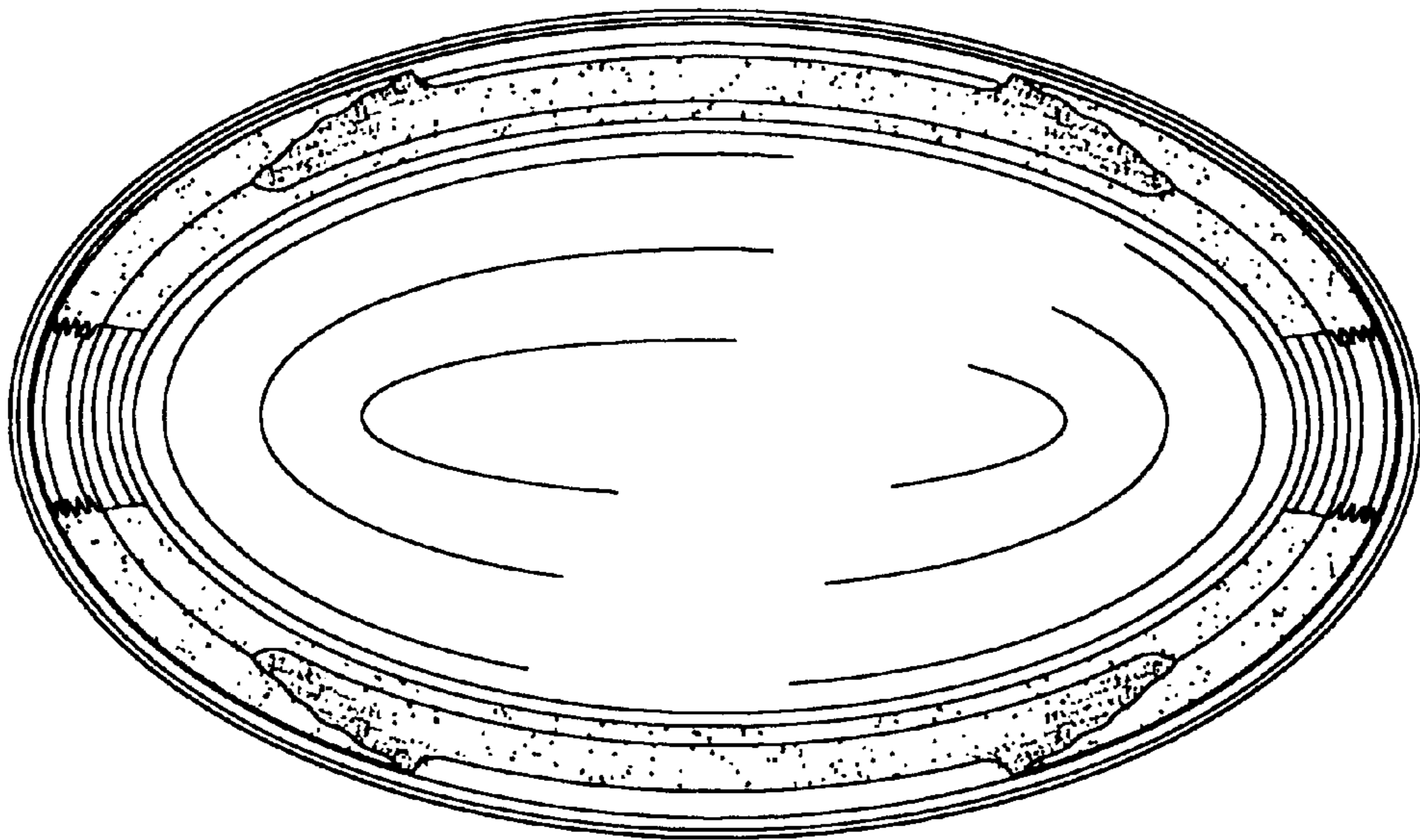

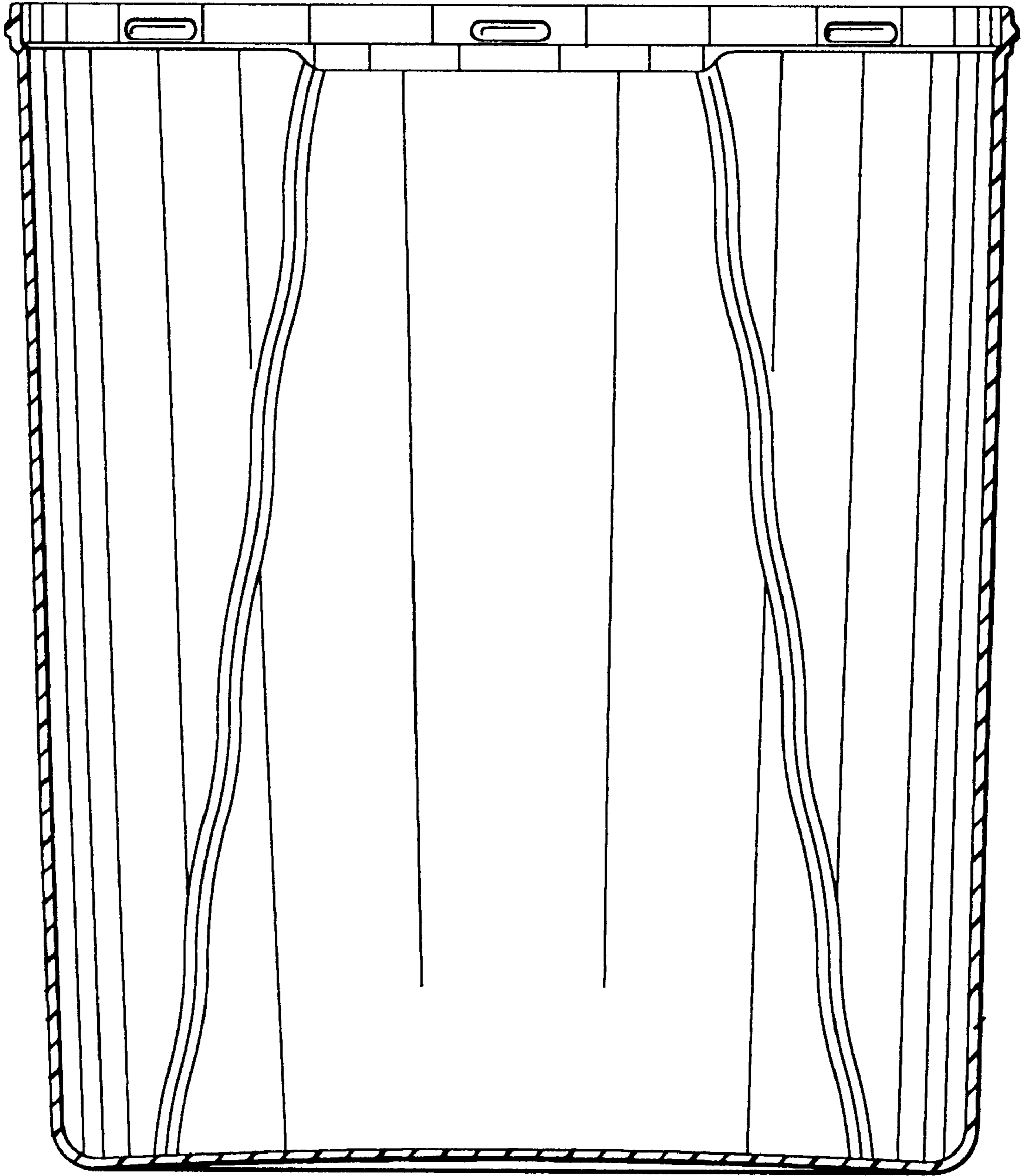

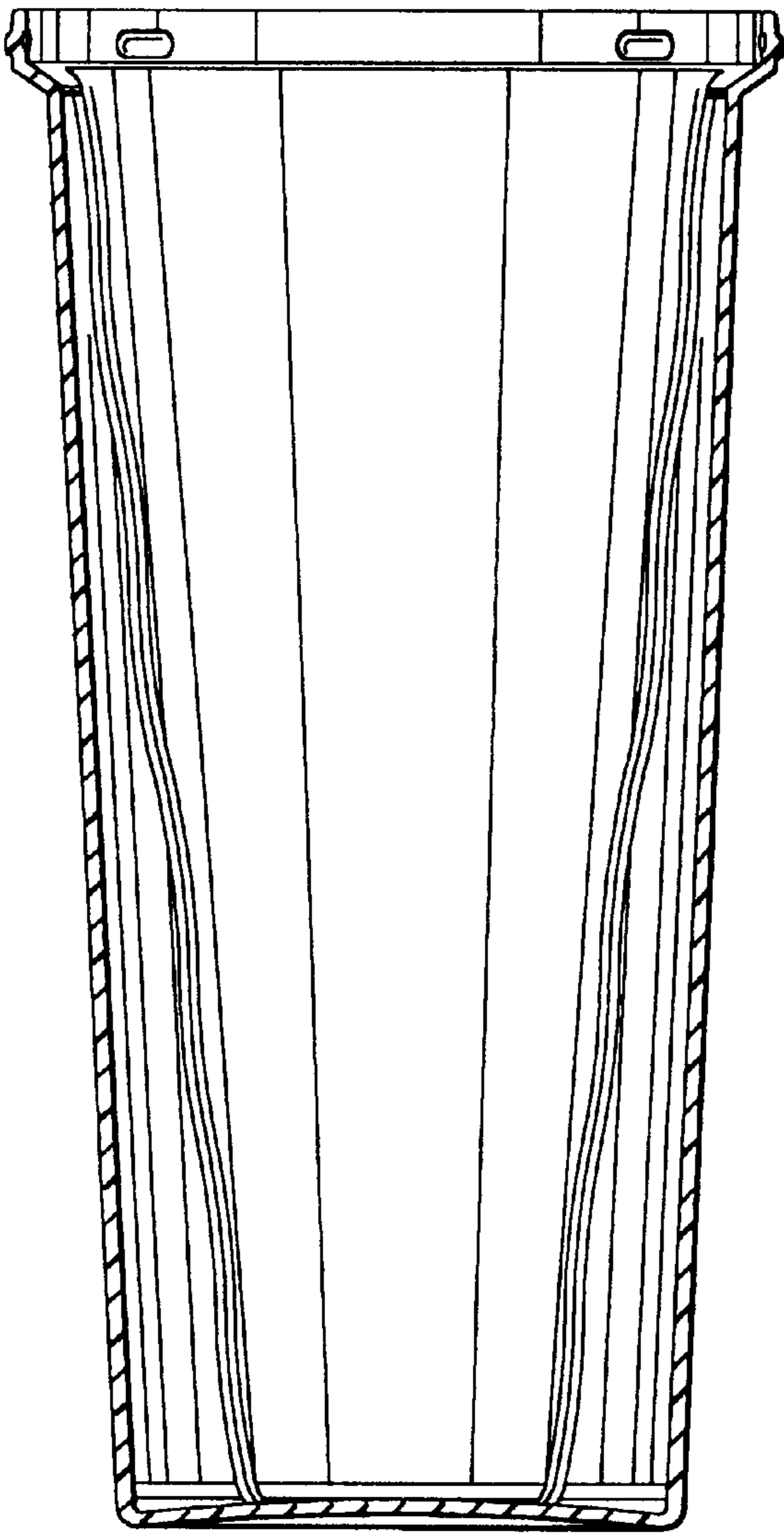

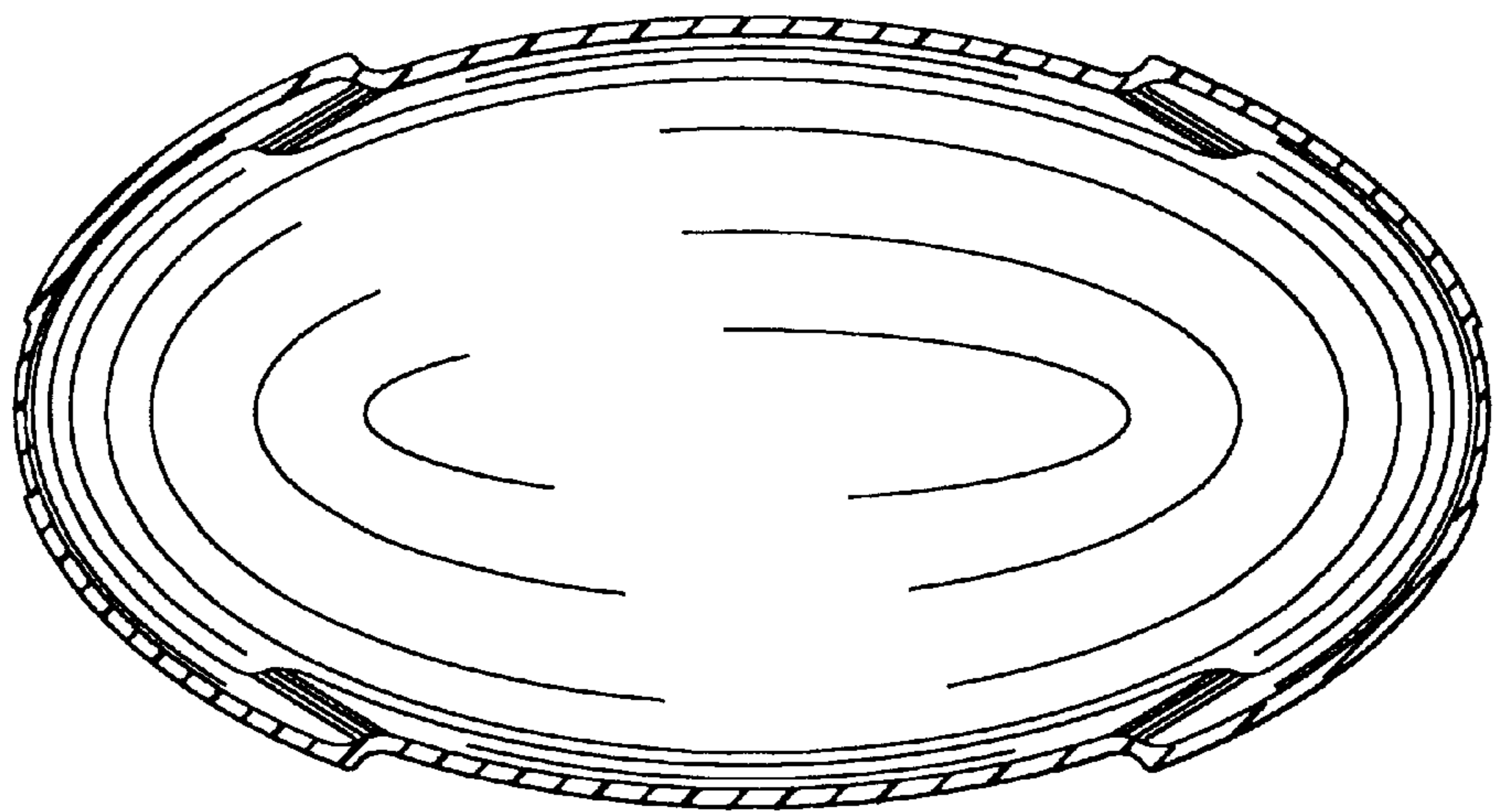
