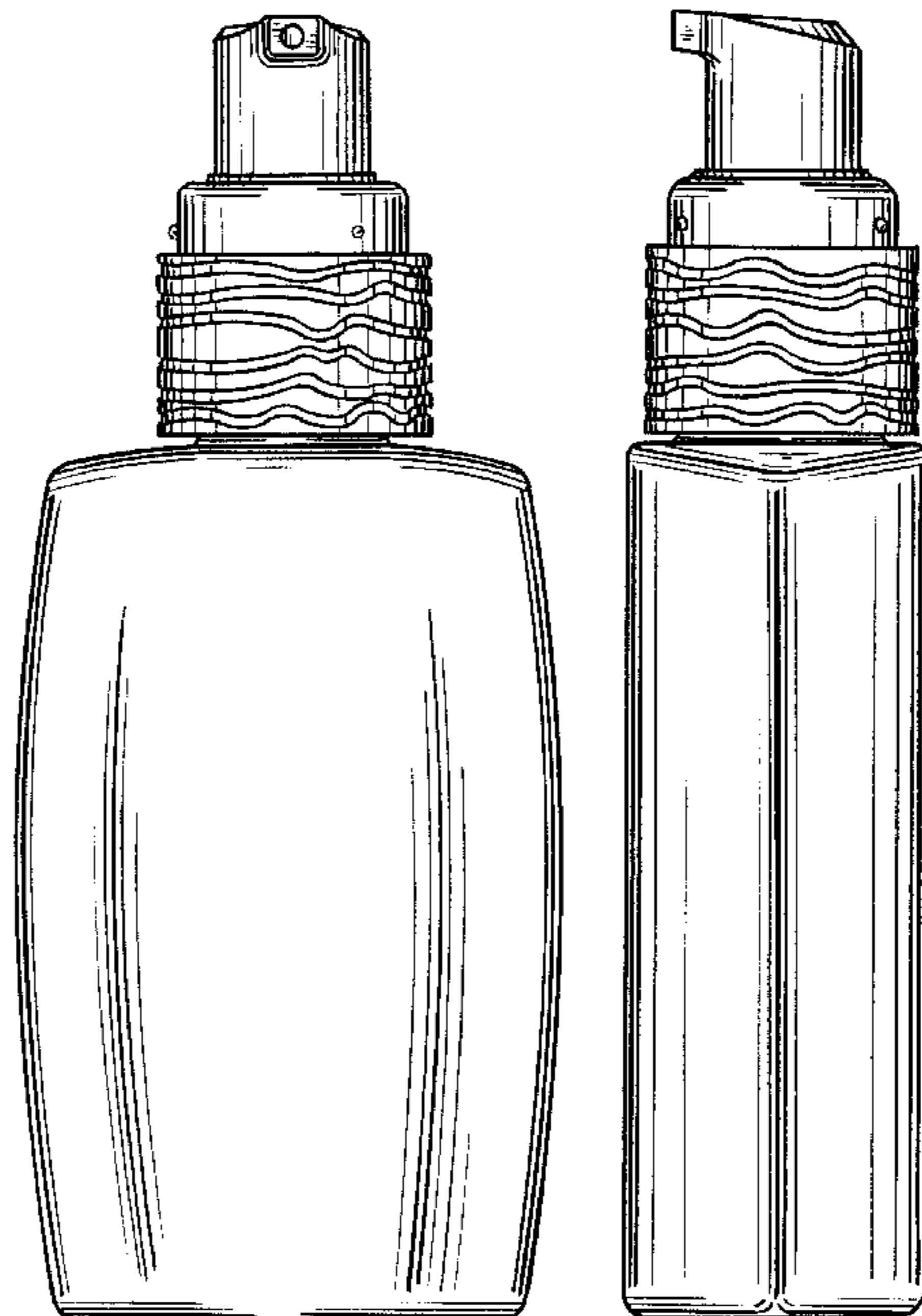

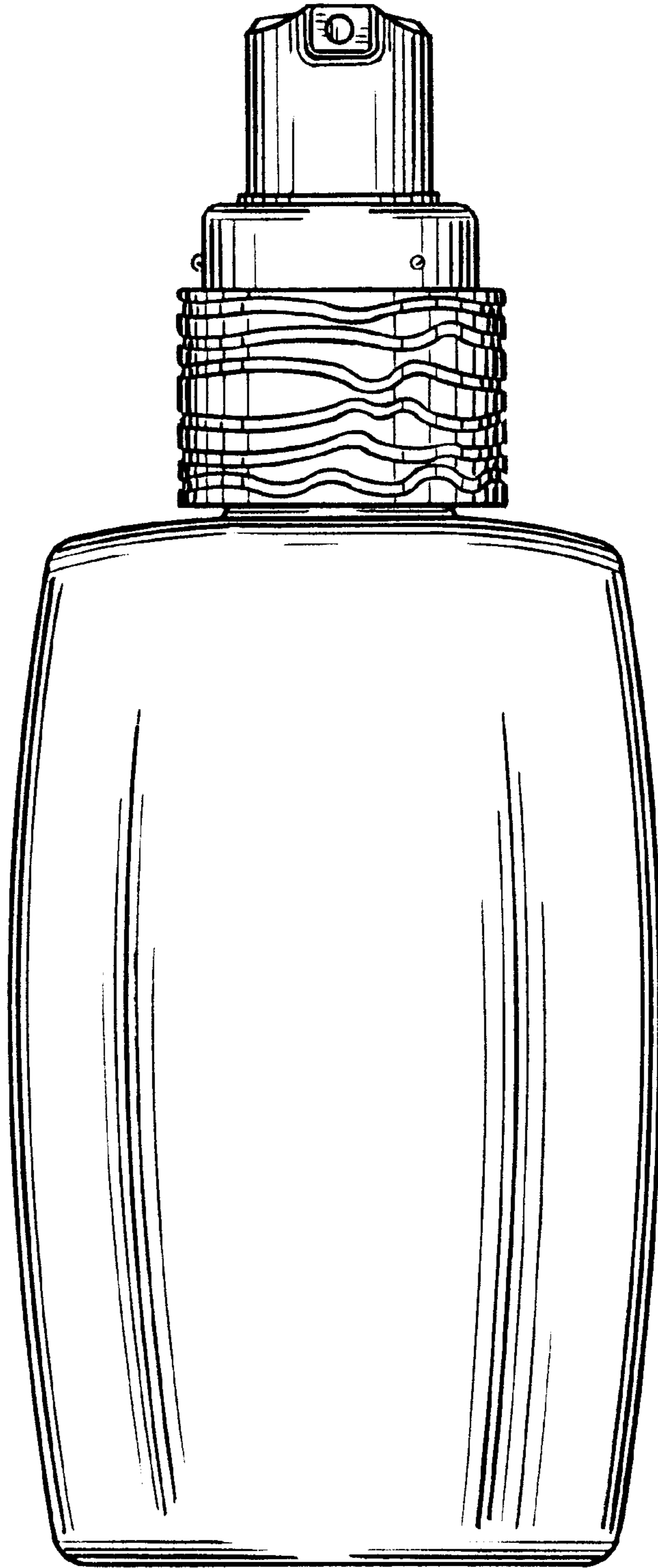
The ornamental design for a dispensing pump and bottle, 00000 as shown and described.

DESCRIPTION

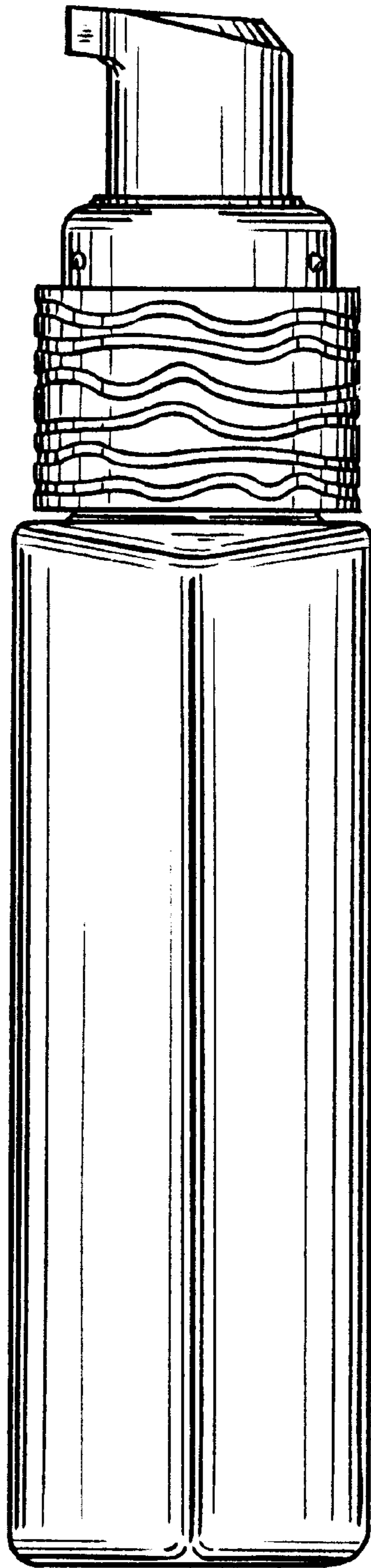
FIG. 1 is a front elevational view of a dispensing pump and bottle embodying the new design;

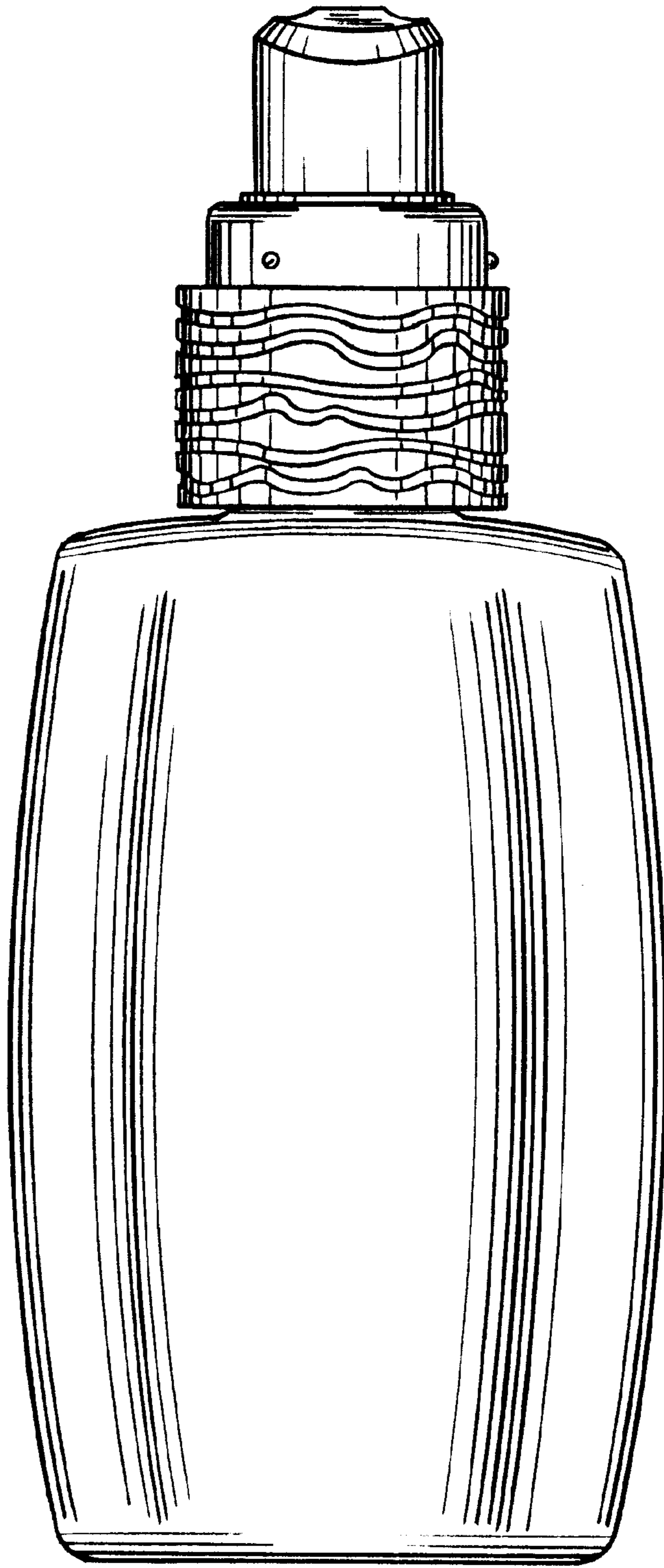




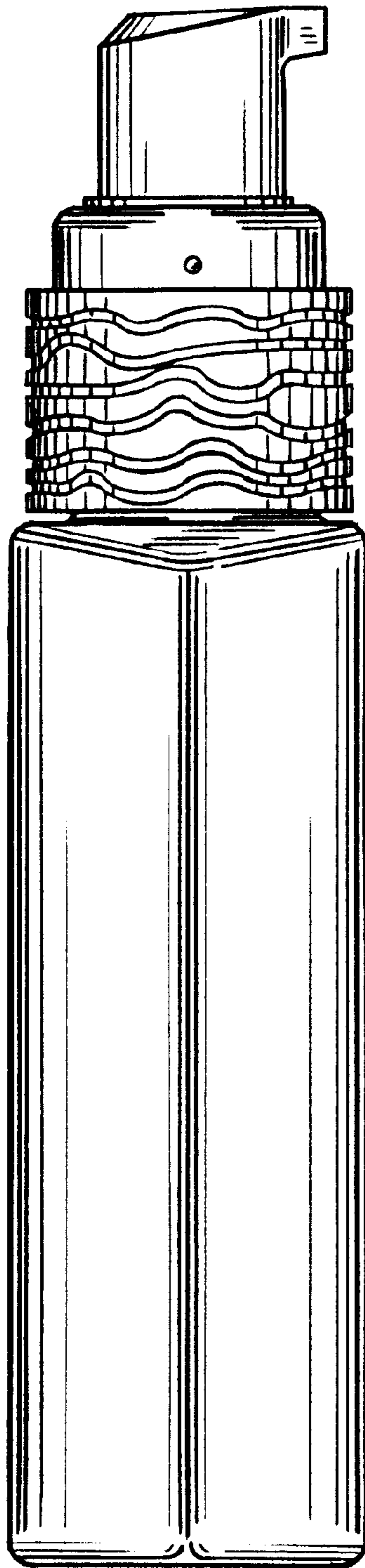

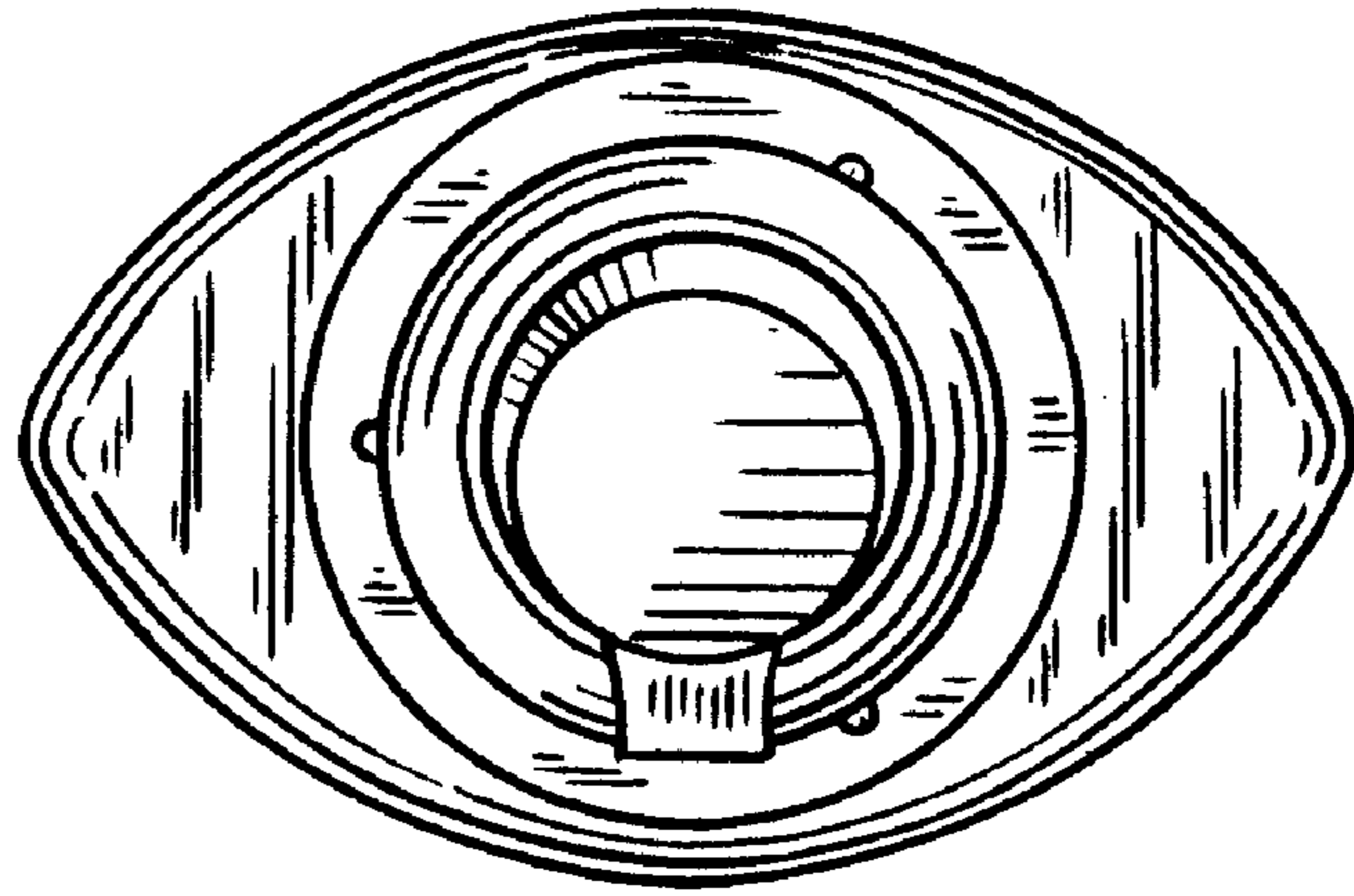

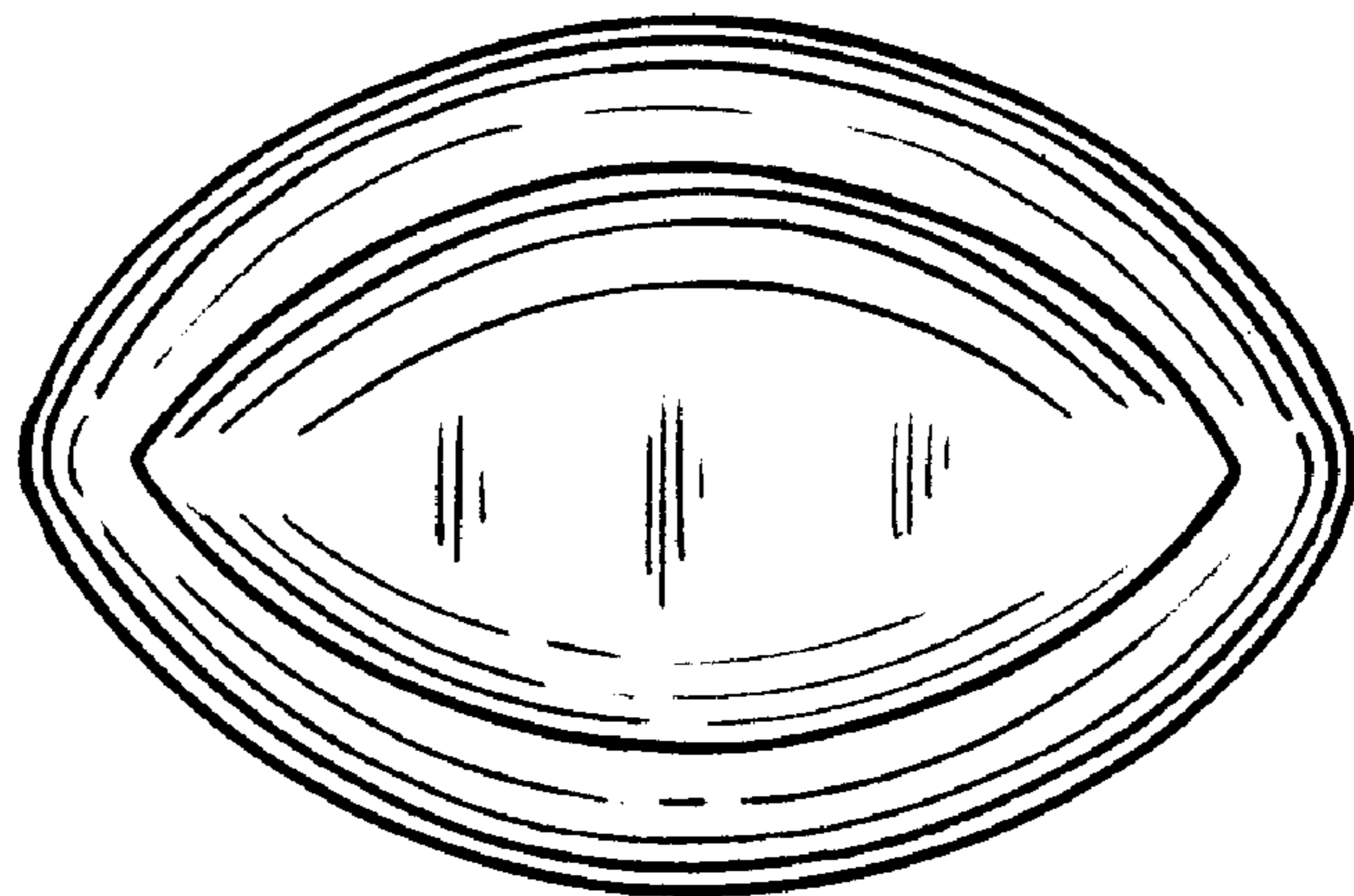
