[57] **CLAIM**

The ornamental design for a writing instrument, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a writing instrument according to a first embodiment of the present invention; FIG. 2 is a right side elevational view of the writing instrument of FIG. 1, the left side being a mirror image of the right side; FIG. 3 is a rear elevational view of the writing instrument of FIG. 1; FIG. 4 is a top plan view of the writing instrument of FIG. 1; FIG. 5 is a bottom plan view of the writing instrument of FIG. 1; FIG. 6 is a perspective view of the writing instrument of FIG. 1, with the writing lead being projected and the eraser member being extended; FIG. 7 is a front elevational view of a writing instrument according to a second embodiment of the present invention; FIG. 8 is a right side elevational view of the writing instrument of FIG. 7, the left side being a mirror image of the right side; FIG. 9 is a rear elevational view of the writing instrument of FIG. 7; FIG. 10 is a top plan view of the writing instrument of FIG. 7; FIG. 11 is a bottom plan view of the writing instrument of FIG. 7; and, FIG. 12 is a perspective view of the writing instrument of FIG. 7, with the writing lead being projected and the eraser member being extended.

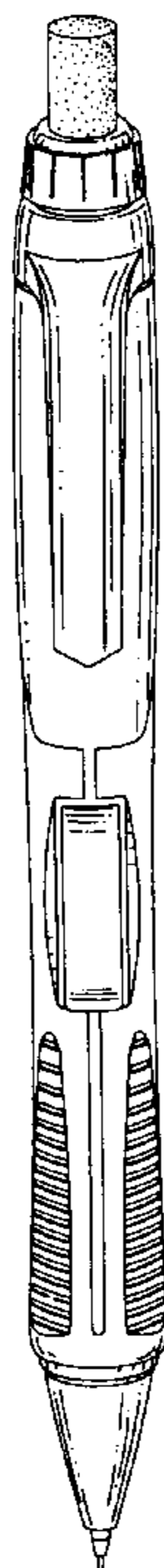

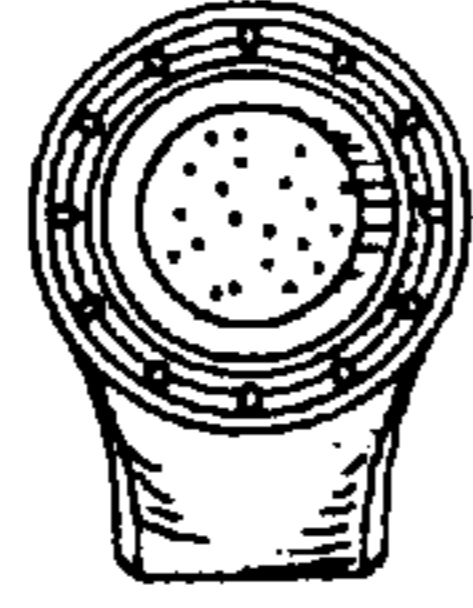

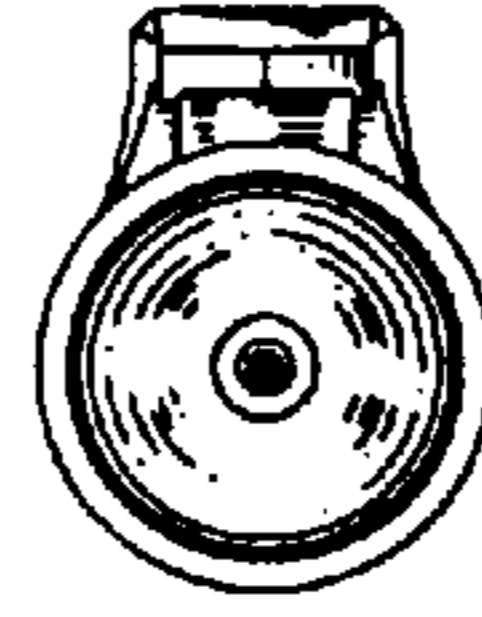

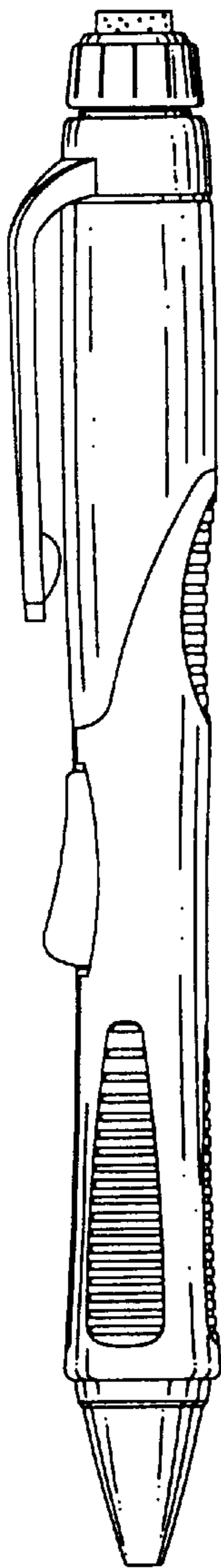

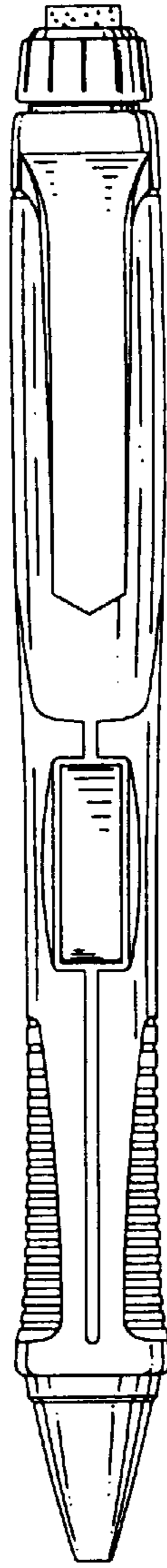

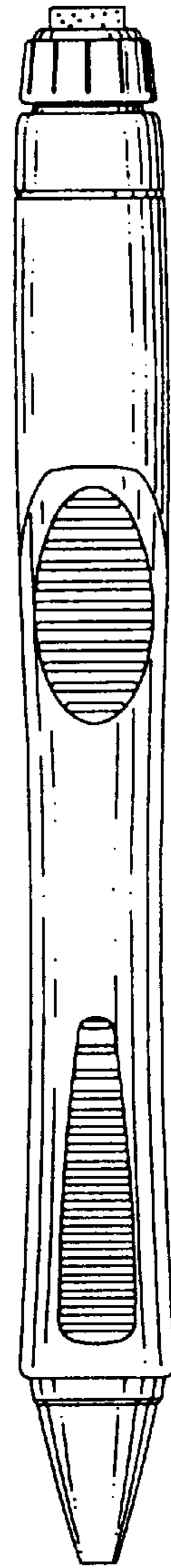

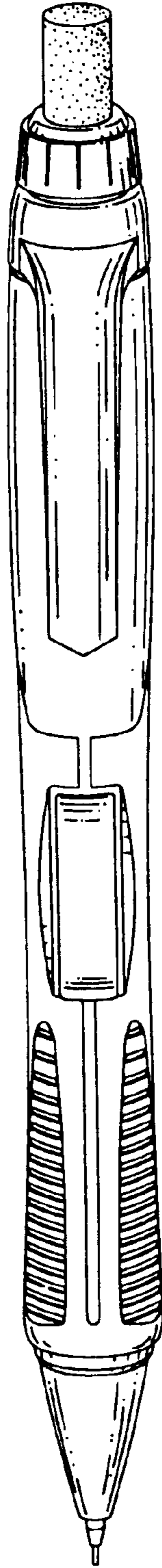

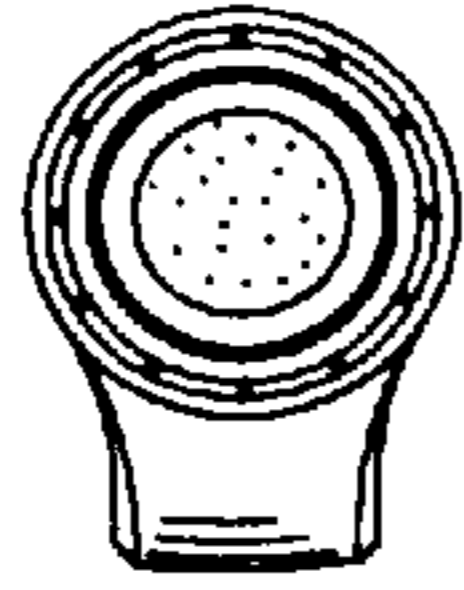

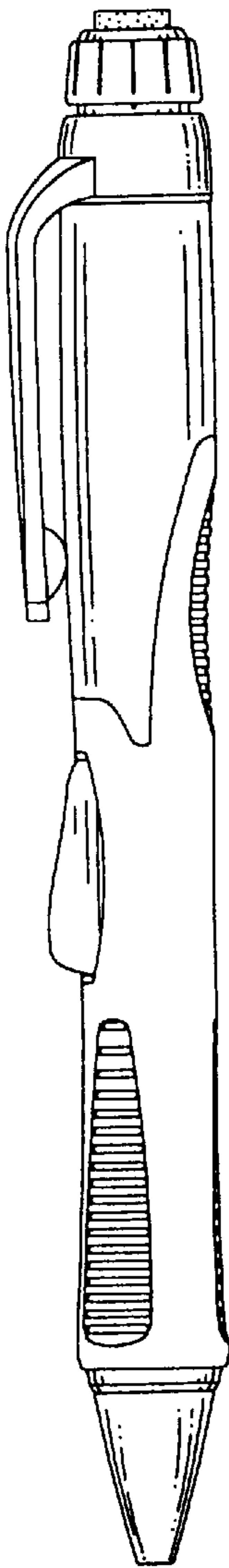

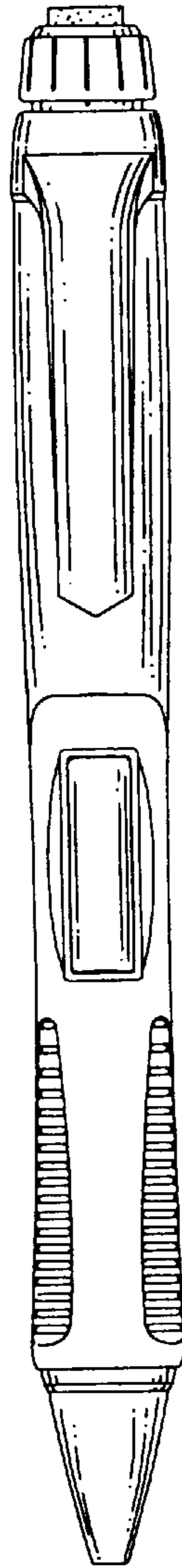

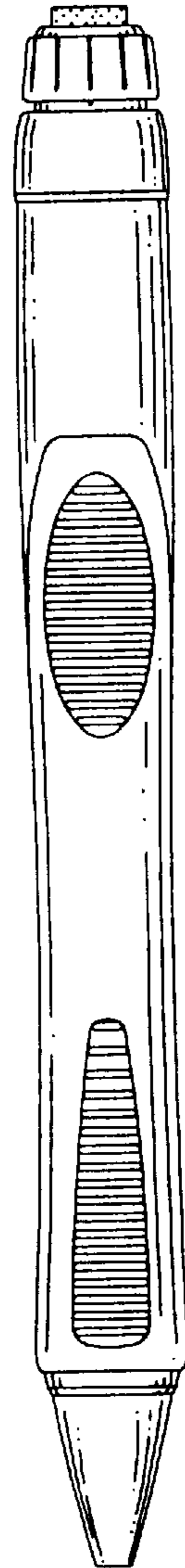
