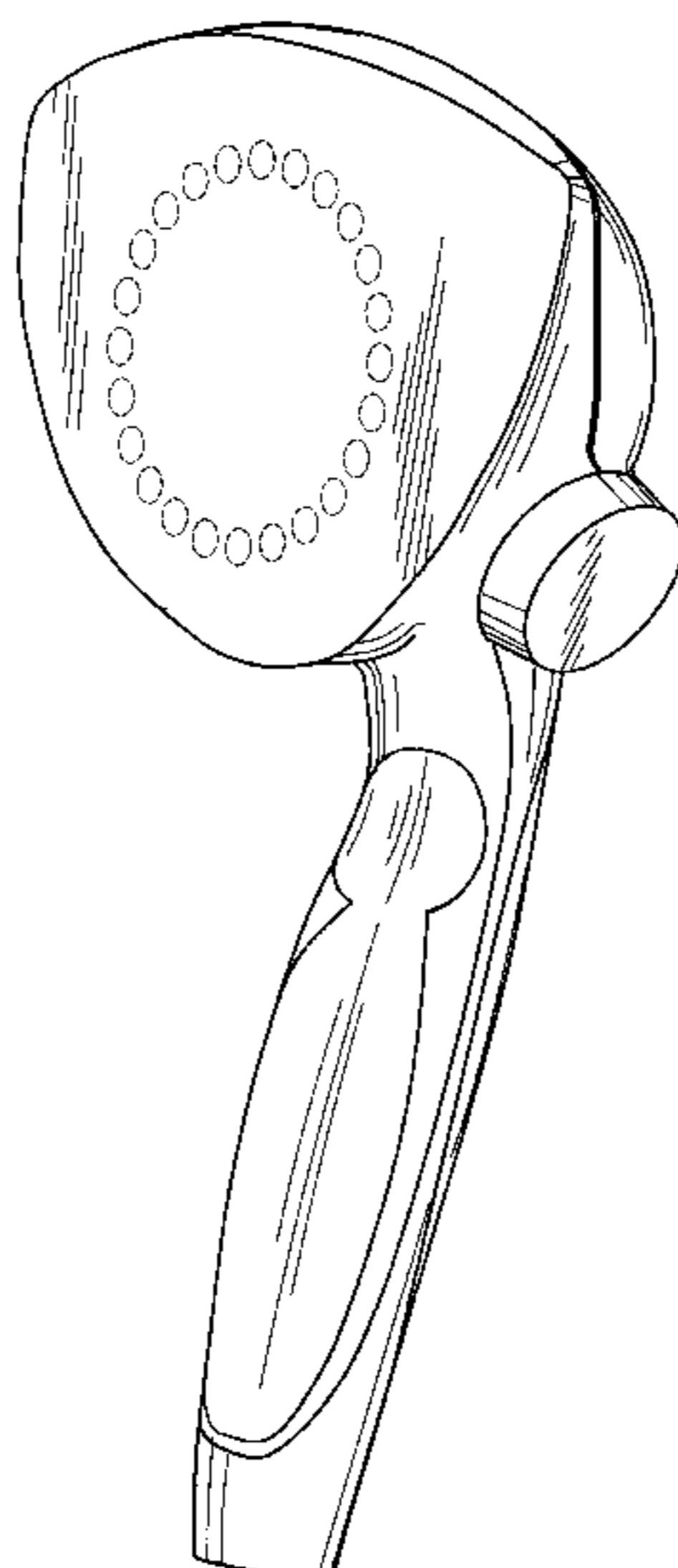
The ornamental design for a hand-held shower head, as shown and described.

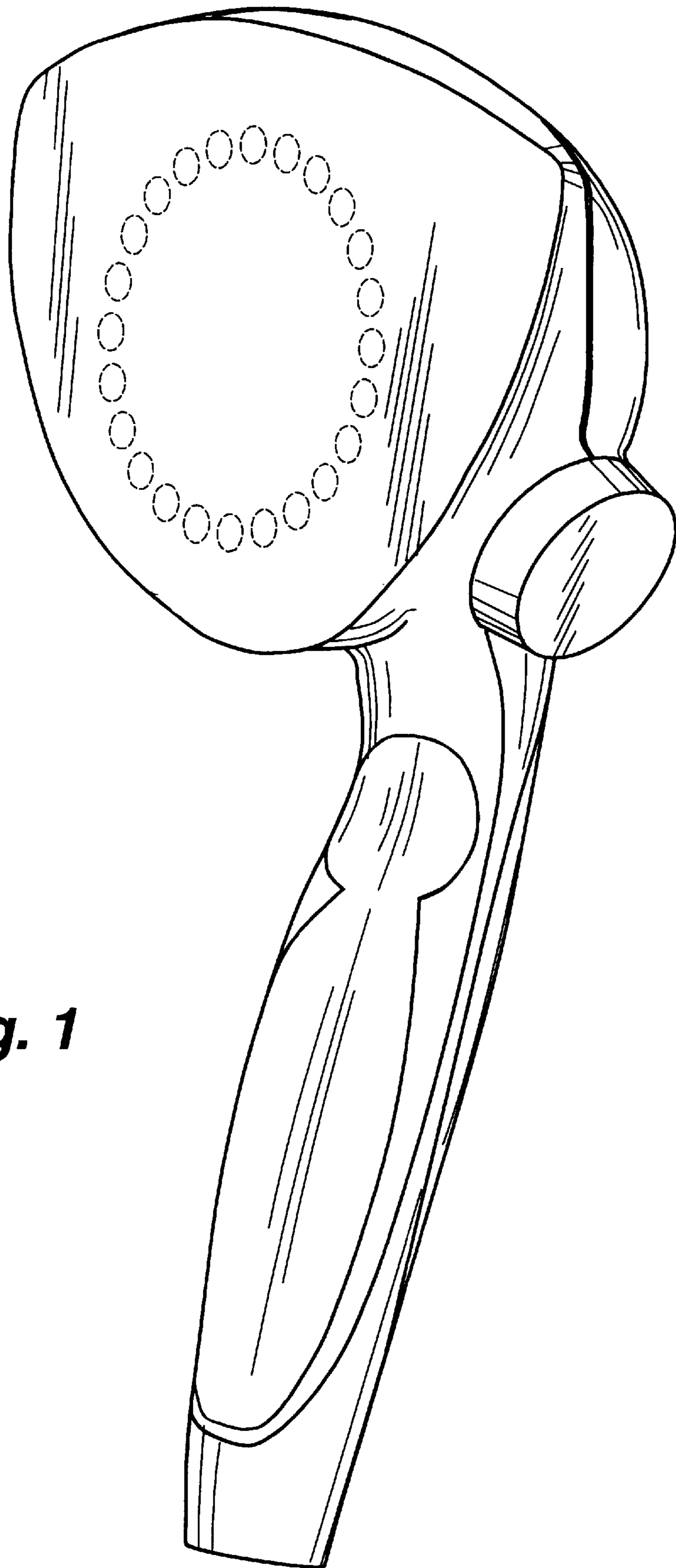
### DESCRIPTION

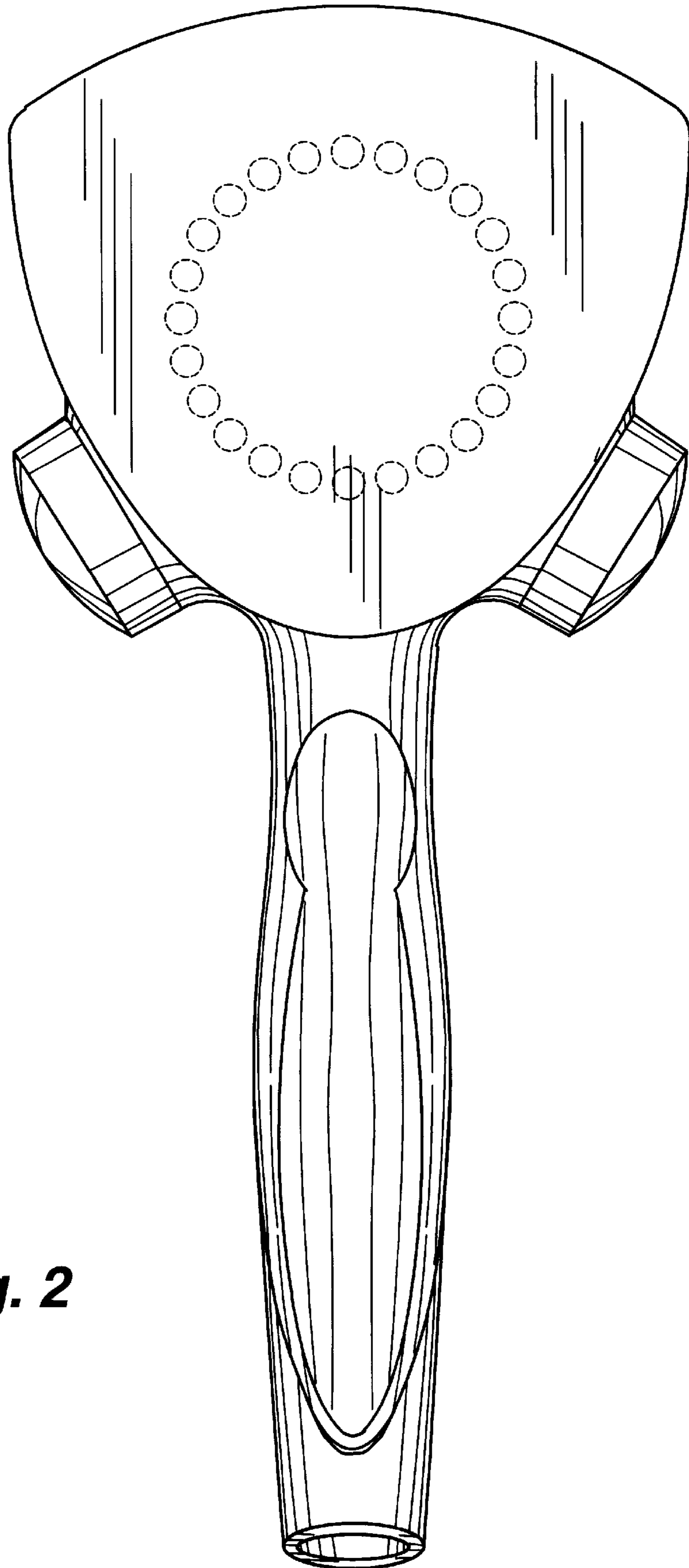
FIG. 2 is a front elevational view thereof;

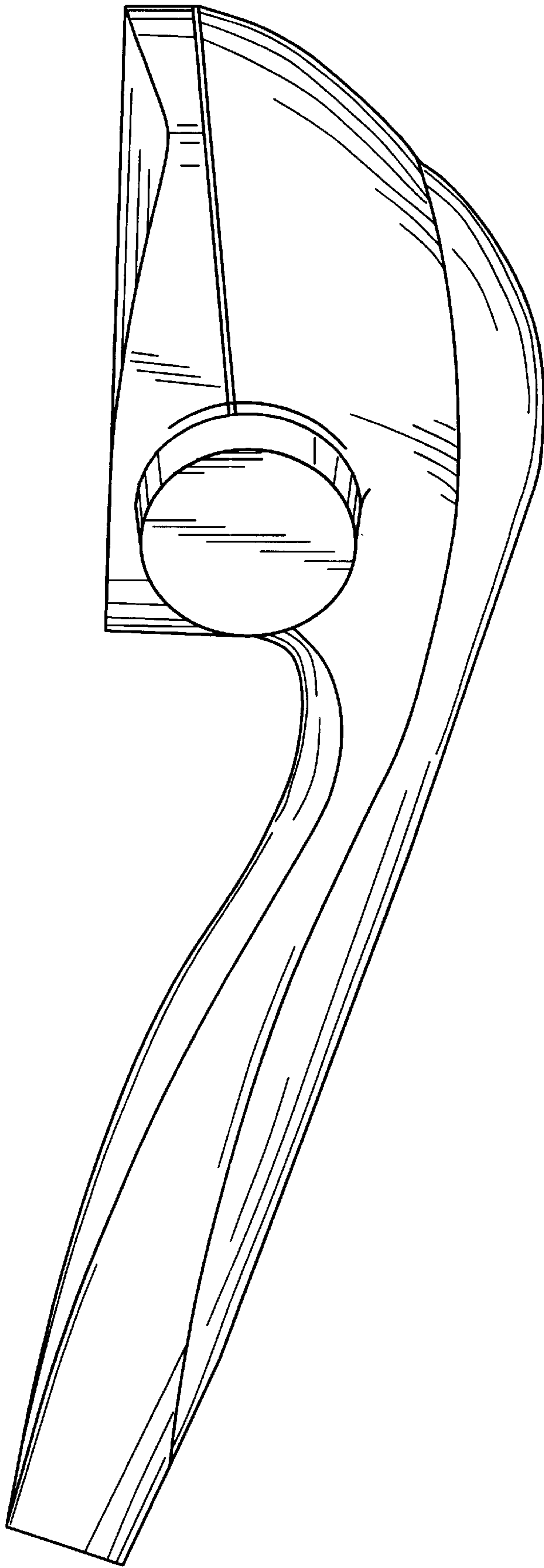




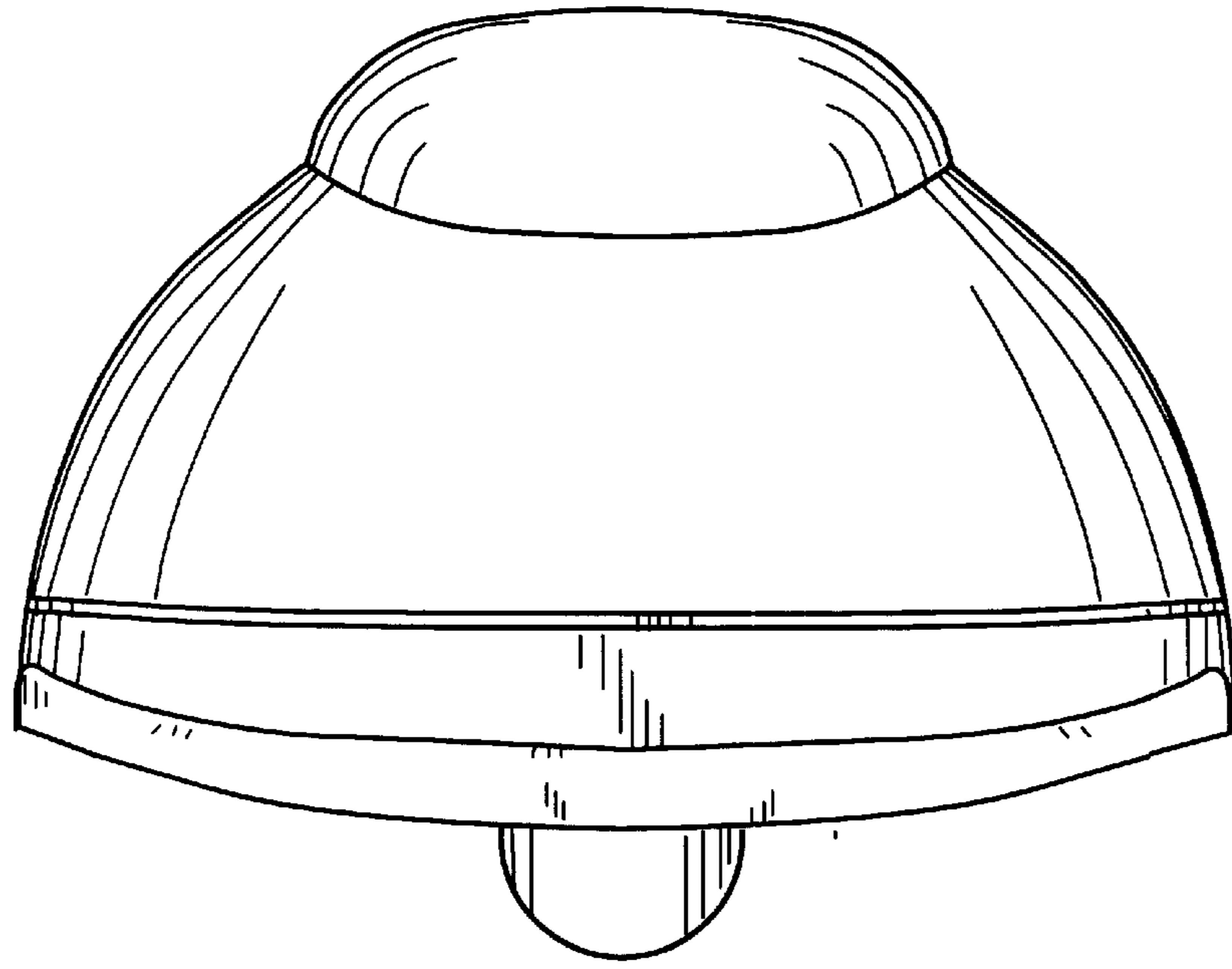

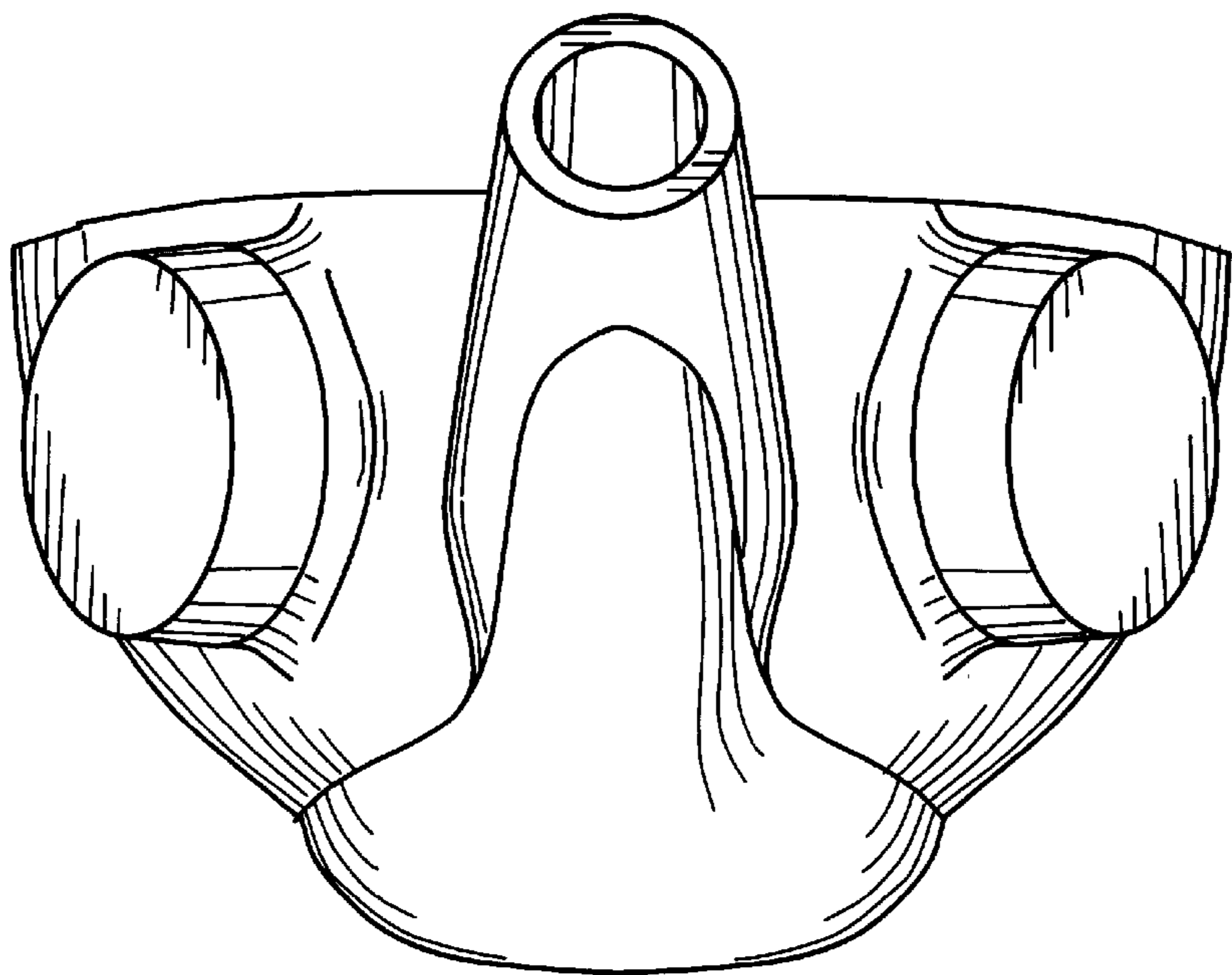

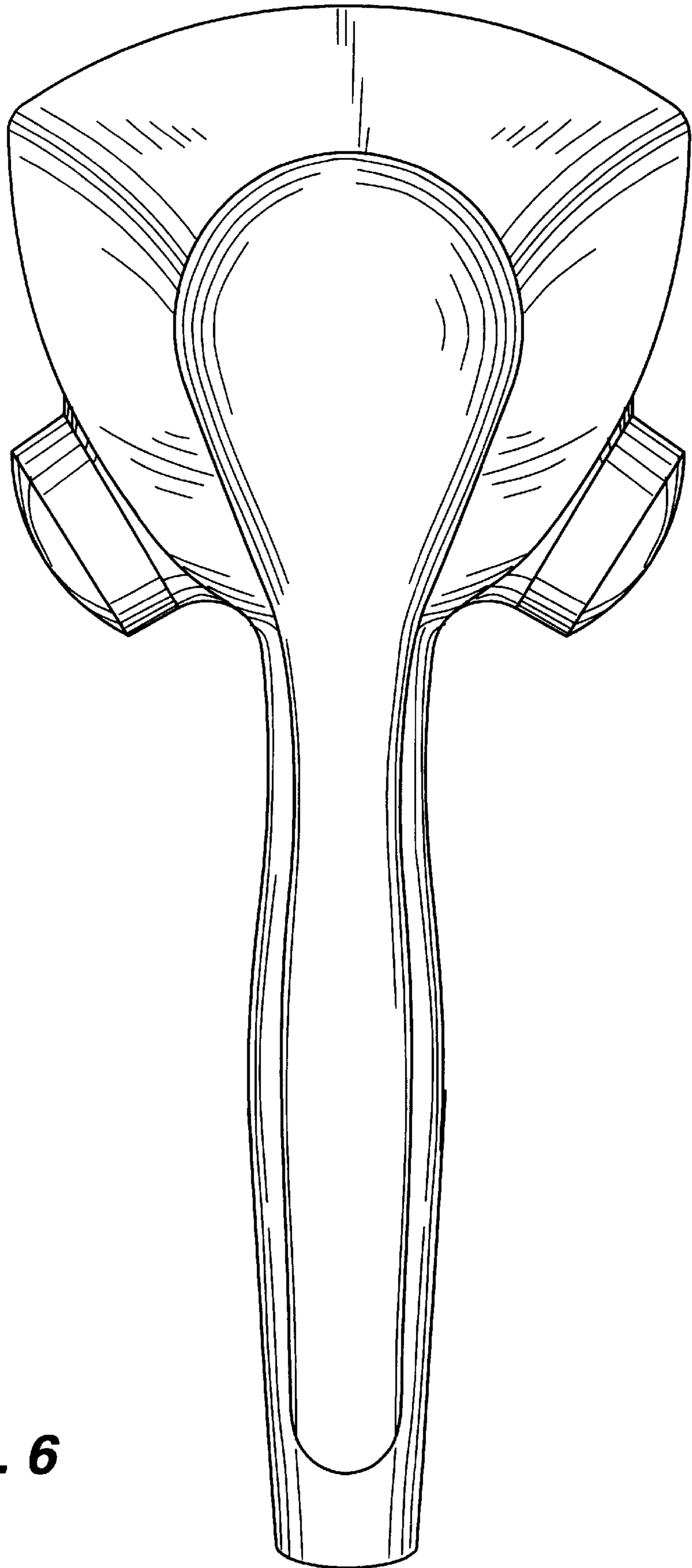
