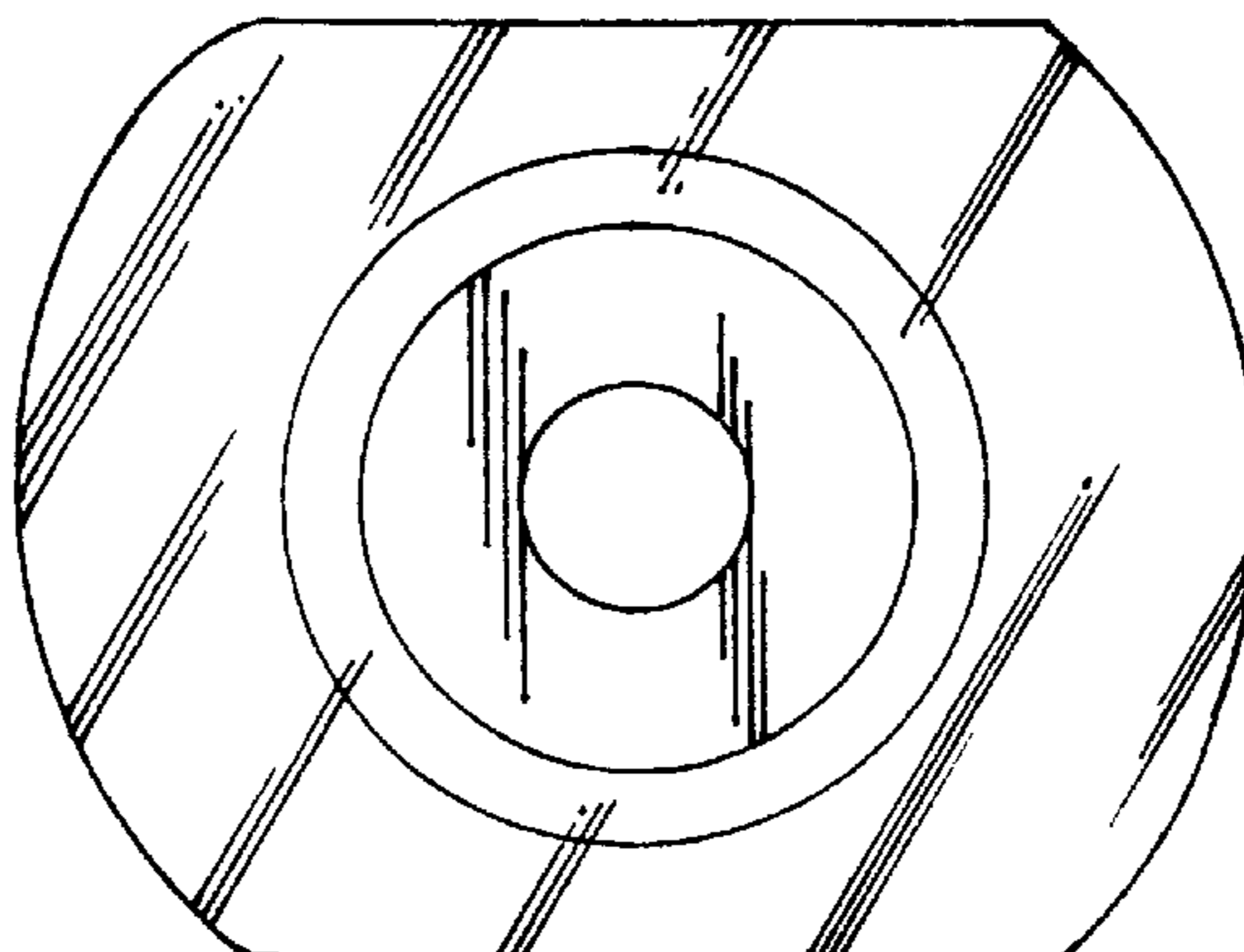
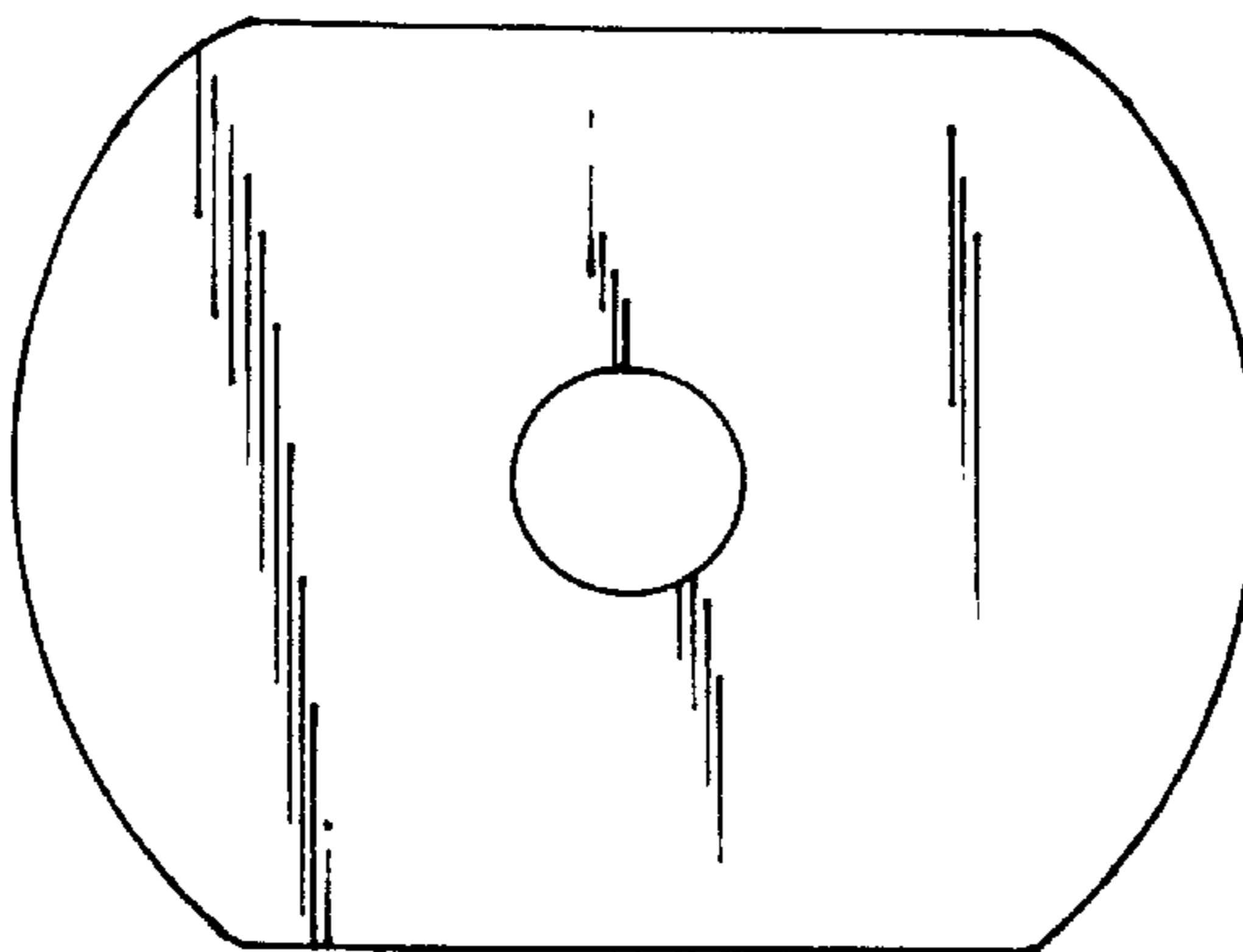
[57] **CLAIM**

The ornamental design for a compact disk/mini disk, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a compact disk/mini disk showing my new design;

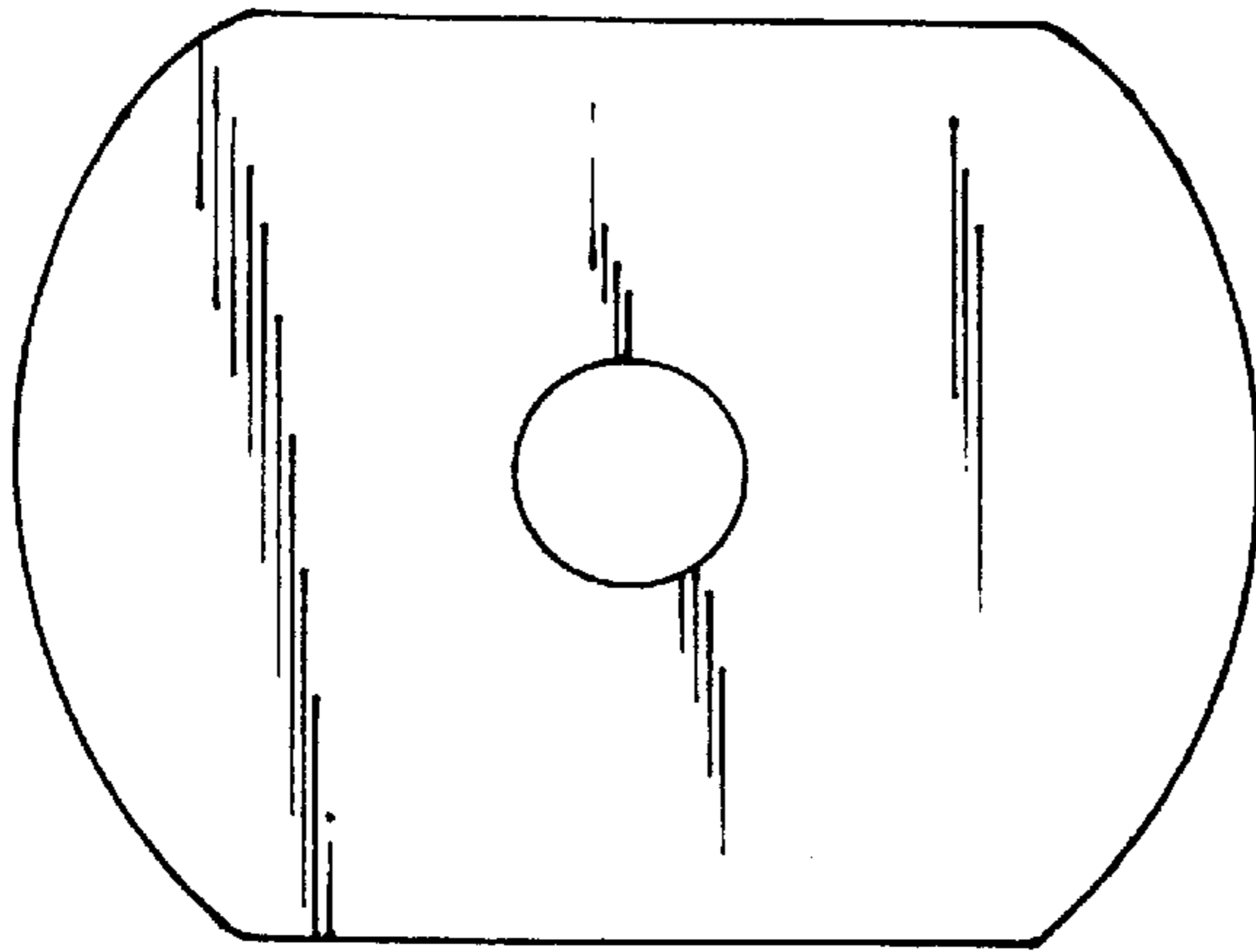

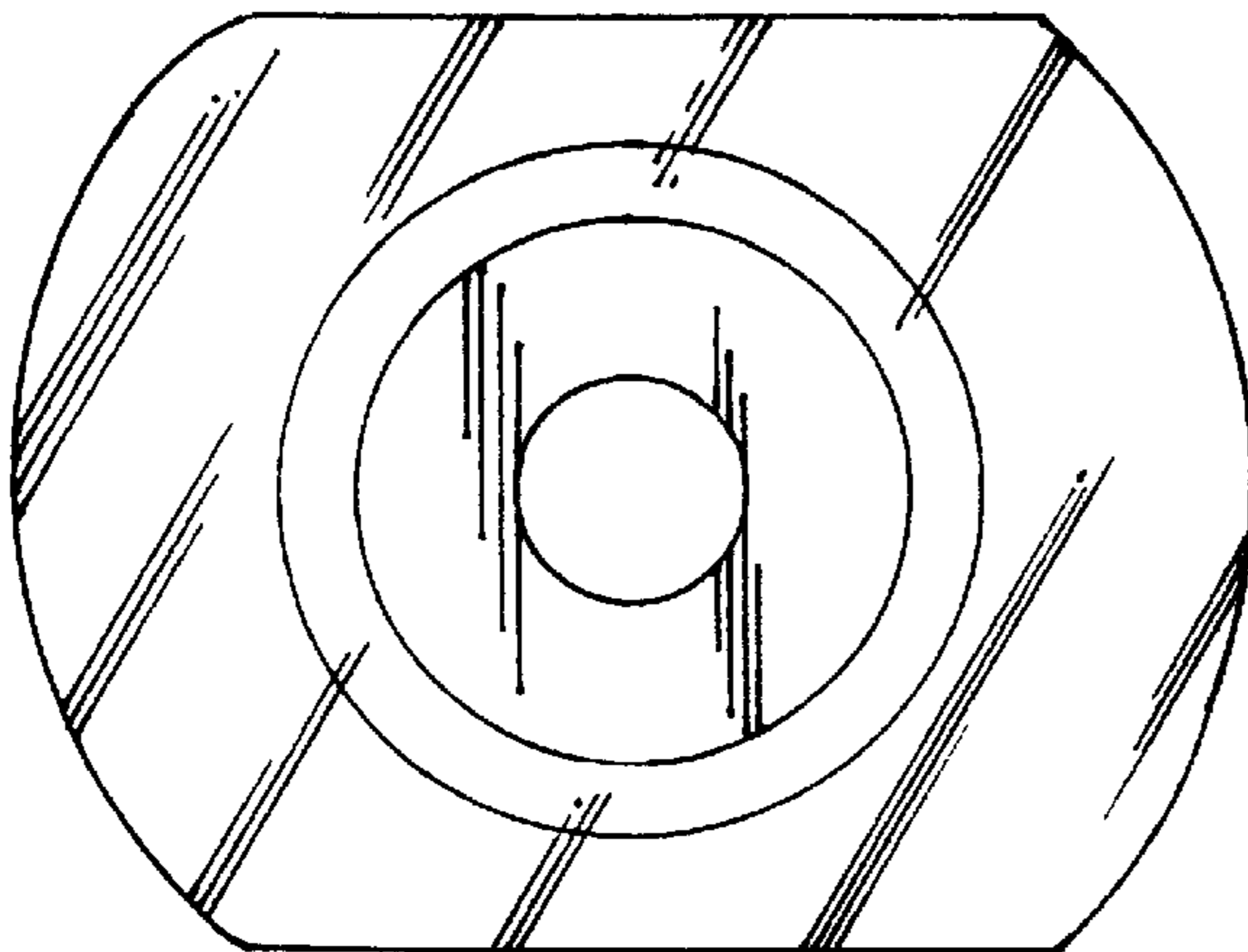

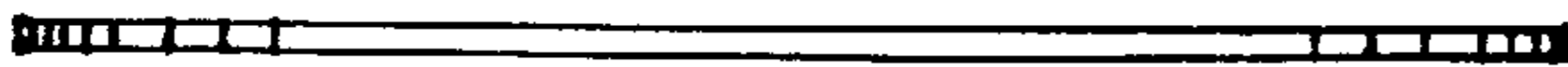

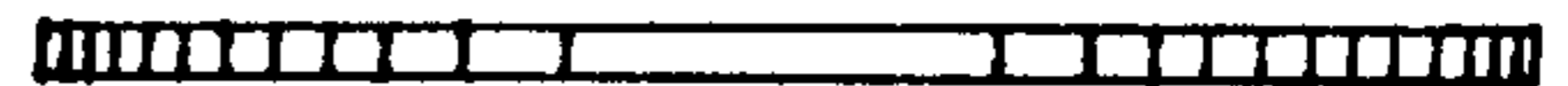

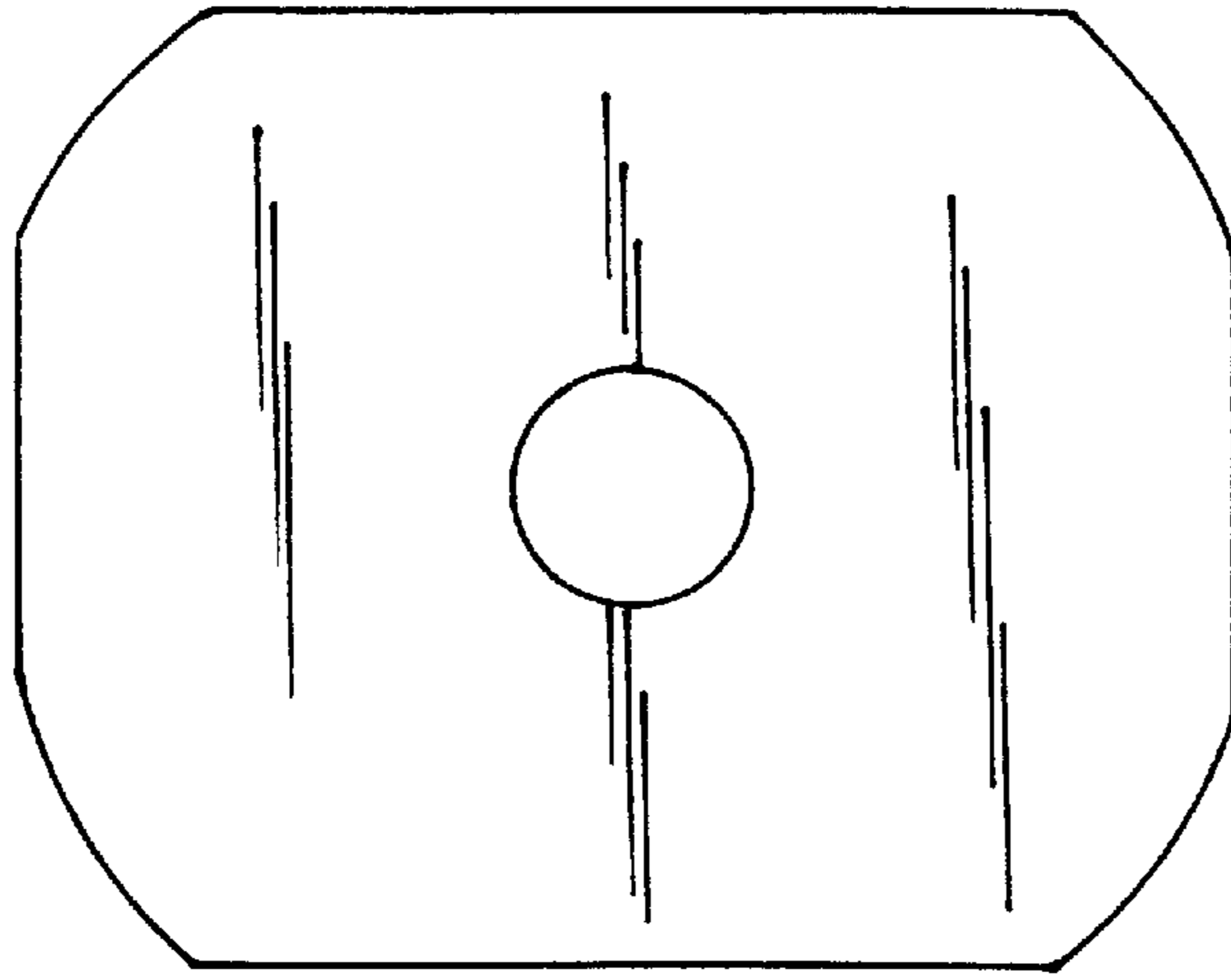

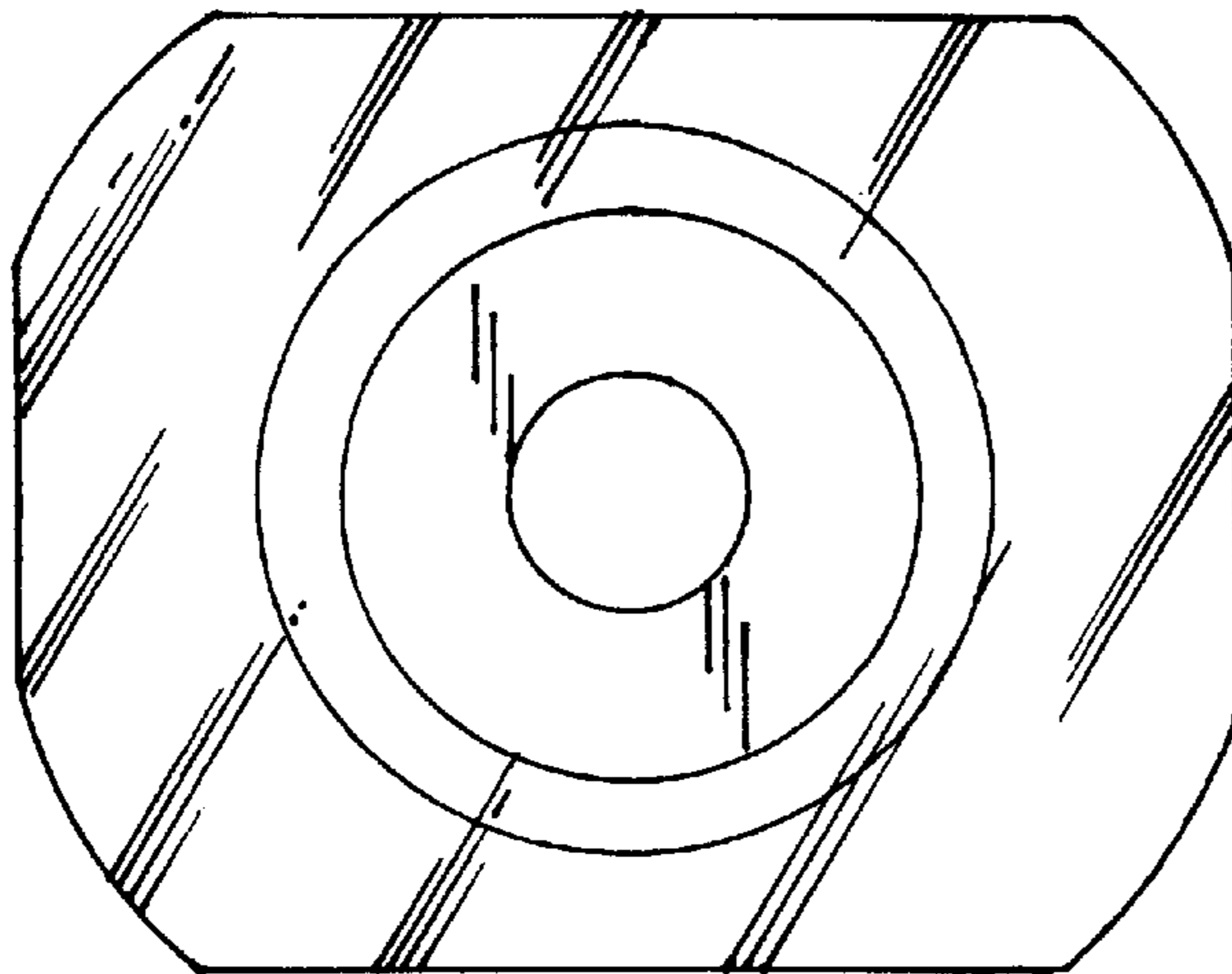

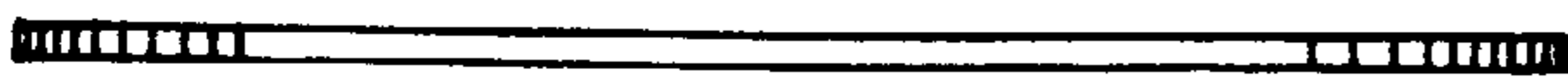

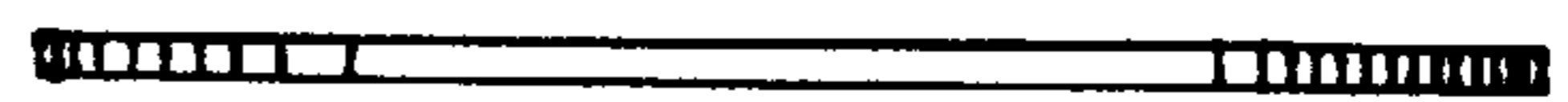

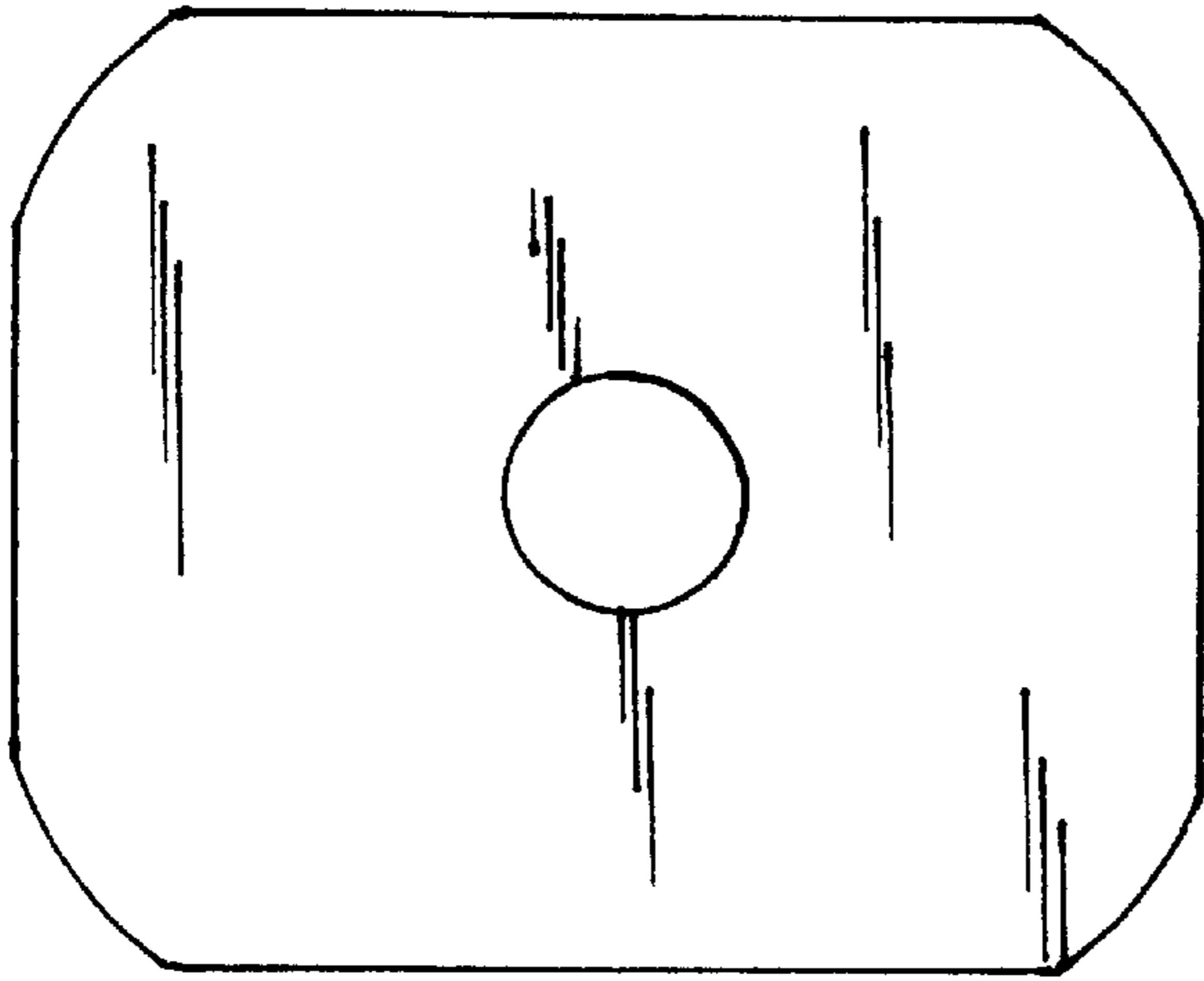

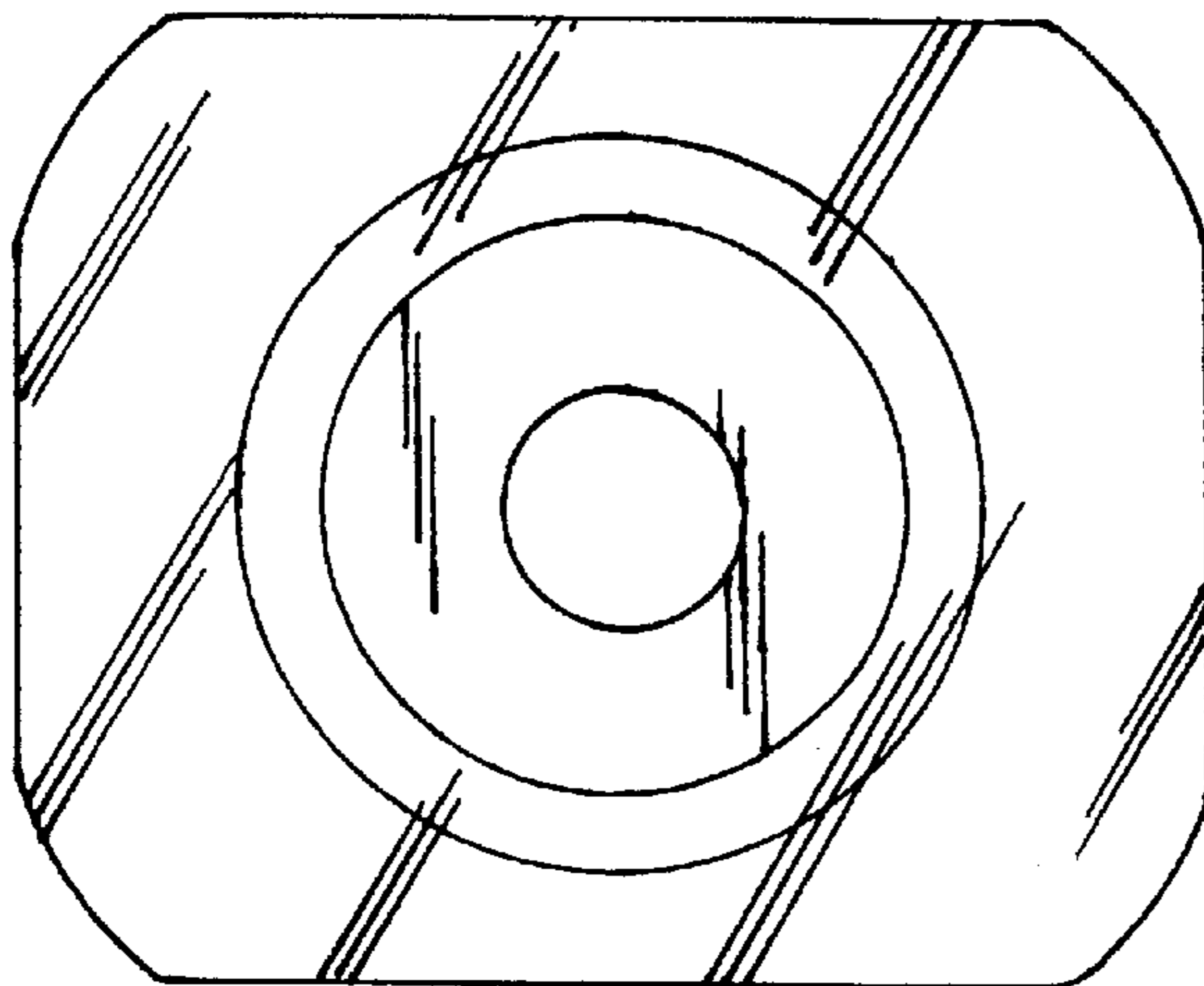

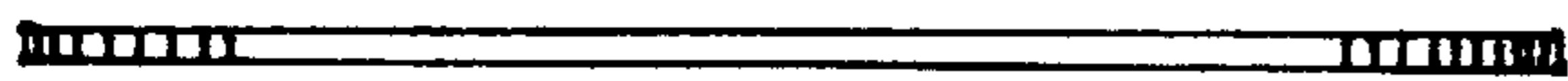

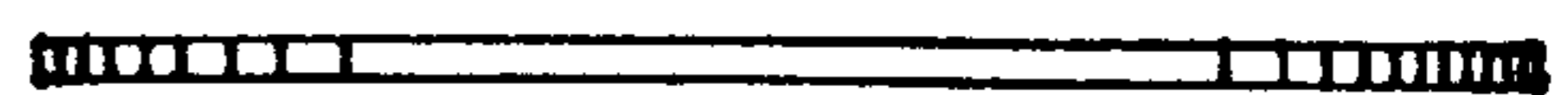
