The ornamental design for “lens for protective eyeglasses,” as shown and described.

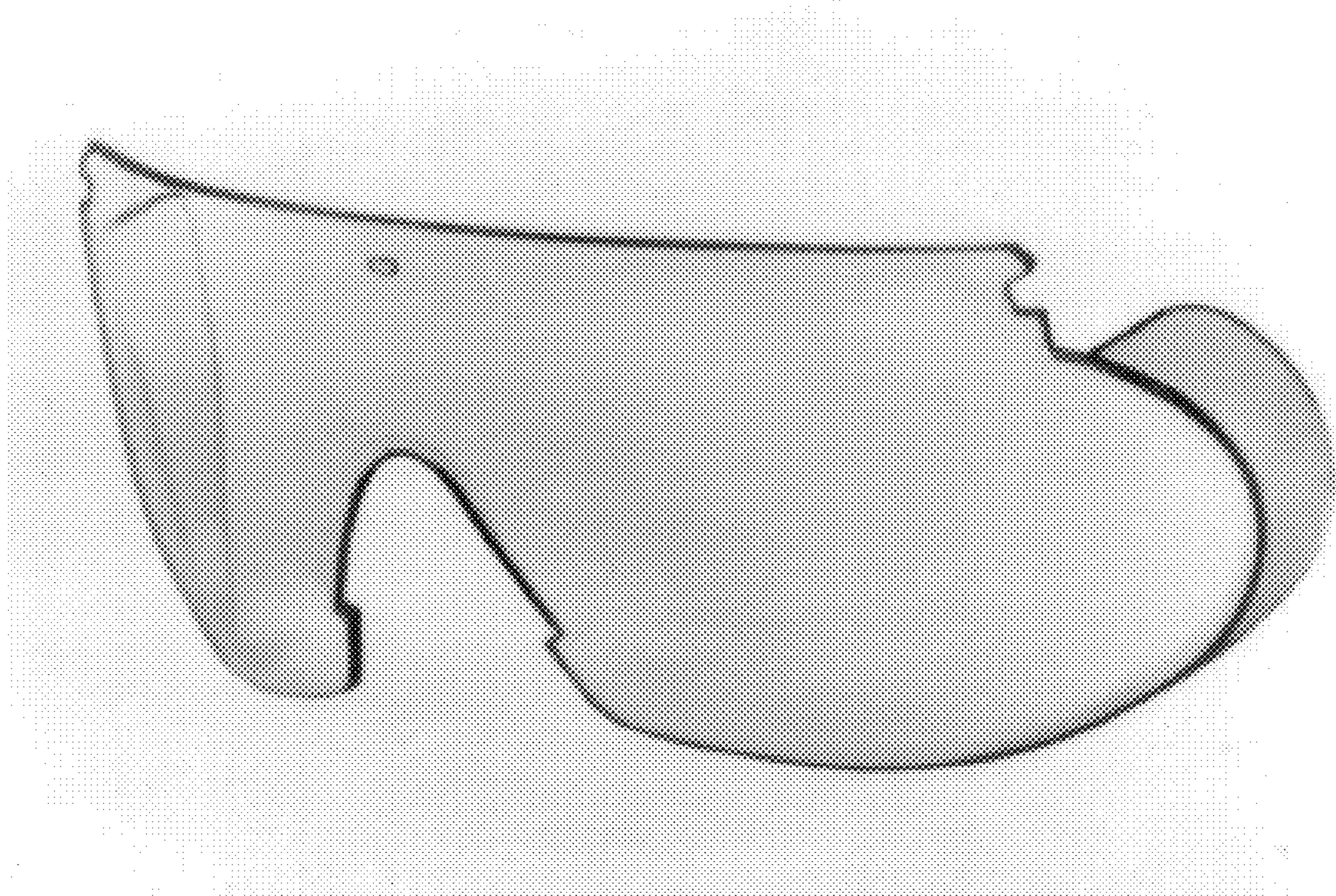

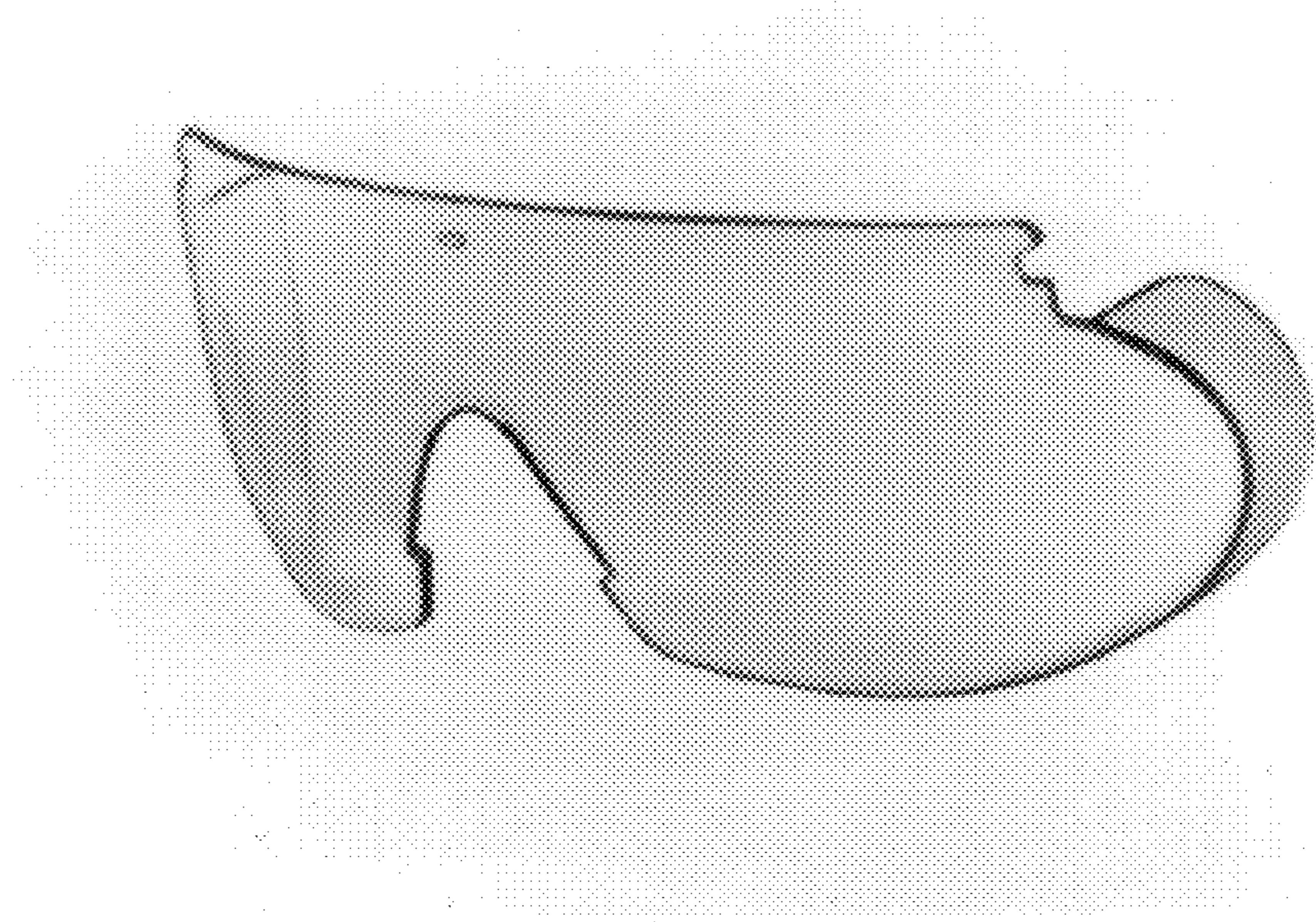

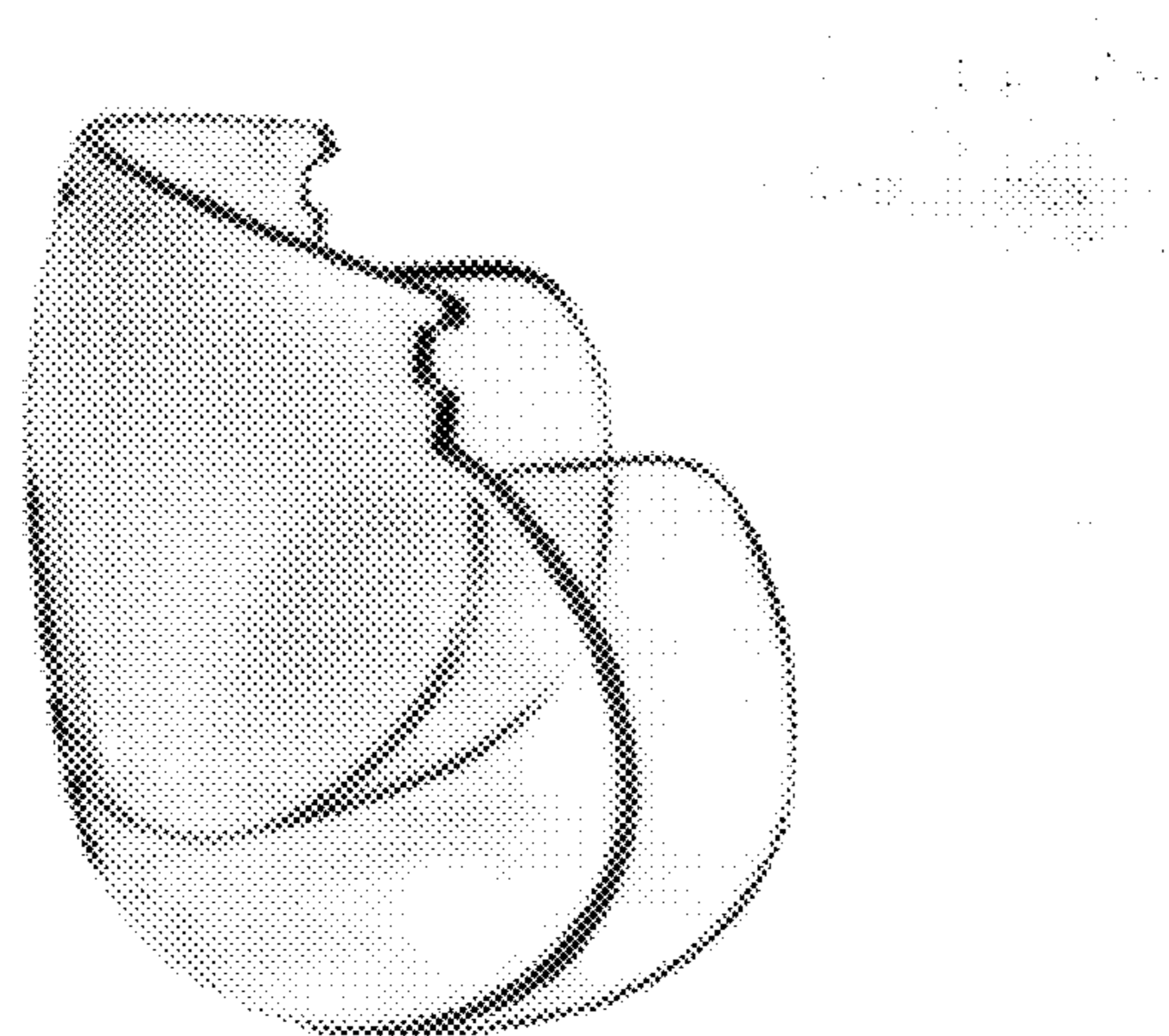

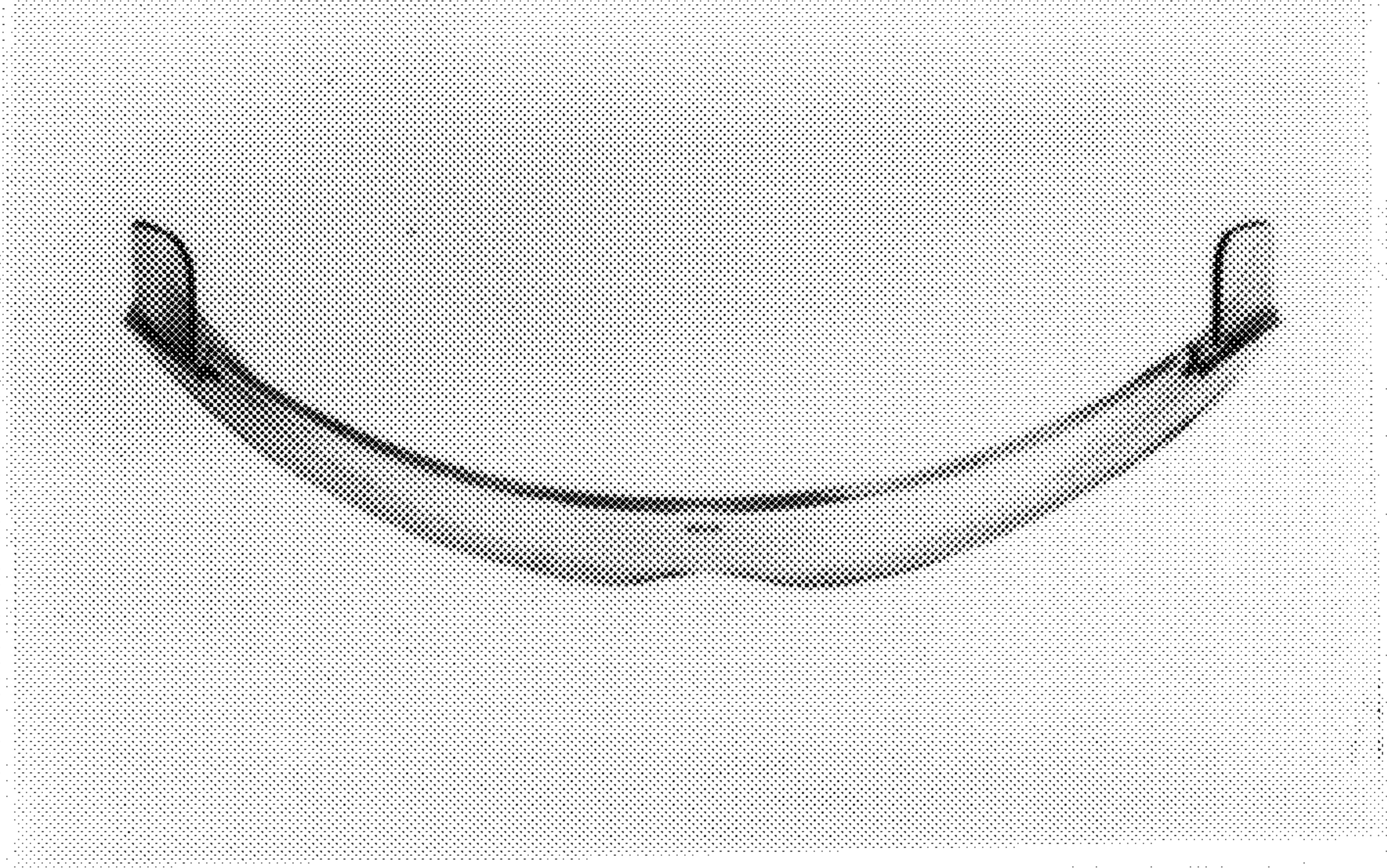
