DESCRIPTION

FIG. 1 is a front perspective view of an exterior lantern showing our new design;

FIG. 2 is a front elevational view thereof;

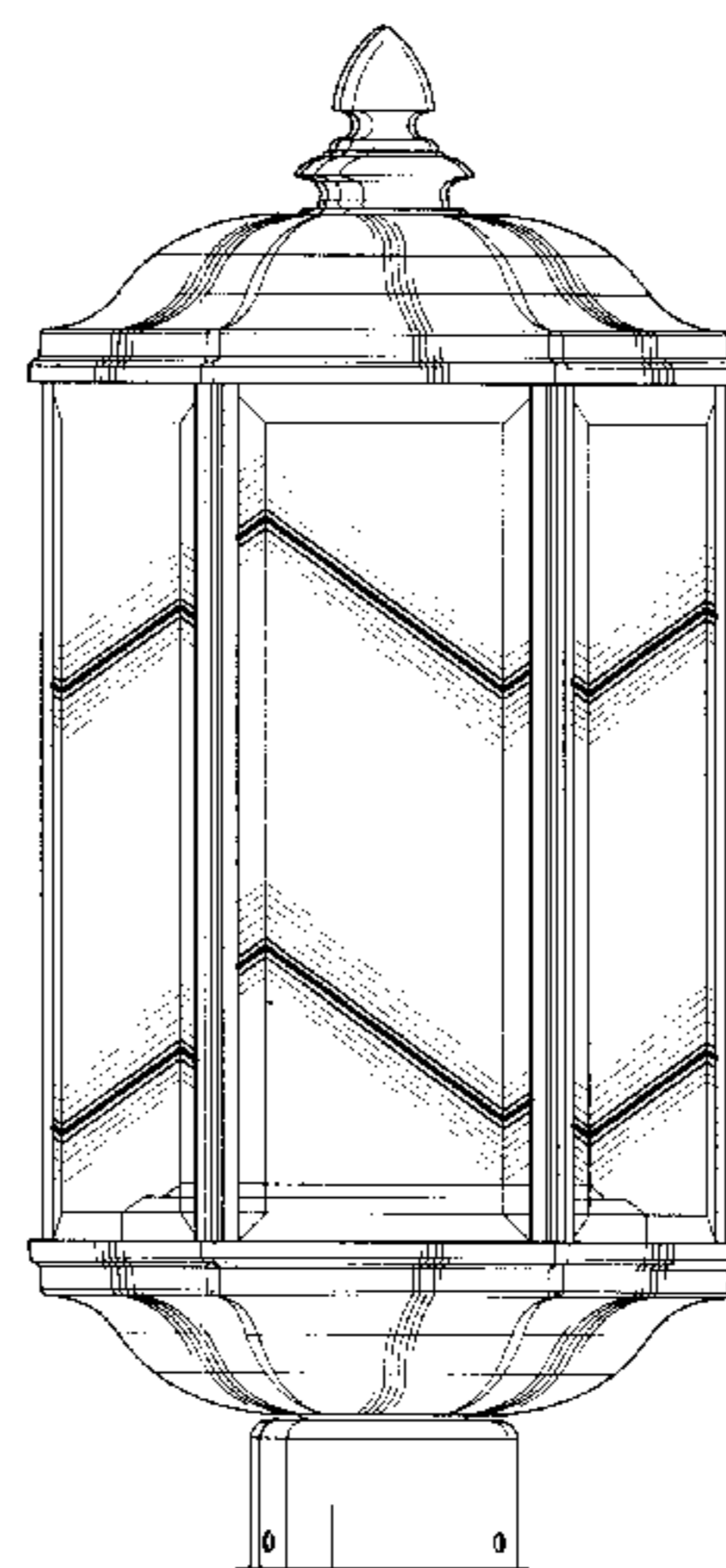
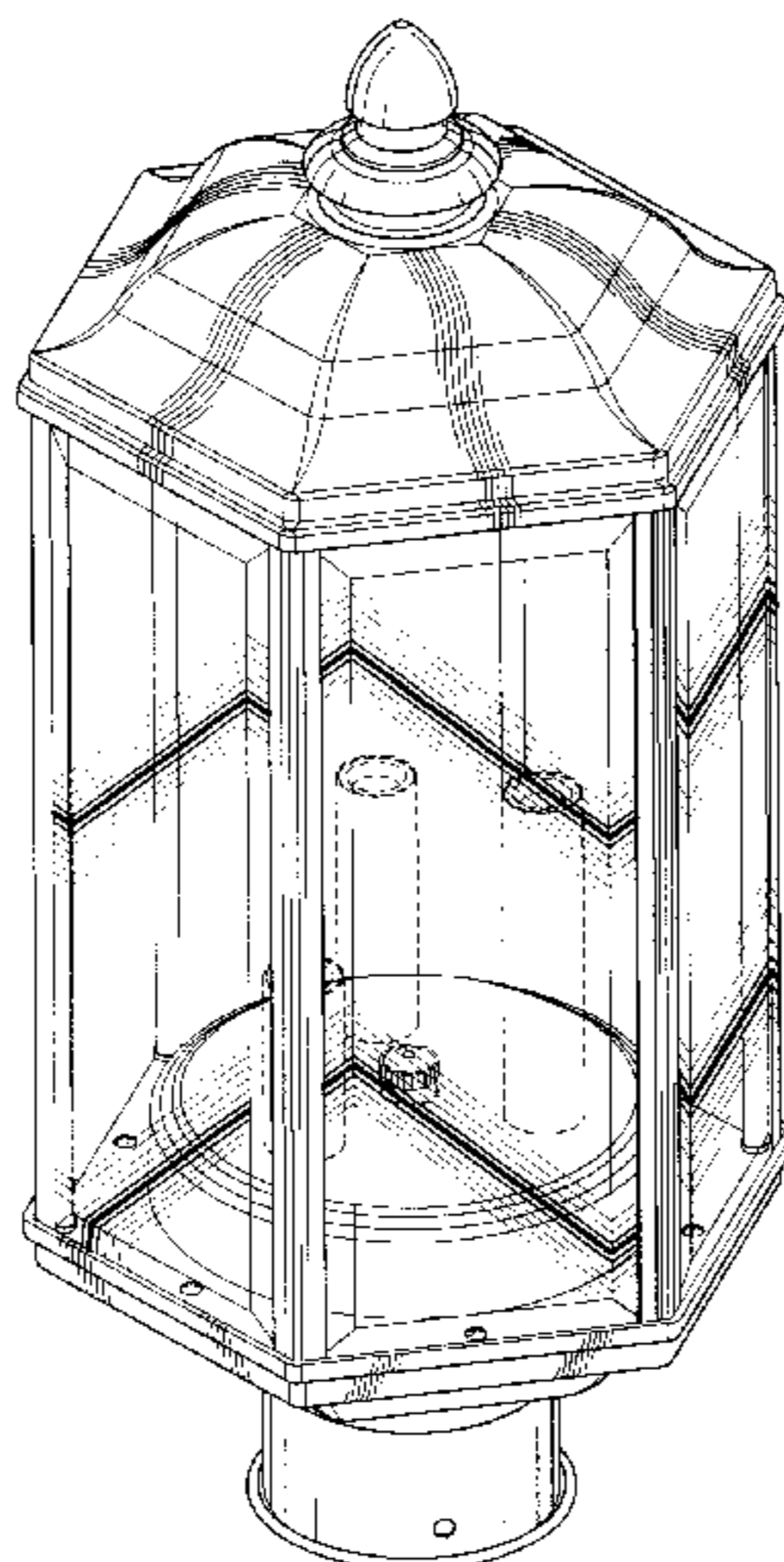
FIG. 3 is a left side elevational view thereof, the right side being a mirror image;

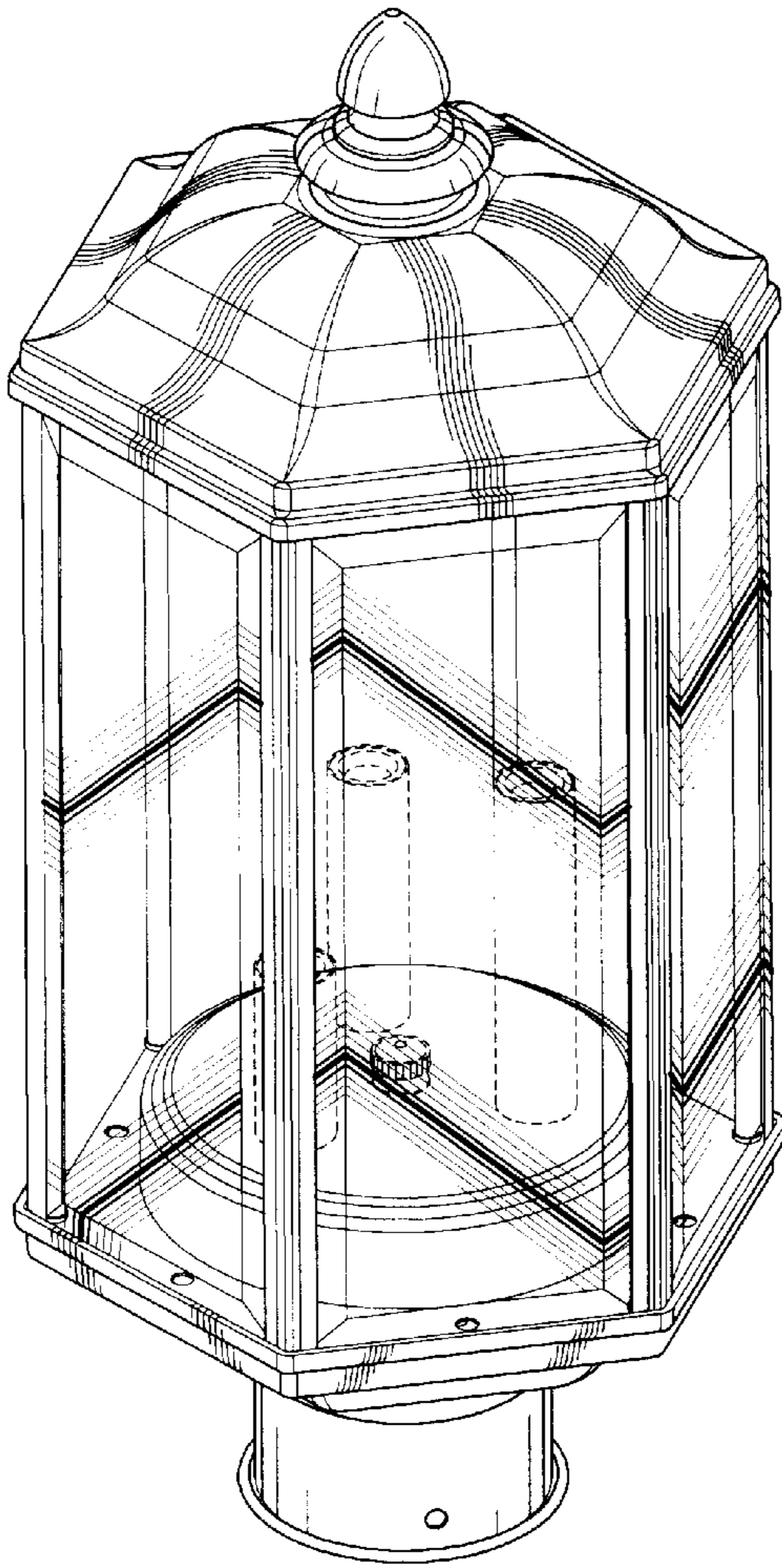

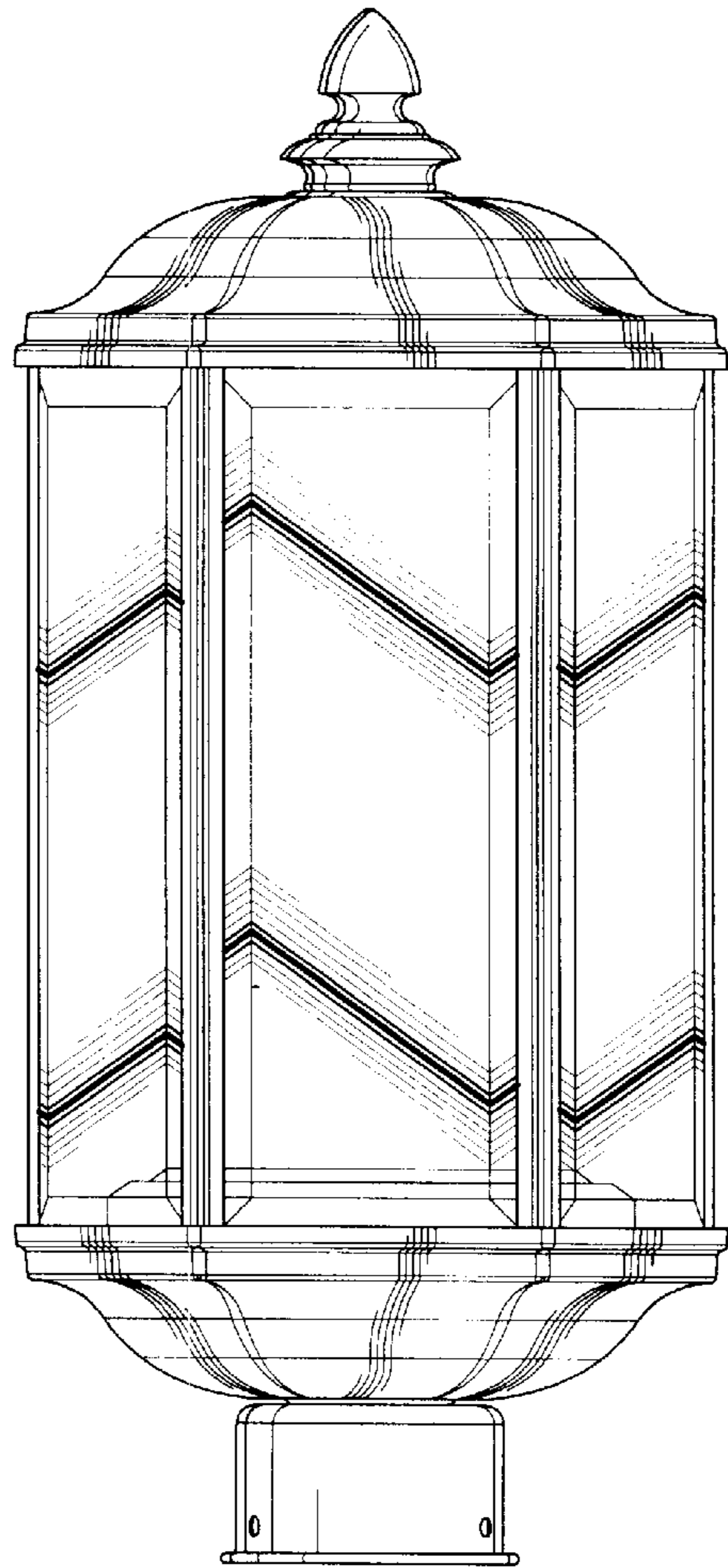

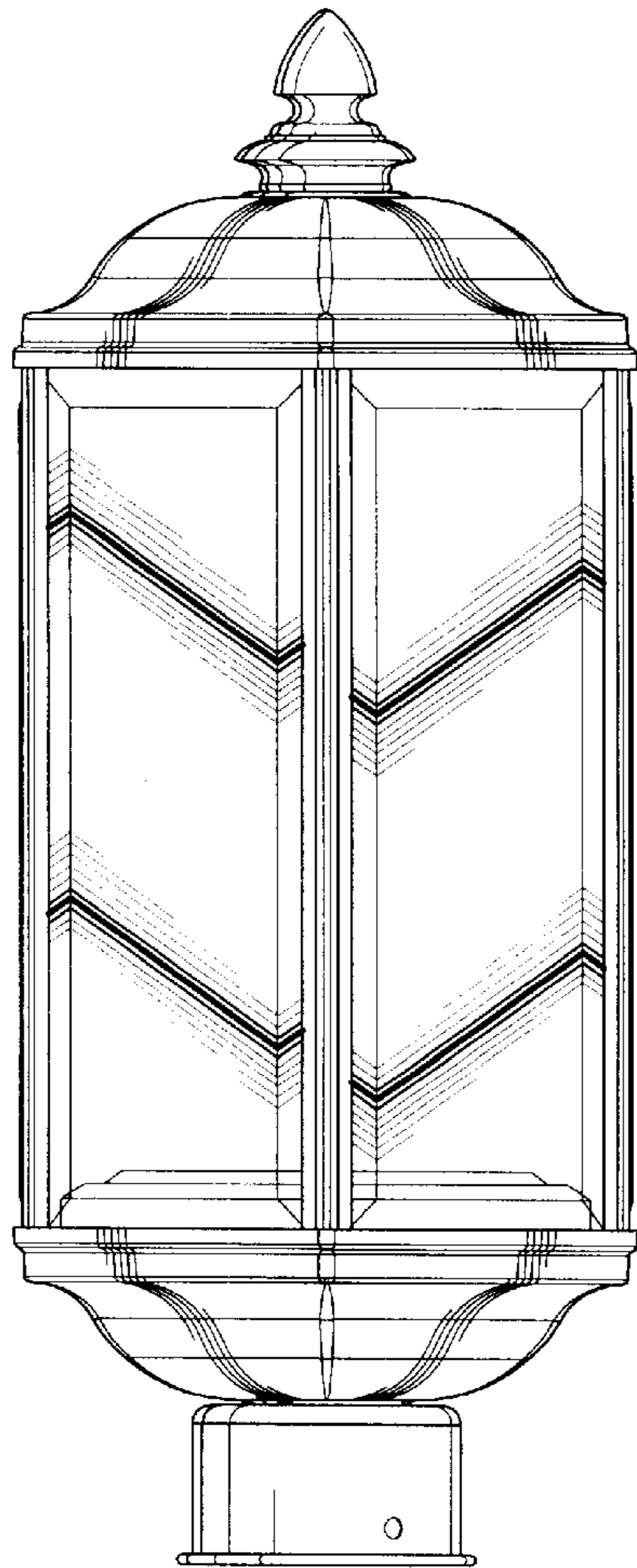

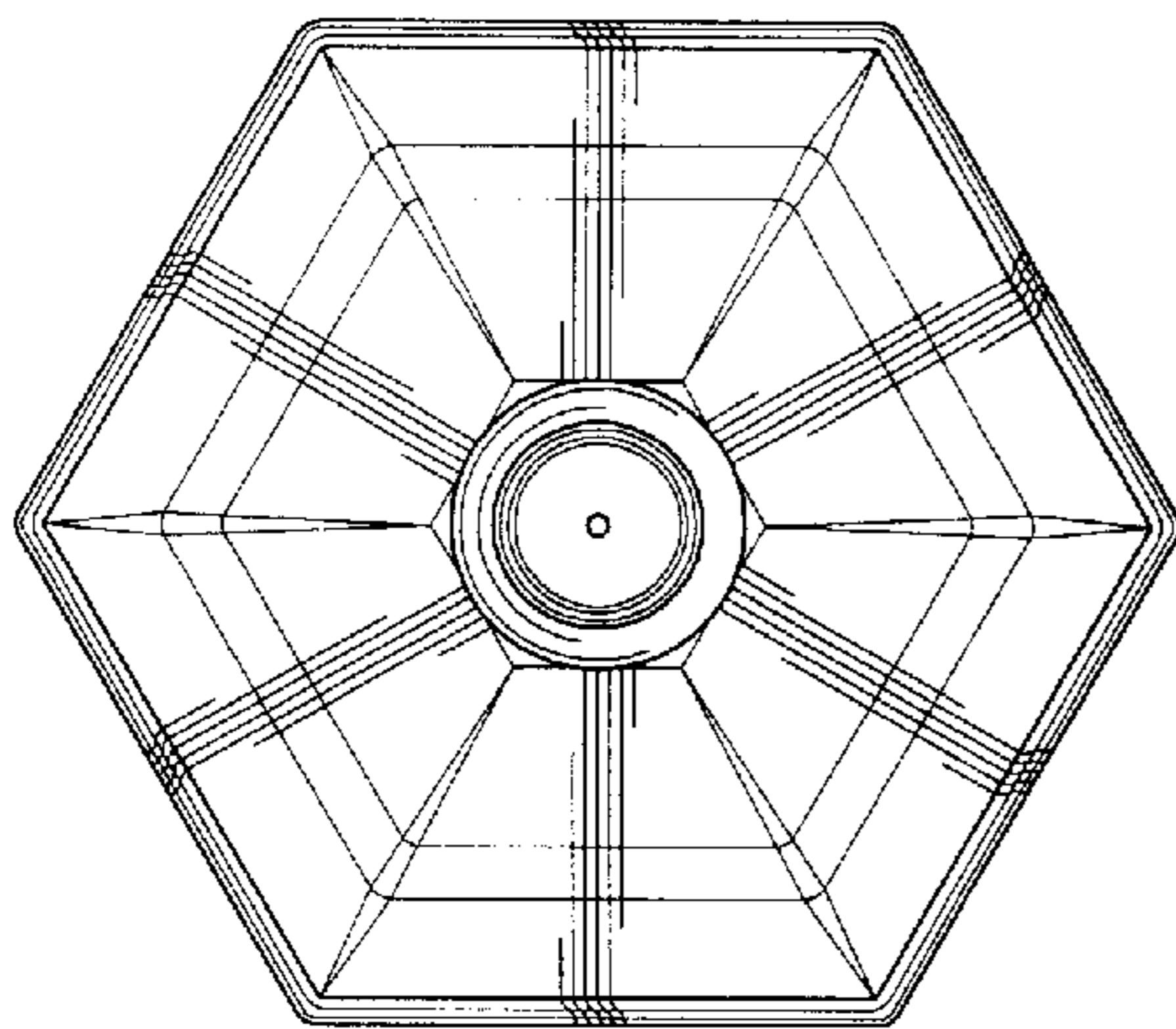

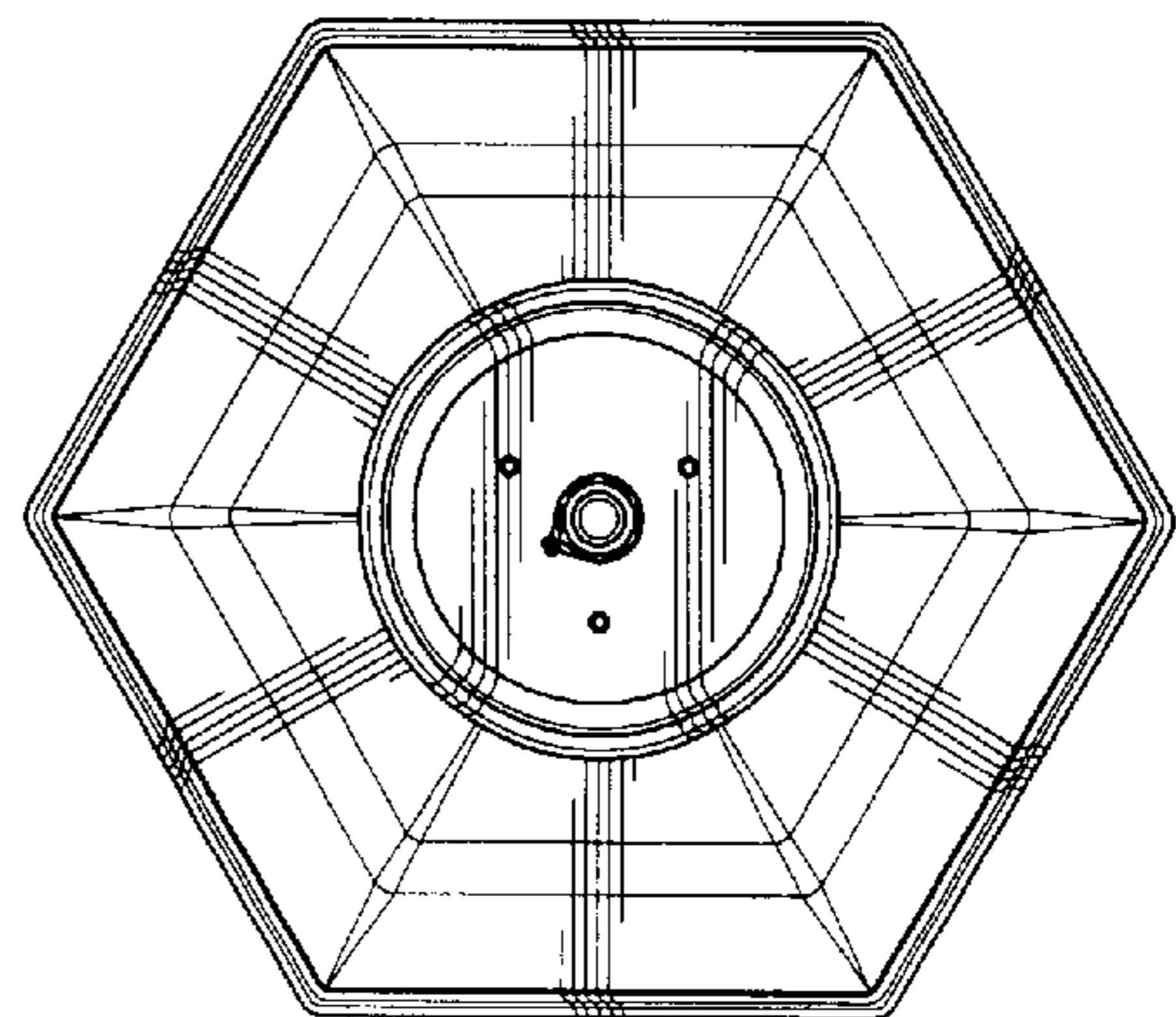
