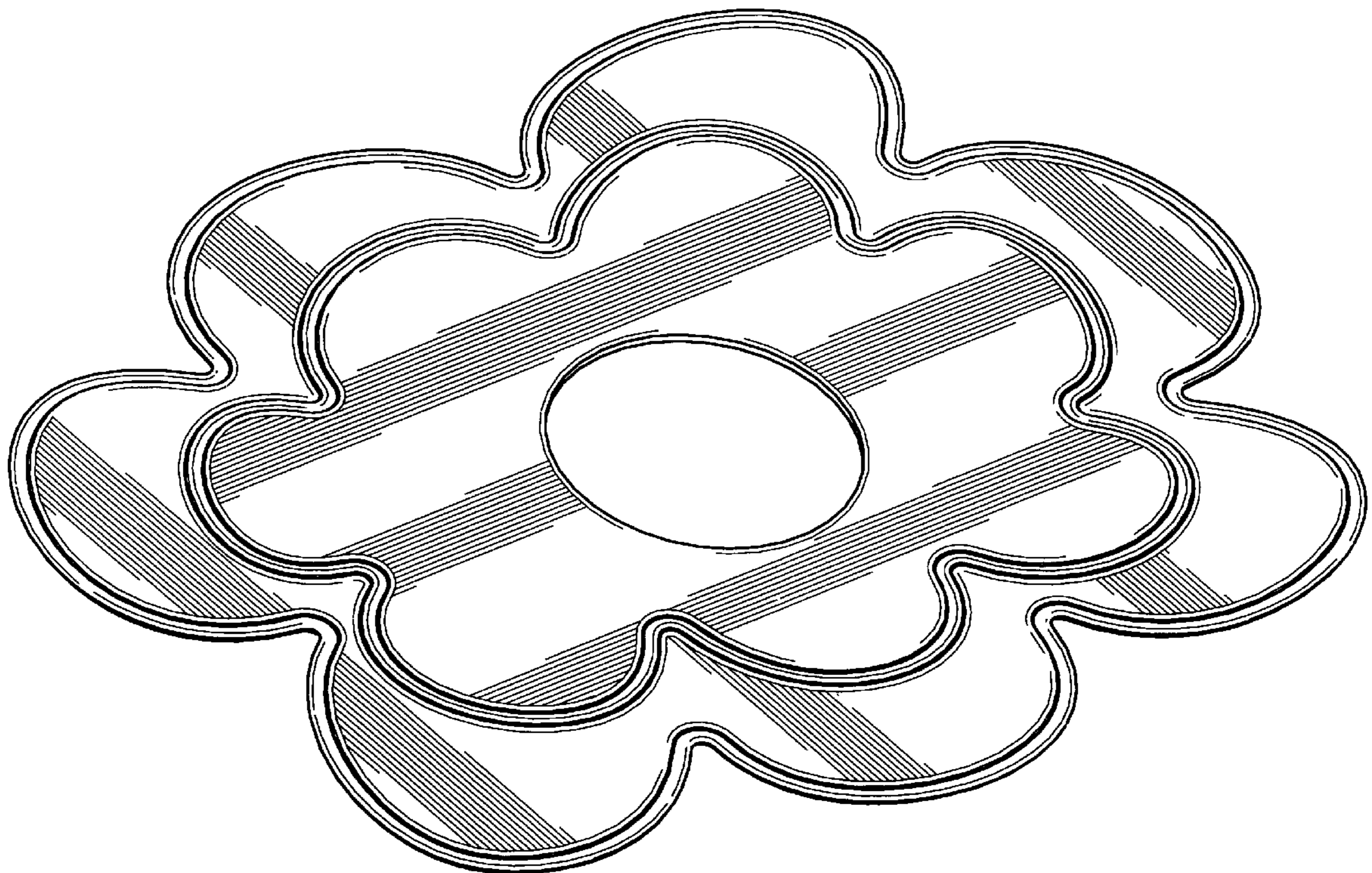
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top left front perspective view of a sink mat showing my new design;
FIG. 2 is a top plan view thereof;

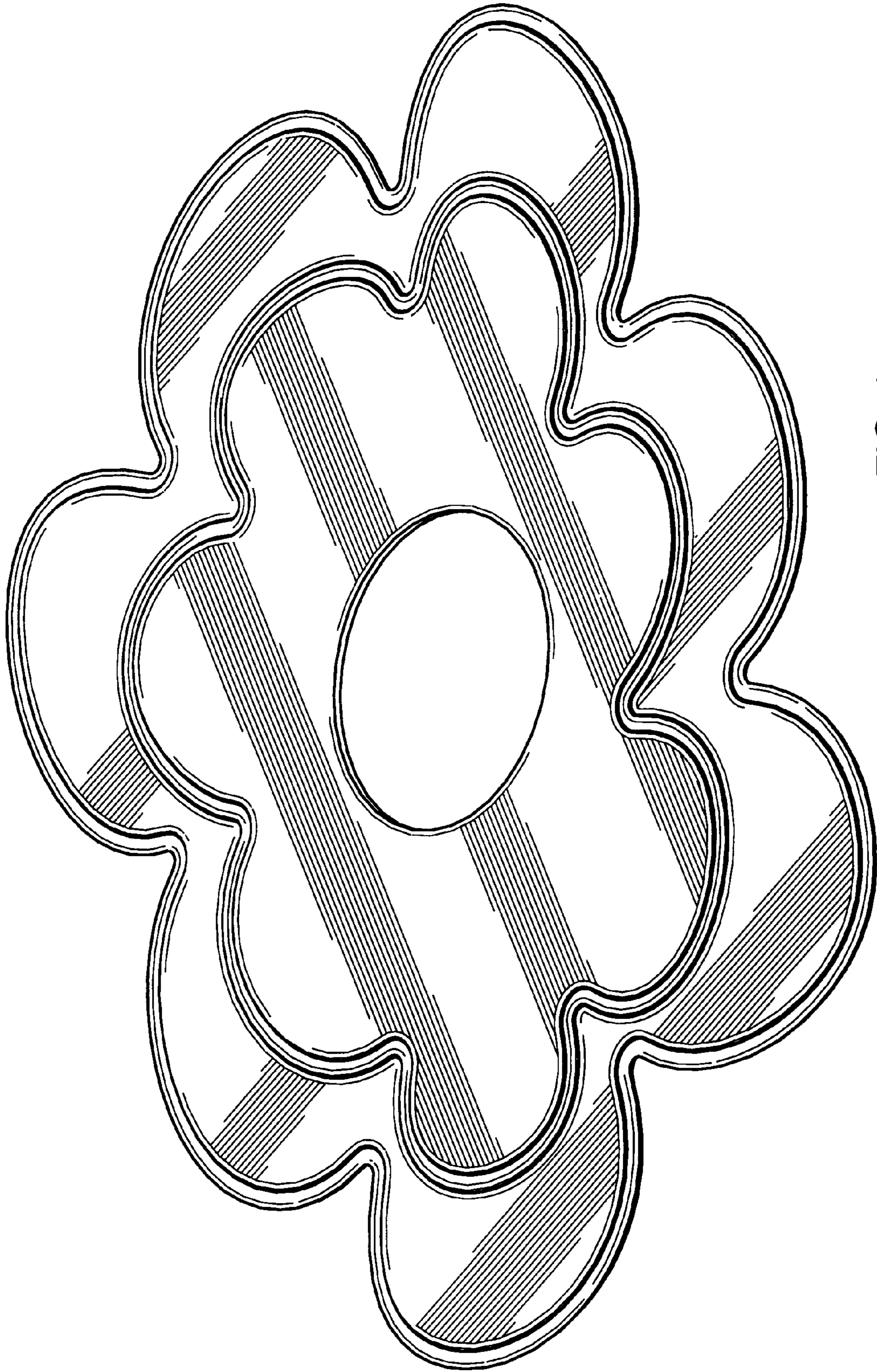

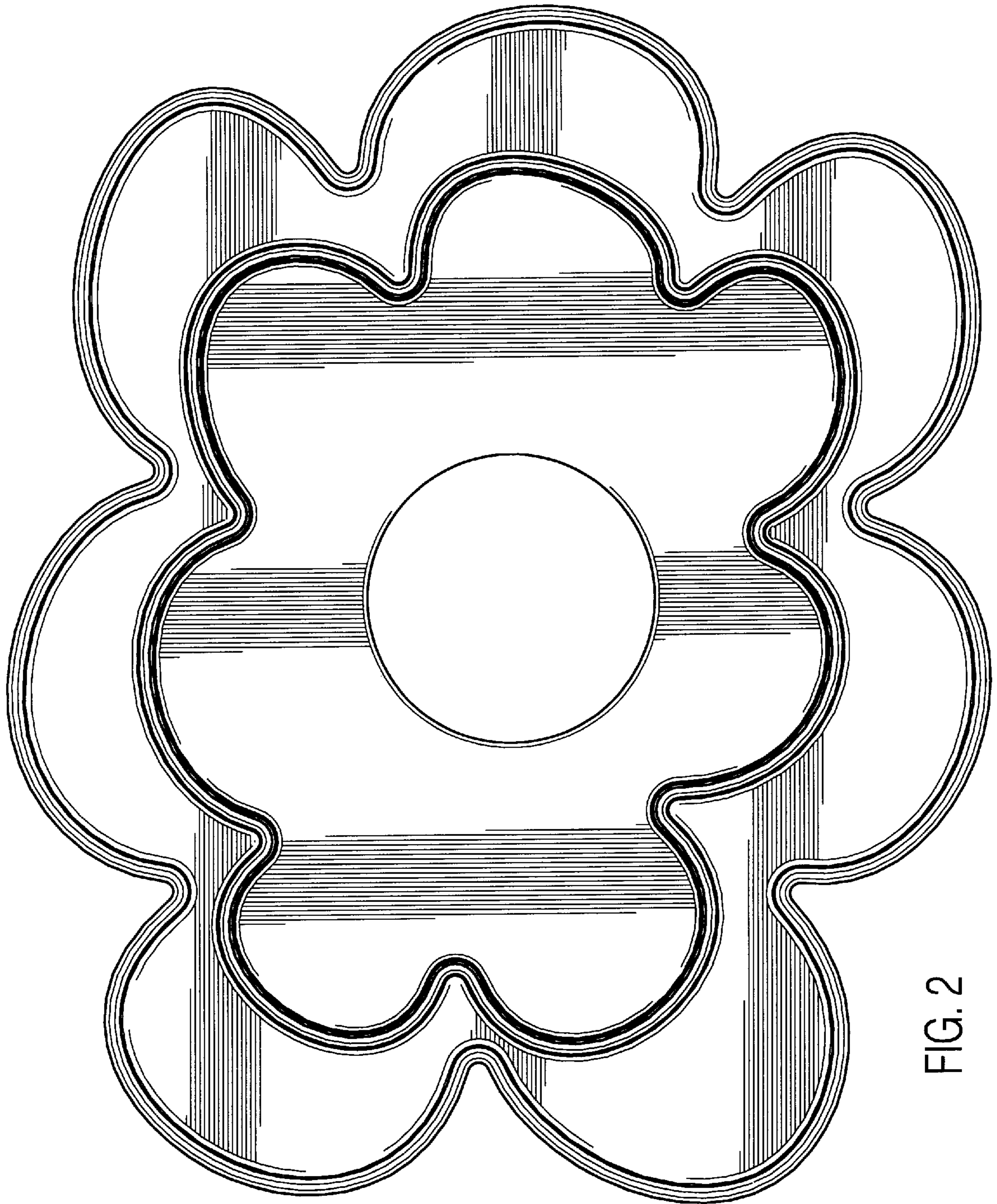

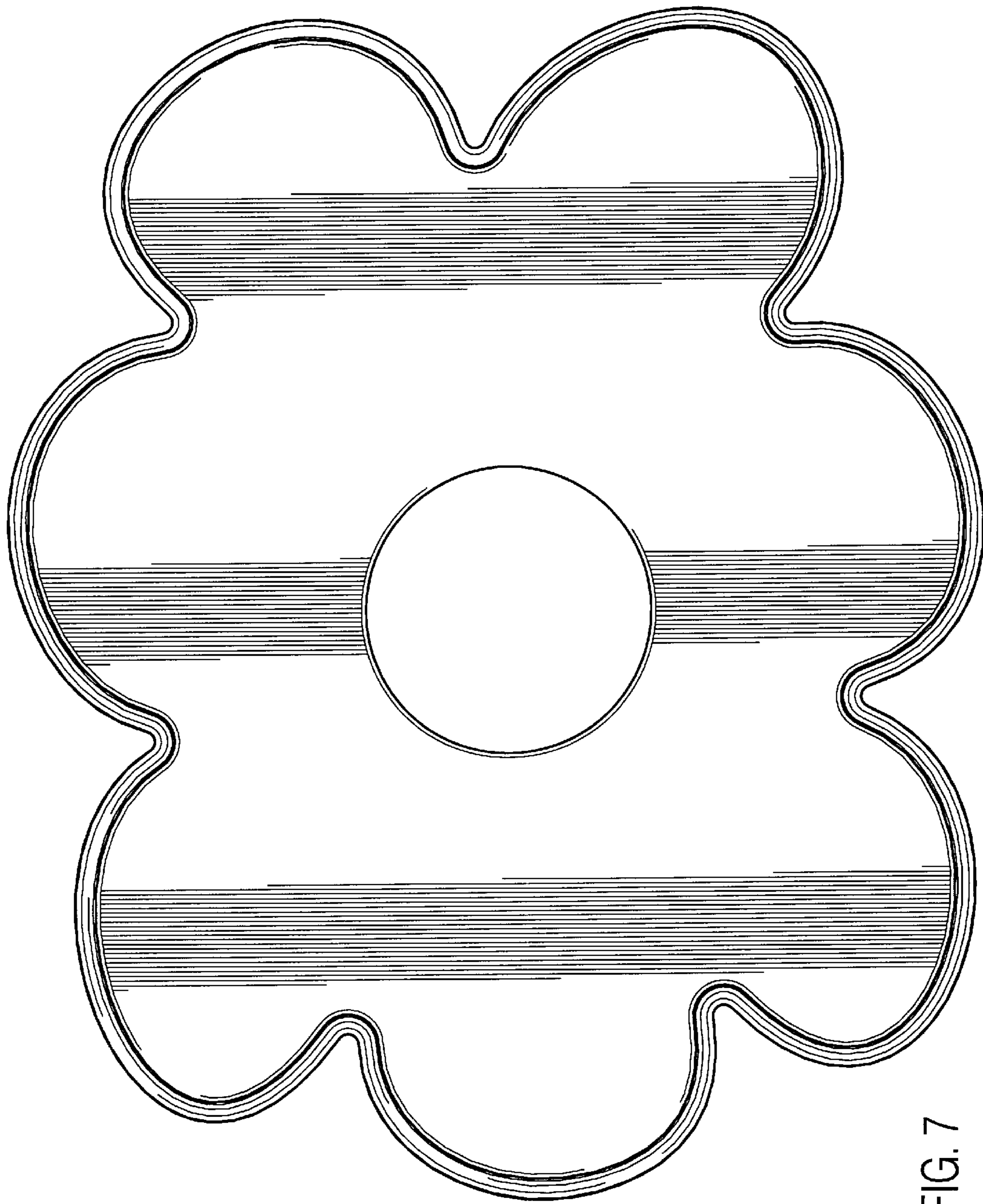
