The ornamental design for a case for a portable telephone, as shown and described.

DESCRIPTION

FIG. 1 is a left, front and bottom side perspective view of a

first embodiment of a case for a portable telephone showing our new design;

FIG. 11 is a front side elevation view of our new design, as shown in FIG. 8;

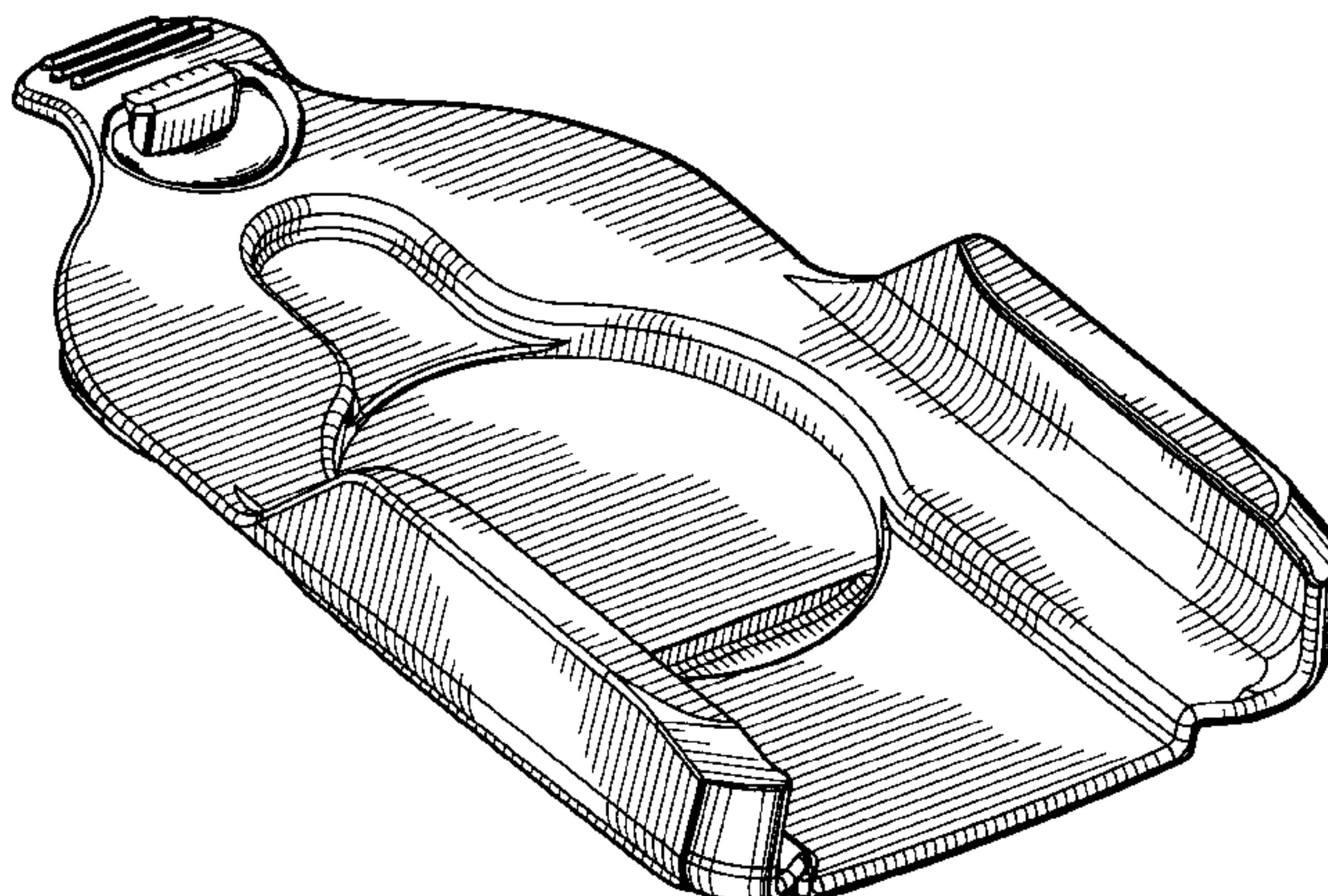
FIG. 12 is a right side elevation view of our new design, as shown in FIG. 8;

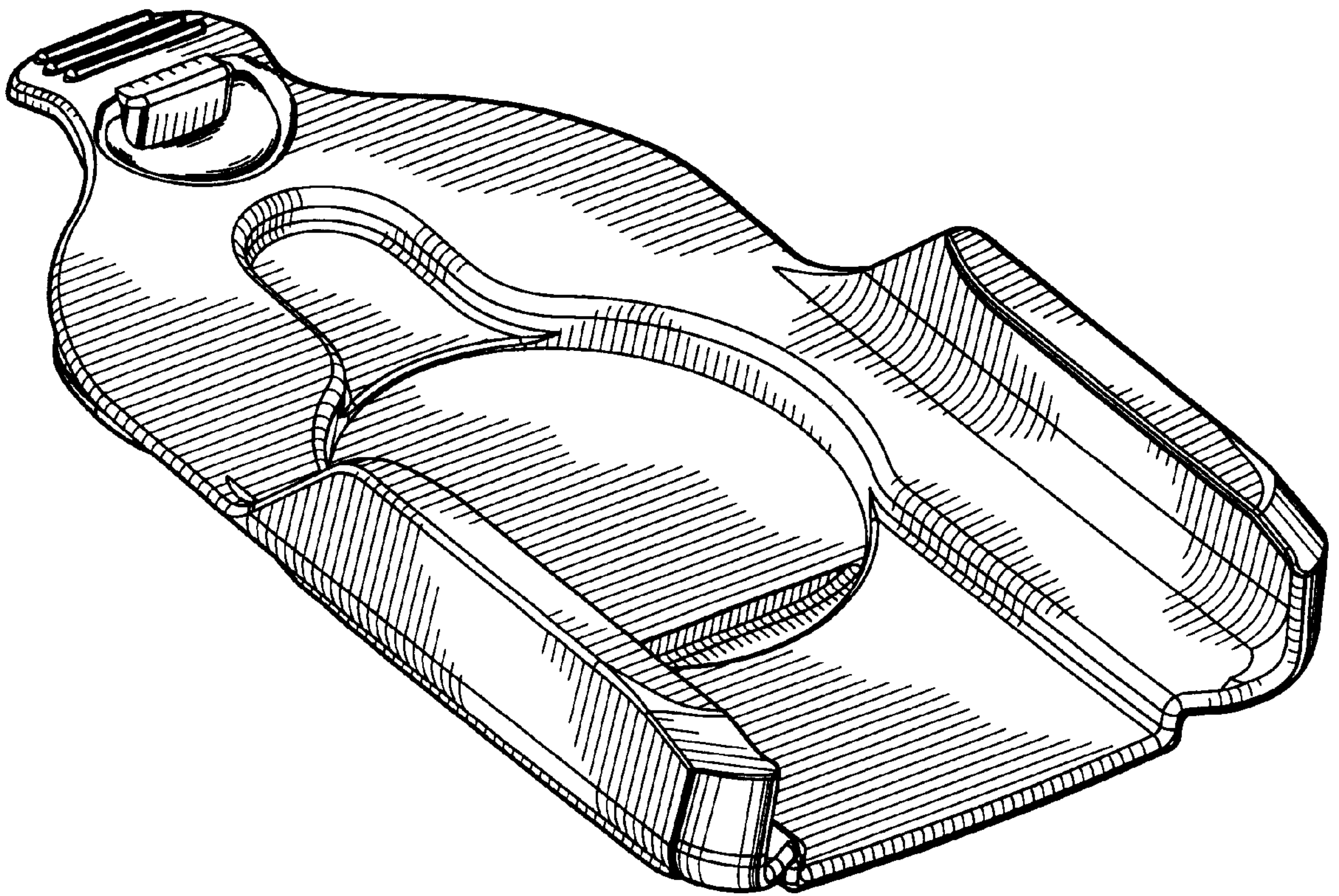

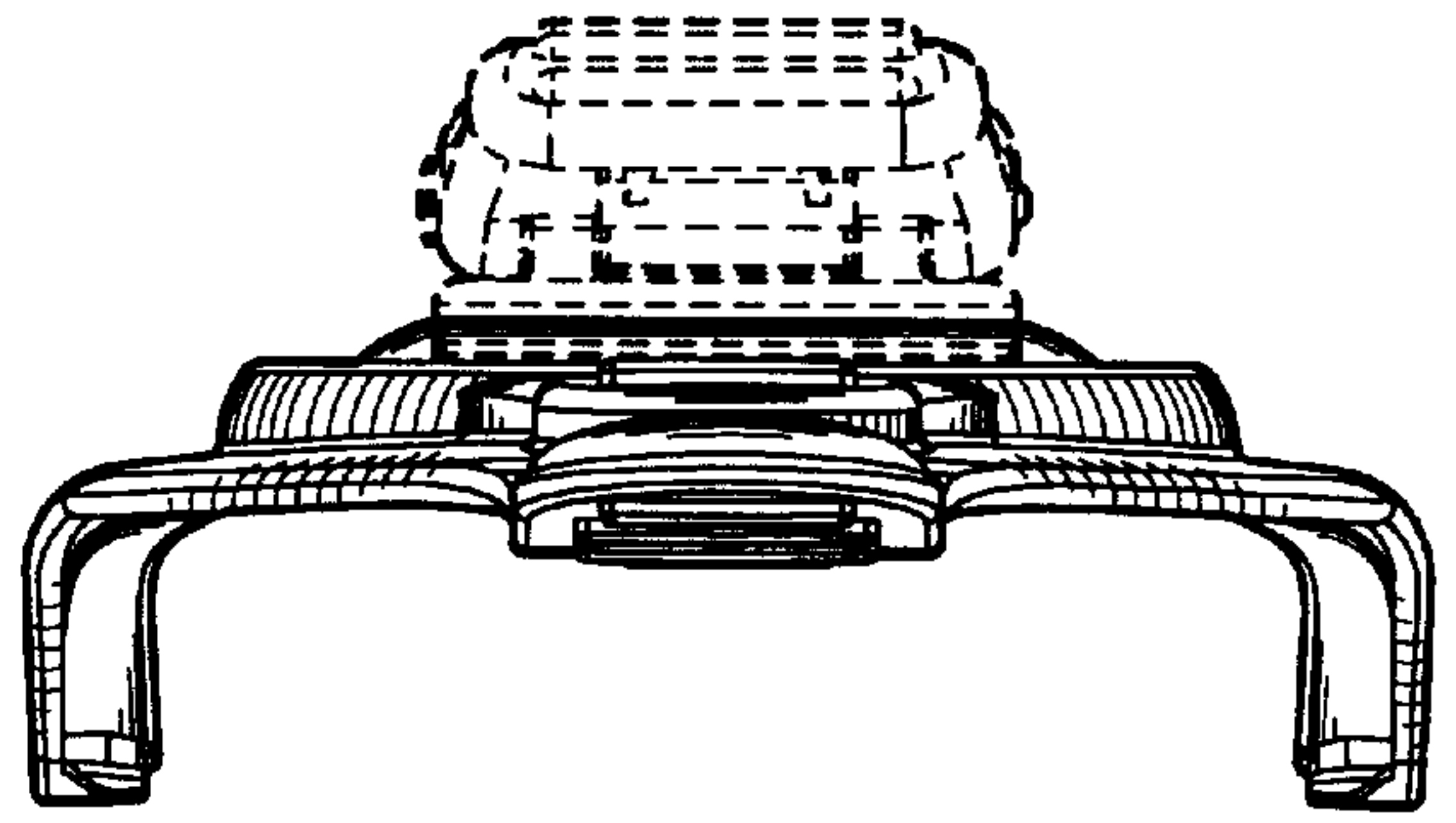

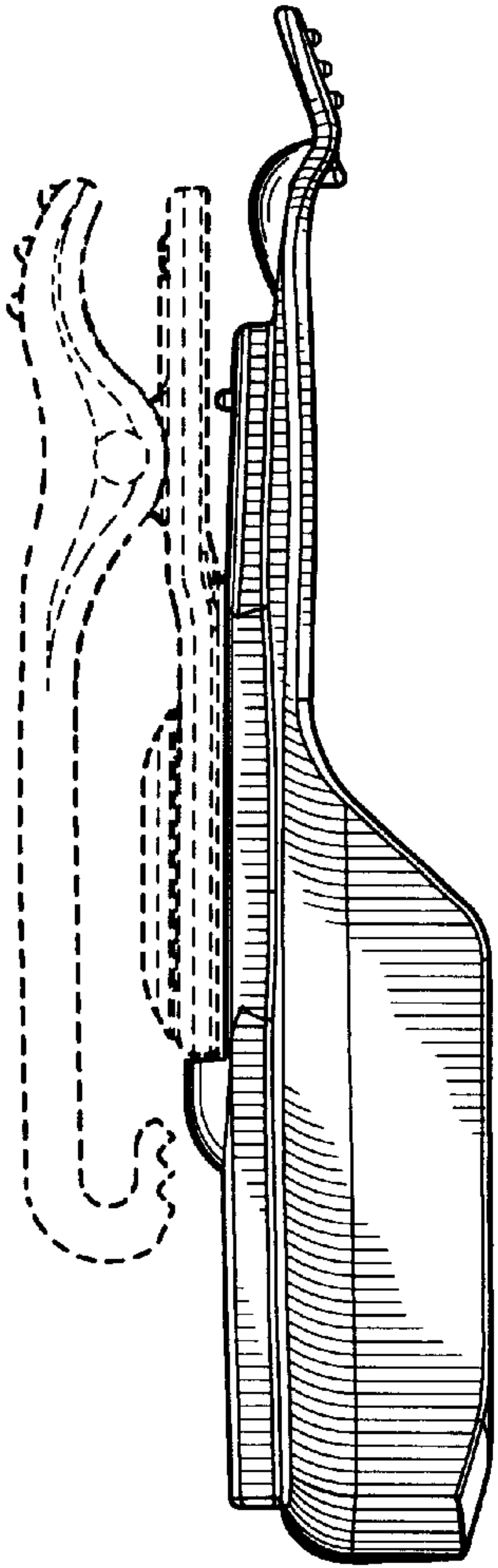

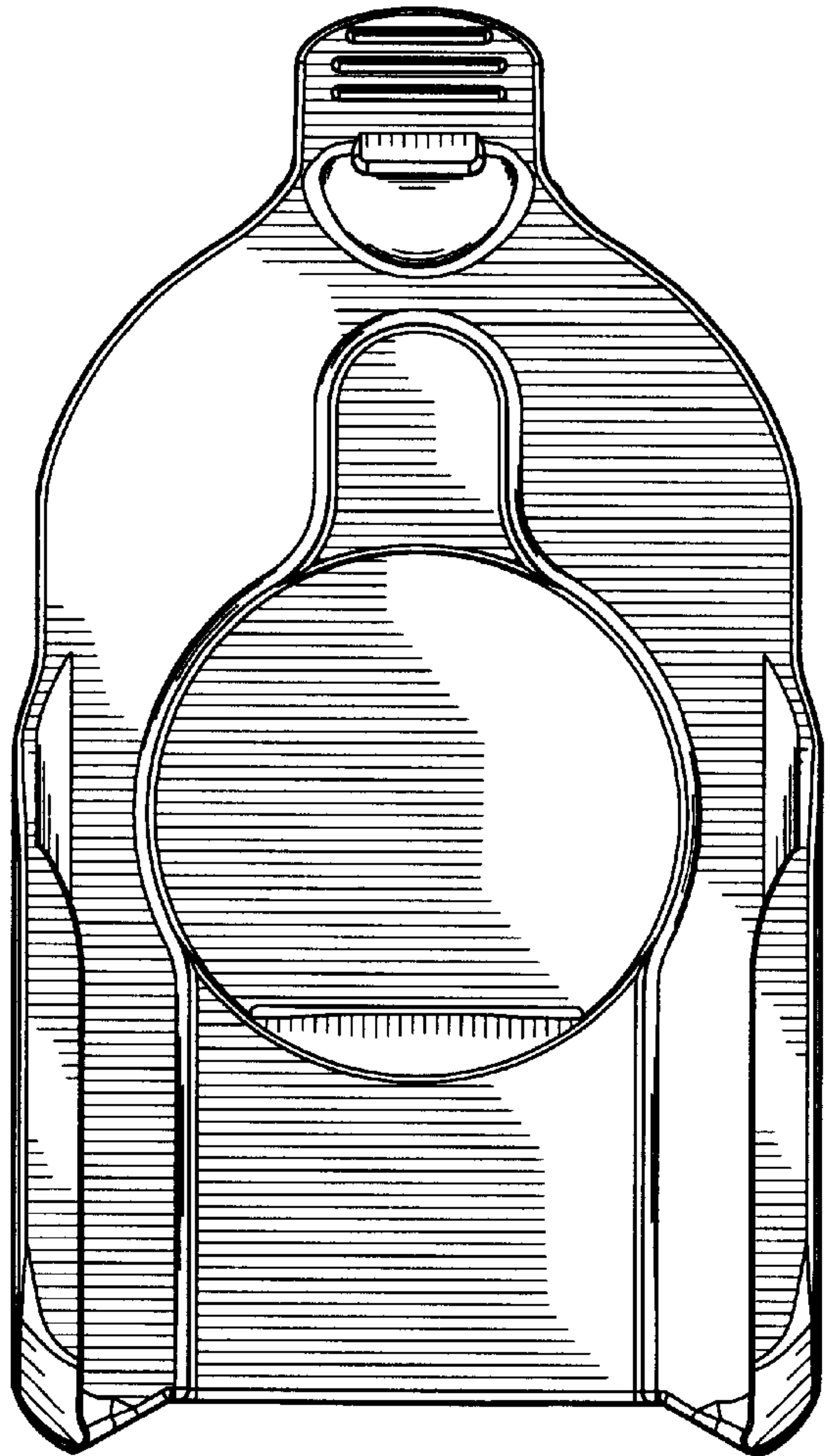

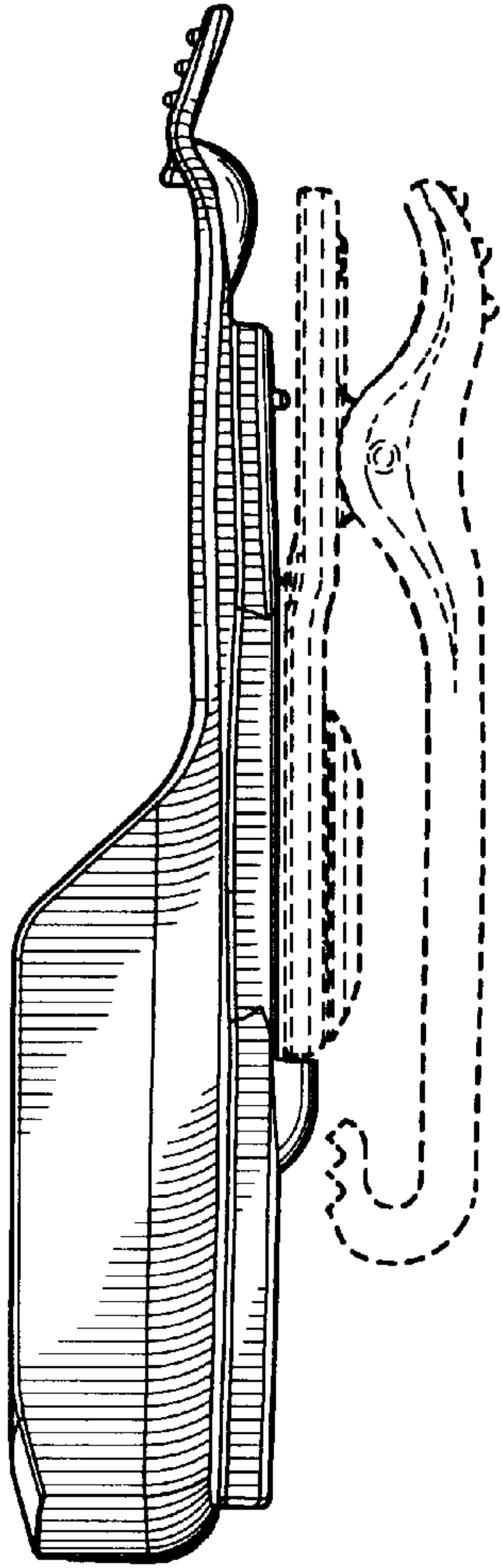

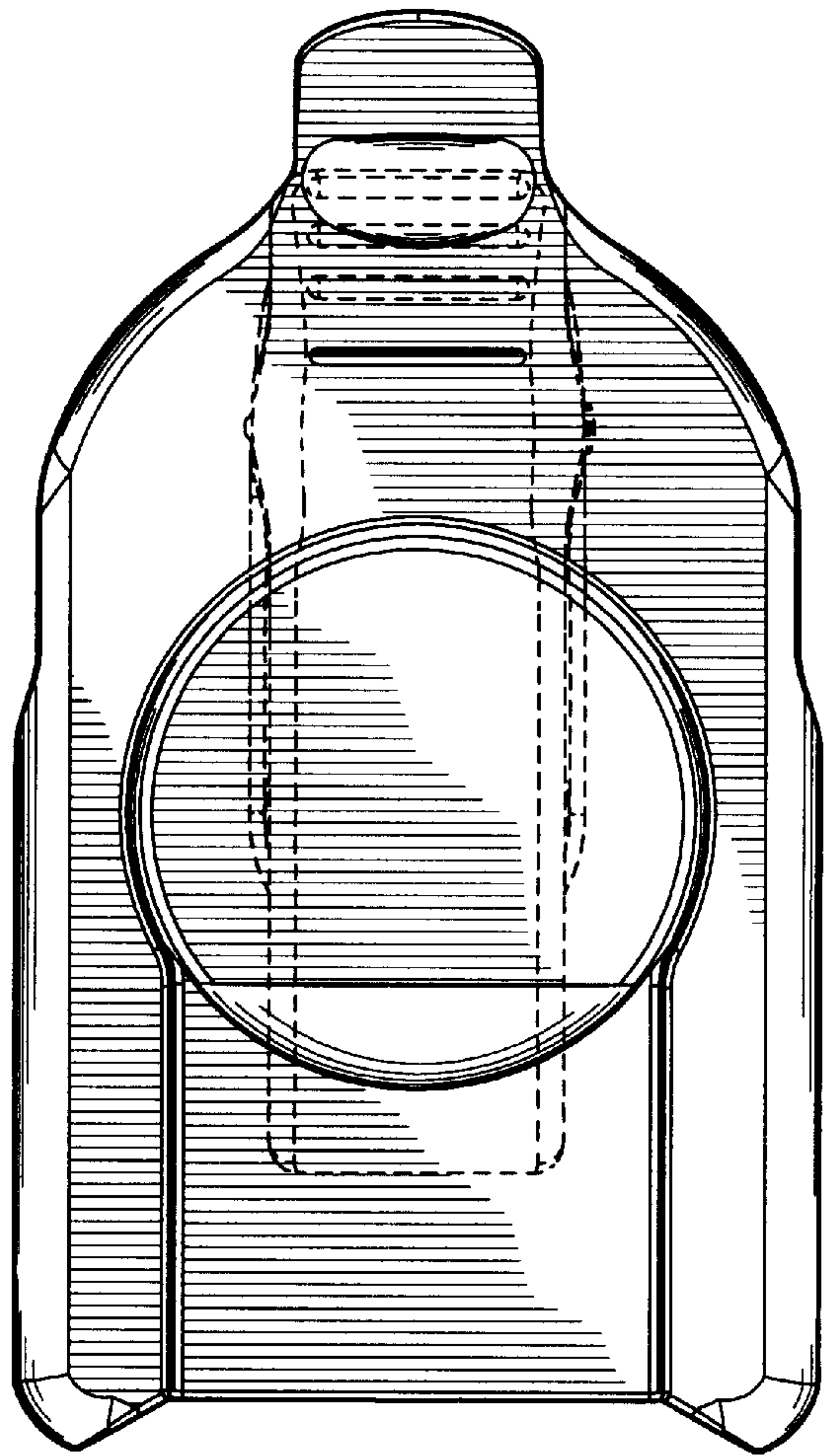

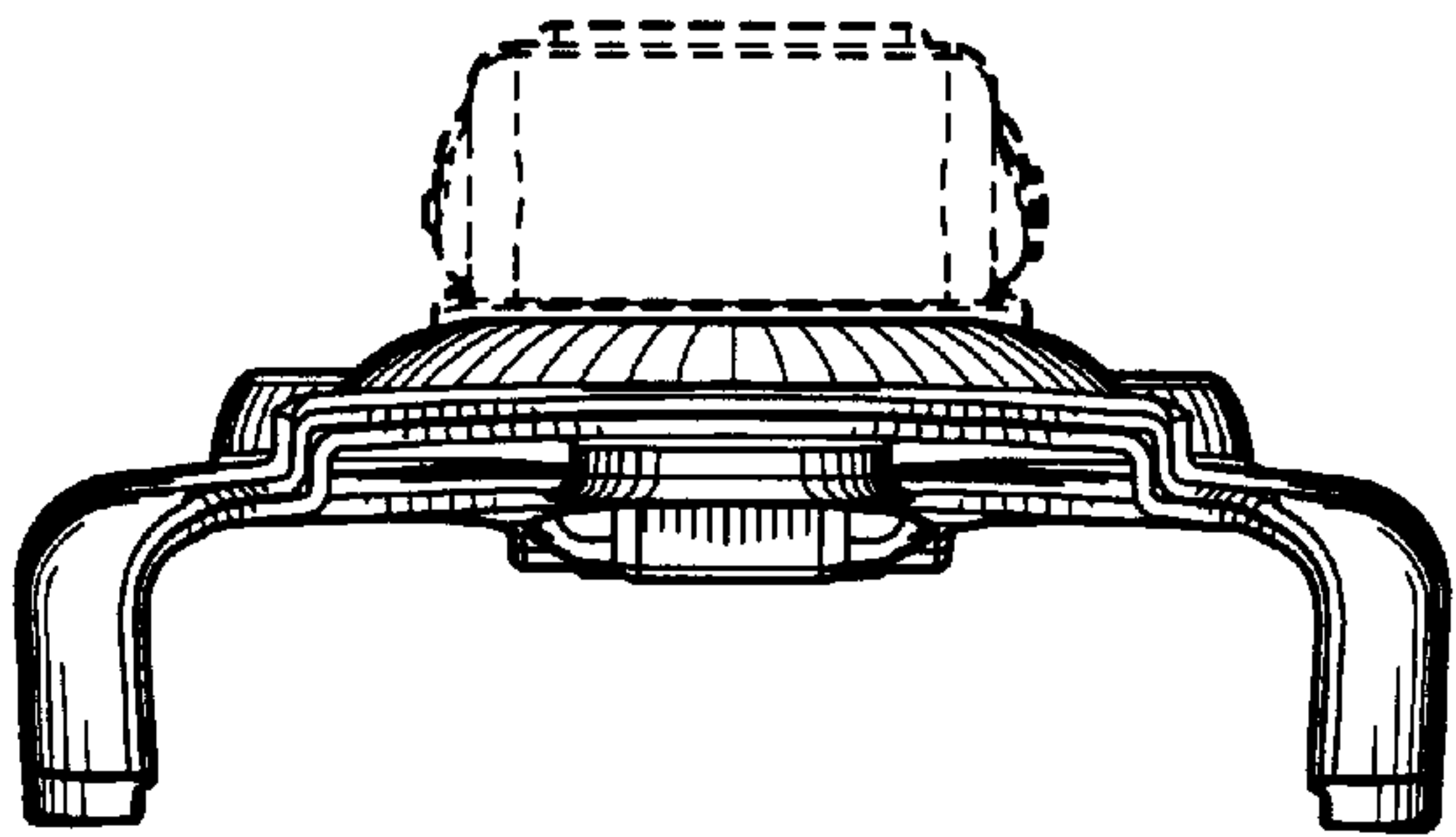

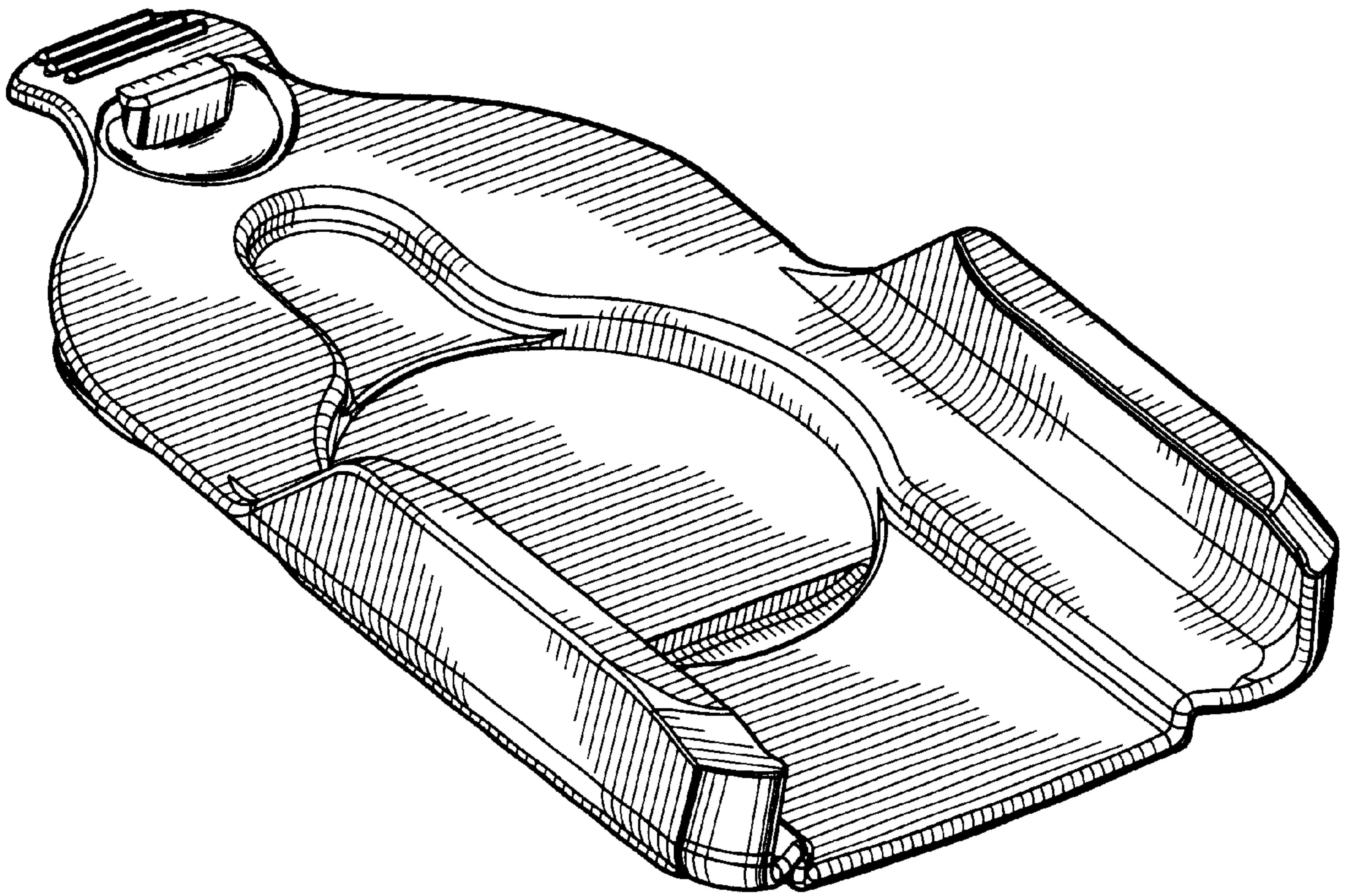

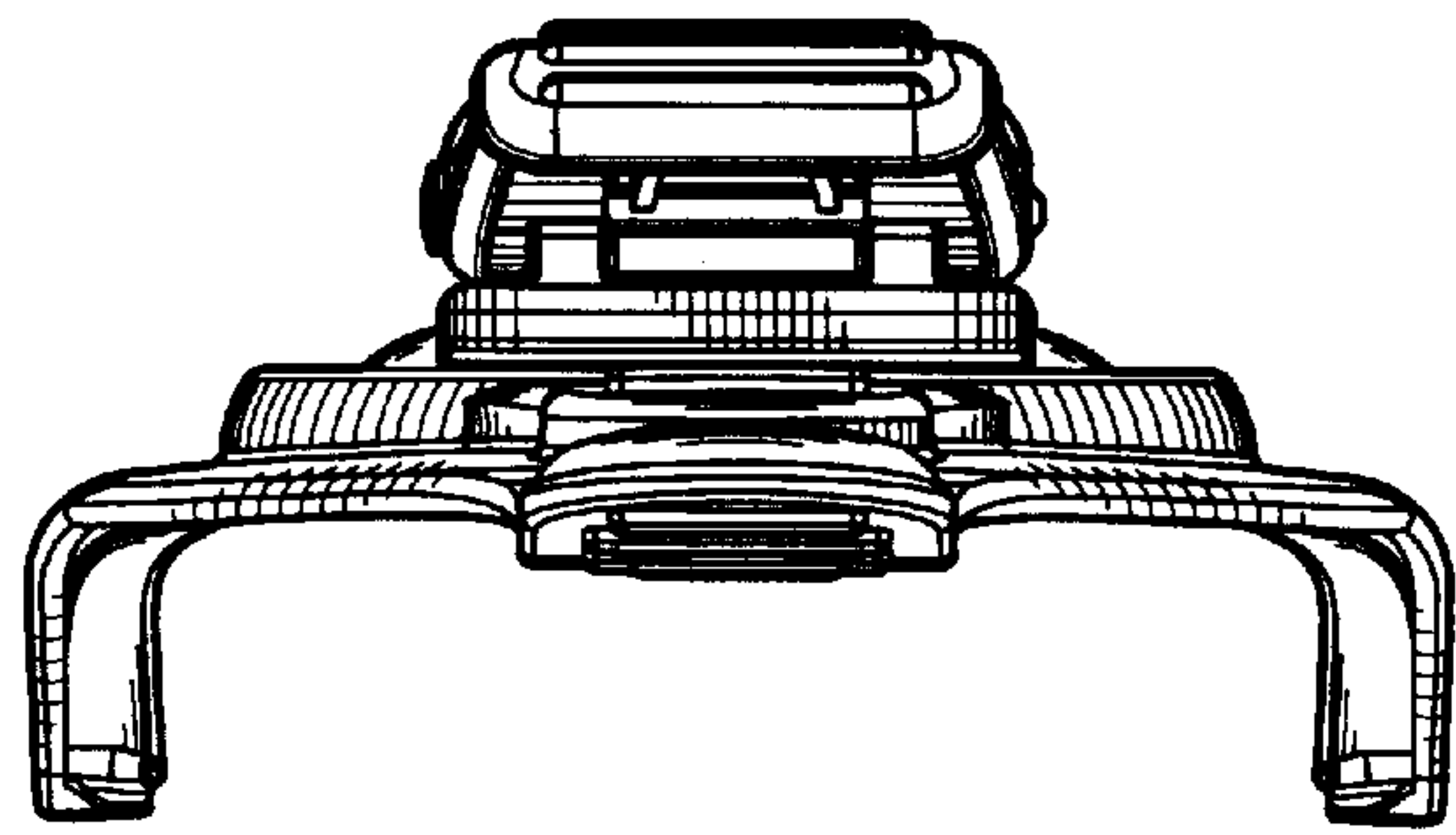

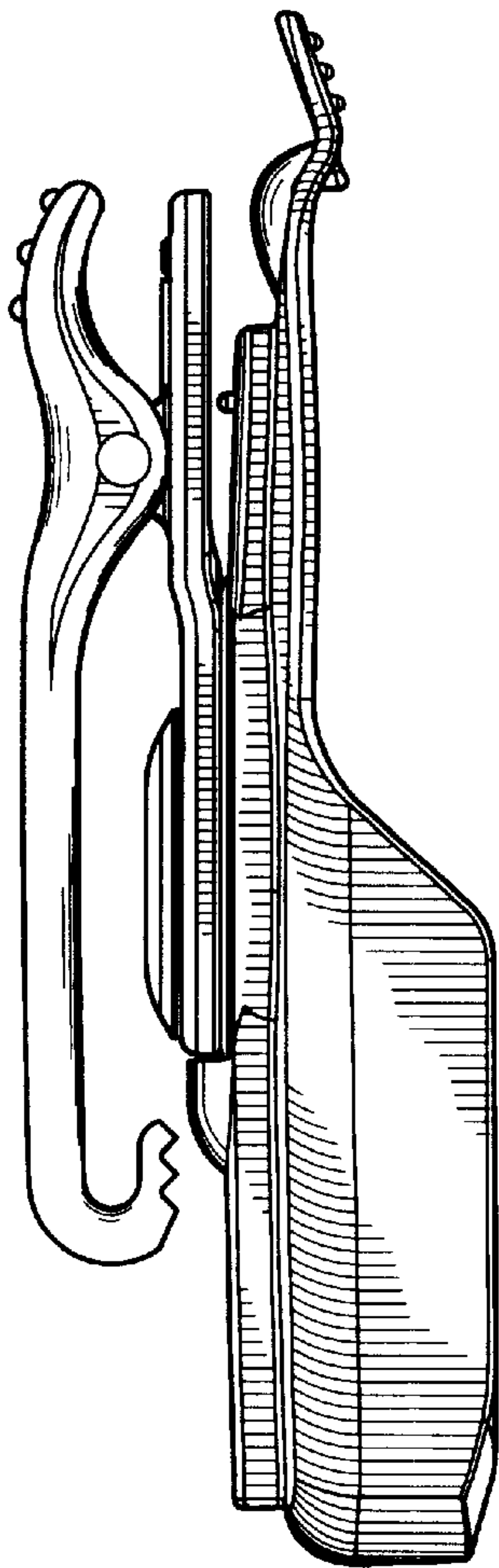

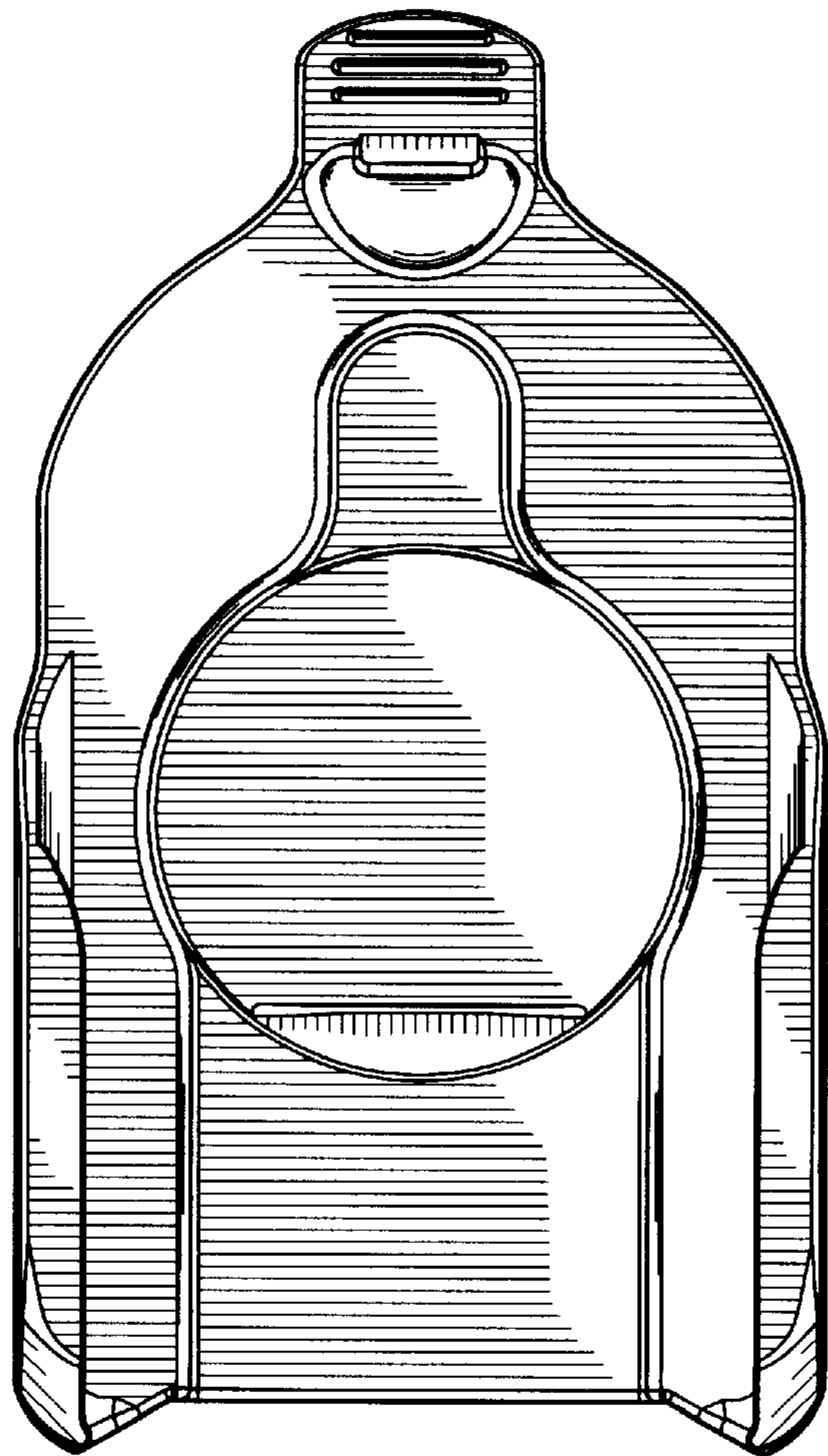

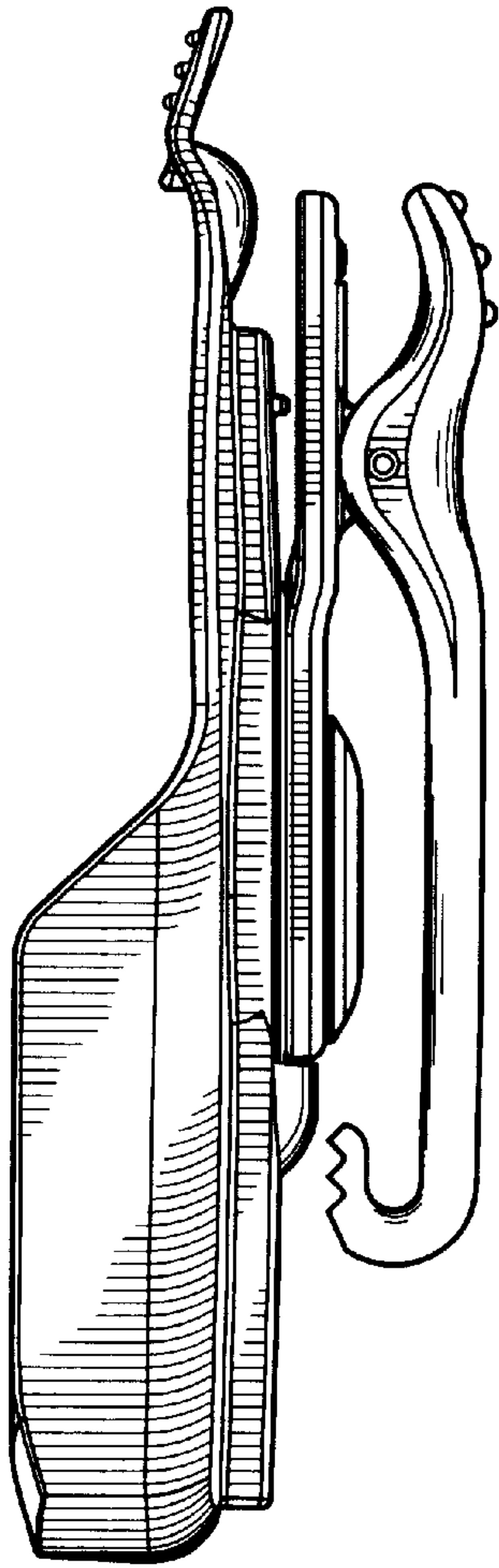

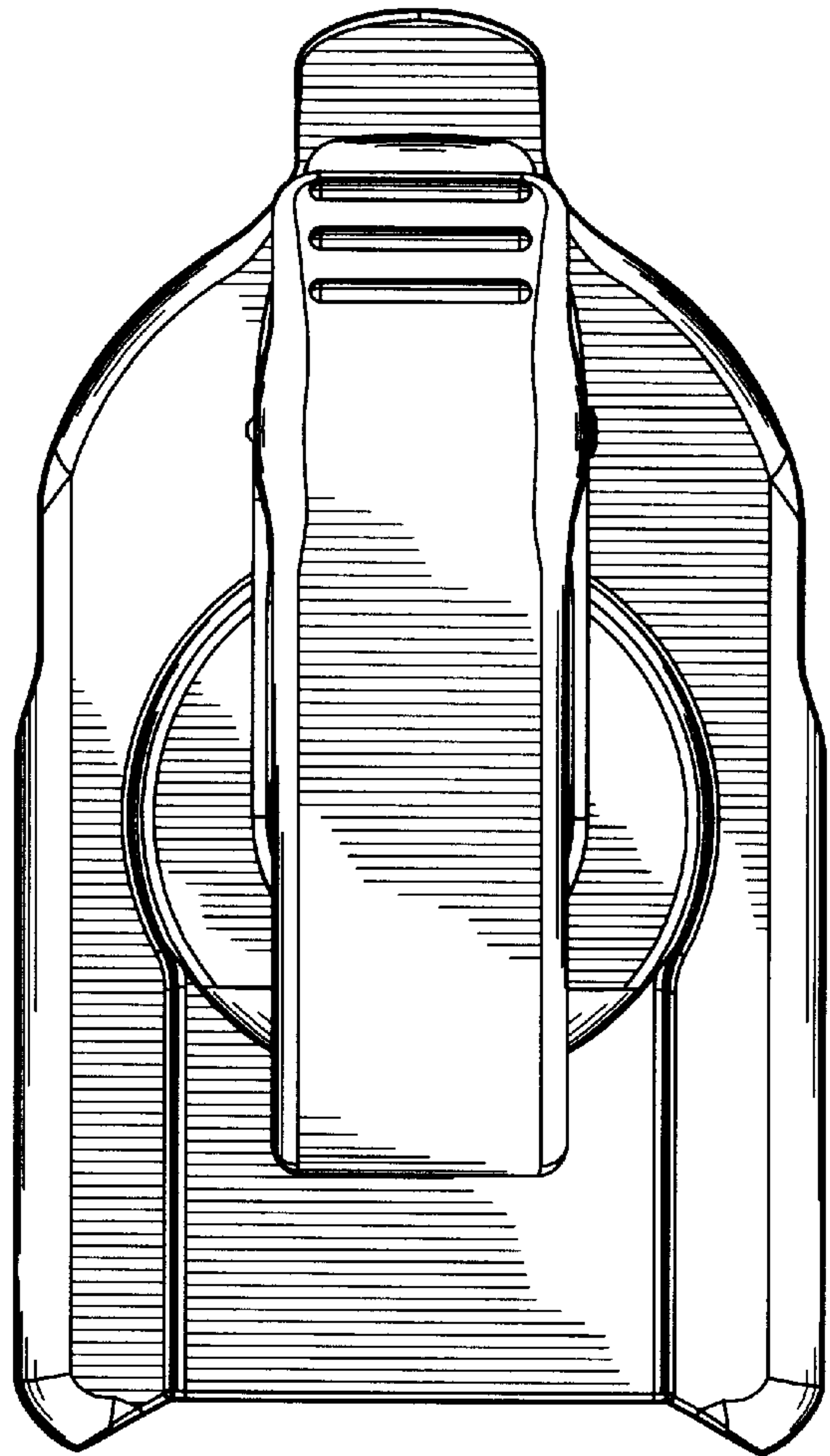

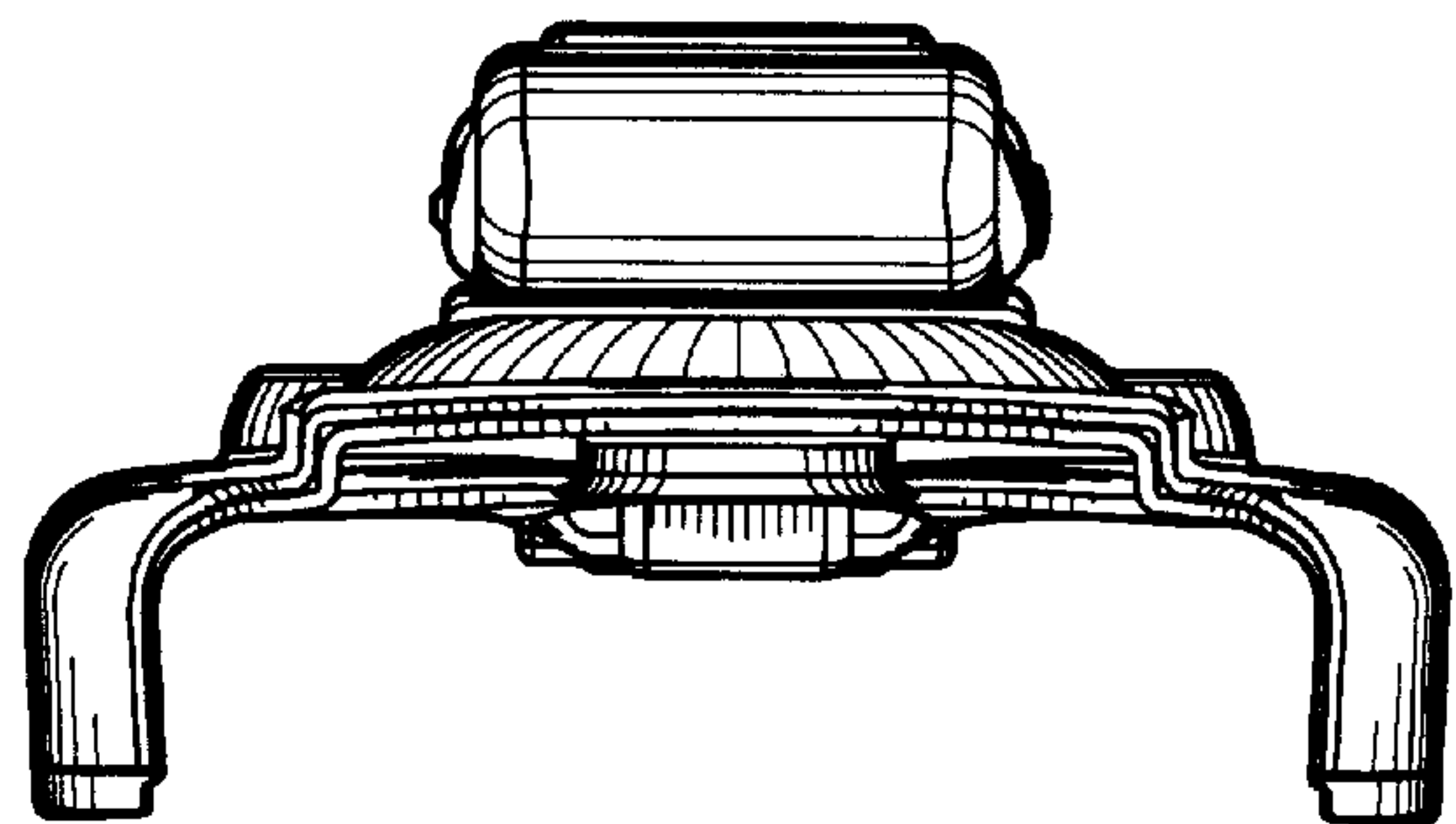
