[57] CLAIM

The ornamental design for one-piece end closure with re-closable punch out lid, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the one piece end closure with re-closable punch out lid of my new design shown on a container, with the tab in the closed position;
FIG. 2 is a perspective view of the one piece end closure with re-closable punch out lid shown on a container, with the tab in the open position;
FIG. 3 is a top plan view of the one piece end closure with re-closable punch out lid;
FIG. 4 is a bottom plan view of the one piece end closure with re-closable punch out lid and with certain functional features shown in broken lines for illustrative purposes only and forming no part of the claimed design; and,
FIG. 5 is a side elevational view of my one piece end closure with re-closable punch out lid.
The broken line showing of a container is for illustrative purposes only and forms no part of the claimed design.

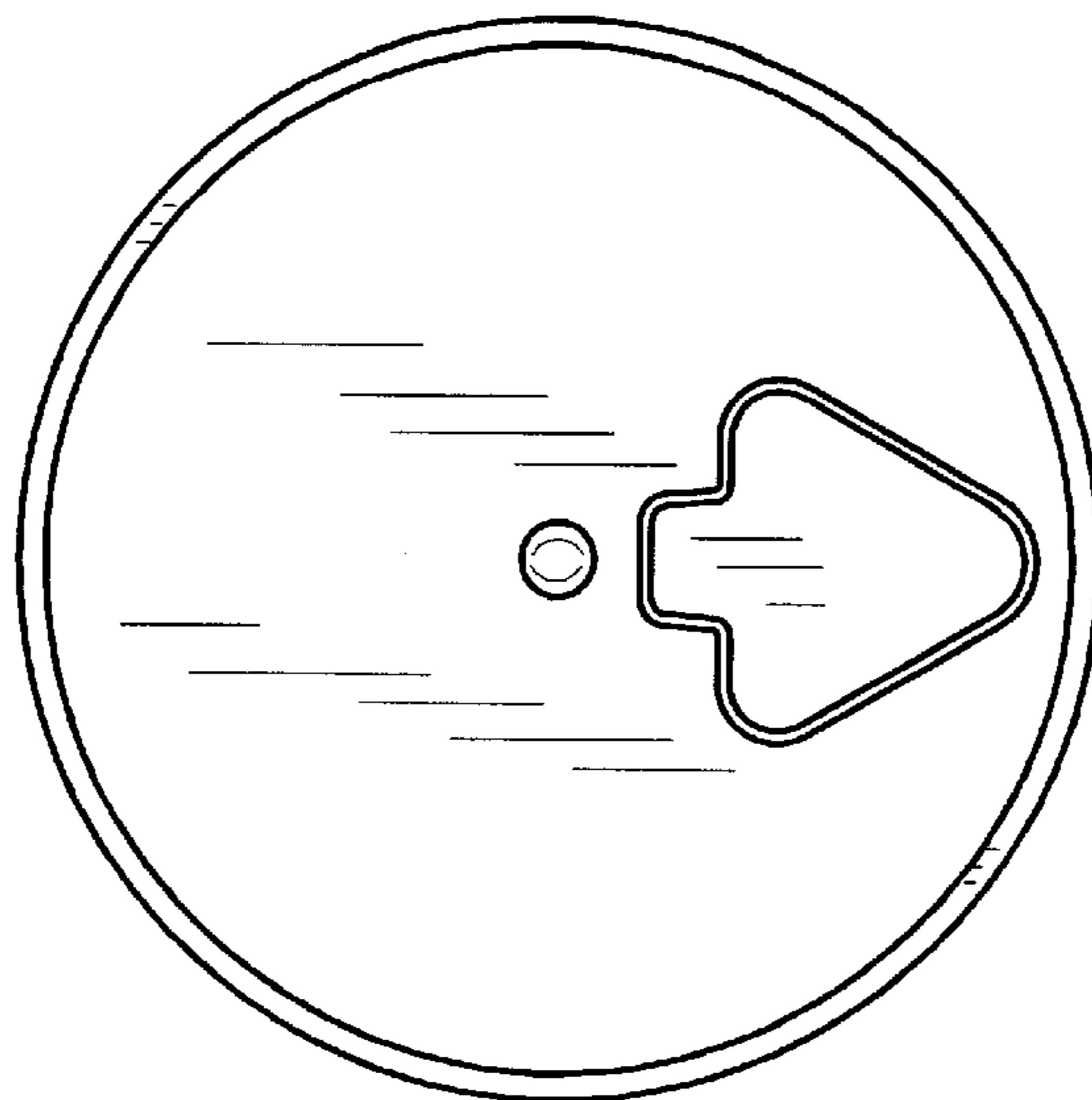

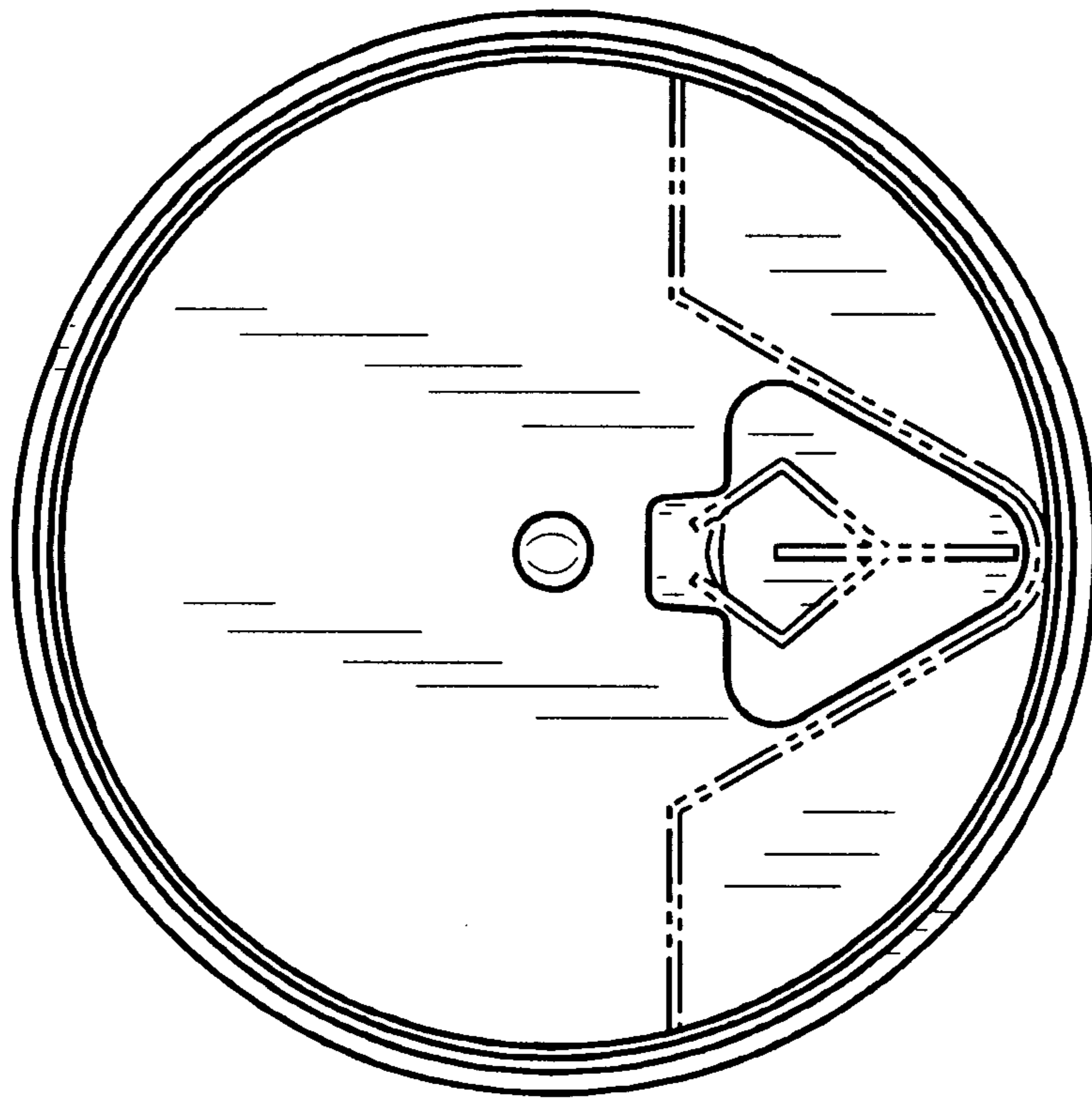

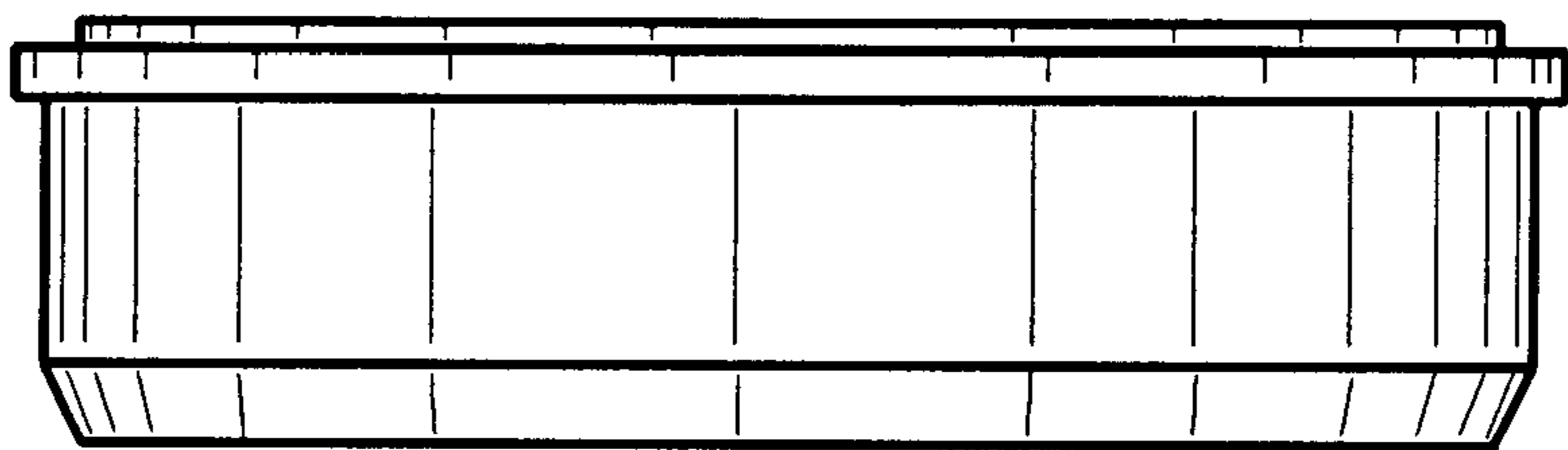
