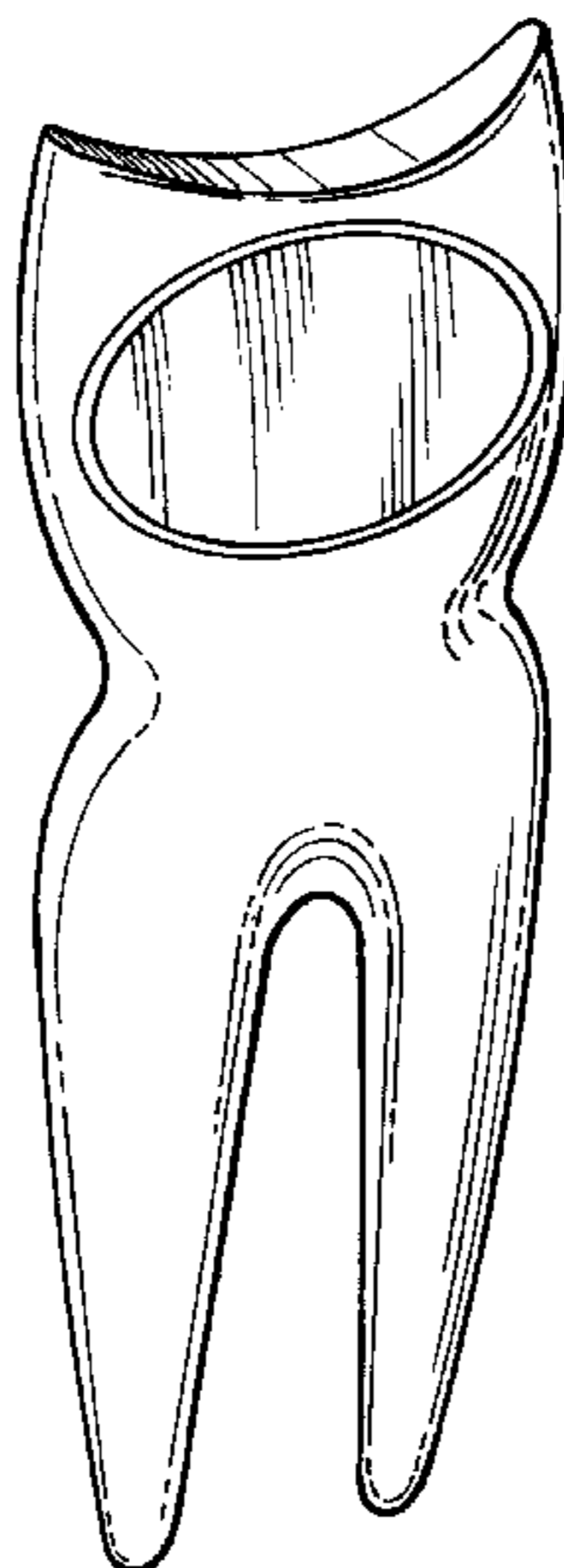
## [57] CLAIM

The ornamental design for a multipurpose golf tool, as shown and described.

## DESCRIPTION

FIG. 1 is a front perspective view of a multipurpose golf tool showing my new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a top plan view thereof;  
 FIG. 4 is a rear elevational view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a right elevational view thereof; the left elevational view being a mirror image thereof;  
 FIG. 7 is a perspective view thereof, showing the ball marker thereof in a removed position; and,  
 FIG. 8 is a cross-sectional view taken on line 8—8 of FIG. 2.

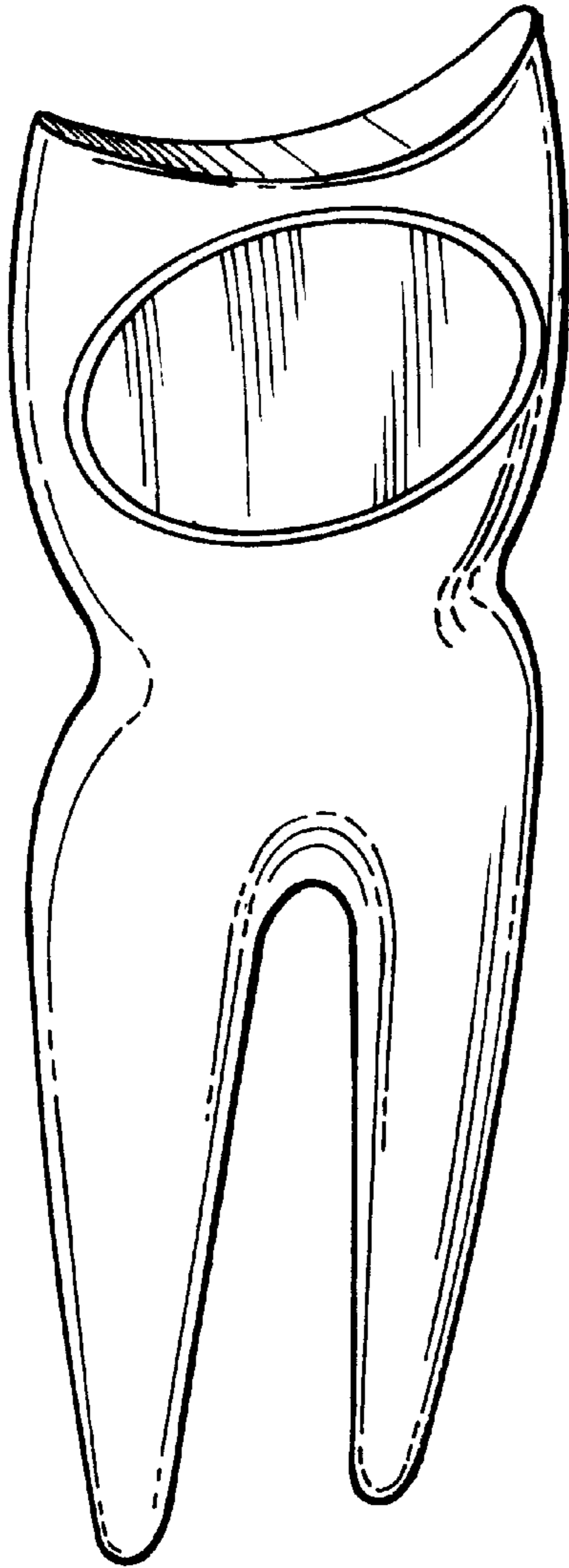

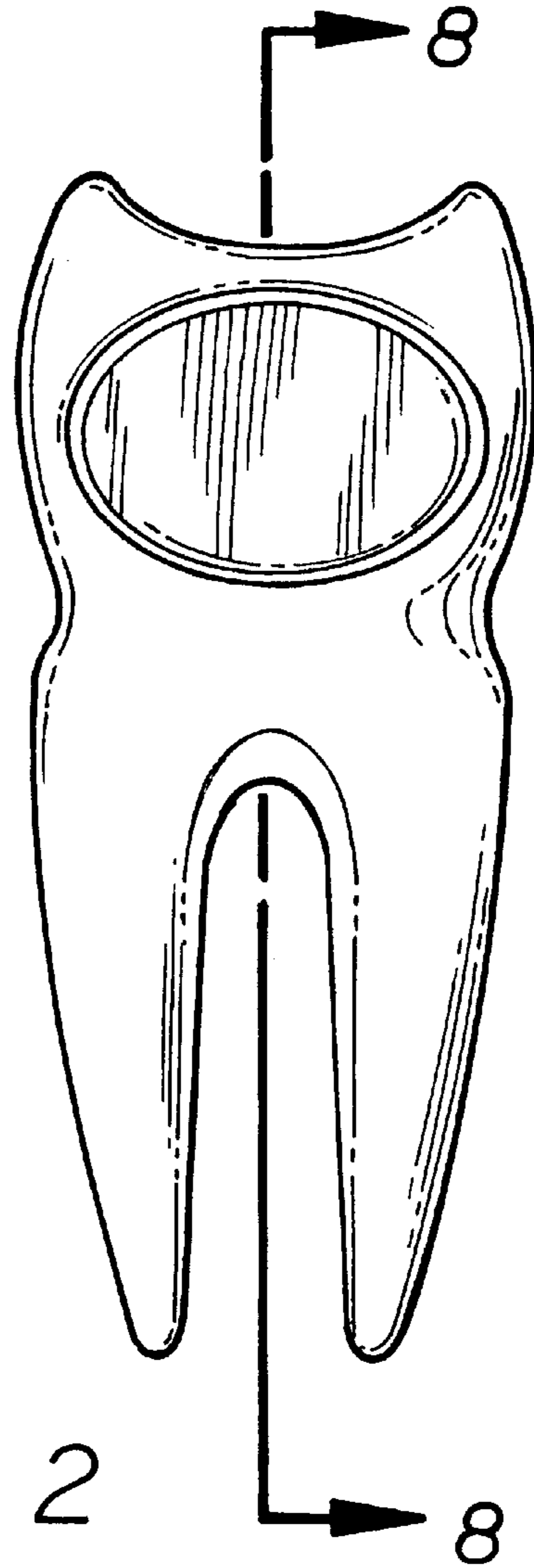

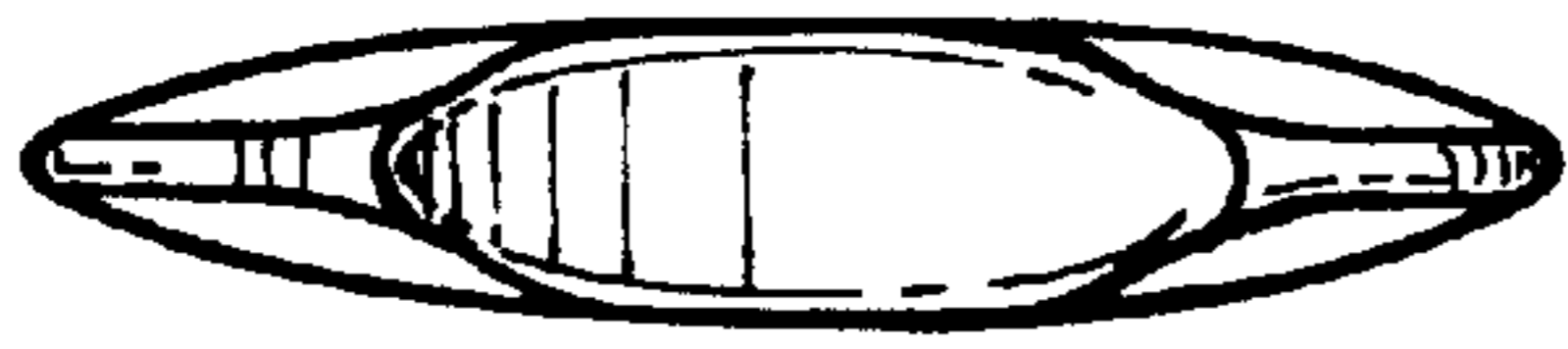

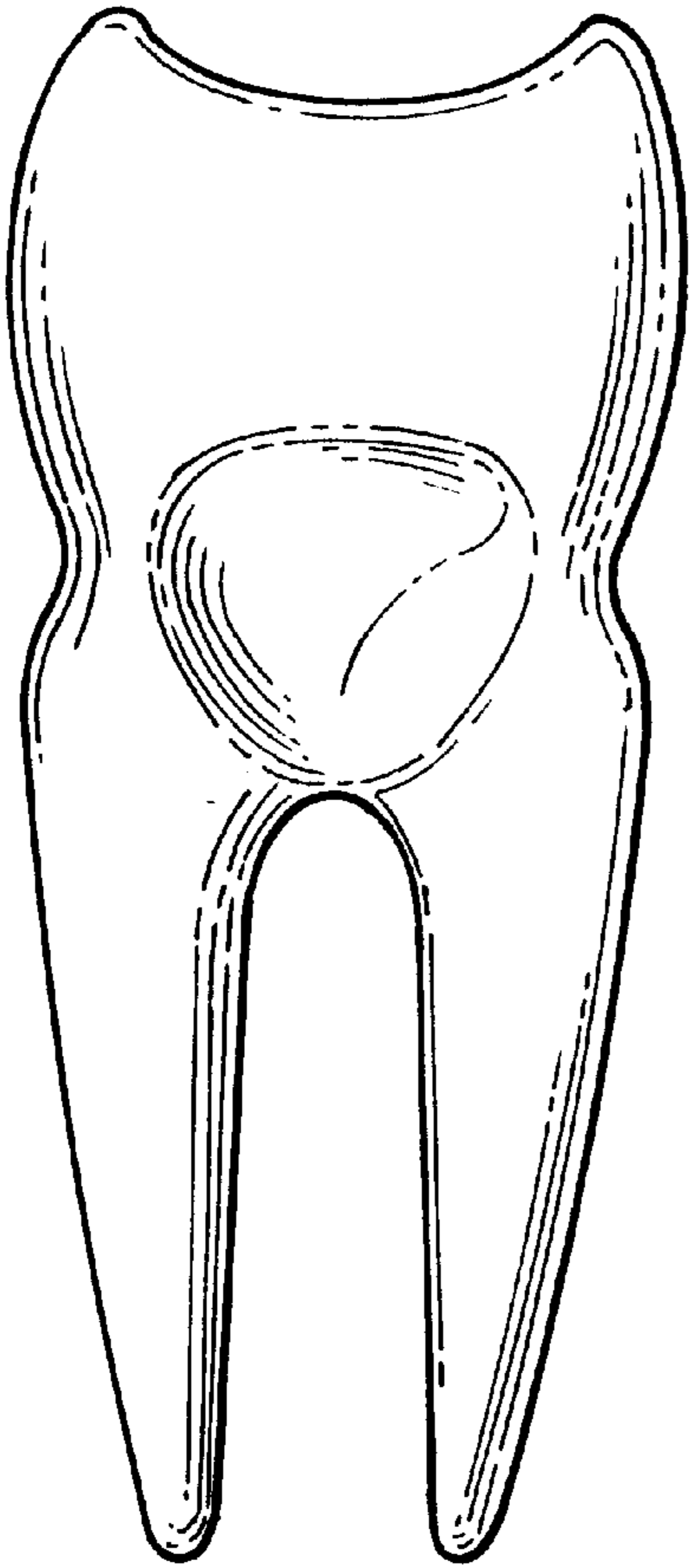

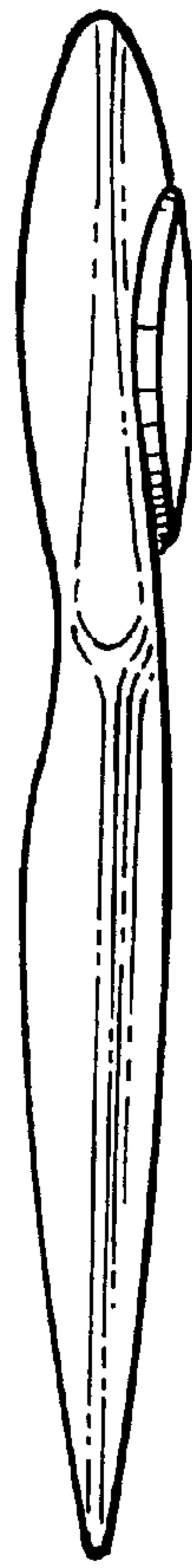

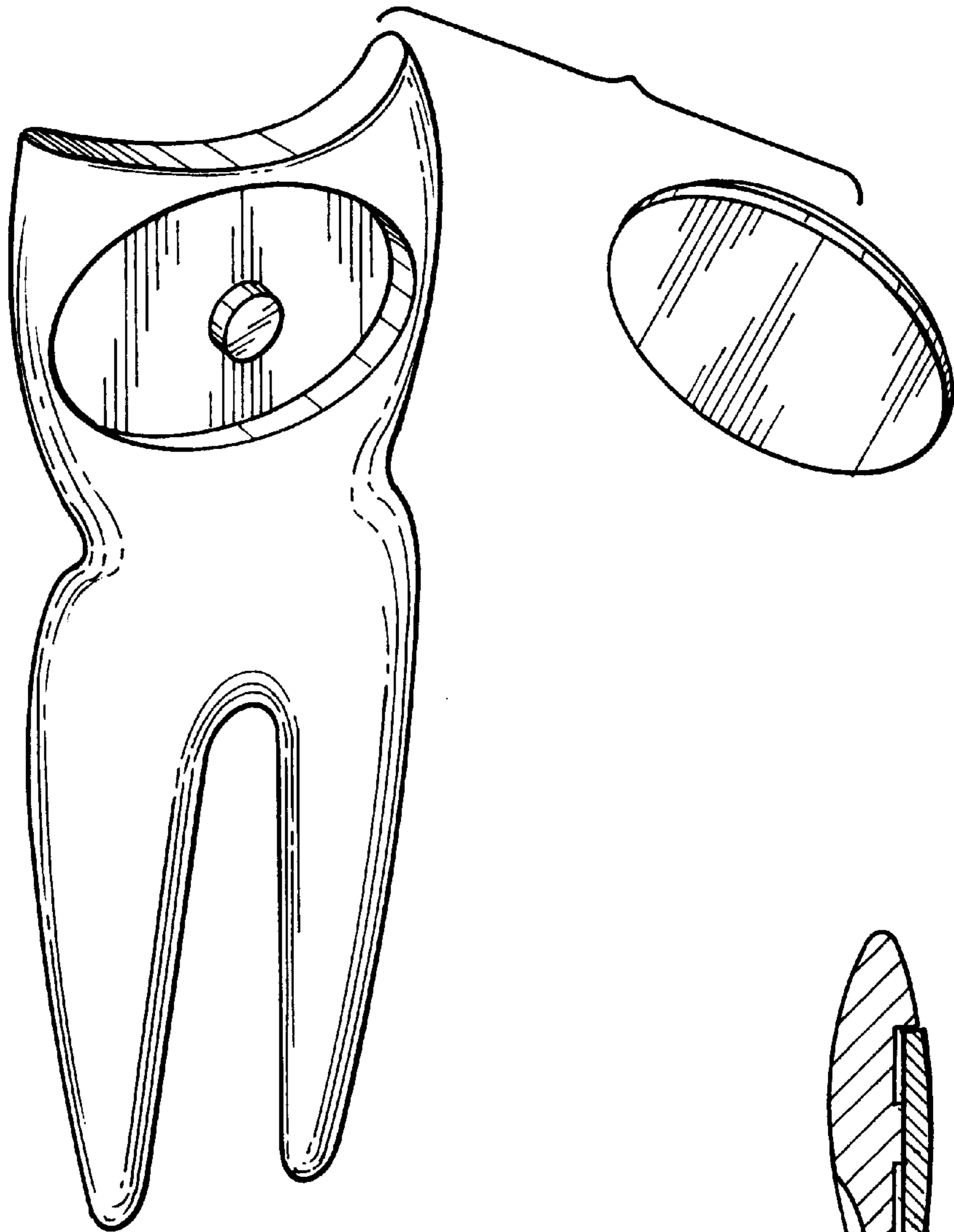
