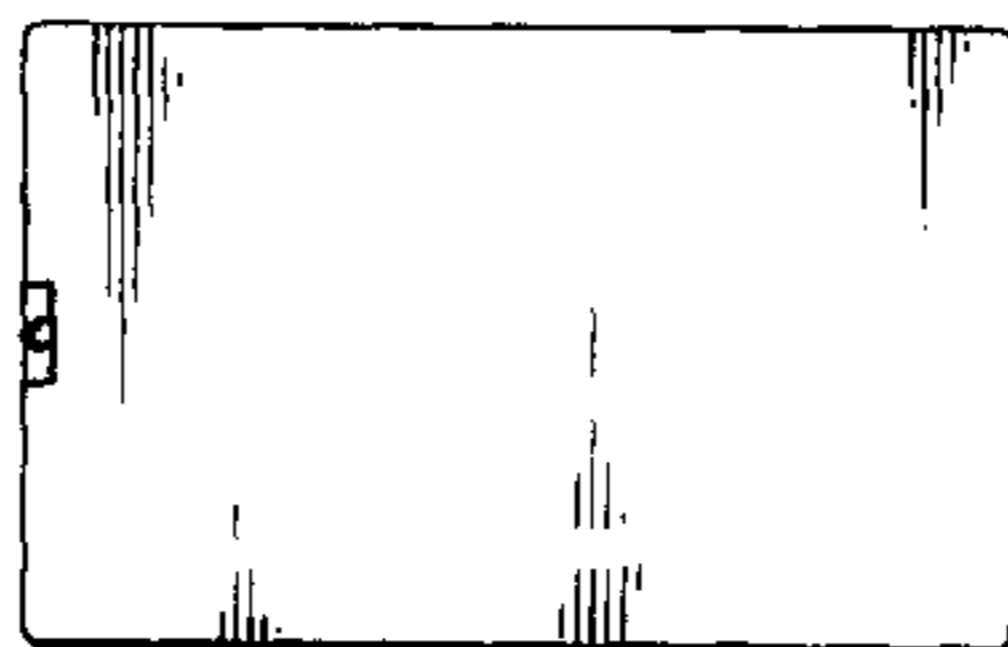
The ornamental design for card light, as shown and described.

**DESCRIPTION**

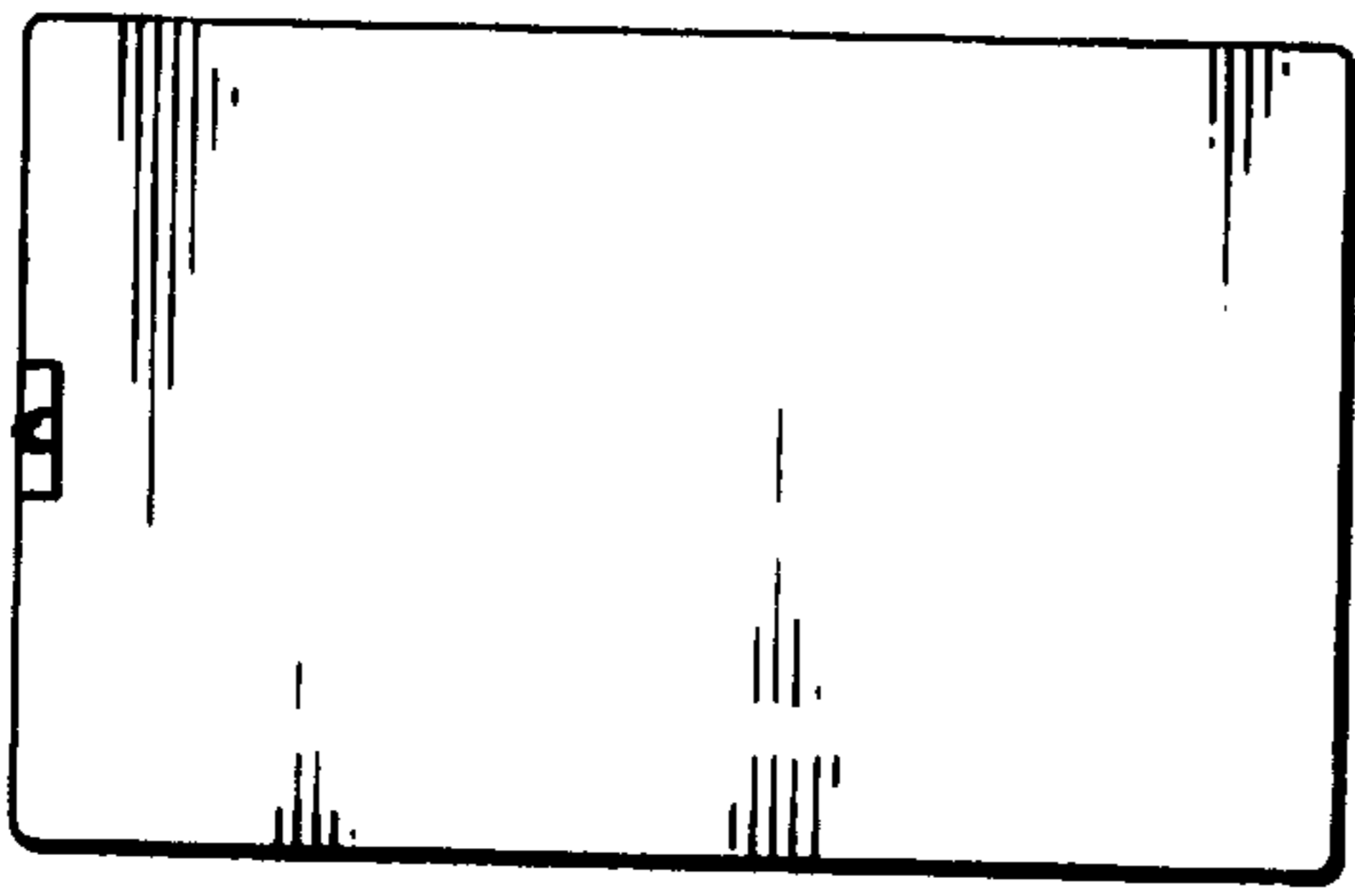

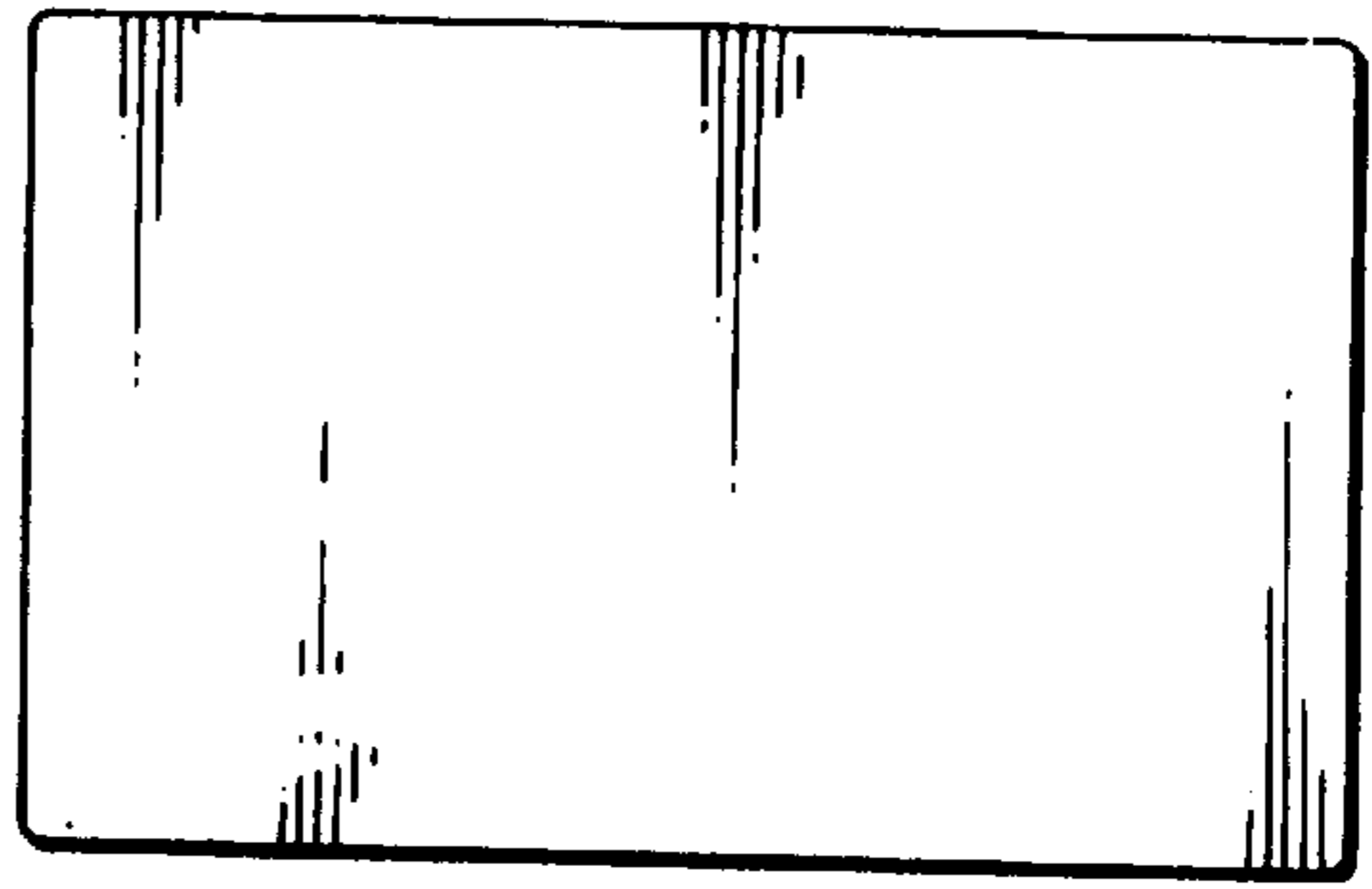

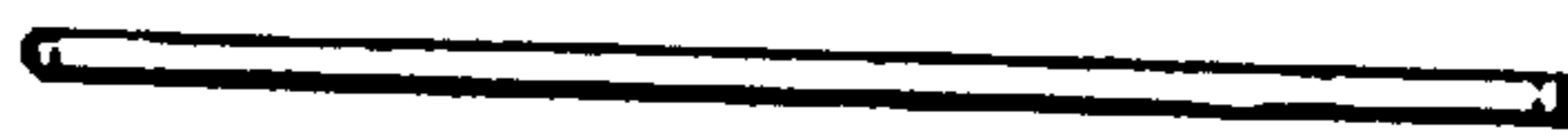

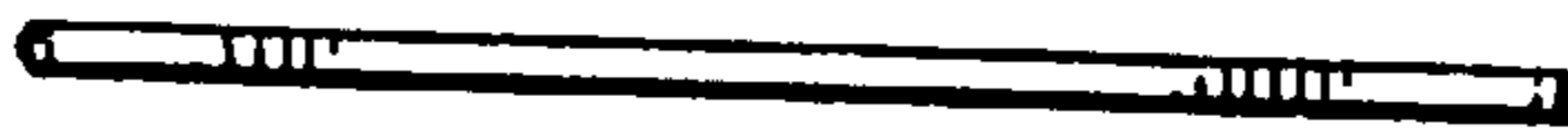

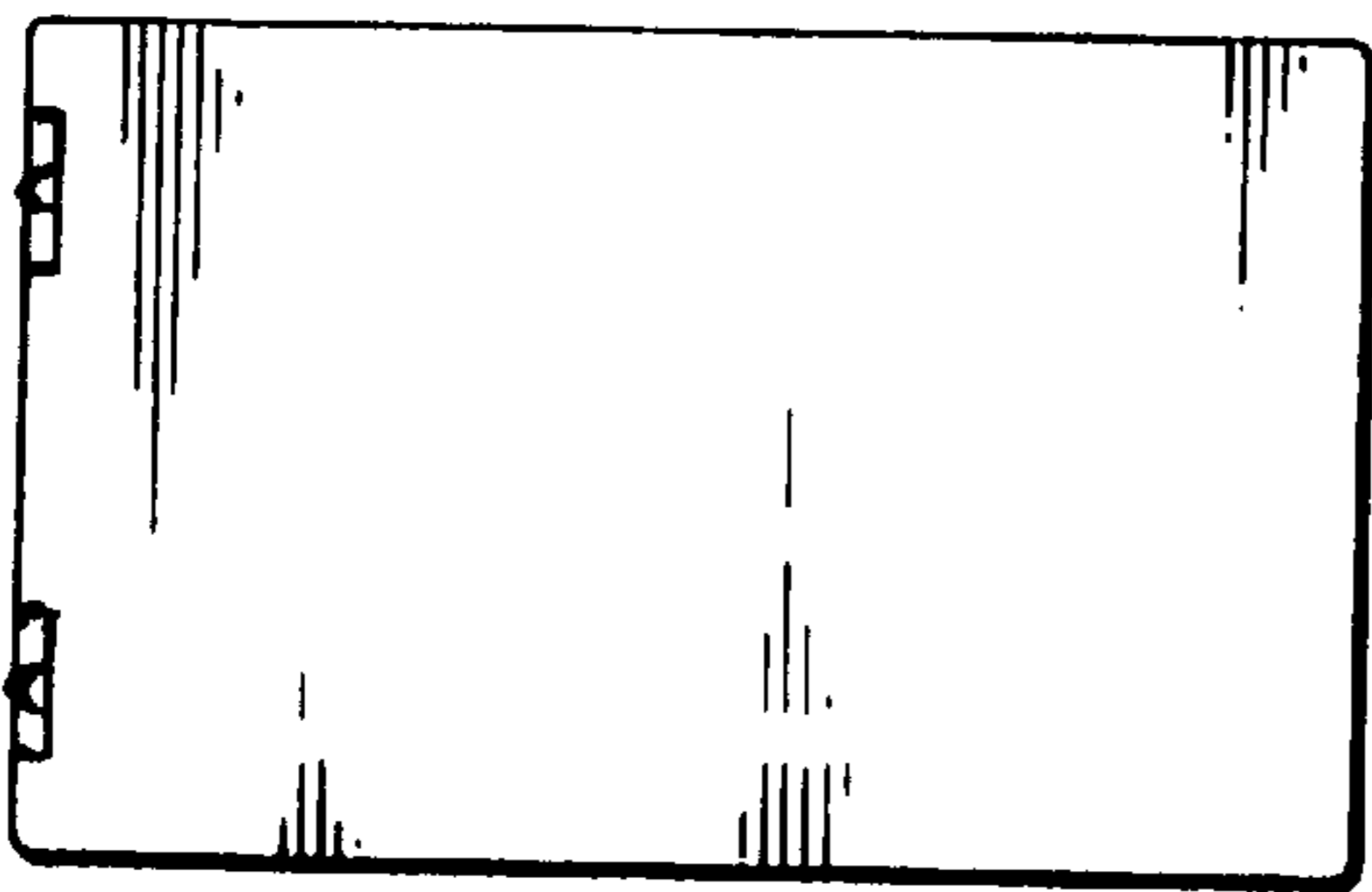

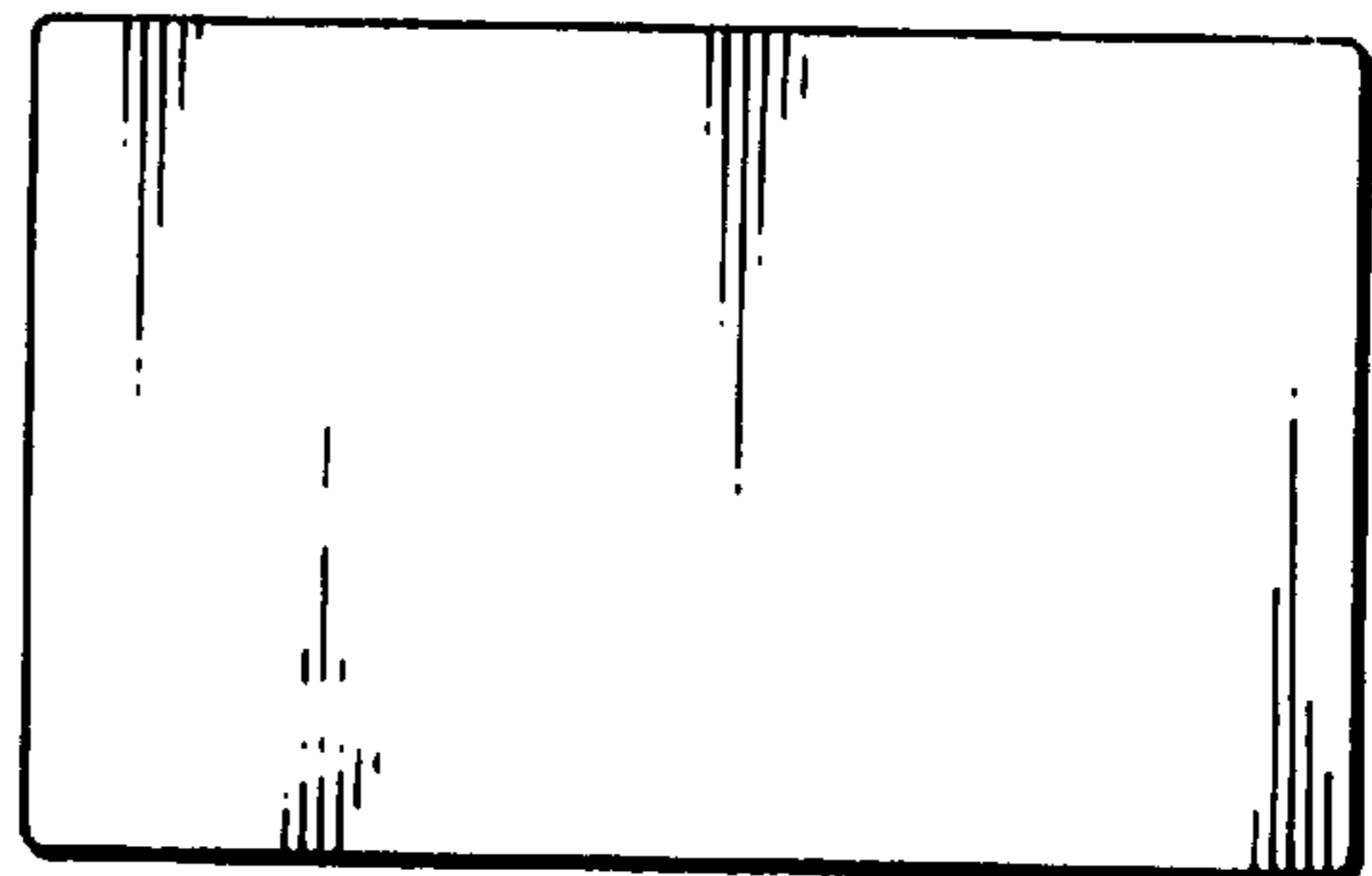

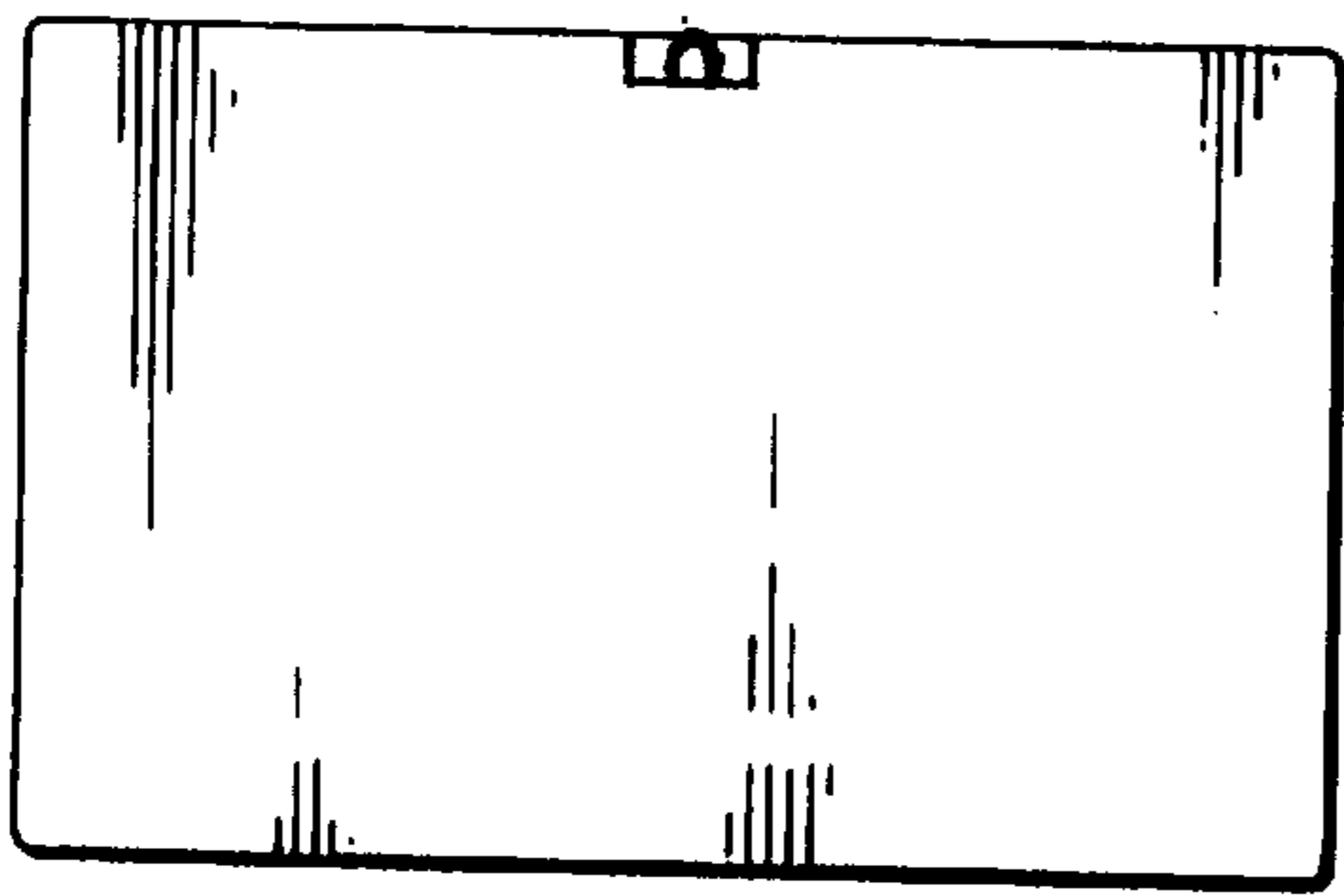

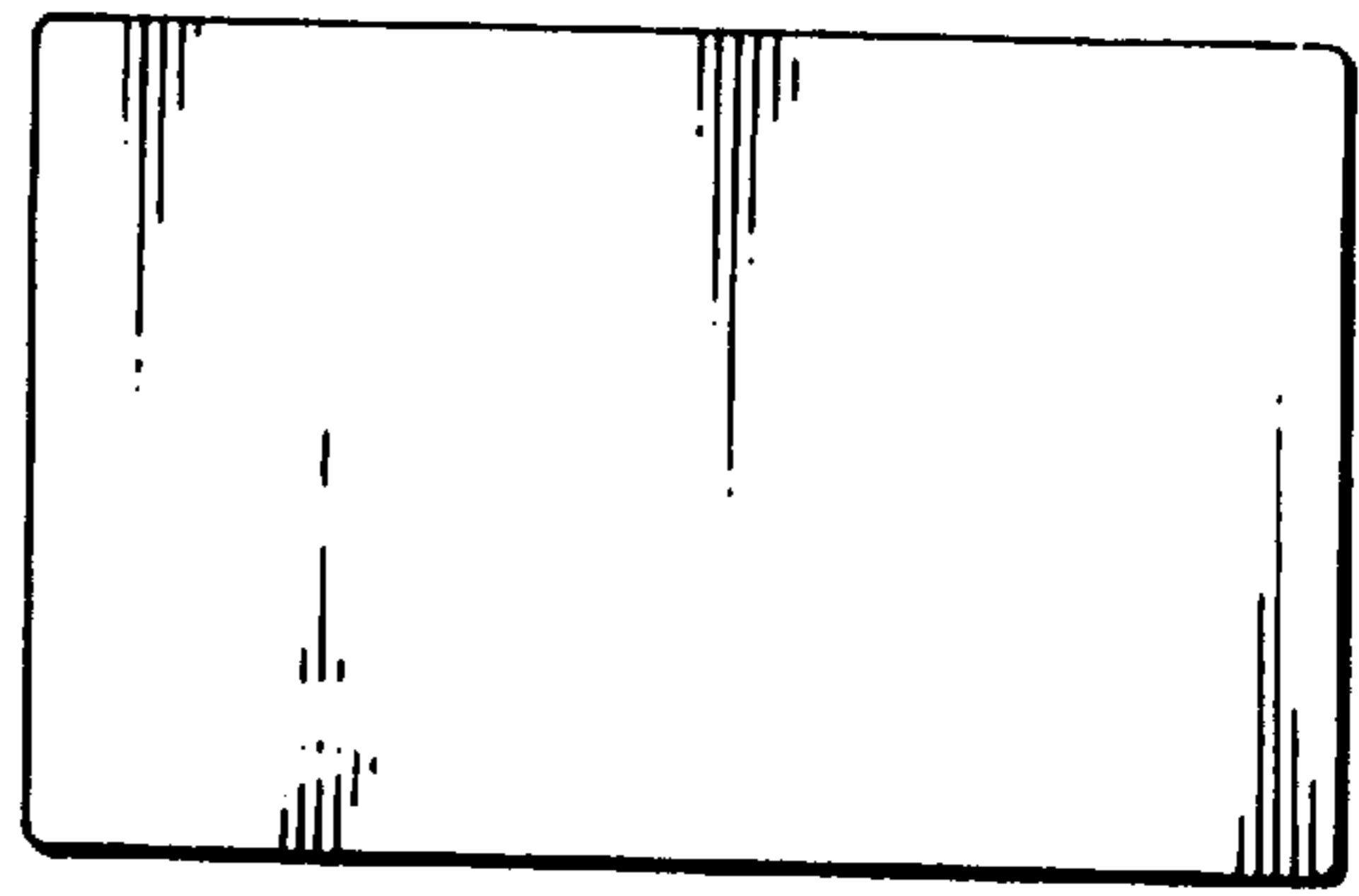

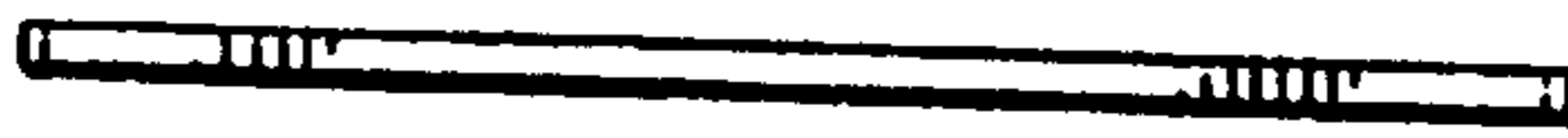

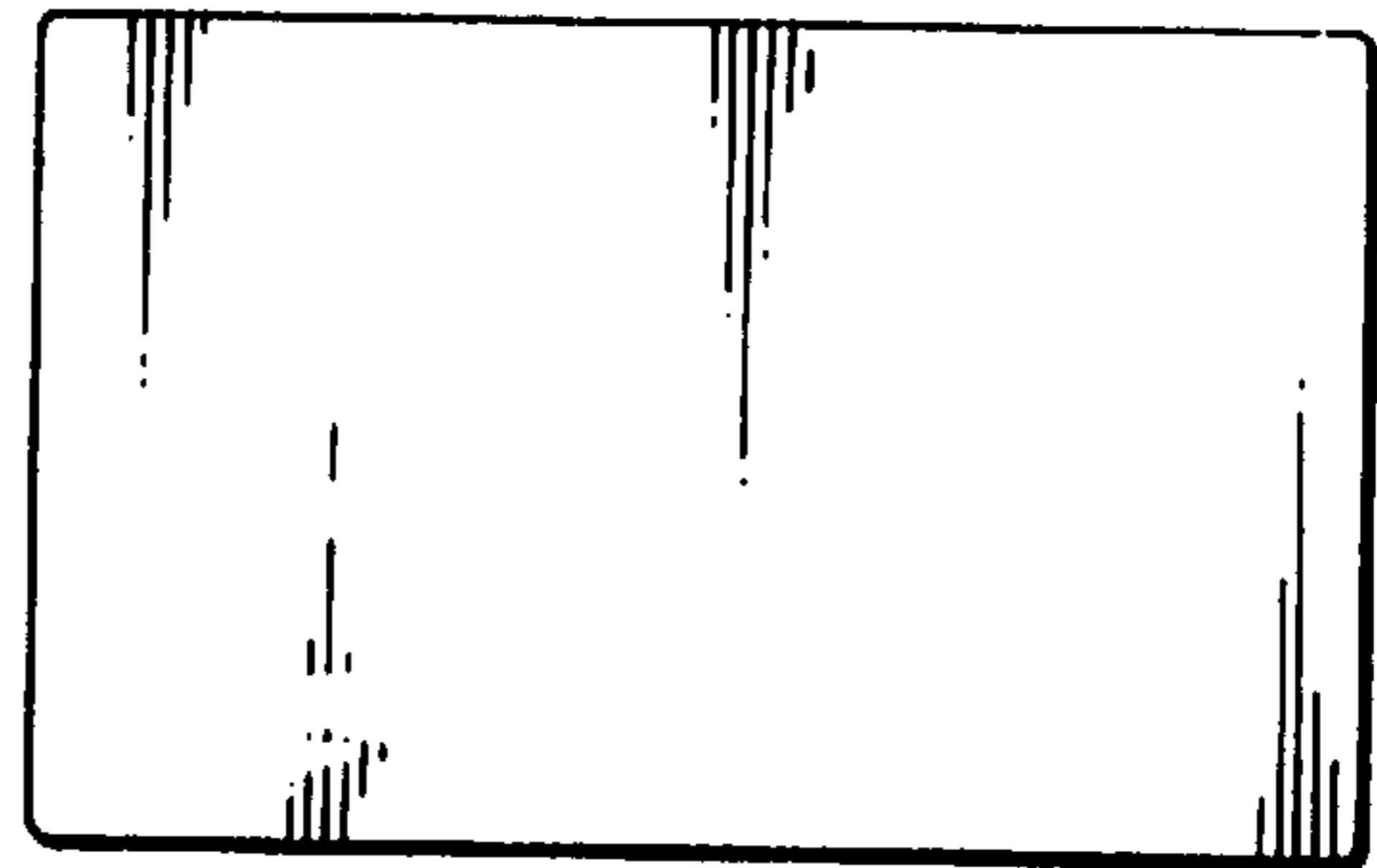

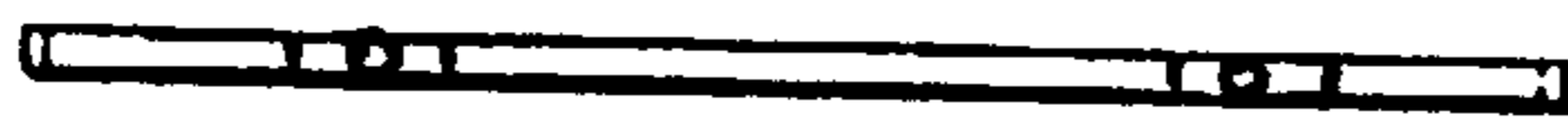

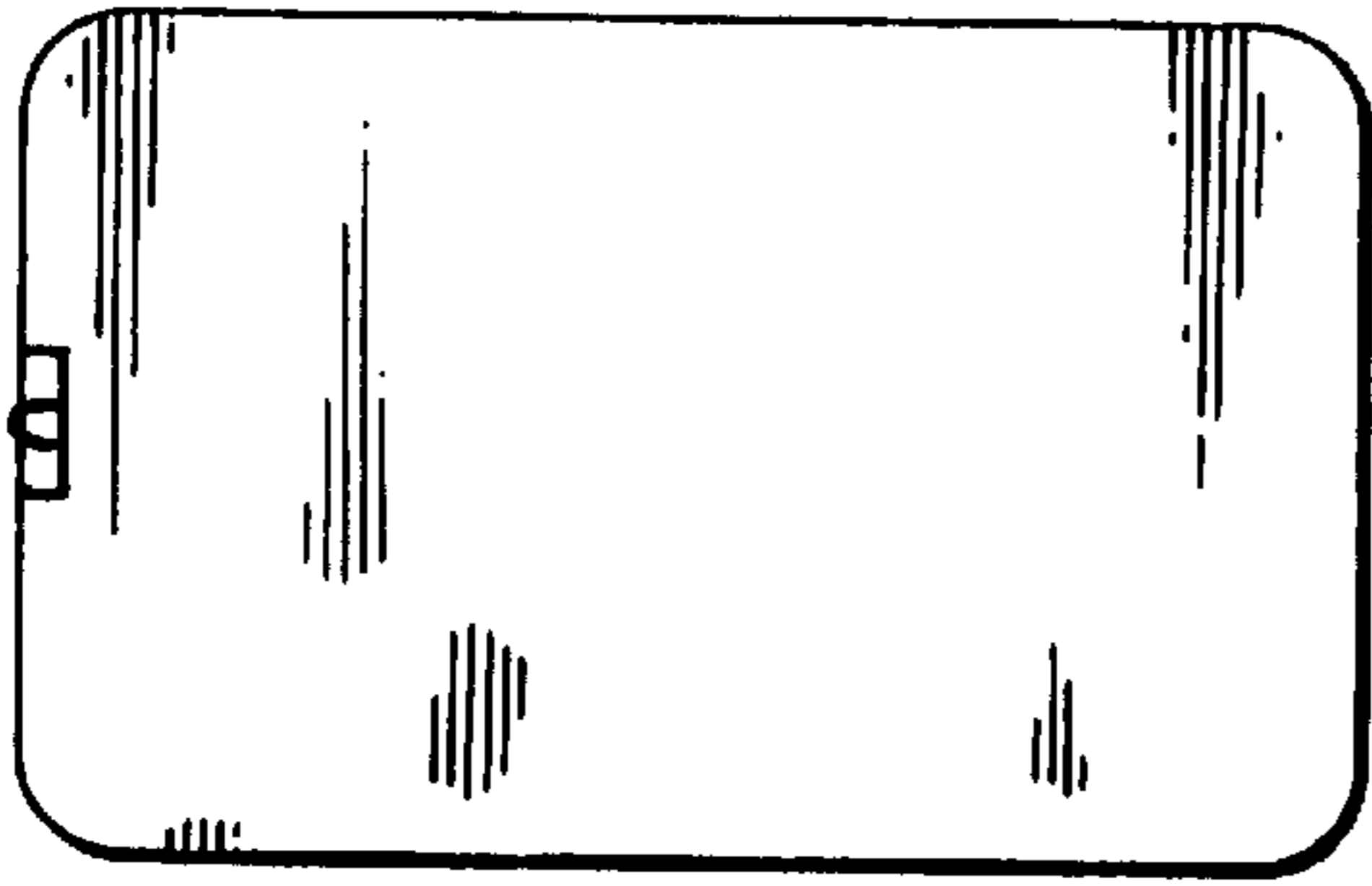

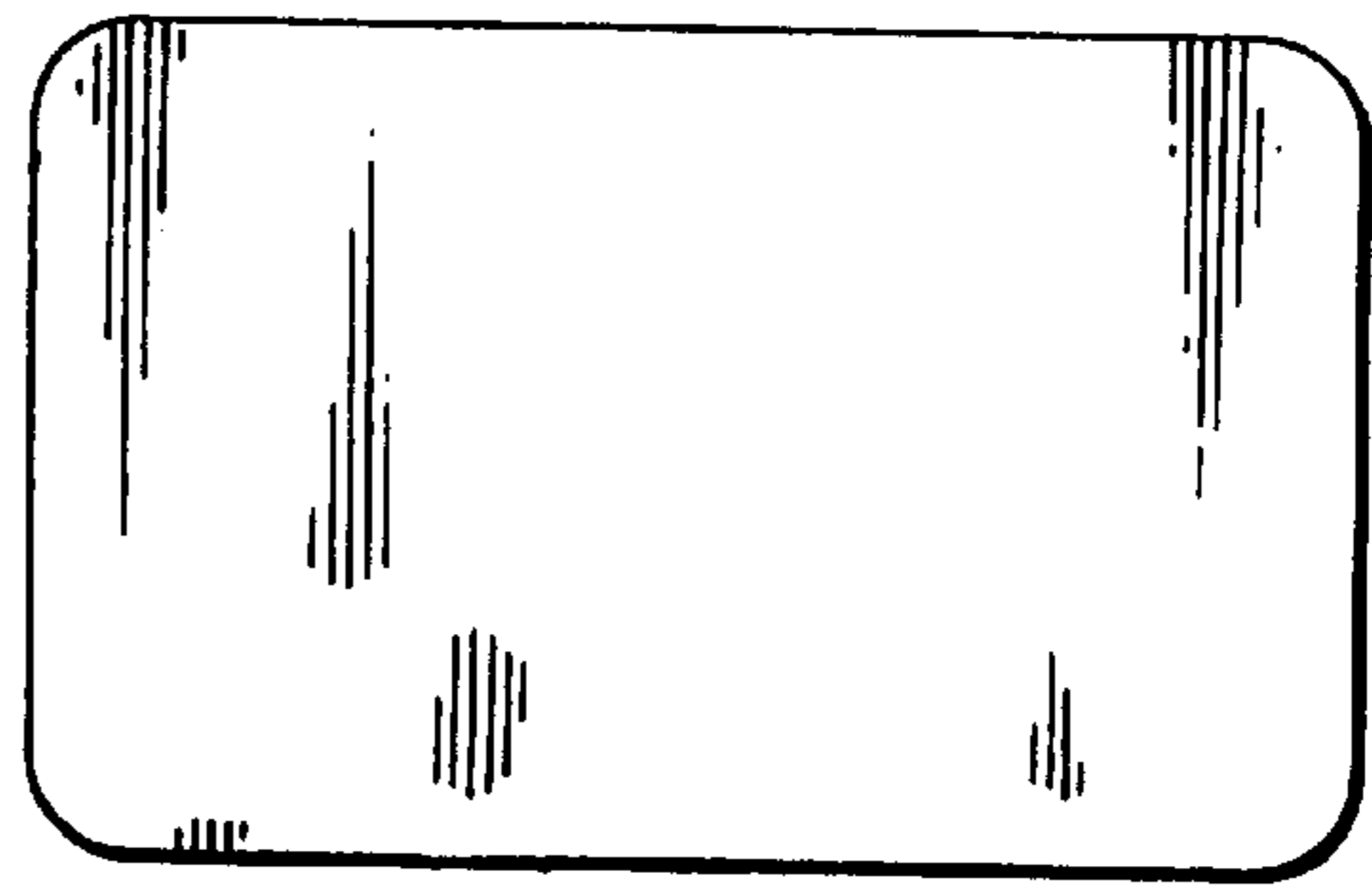

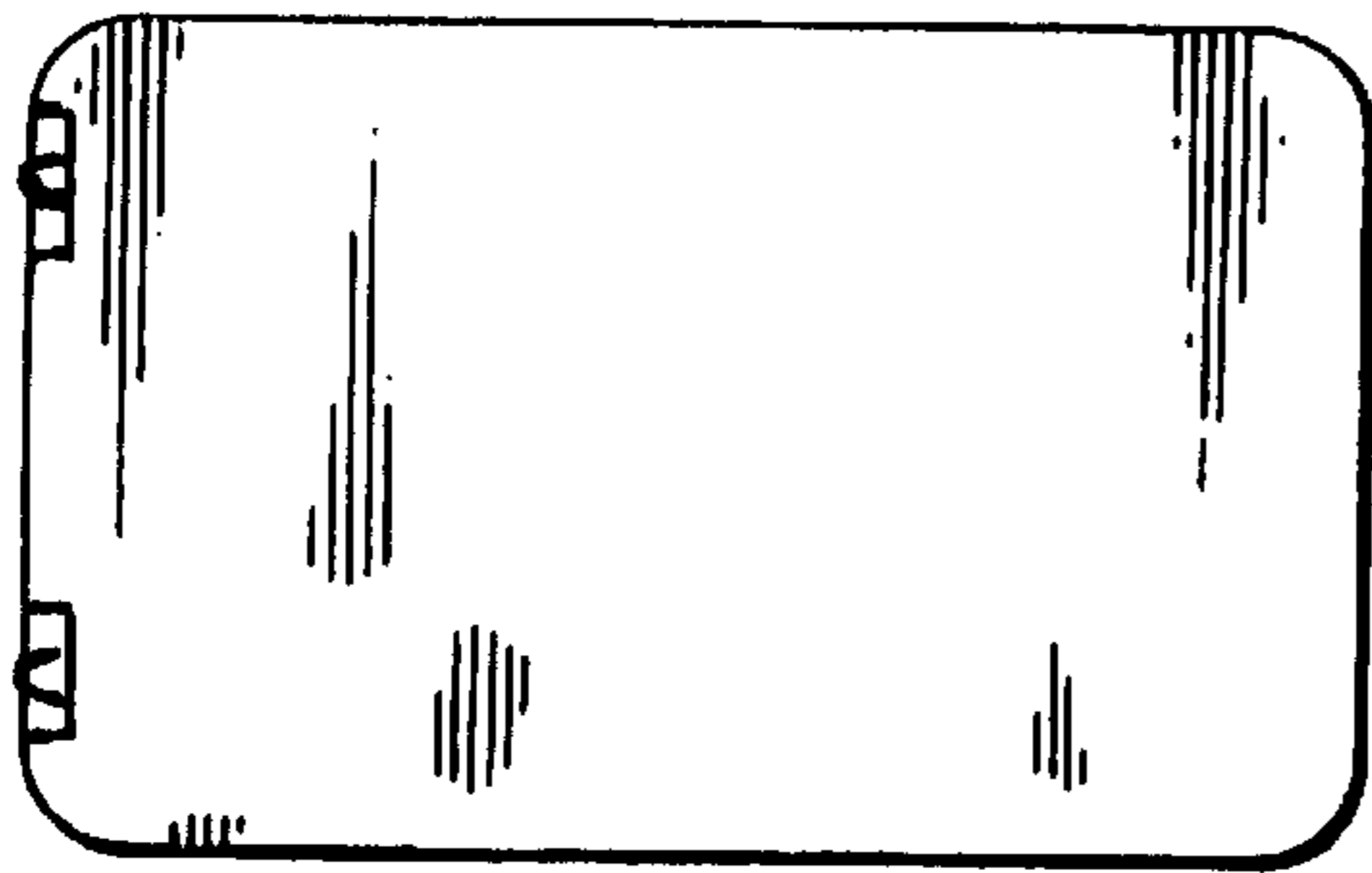

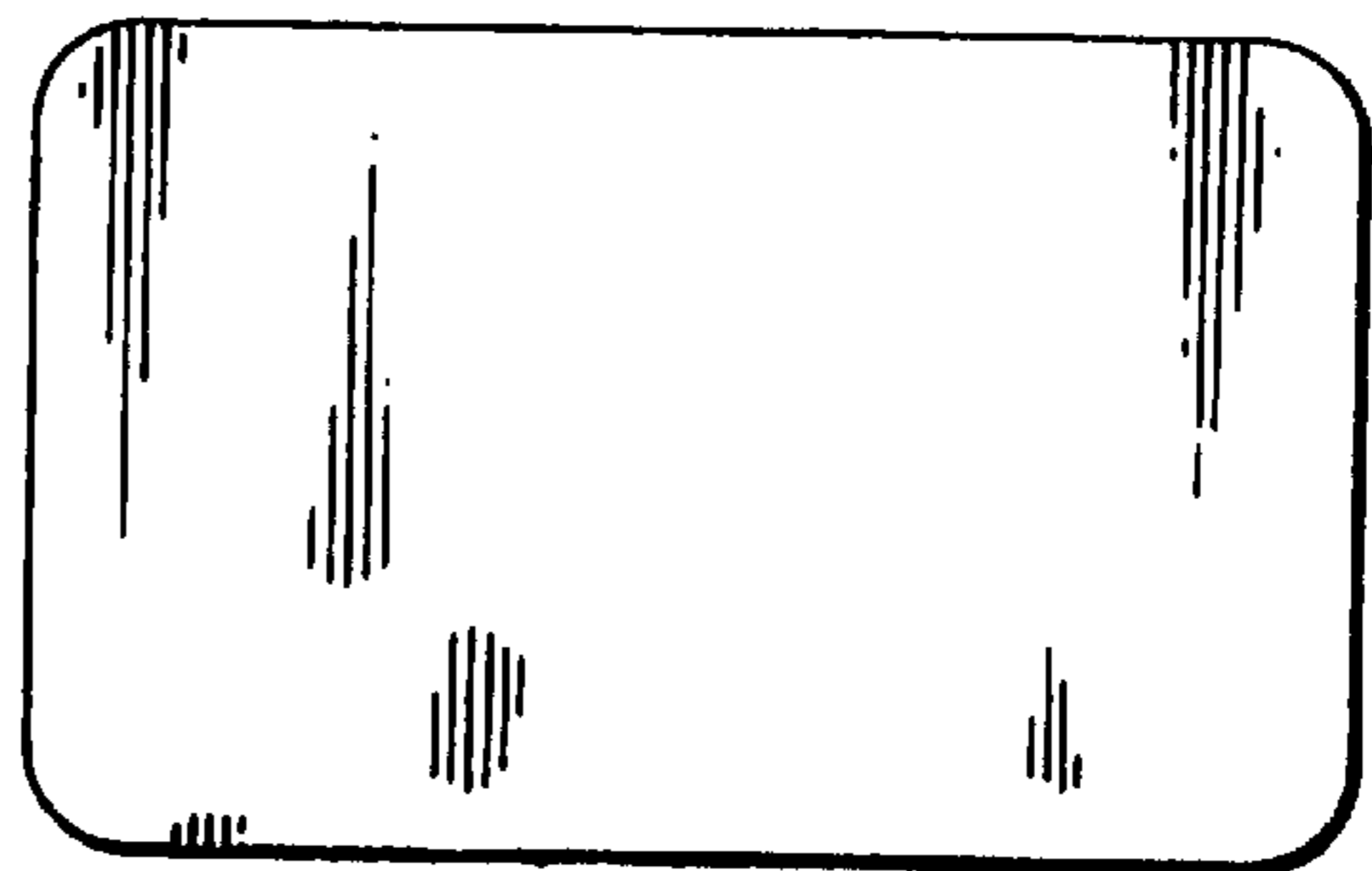

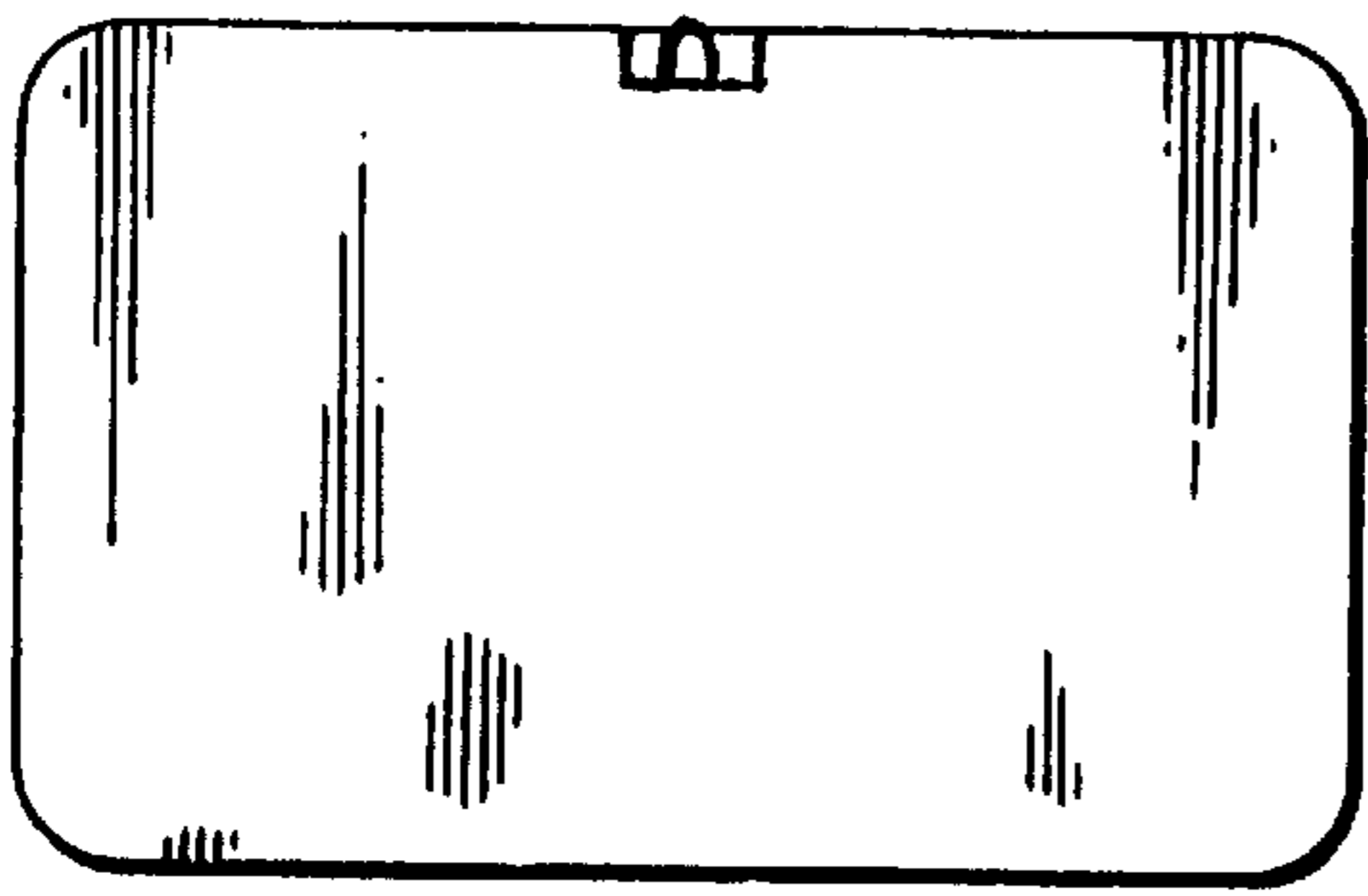

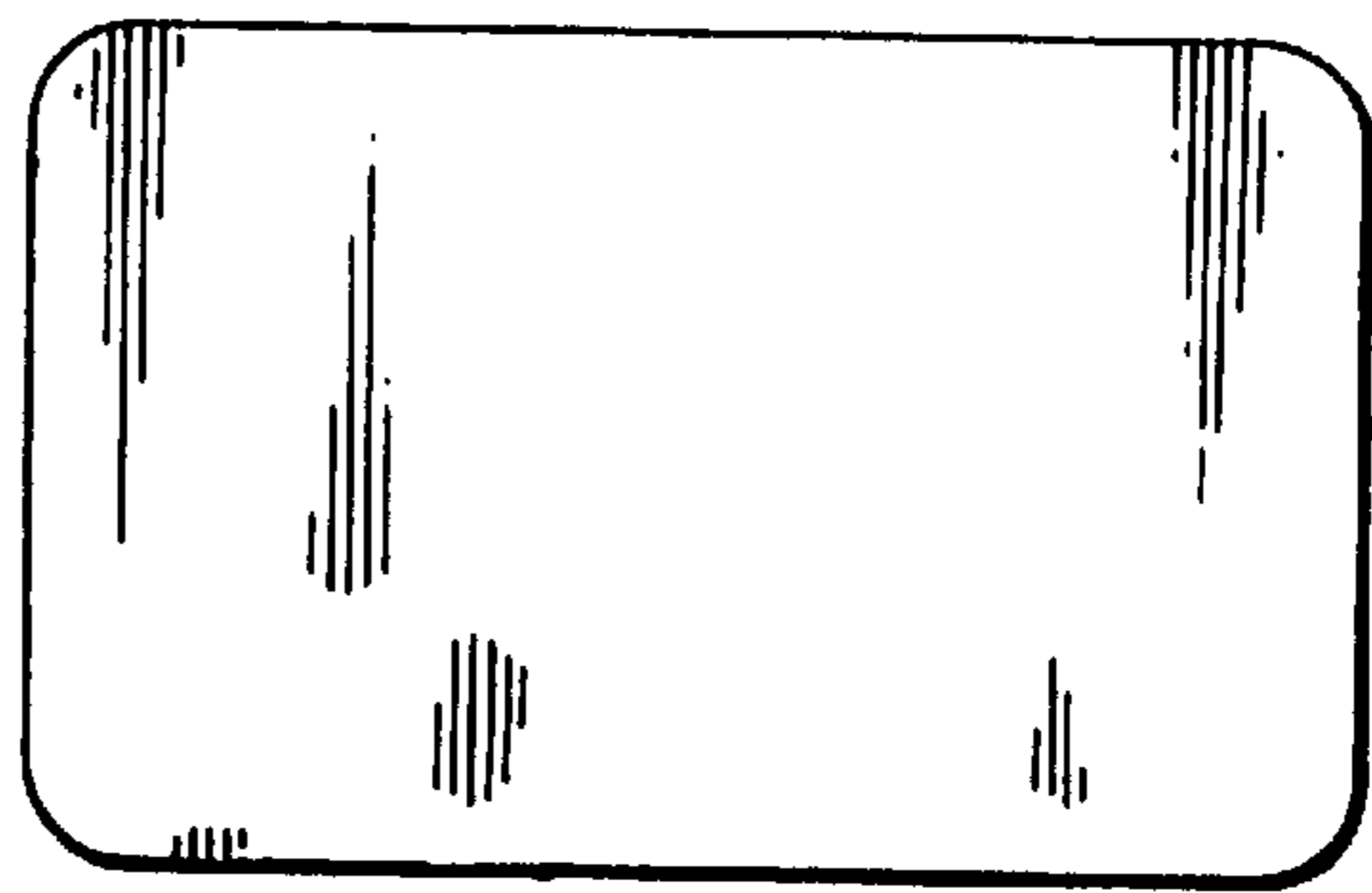

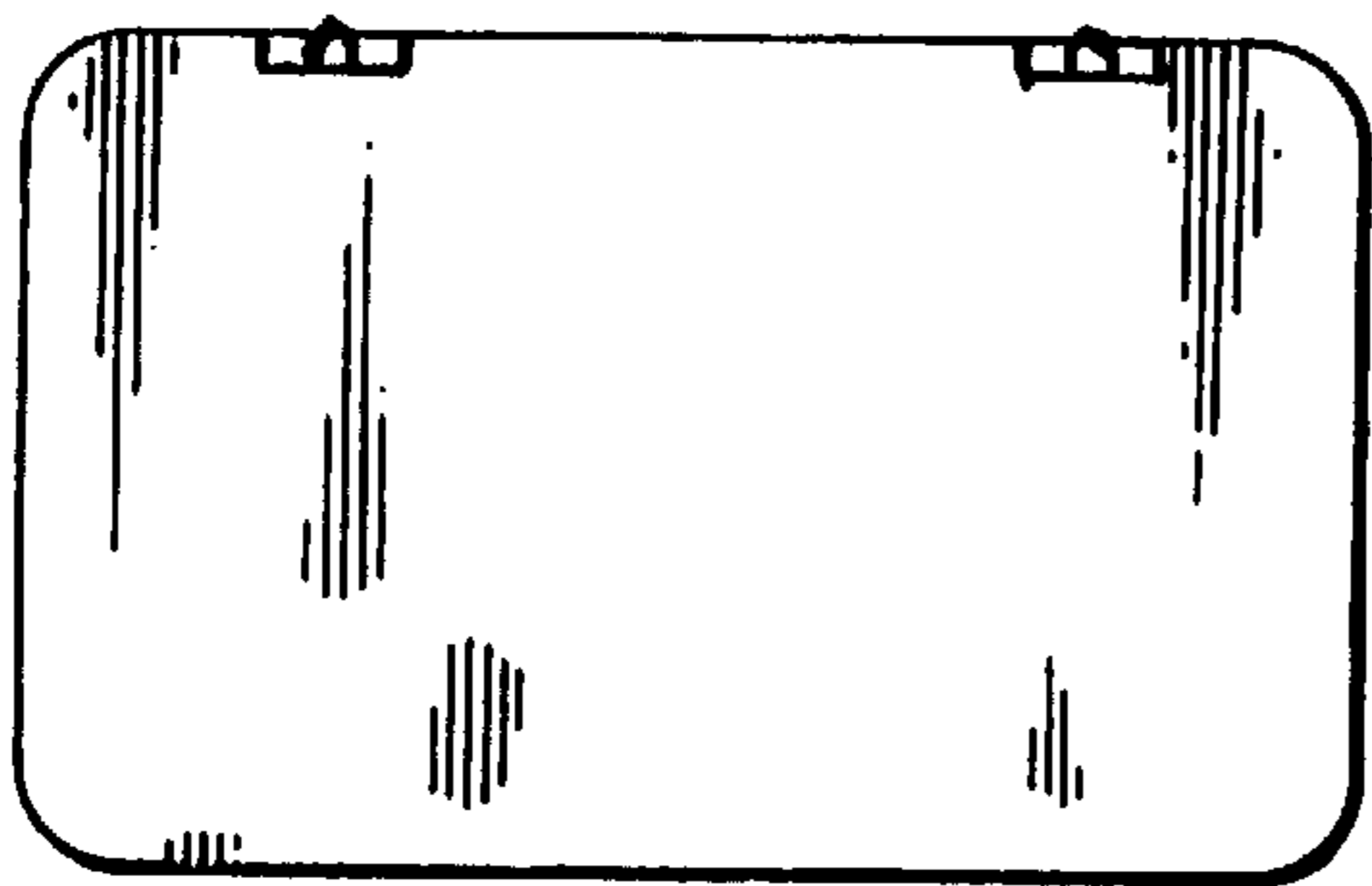

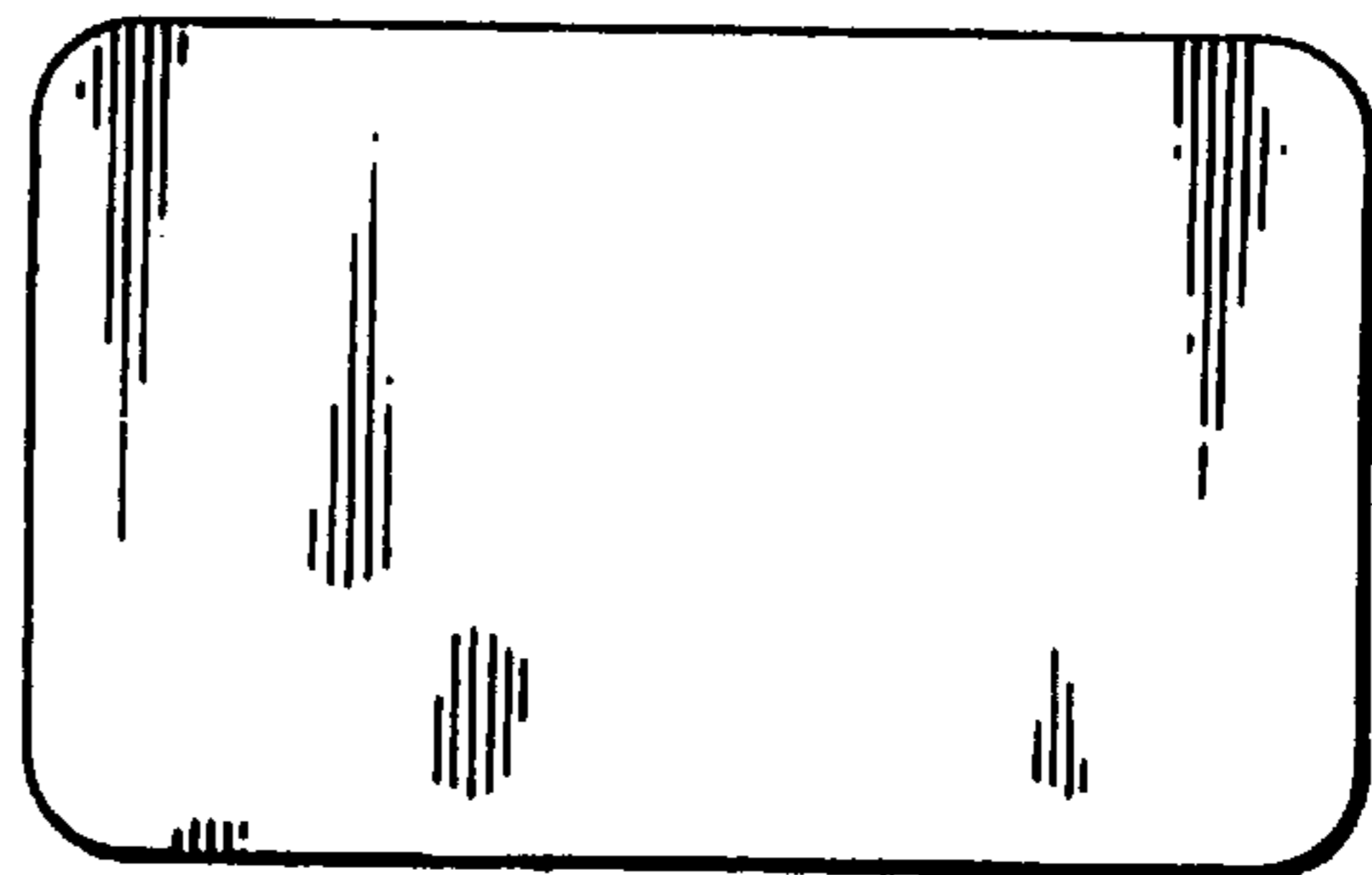

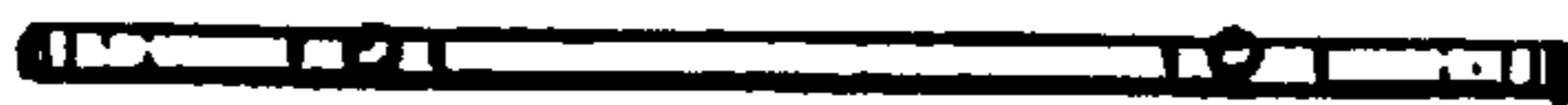

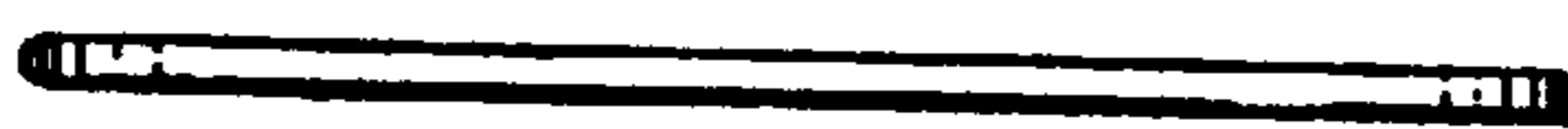
