[57] **CLAIM**

The ornamental design for a tattoos spray device, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of the top and one side of a tattoos spray device showing my new design and a pattern template shown in phantom lines which does not constitute part of the present design;

FIG. 2 is a side elevational view of said one side thereof, all other side views being identical;

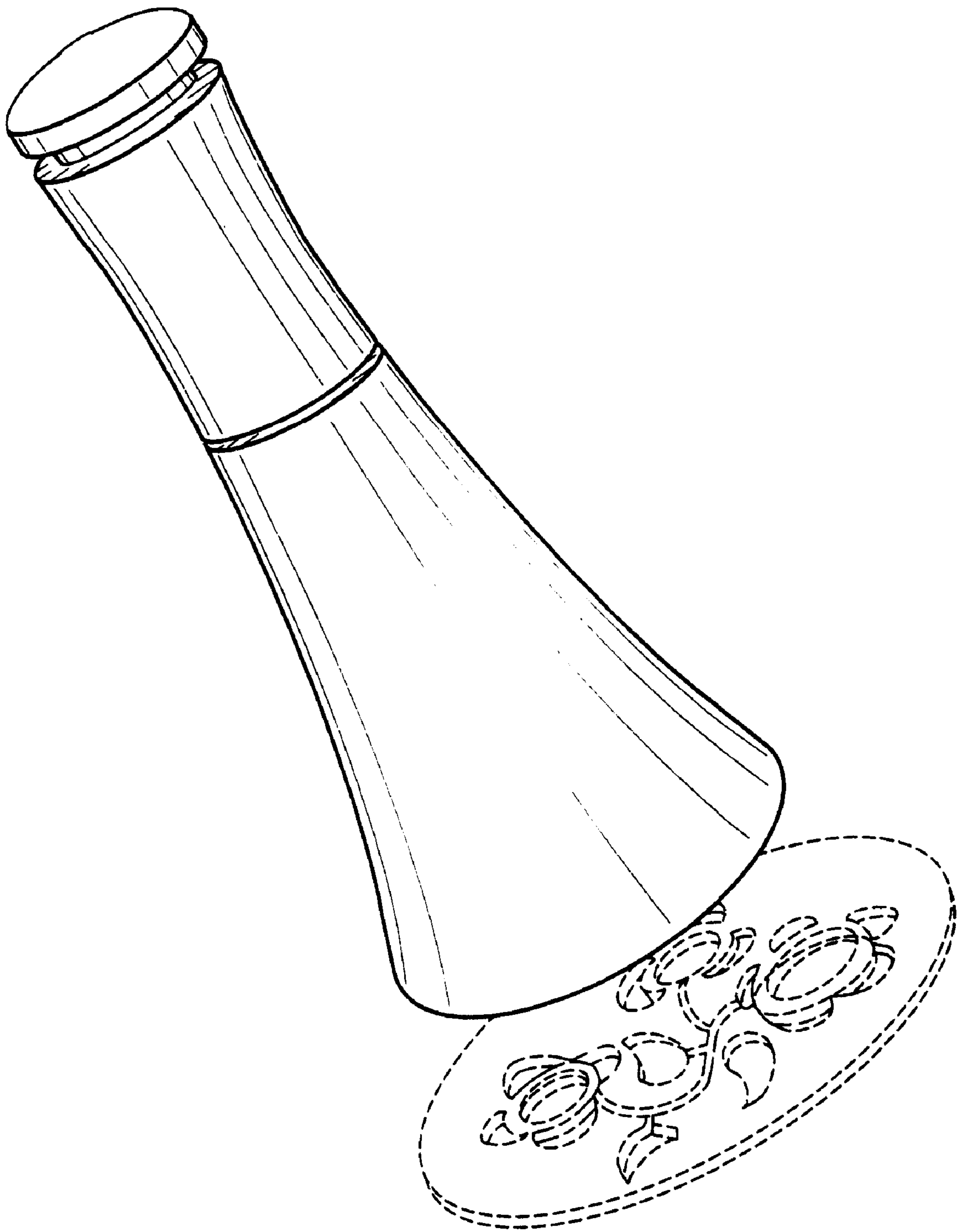
FIG. 3 is a top plan view thereof; and,

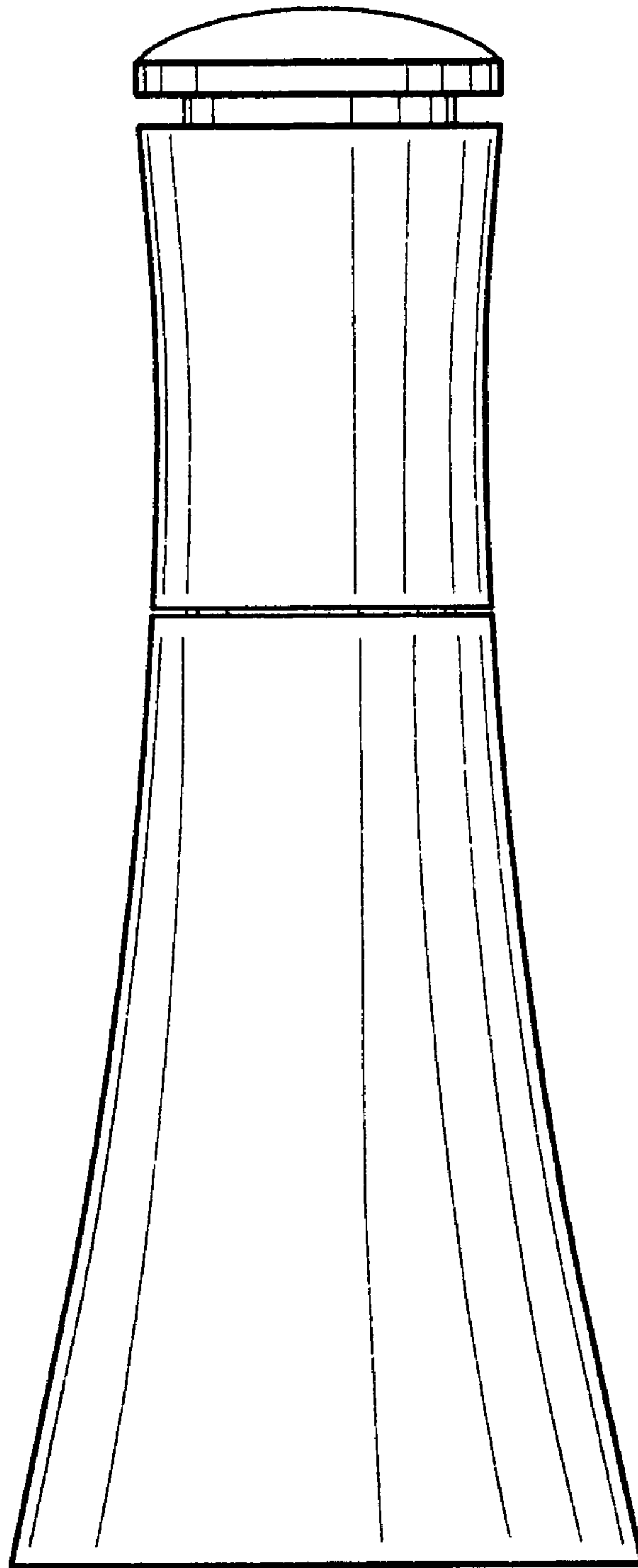

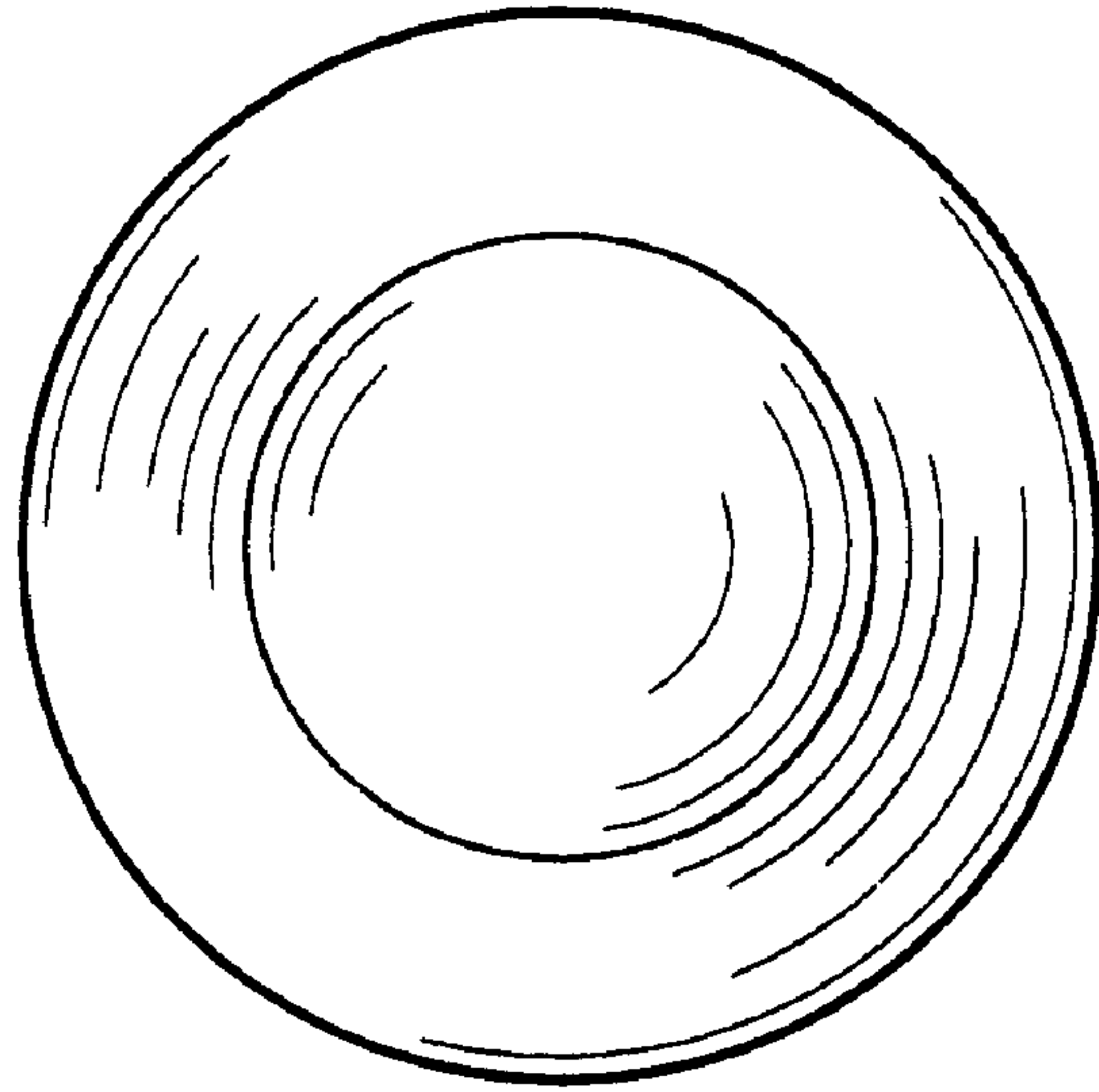
