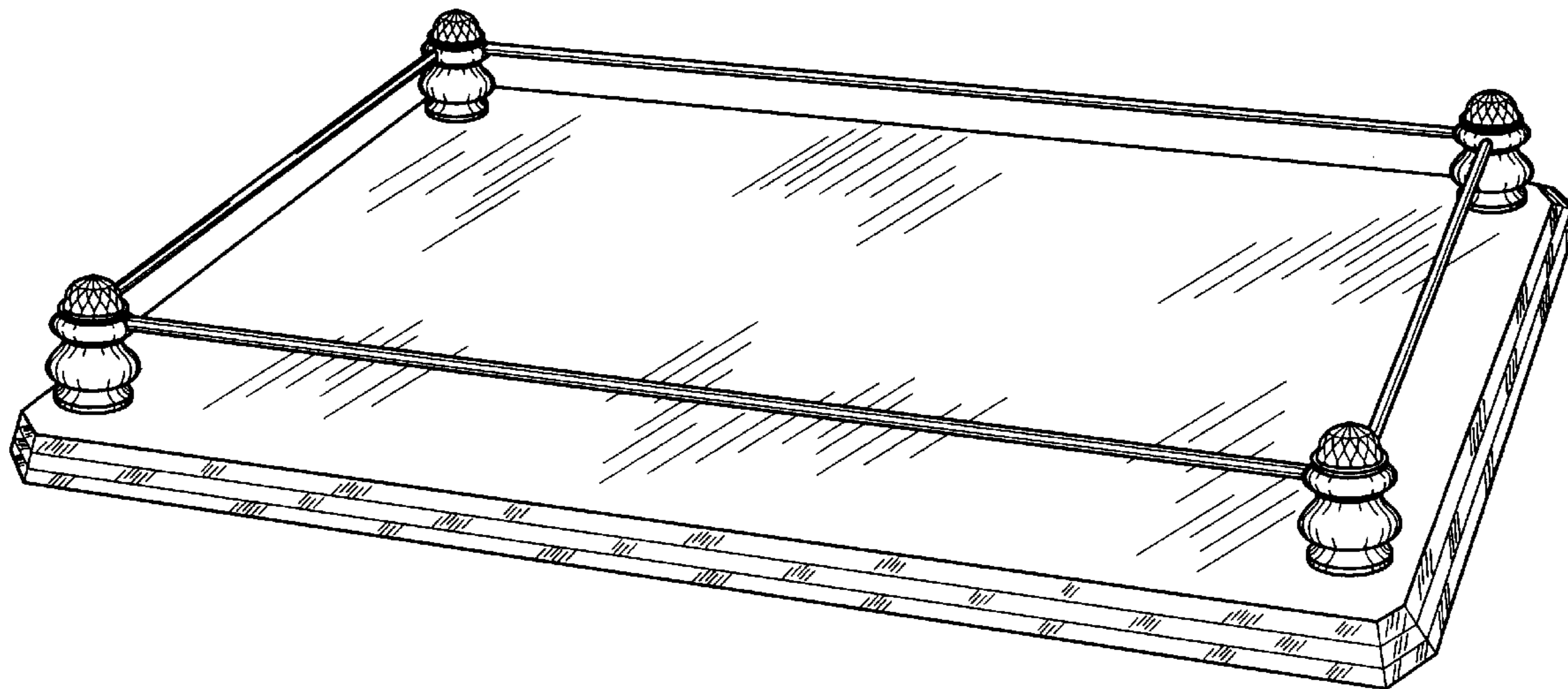
### [57] **CLAIM**

The ornamental design for a vanity tray, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a vanity tray, showing my new design;  
FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;  
FIG. 3 is a front elevational view thereof, the rear elevational view being a mirror image thereof;  
FIG. 4 is a top plan view, thereof; and,  
FIG. 5 is a bottom view thereof.

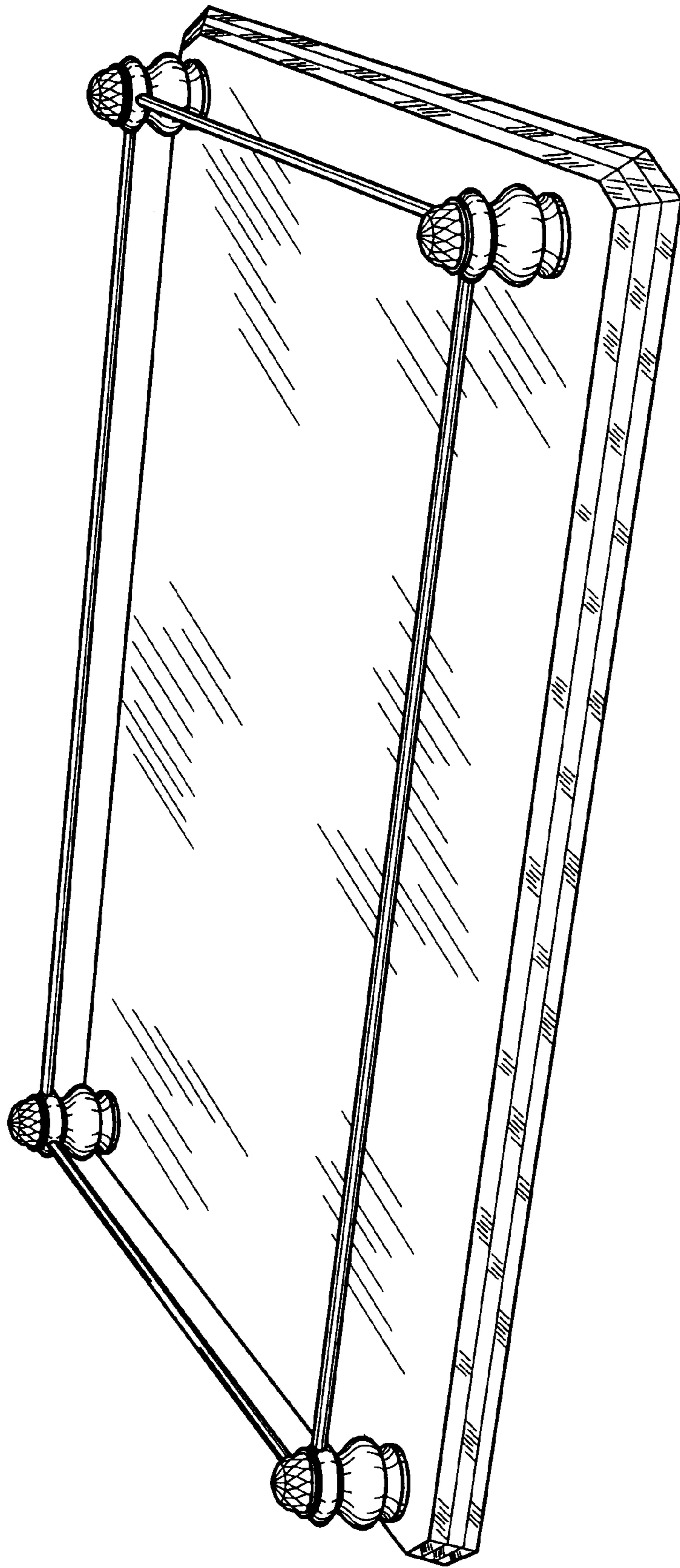

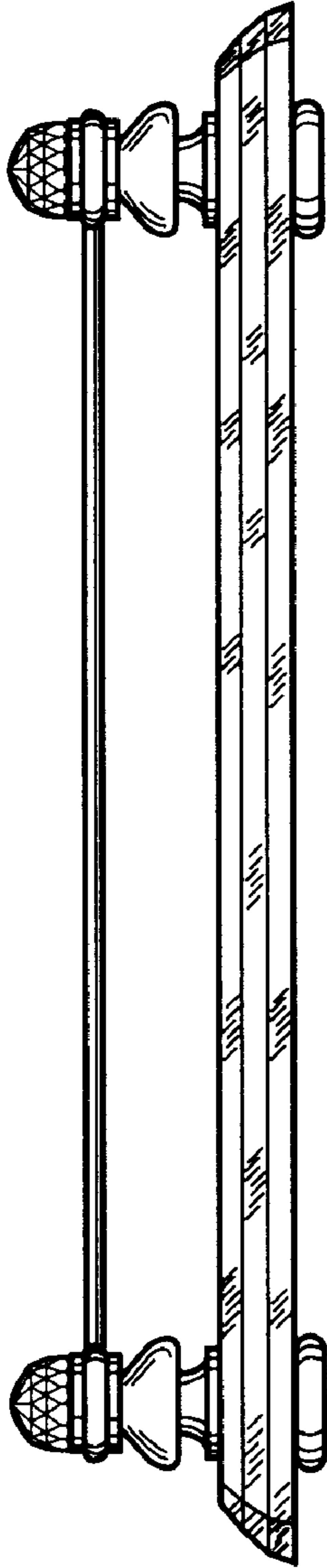

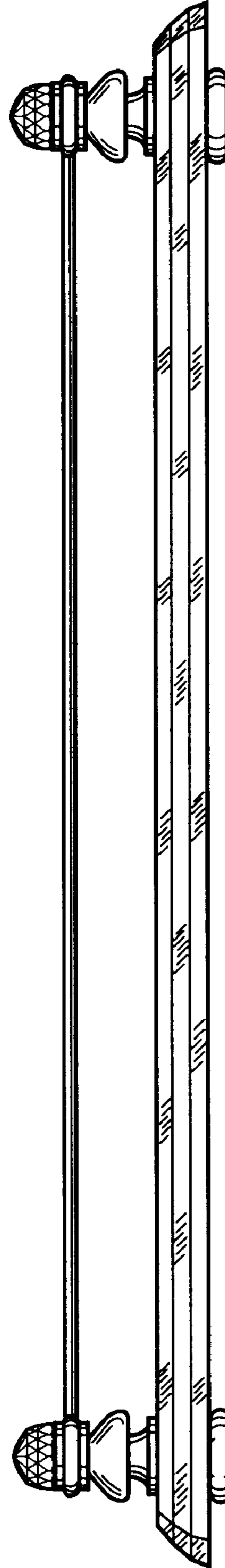

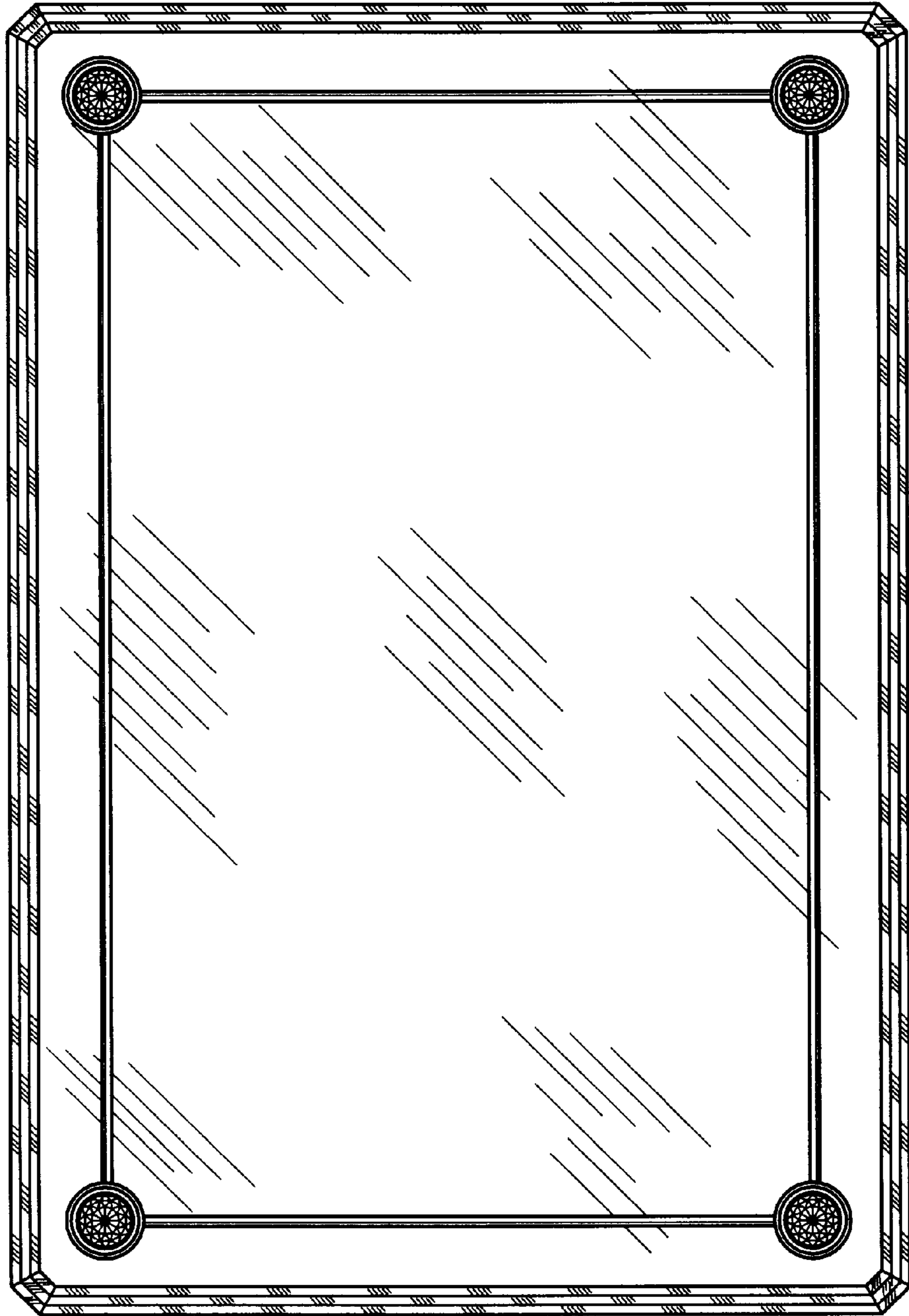

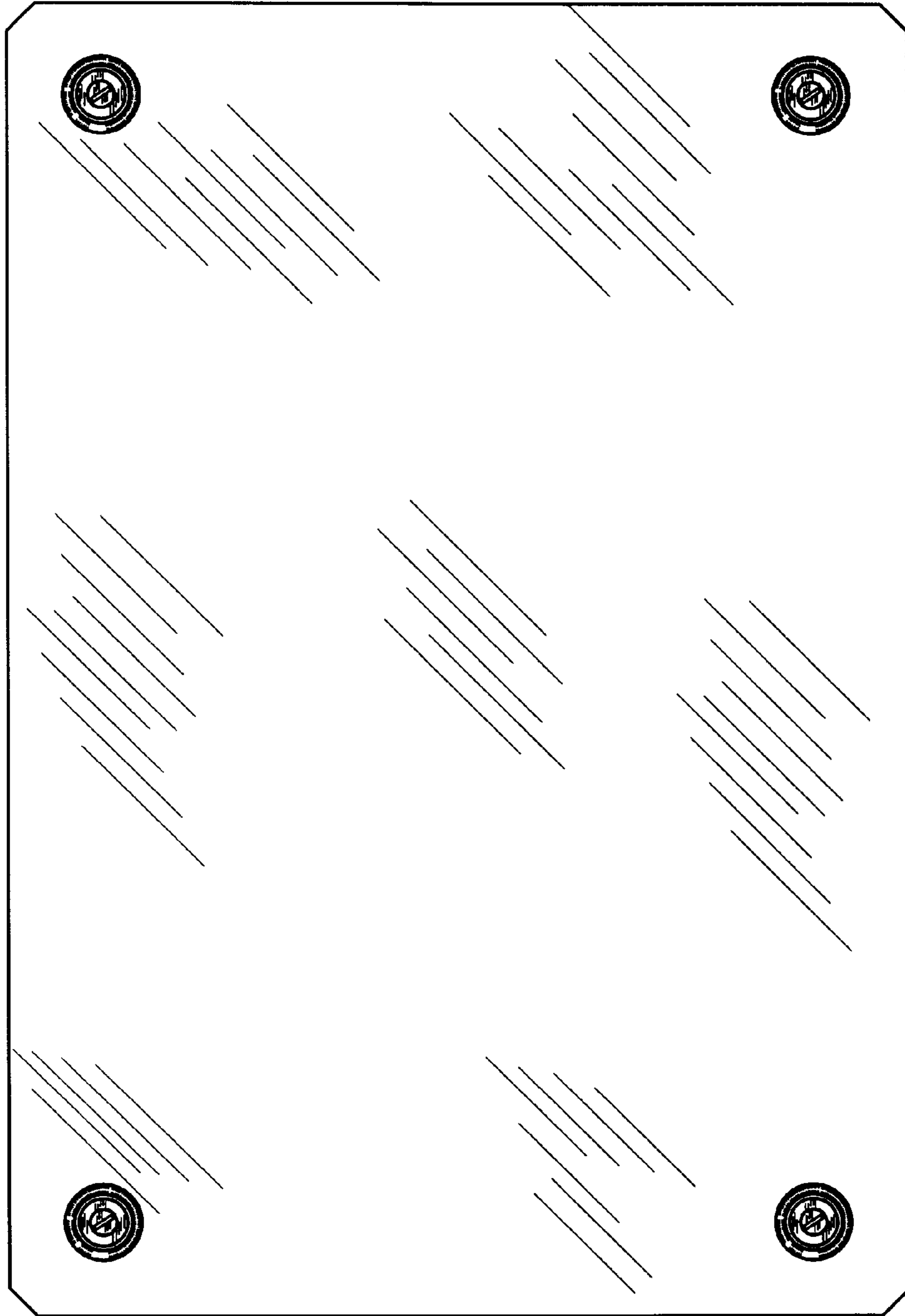
