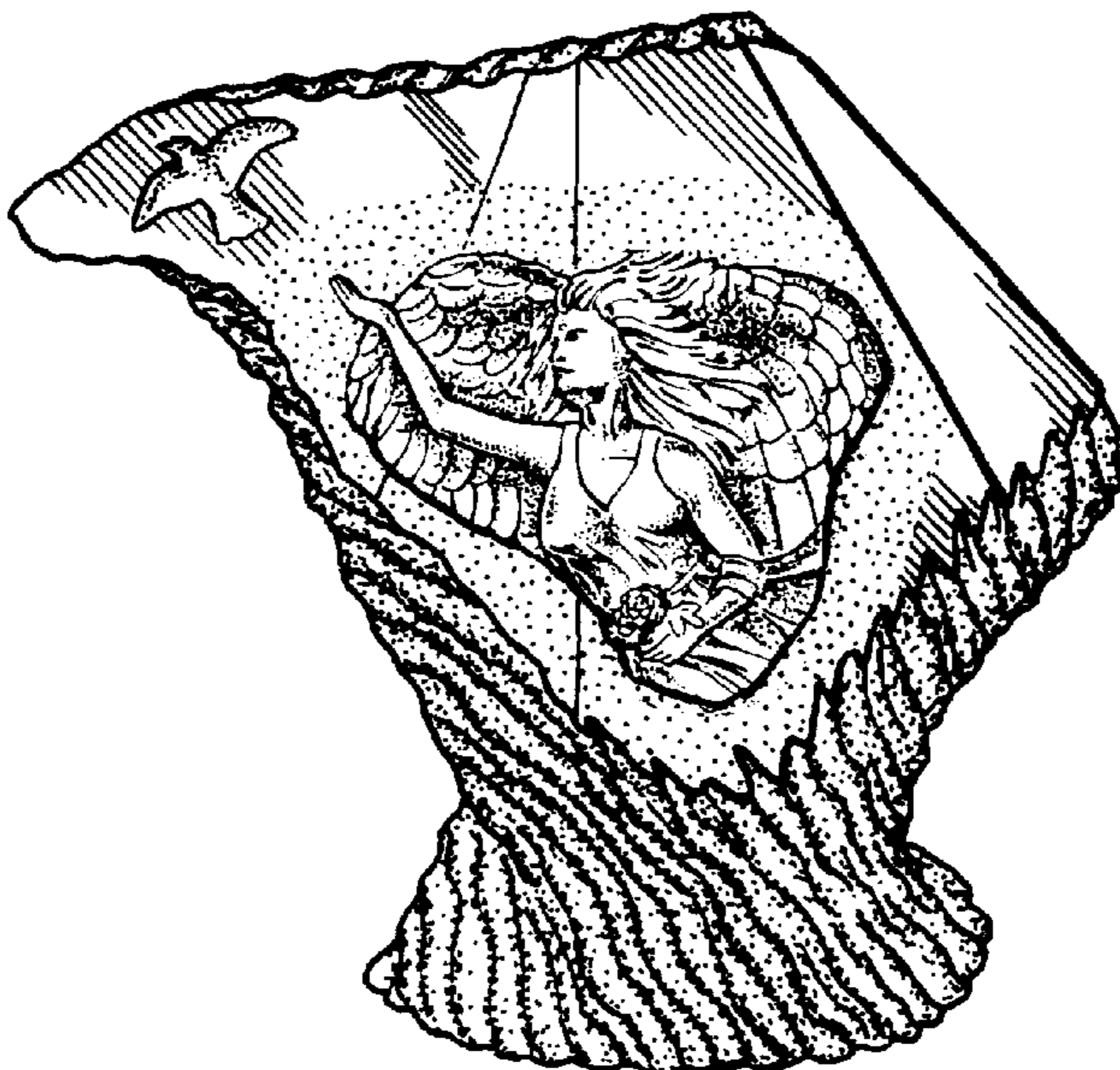
[57] CLAIM

DESCRIPTION

FIG. 1 is a front perspective view of a cremation urn showing my new design;

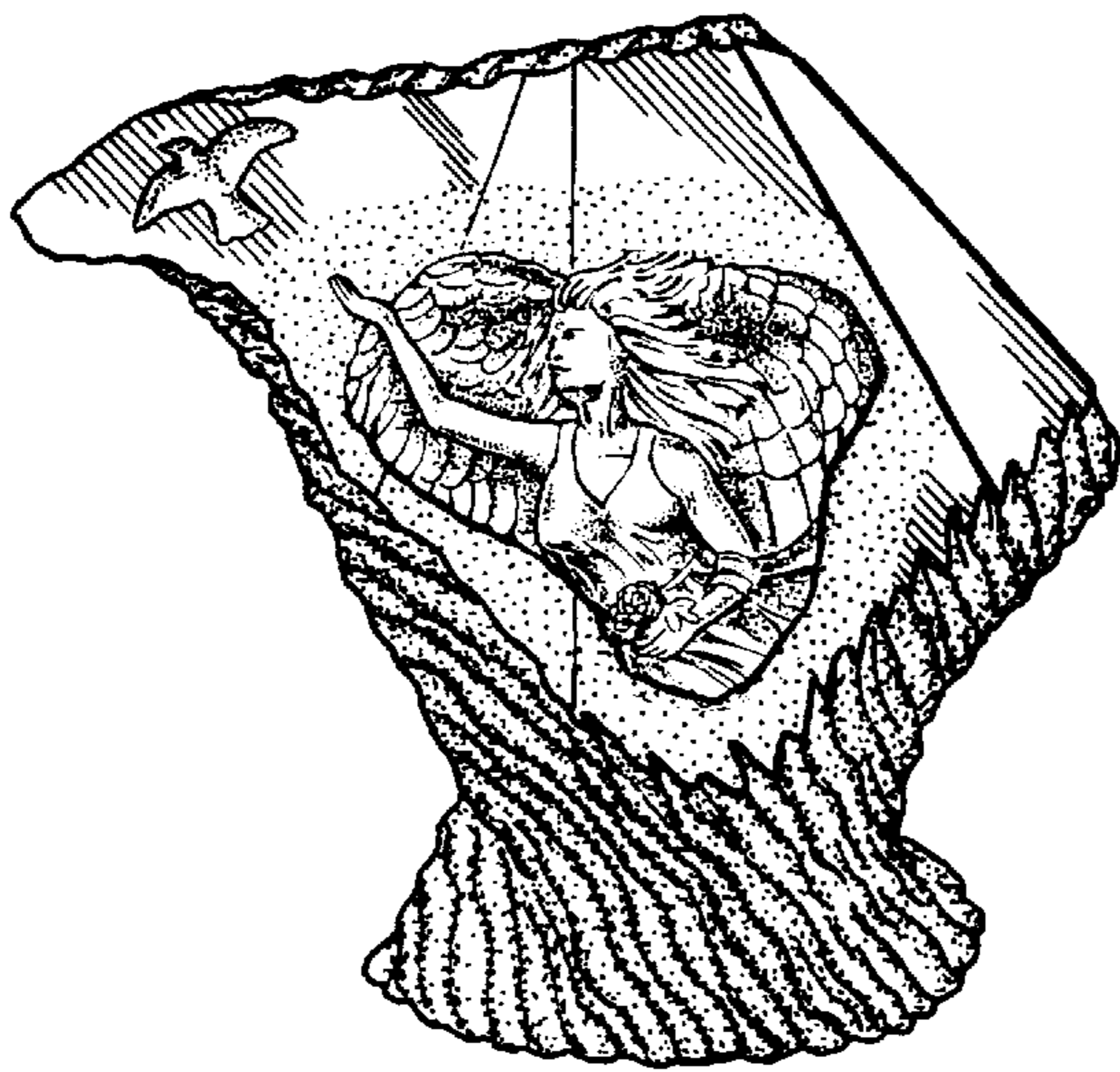

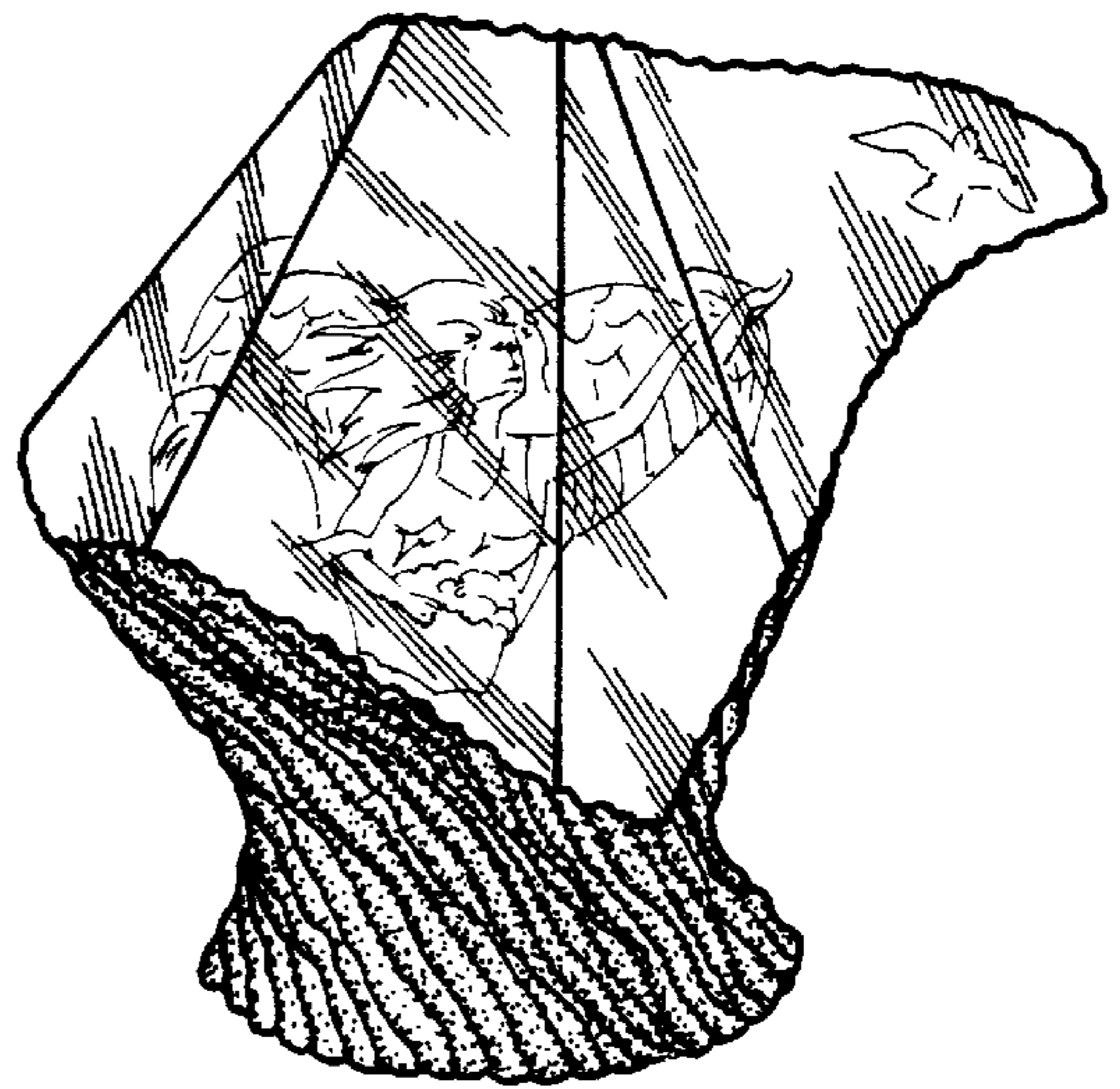

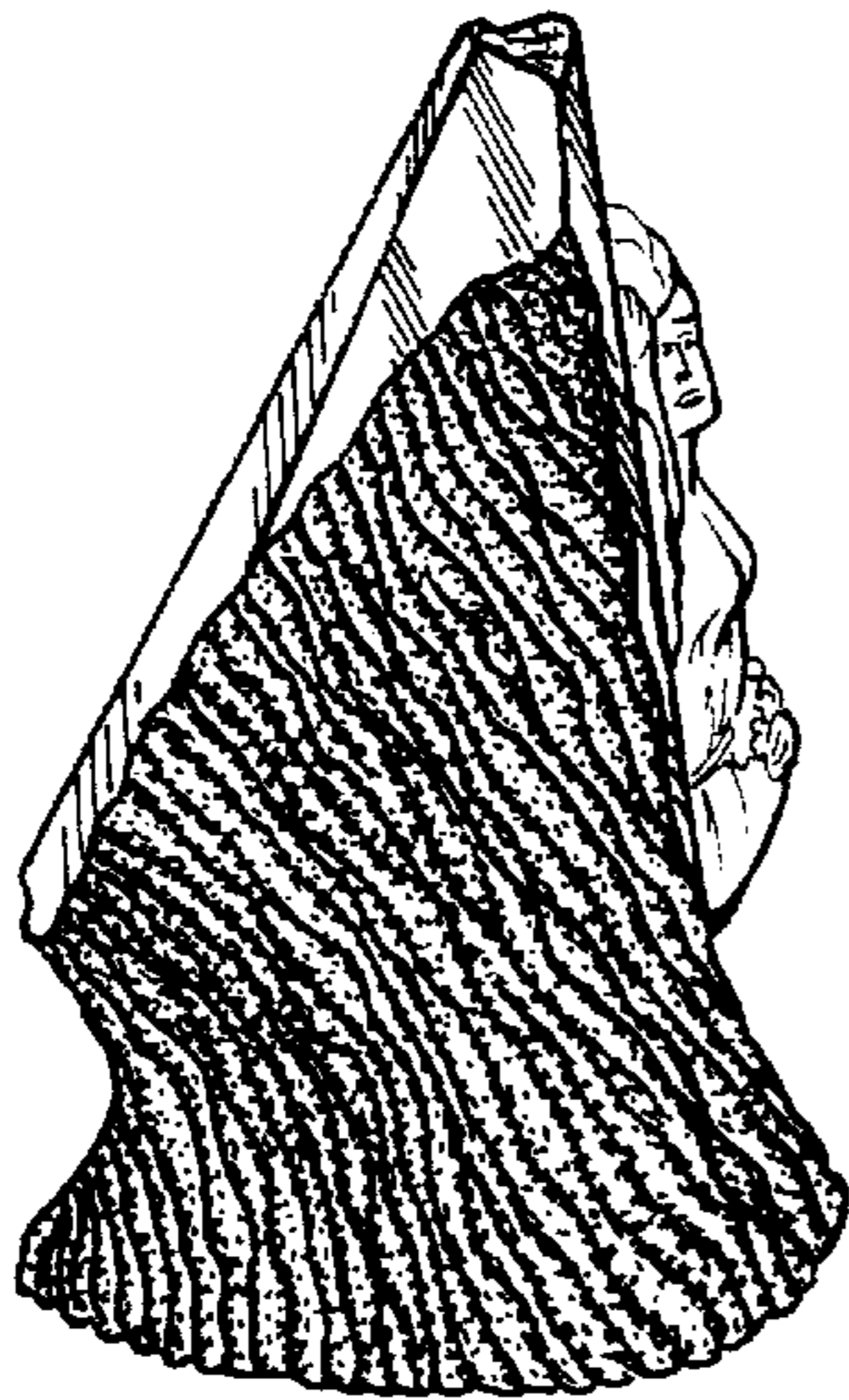

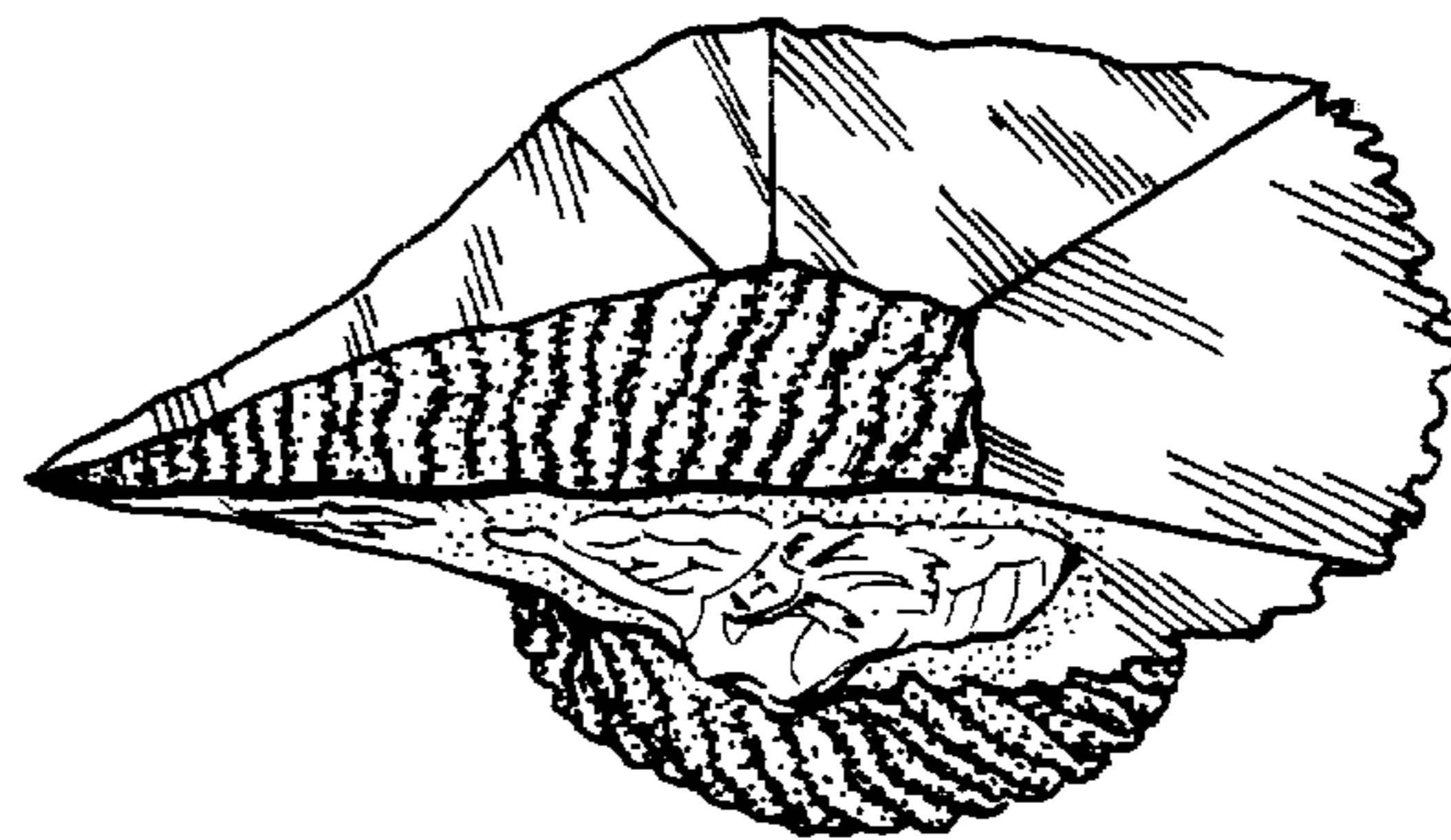

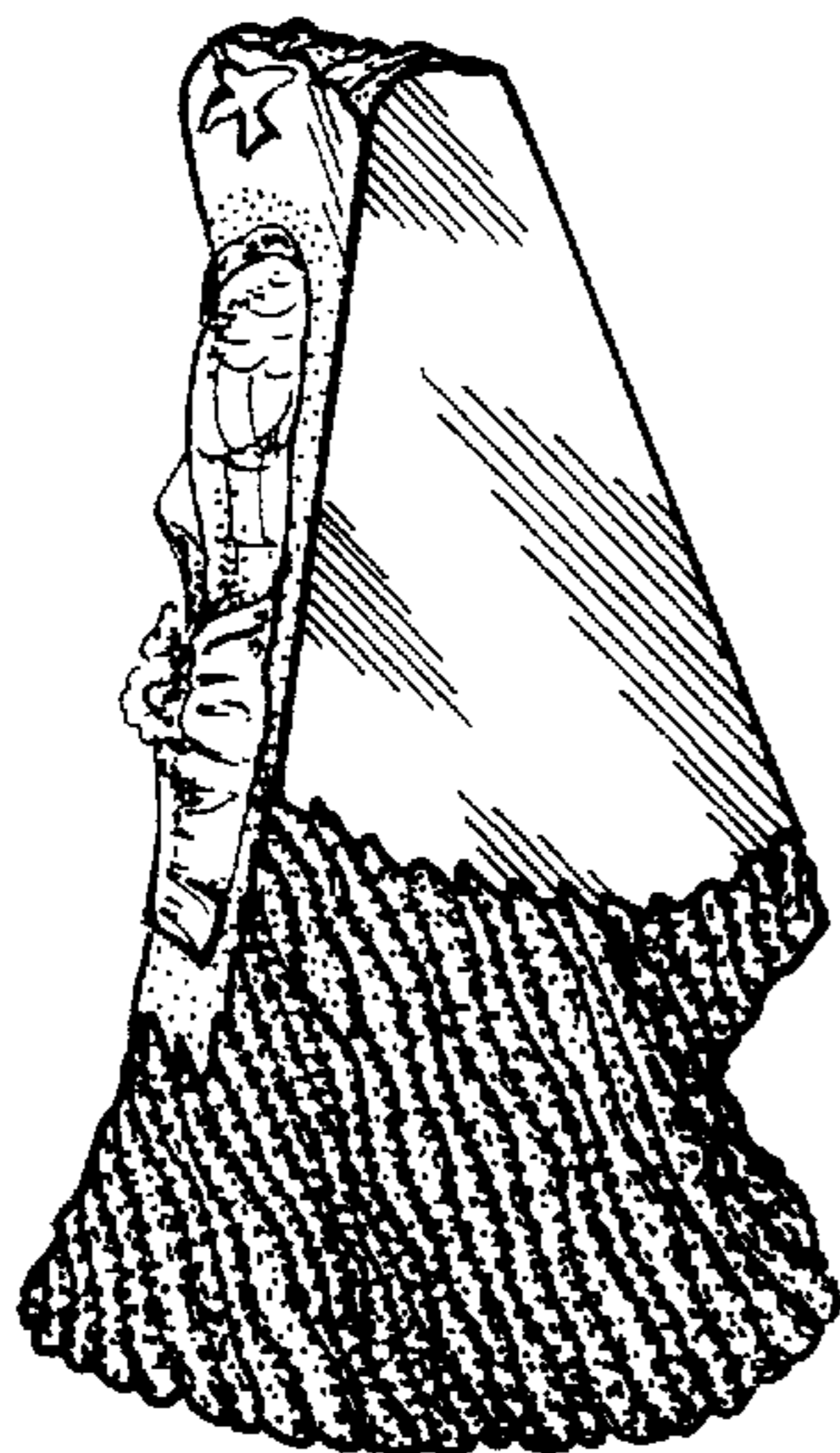

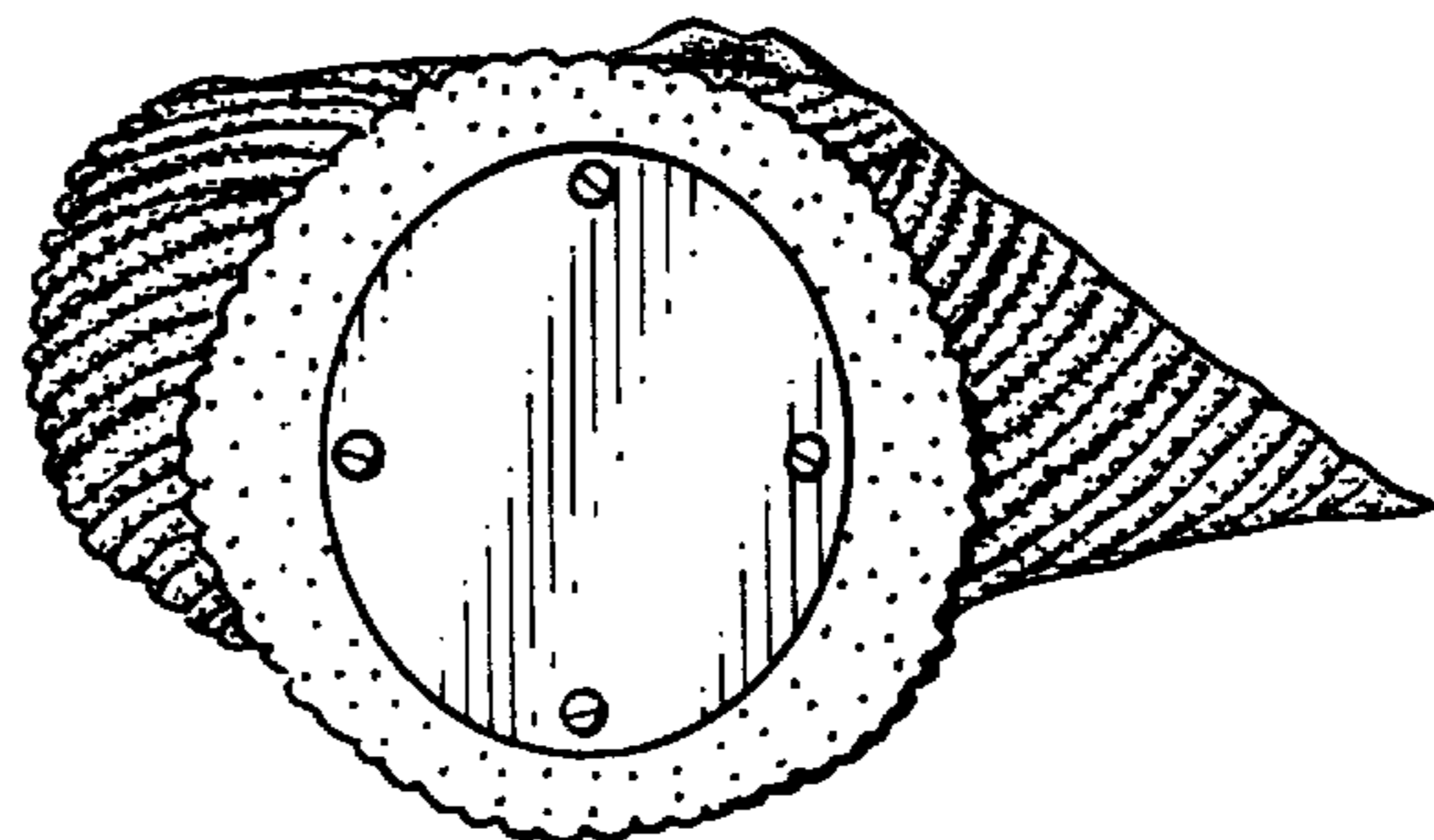
