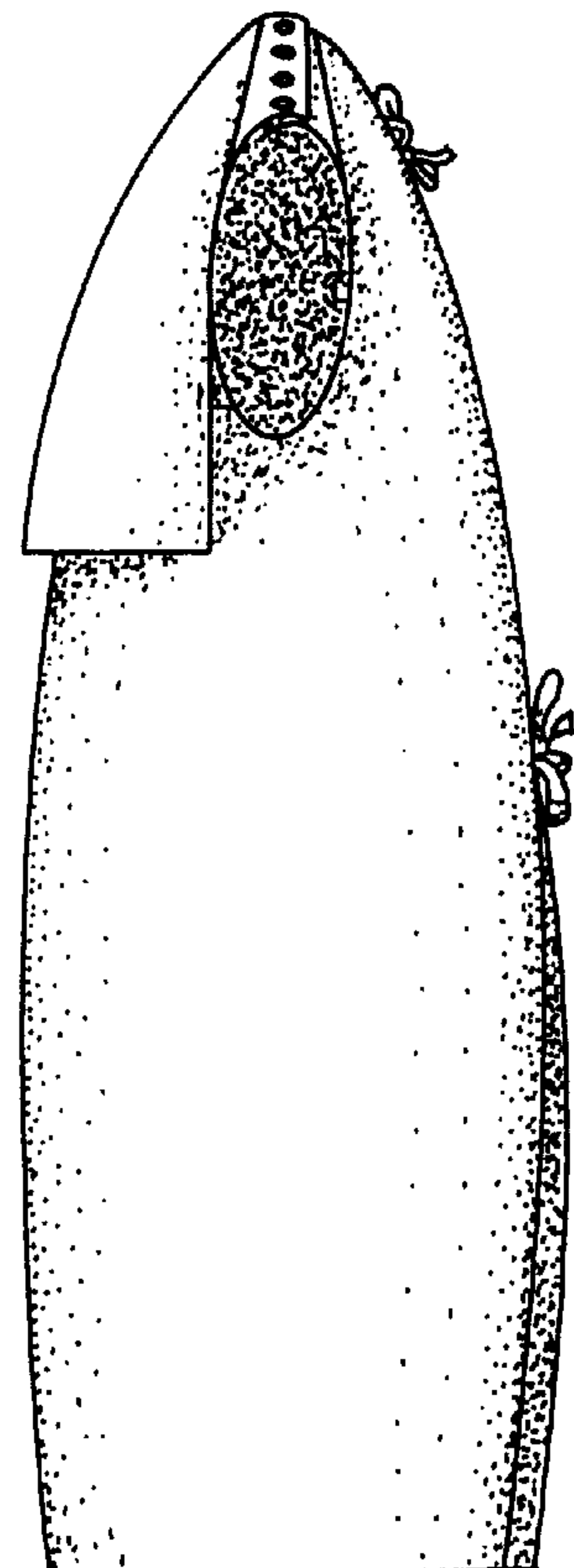
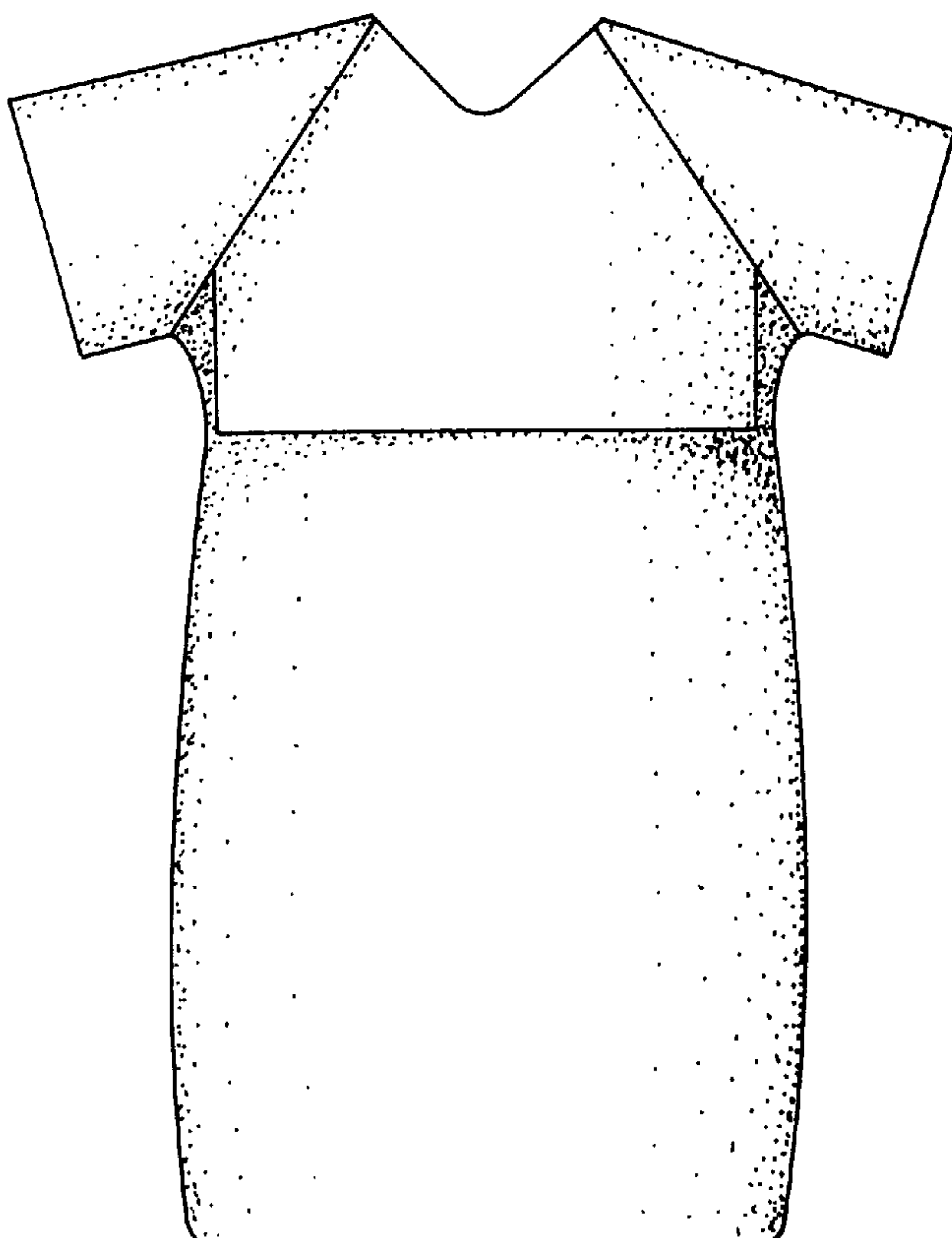
[57] **CLAIM**

The ornamental design for a multi purpose hospital gown, as shown and described.

DESCRIPTION

FIG. 1 is front view of the multi purpose hospital gown as it would appear while being worn, showing my new design; FIG. 2 is a front view of the multi purpose hospital gown; FIG. 3 is a left side view of the multi purpose hospital gown; FIG. 4 is a back view of the multi purpose hospital gown; FIG. 5 is a right side view of the multi purpose hospital gown; and, FIG. 6 is a top view of the multi purpose hospital gown.

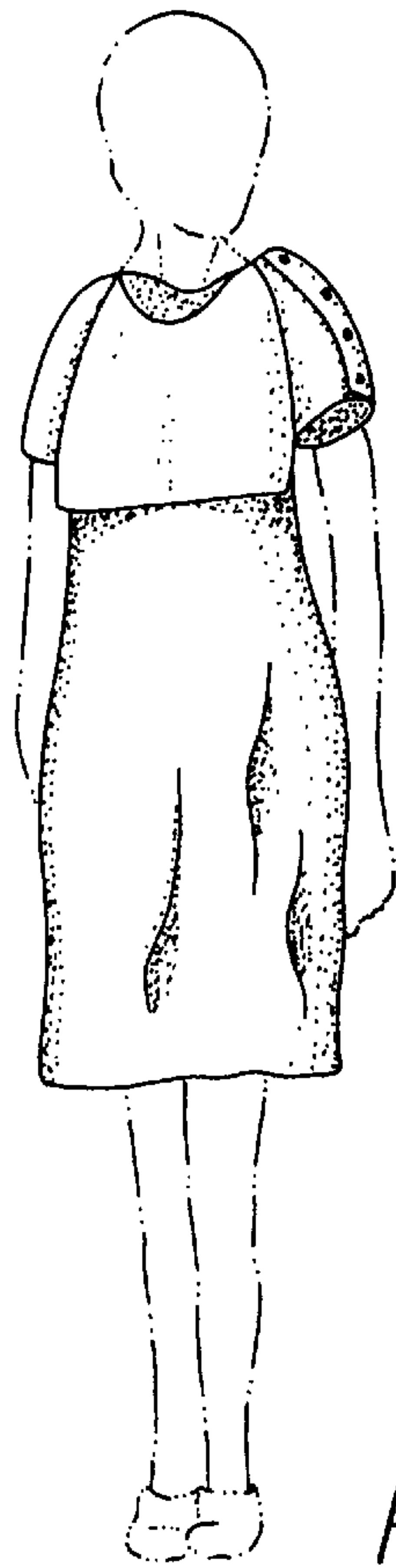

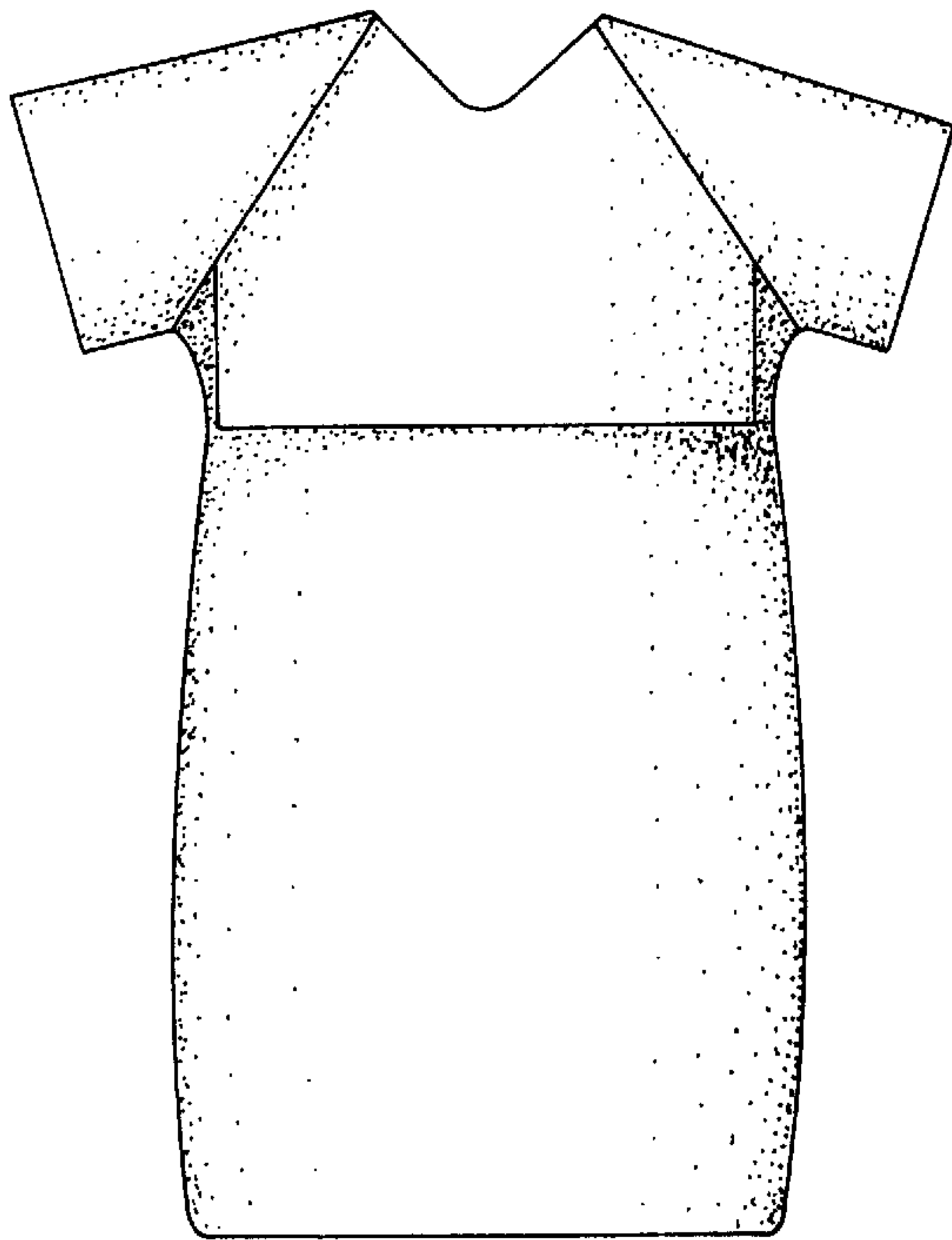

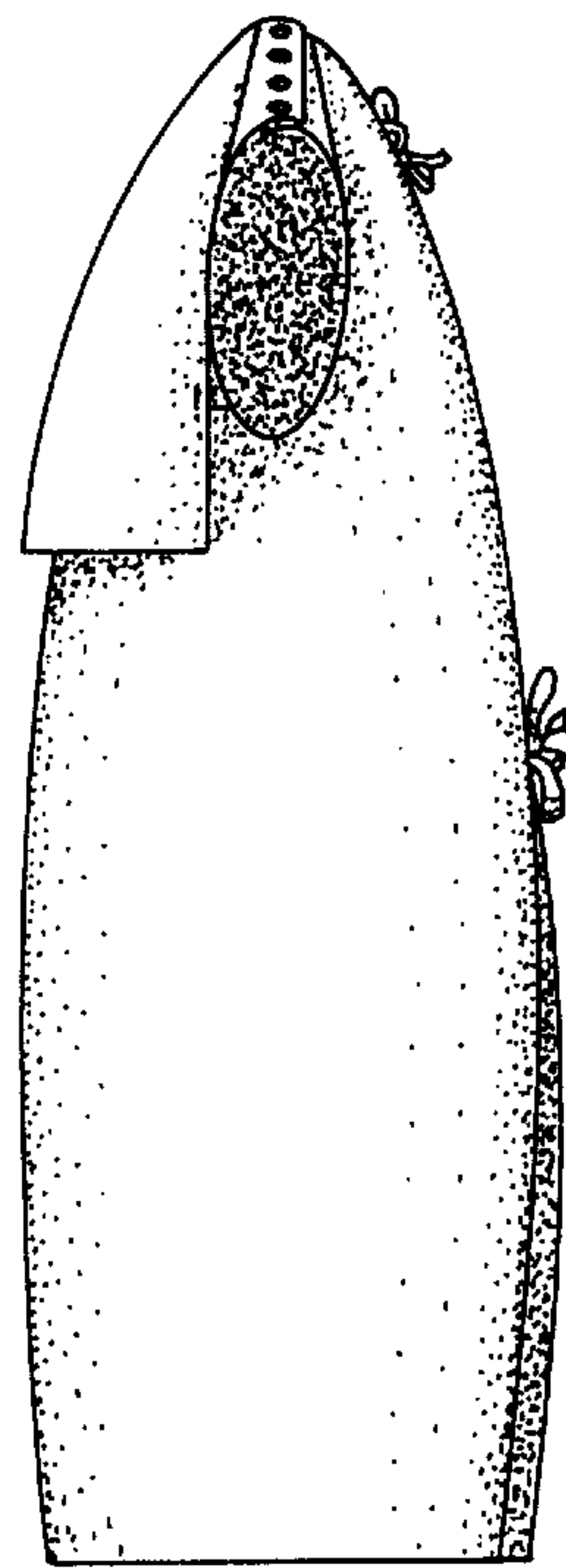

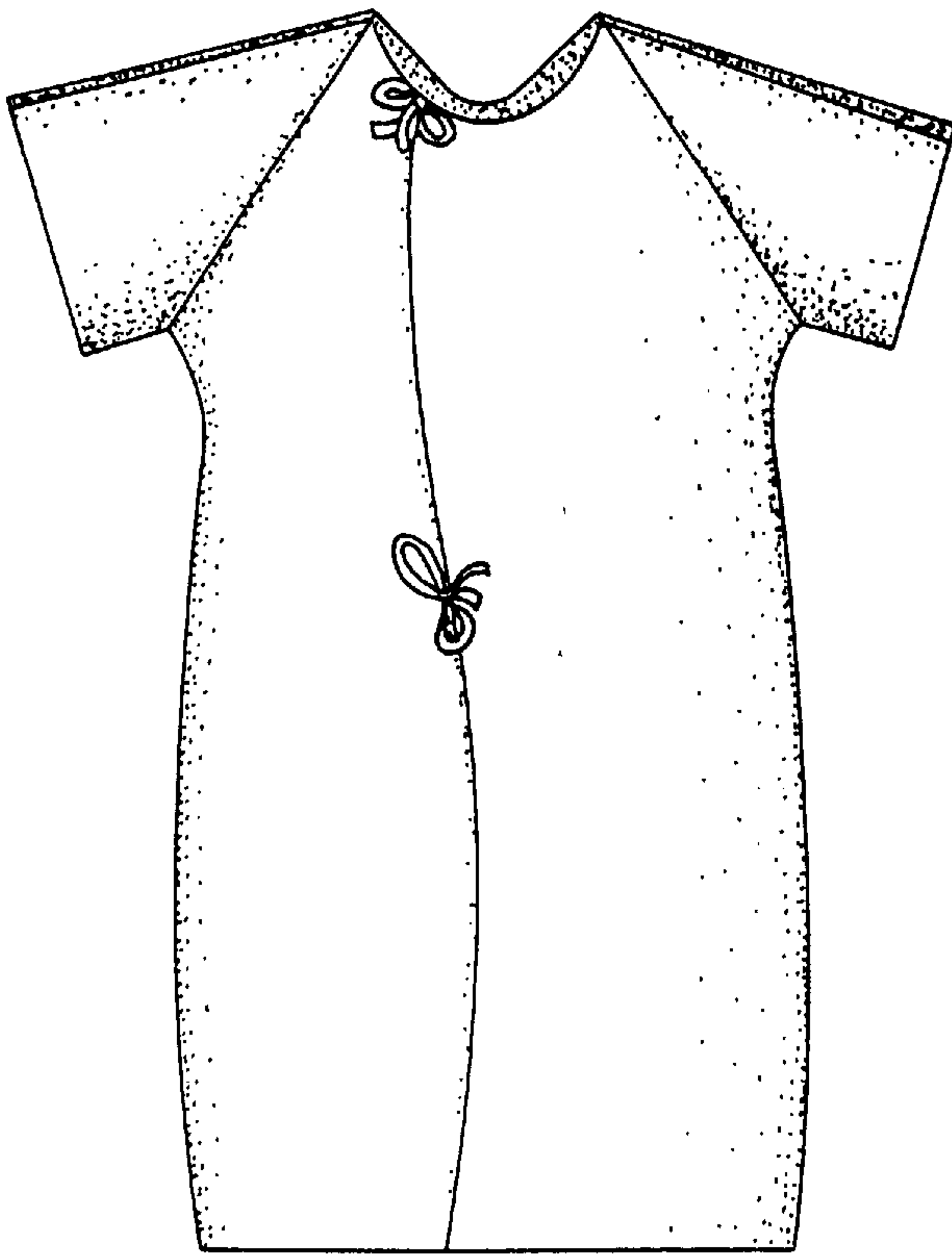

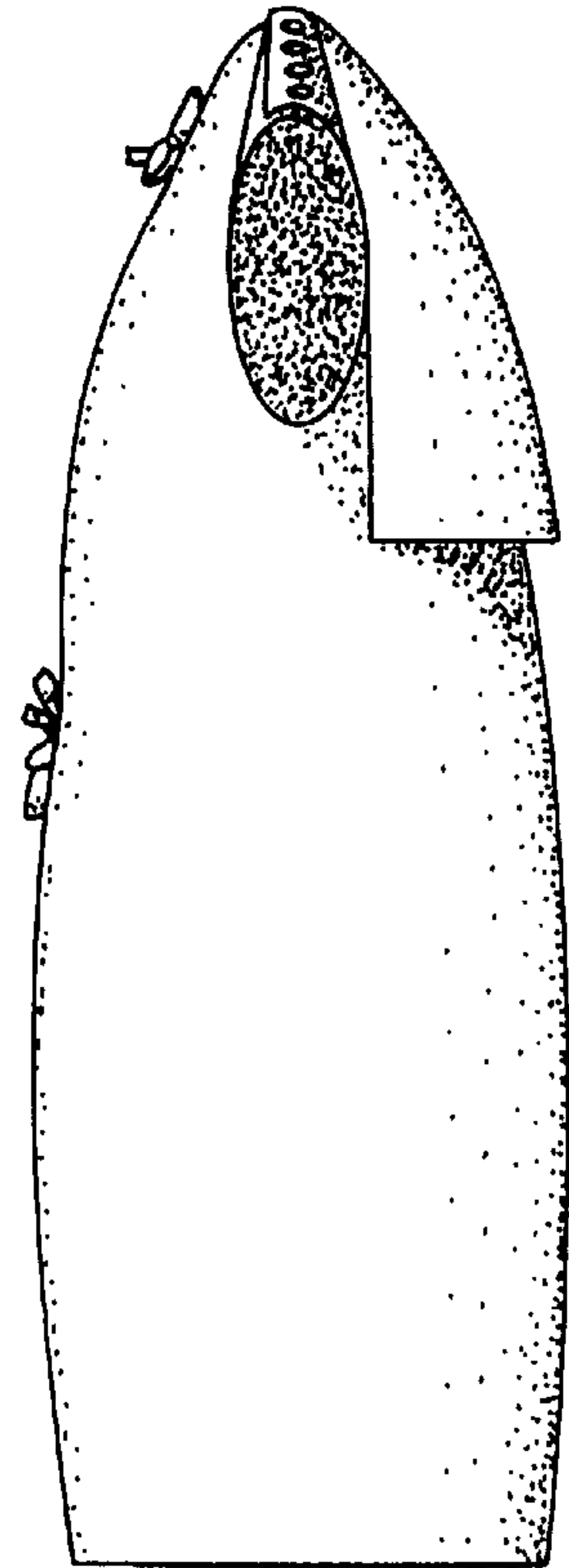

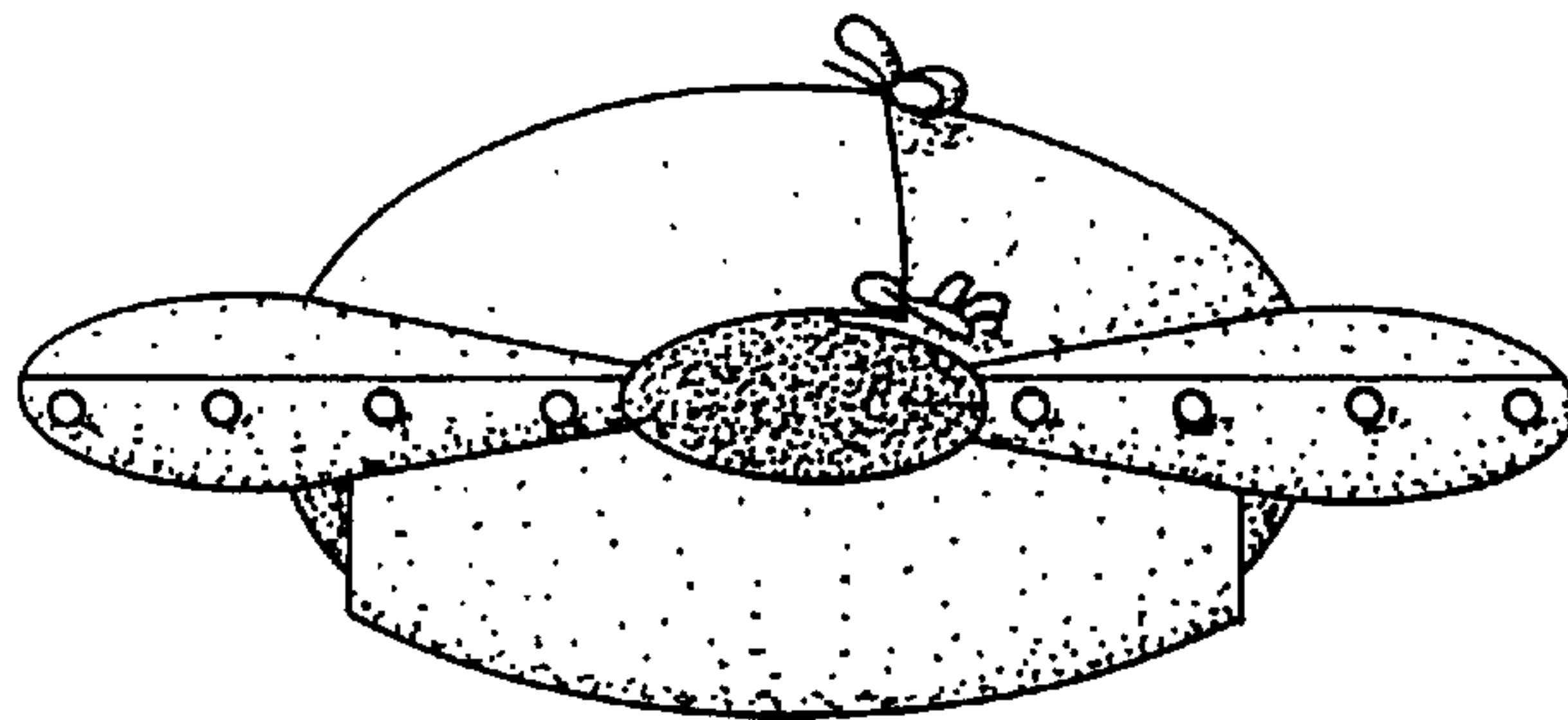
