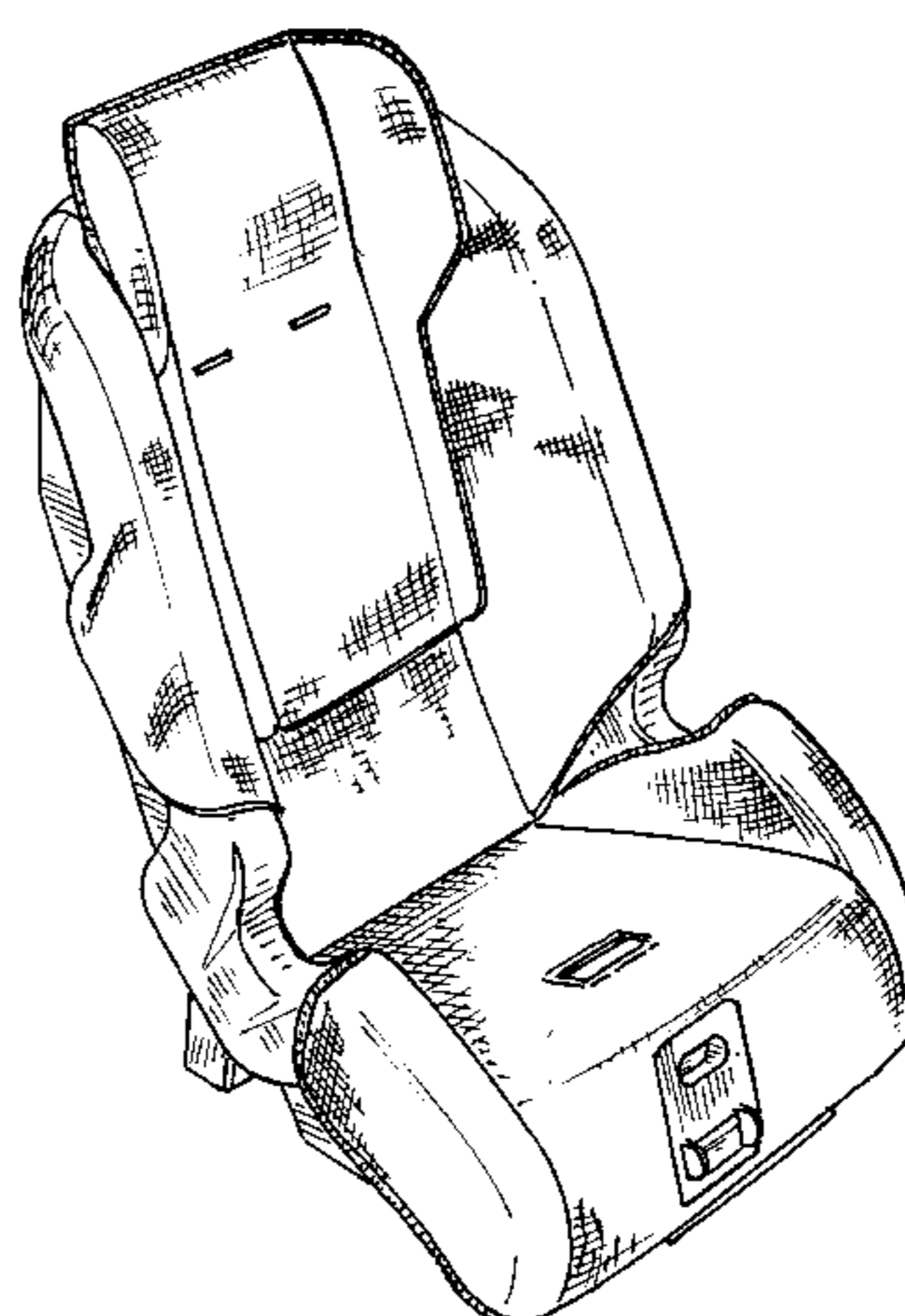
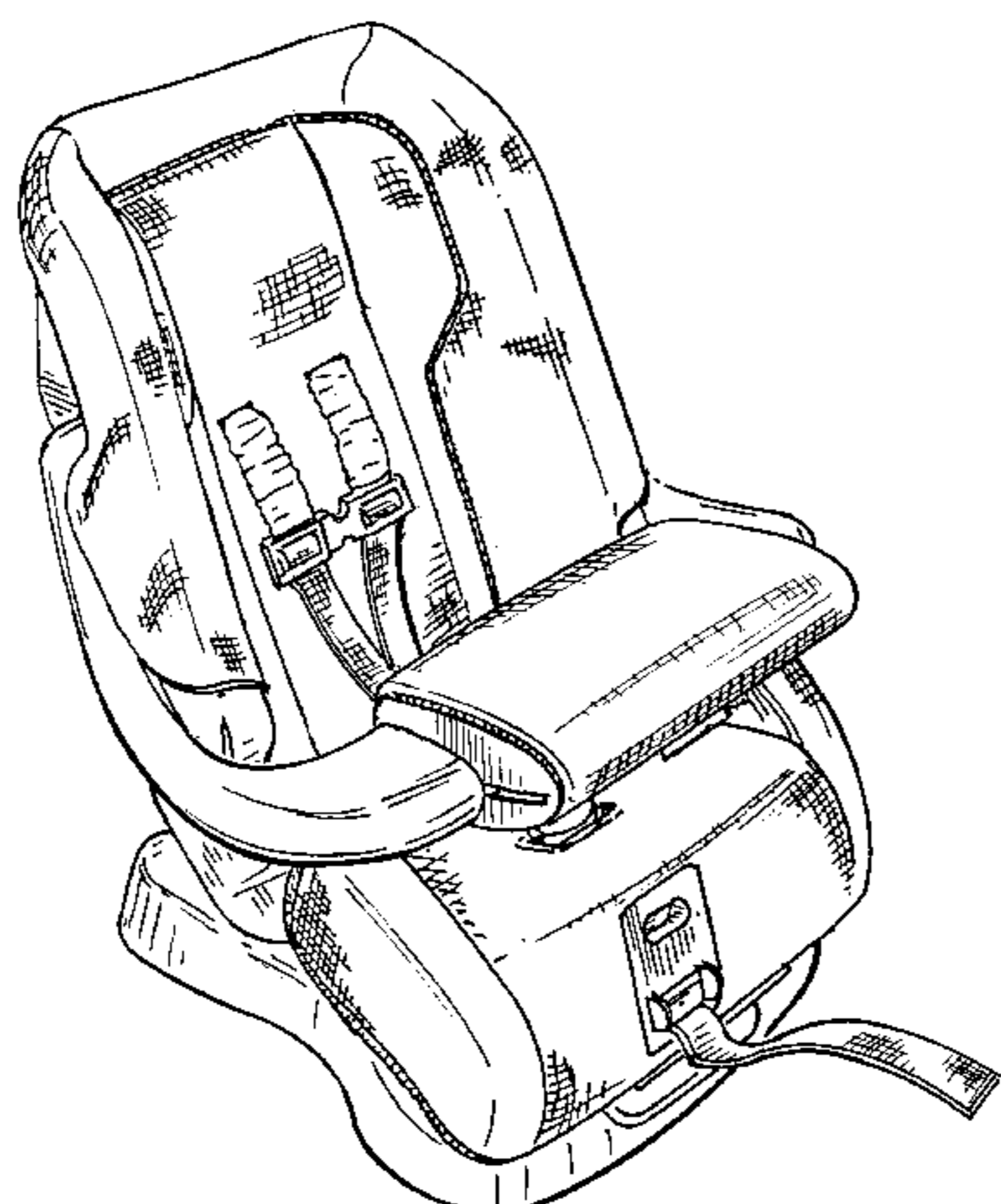
[57] **CLAIM**

The ornamental design for a juvenile vehicle seat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a juvenile vehicle seat showing a first embodiment of my new design; FIG. 2 is a left-side elevational view thereof, with the right-side elevational view being a mirror image thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view of a juvenile vehicle seat showing a second embodiment of my new design; FIG. 8 is a left-side elevational view thereof, with the right-side elevational view being a mirror image thereof; FIG. 9 is a front elevational view thereof; FIG. 10 is a rear elevational view thereof; FIG. 11 is a top plan view thereof; and, FIG. 12 is a bottom view thereof.

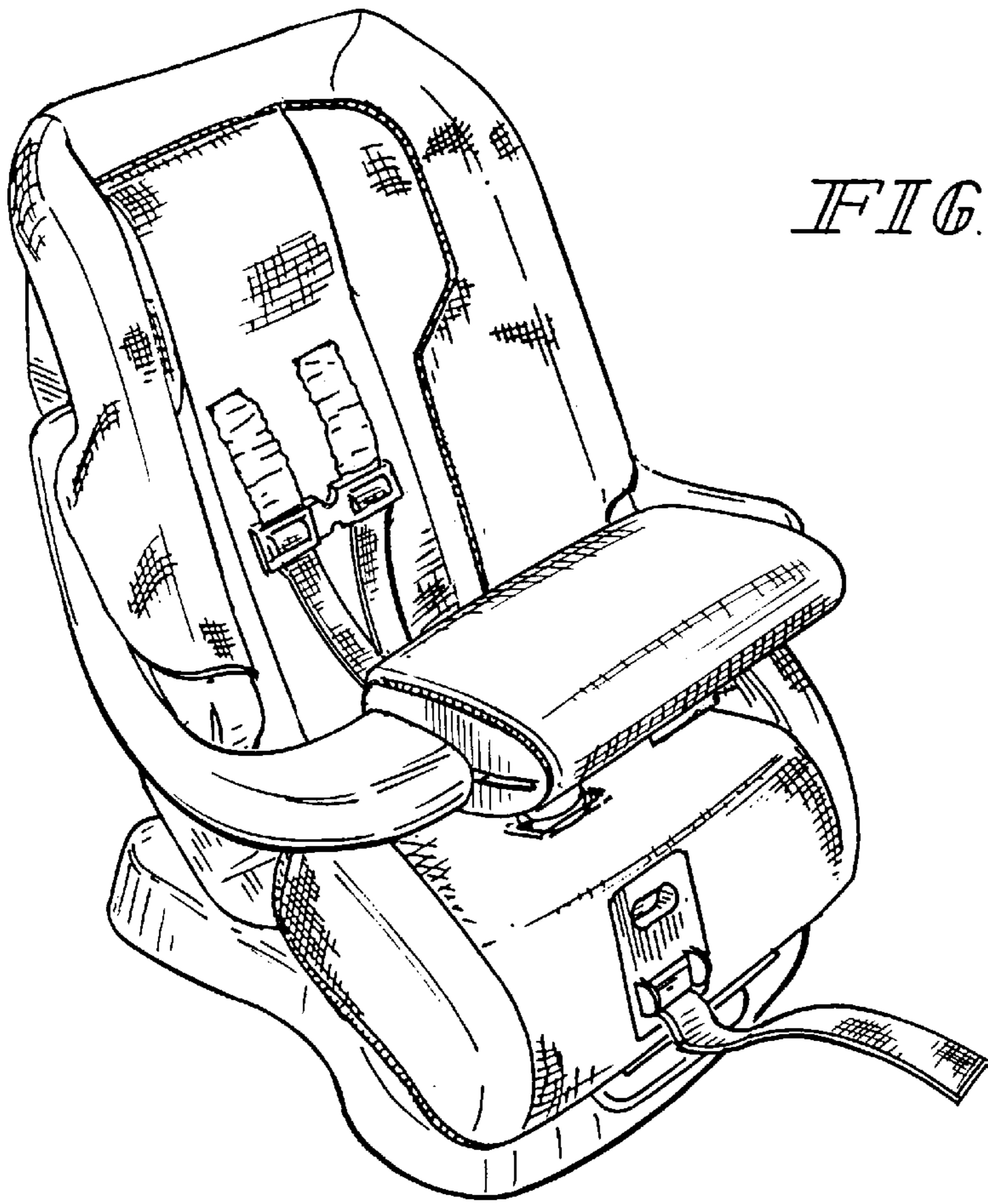

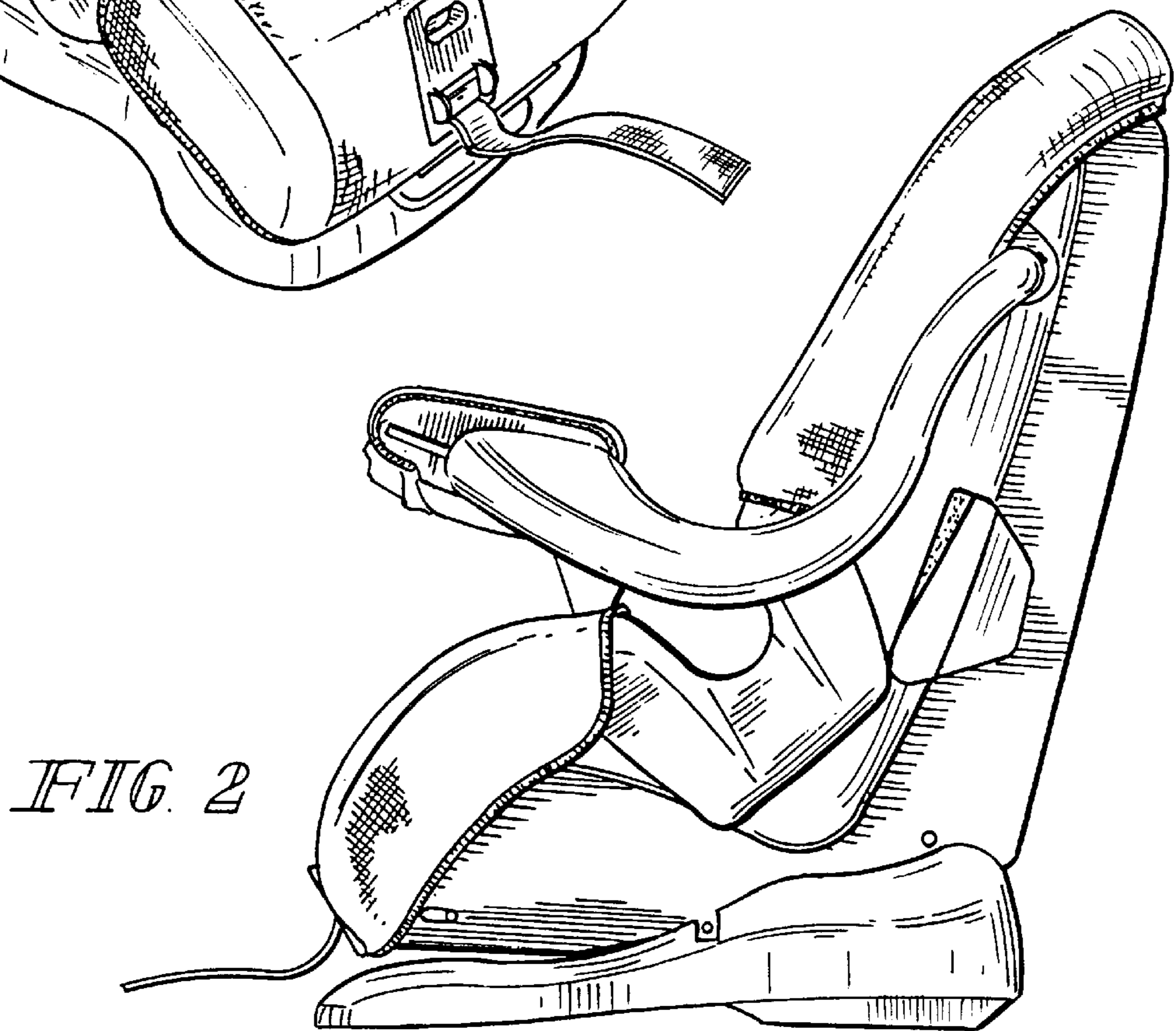

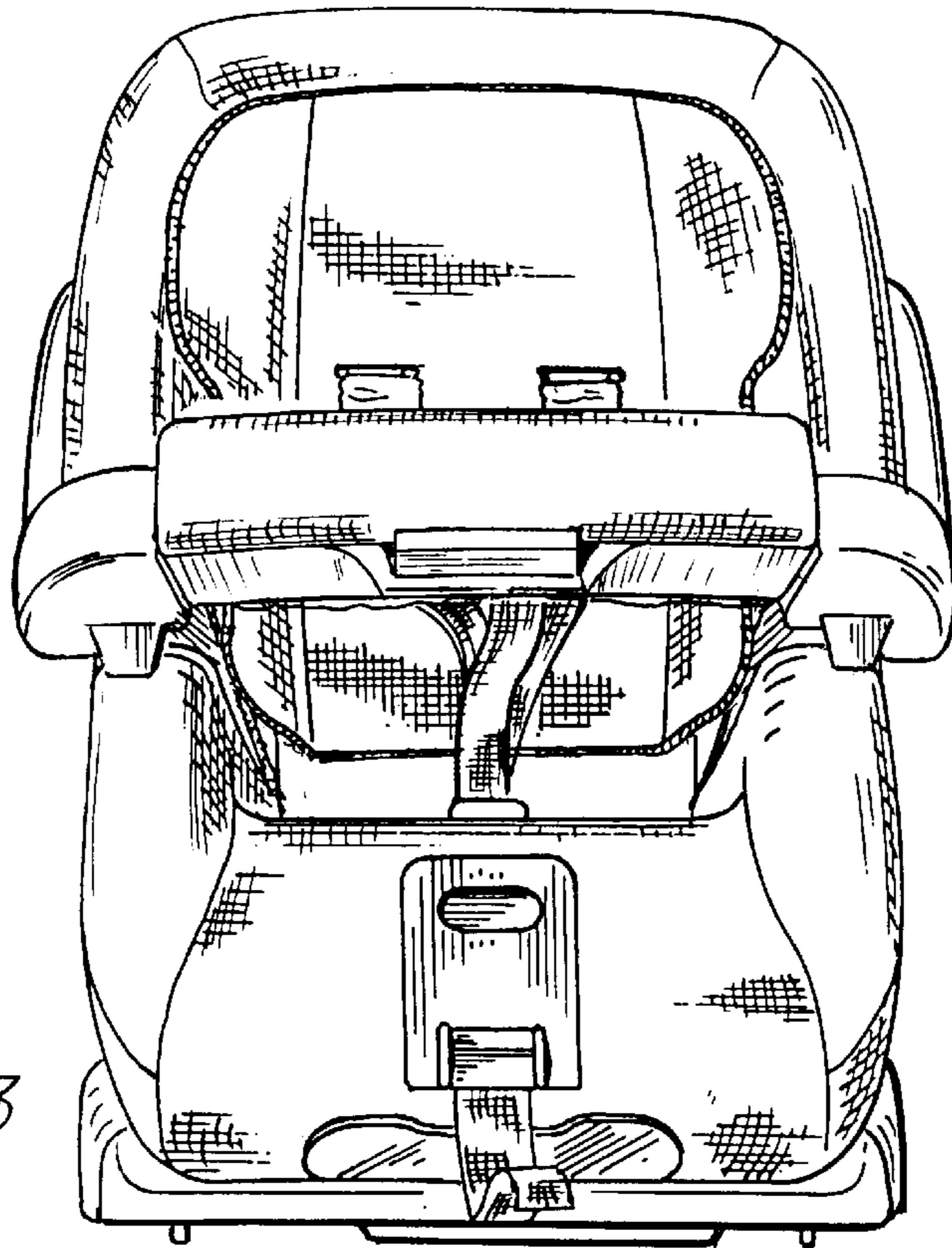

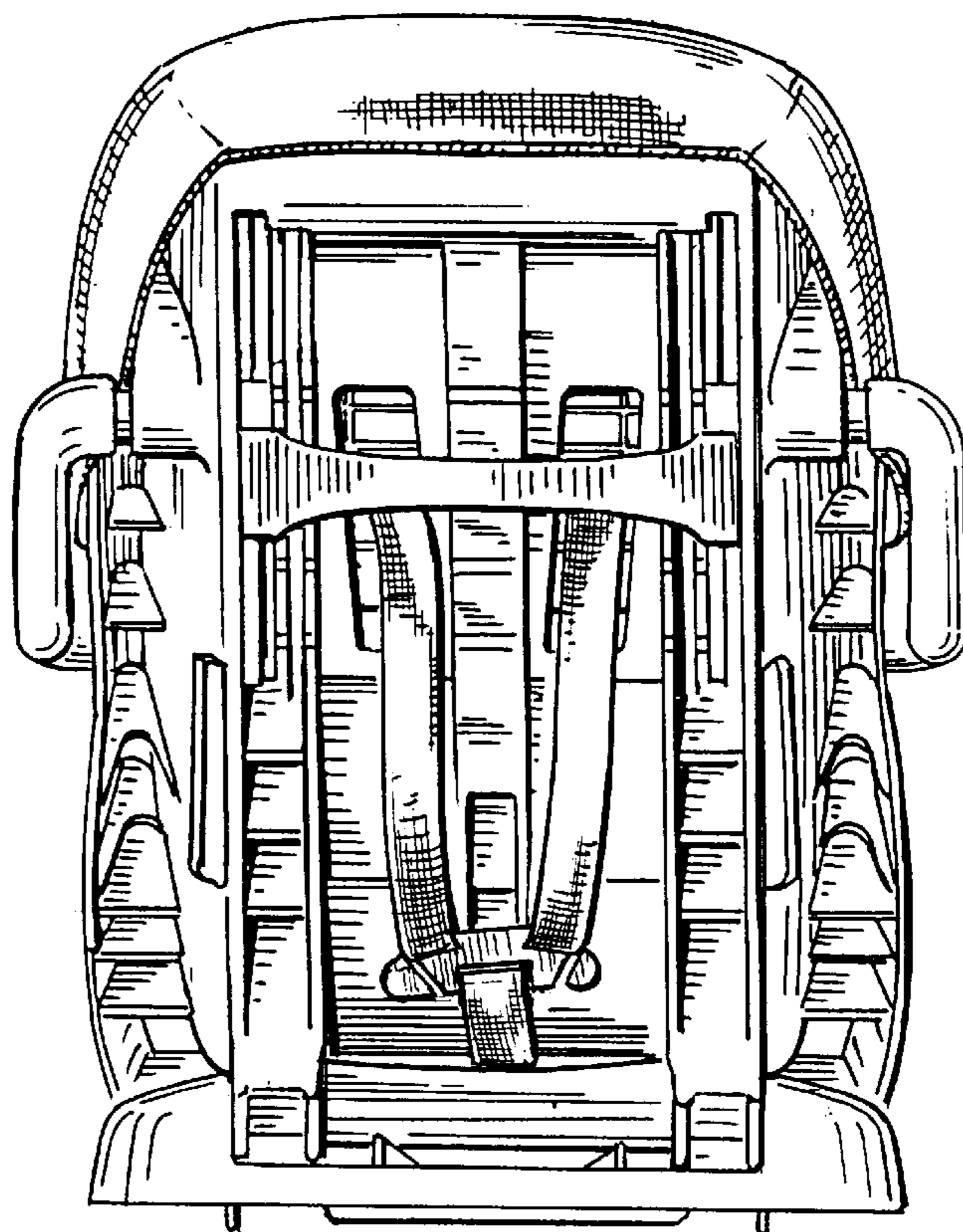

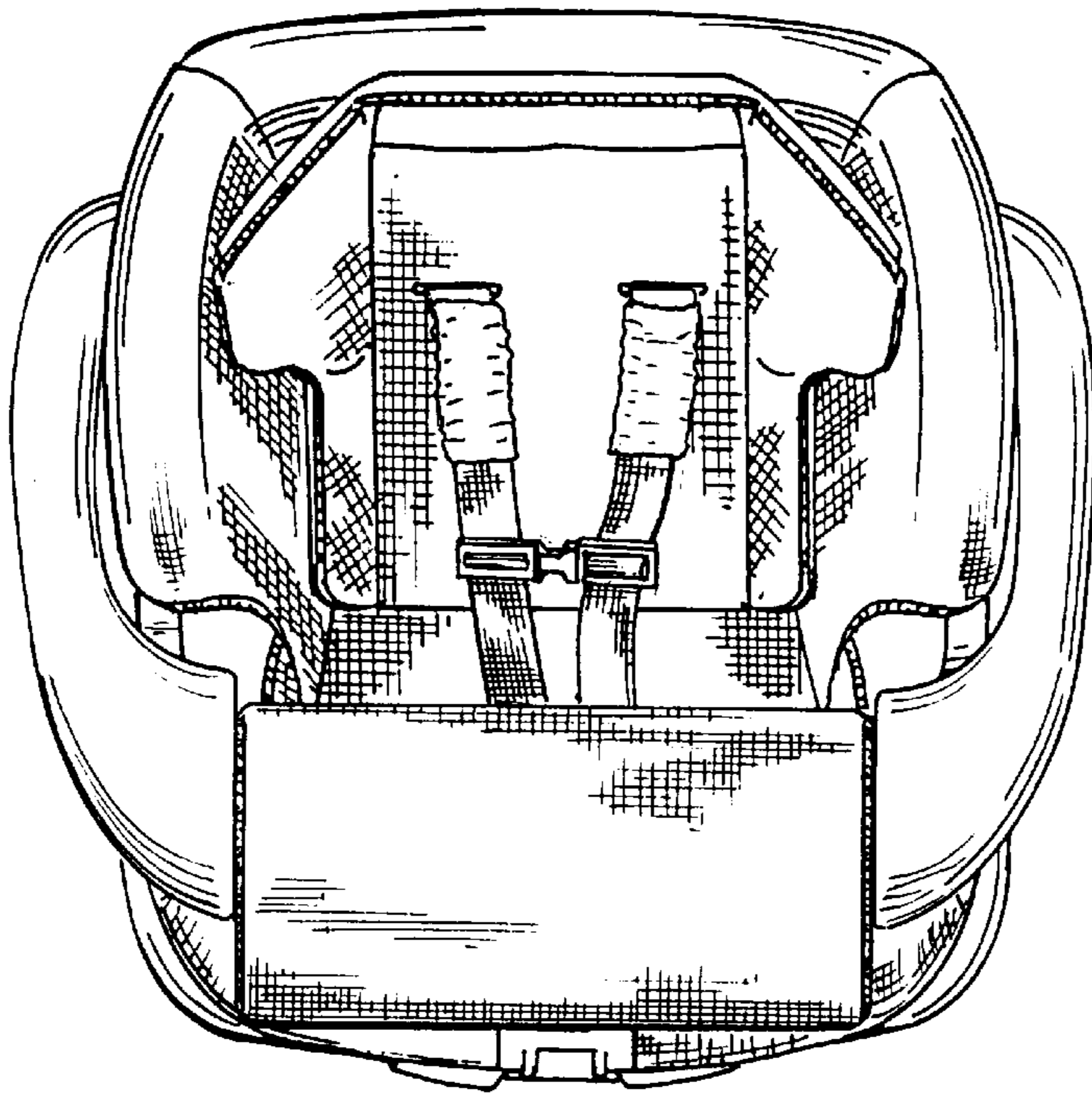

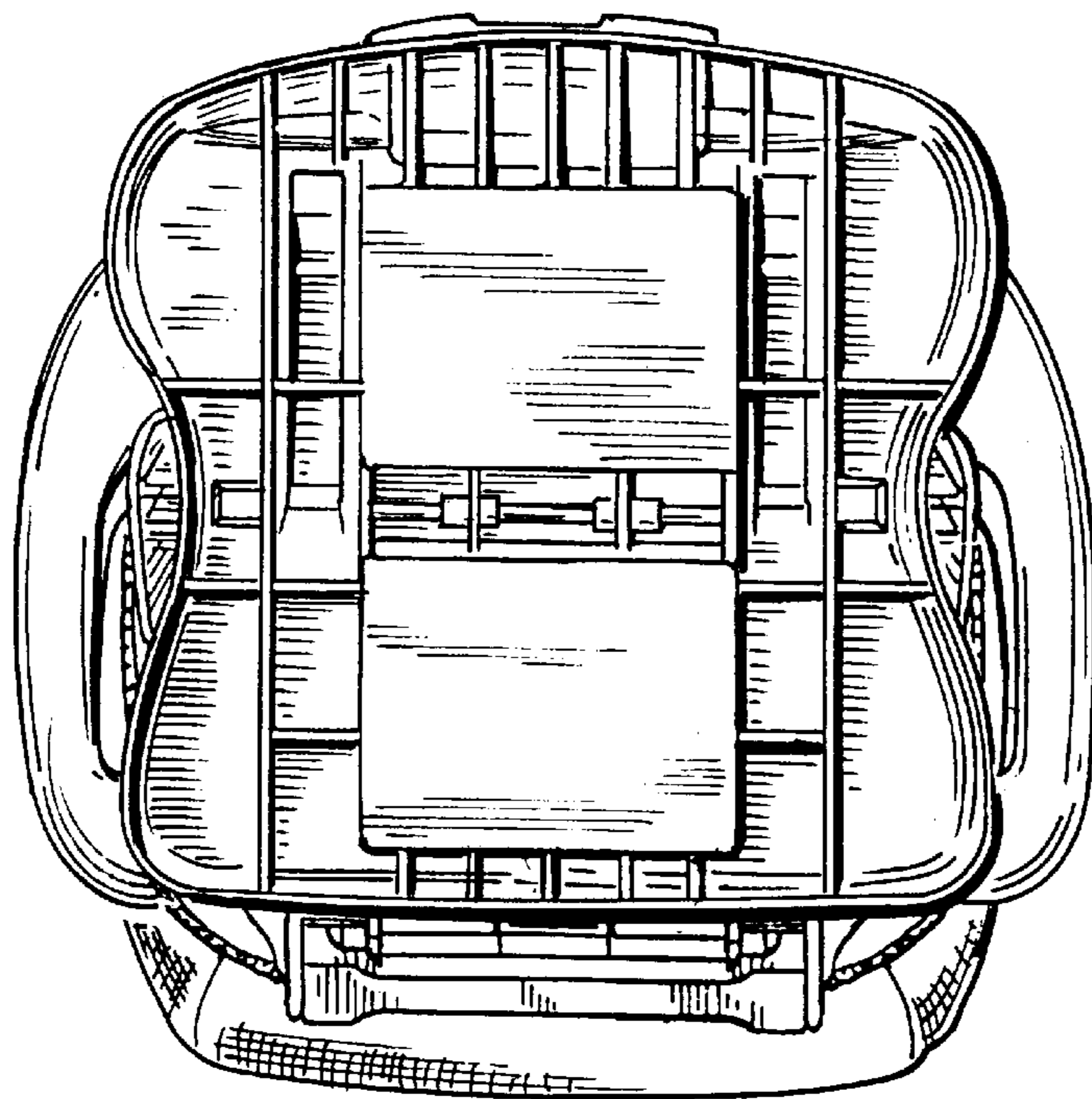

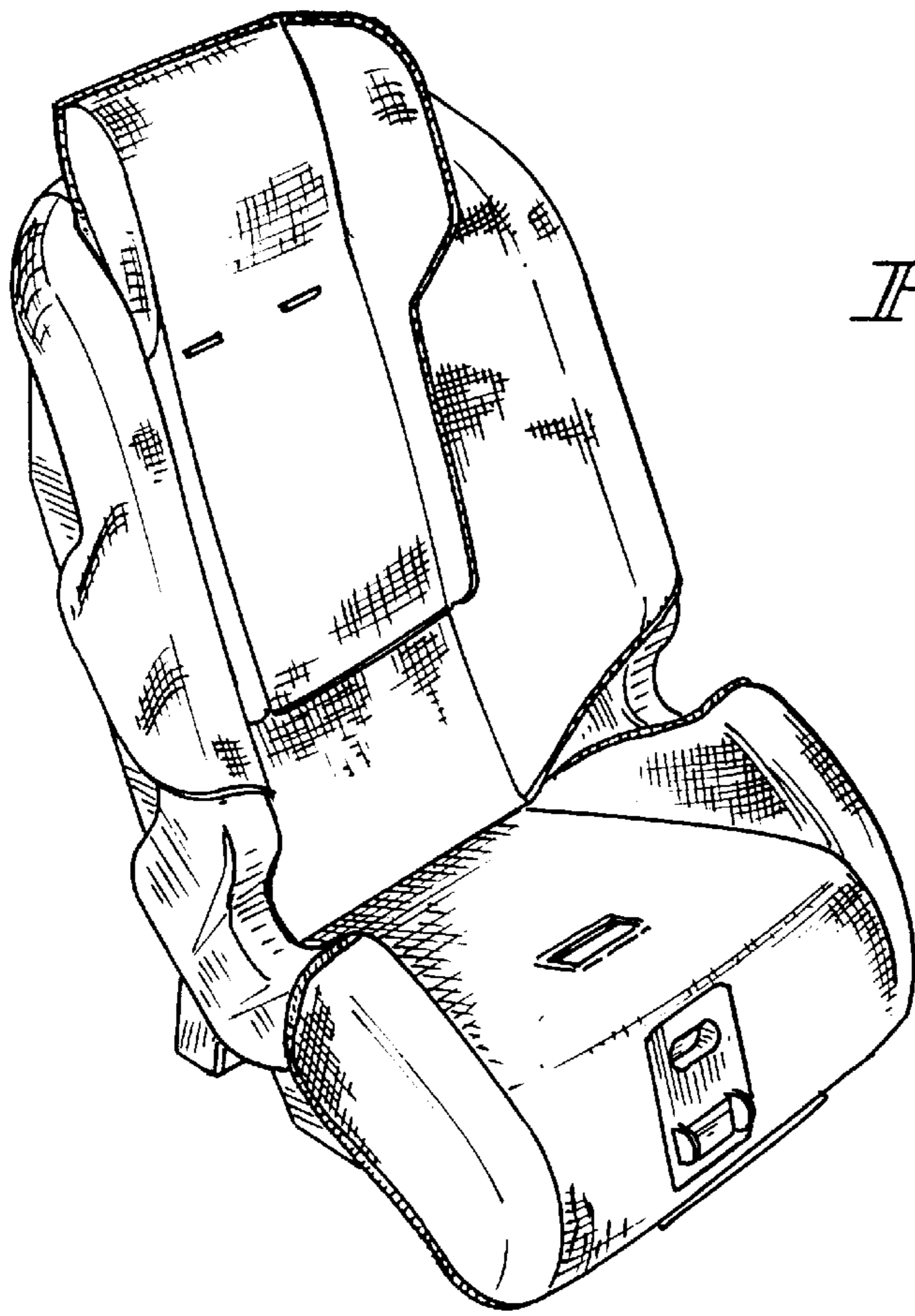
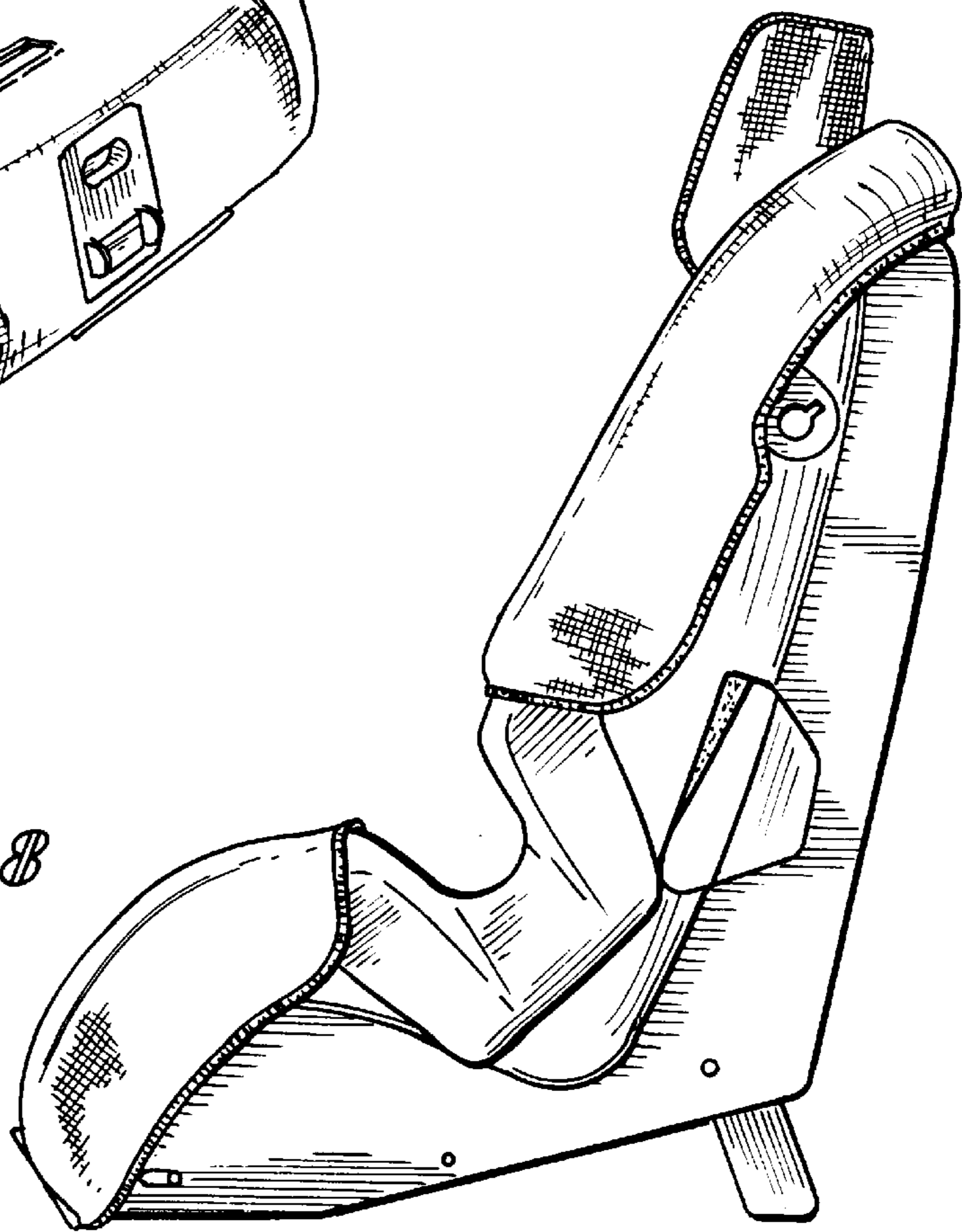

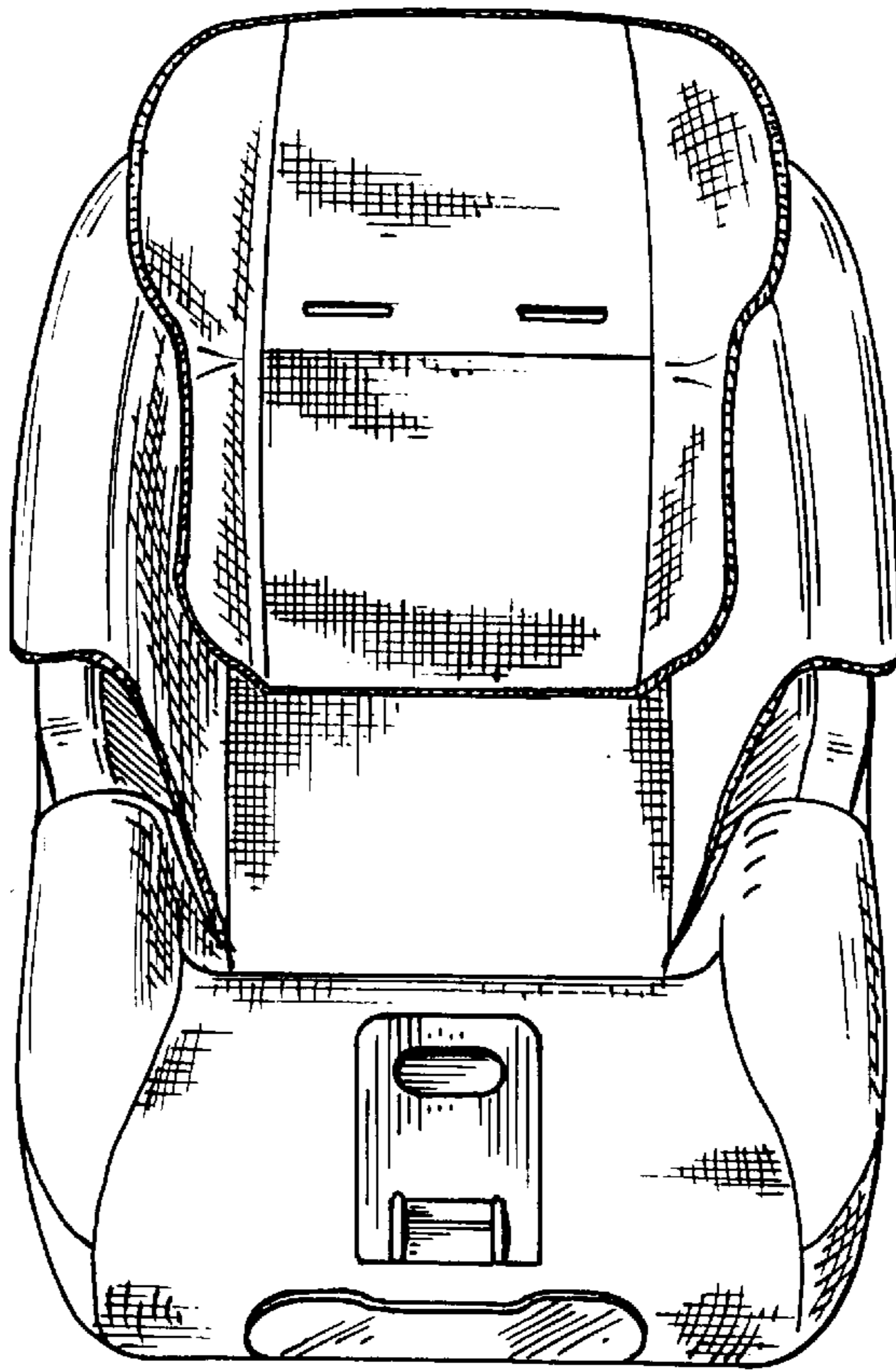

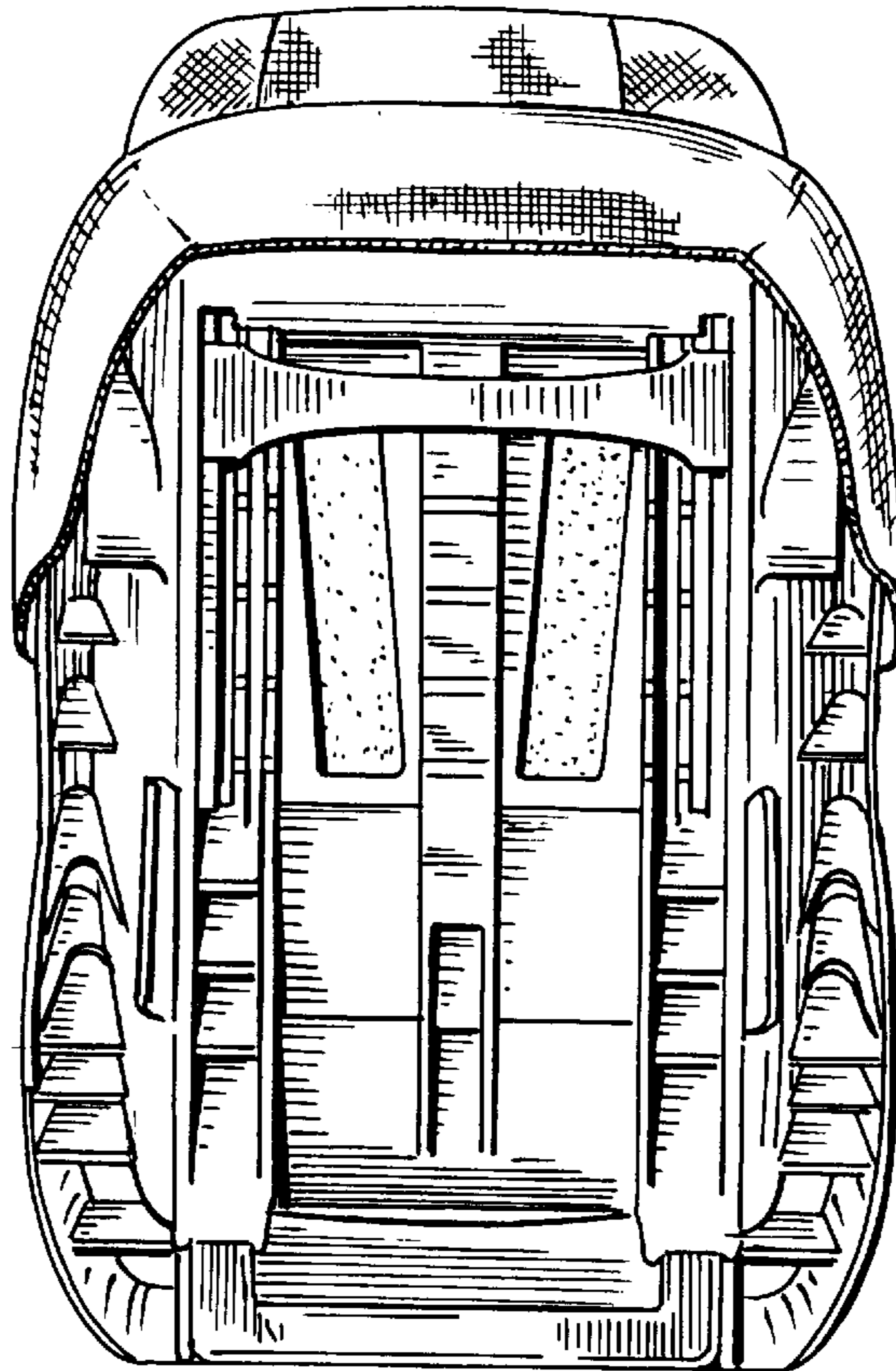

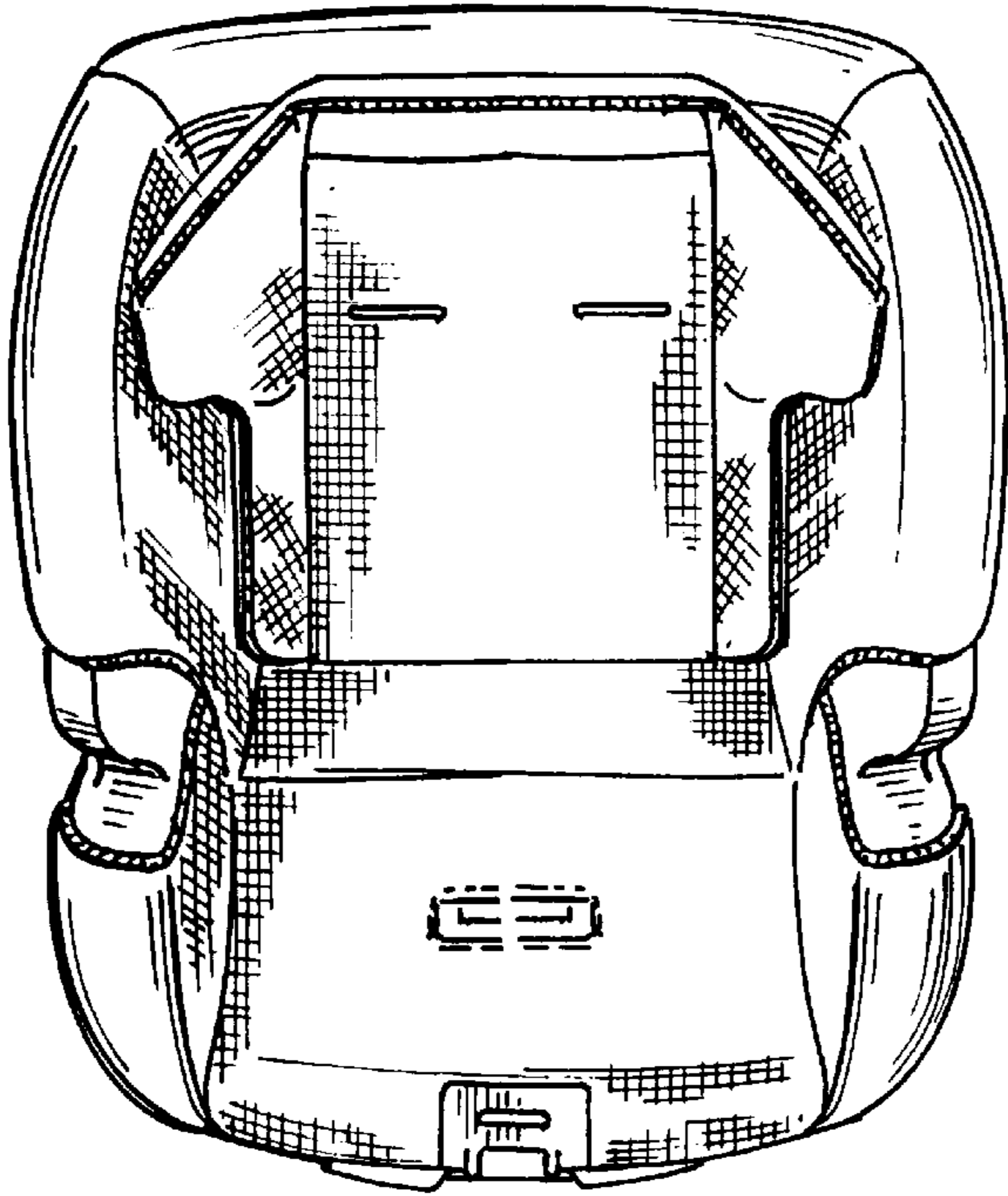

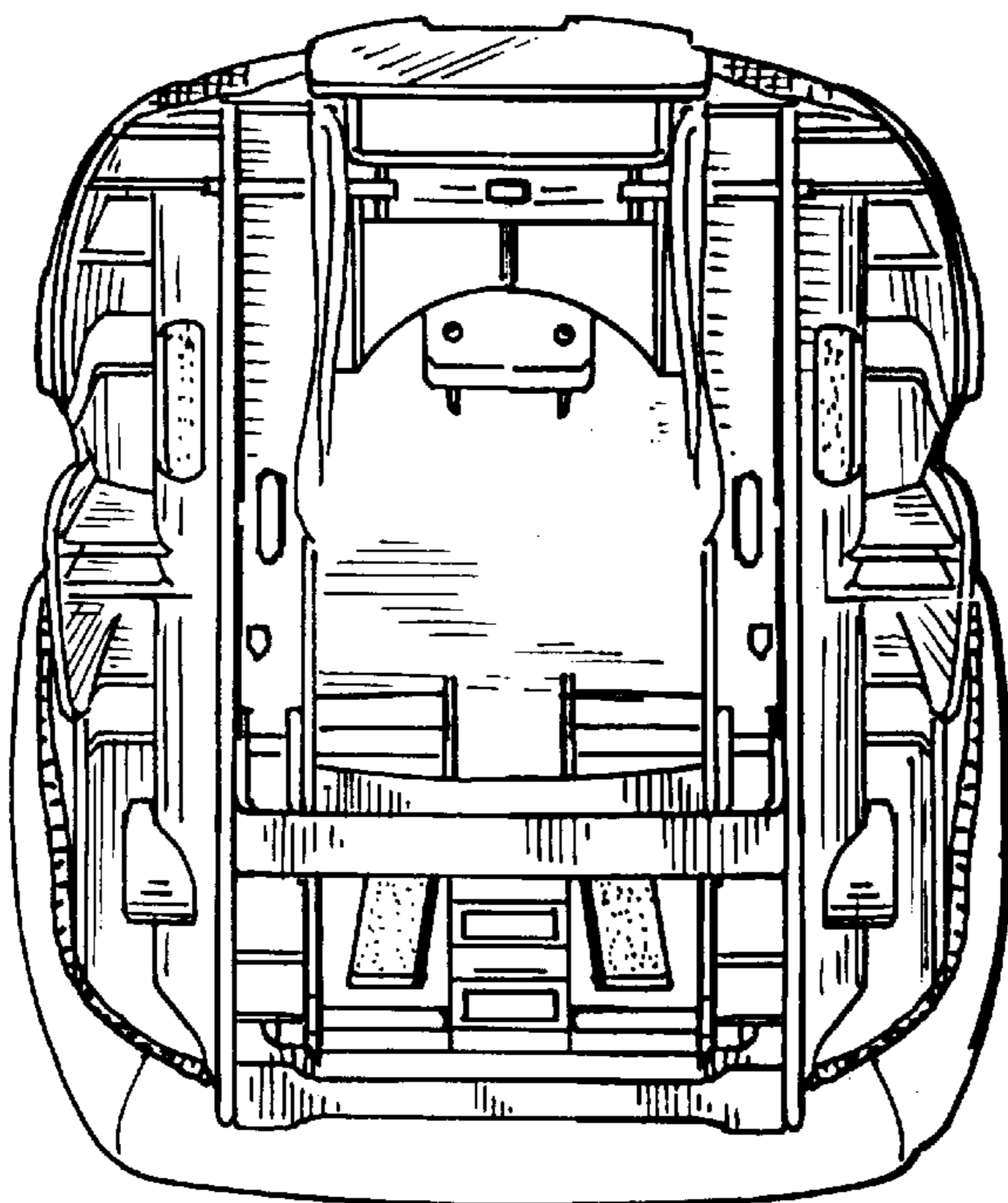
