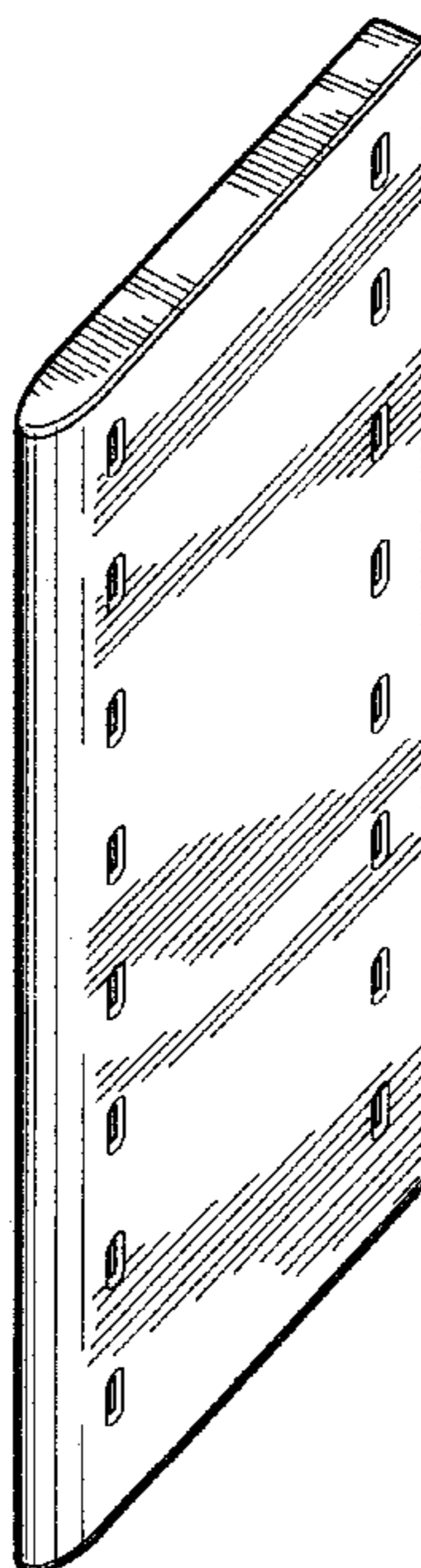
[57] **CLAIM**

The ornamental design for an end panel for a storage unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an end panel for a storage unit, showing our new design.
FIG. 2 is a front elevational view;
FIG. 3 is a right side elevational view, the left side being a mirror image thereof; and,
FIG. 4 is a top plan view thereof.

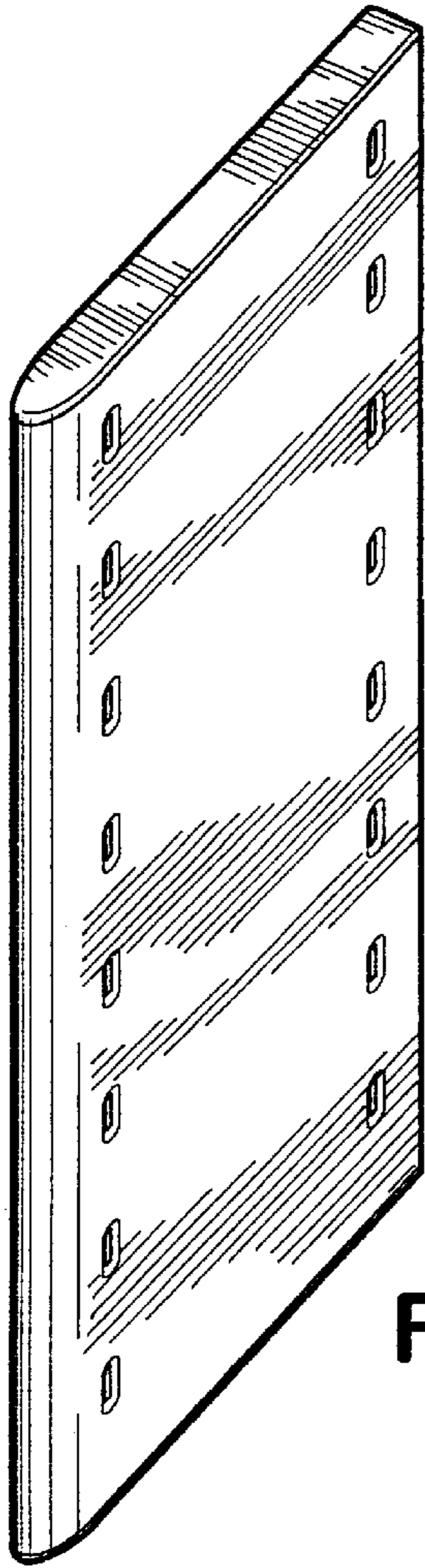

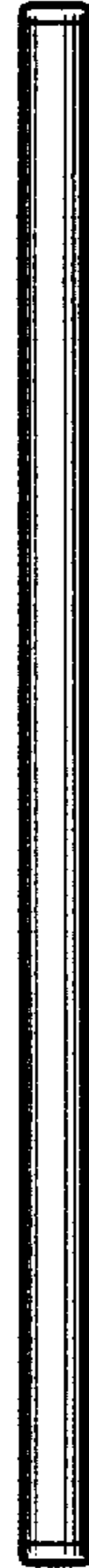

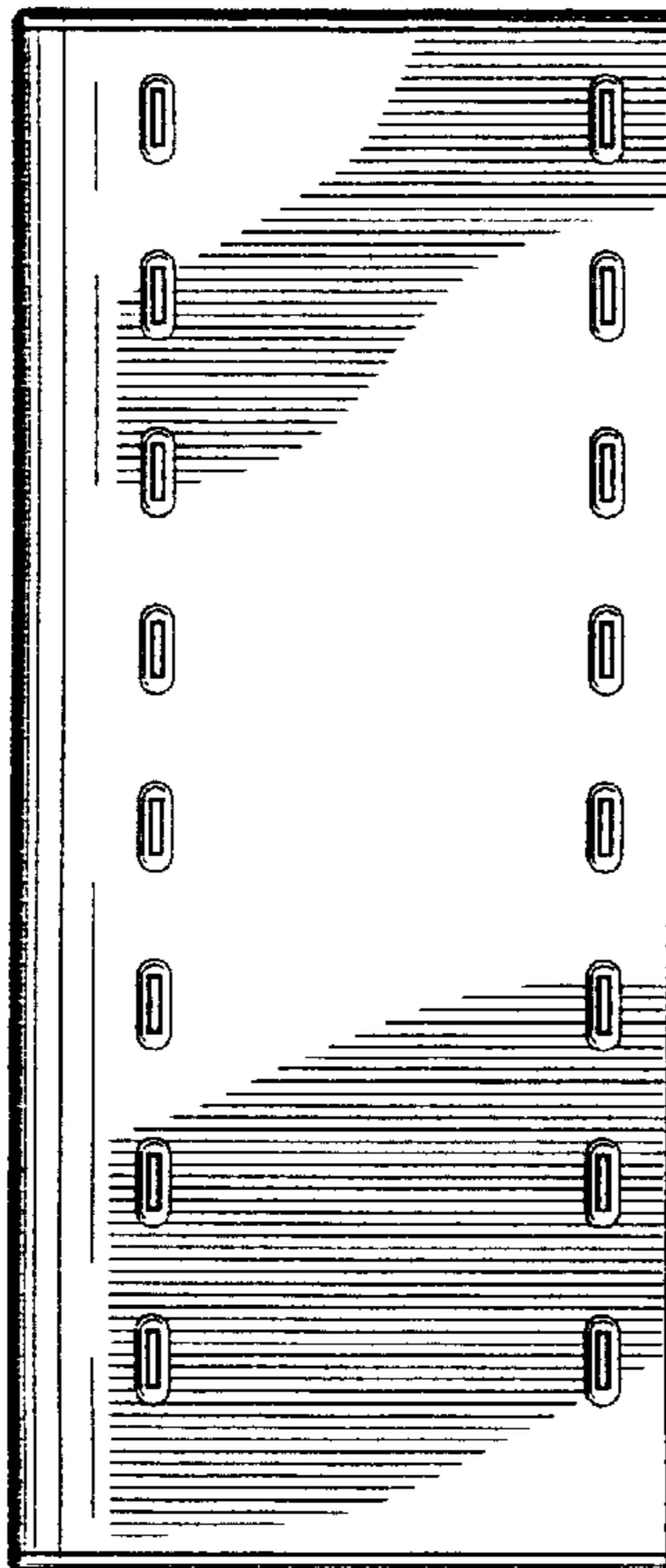
