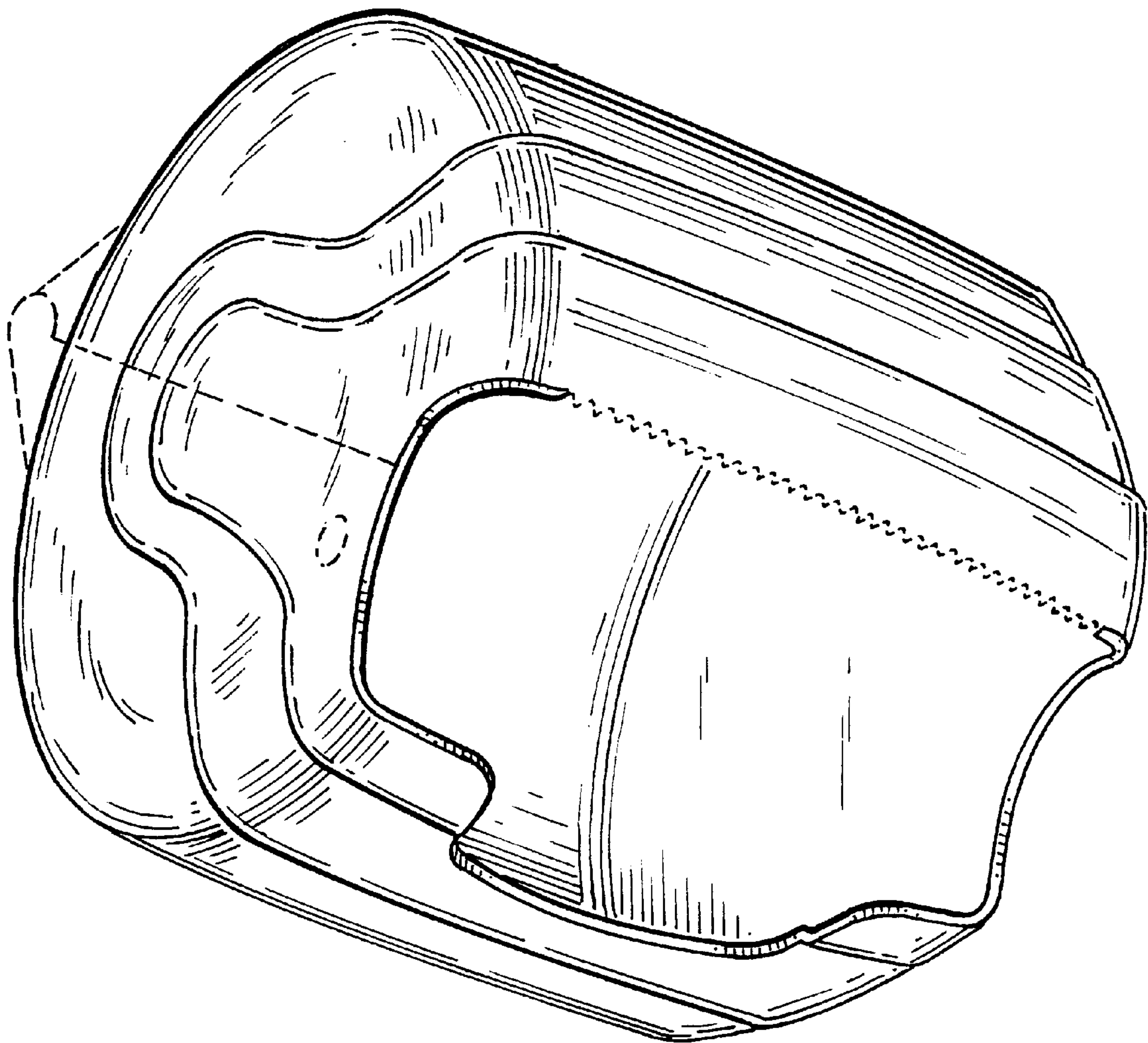

We claim the ornamental design for paper towel dispenser, as shown and described.

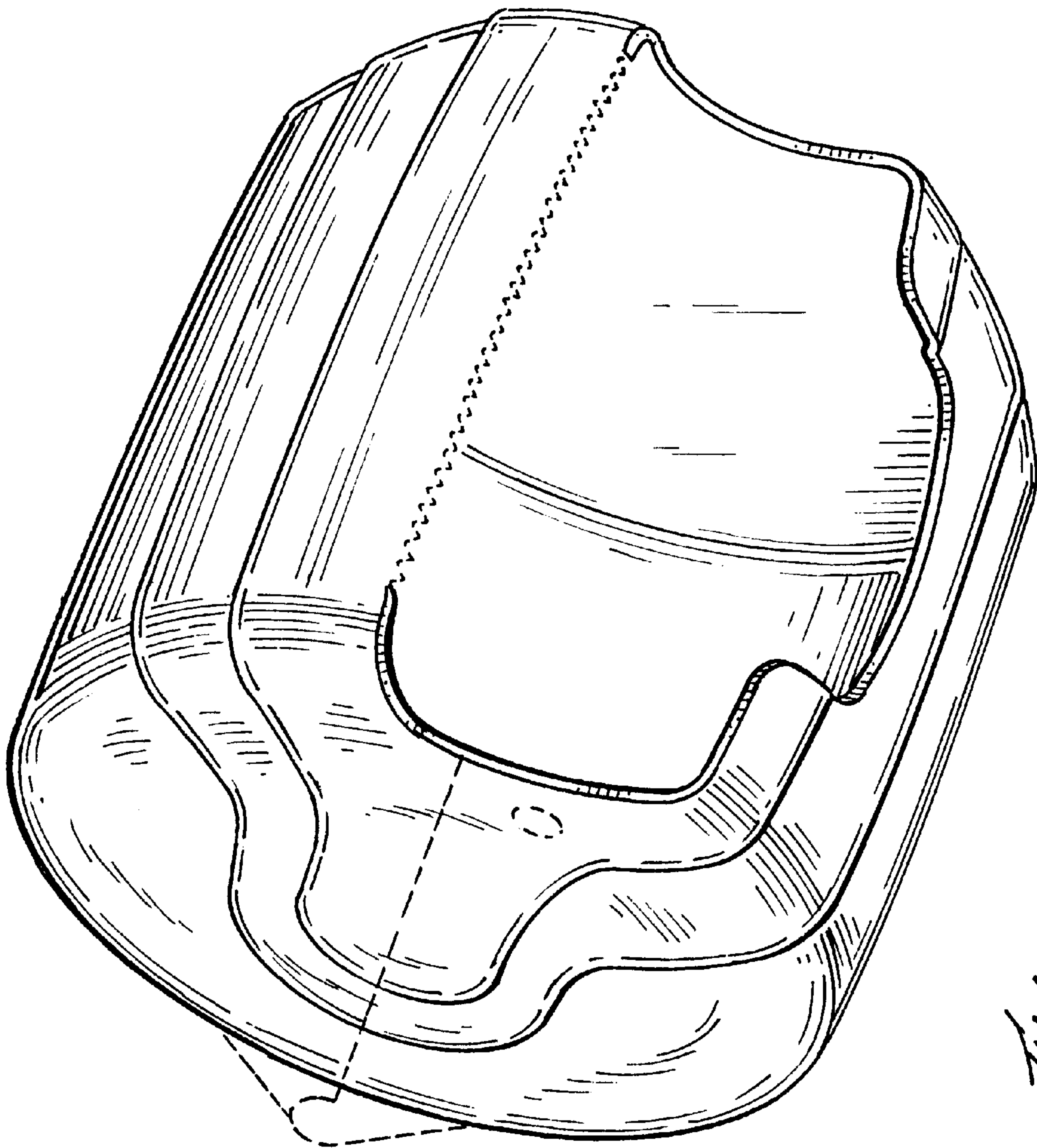
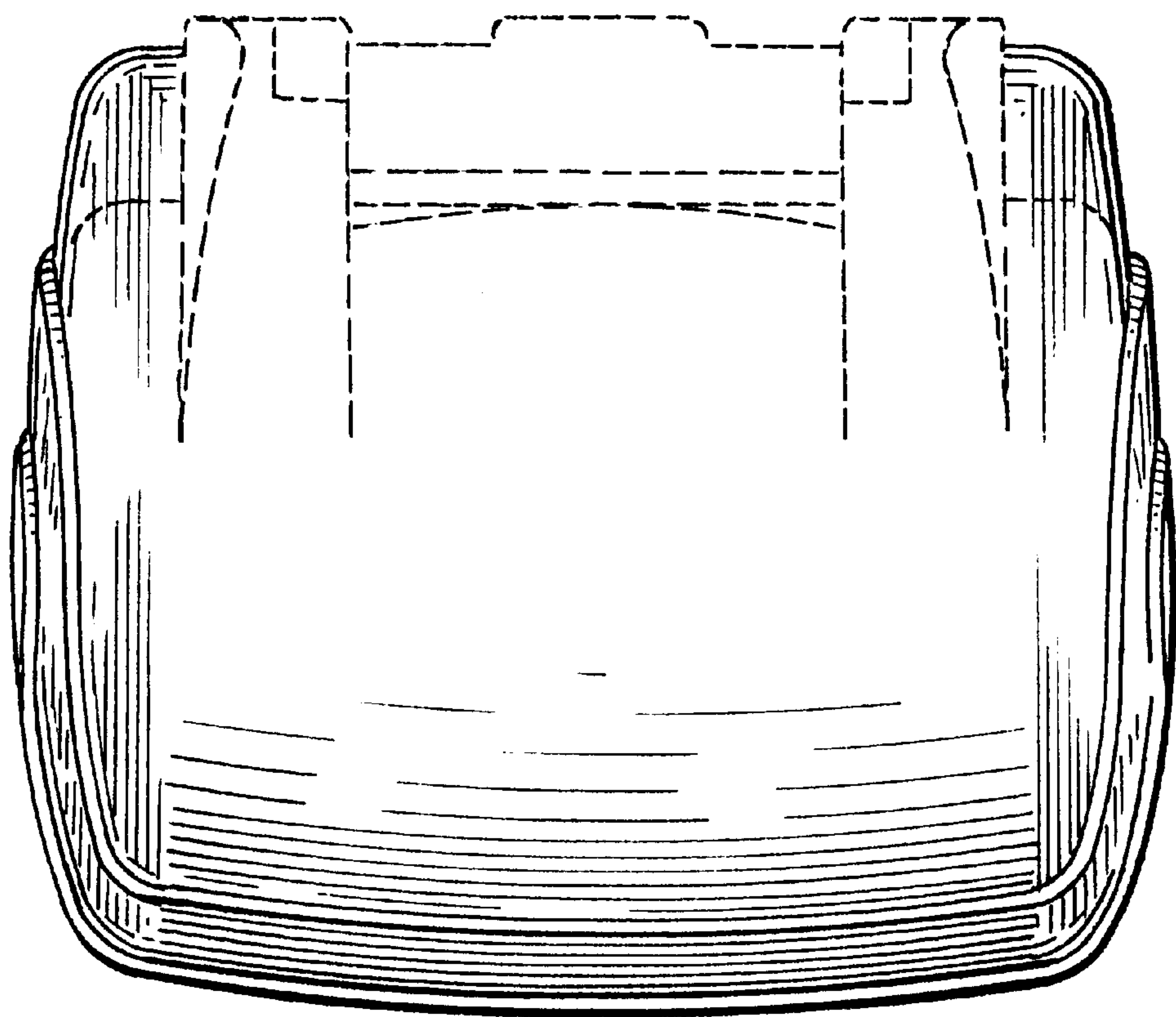

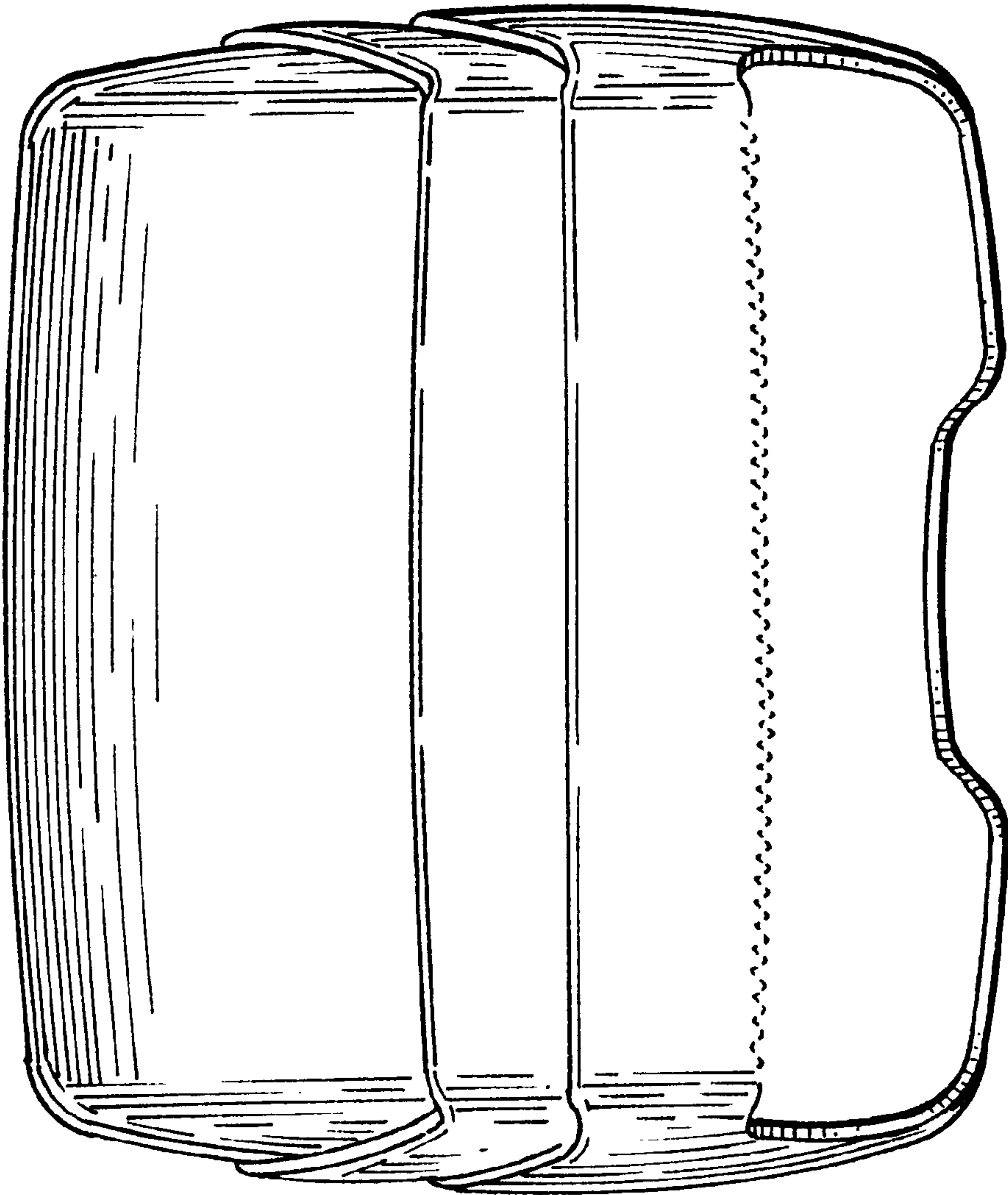

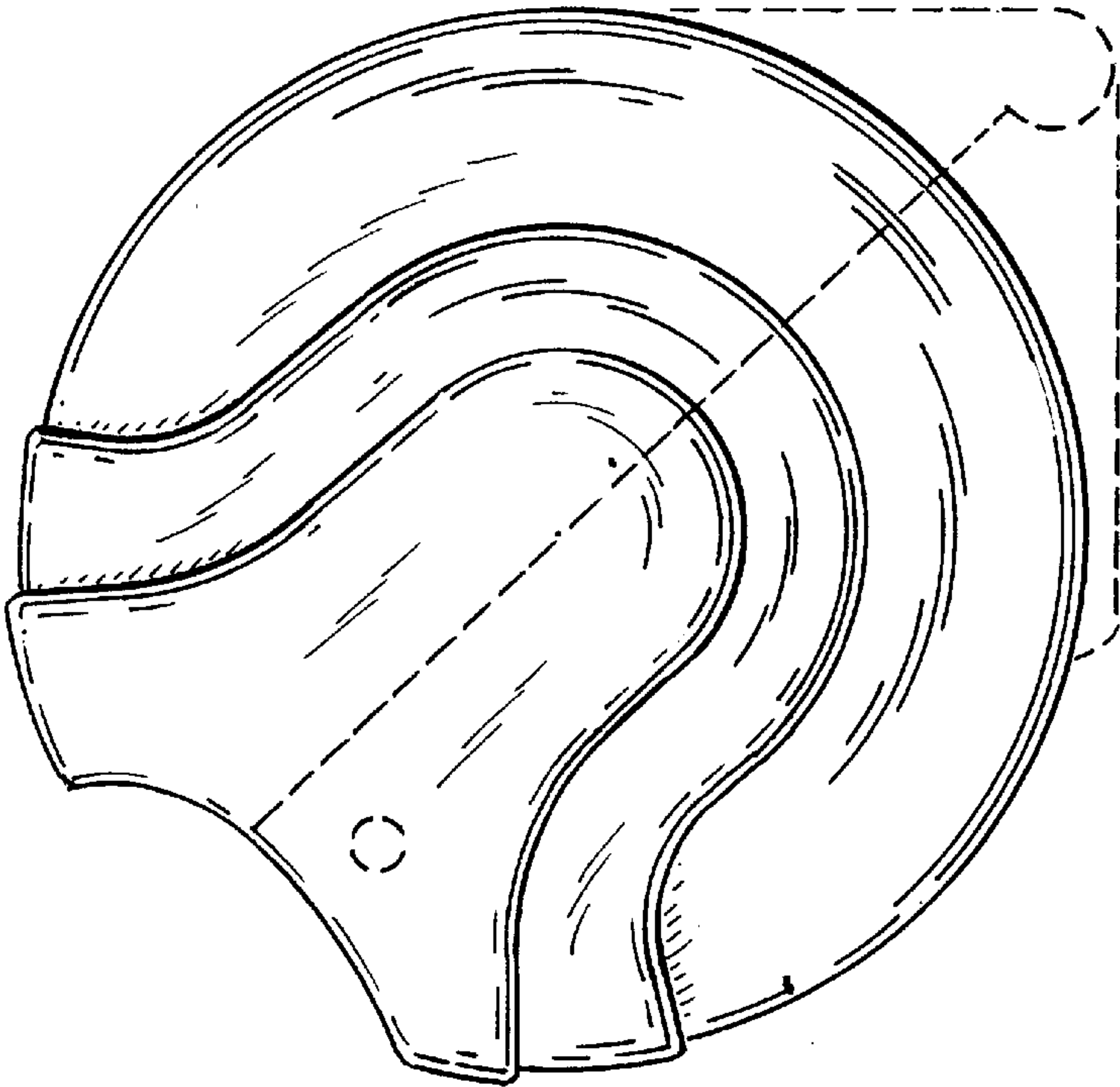
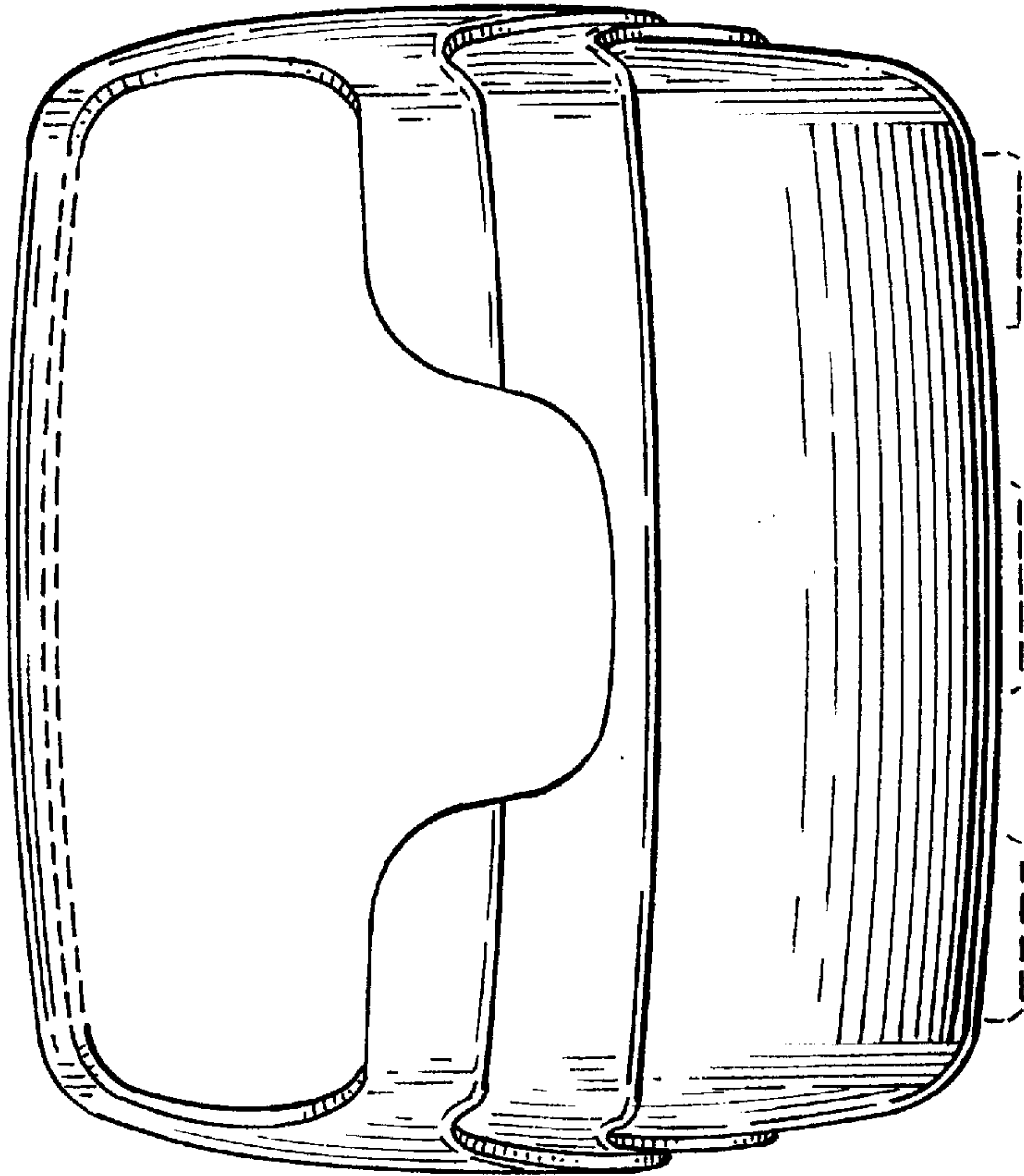
