[57] **CLAIM**

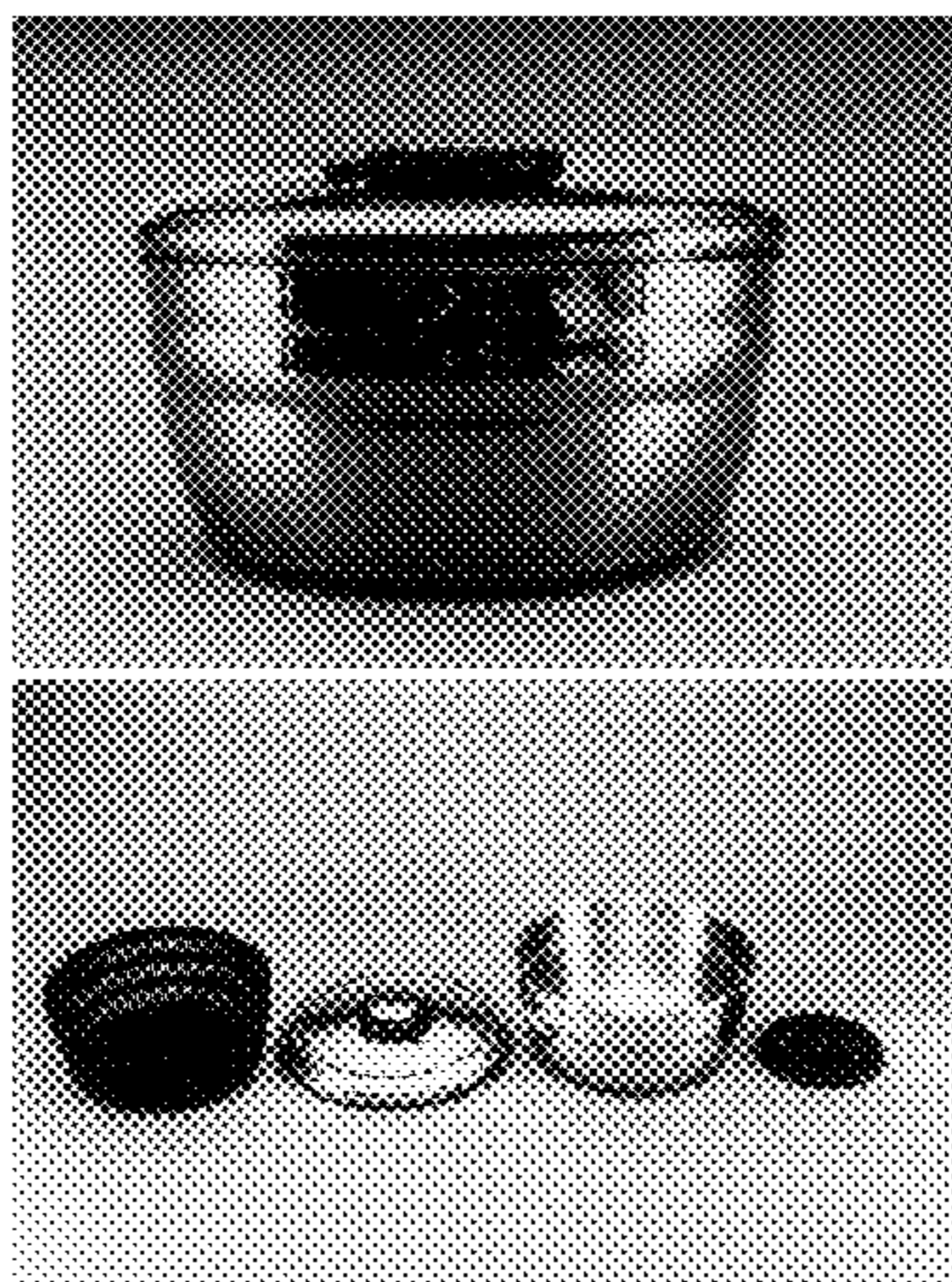
The ornamental design for spinner with accessories (including lid, basket, bowl and spinner support), as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a spinner illustrating my design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a first side elevational view thereof; FIG. 4 is a second side elevational view thereof opposite the first side; the front and rear views being substantially the same as the side views; FIG. 5 is a perspective view thereof; FIG. 6 is a top plan view of a bowl with basket illustrating my design;

FIG. 7 is a bottom plan view thereof; FIG. 8 is a first side elevational view thereof; FIG. 9 is a second side elevational view thereof opposite the first side; the front and rear views being substantially the same as the side views; FIG. 10 is a perspective view thereof; FIG. 11 is a top plan view the bowl with spinner support; FIG. 12 is a bottom plan view thereof; FIG. 13 is a first side elevational view thereof; FIG. 14 is a second side elevational view thereof opposite the first side; the front and rear views being substantially the same as the side views; FIG. 15 is a perspective view thereof; FIG. 16 is a top plan view of a bowl; FIG. 17 is a bottom plan view thereof; FIG. 18 is a first side elevational view thereof; FIG. 19 is a second side elevational view thereof opposite the first side; the front and rear views being substantially the same as the side views; FIG. 20 is a perspective view thereof; FIG. 21 is a top plan view of the basket; FIG. 22 is a bottom plan view thereof; FIG. 23 is a first side elevational view thereof; FIG. 24 is a second side elevational view thereof opposite the first side; the front and rear views being substantially the same as the side views; FIG. 25 is a perspective view thereof; FIG. 26 is a top plan view of the lid; FIG. 27 is a bottom plan view thereof; FIG. 28 is a first side elevational view thereof; FIG. 29 is a second side elevational views thereof opposite the first side; the front and rear view being sustantially the same as the side views; FIG. 30 is a perspective view thereof; FIG. 31 is a top plan view of the spinner support; FIG. 32 is a bottom plan view thereof; FIG. 33 is a first side elevational view thereof; FIG. 34 is a second side elevational view thereof opposite the first side; the front and rear views being substantially the same as the side views; FIG. 35 is a perspective view thereof; and, FIG. 36 is an exploded perspective view for the basket, the lid, the bowl and the spinner. The lid, basket, bowl and spinner are shown separately for clarity of illustration.

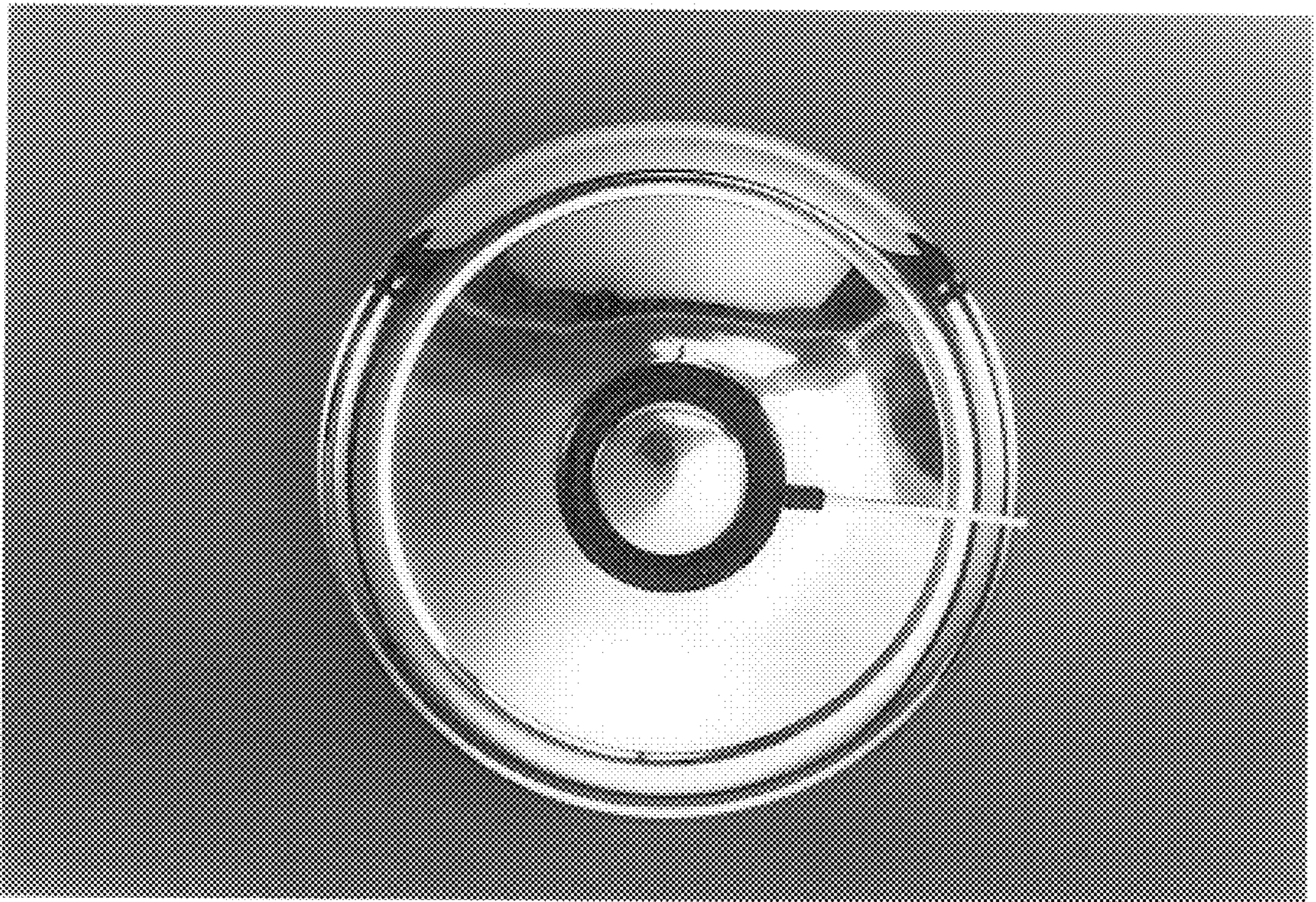

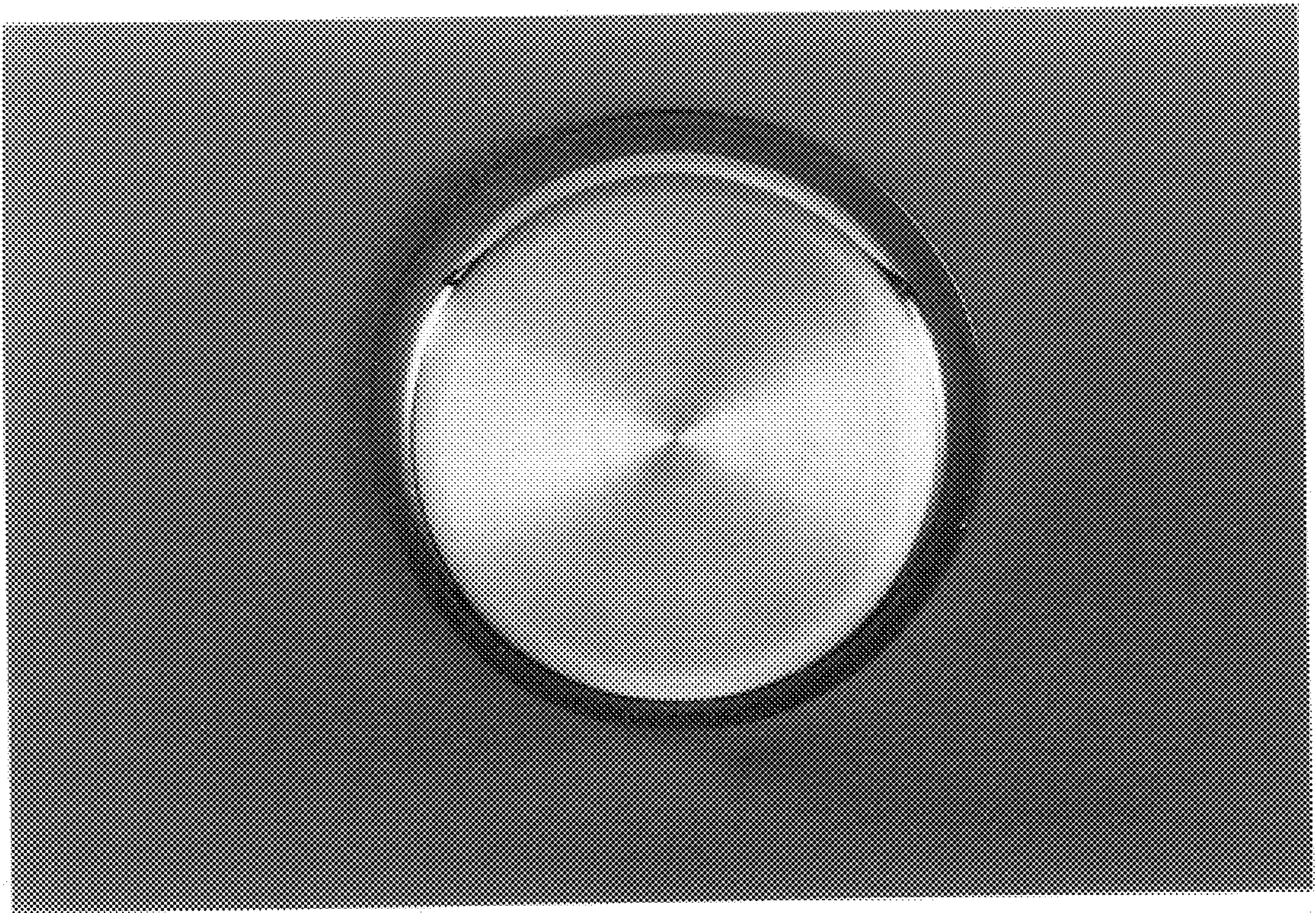

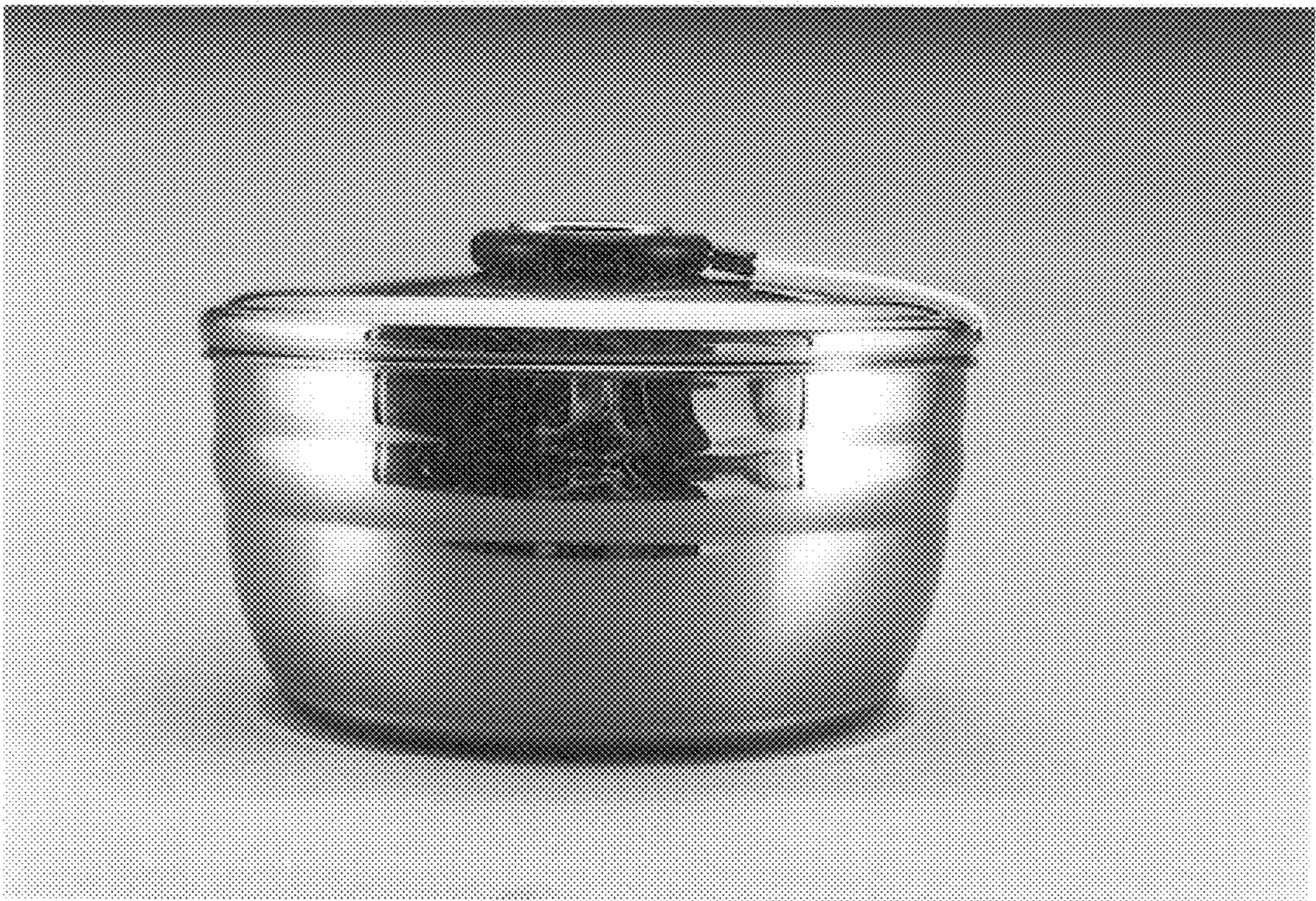

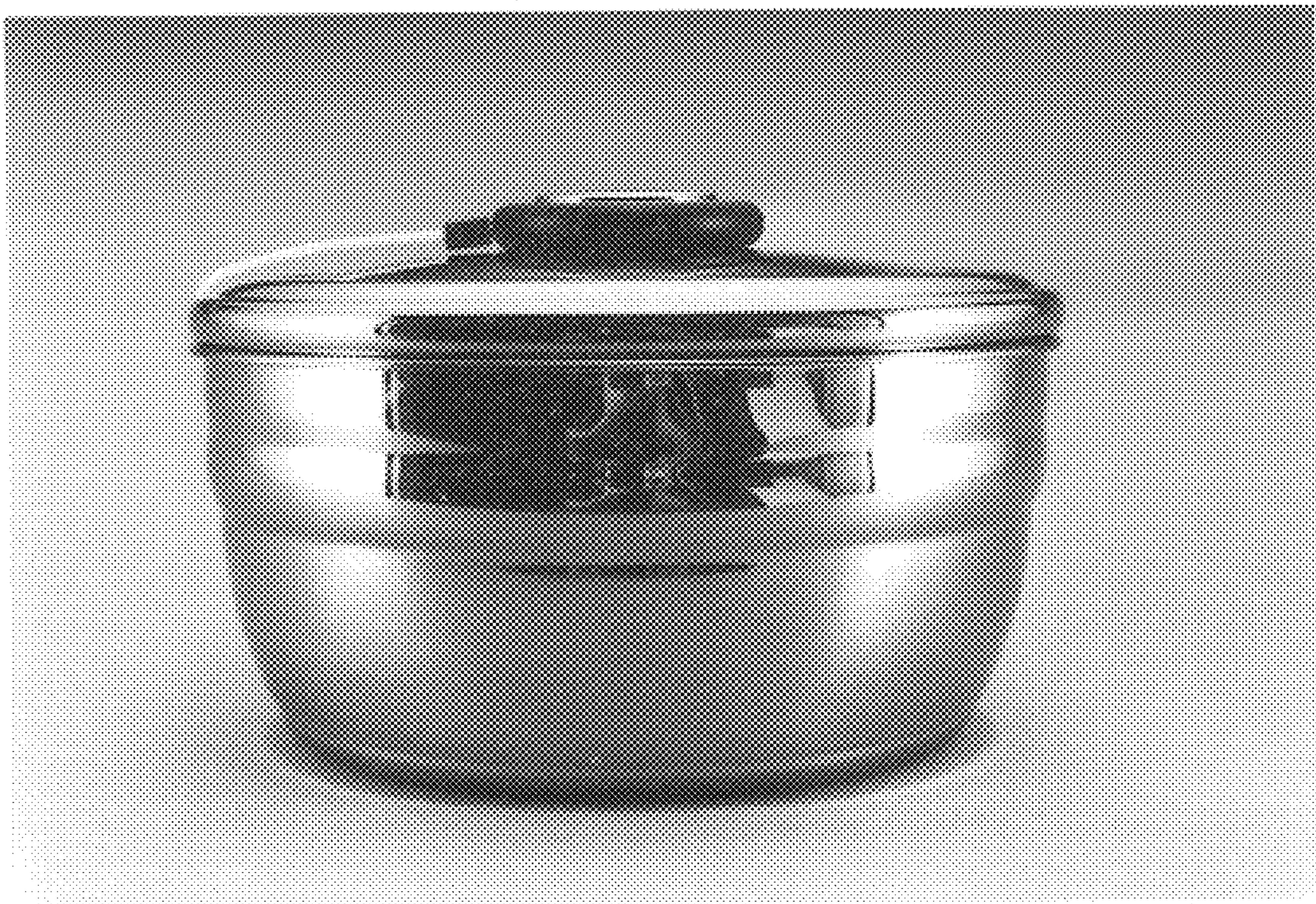

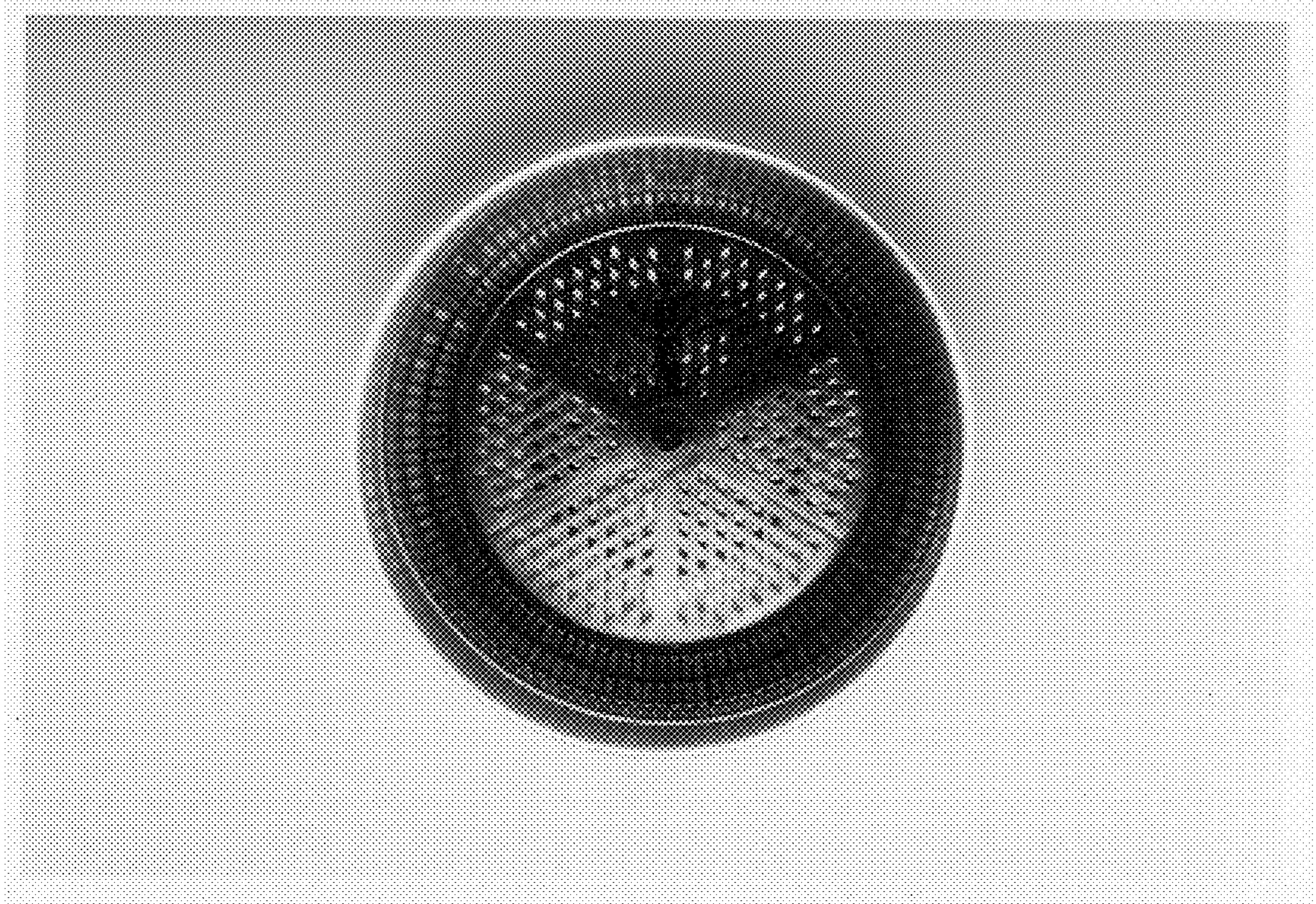

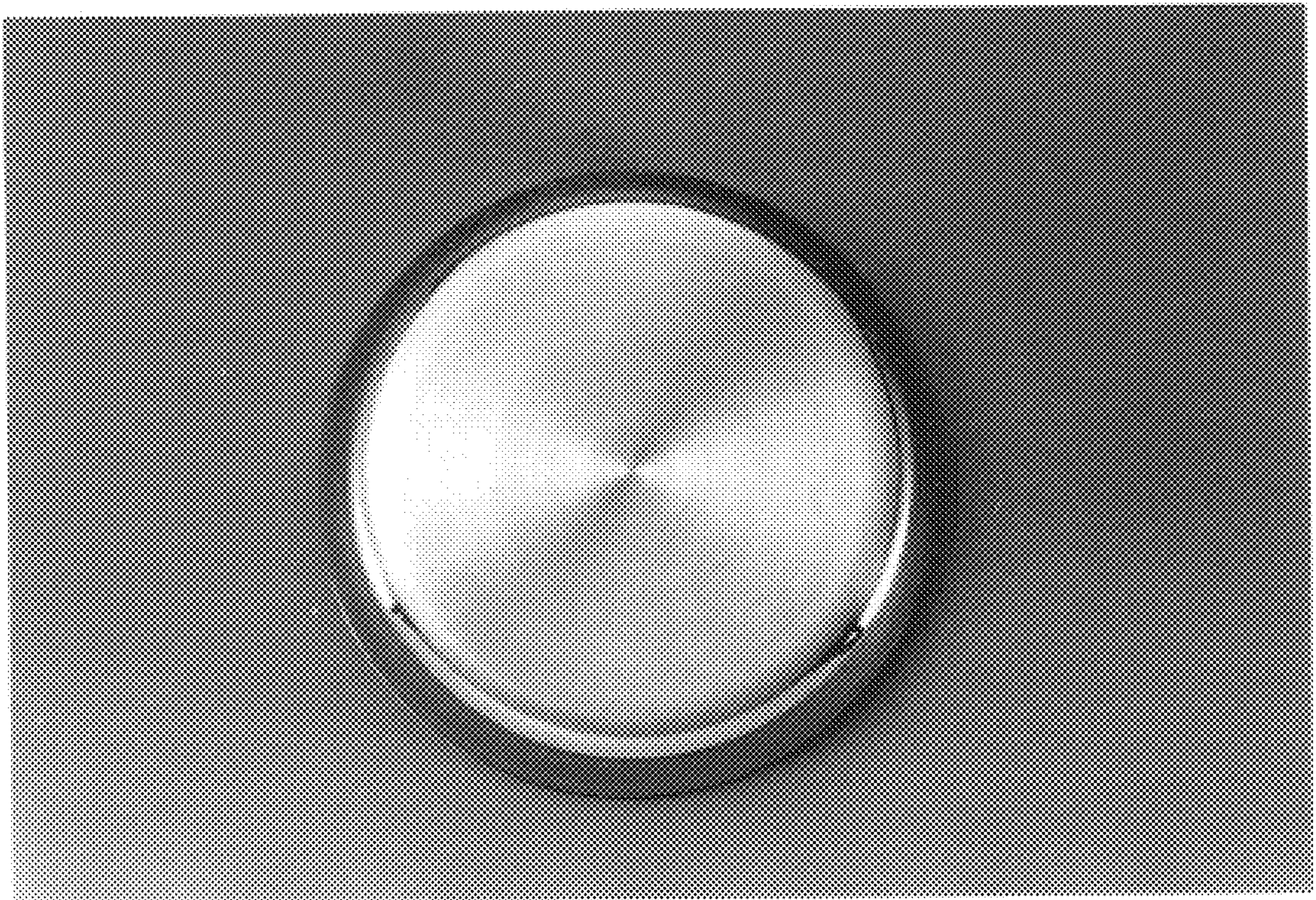

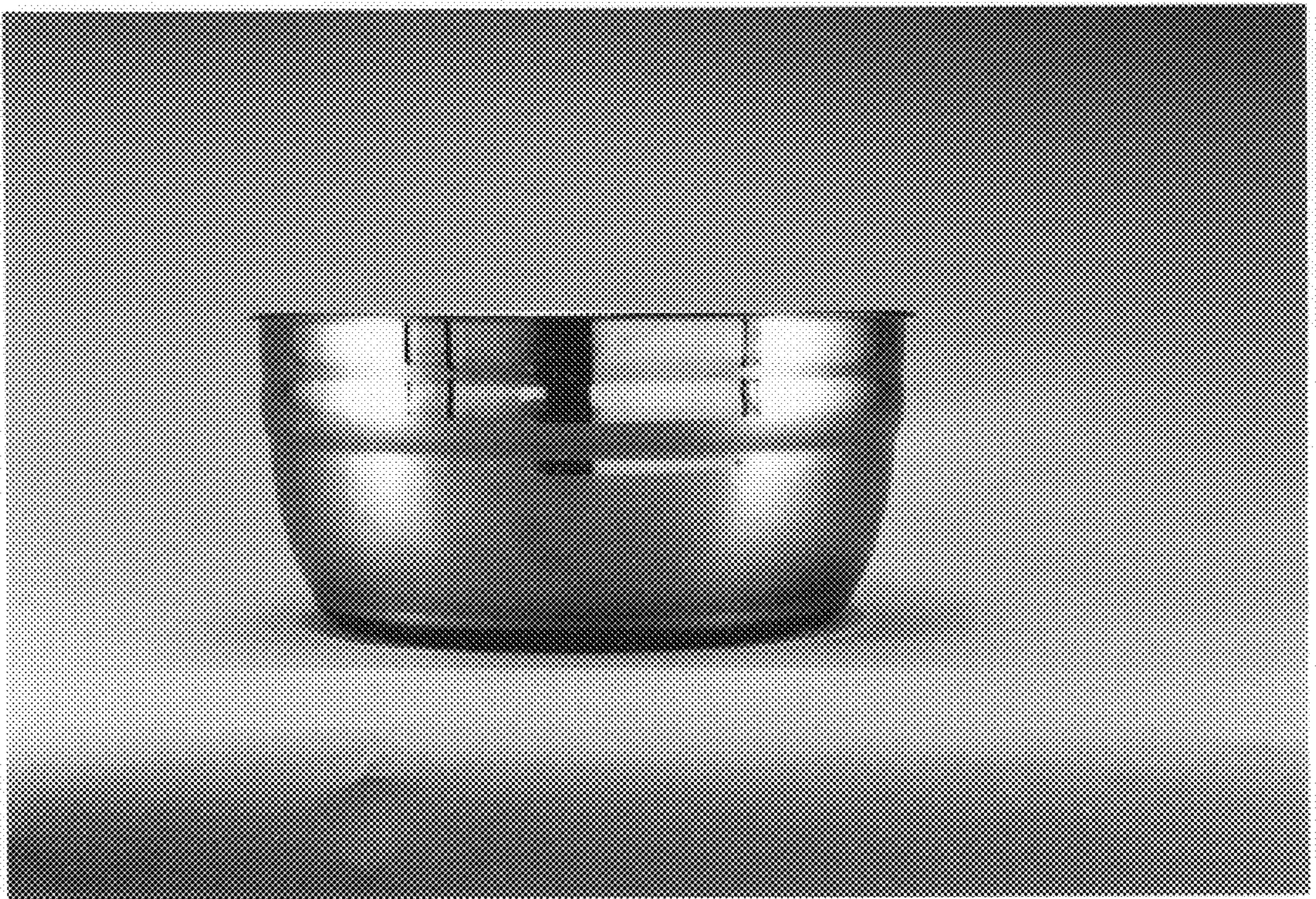

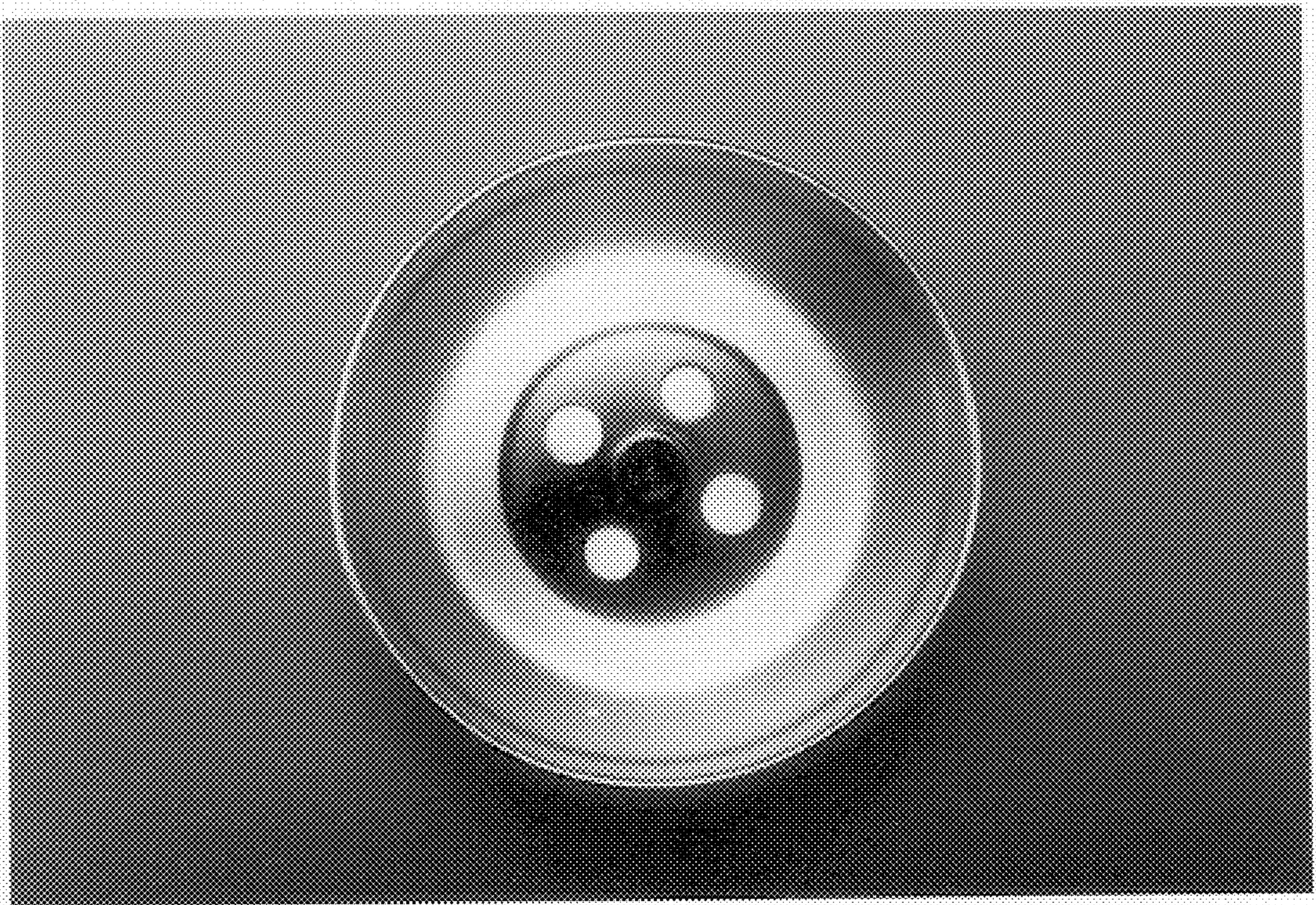

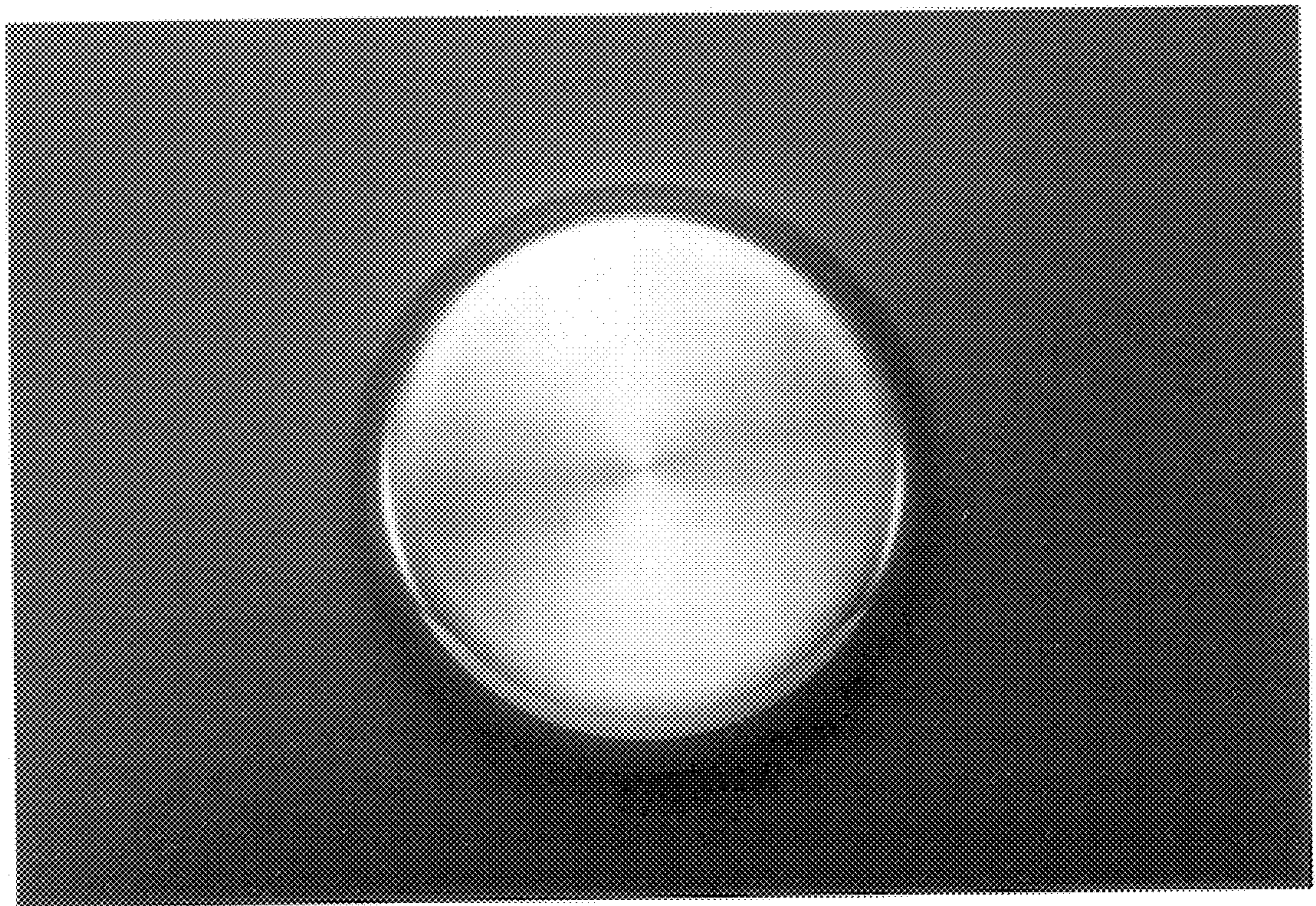

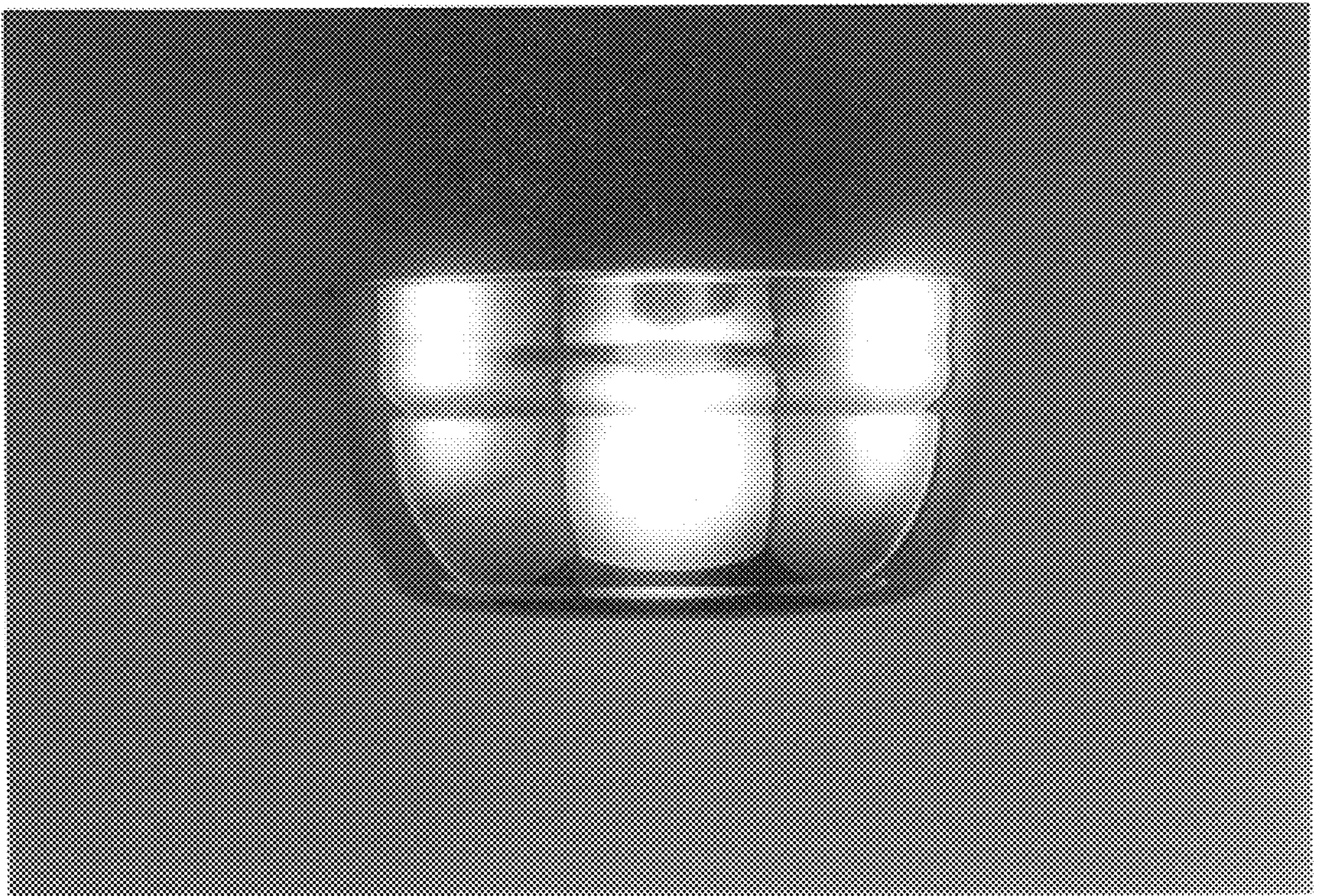

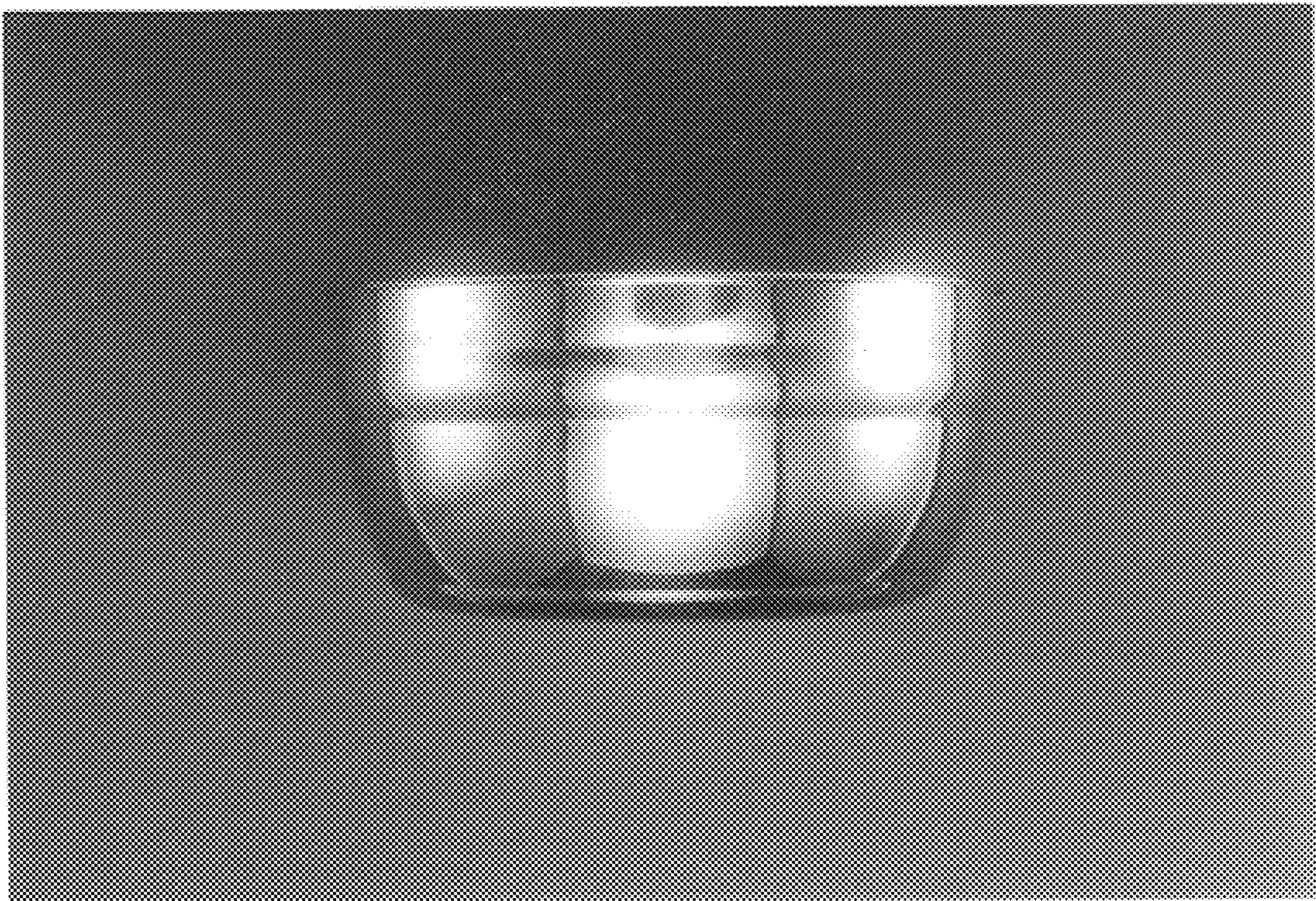

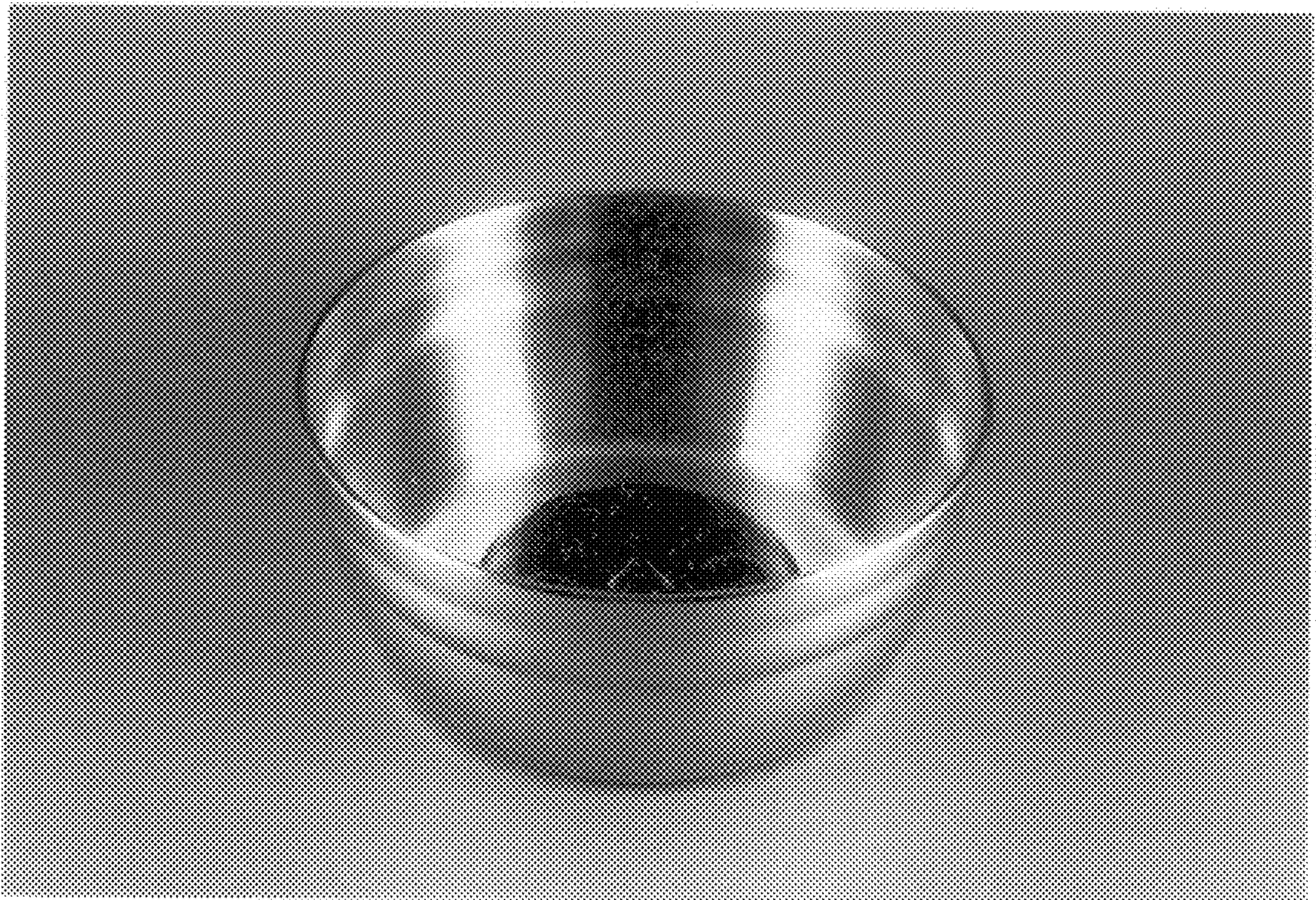

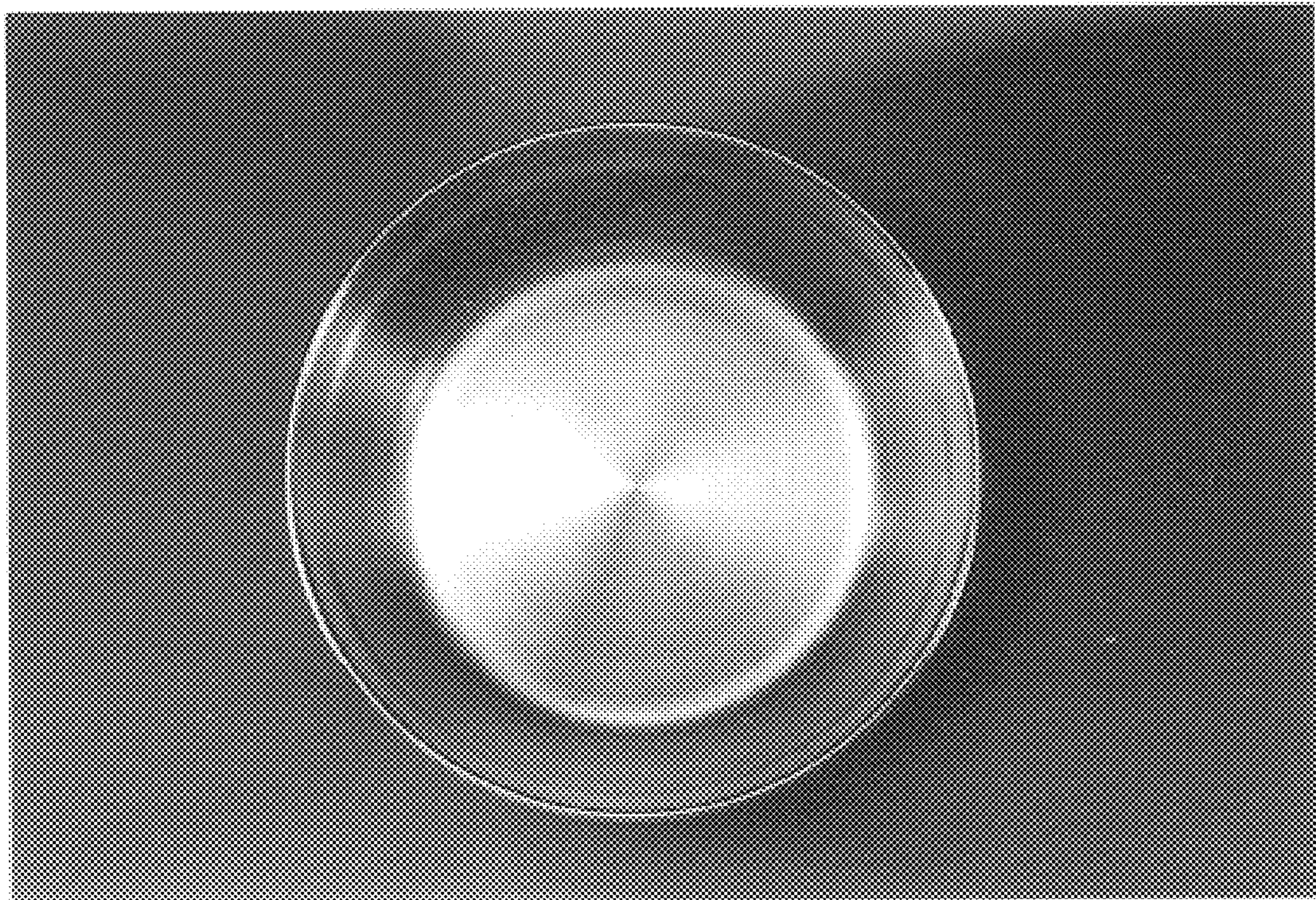

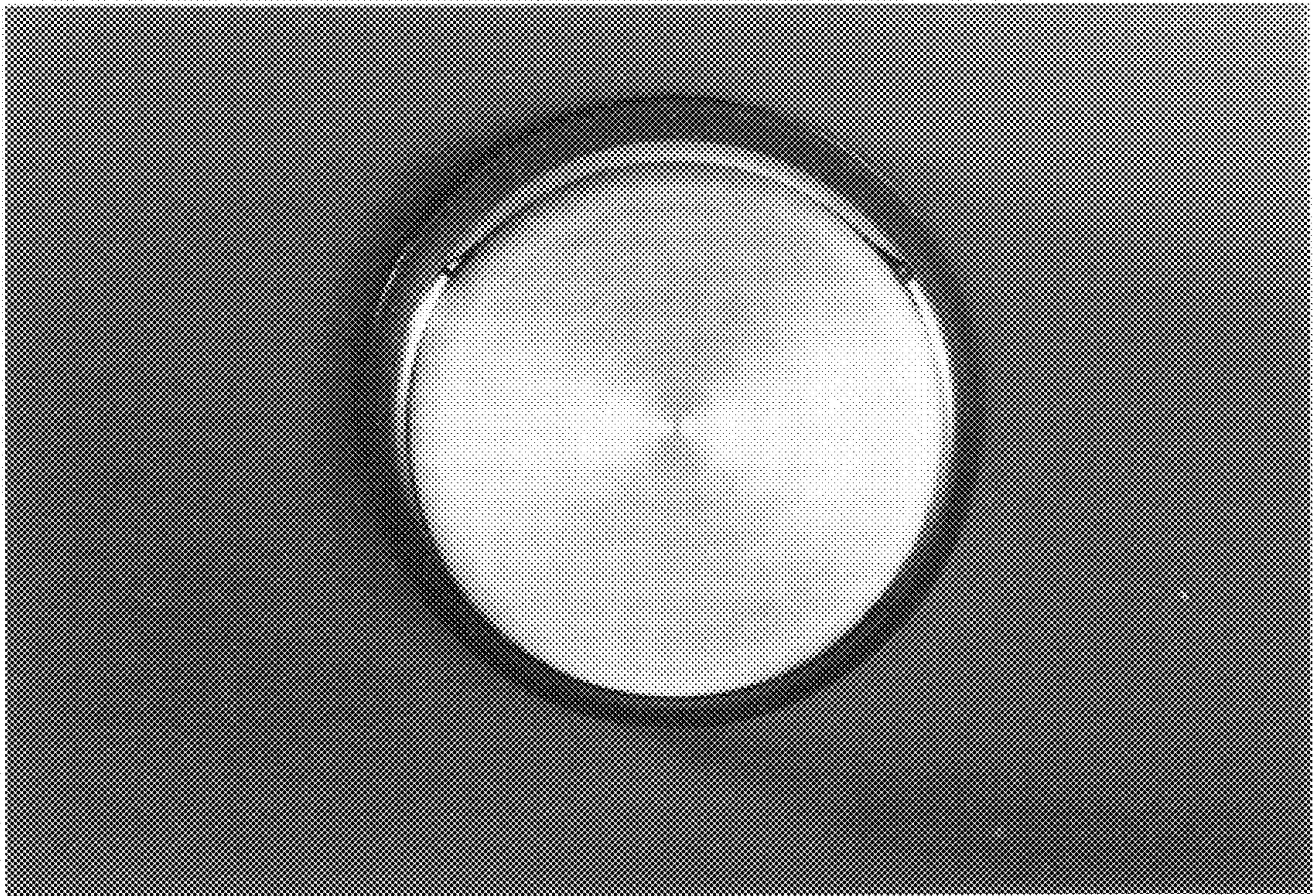

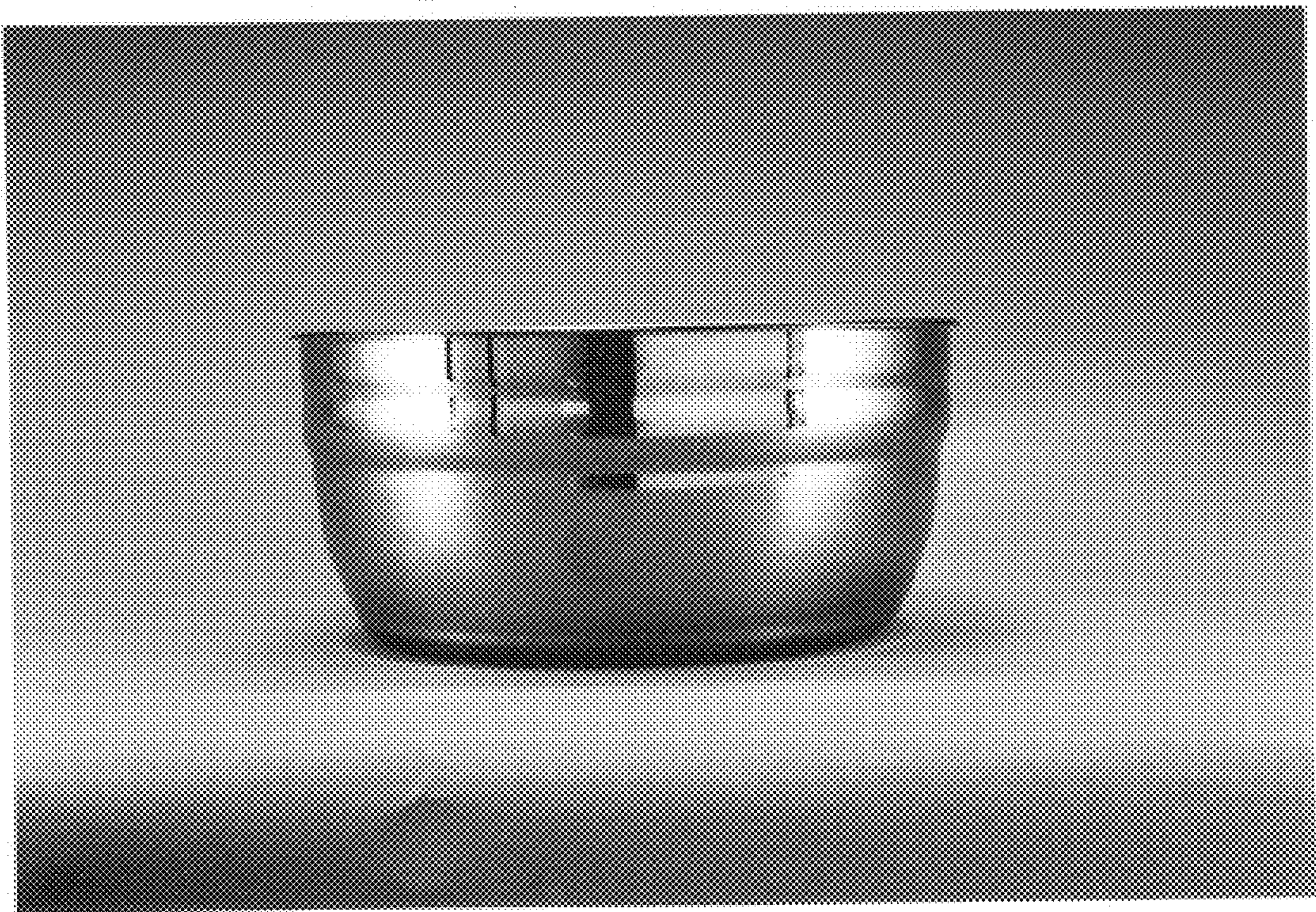

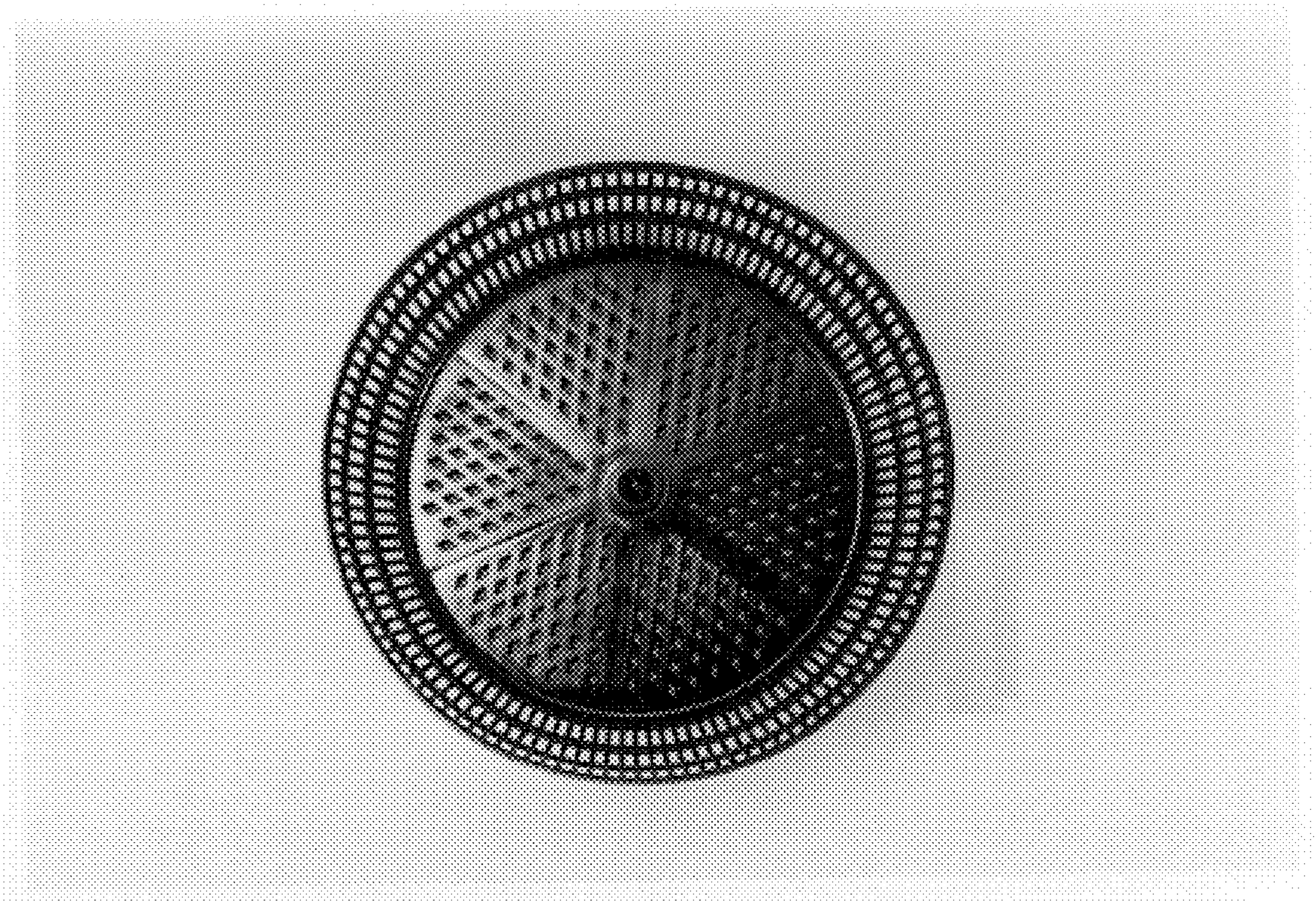

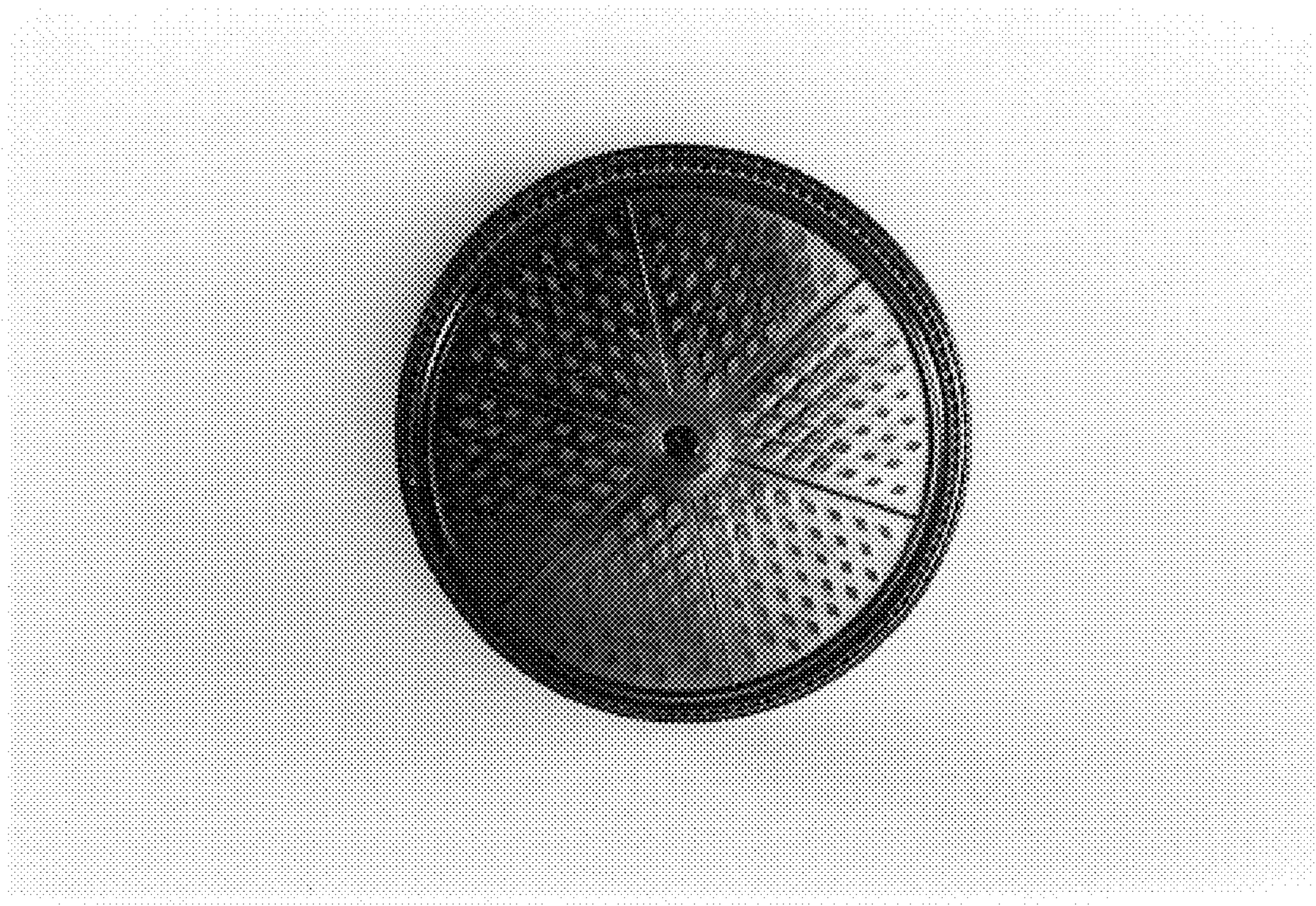

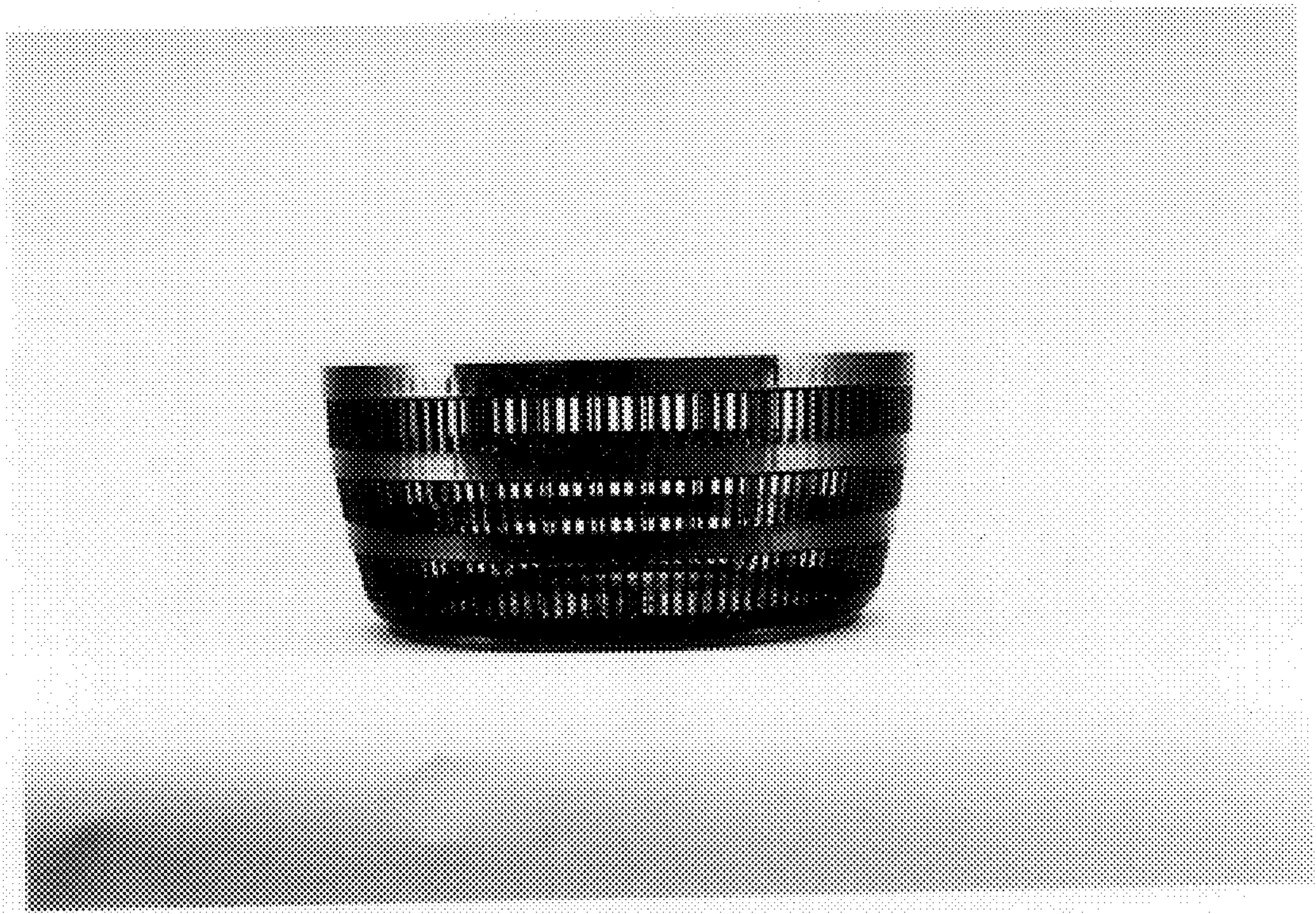

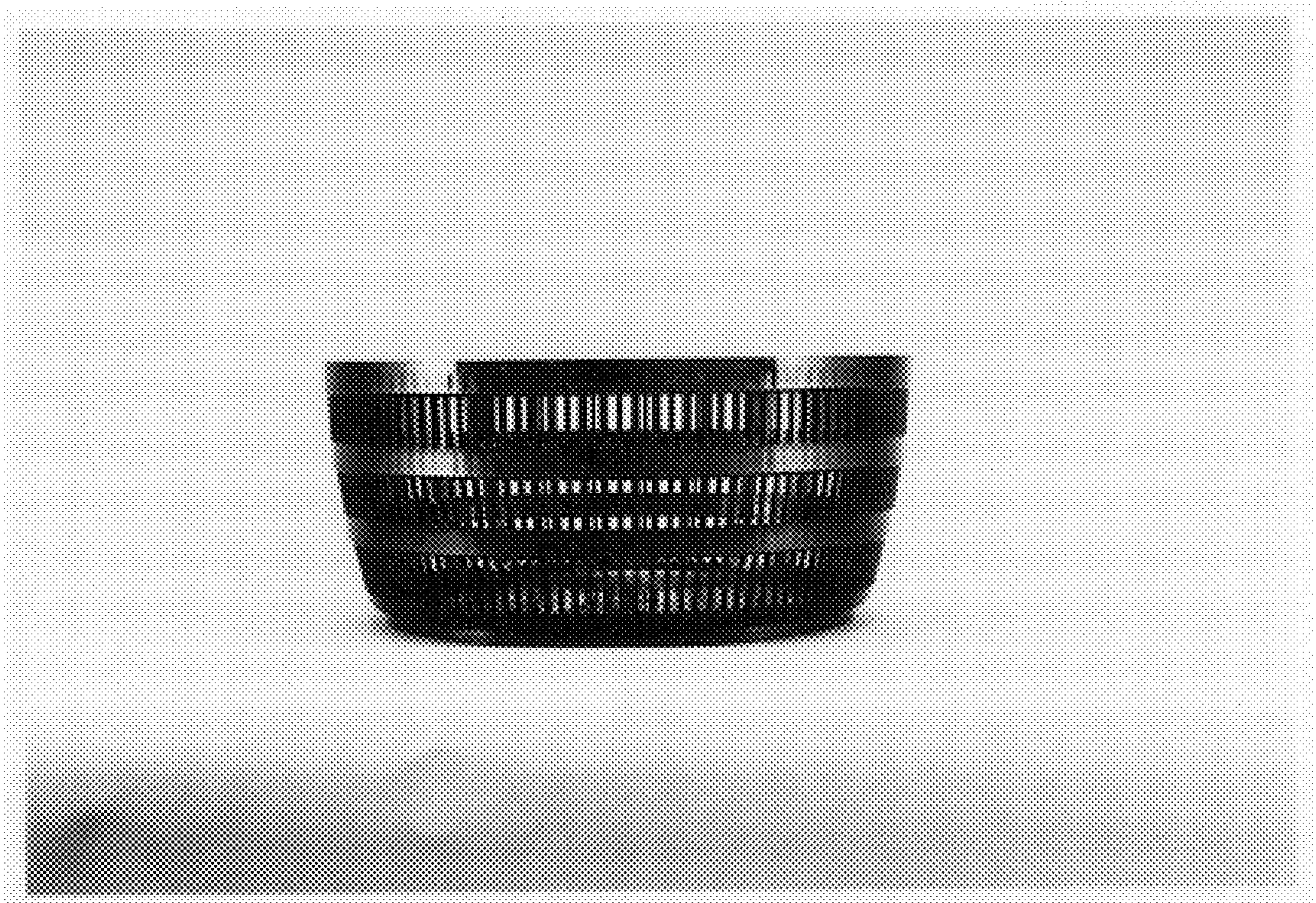

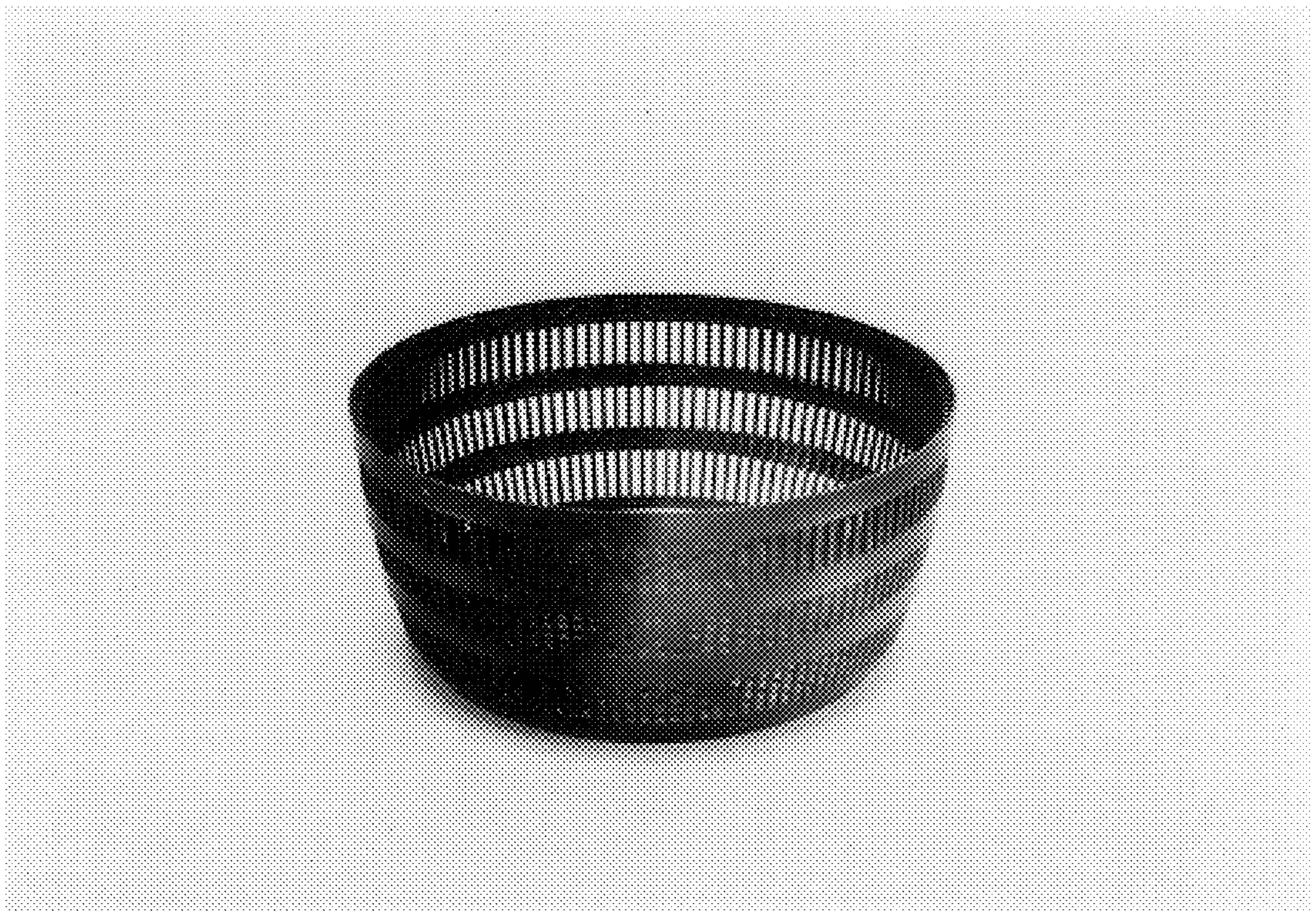

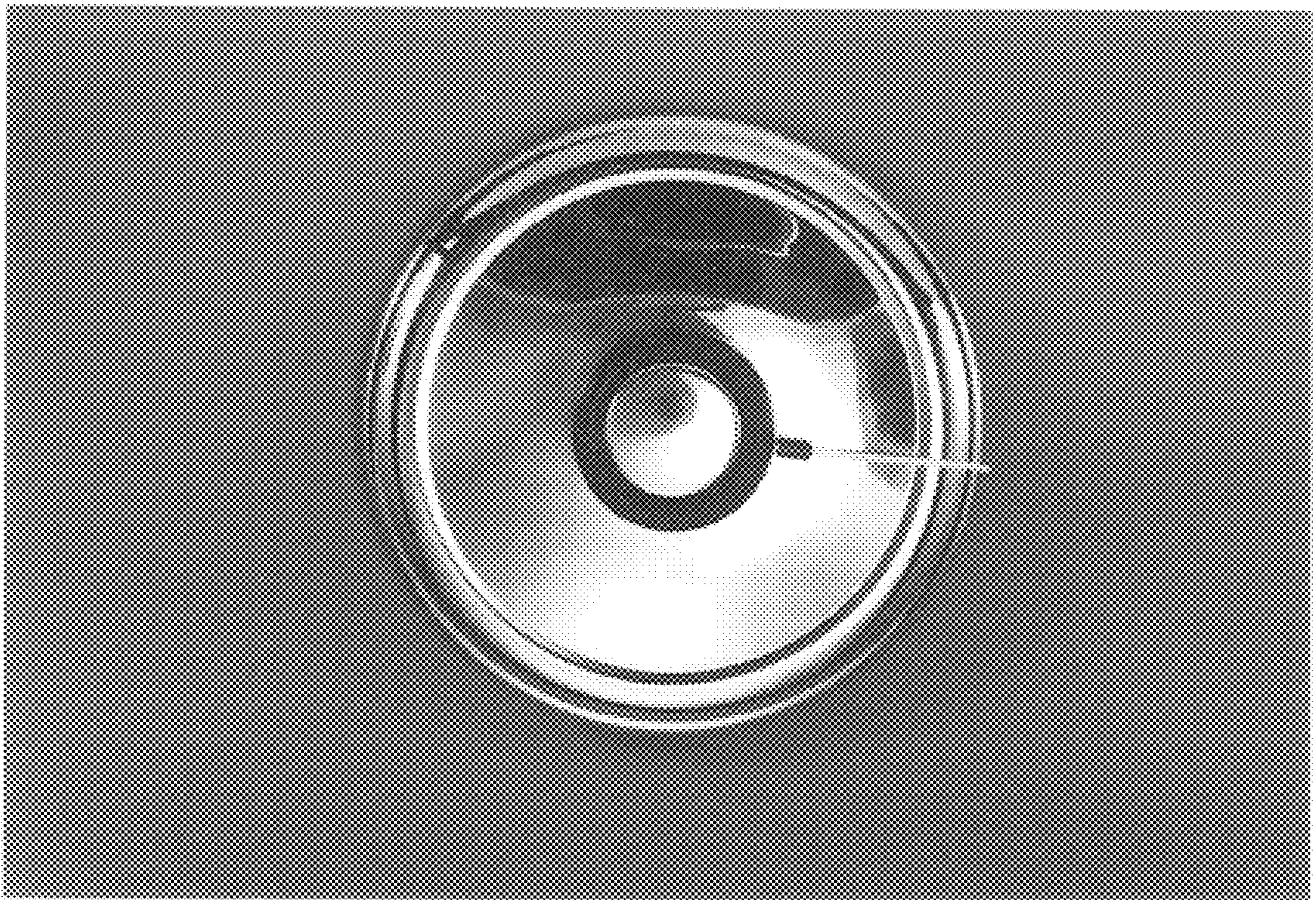

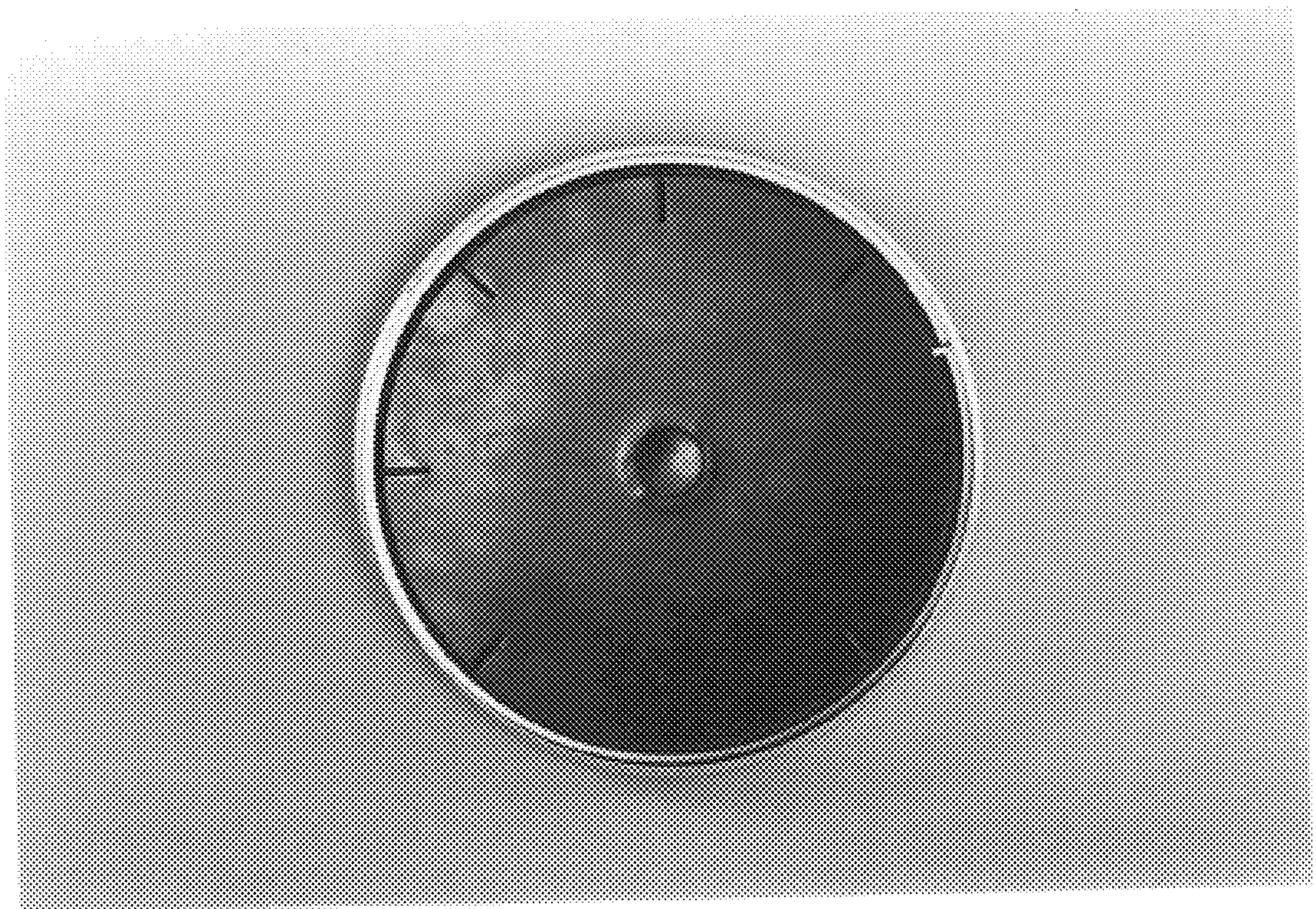

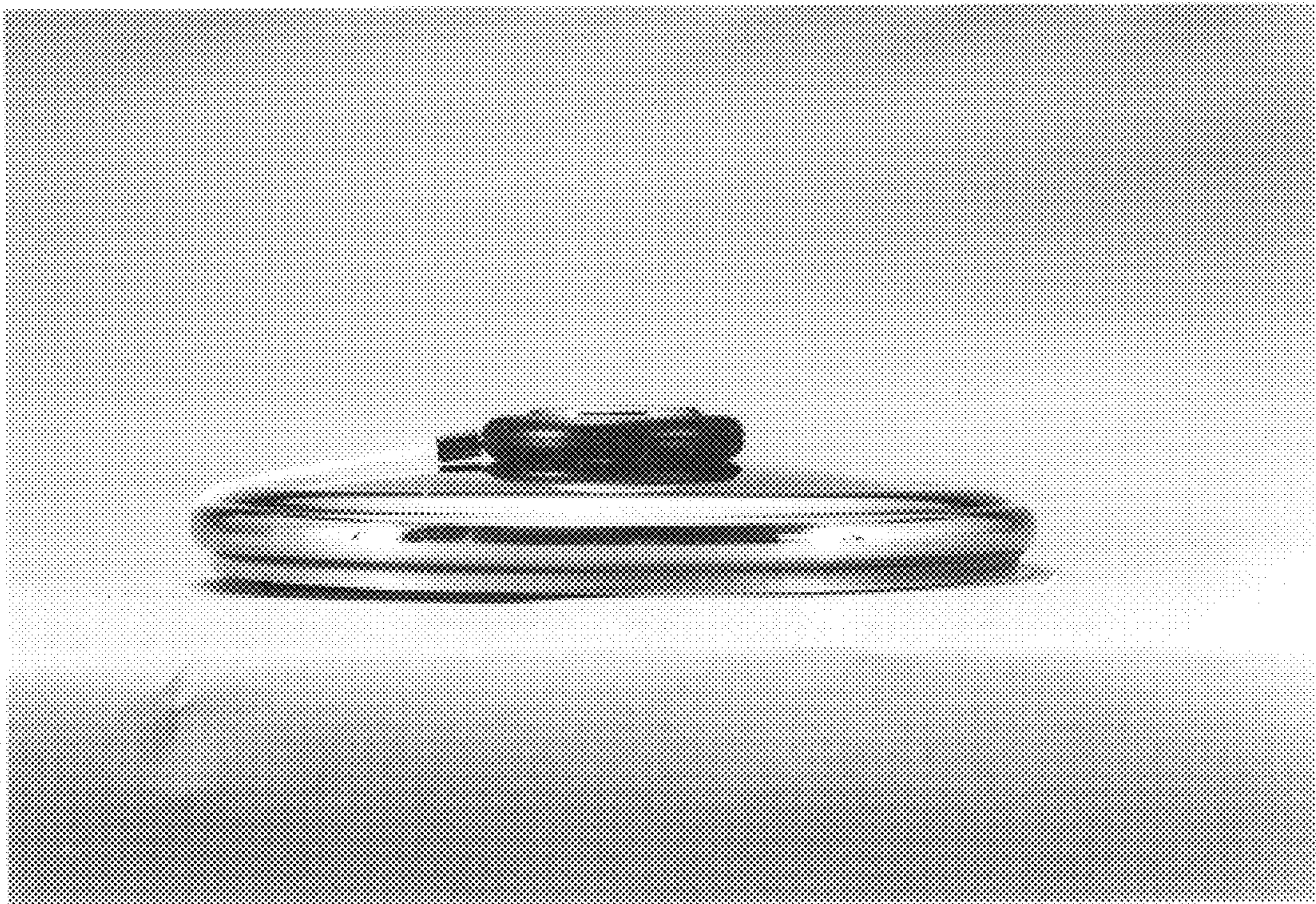

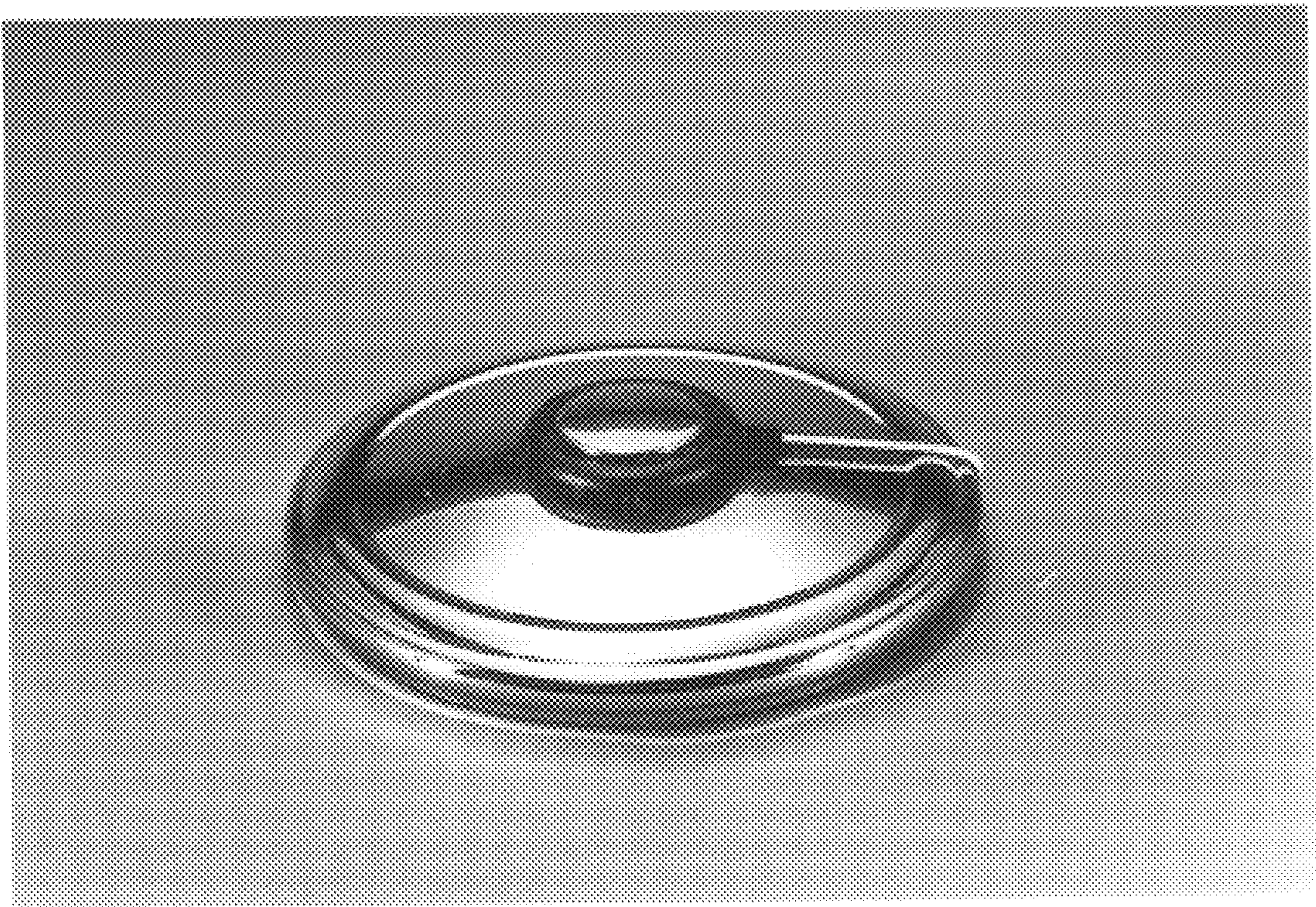

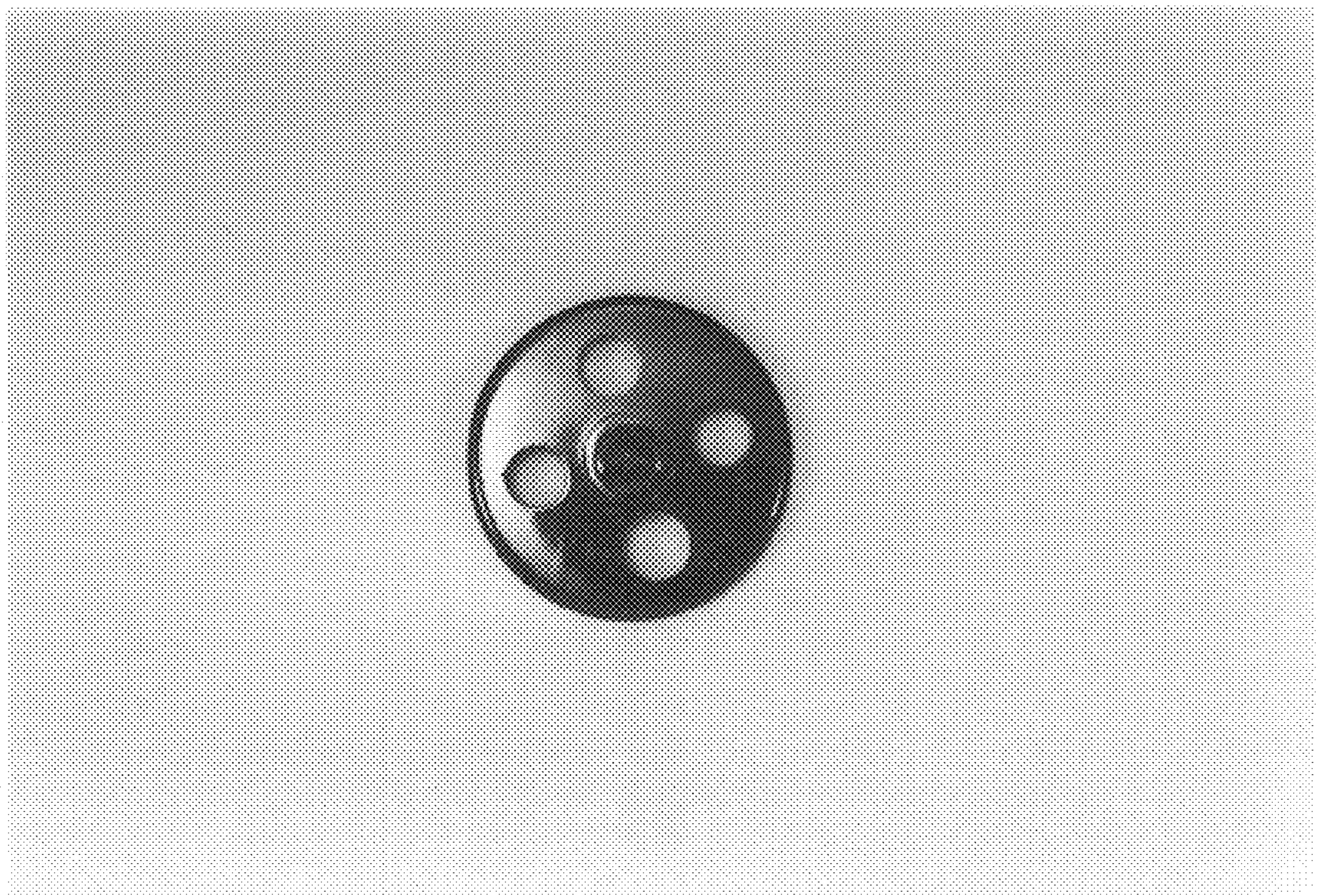

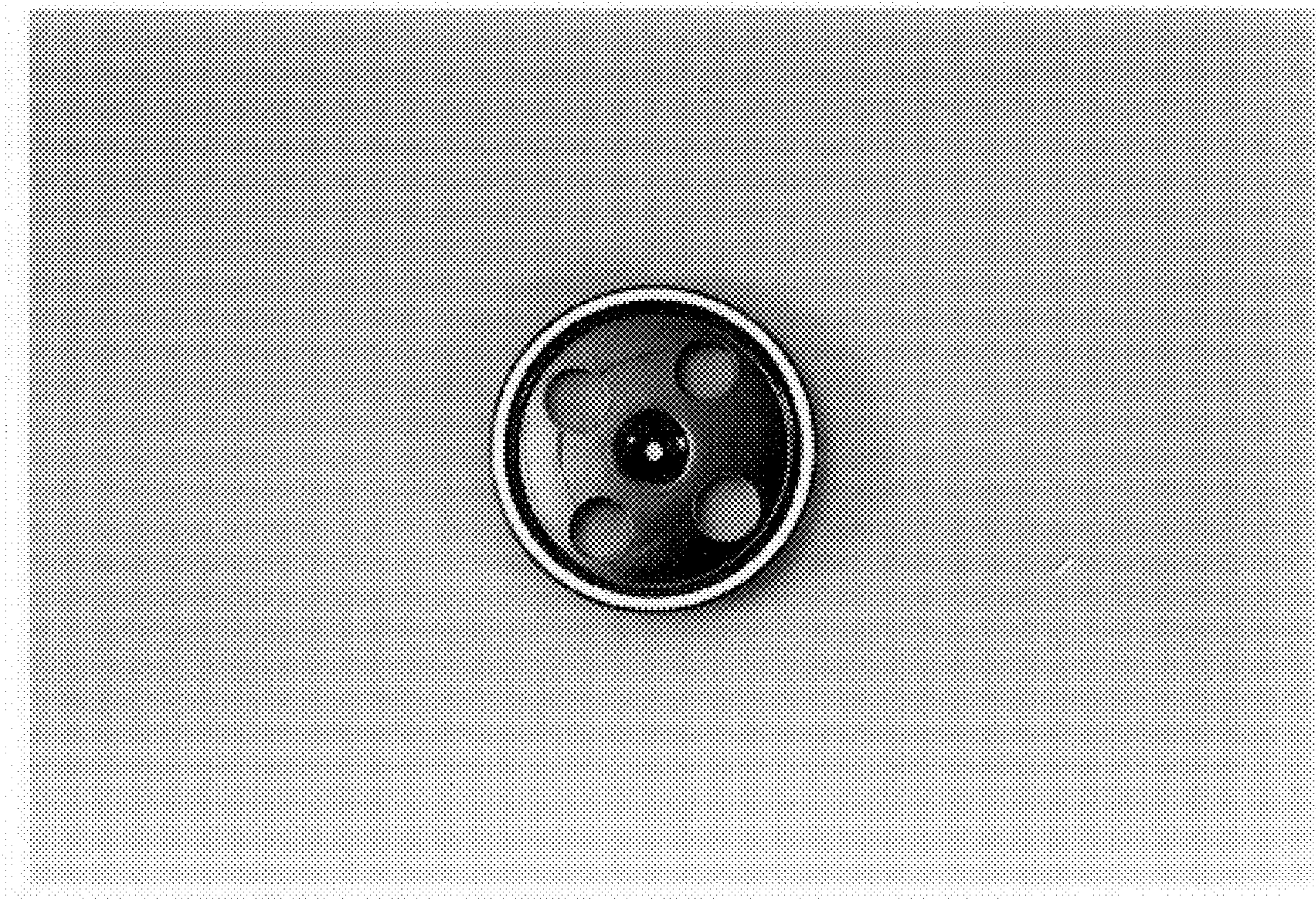

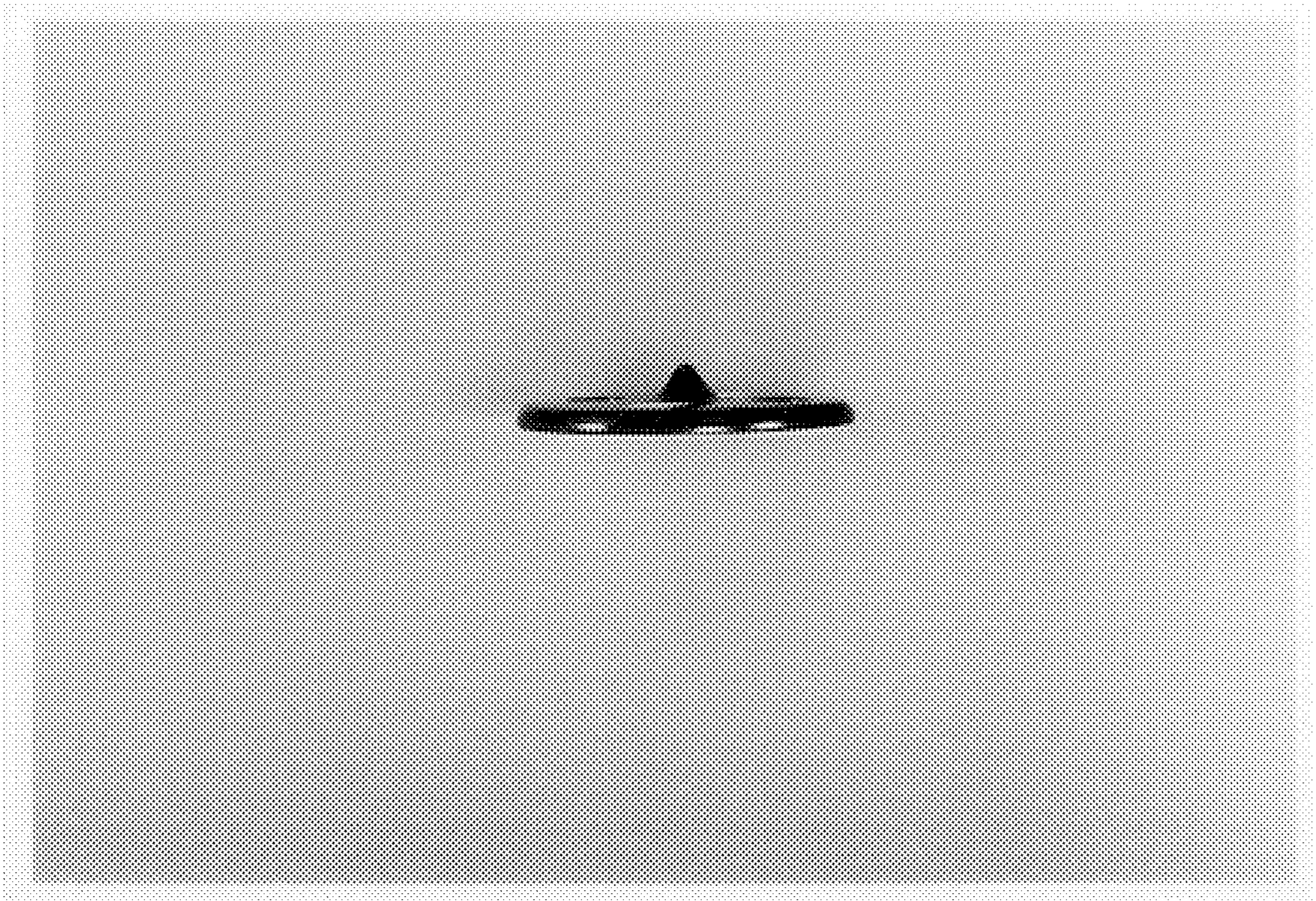

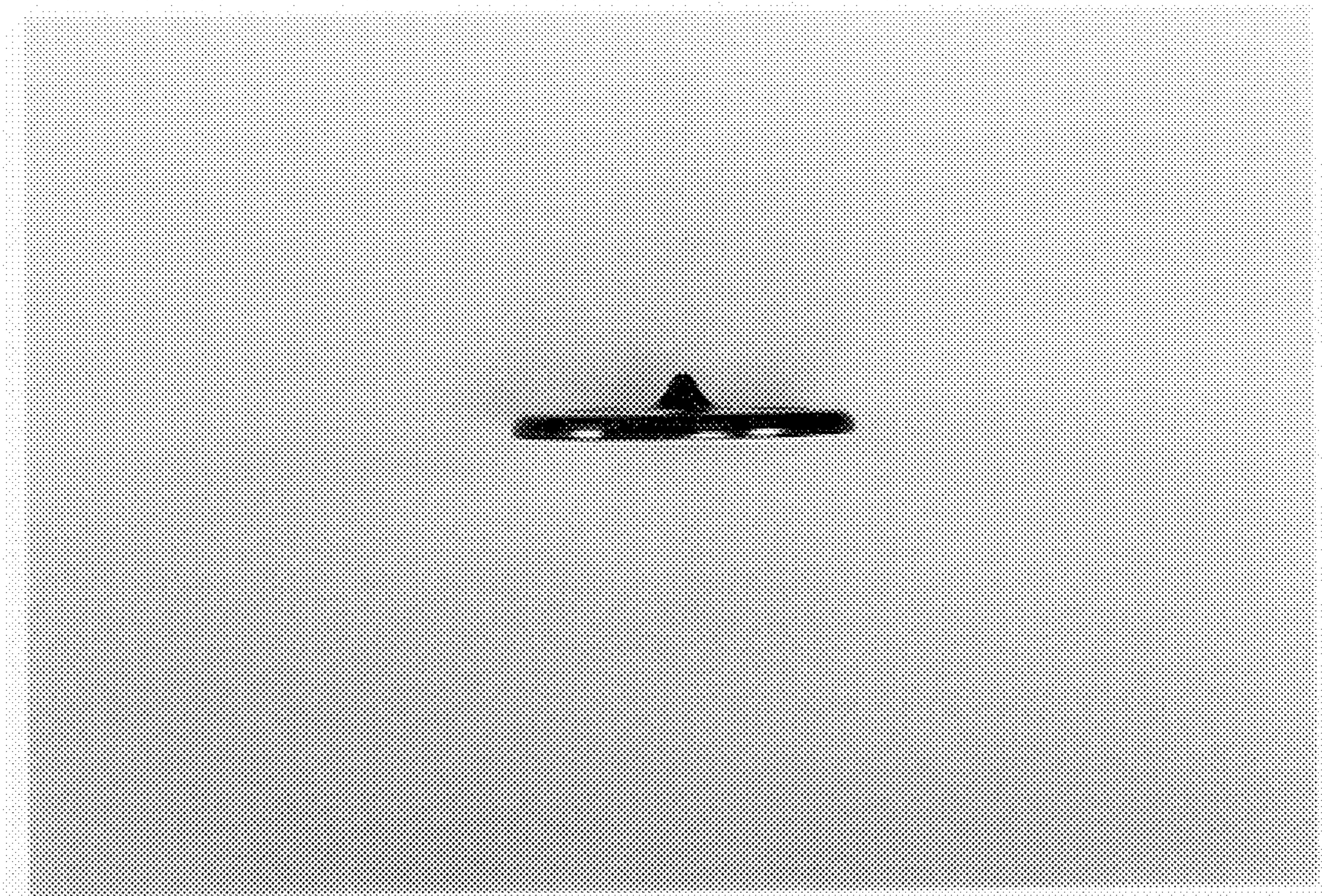

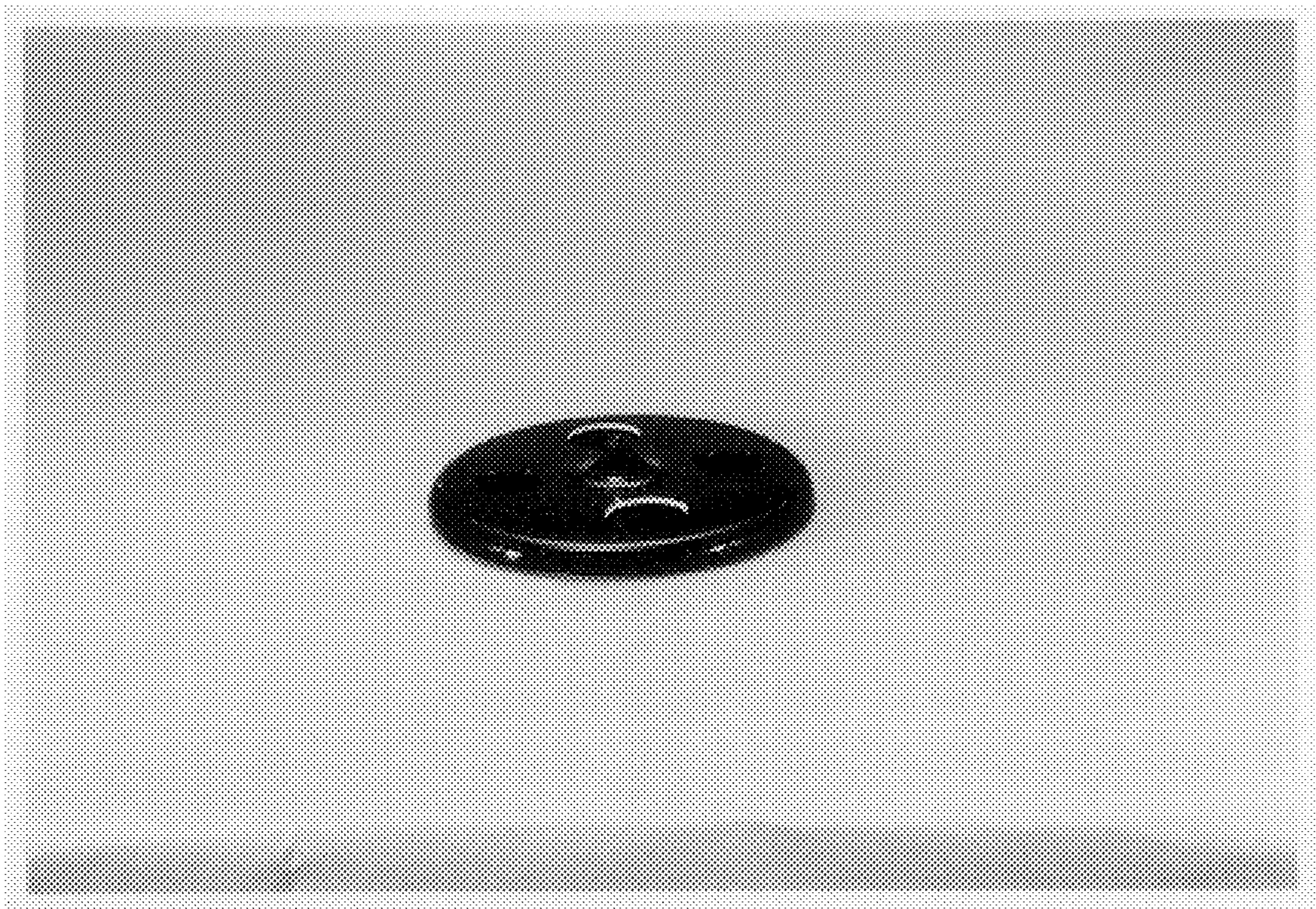
