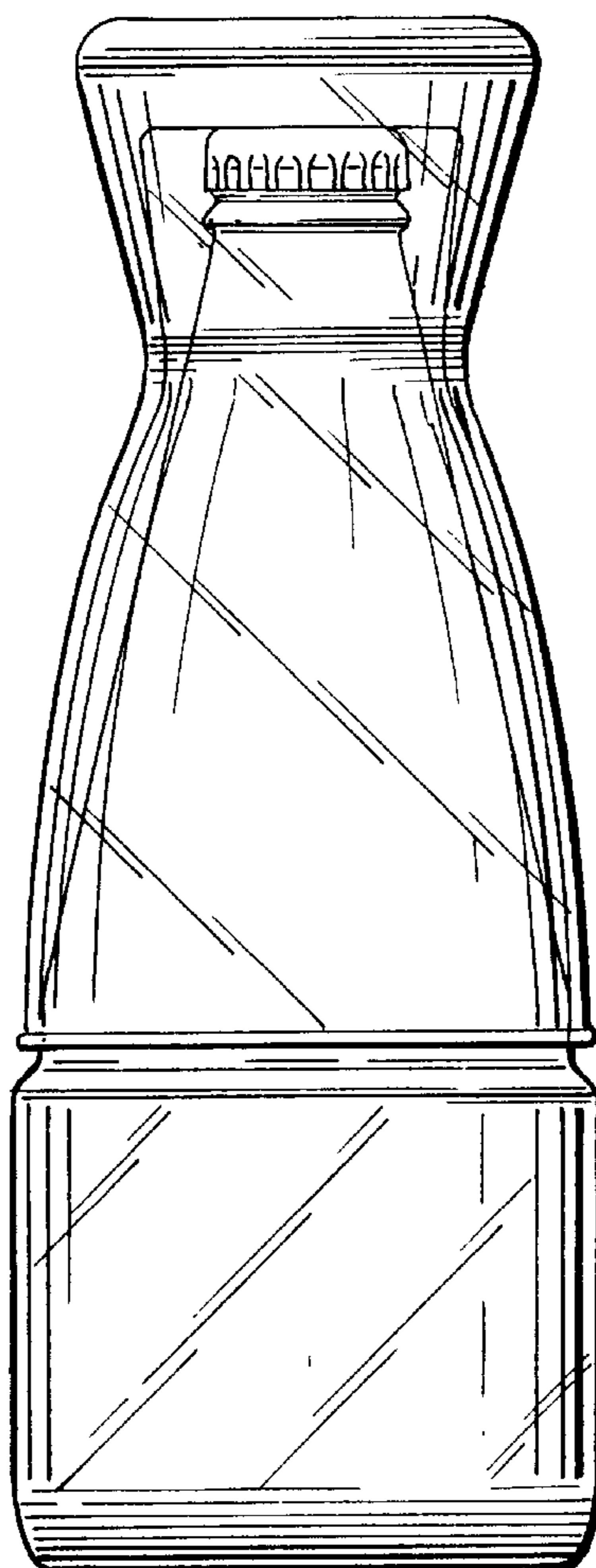
[57] **CLAIM**

The ornamental design for a beer bottle and glass, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevational view showing a side of a beer bottle and glass showing my new design; the opposite side being the same as the side shown;  
FIG. 2 is a top plan view of the beer bottle and glass of FIG. 1; and,  
FIG. 3 is a bottom plan view of the beer bottle and glass of FIG. 1.

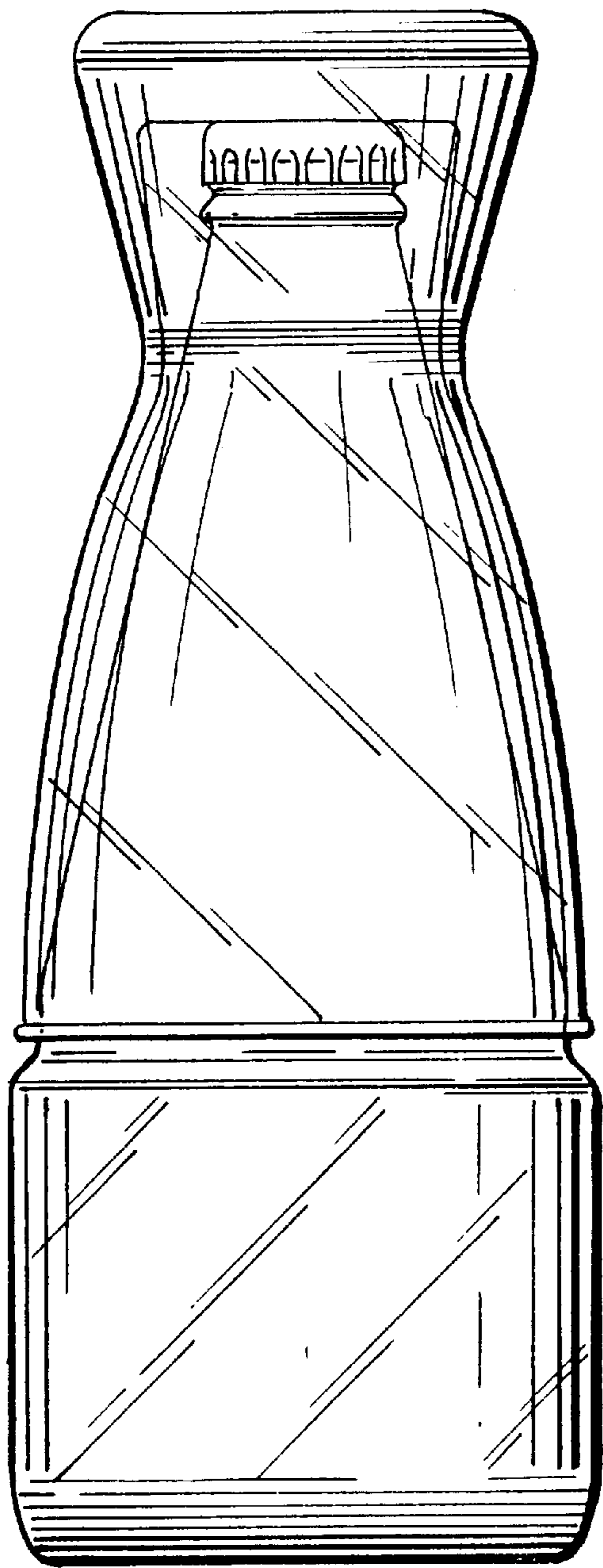

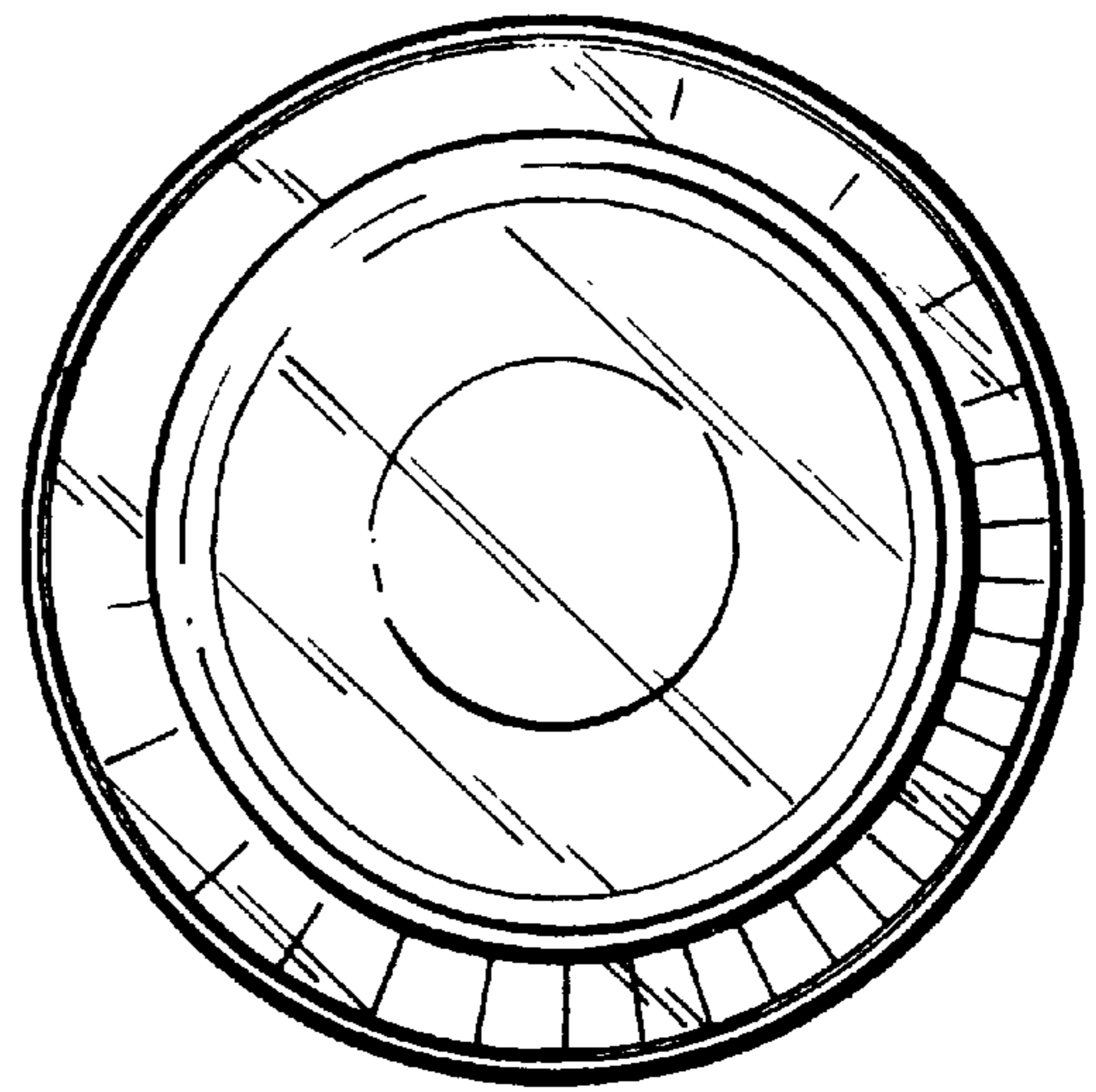

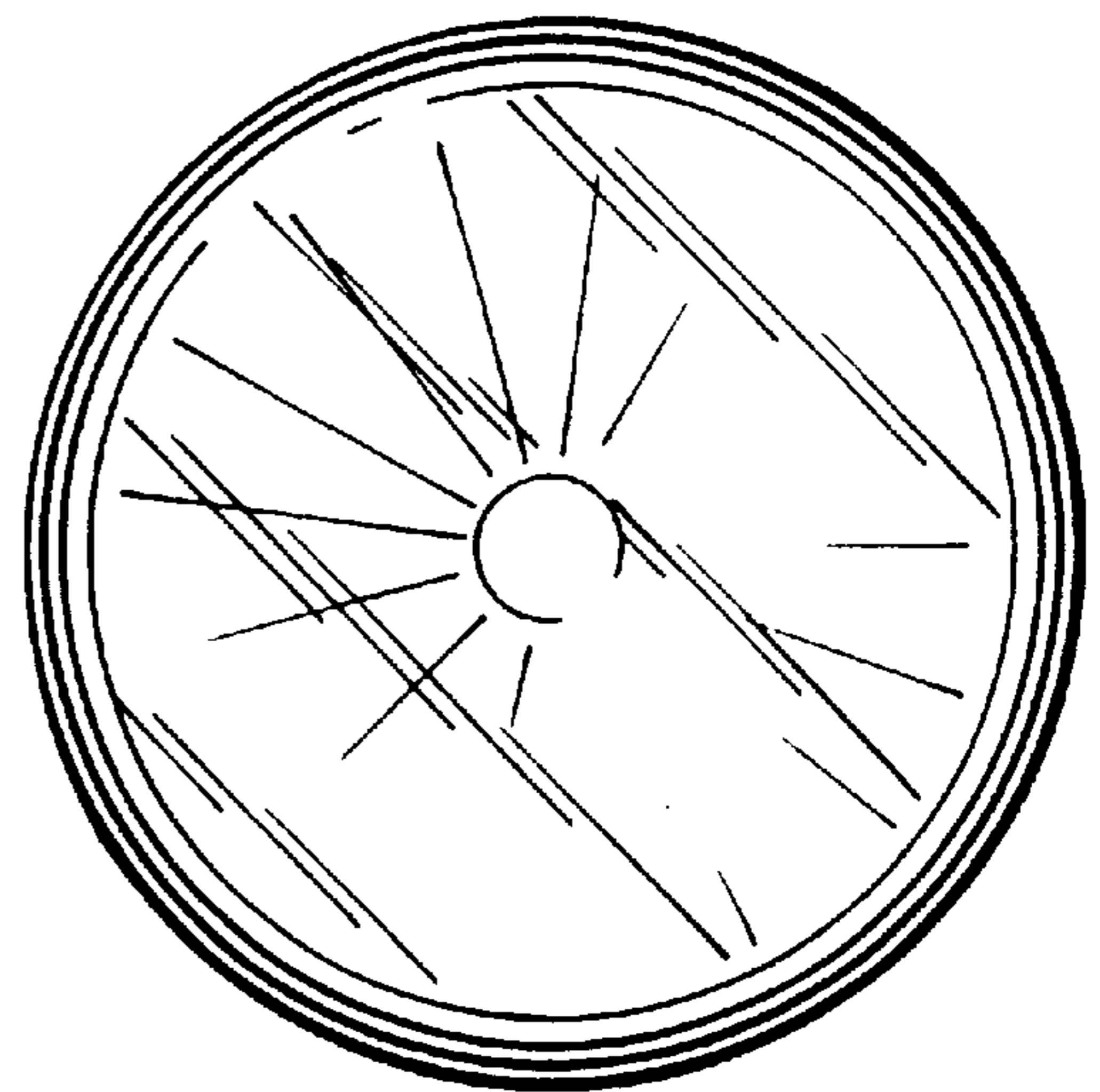
