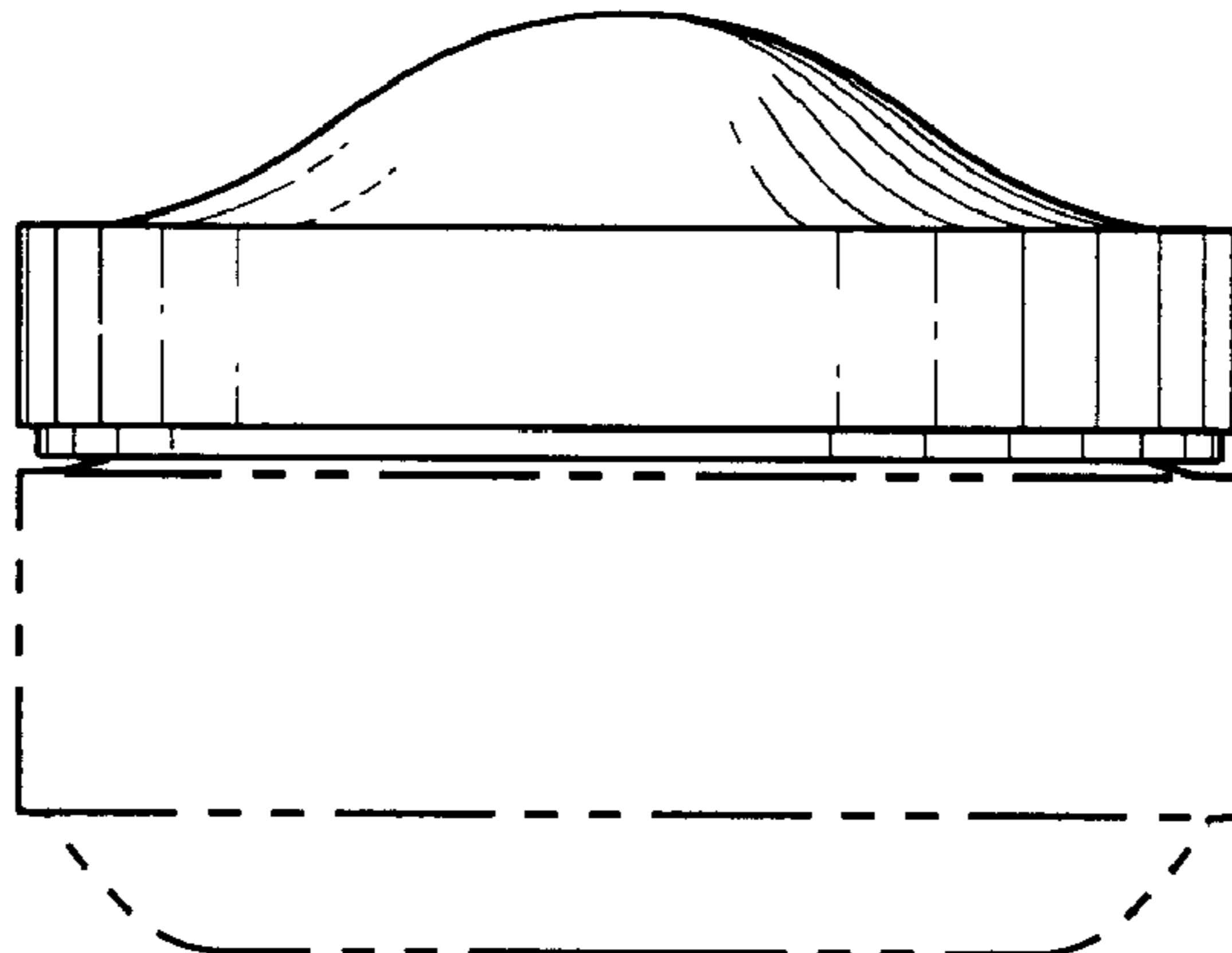
[57] **CLAIM**

The ornamental design for a container cover, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a container cover, embodying our new design, the opposite side not shown being a mirror image thereof; and, FIG. 2 is a top view thereof. The broken lines shown in the drawings depicting environmental structure are for illustrative purposes only and form no part of the claimed design.

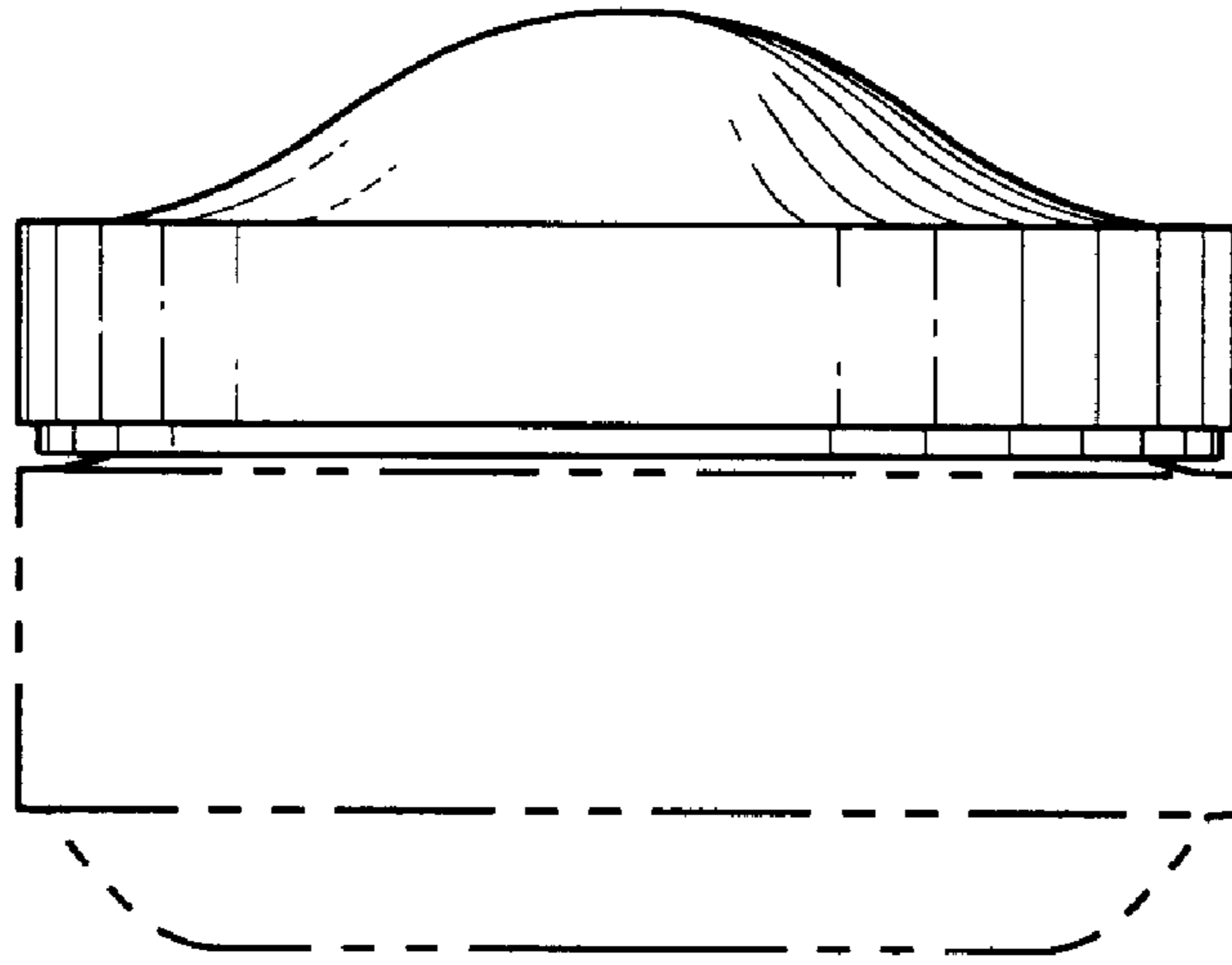

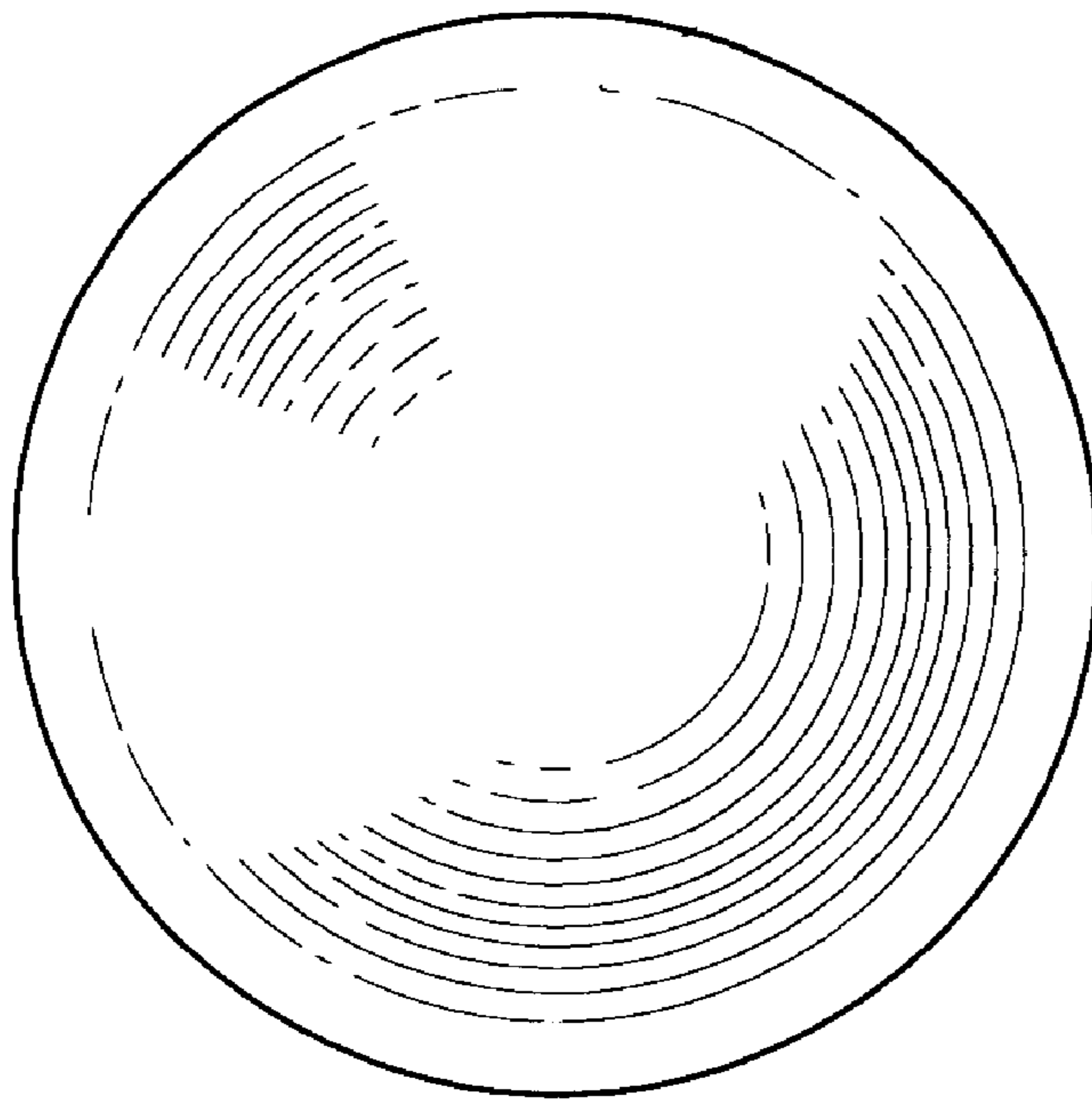
