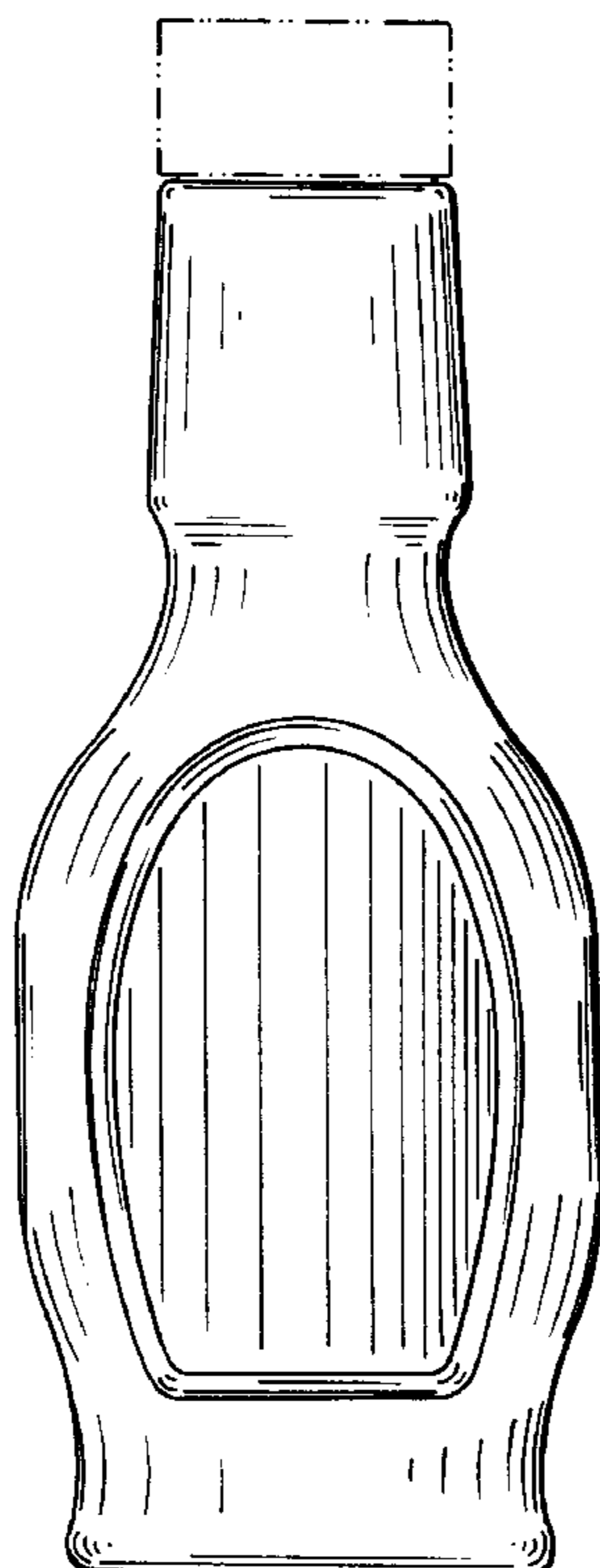
[57] **CLAIM**

The ornamental design for a bottle, as shown and described.

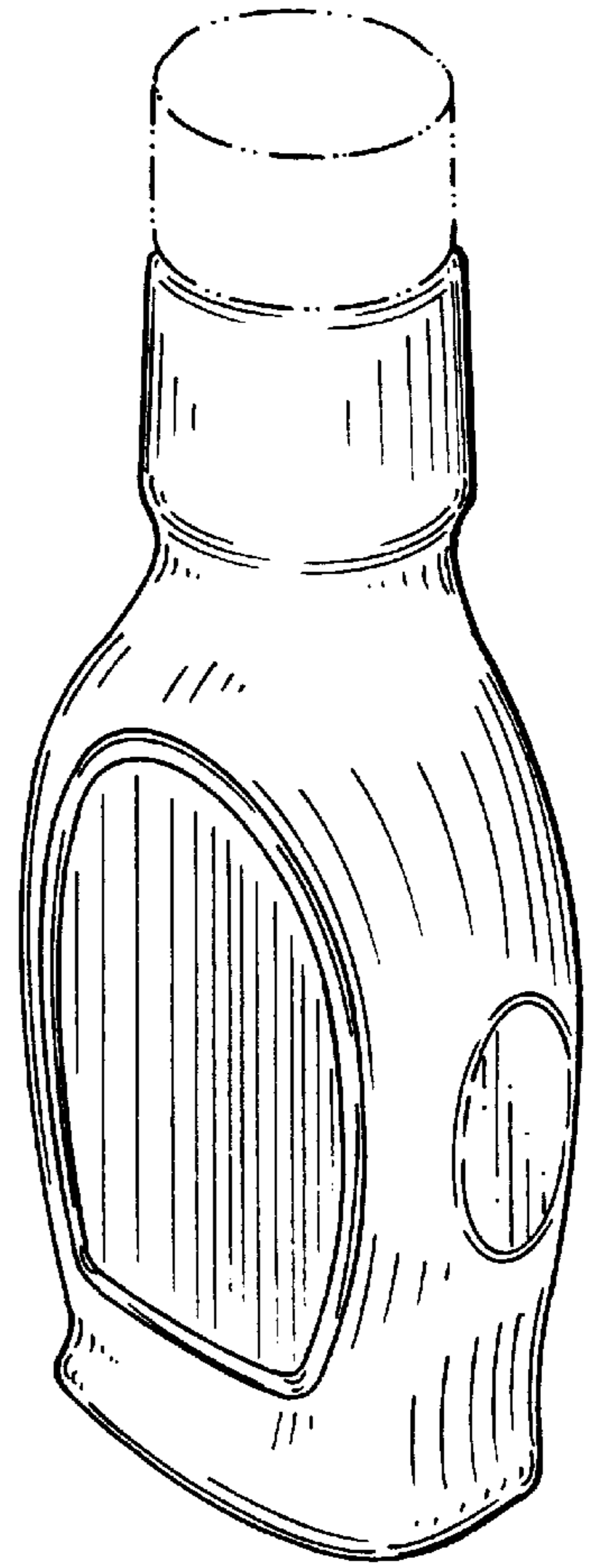
**DESCRIPTION**

FIG. 1 is a perspective view of a bottle showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof, the rear being identical thereto; and,  
FIG. 4 is a side elevational view thereof, the opposite side being identical thereto.  
The broken lines at the top of the bottle indicate a cap for the bottle which forms no part of the claimed design.

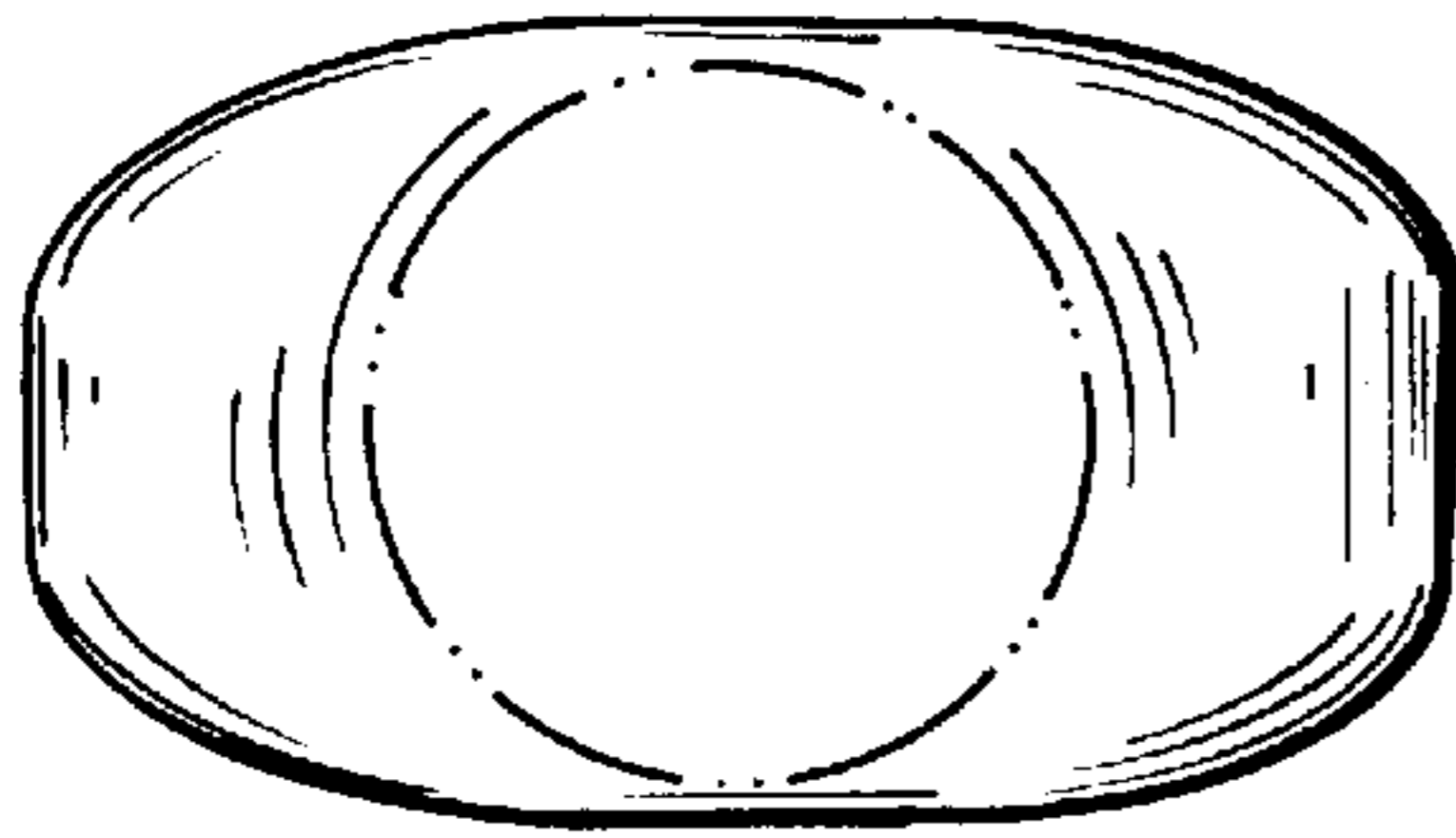

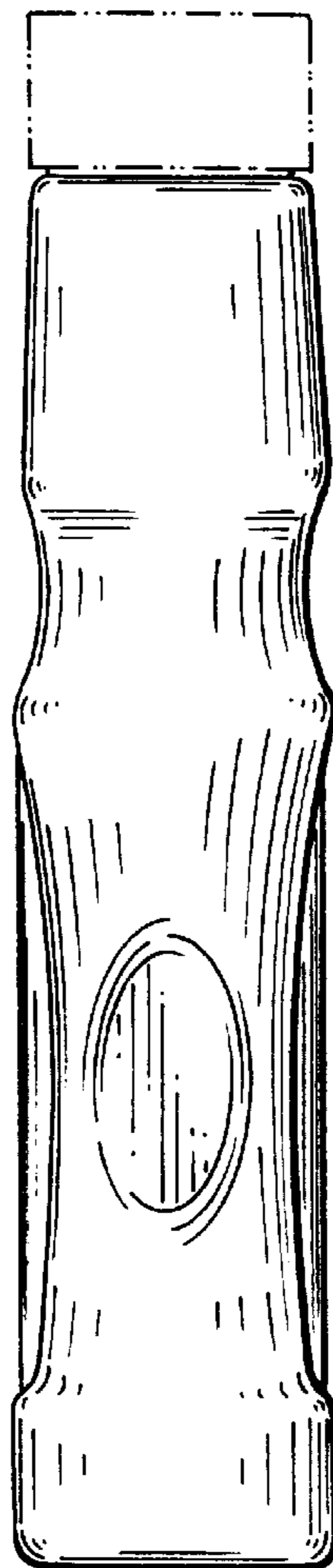
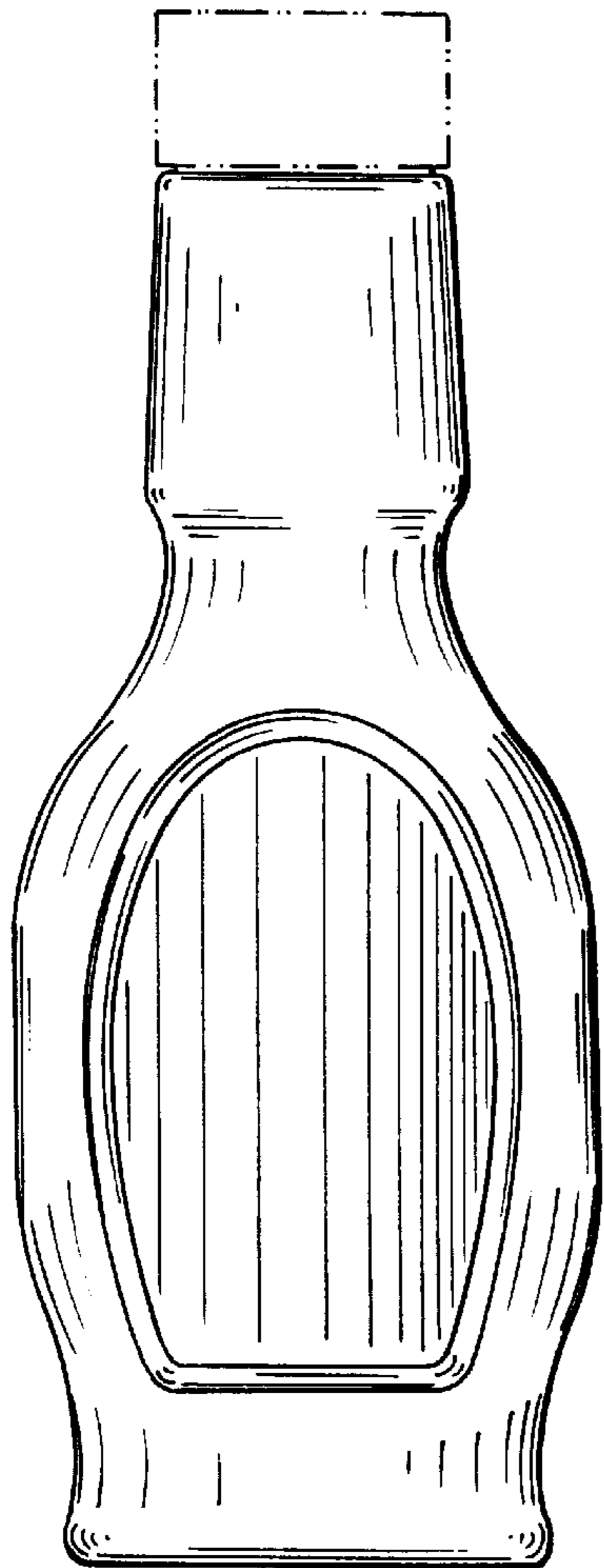
