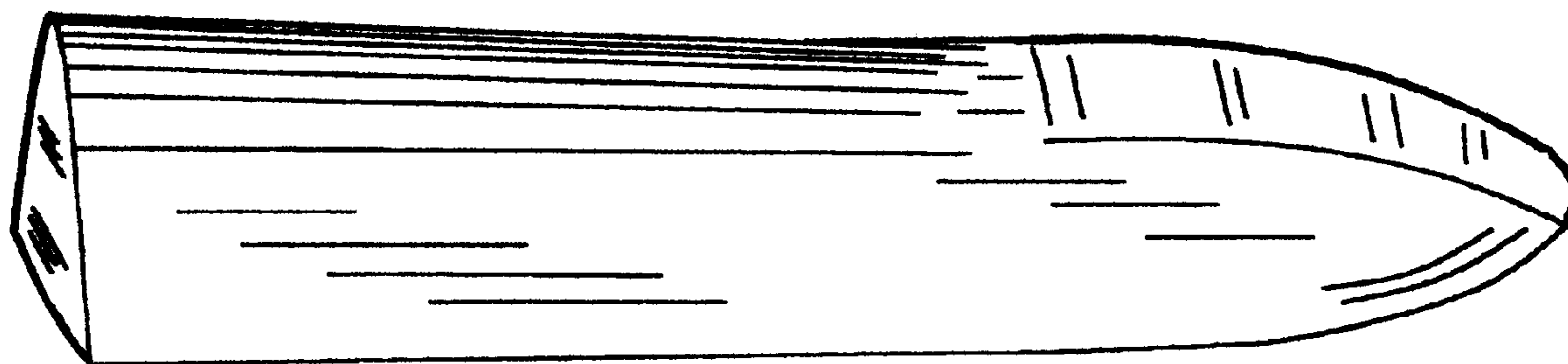

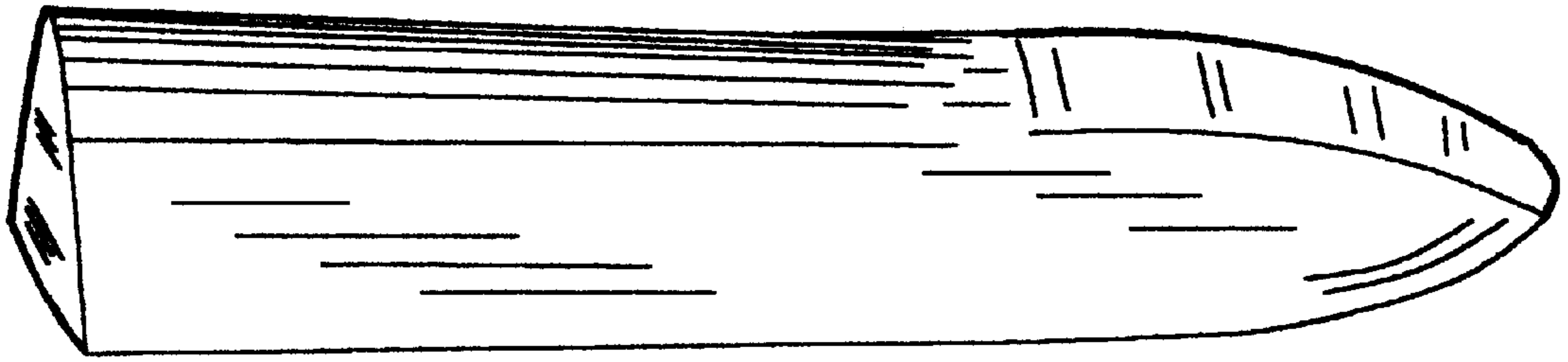
The ornamental design for a car top carrier and container, as shown and described.

**DESCRIPTION**

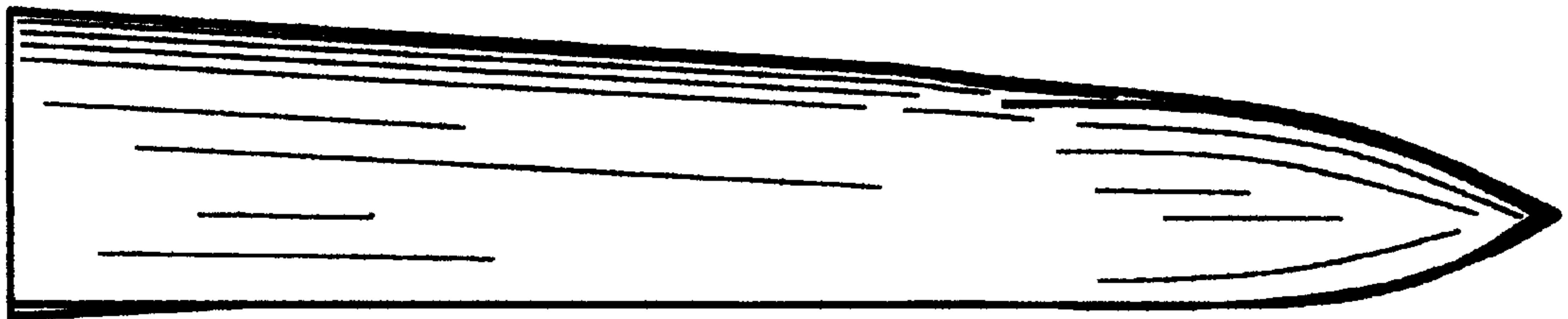
FIG. 1 is a side, partial top, partial rear perspective view of a car top carrier and container showing my new design; FIG. 2 is a side elevational view thereof; with the opposite side being a mirror image of this side shown; FIG. 3 is a top elevational view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof, showing the rear cover door in place; and, FIG. 6 is a bottom elevational view thereof.

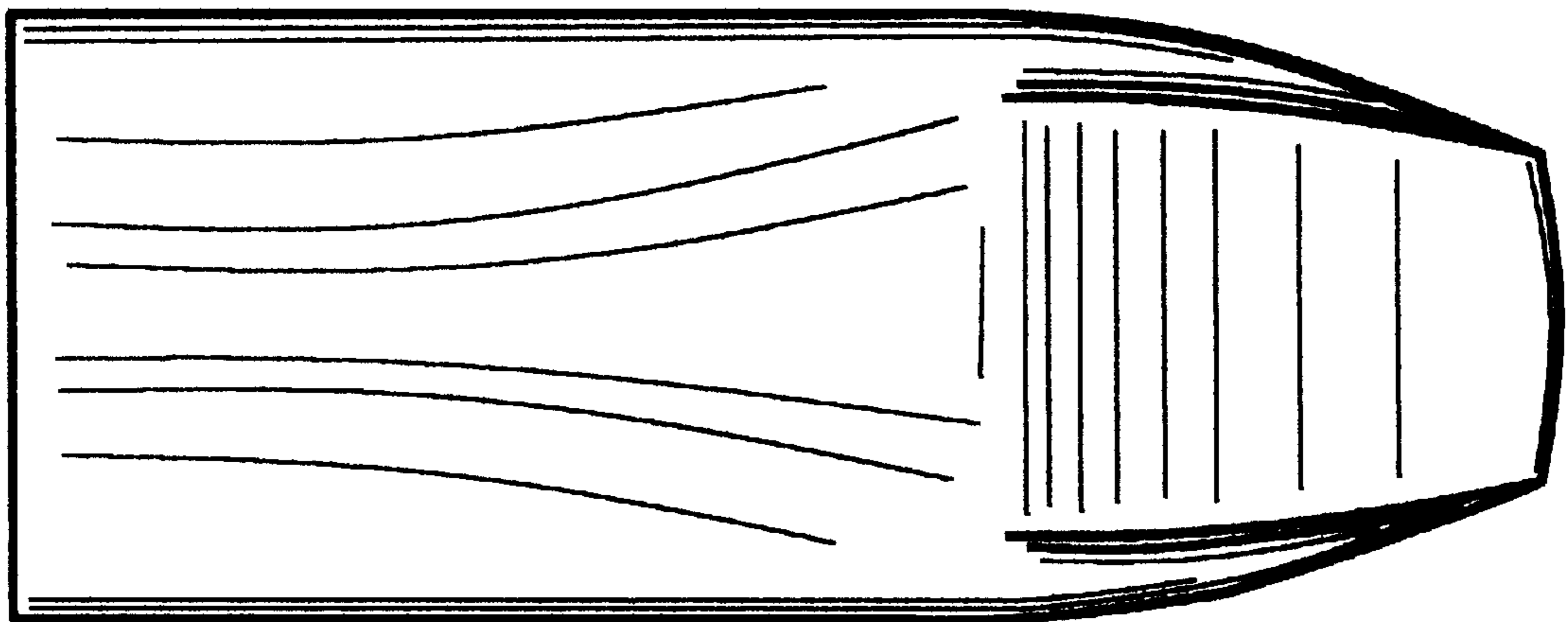

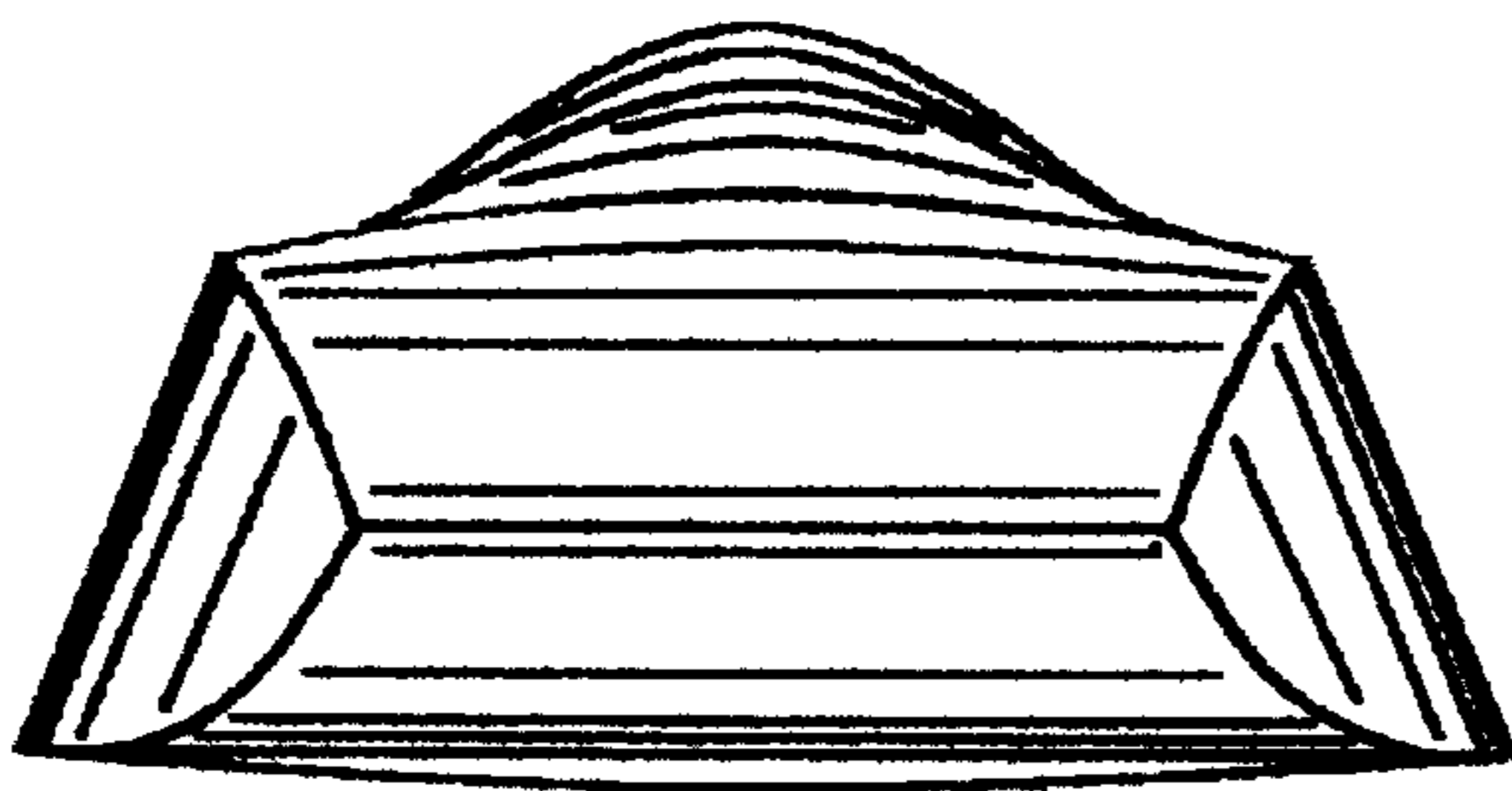

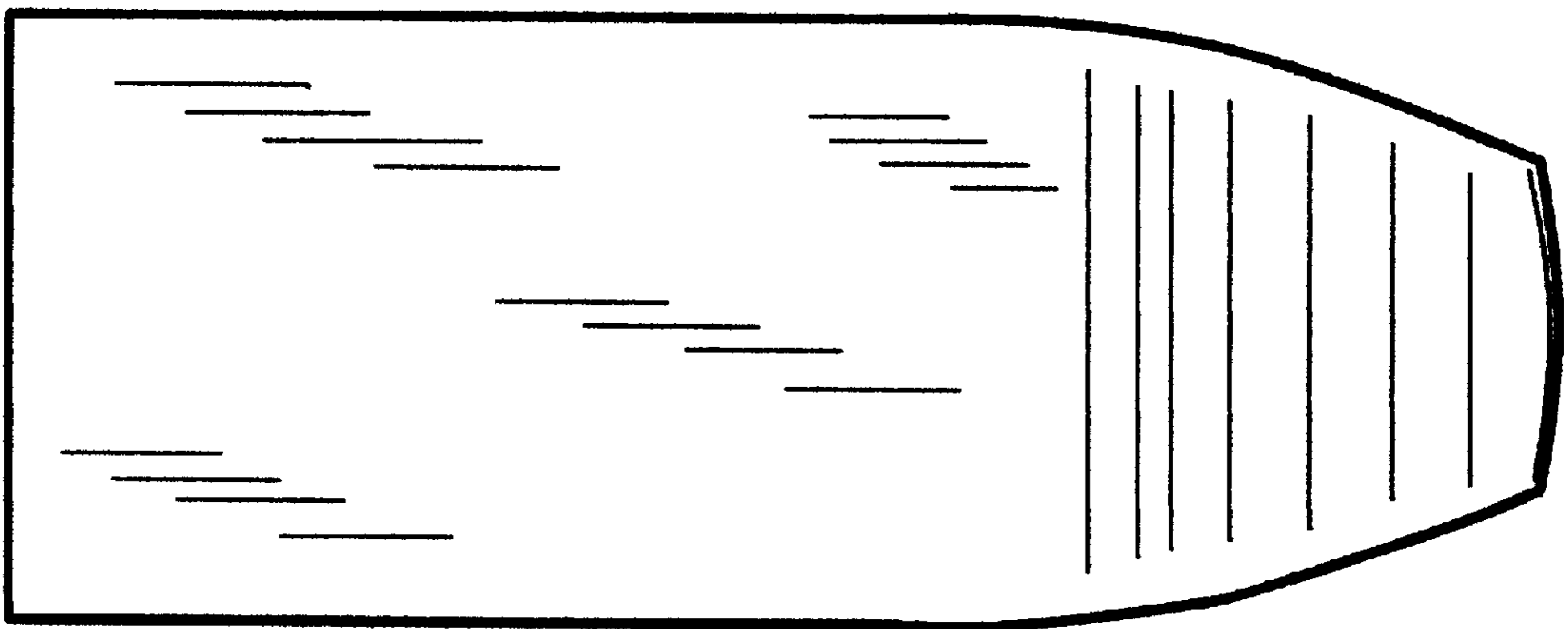
