The ornamental design for a loudspeaker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view from the front, above and one side of the loudspeaker;

FIG. 2 is a front view of the loudspeaker;

FIG. 3 is a rear view of the loudspeaker;

FIG. 4 is a view of one side of the loudspeaker;

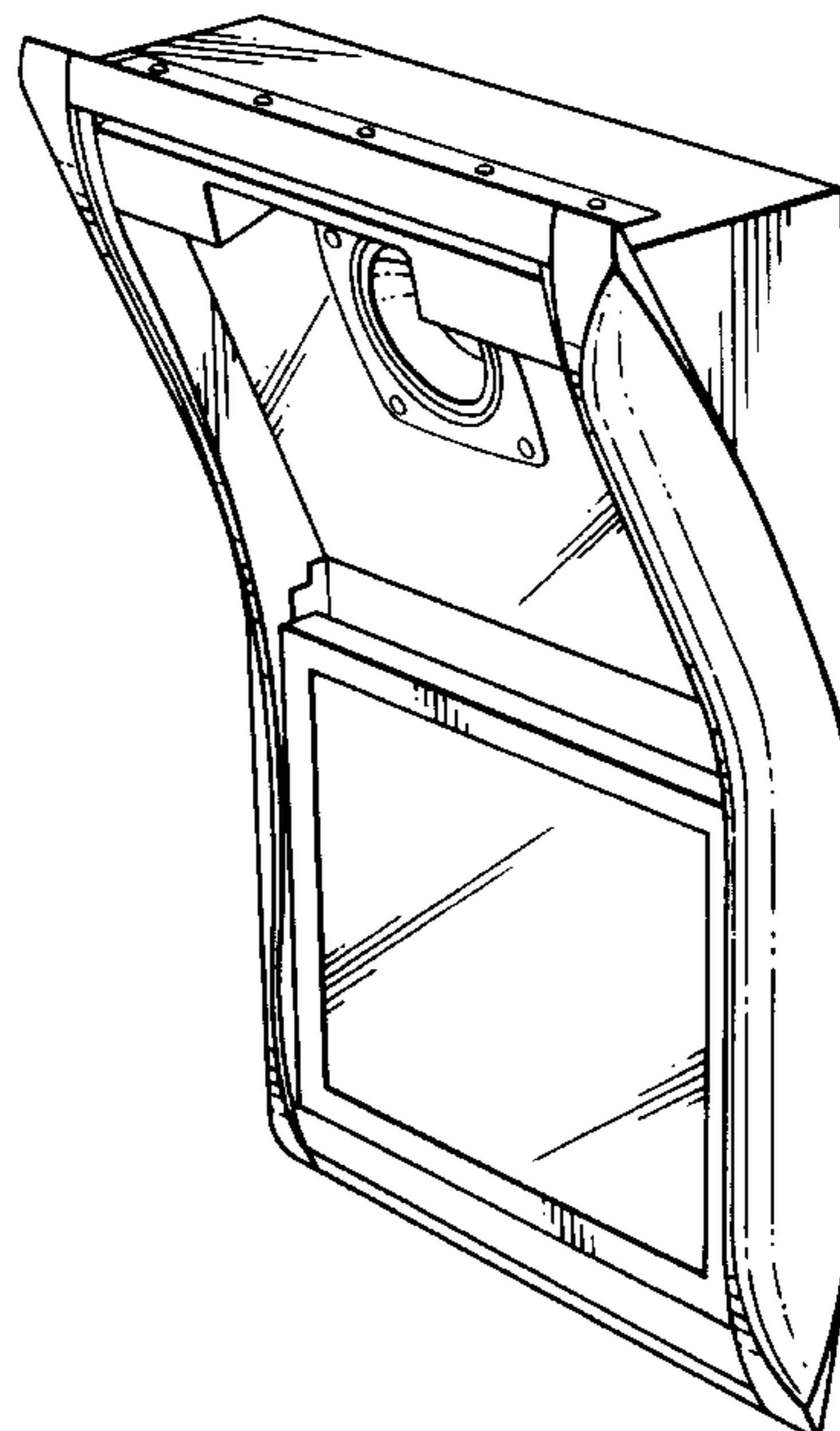
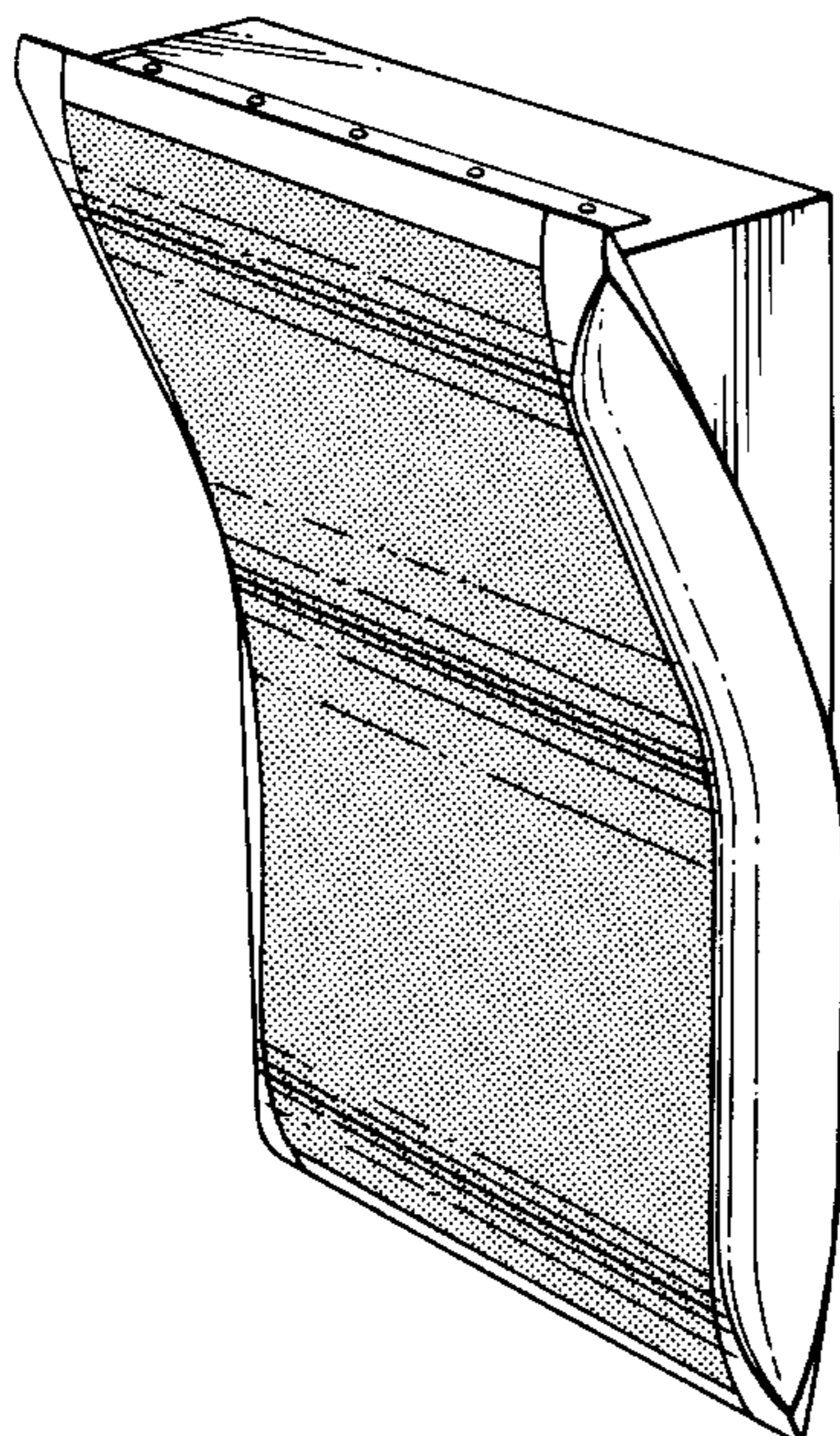
FIG. 5 is a view of the other side of the loudspeaker;

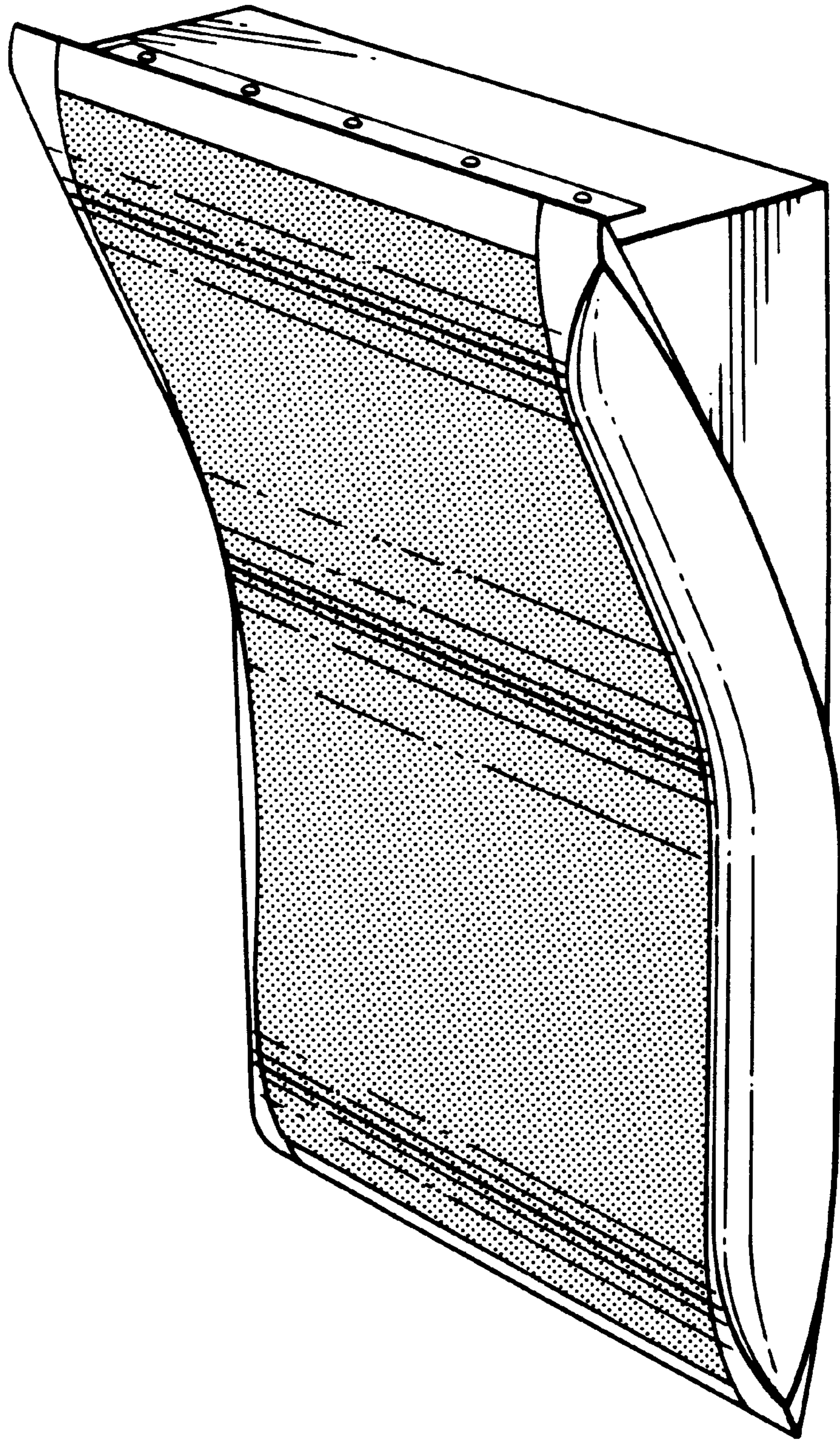

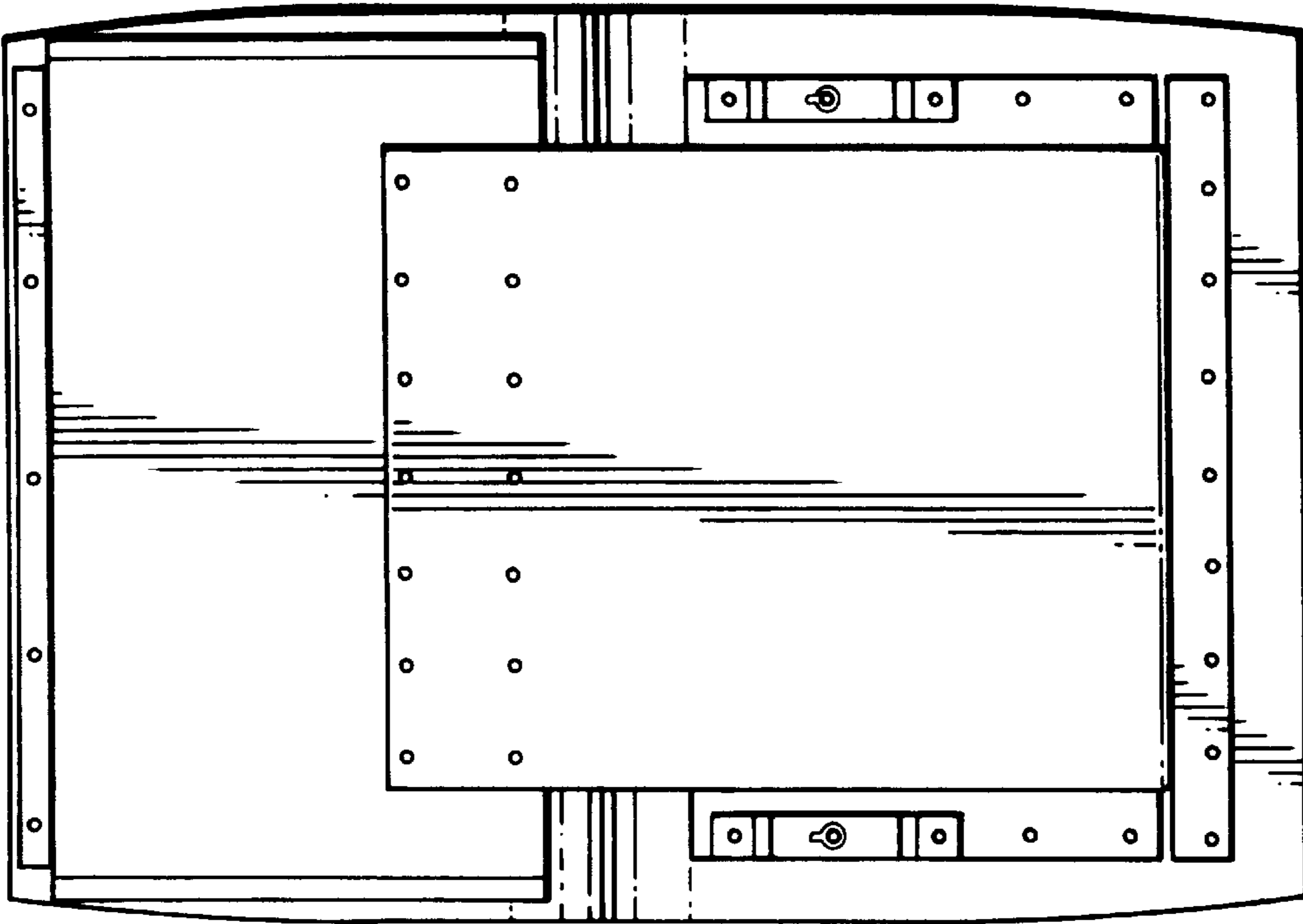

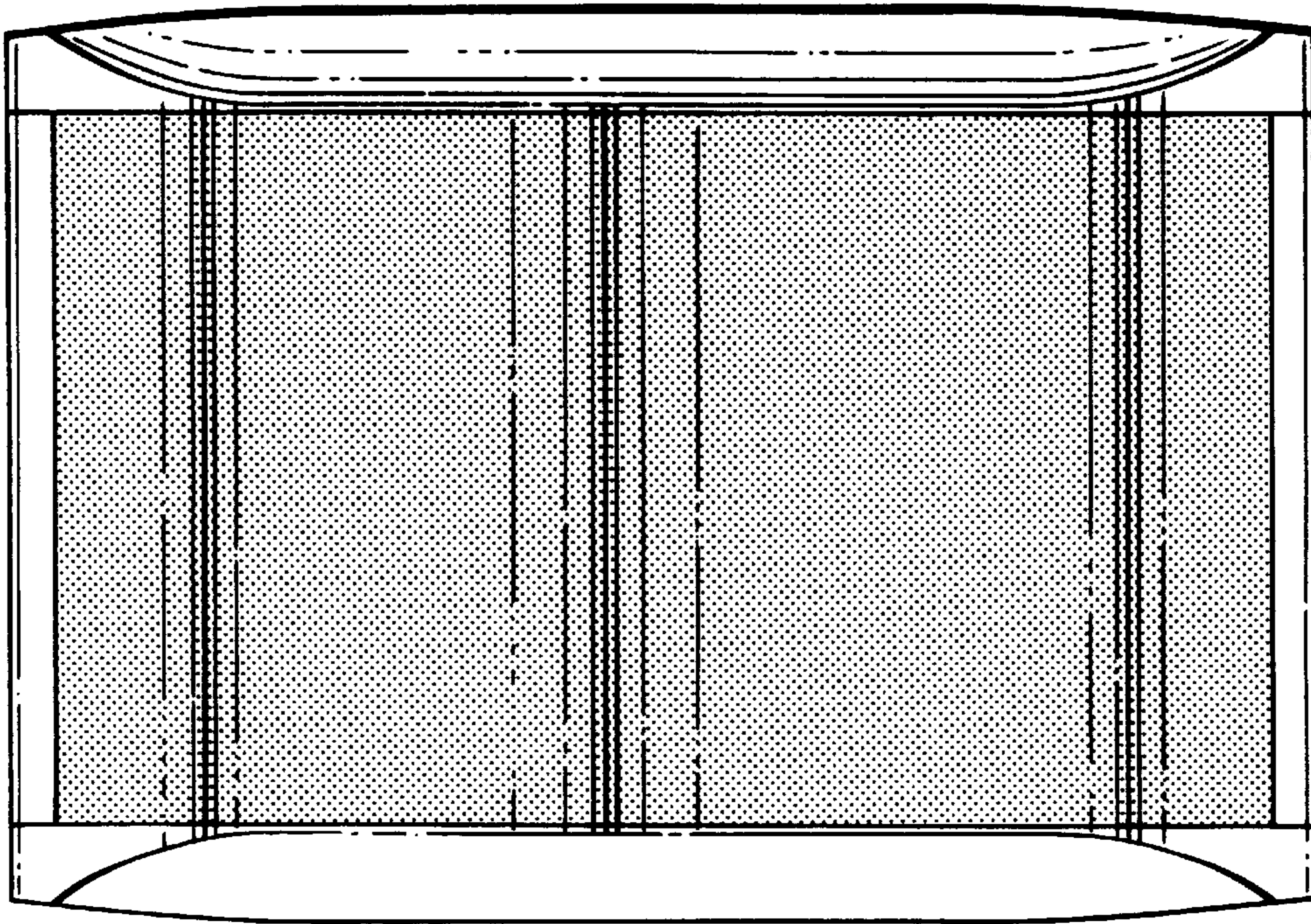

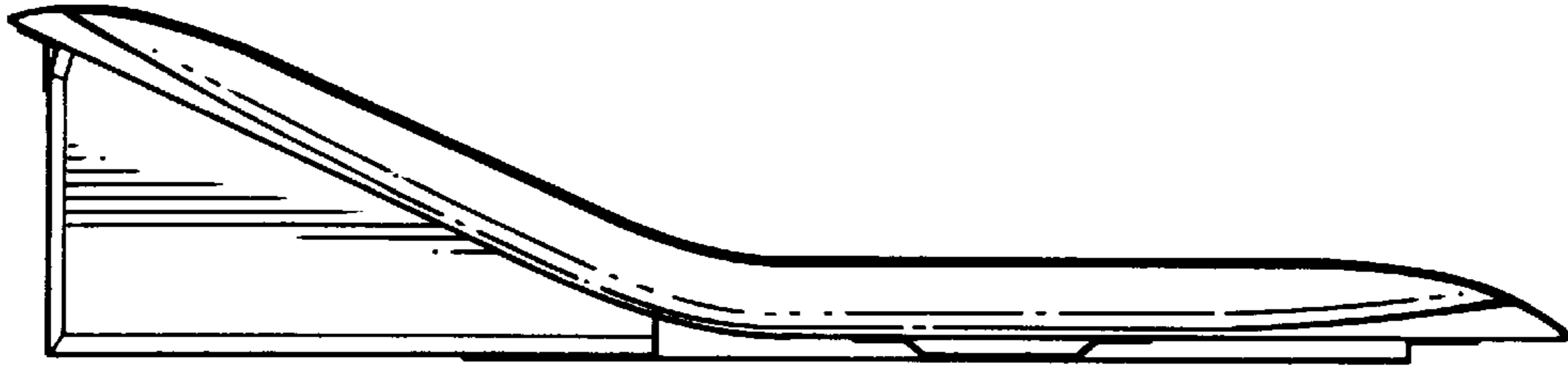

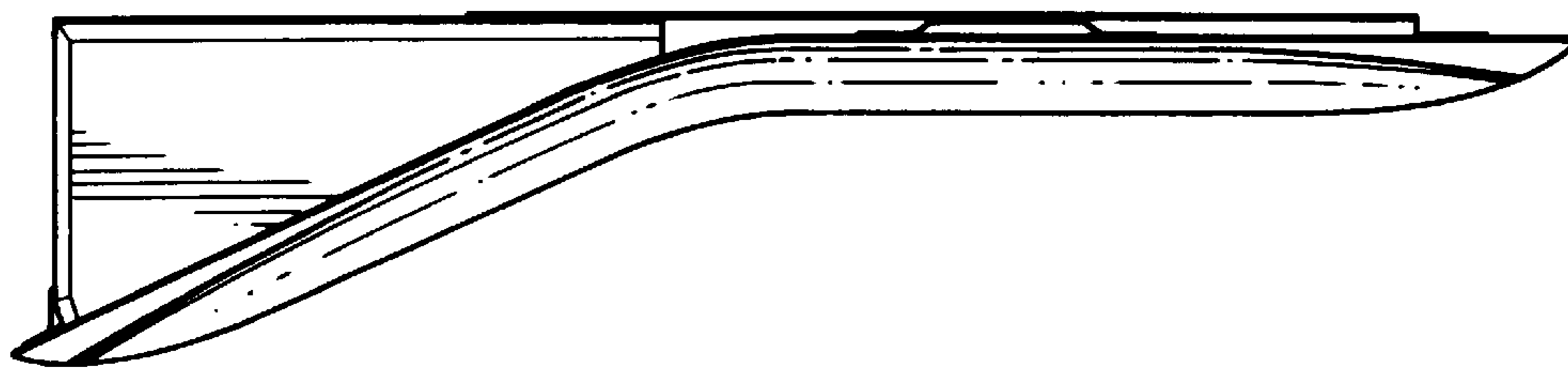

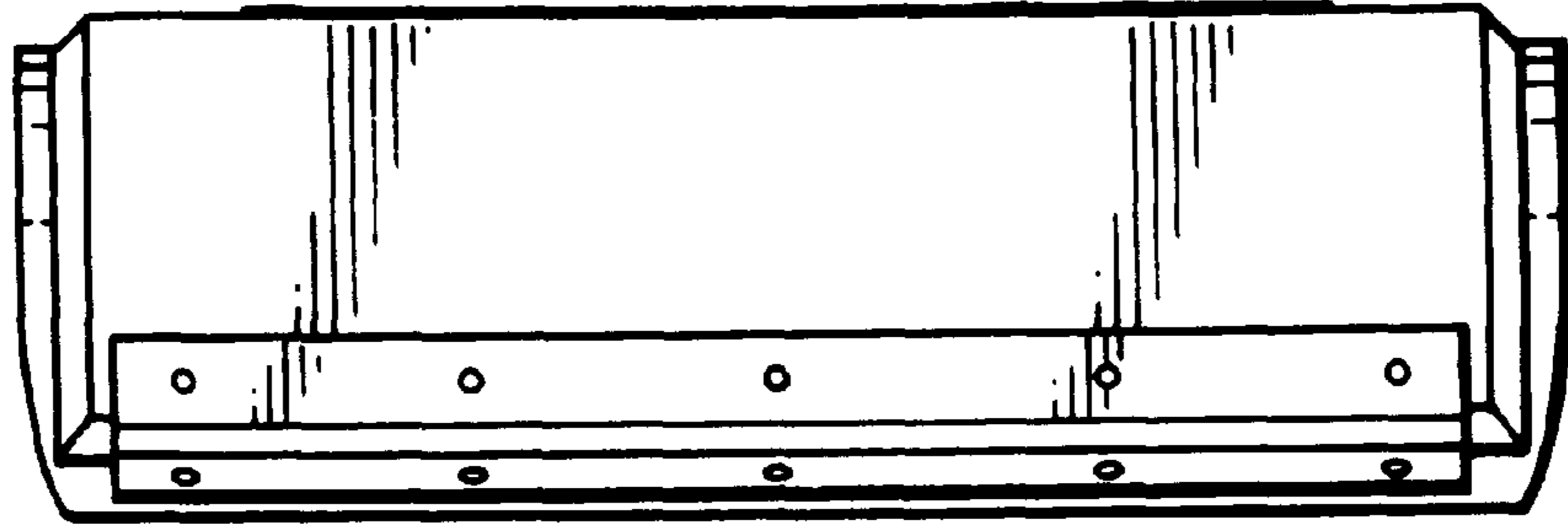

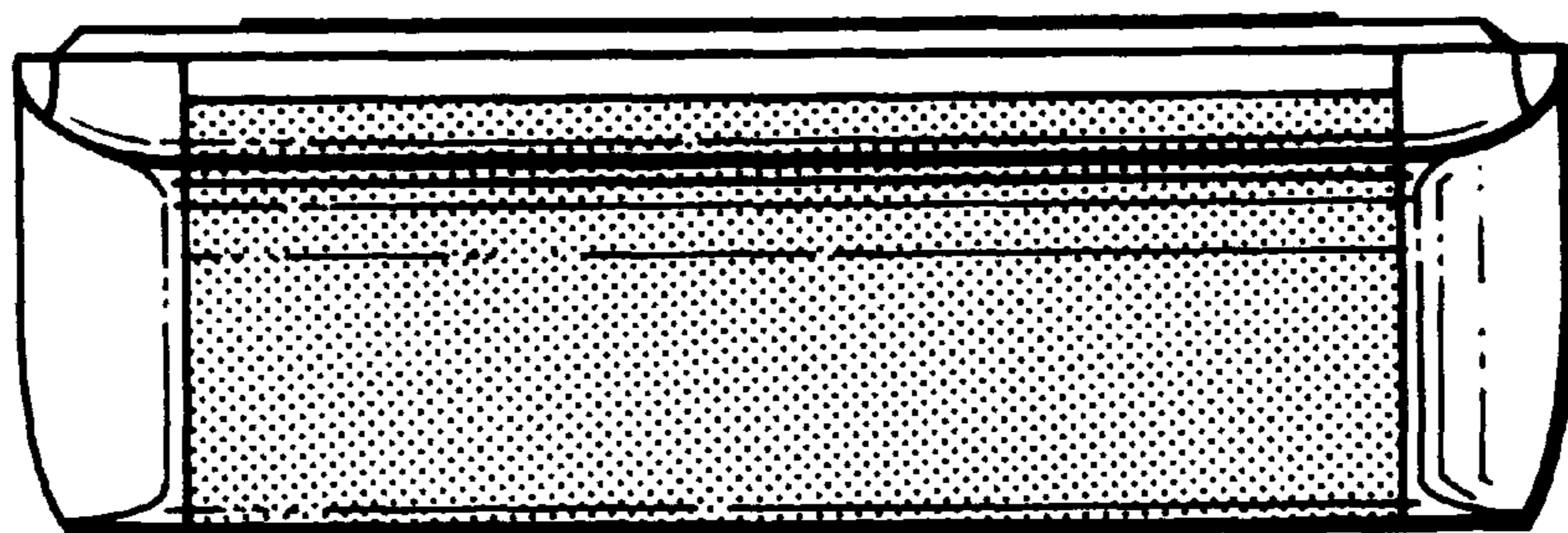

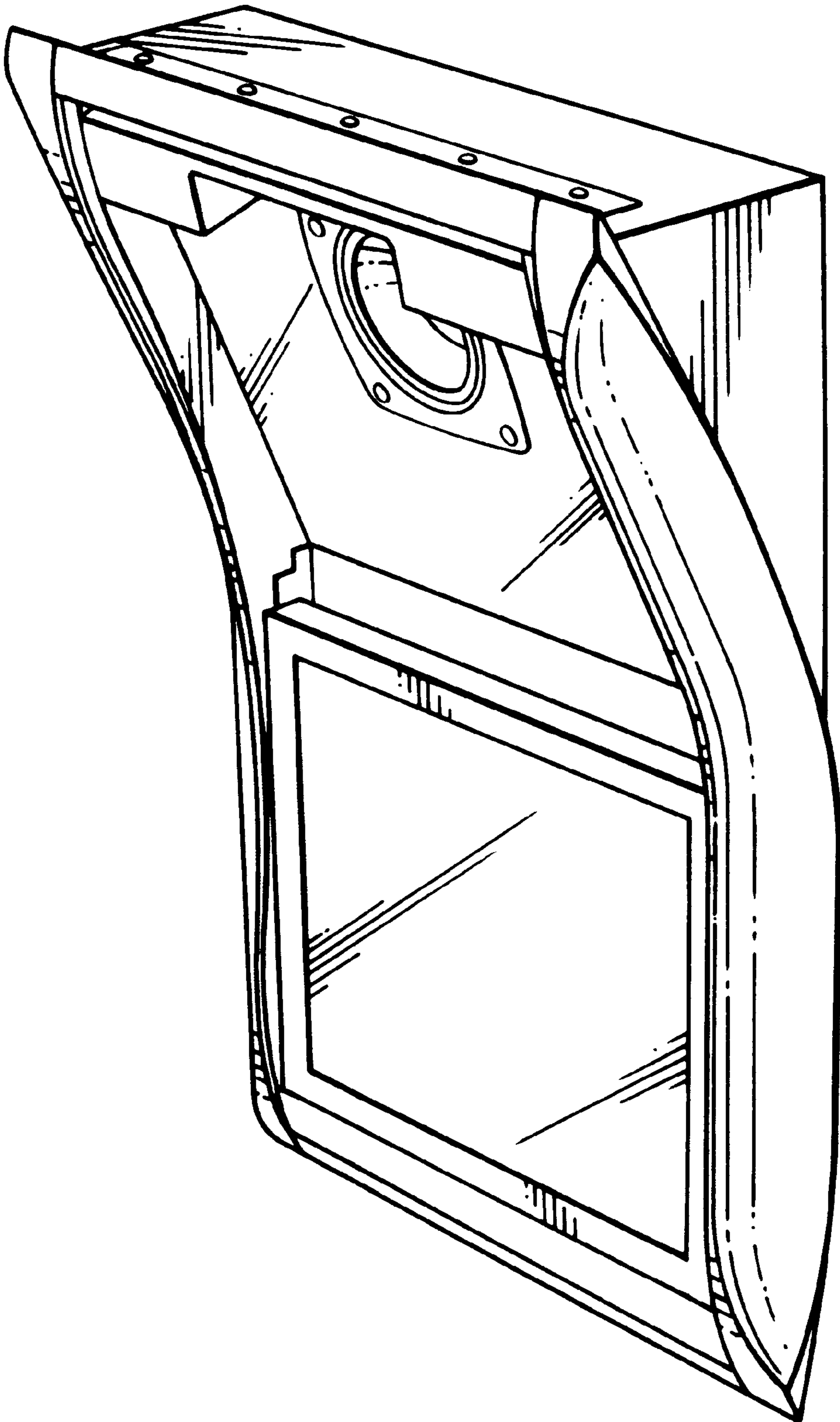
