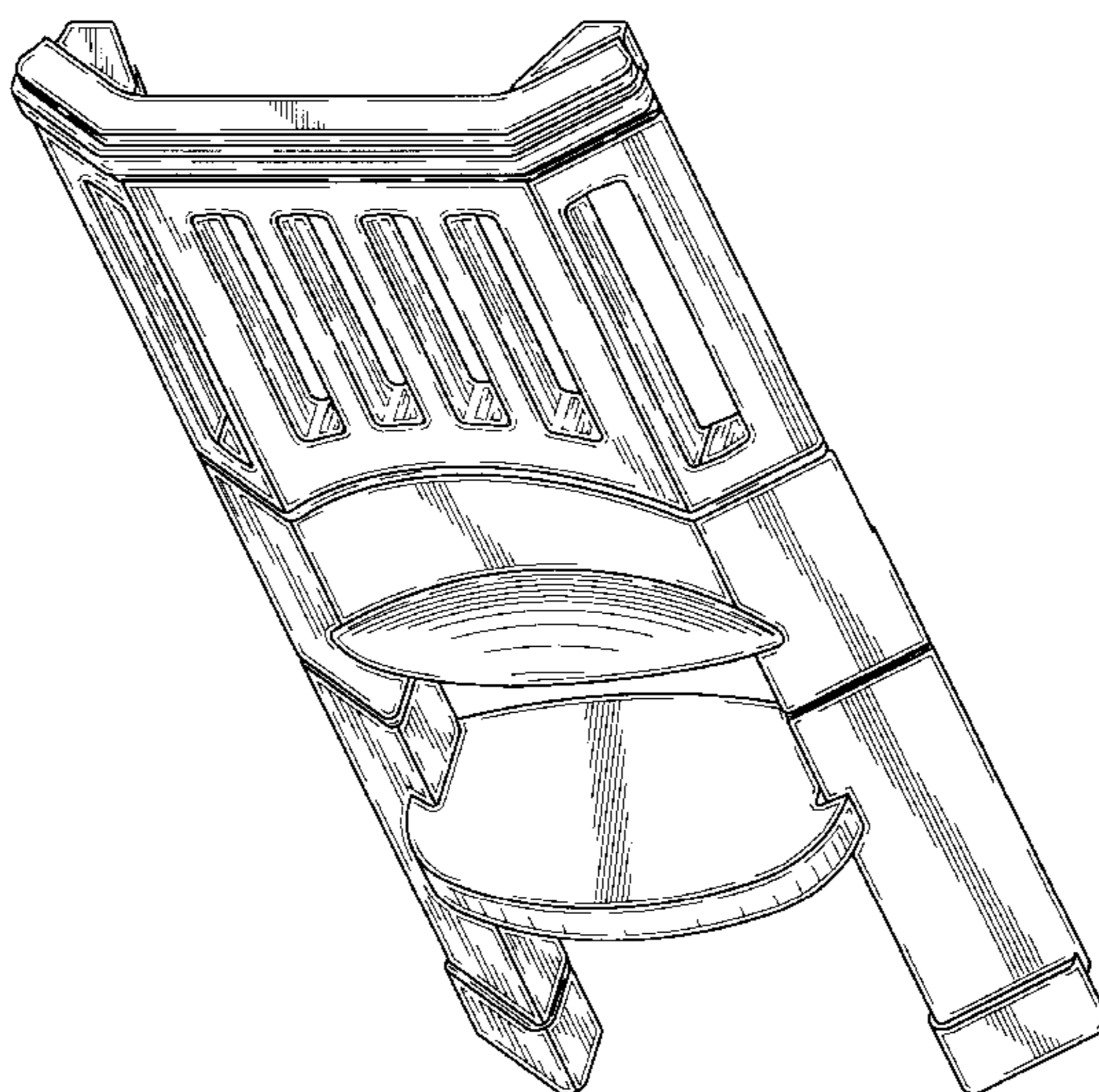
[57] **CLAIM**

The ornamental design for a panel for playground structure, as shown and described.

**DESCRIPTION**

FIG. 1 is a top right front perspective view of a panel for playground structure showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a right side elevational view thereof; the left side elevational view being a mirror image; and,  
FIG. 6 is a rear elevational view thereof.

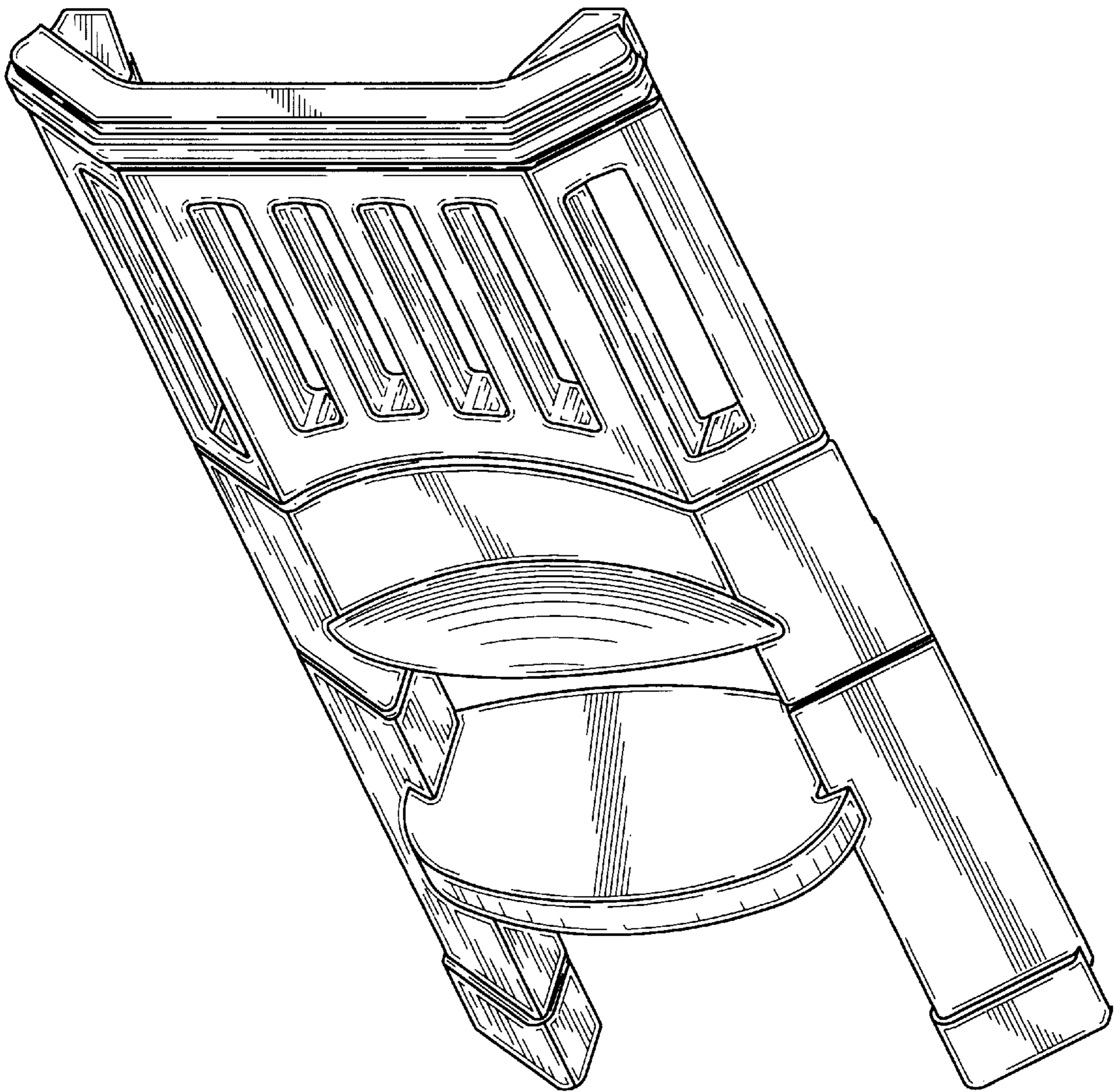

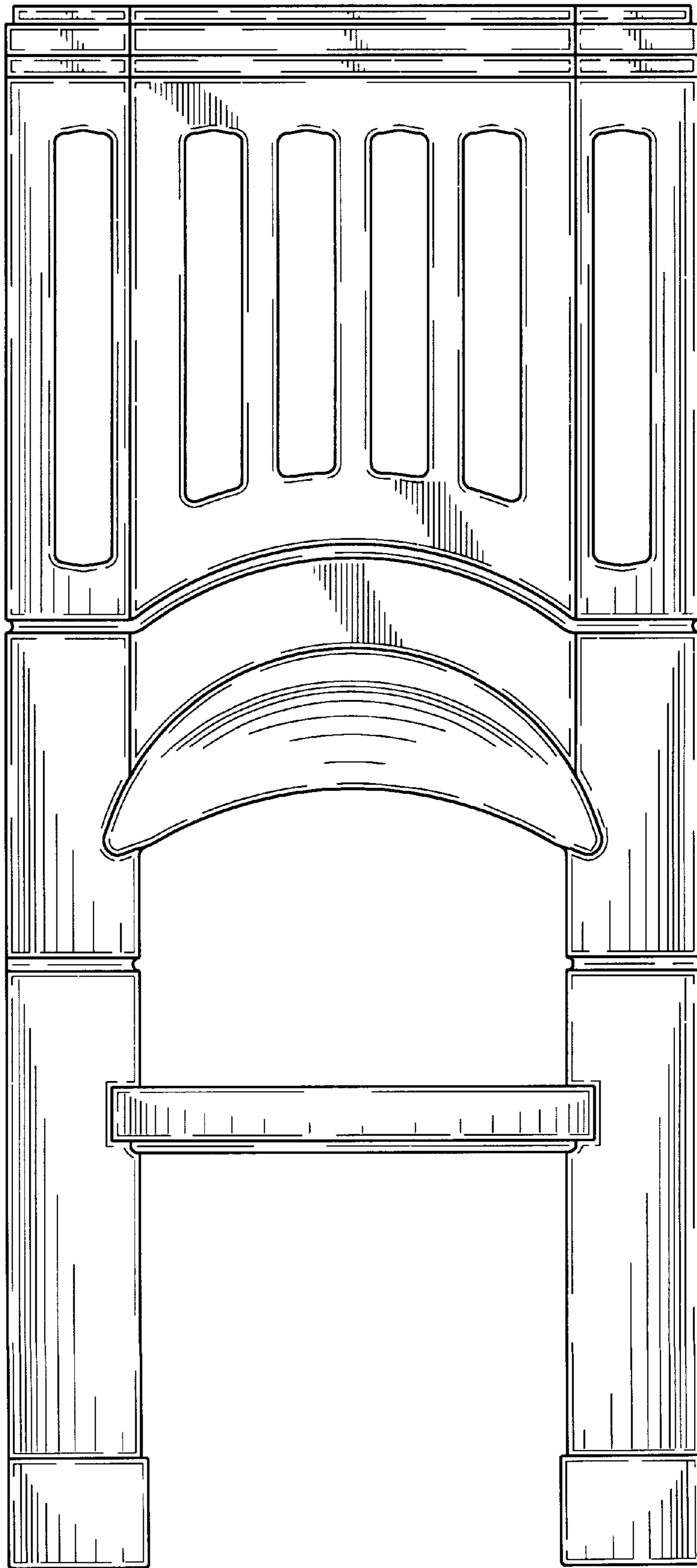

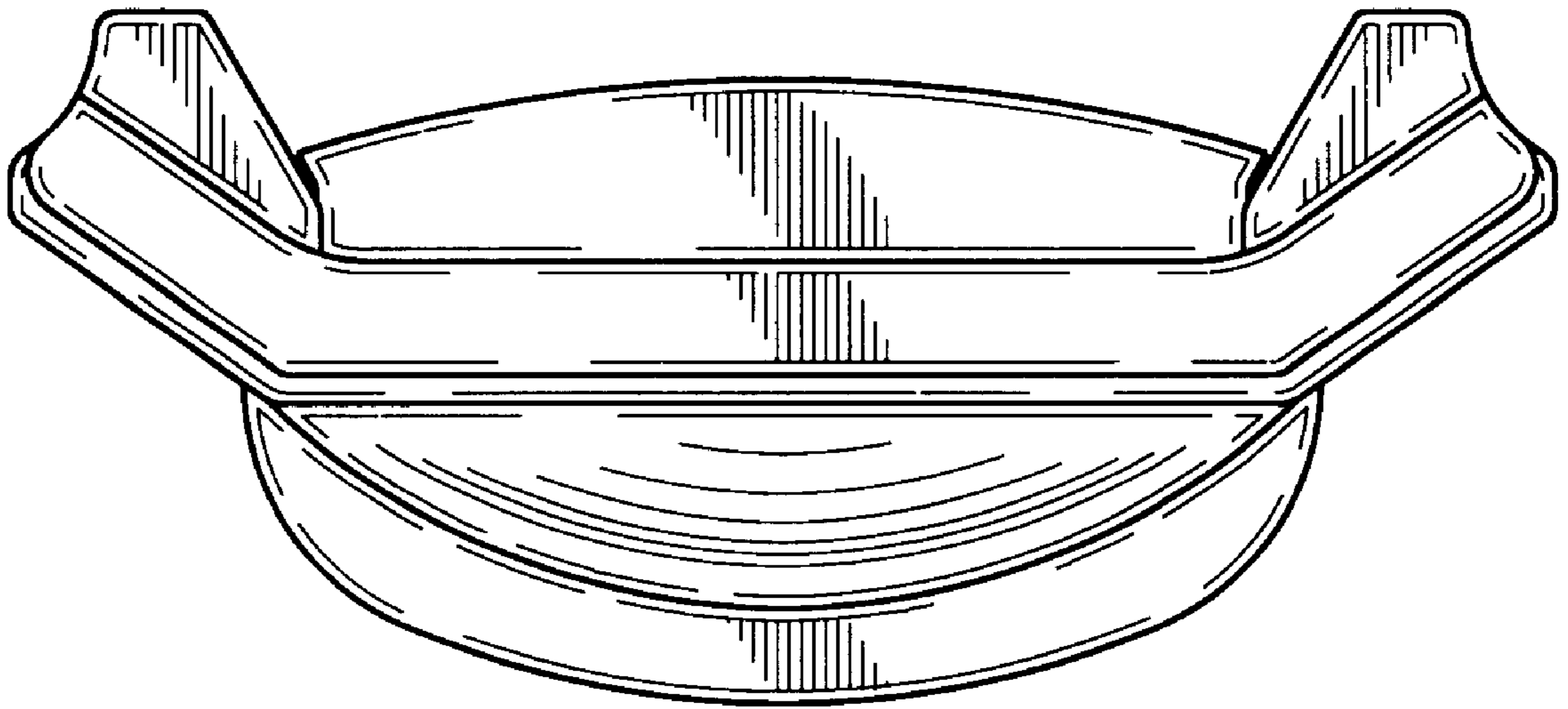

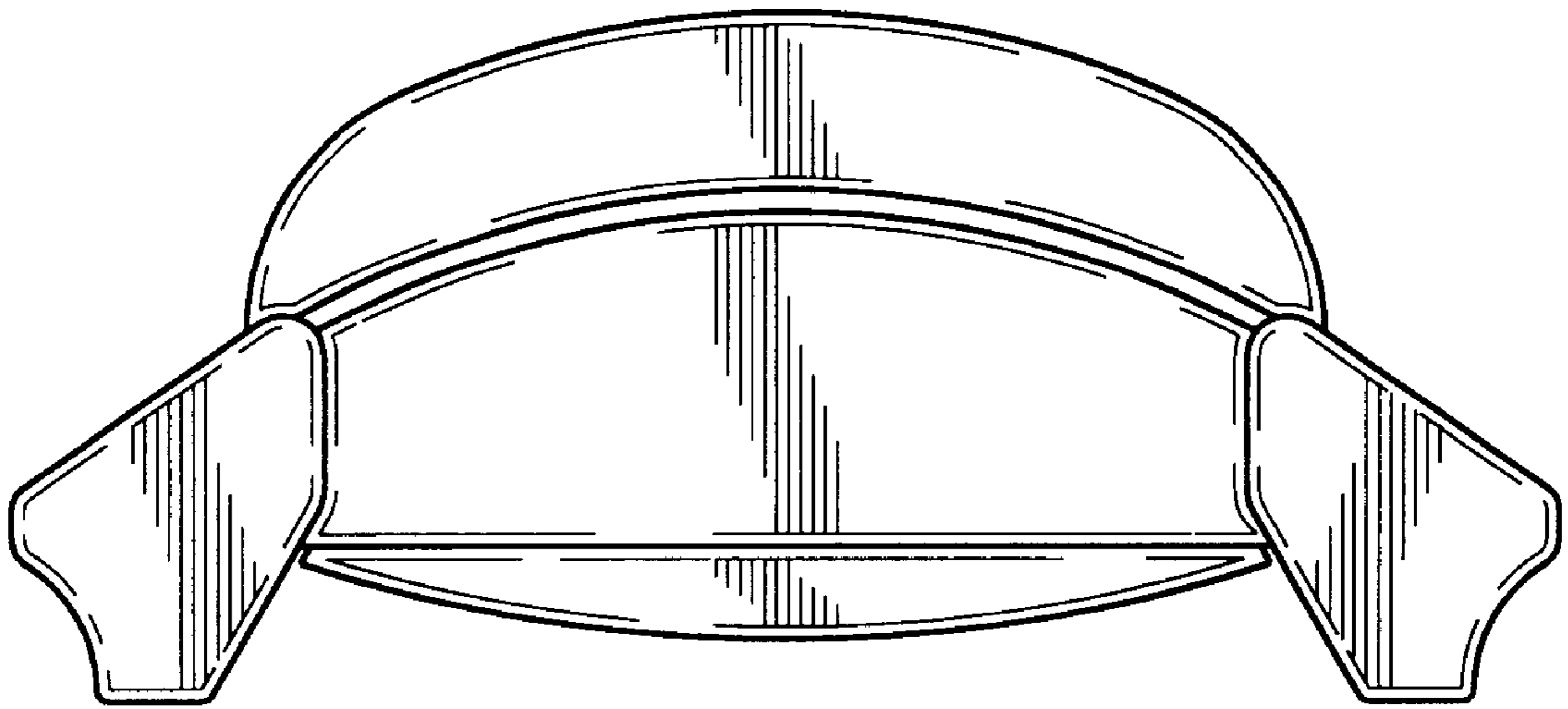

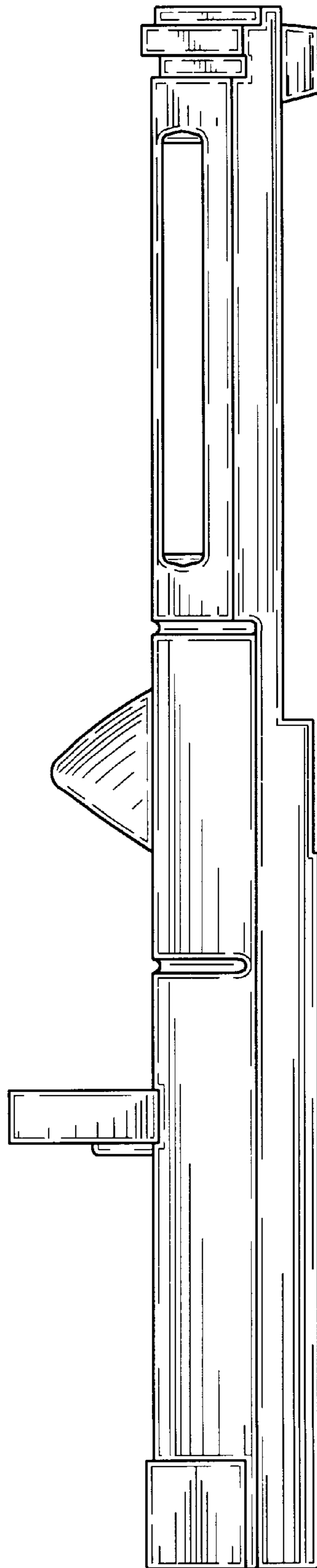

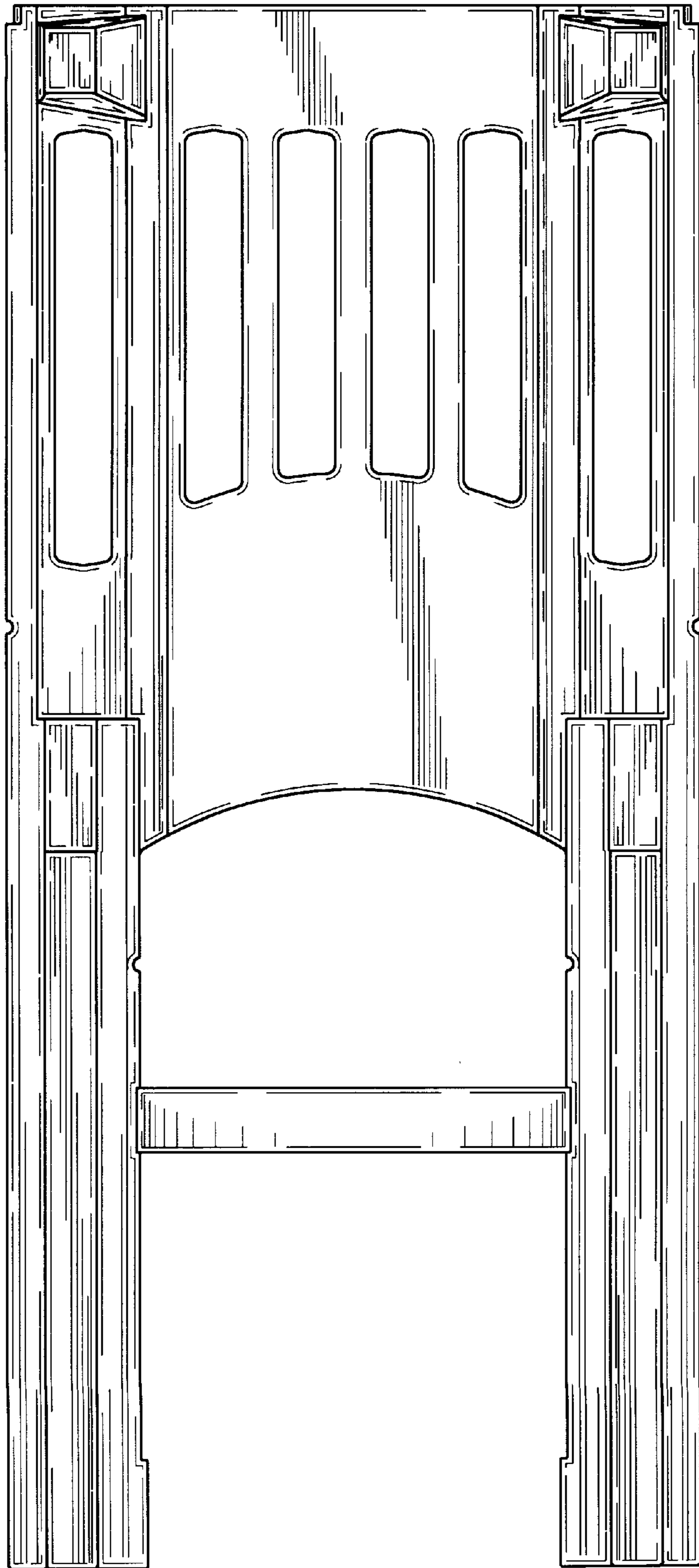
