FIG. 5 is an open end view thereof;

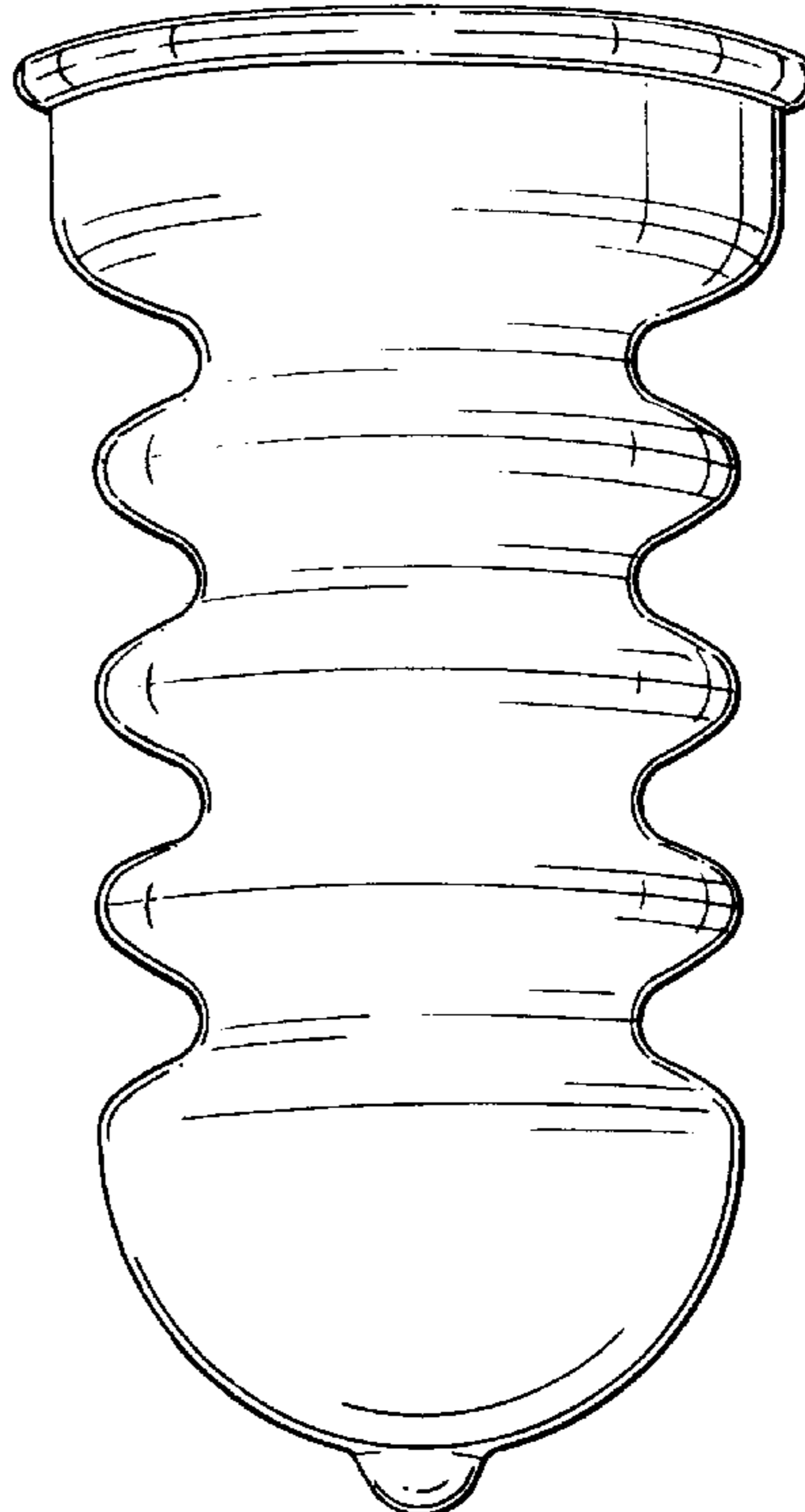
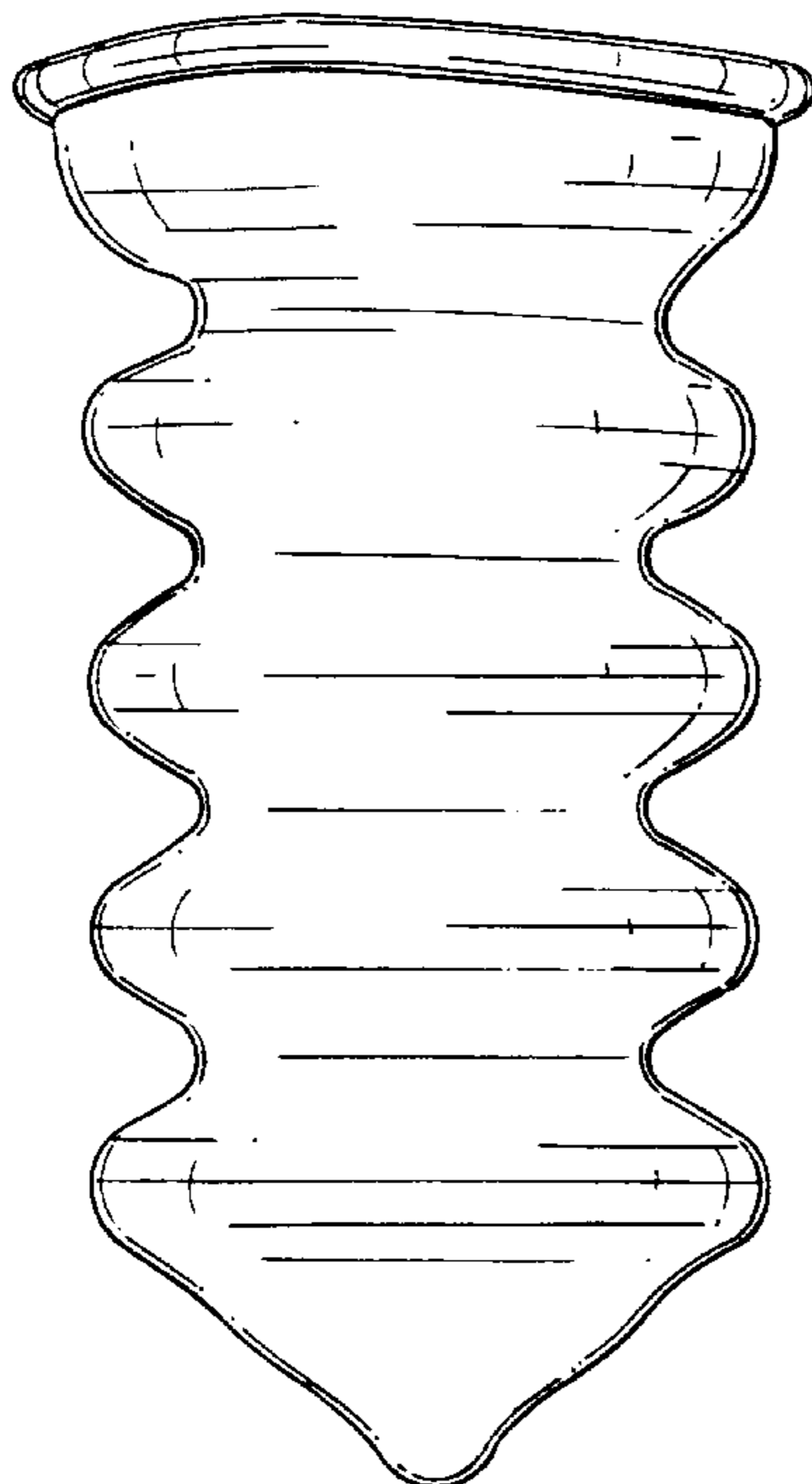
FIG. 6 is a side view in a folded condition of a second embodiment of a condom, showing our new design;

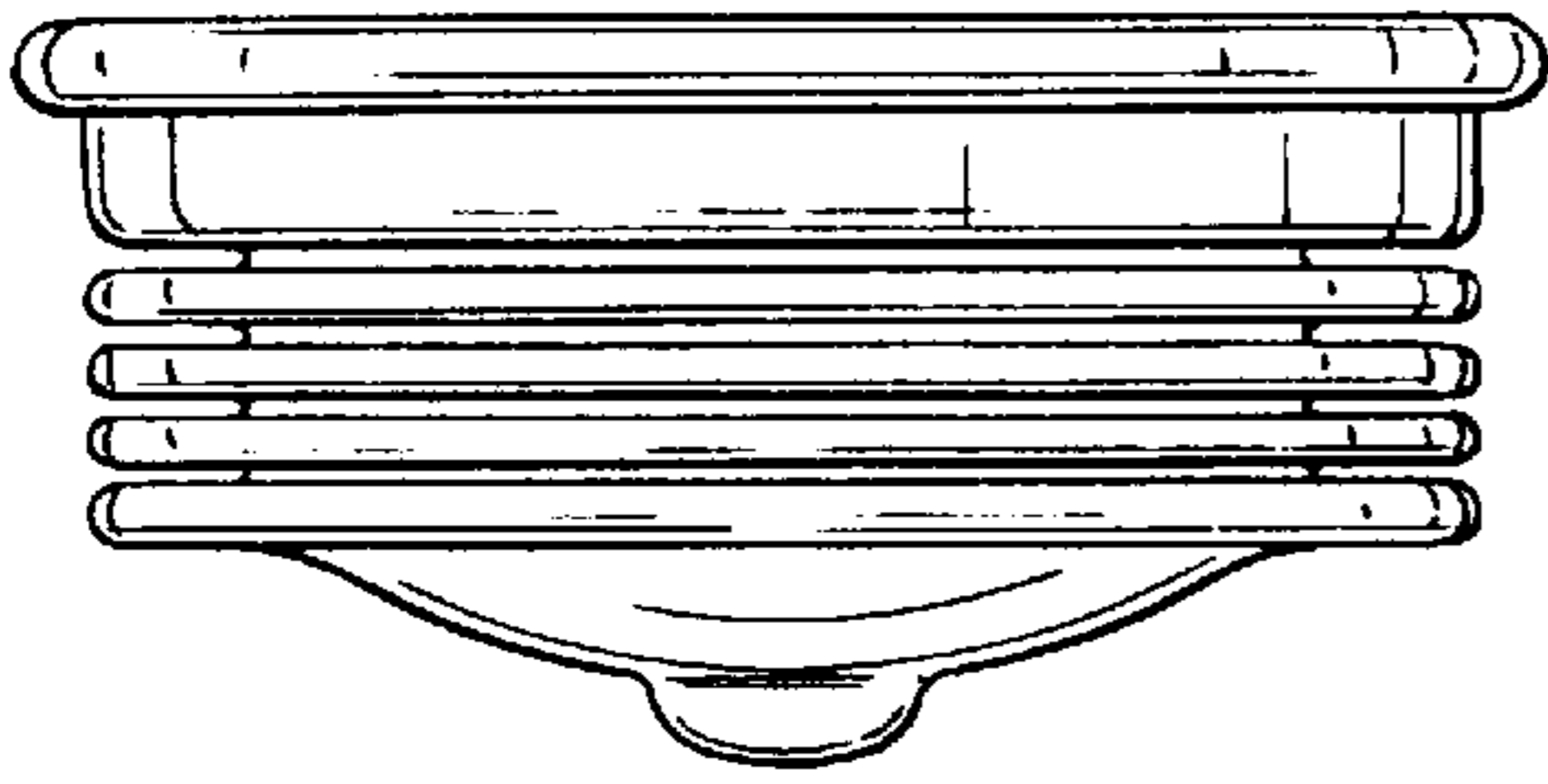

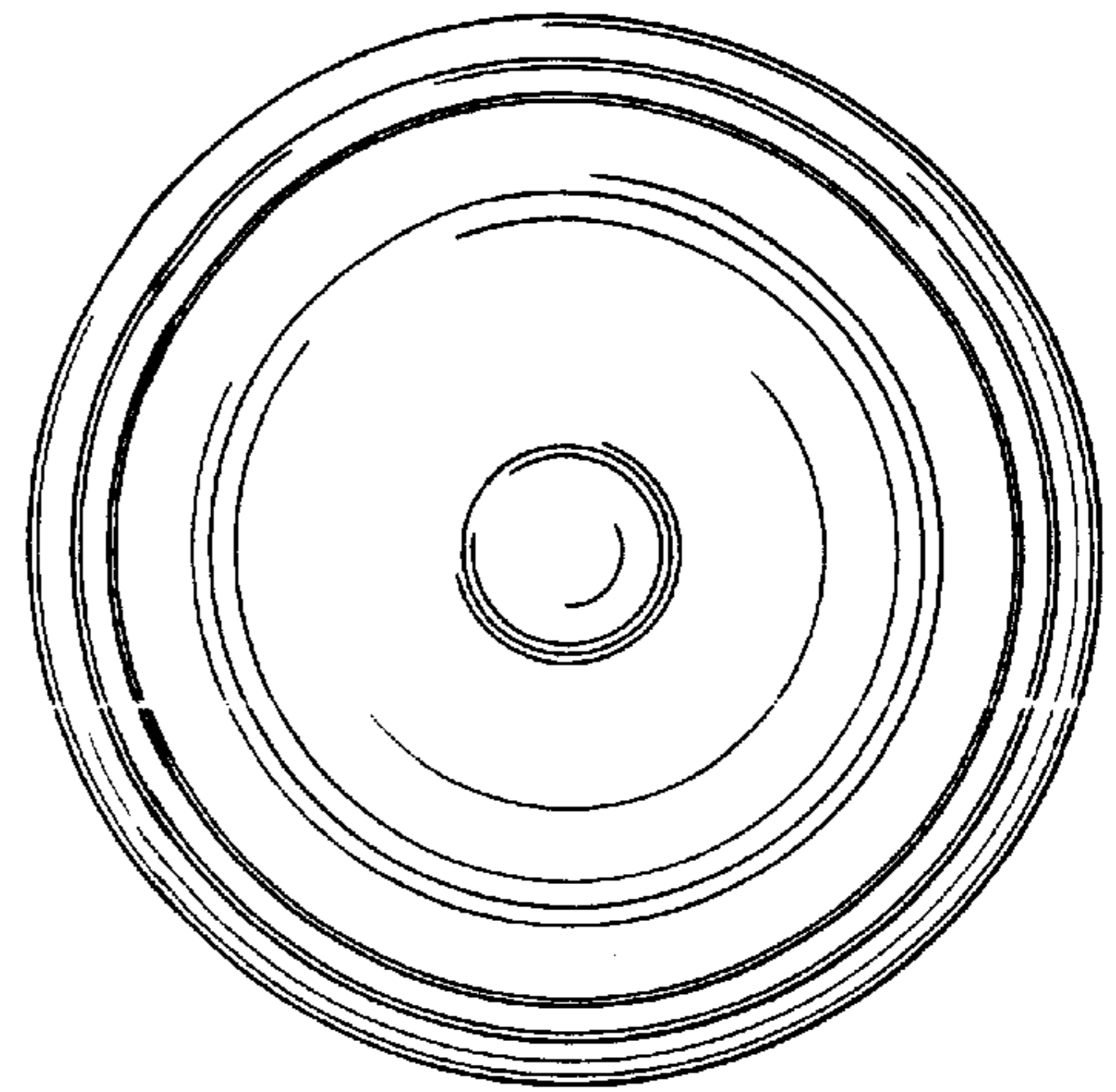

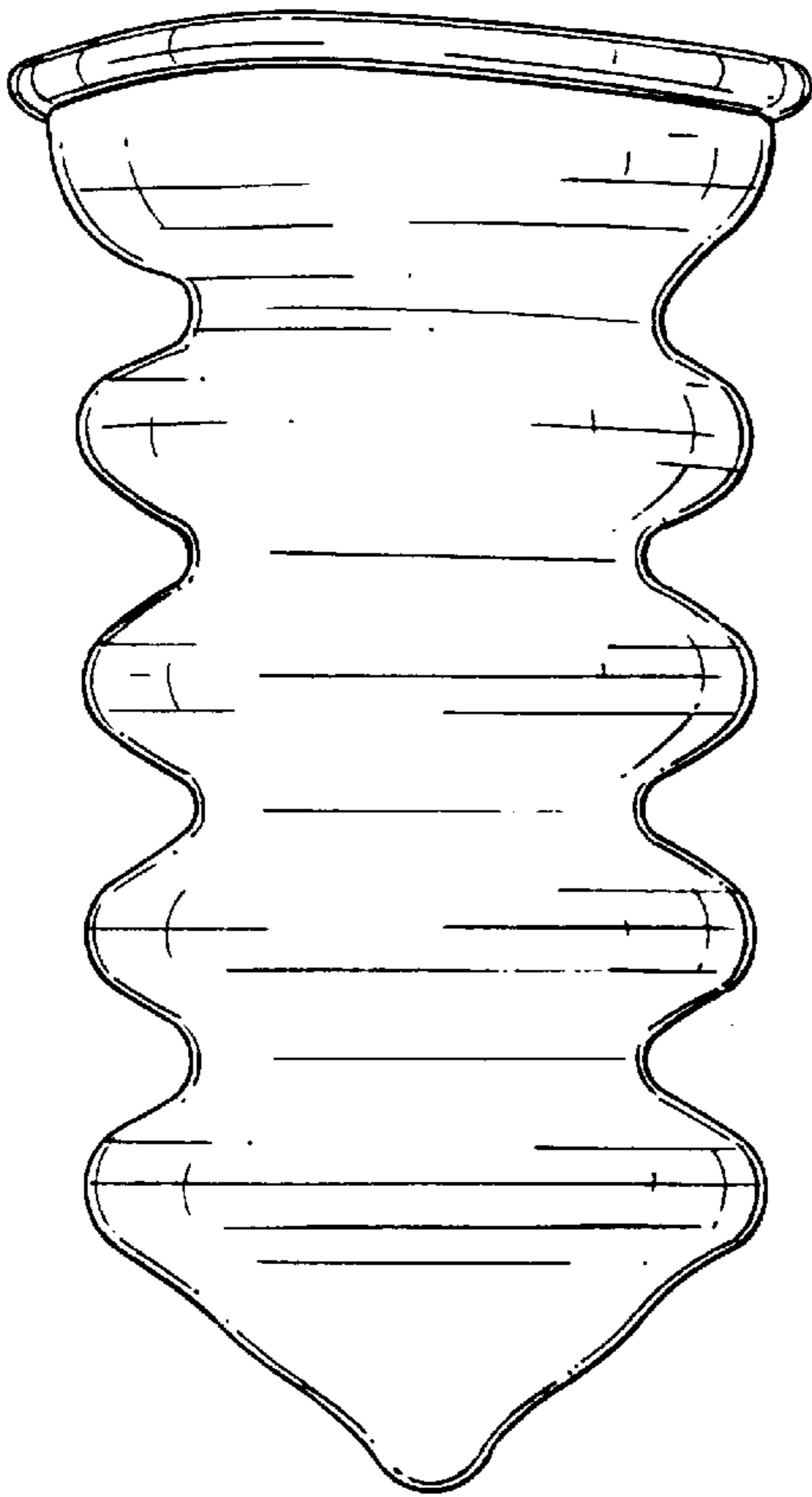

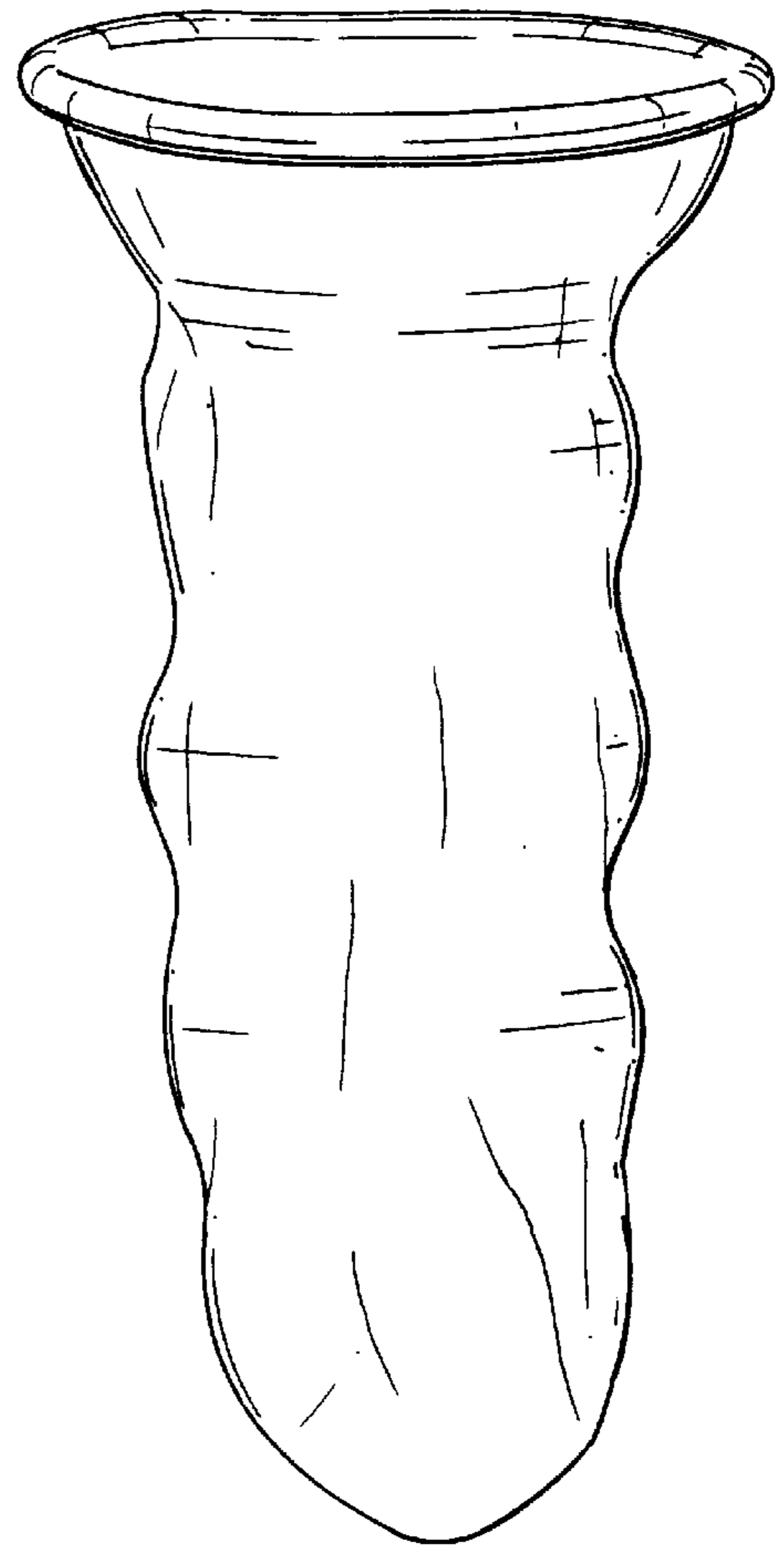

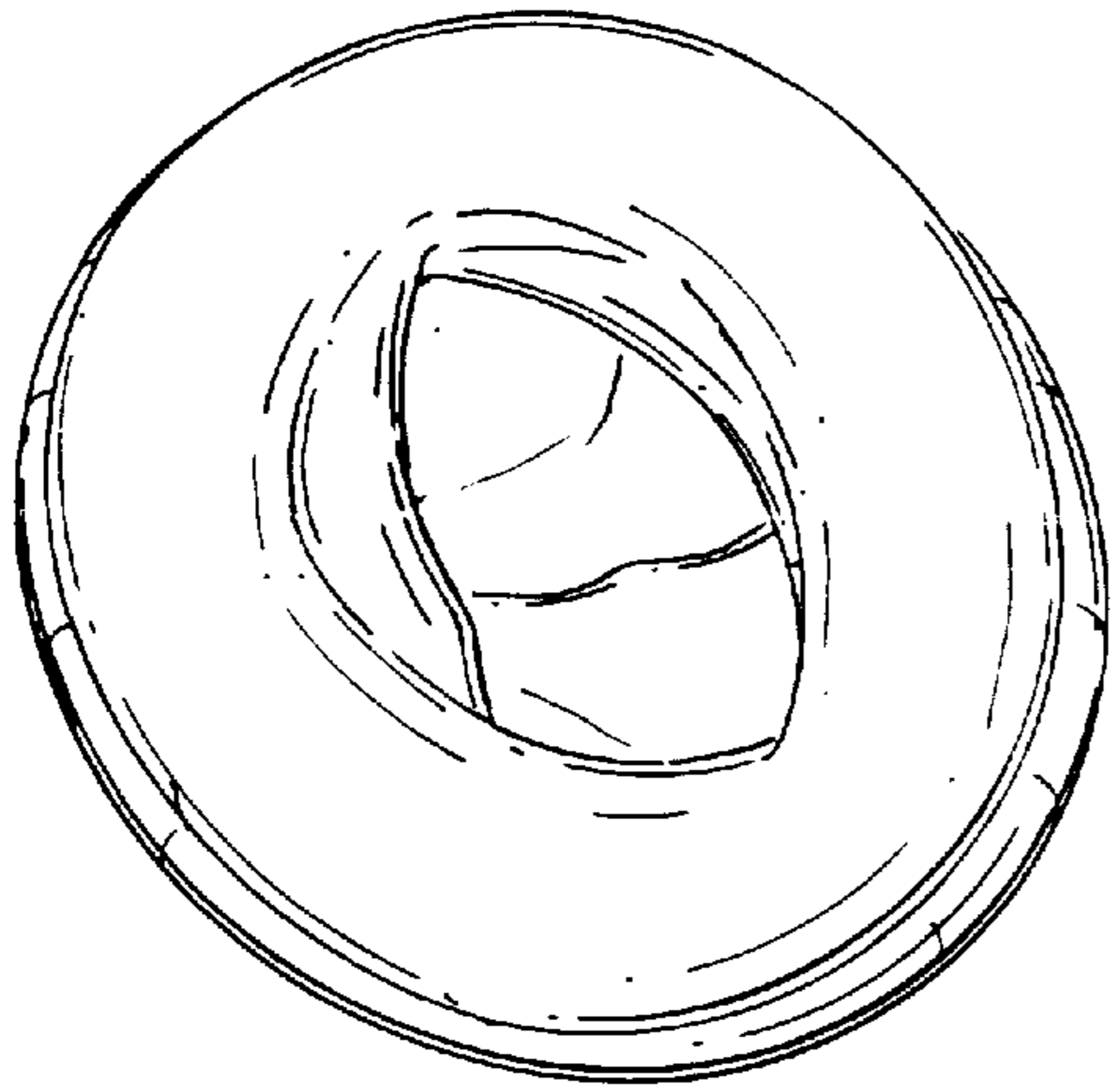

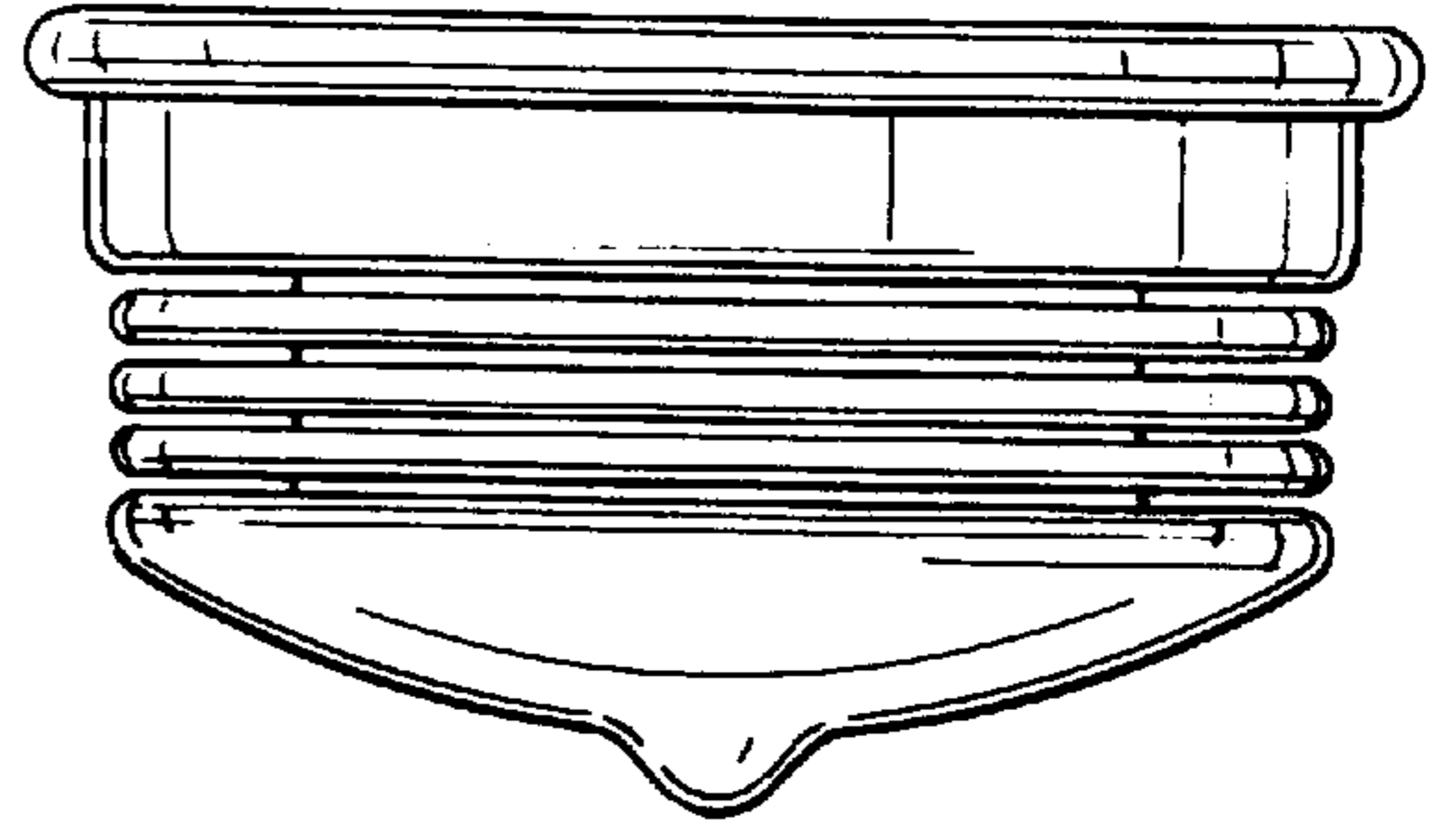

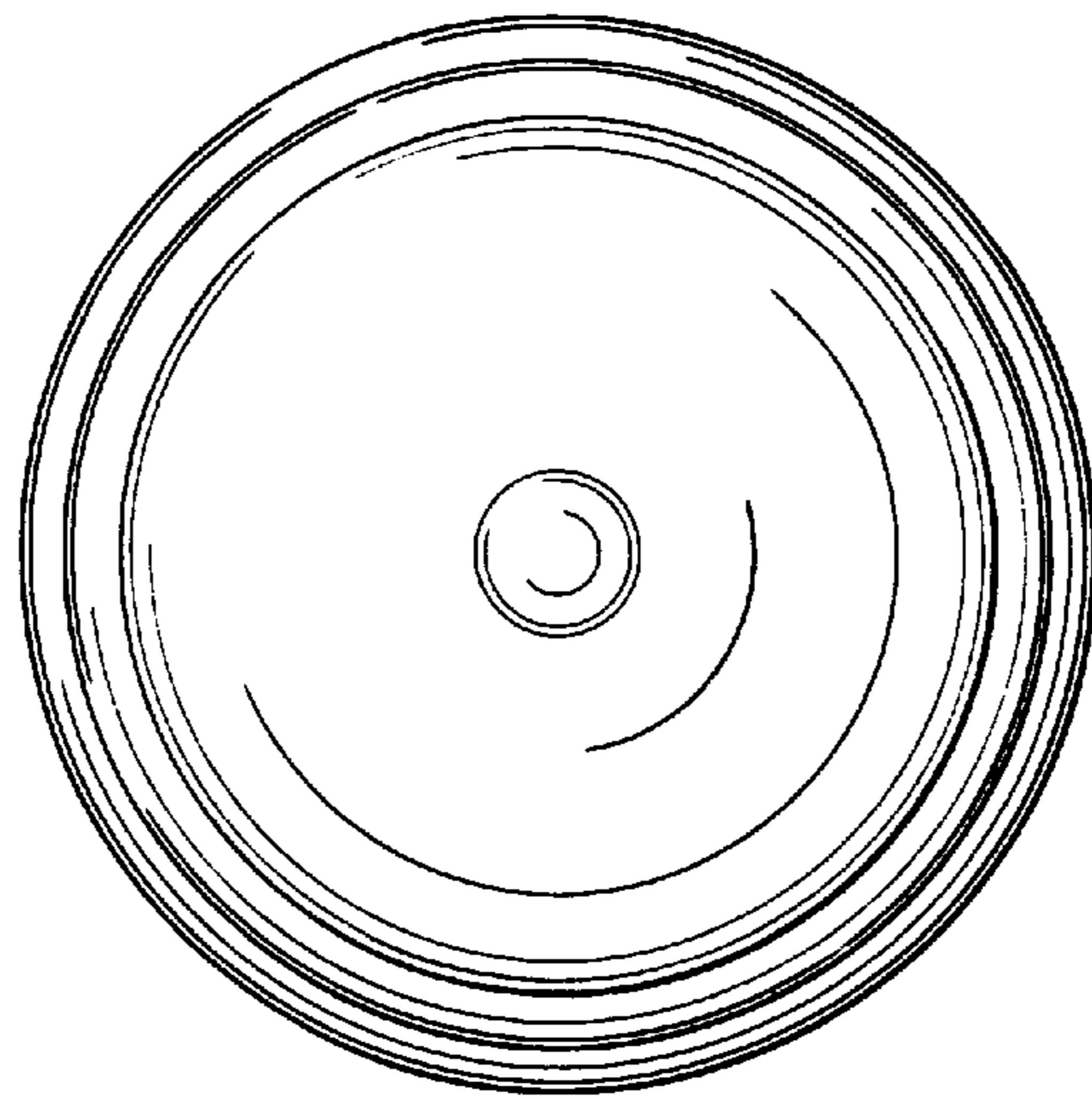

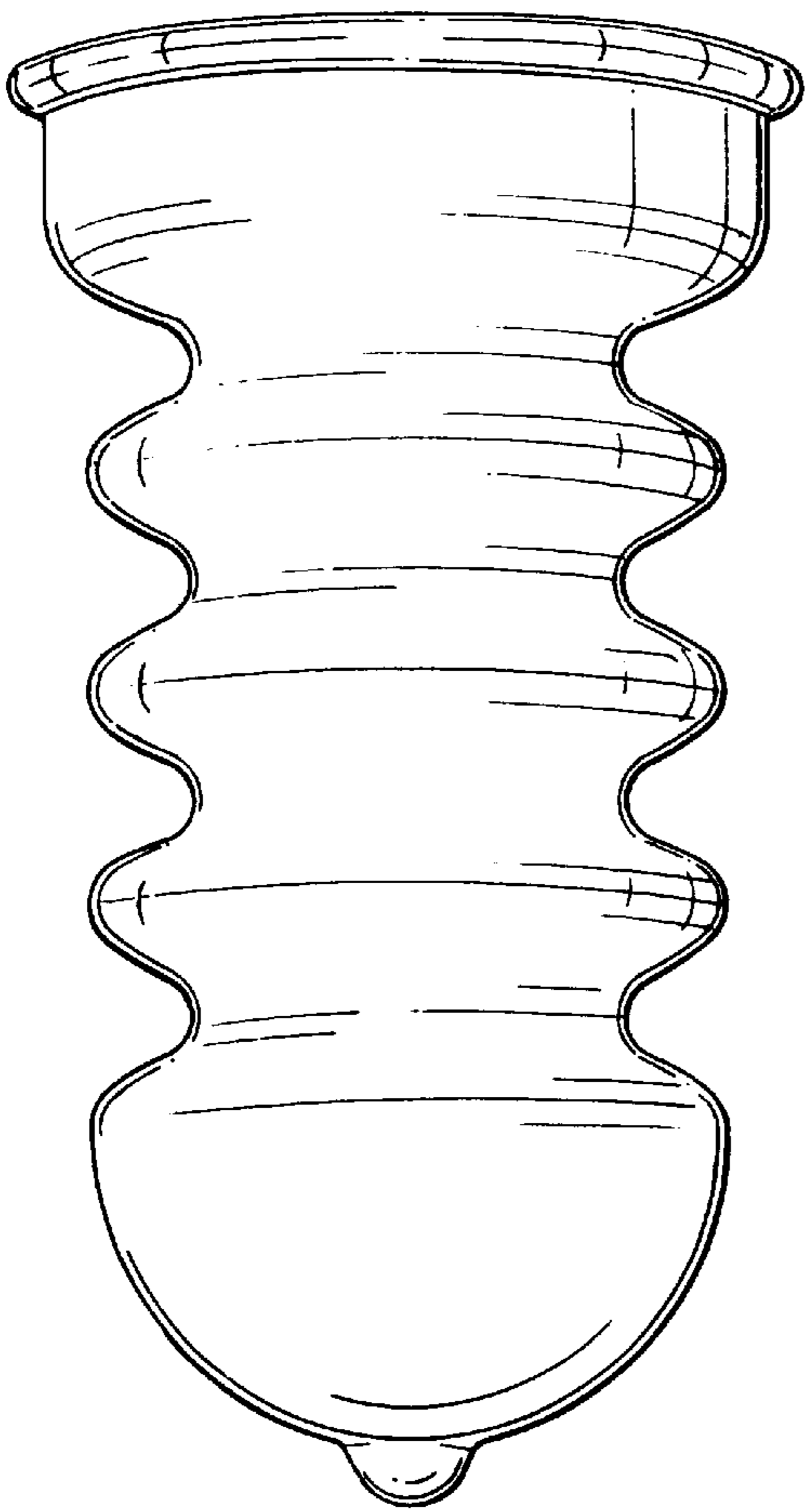

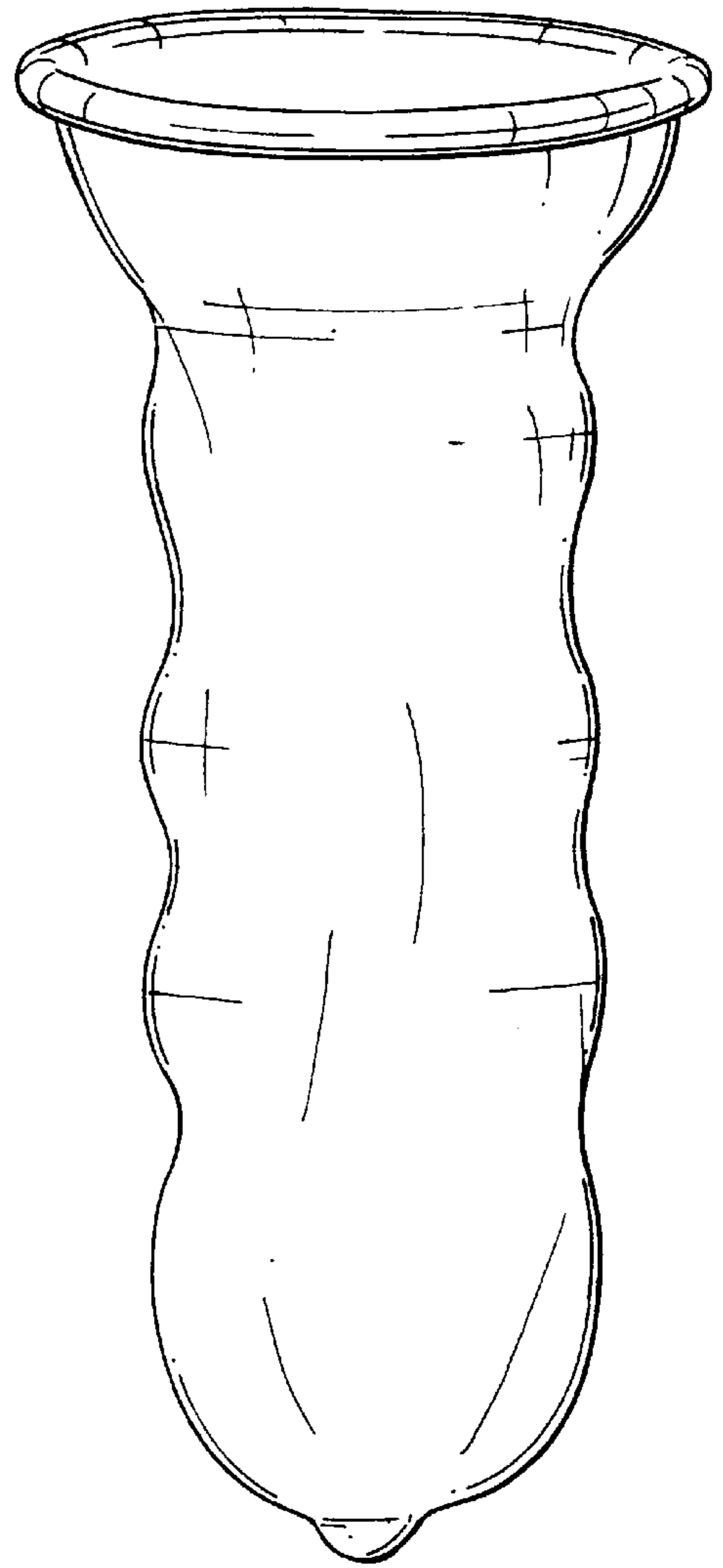
