[57] **CLAIM**

I claim the ornamental design for a receptacle for rolled tobacco products and cuttings/ashes therefrom, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing my design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a left side elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof. The broken line drawing of the lighter receptacle in FIG. 1 is shown for illustrative purposes only and forms no part of the claimed design.

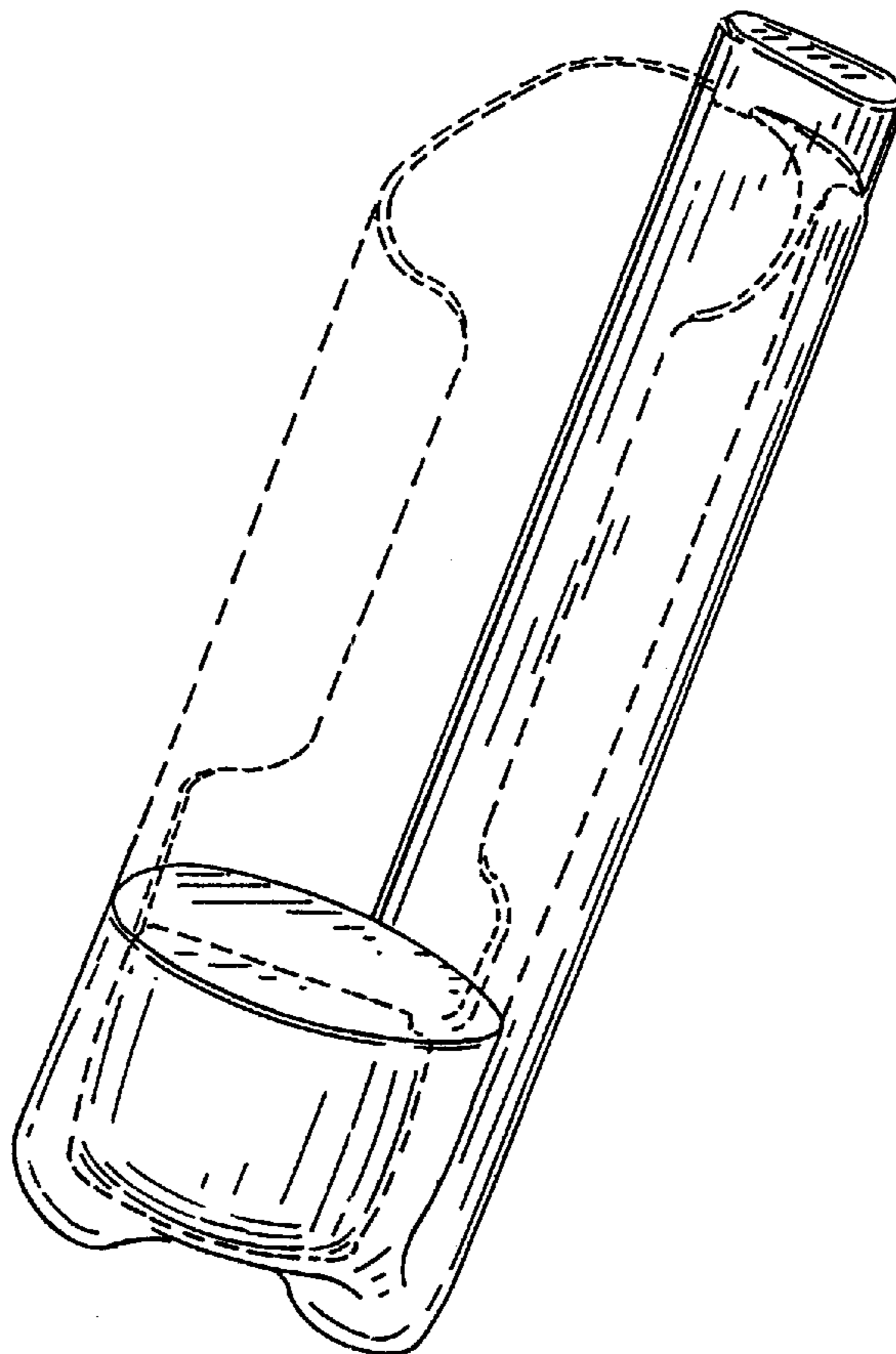

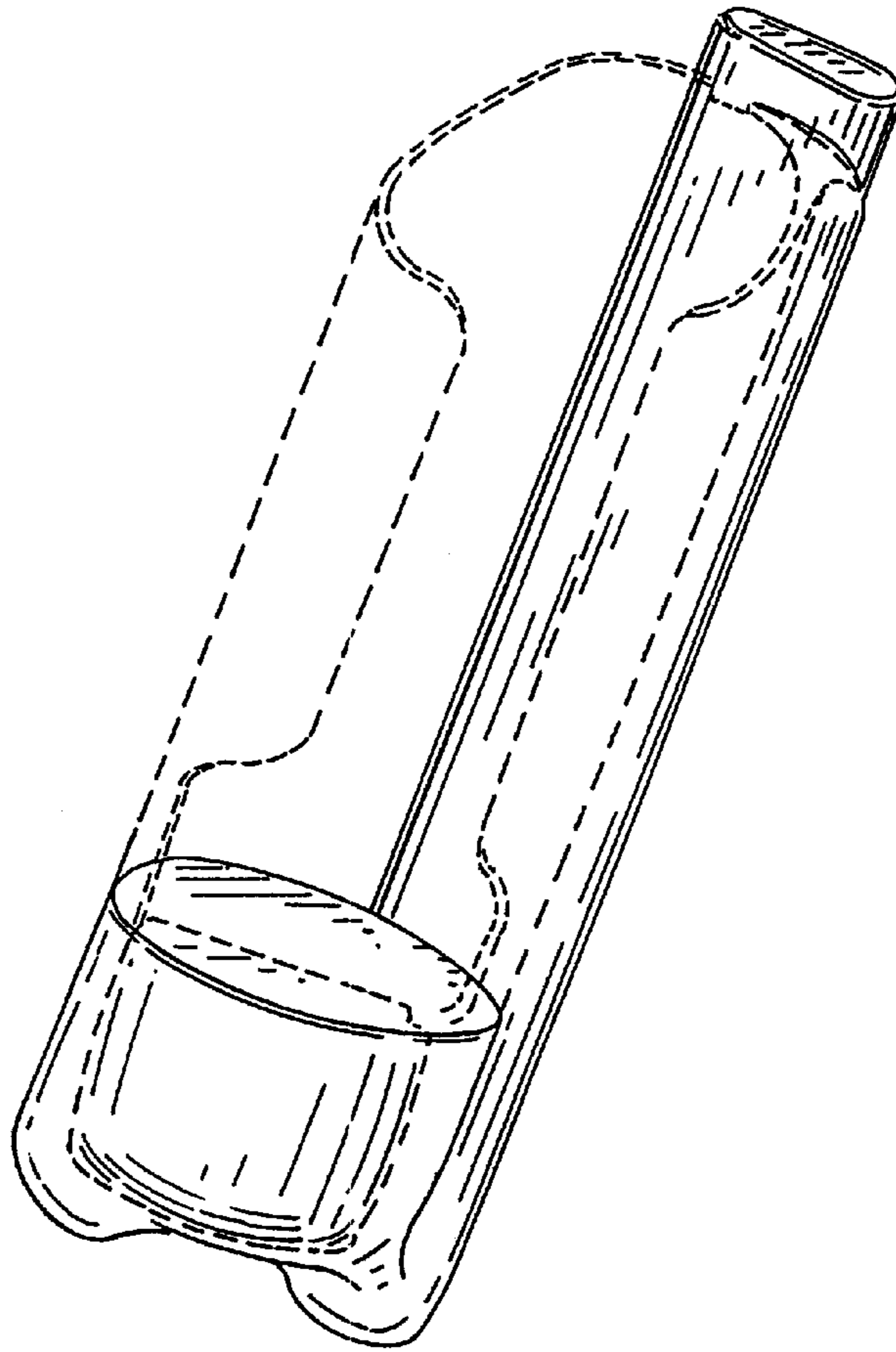
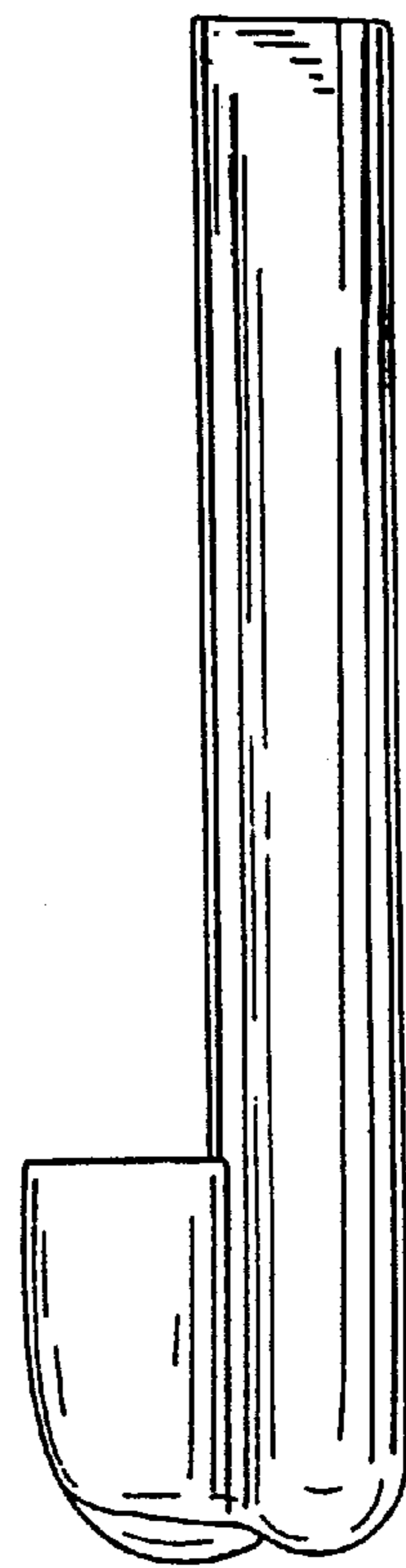

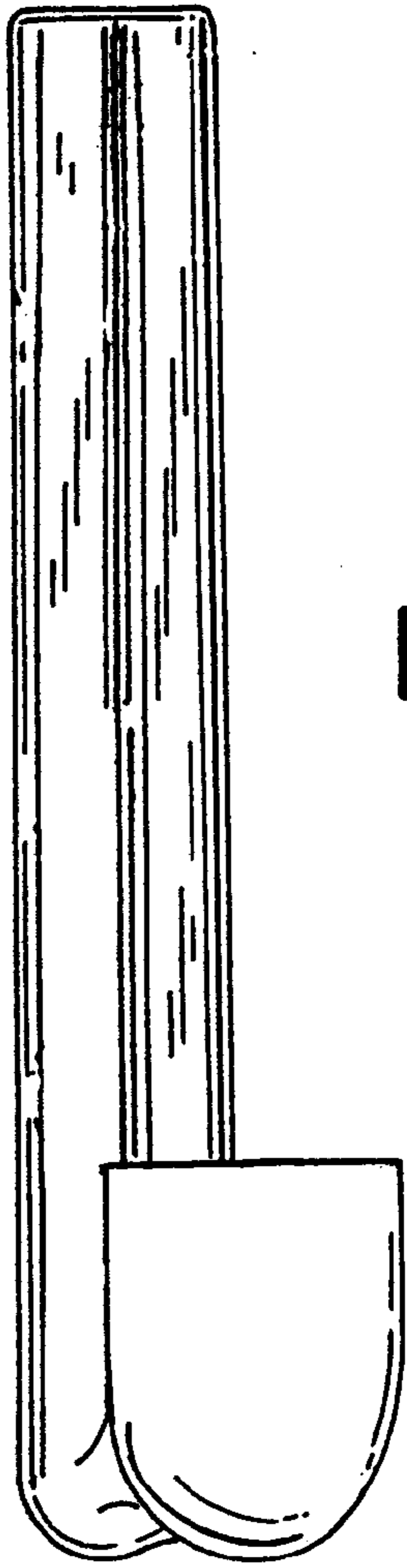

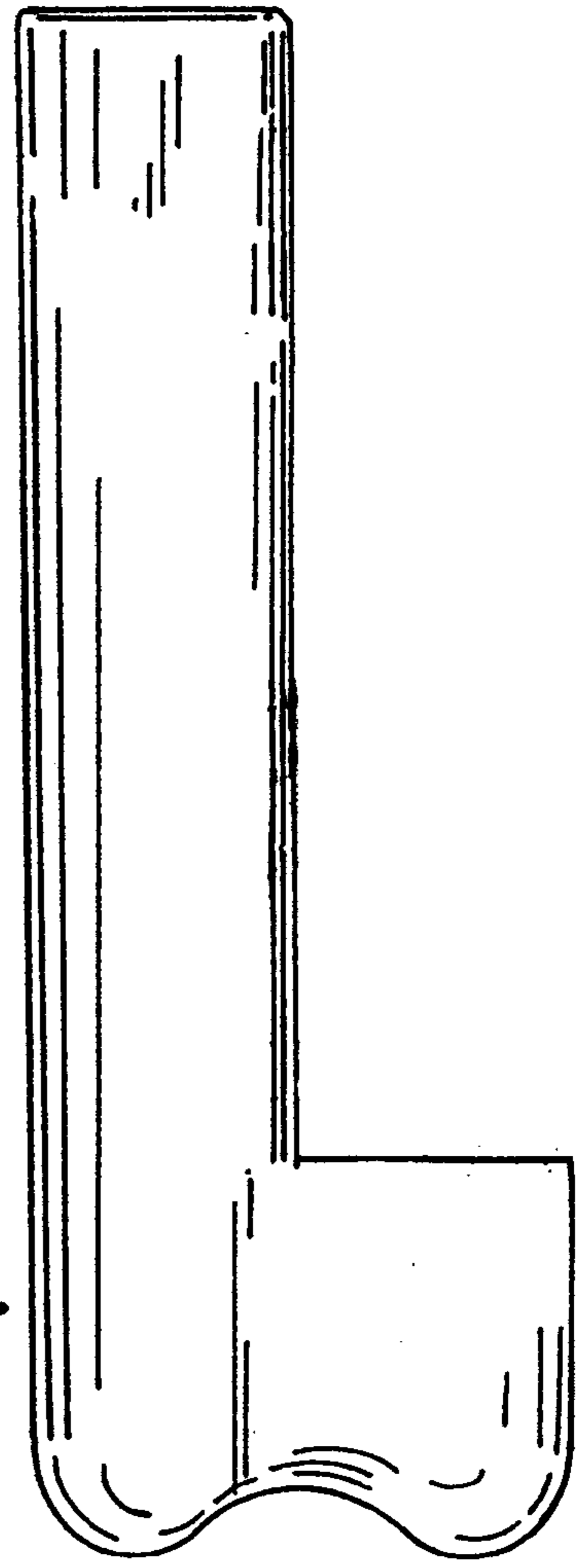

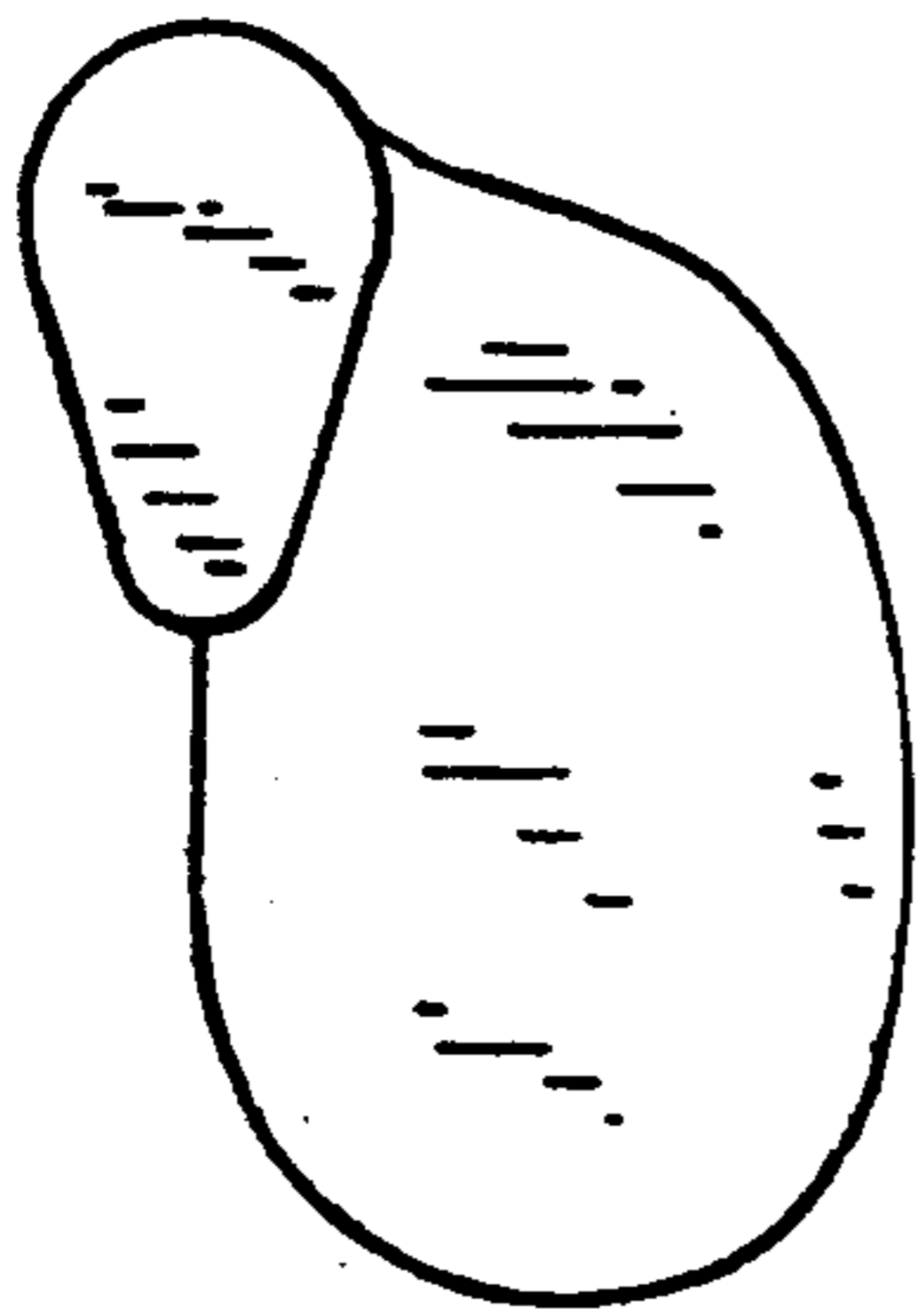

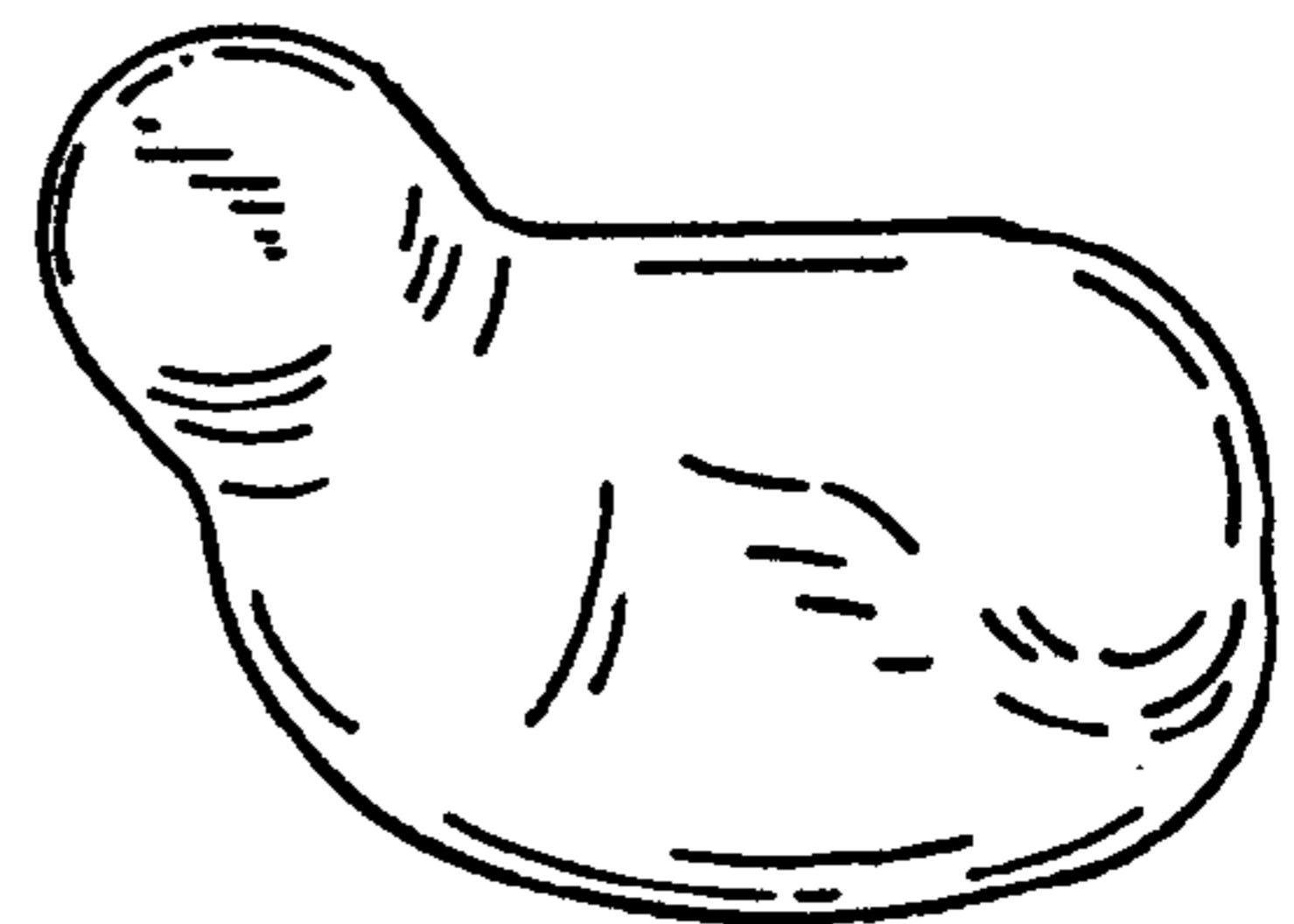
