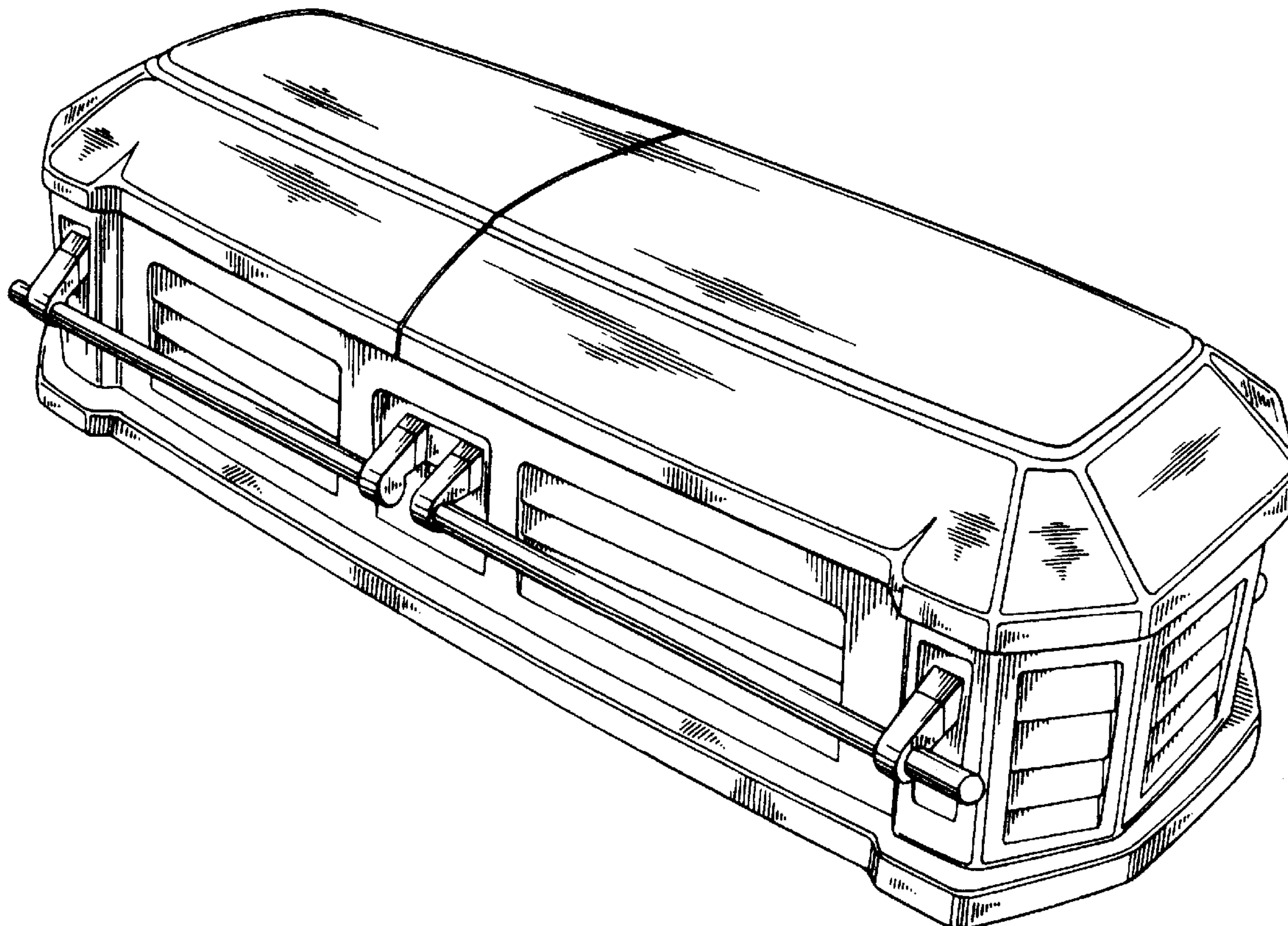
[57] CLAIM

I claim the ornamental design for a casket, as shown.

DESCRIPTION

- FIG. 1 is a front perspective view taken from the right side showing my new design;

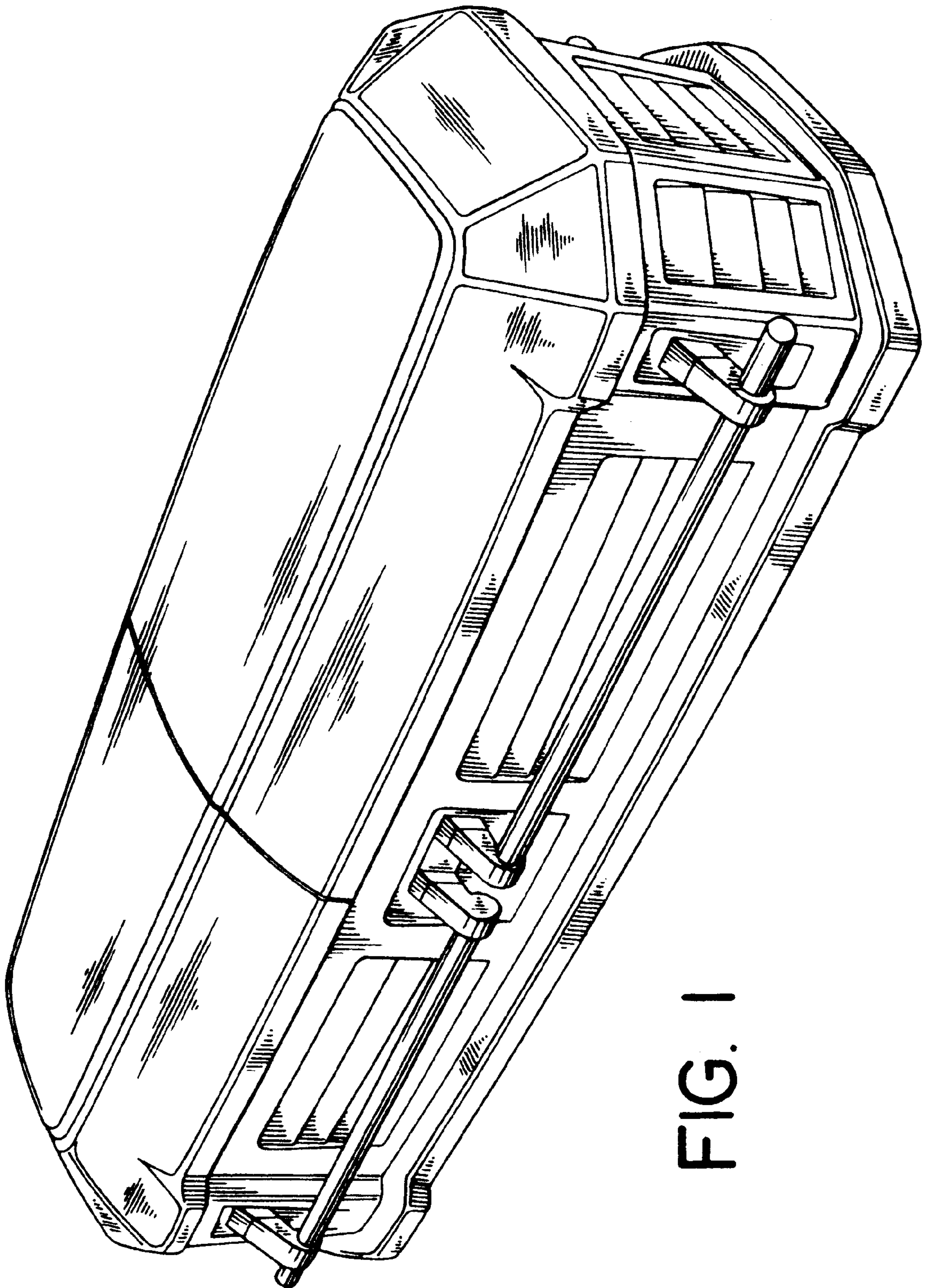

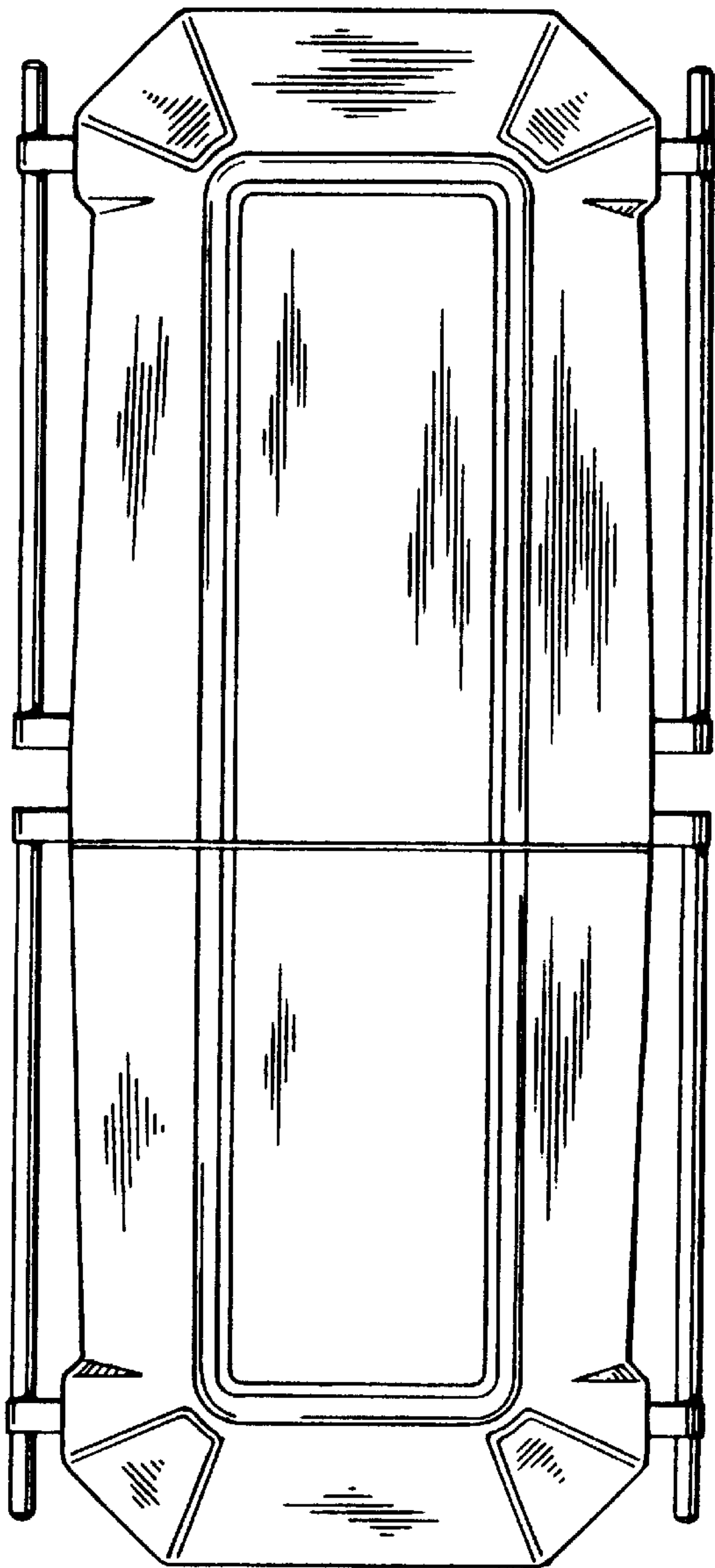
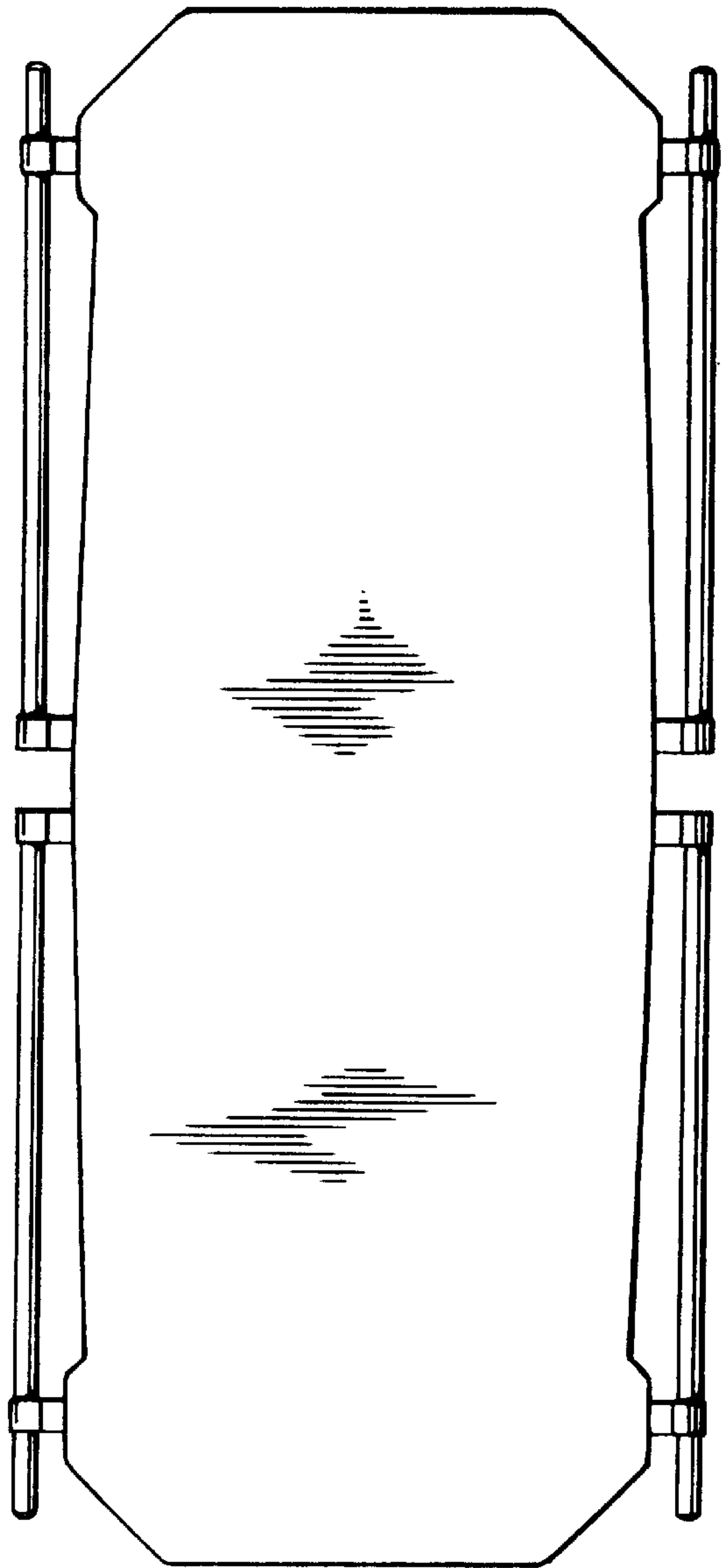

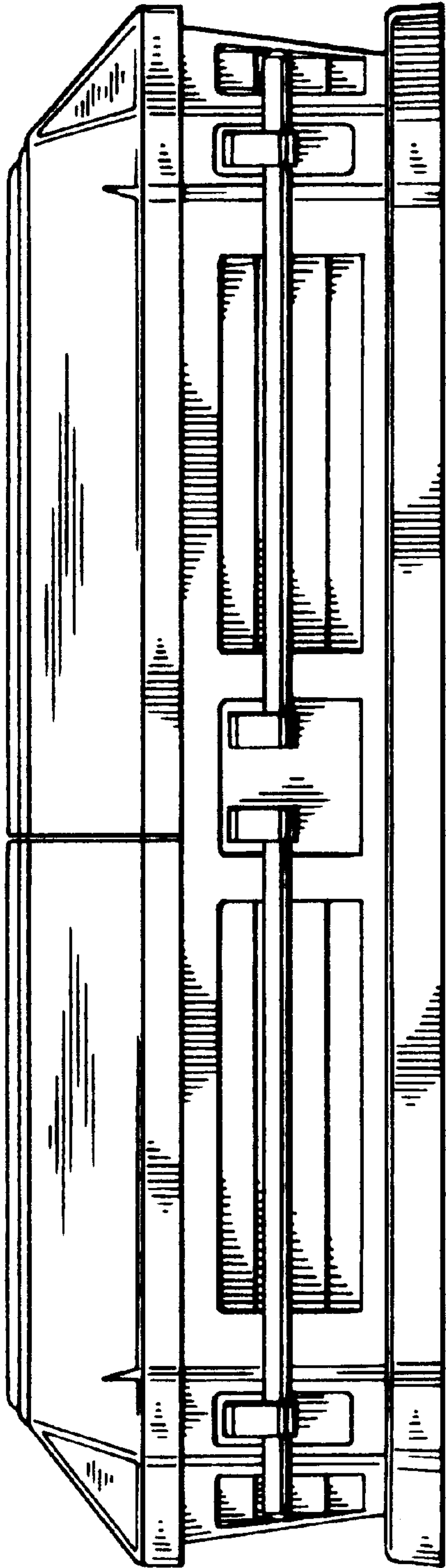

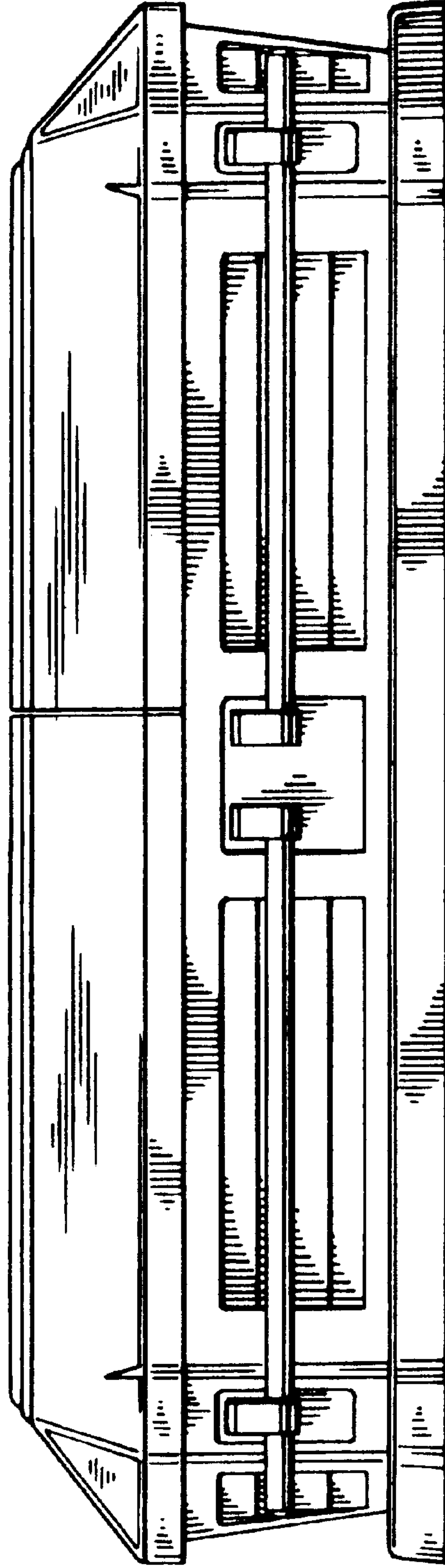

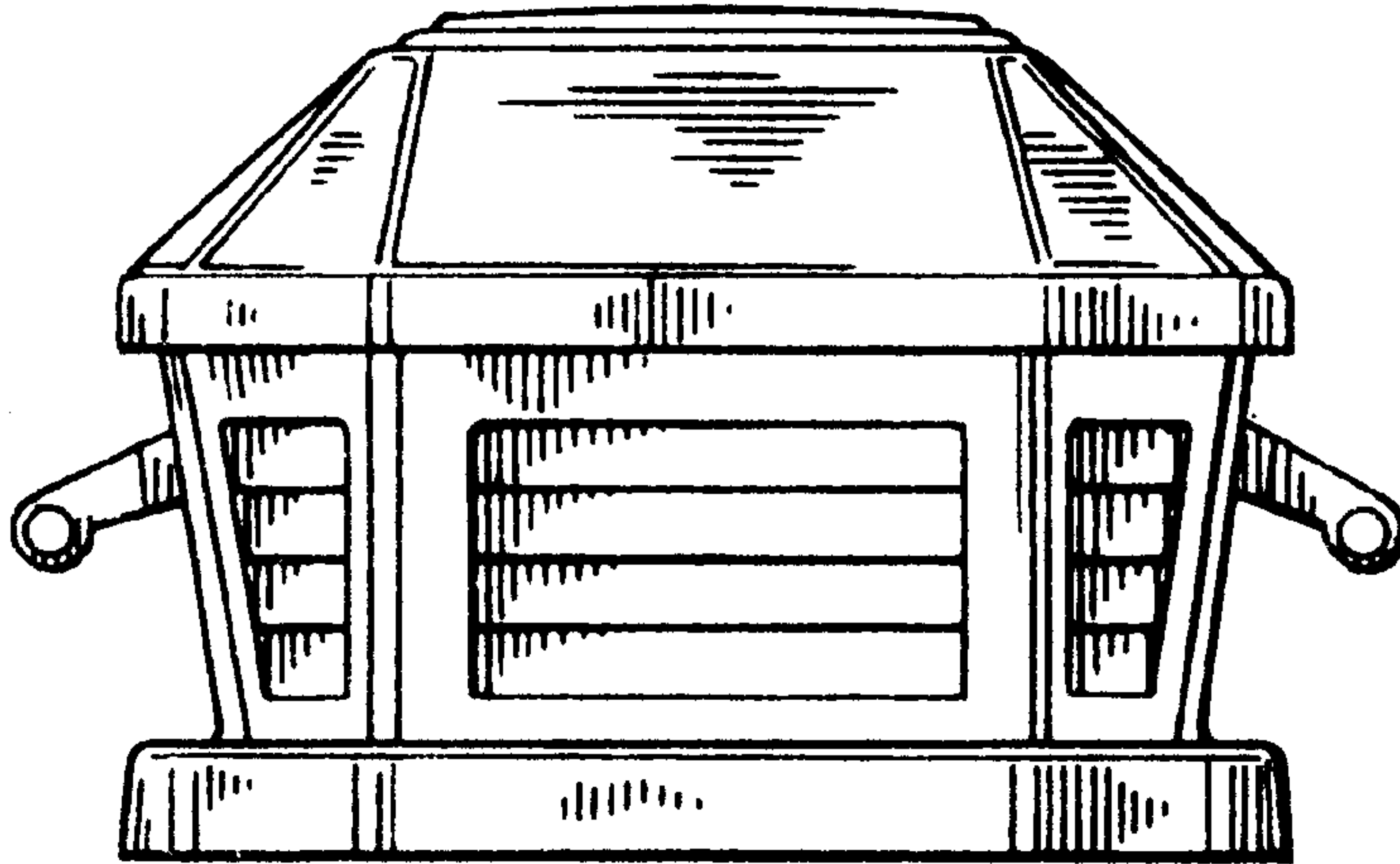

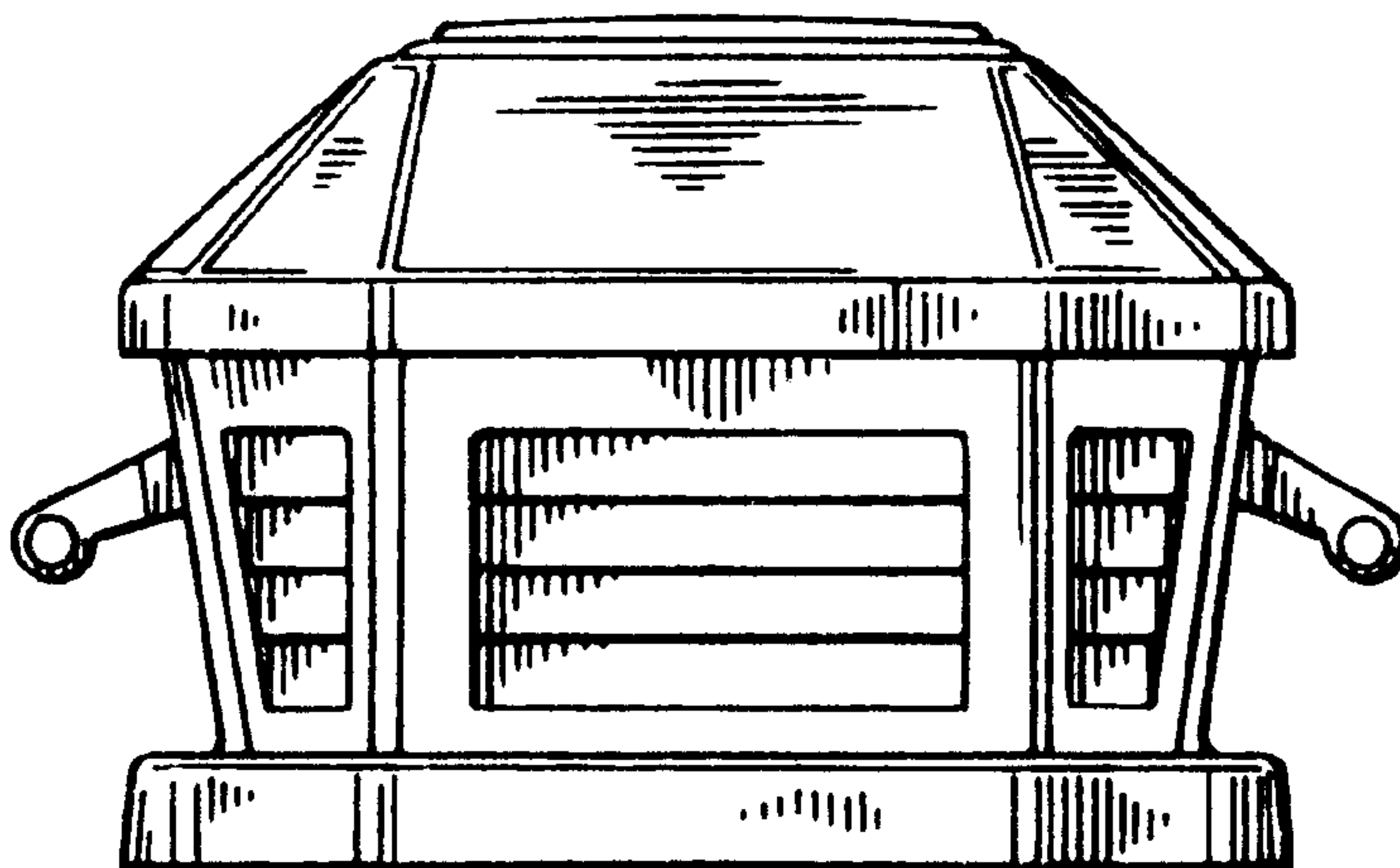
