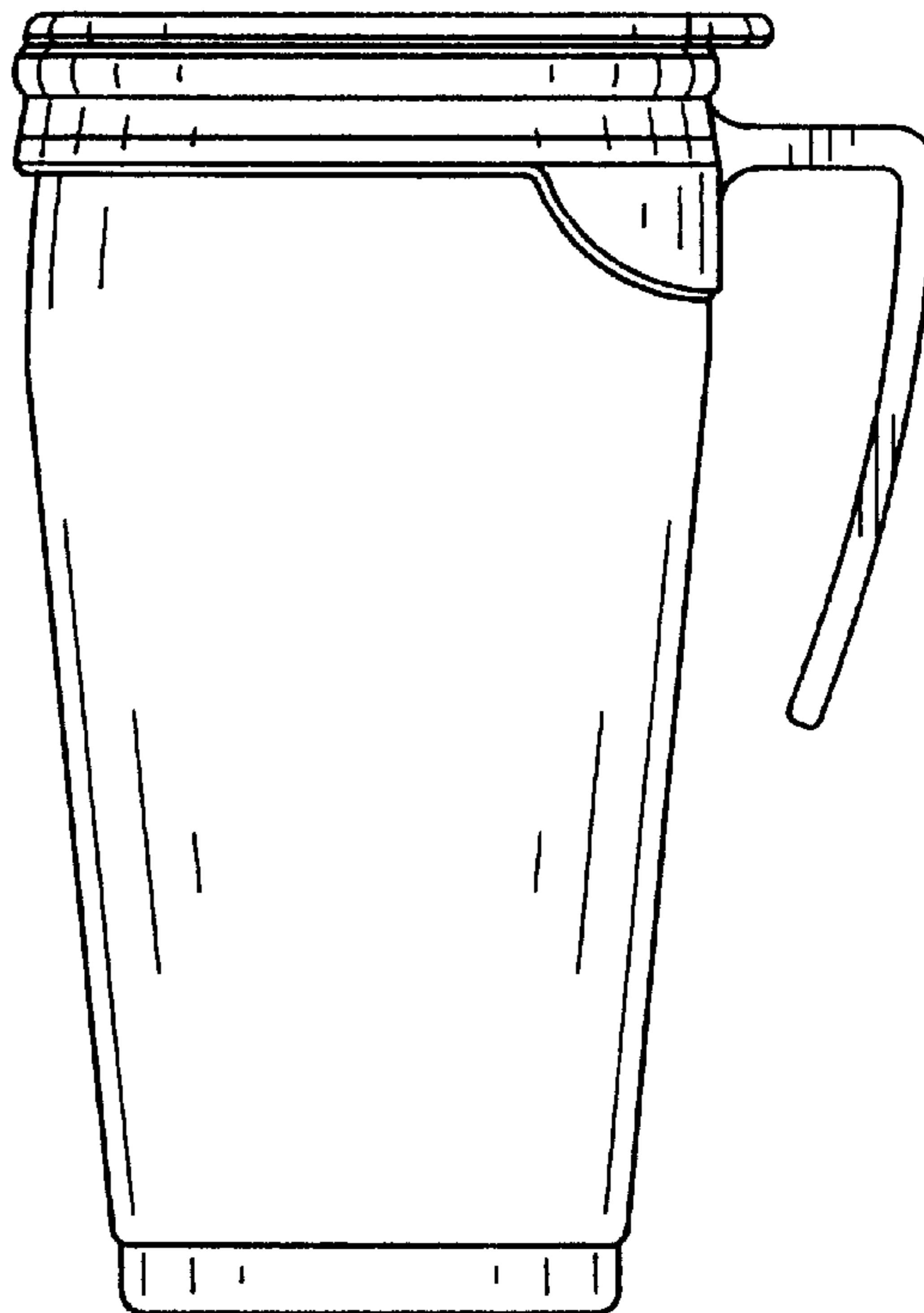
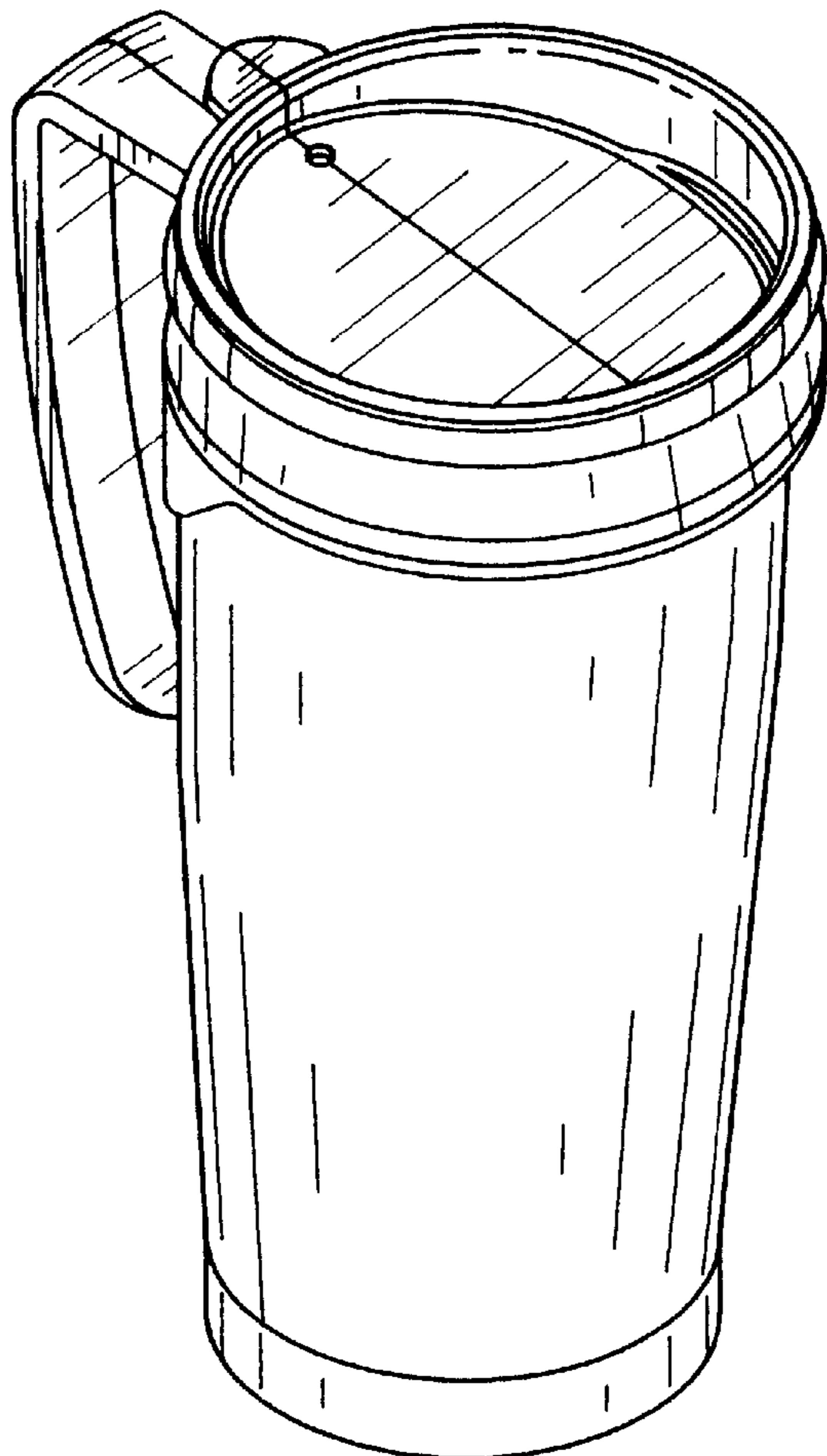
[57] **CLAIM**

The ornamental design for a double mug for use in a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a double mug for use in a vehicle showing my new design;
FIG. 2 is a top plan view thereof;

FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;

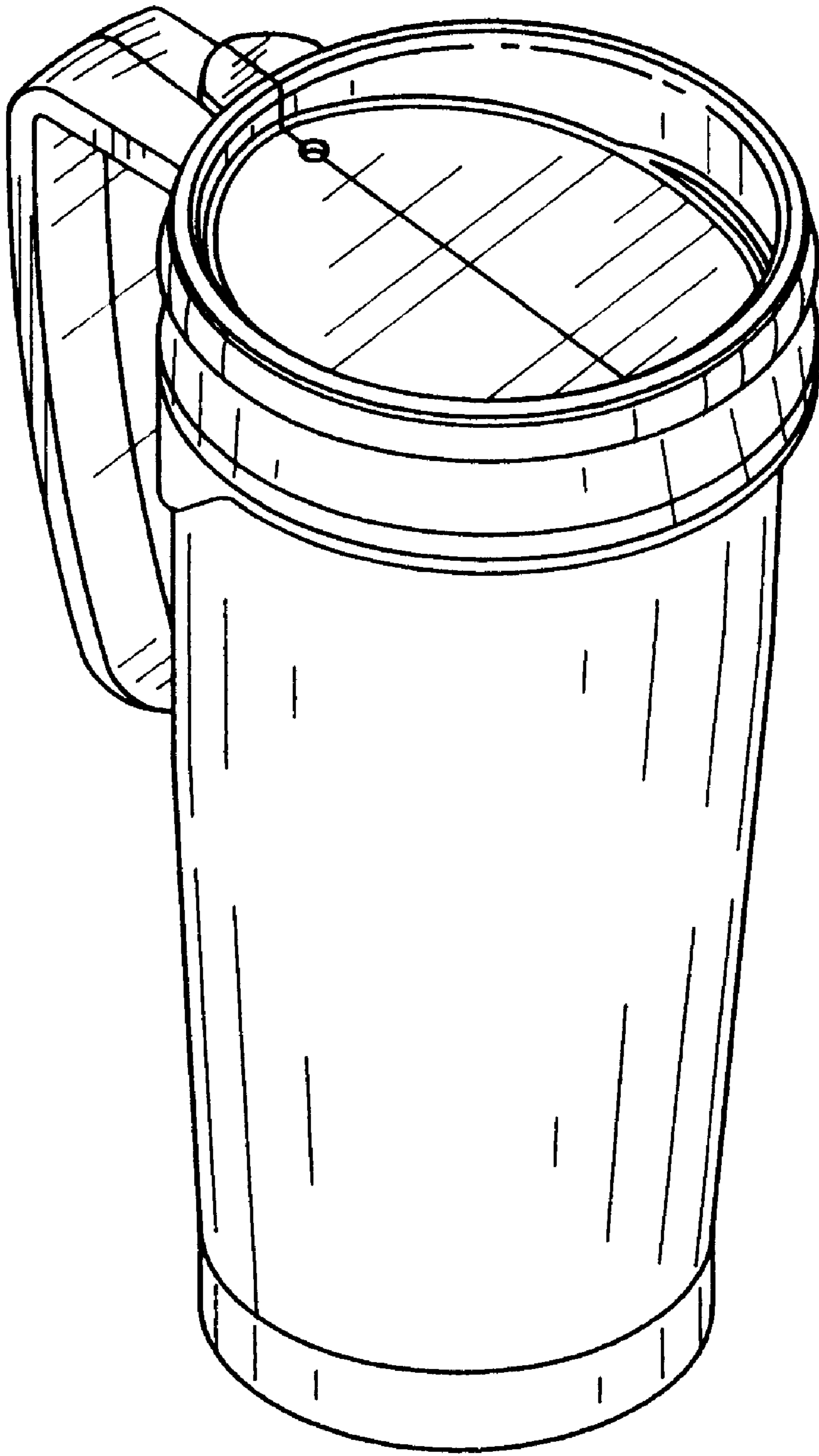

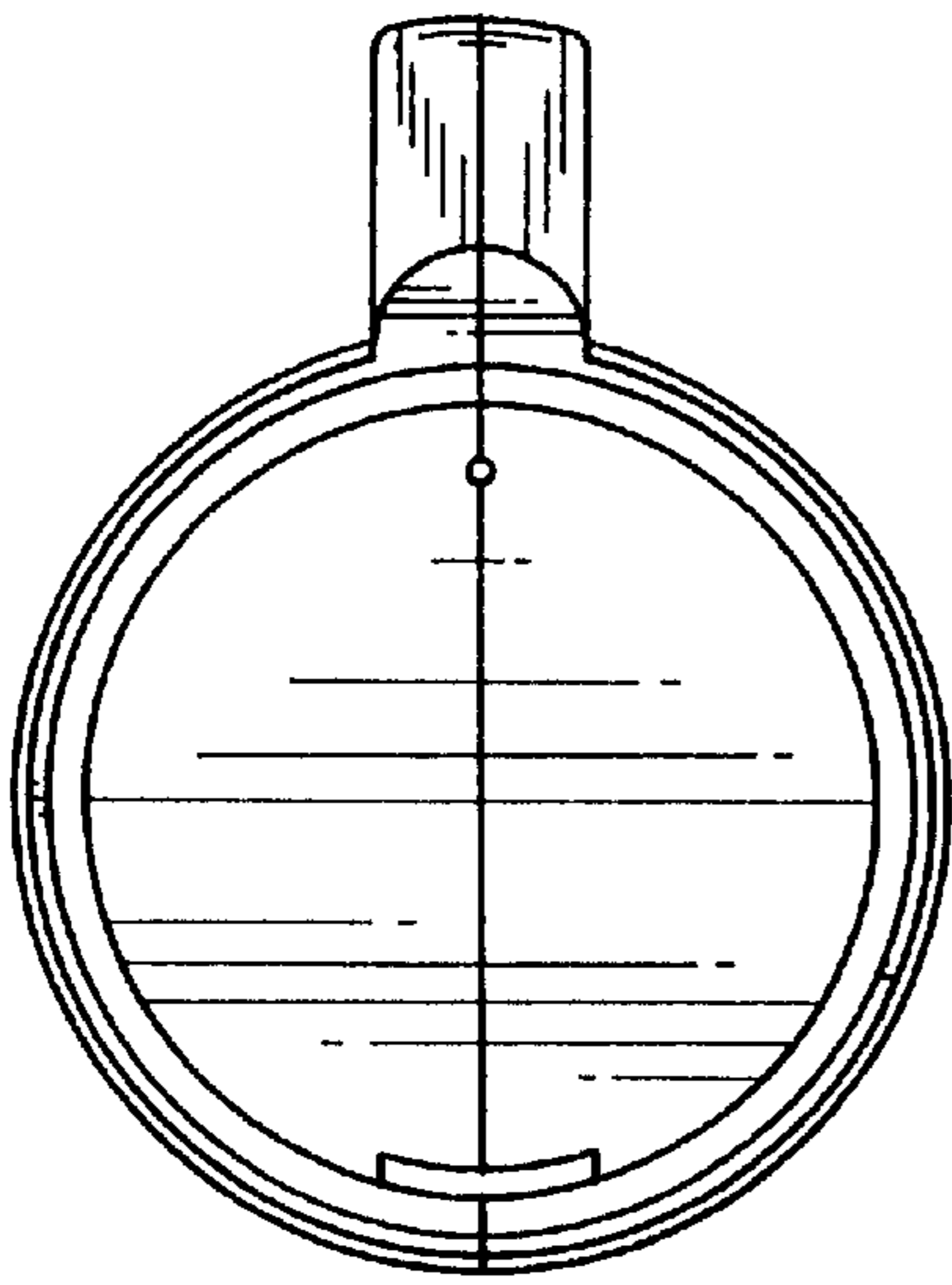

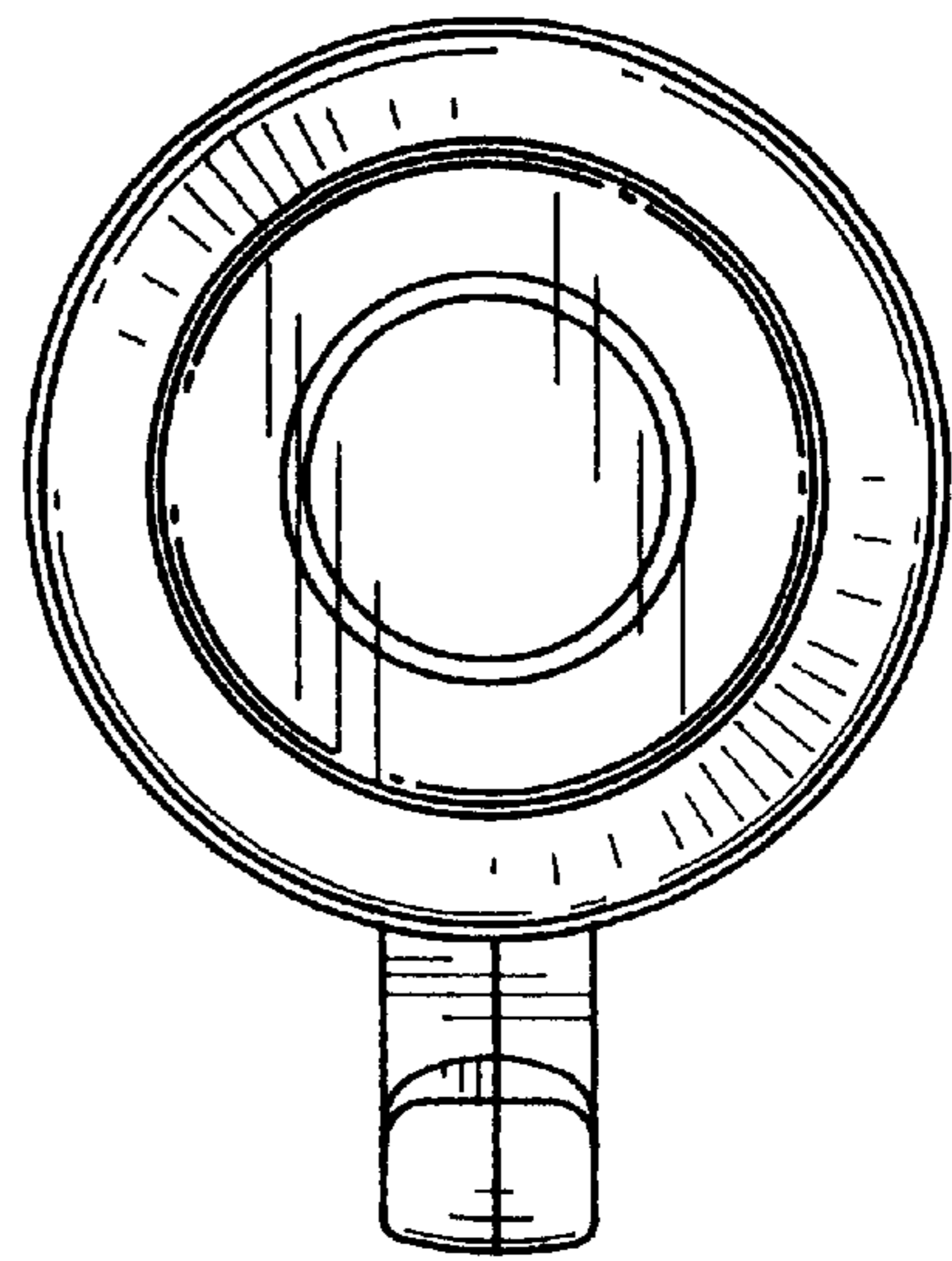

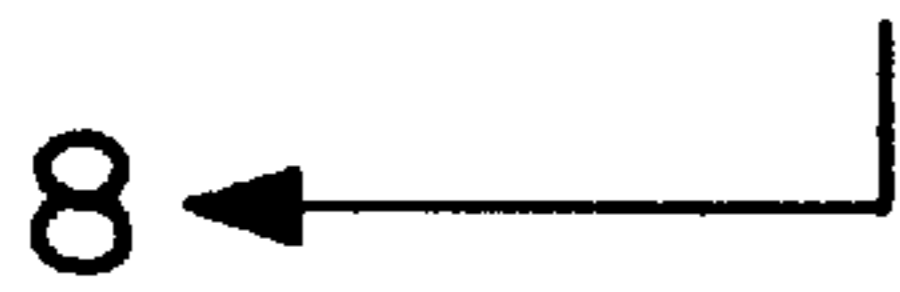
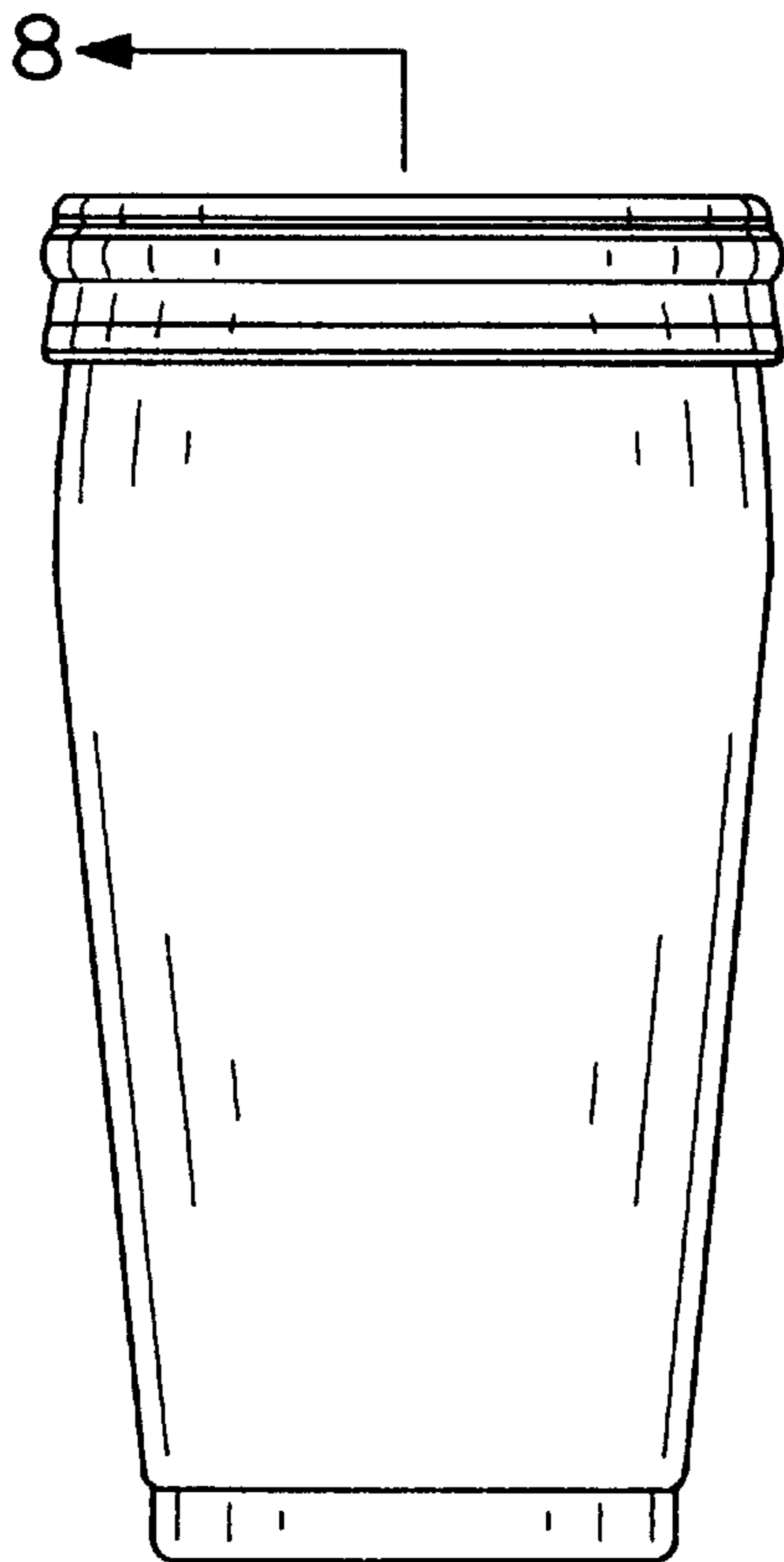

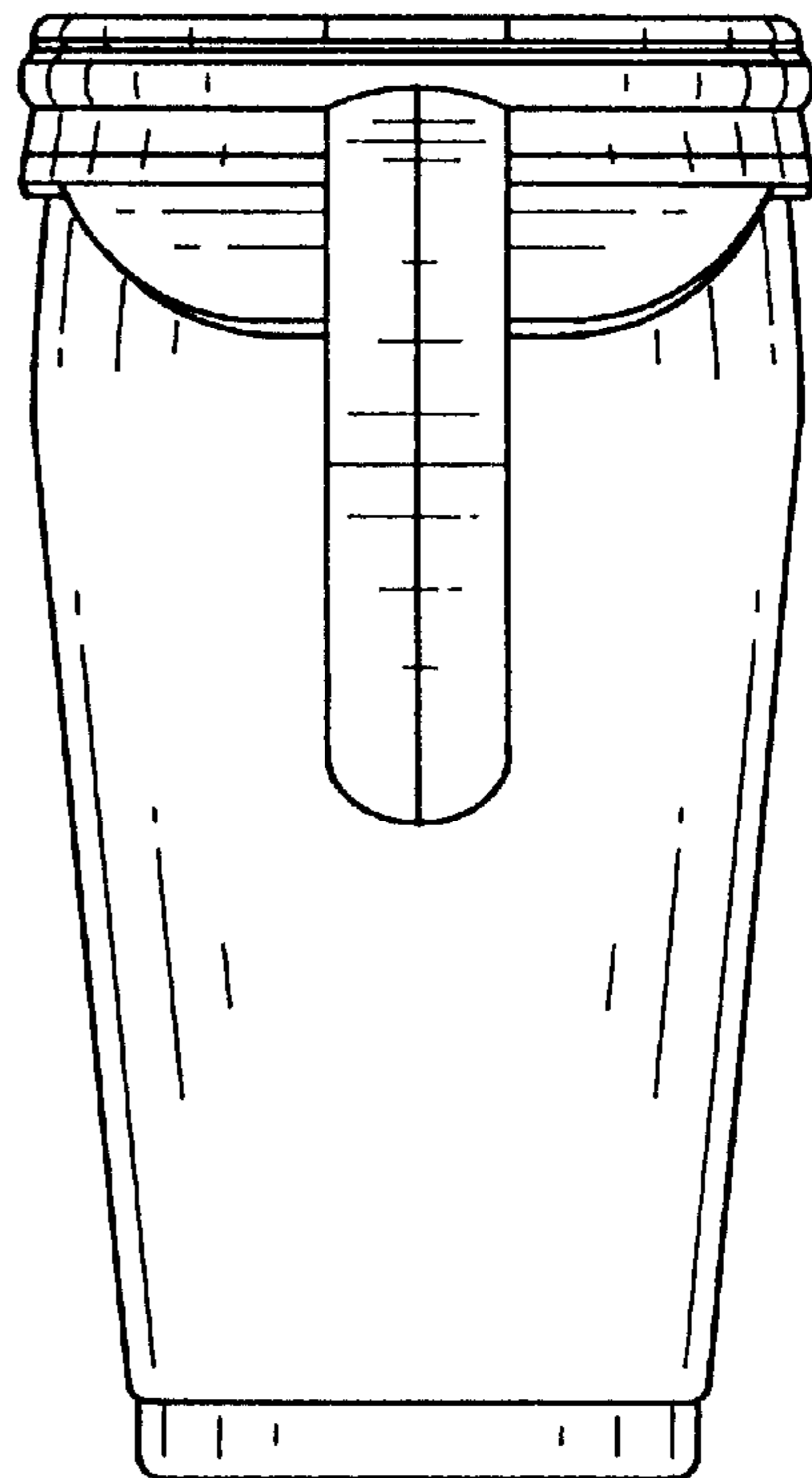

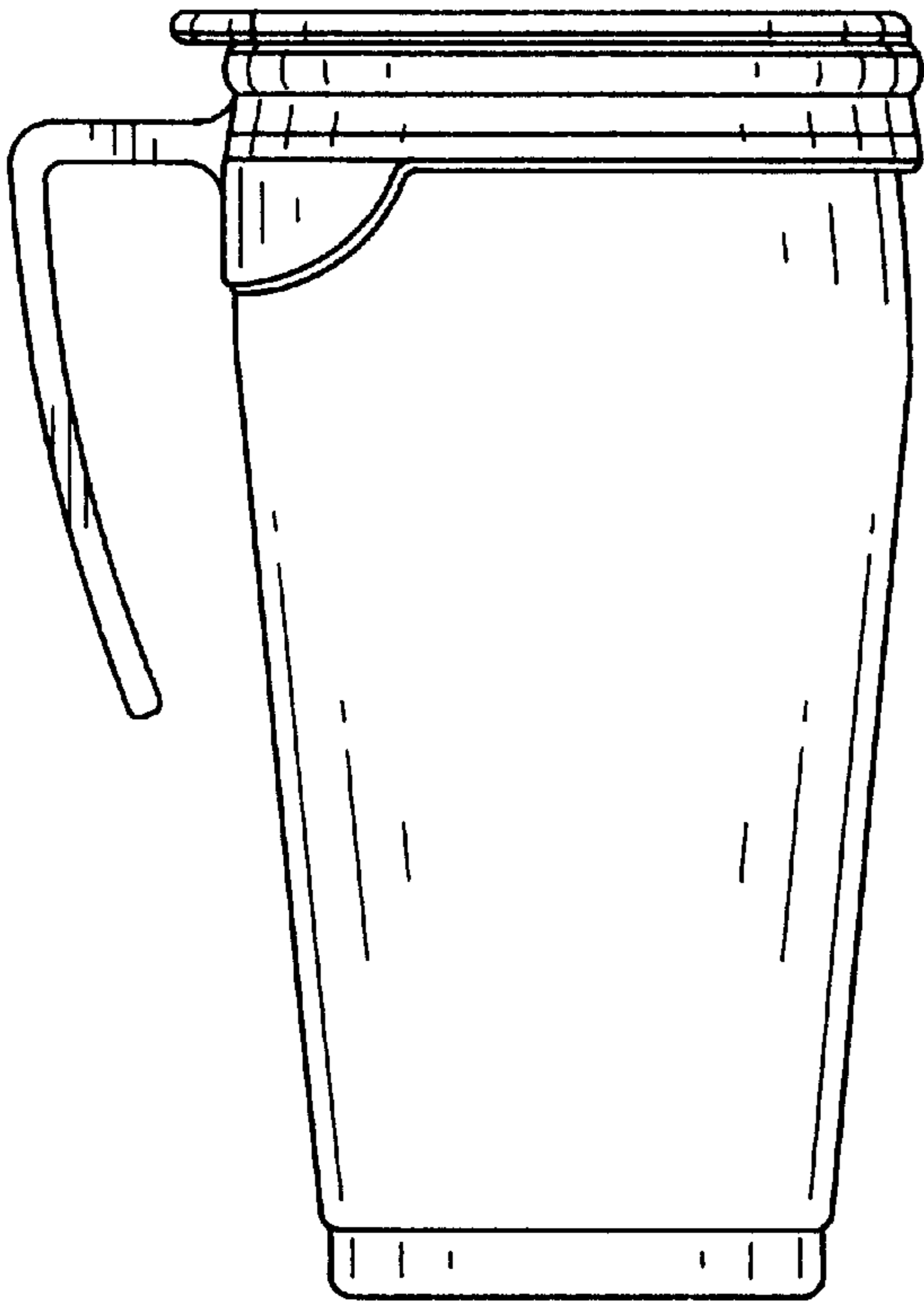

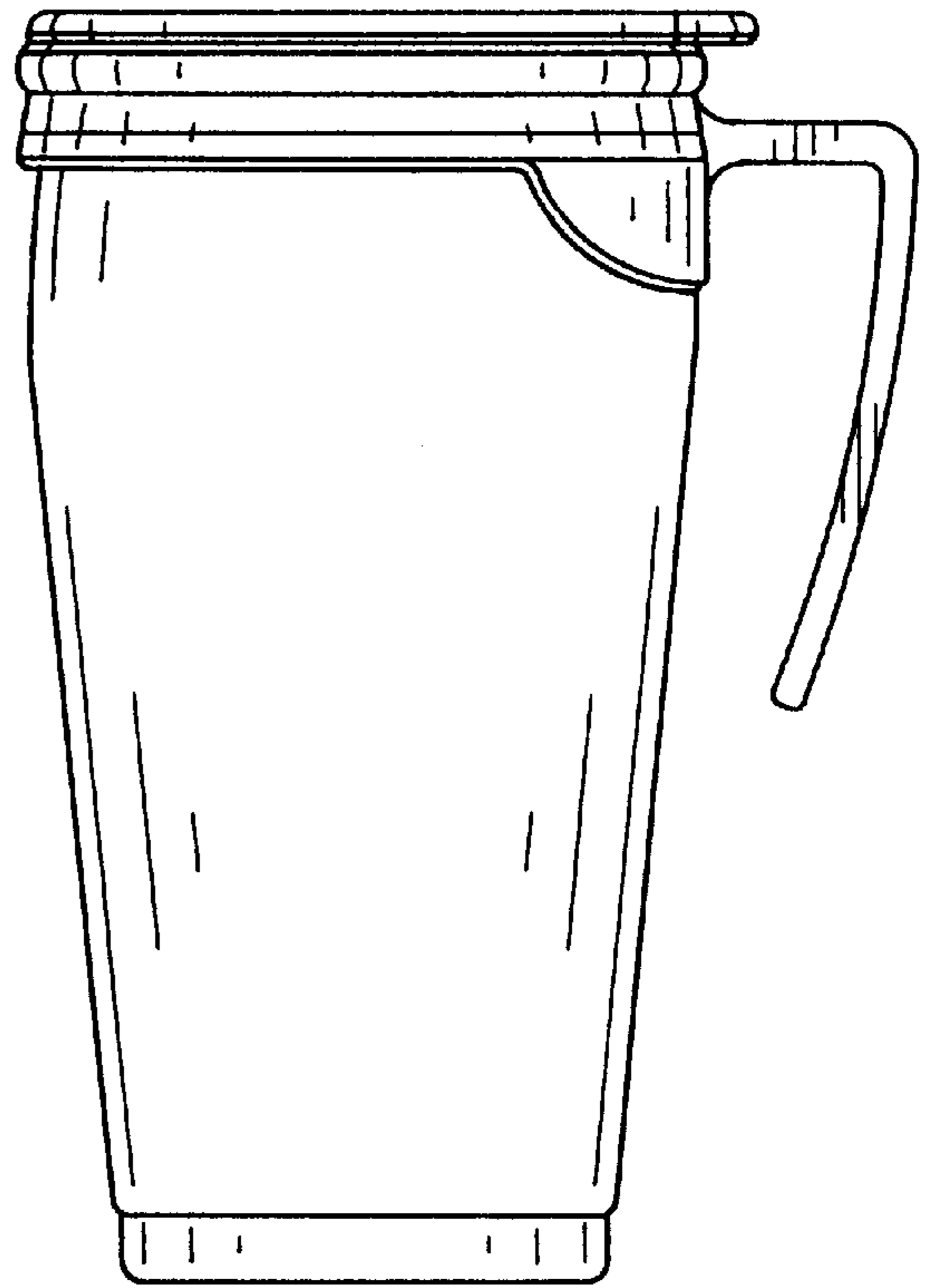

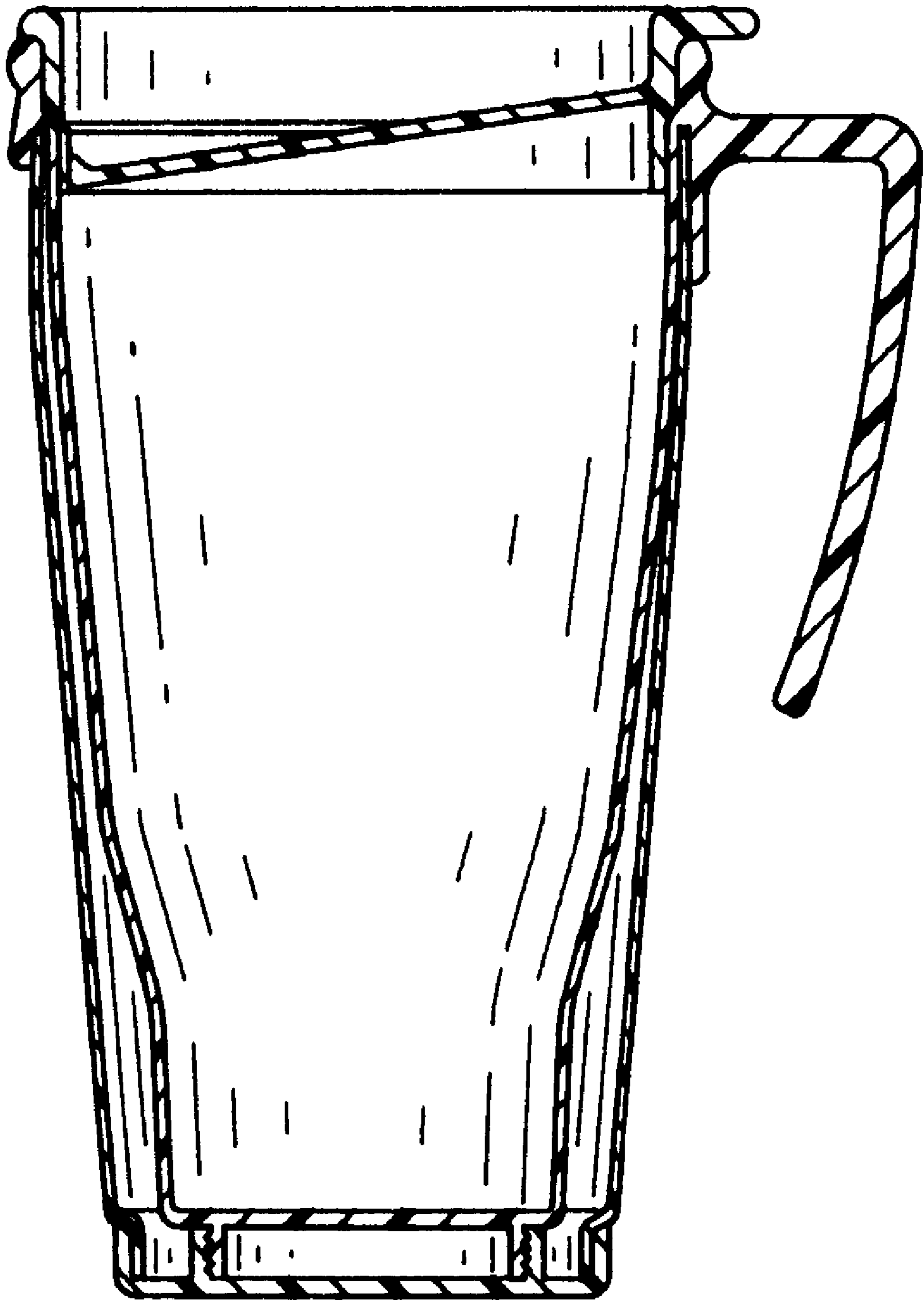

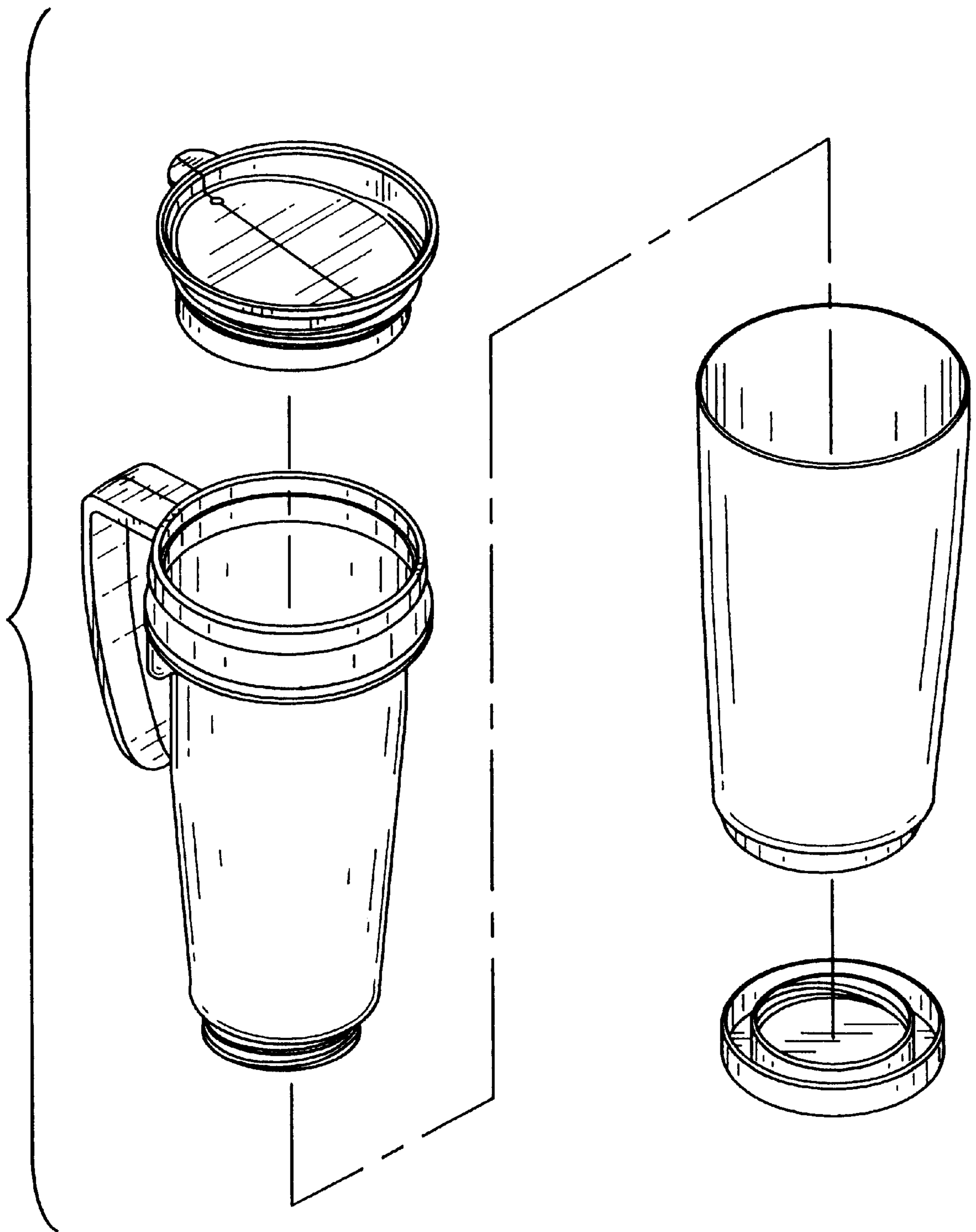
