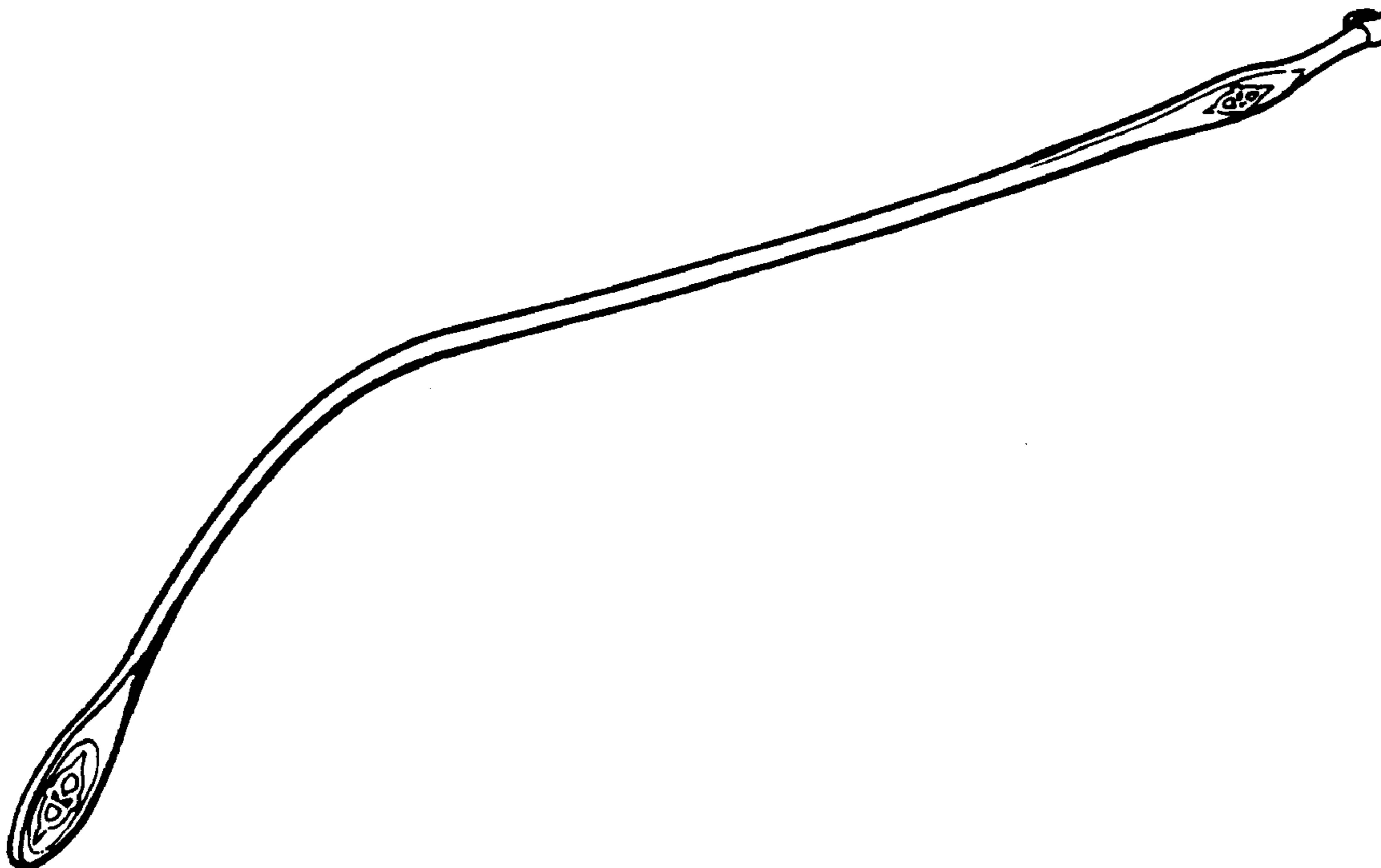
[57] **CLAIM**

The ornamental design for eyewear temple, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of an eyewear temple showing my new design;
FIG. 2 is a side elevational view thereof;
FIG. 3 is a side elevational view opposite that of FIG. 2;
FIG. 4 is a top plan view of FIG. 1;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear view thereof; and,
FIG. 7 is a front view thereof.

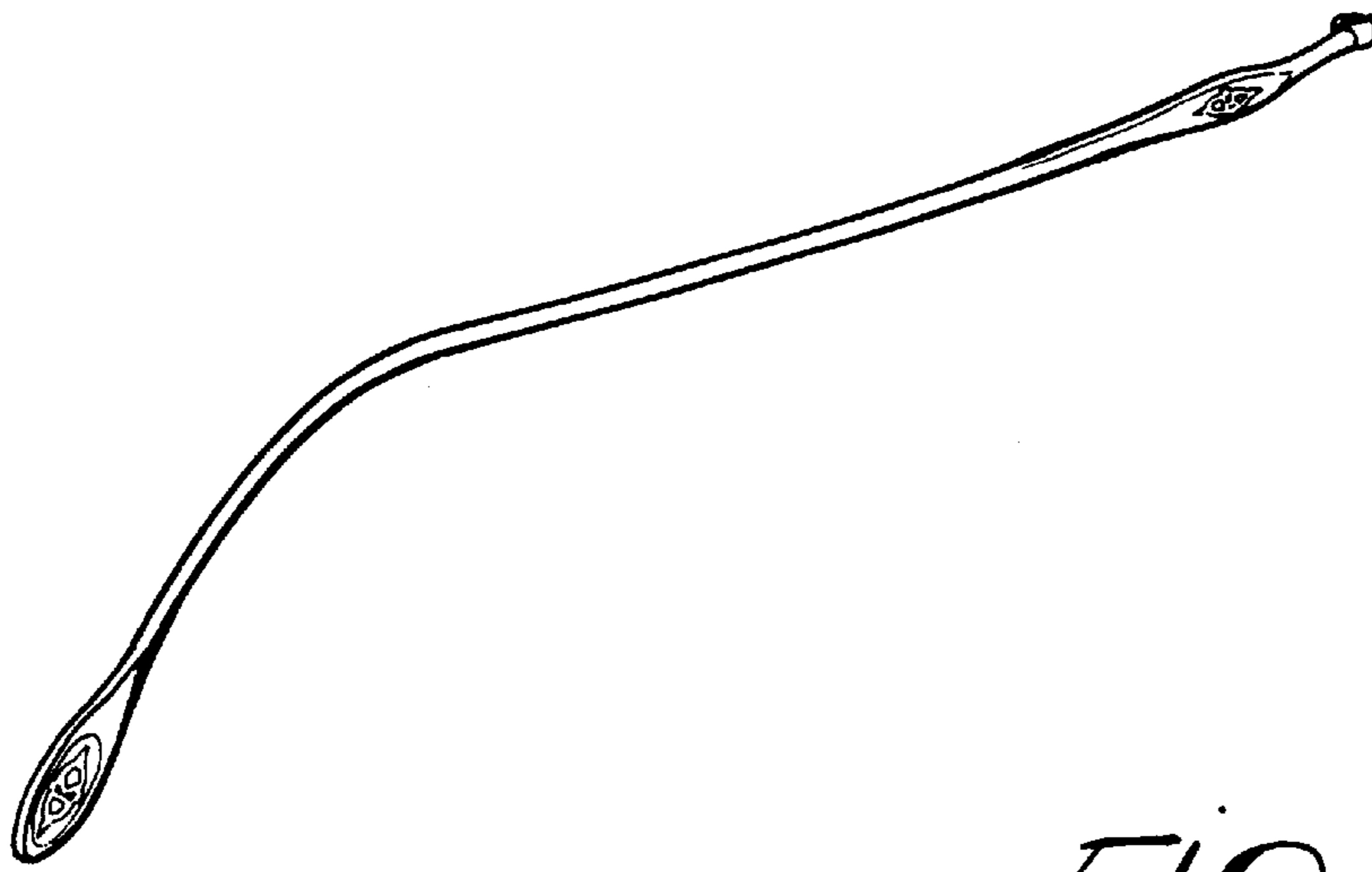

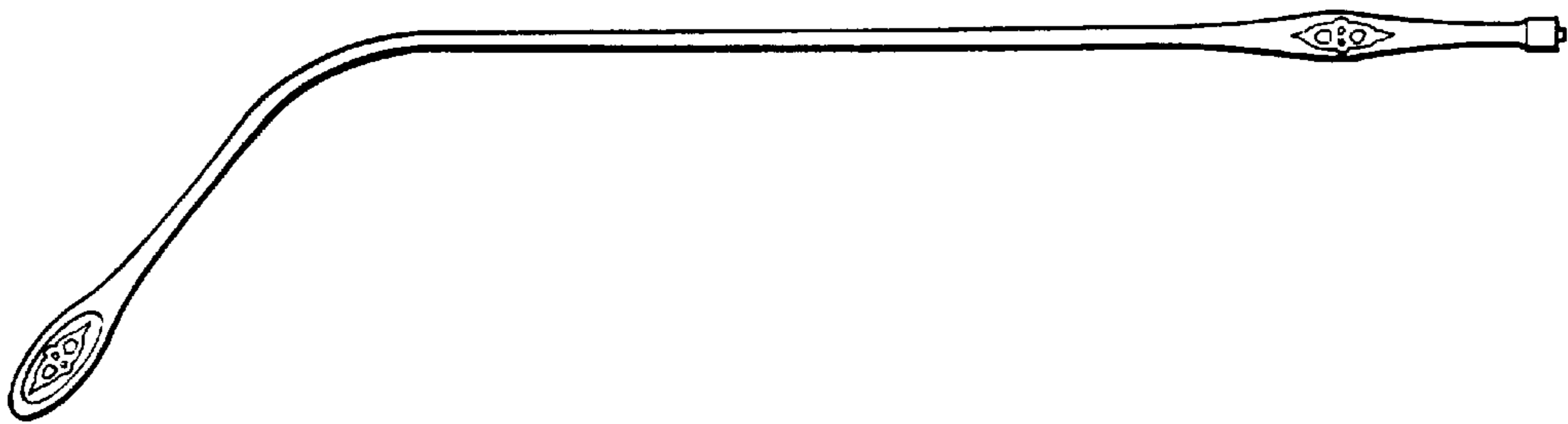

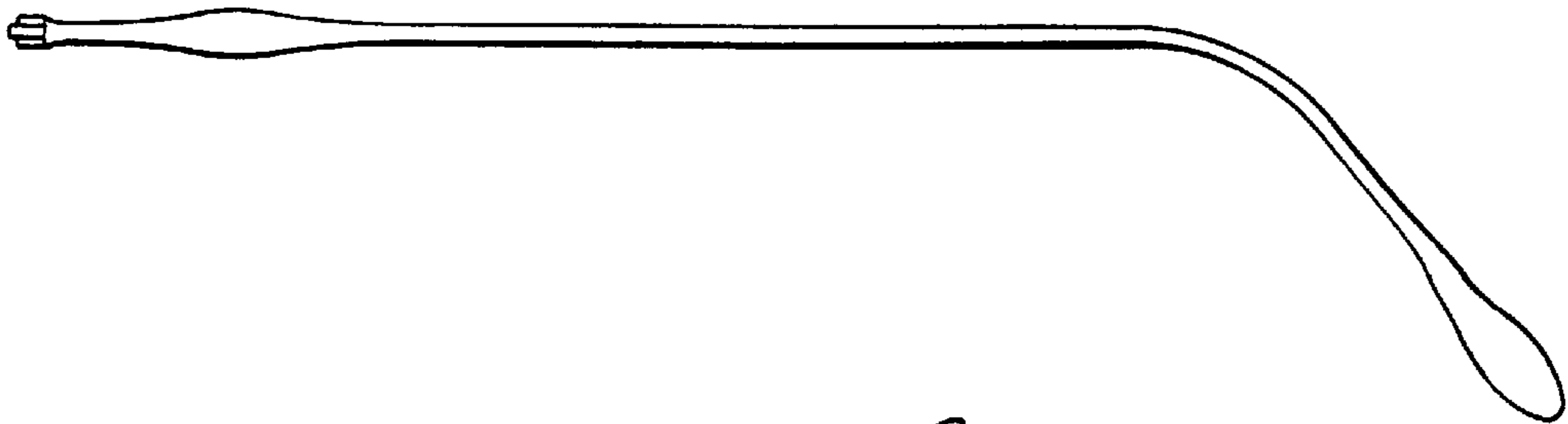

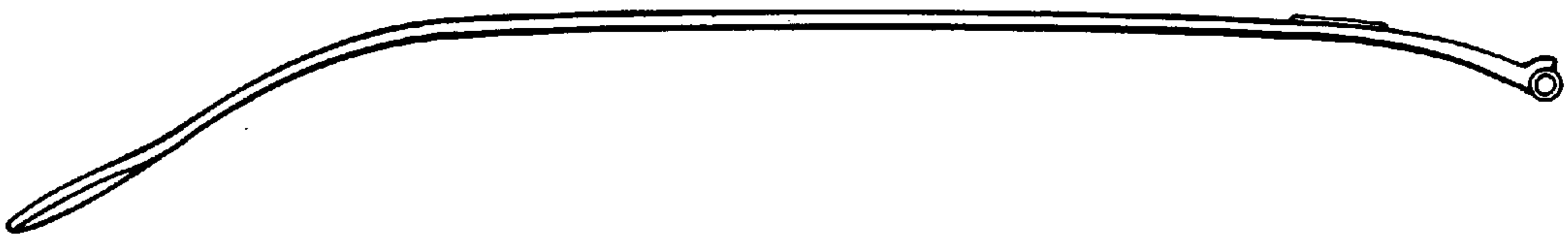
