[57] **CLAIM**

The ornamental design for game pieces with game board, as shown and described.

DESCRIPTION

- FIG. 1 is a top perspective view of the game board with representative game pieces thereon;
- FIG. 2 is an enlarged top plan view thereof;
- FIG. 3 is front elevational view thereof, the rear view and both side views being identical;
- FIG. 4 is a bottom plan view thereof;
- FIG. 5 is a further enlarged top right perspective view of the first game piece for use with the game board;
- FIG. 6 is front elevational view of the first game piece, all side views and the rear view being identical;
- FIG. 7 is a top plan view of the first game piece;

FIG. 8 is a top right perspective view of a second game piece for use with the game board;

FIG. 24 is a top perspective view of a sixth game piece for use with the game board;


FIG. 25 is a front elevational view of the sixth game piece, the rear elevational view being a mirror image thereof;

- FIG. 58 is a front elevational view of the fifteenth game piece, the rear view and both side views being identical;

- FIG. 60 is a top right perspective view of a sixteenth game piece for use with the game board;
- FIG. 61 is a front elevational view of the sixteenth game piece, the rear view and both side views being identical;
- FIG. 62 is a top plan view of the sixteenth game piece; and,
- FIG. 63 is a bottom plan view of the game pieces illustrated in FIGS. 5 through 62.

The broken line showing of the boundary of the game board in FIGS. 1–4 is for illustrative purposes only, and forms no part of the claimed design.















































































































