FIG. 2 is a top view;

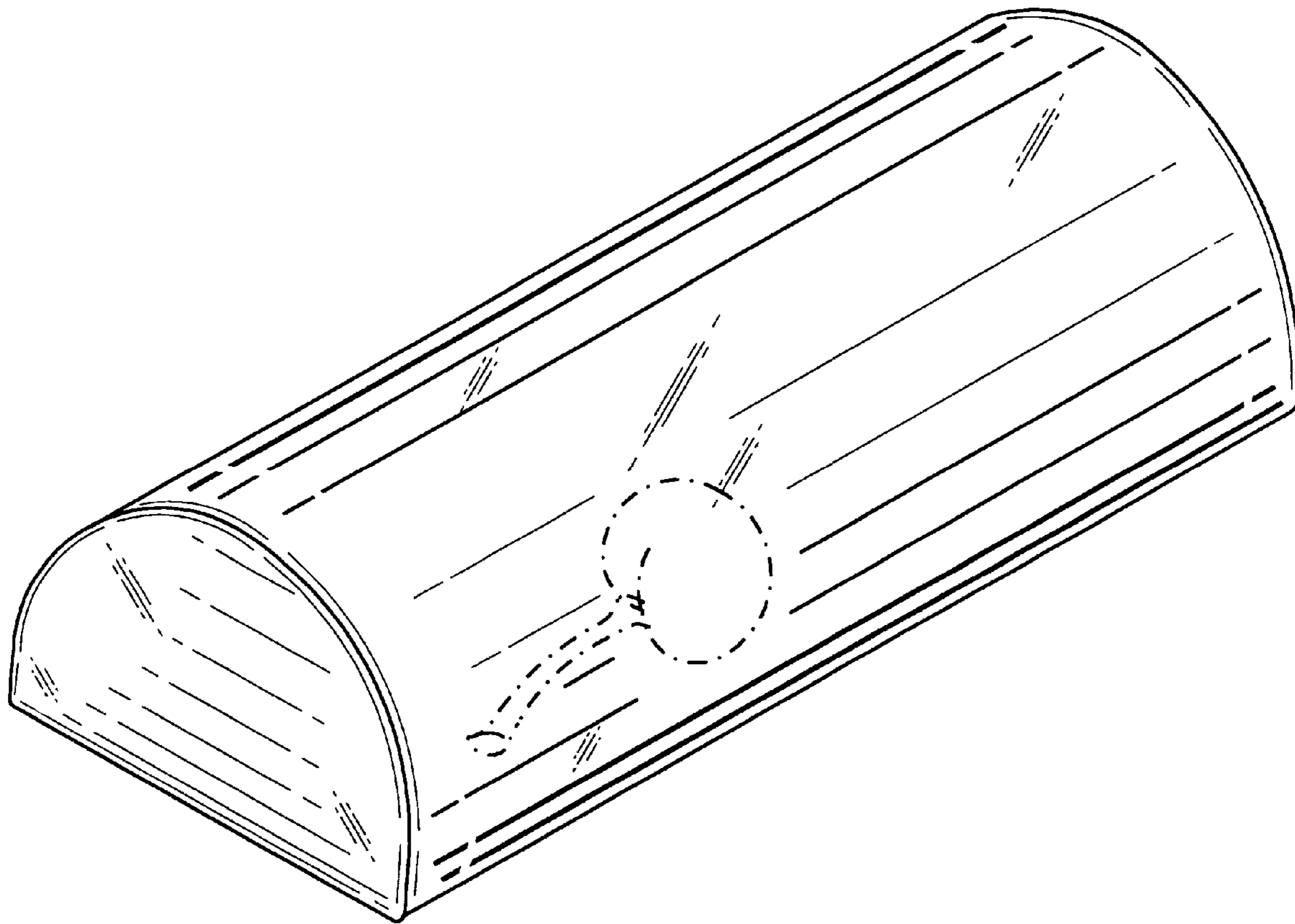
FIG. 3 is a side view;

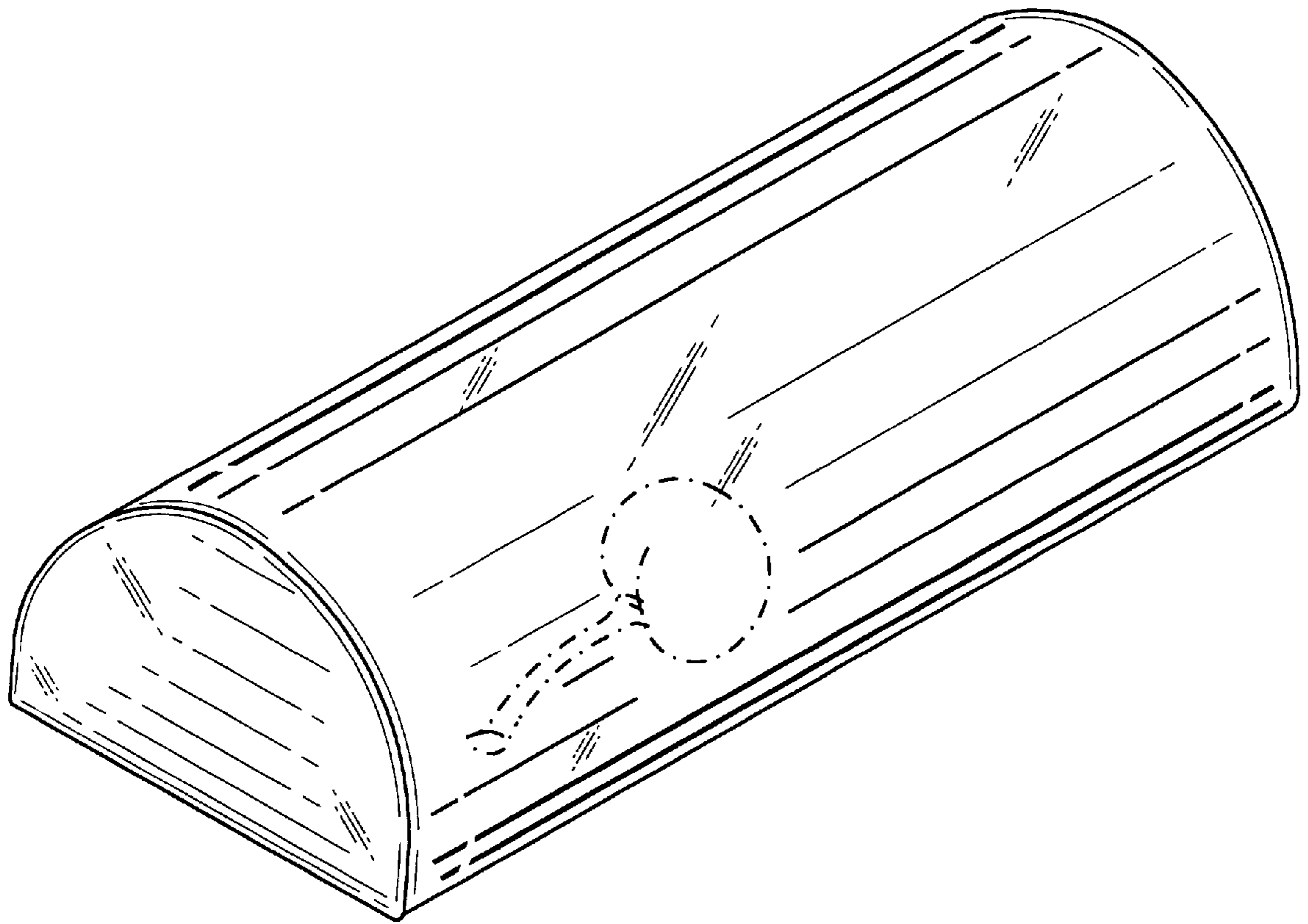

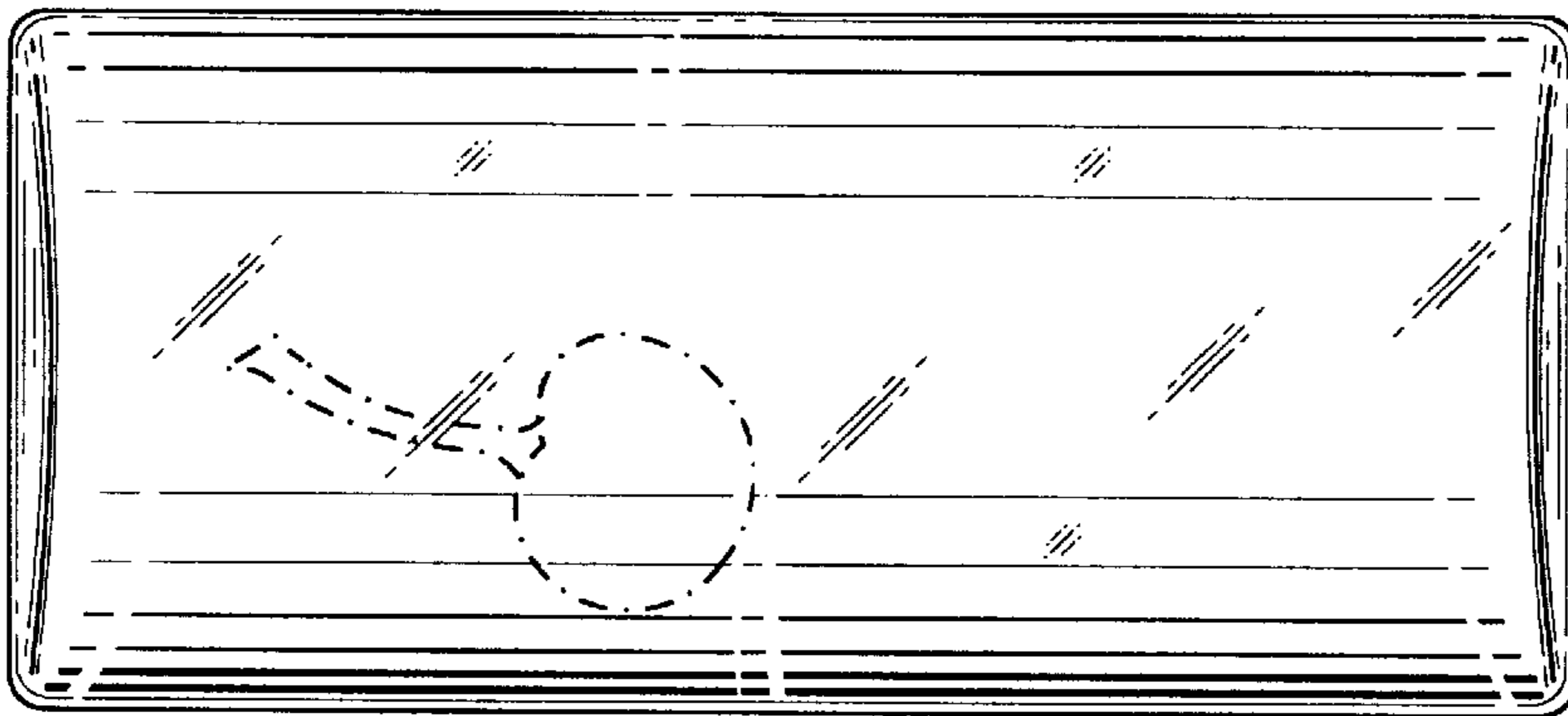

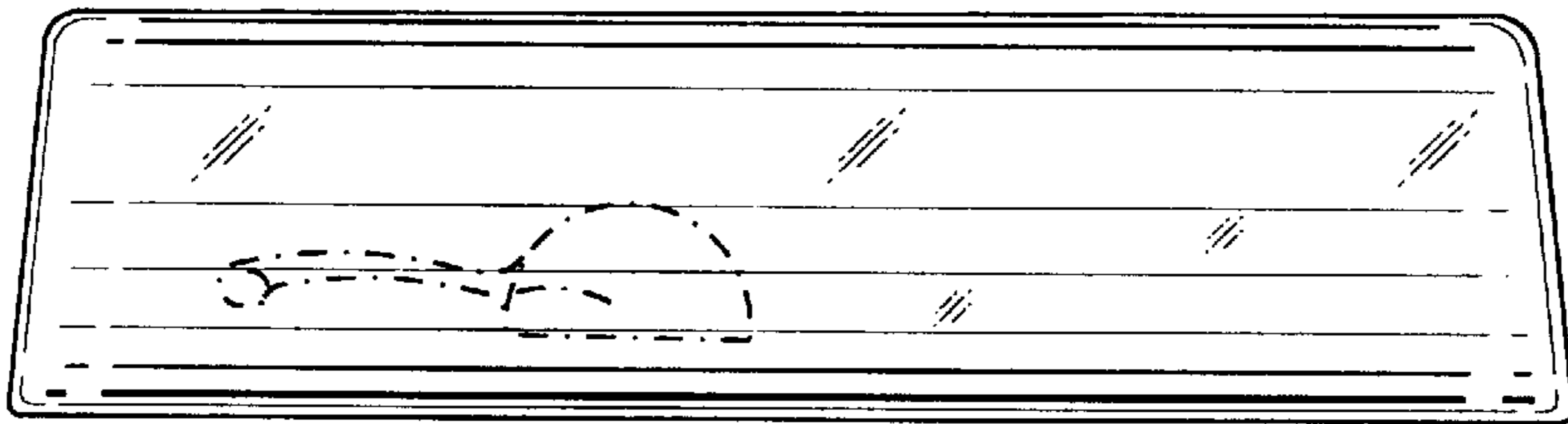

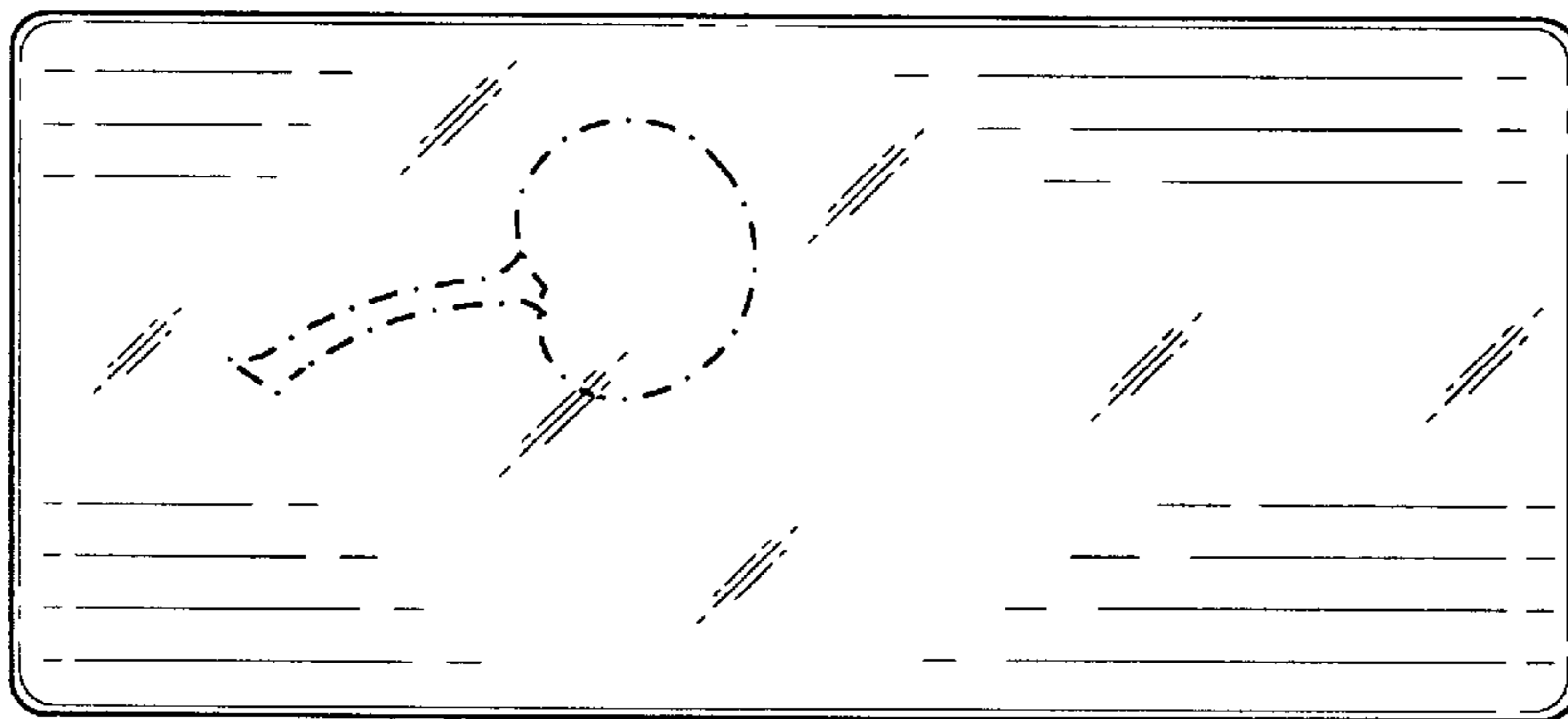

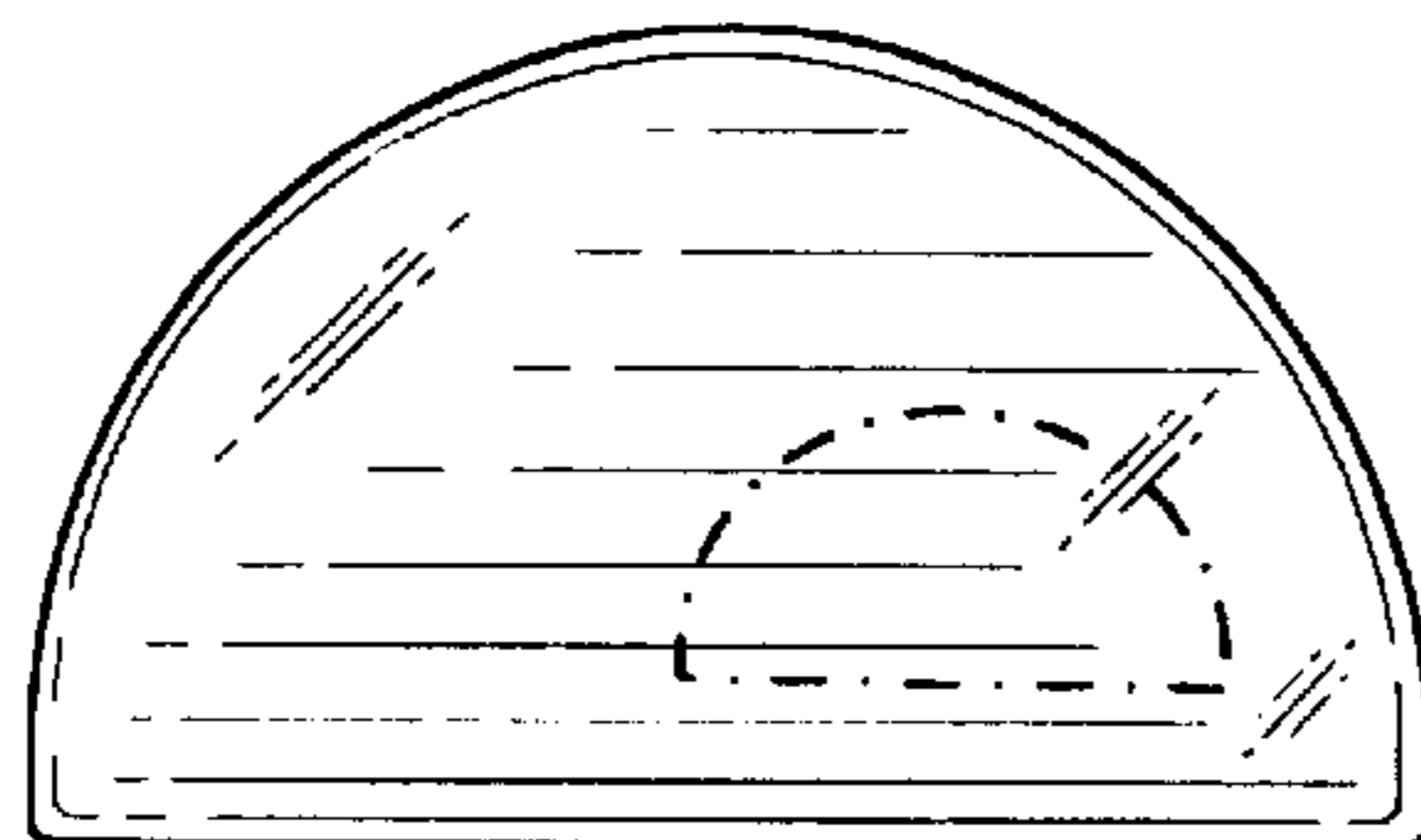
