[57] **CLAIM**

The ornamental design for a combined cordless wet and dry vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a combined wet and

dry cordless vacuum cleaner showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view of the floor brush thereof, shown in an alternate position;

FIG. 8 is a bottom plan view thereof, showing a further alternate position of the floor brush;

FIG. 9 is a right side elevational view thereof, showing the floor brush in an alternate position;

FIG. 10 is a right side elevational view thereof, showing the floor brush in another alternate position;

FIG. 11 is a right side elevational view thereof, showing the parts in an alternate position;

FIG. 12 is a bottom plan view of the main body thereof;

FIG. 13 is a top plan view of the main body thereof;

FIG. 14 is a left side elevational view of the main body thereof;

FIG. 15 is a front elevational view of the main body thereof;

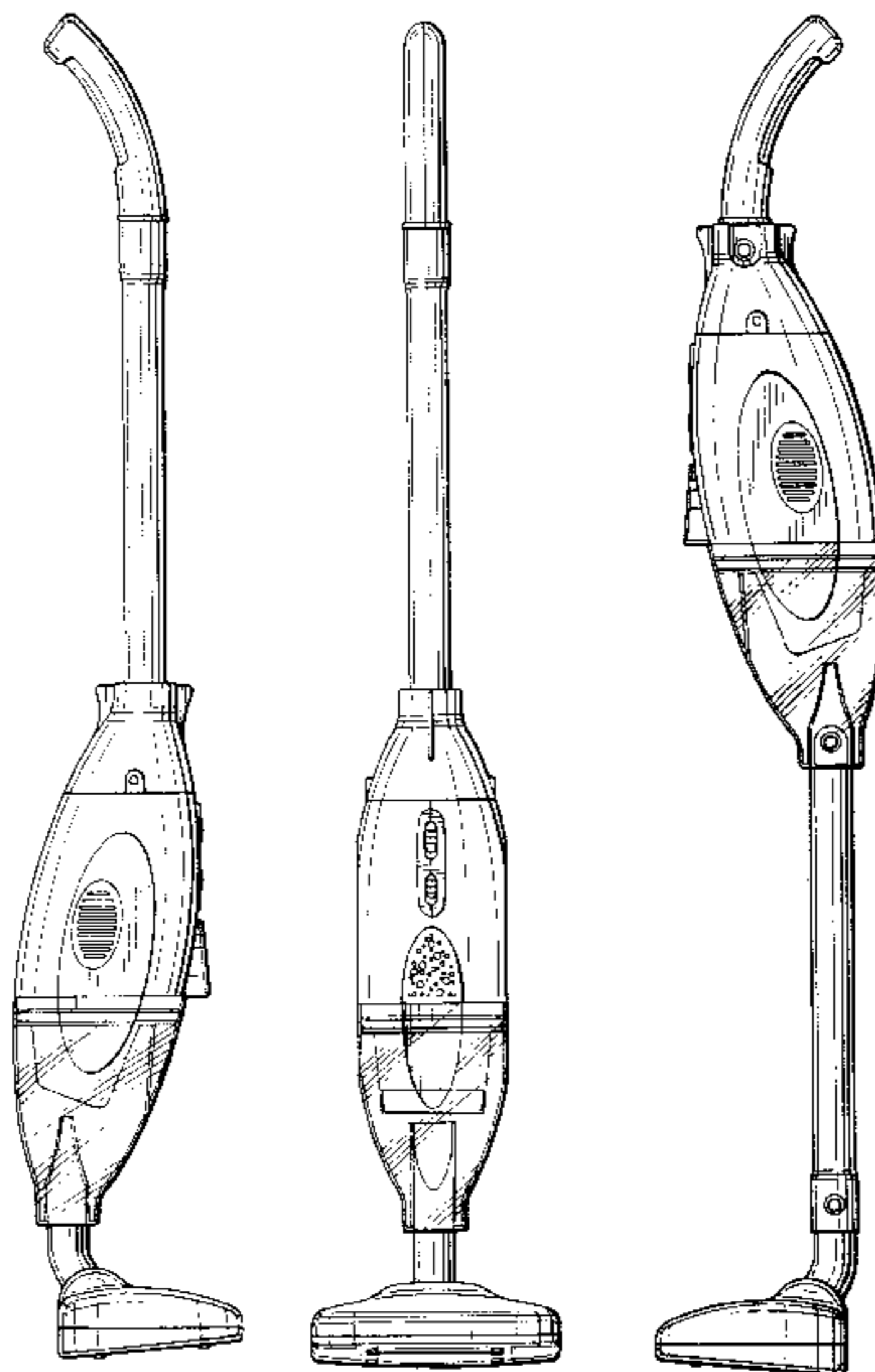
FIG. 16 is a right side elevational view of the main body thereof;

FIG. 17 is a rear elevational view of the main body thereof; and,

FIG. 18 is an enlarged sectional view of the main body taken along lines 18—18 in FIG. 15.

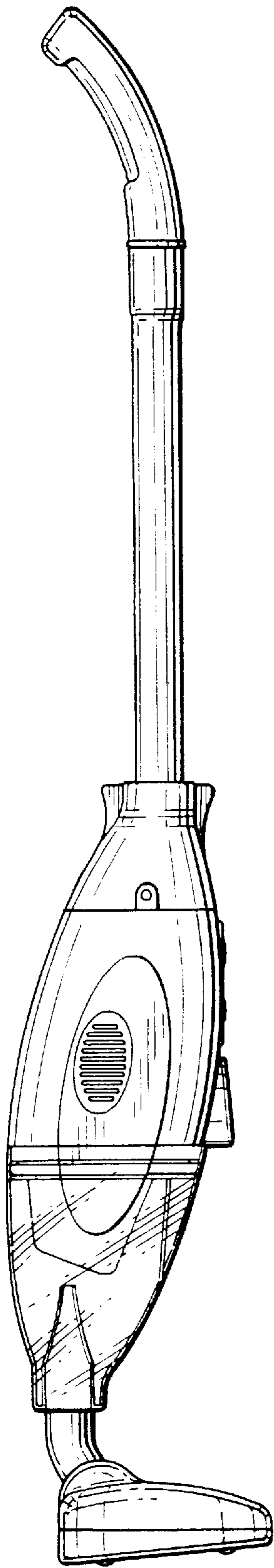

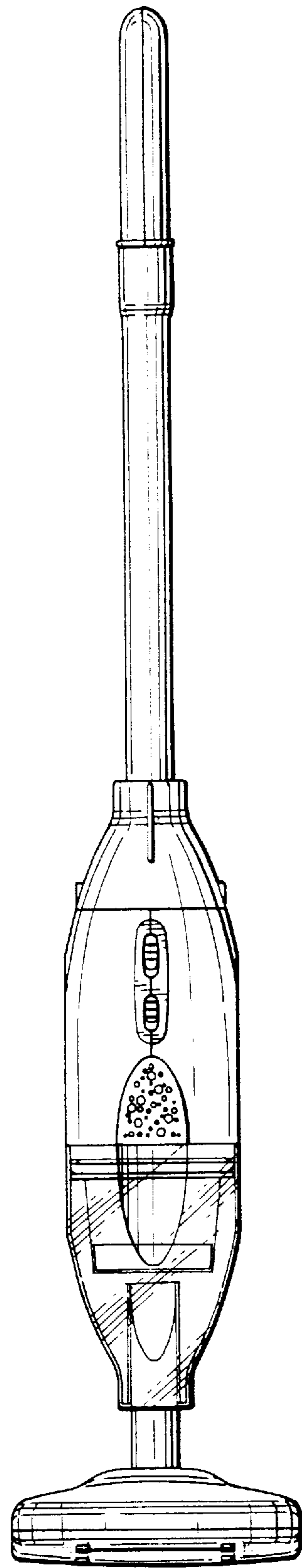

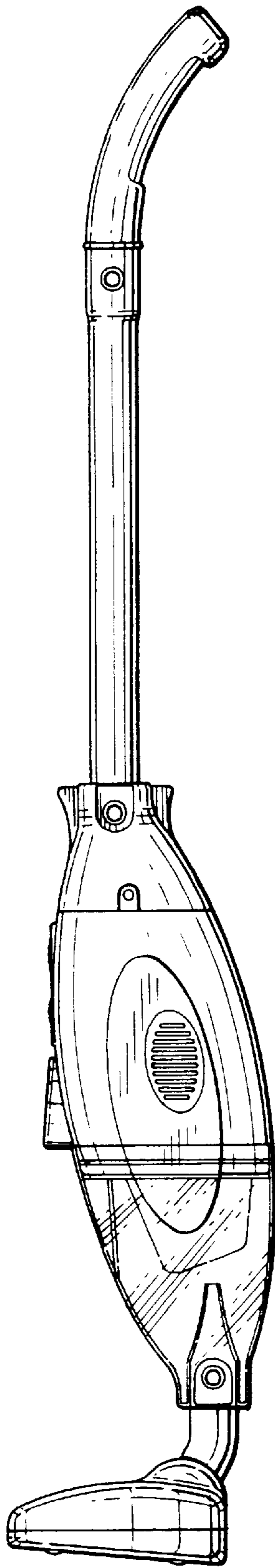

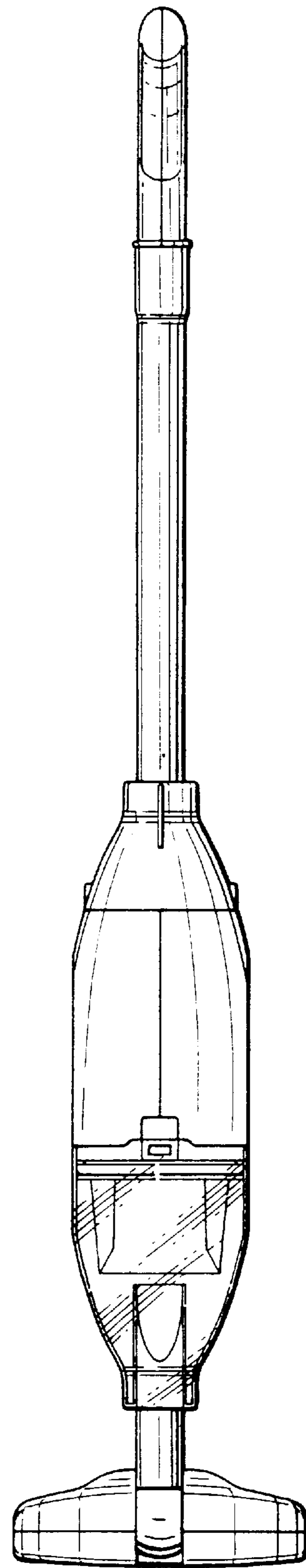

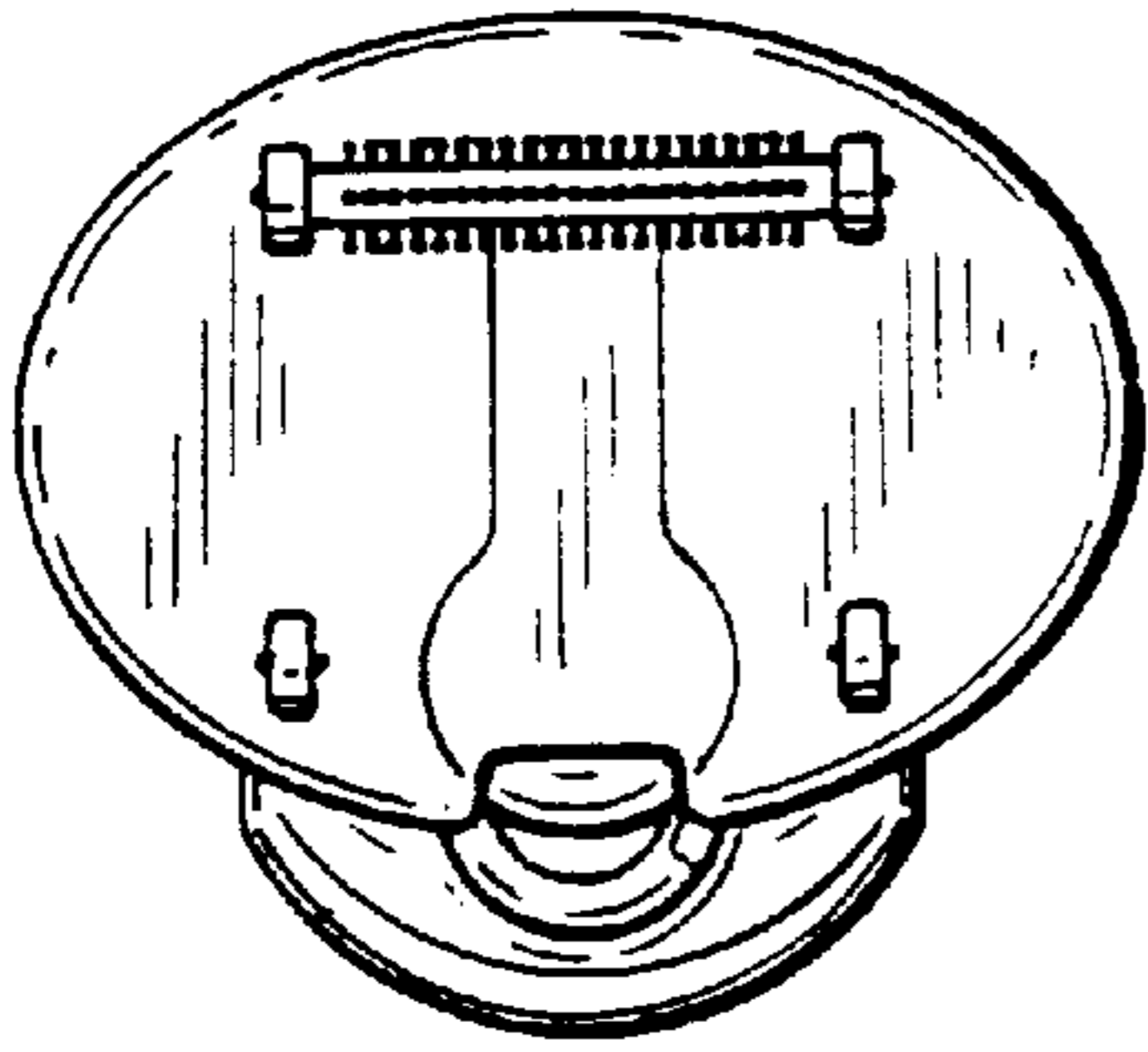

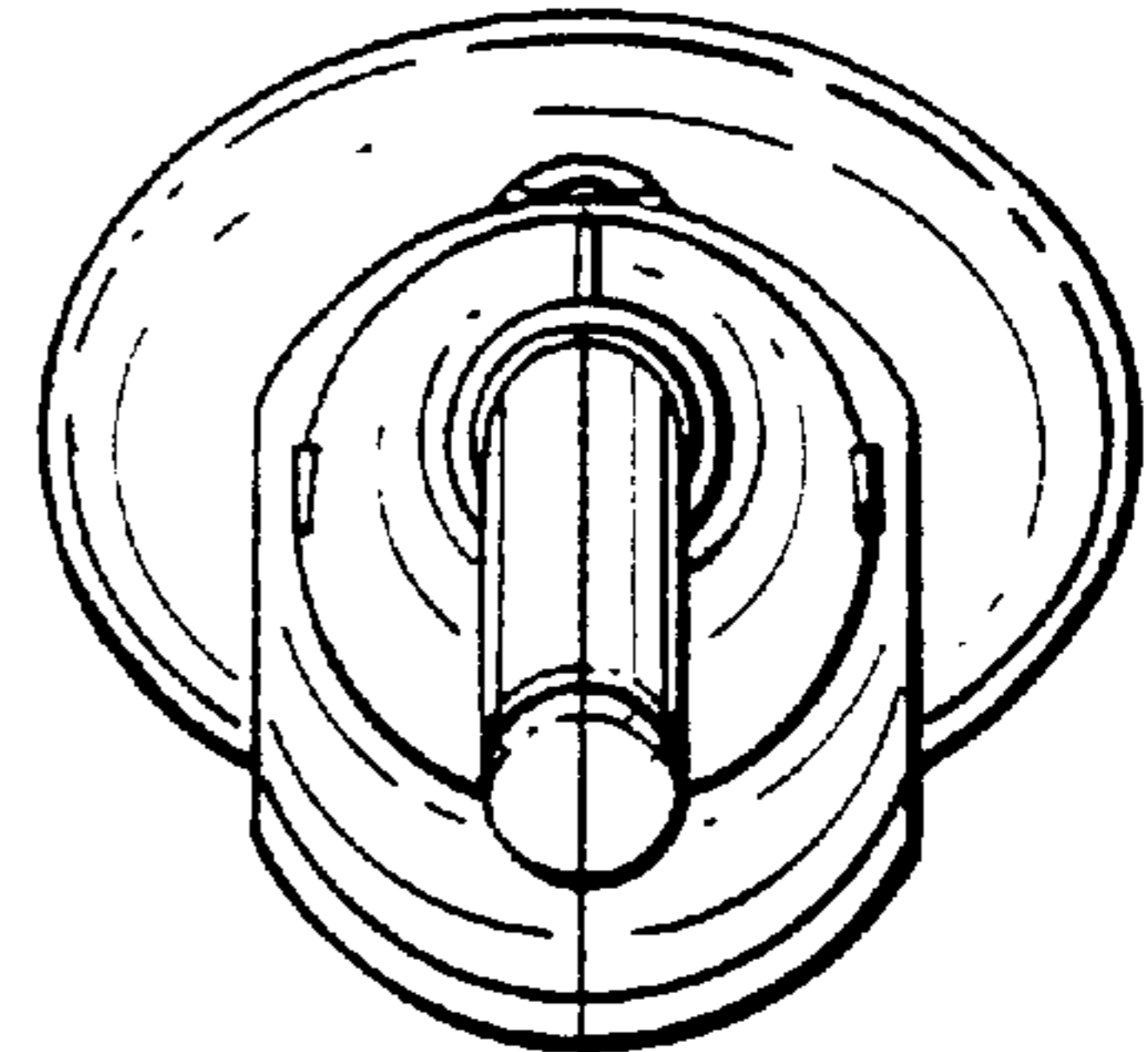

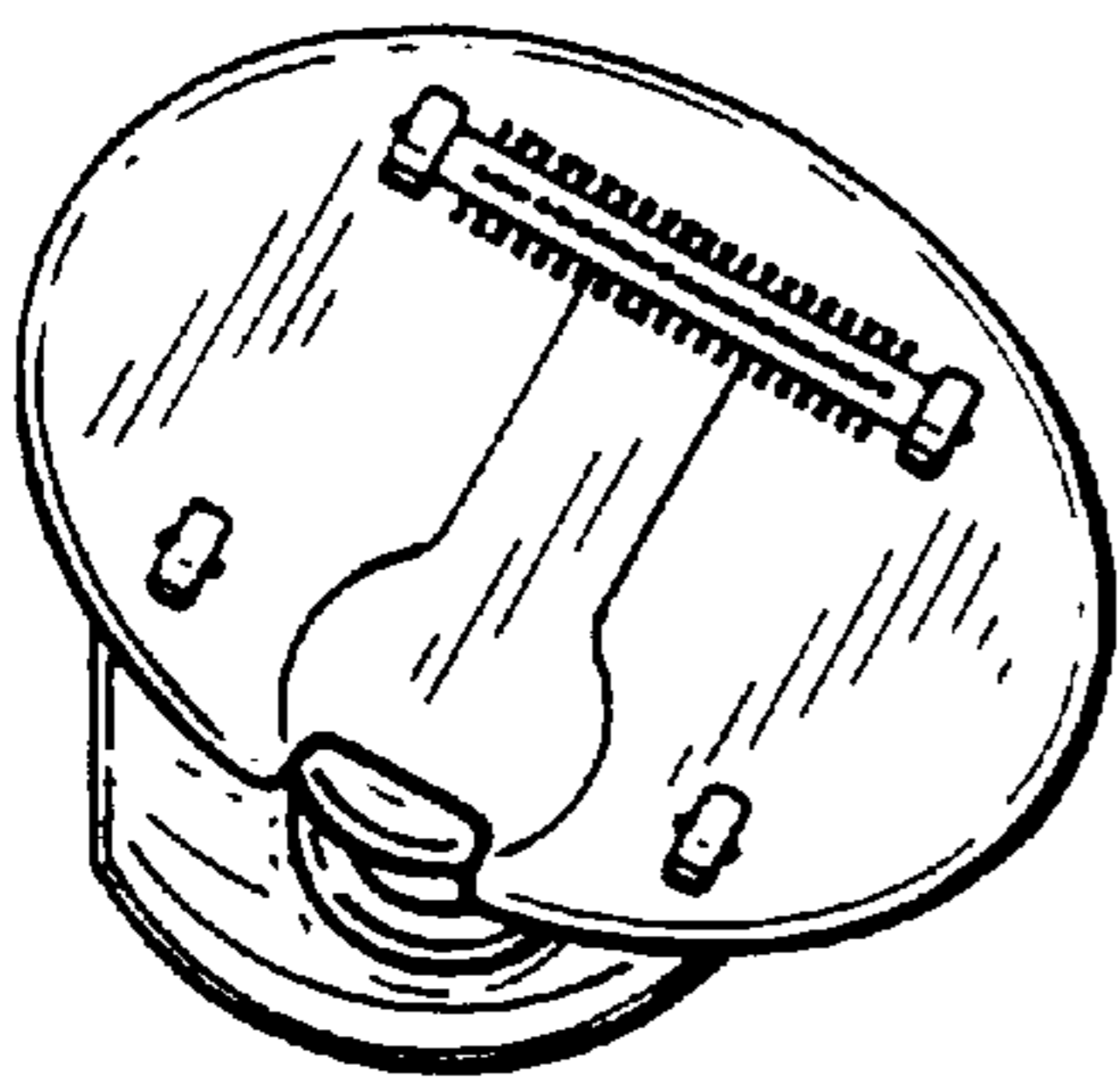

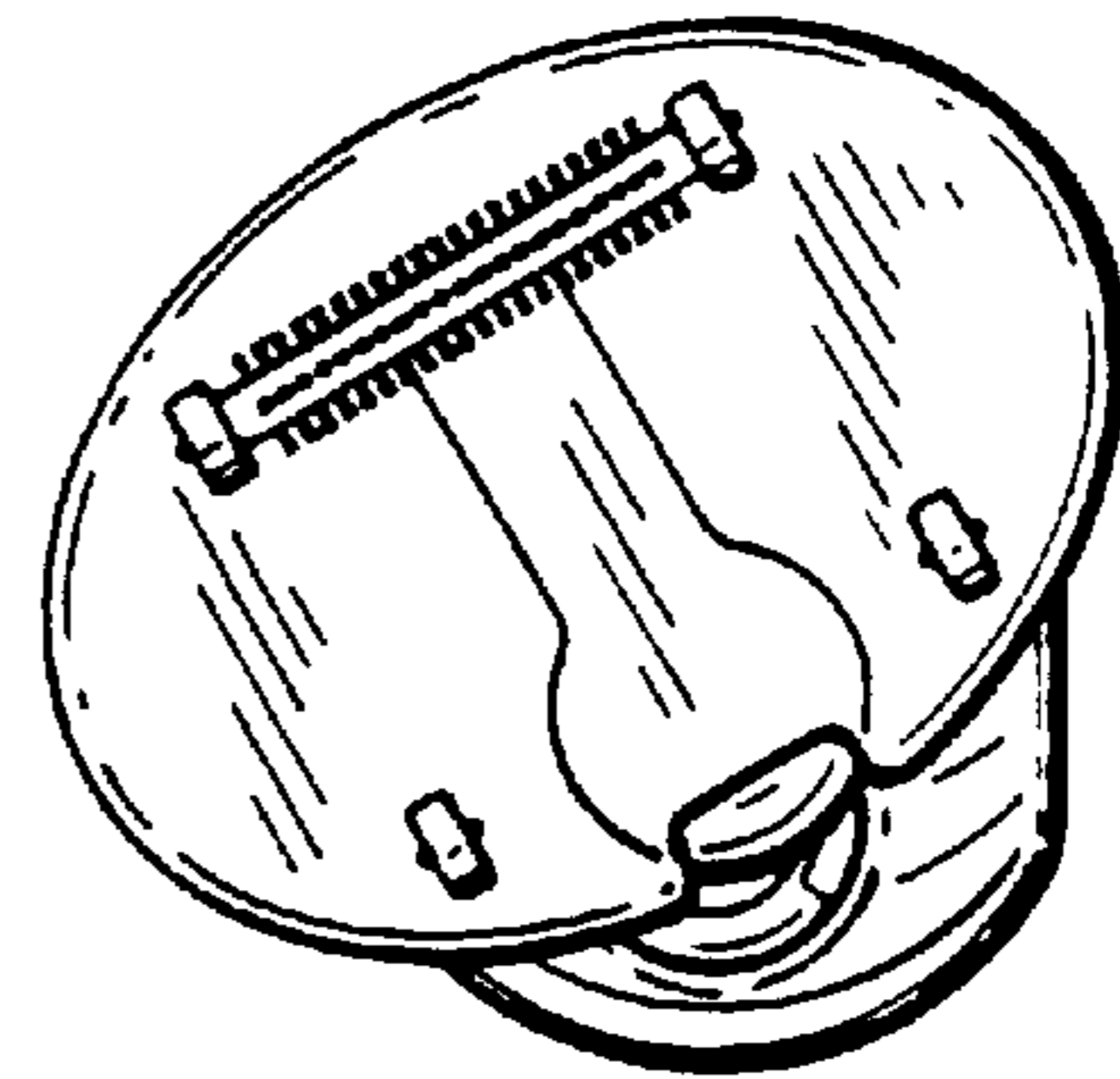

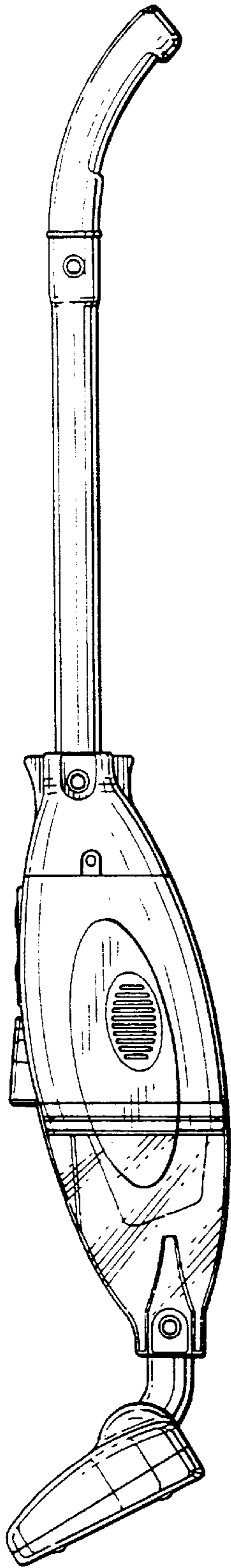

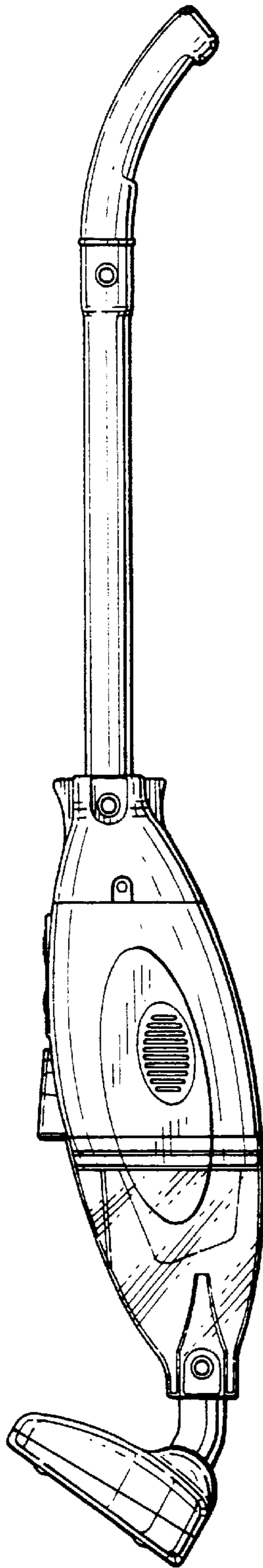

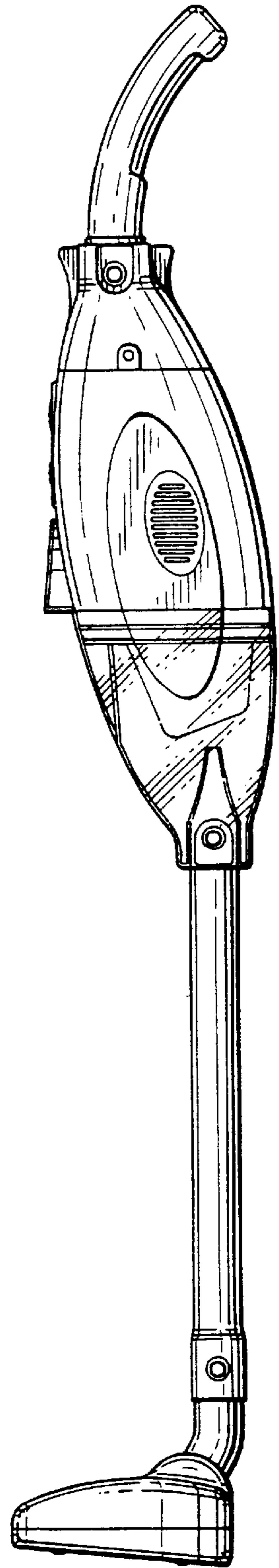

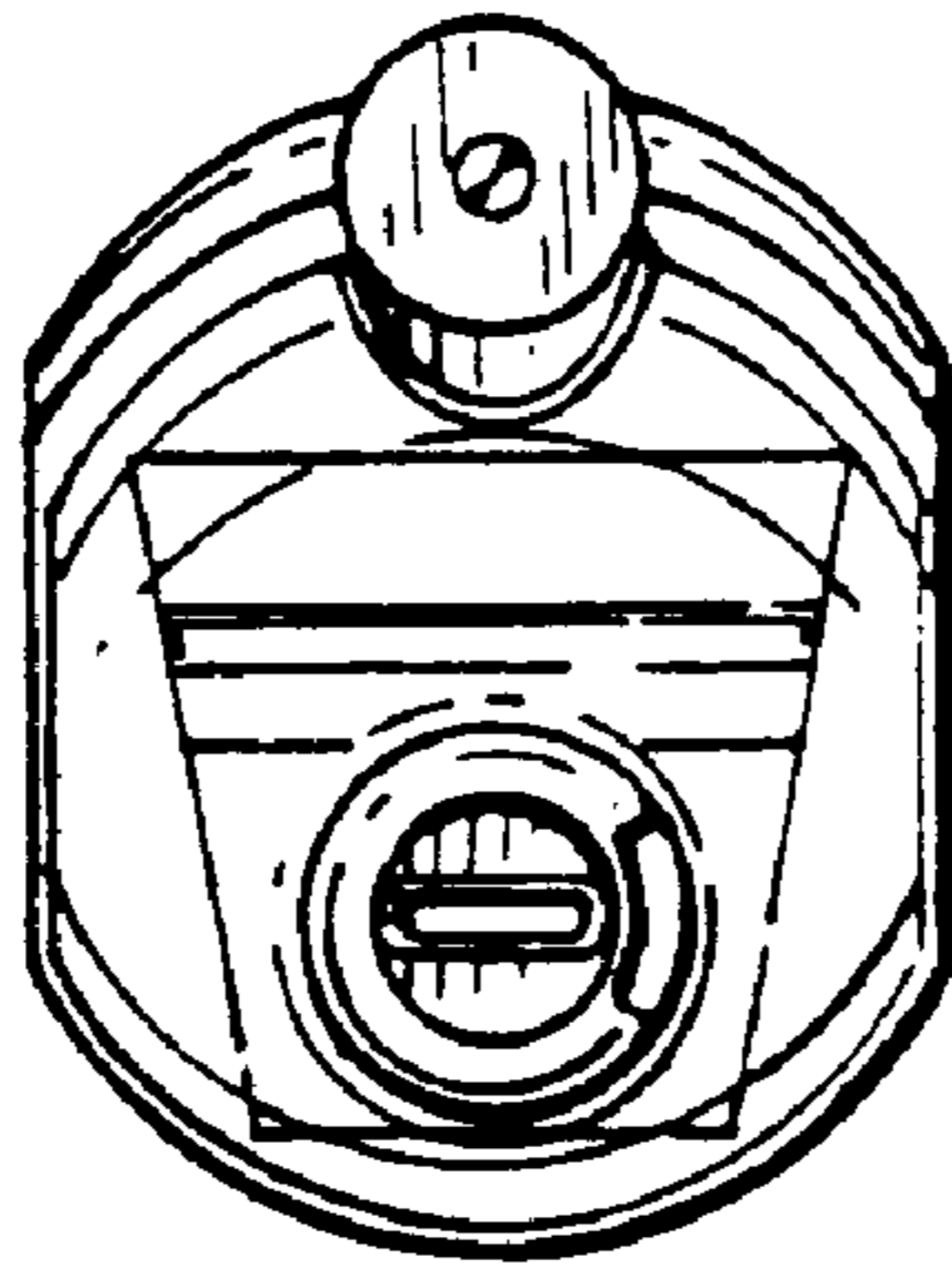

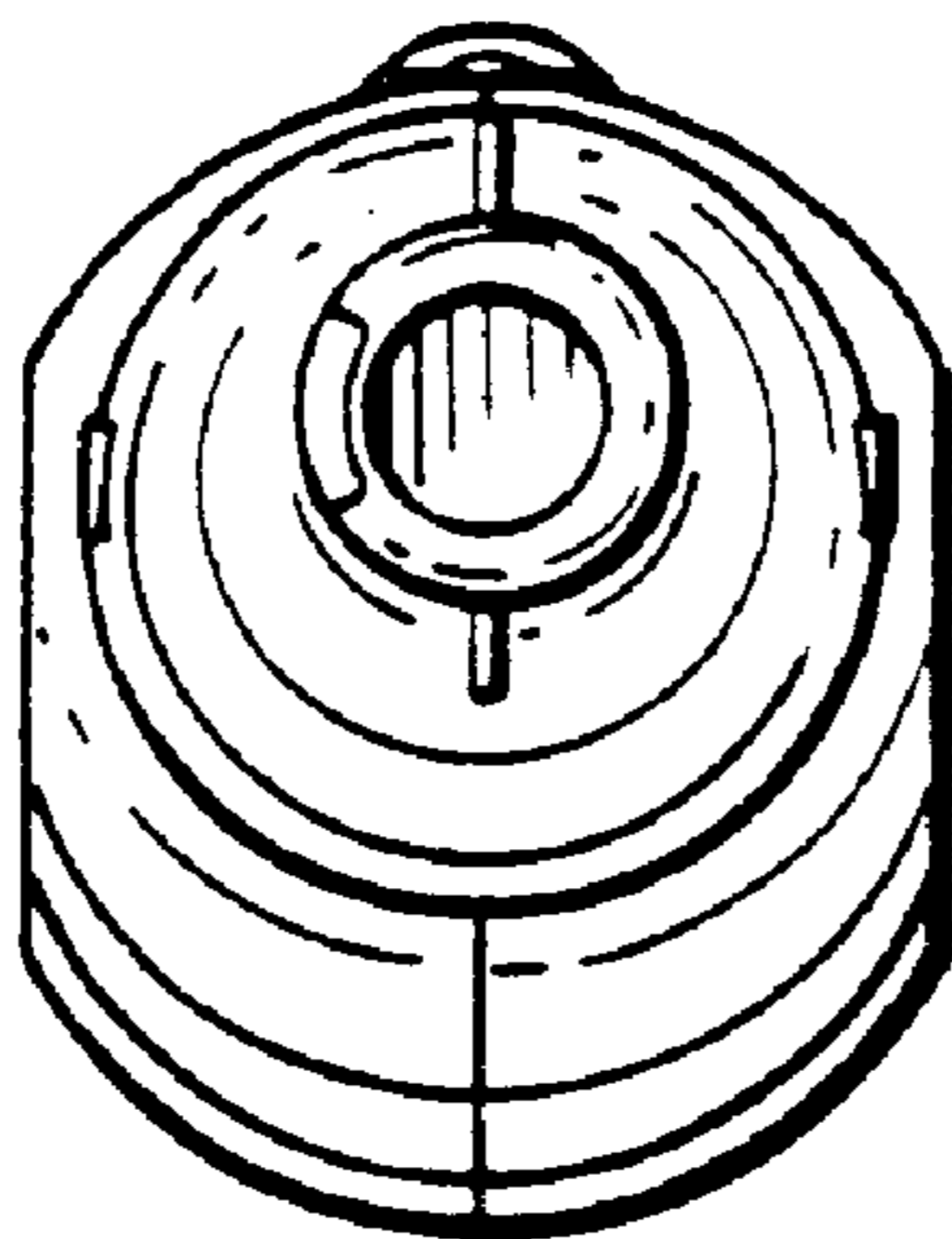

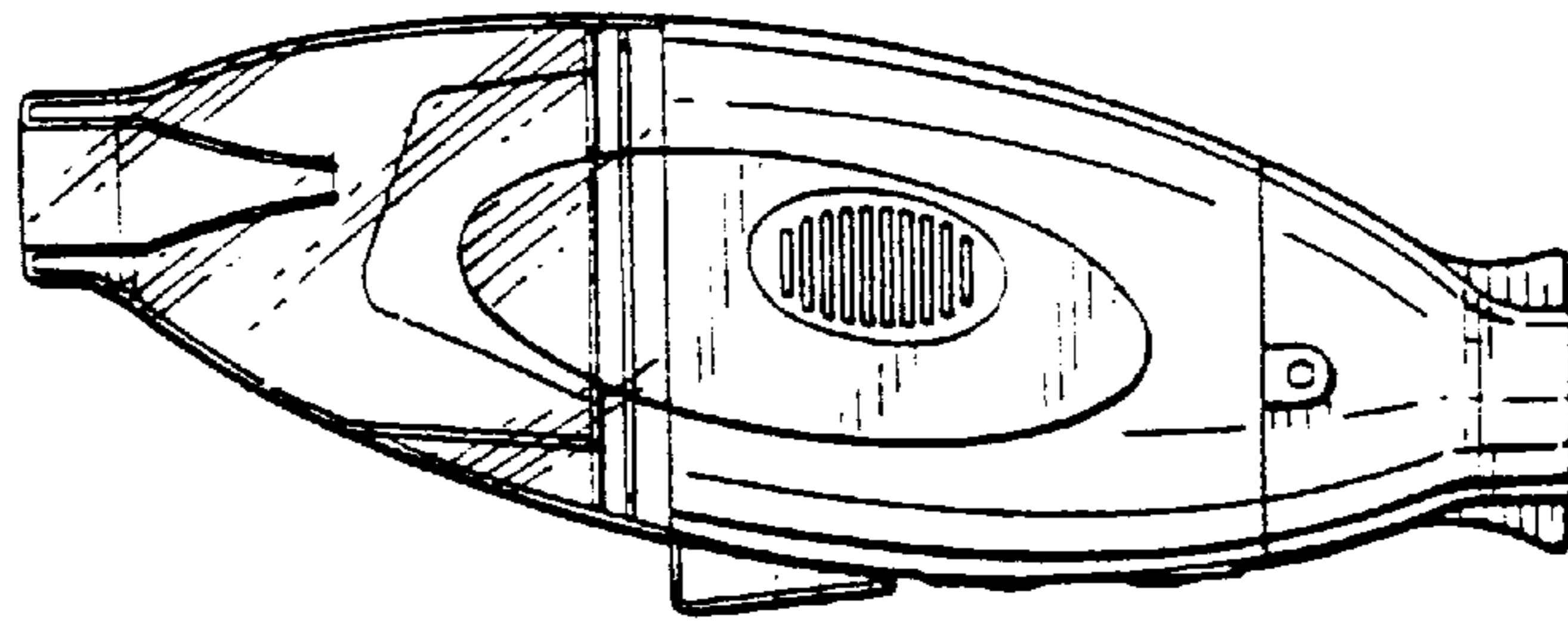

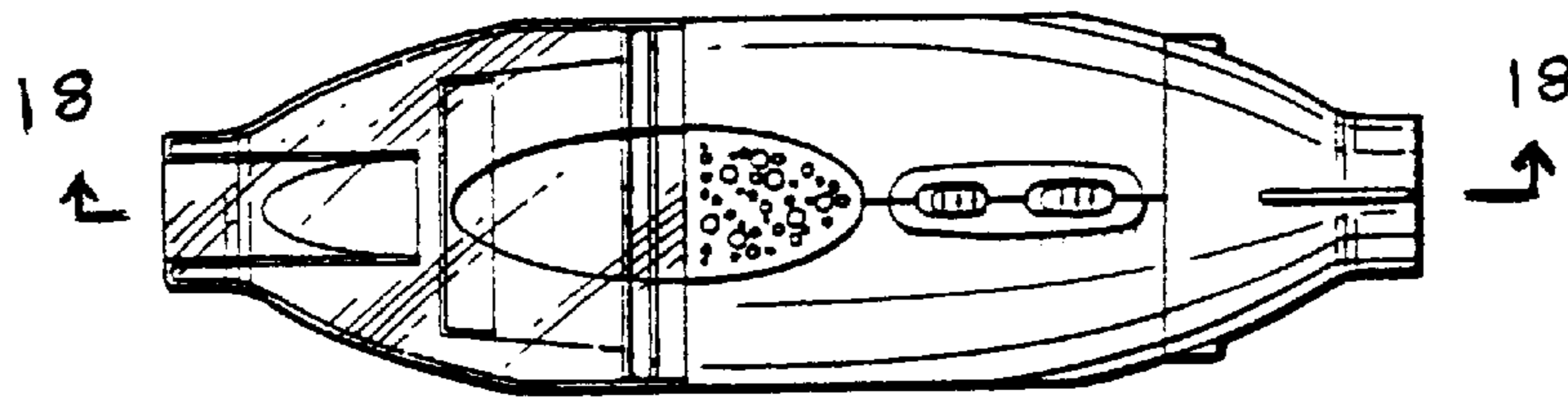

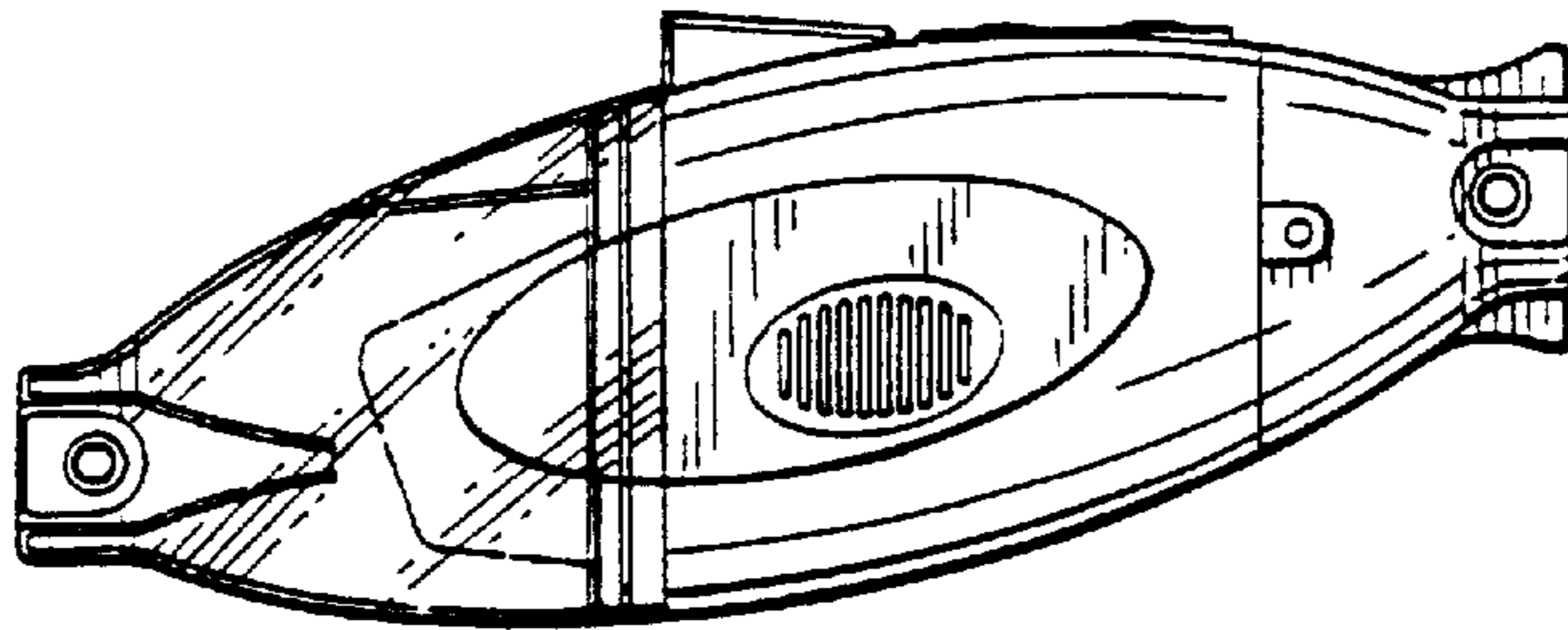

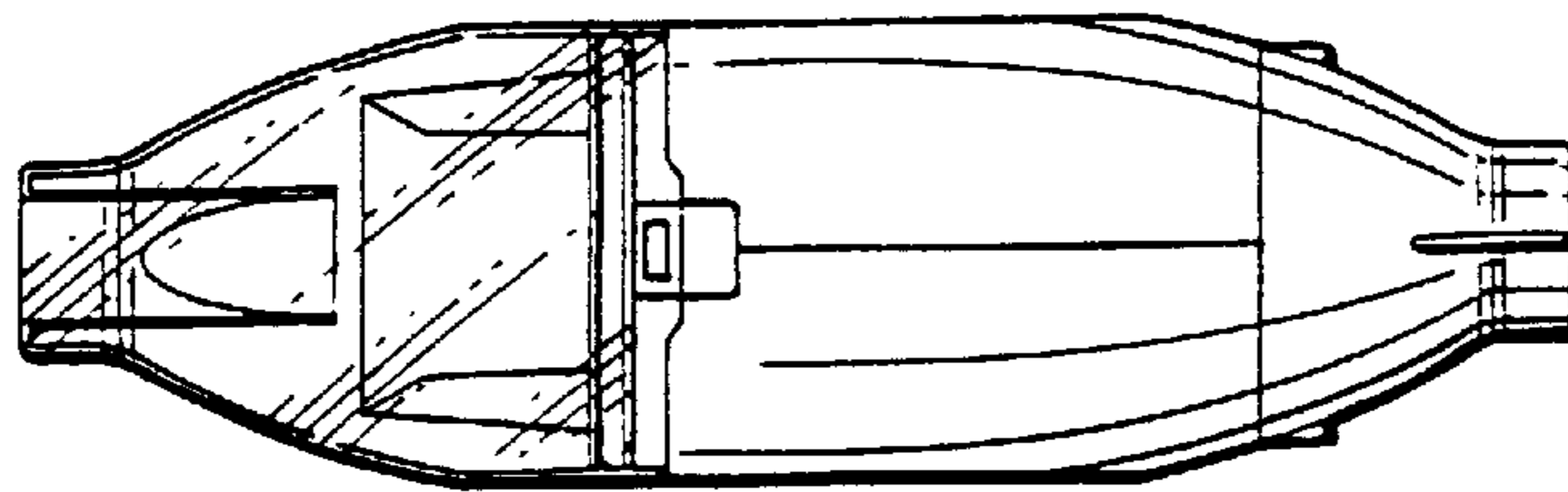

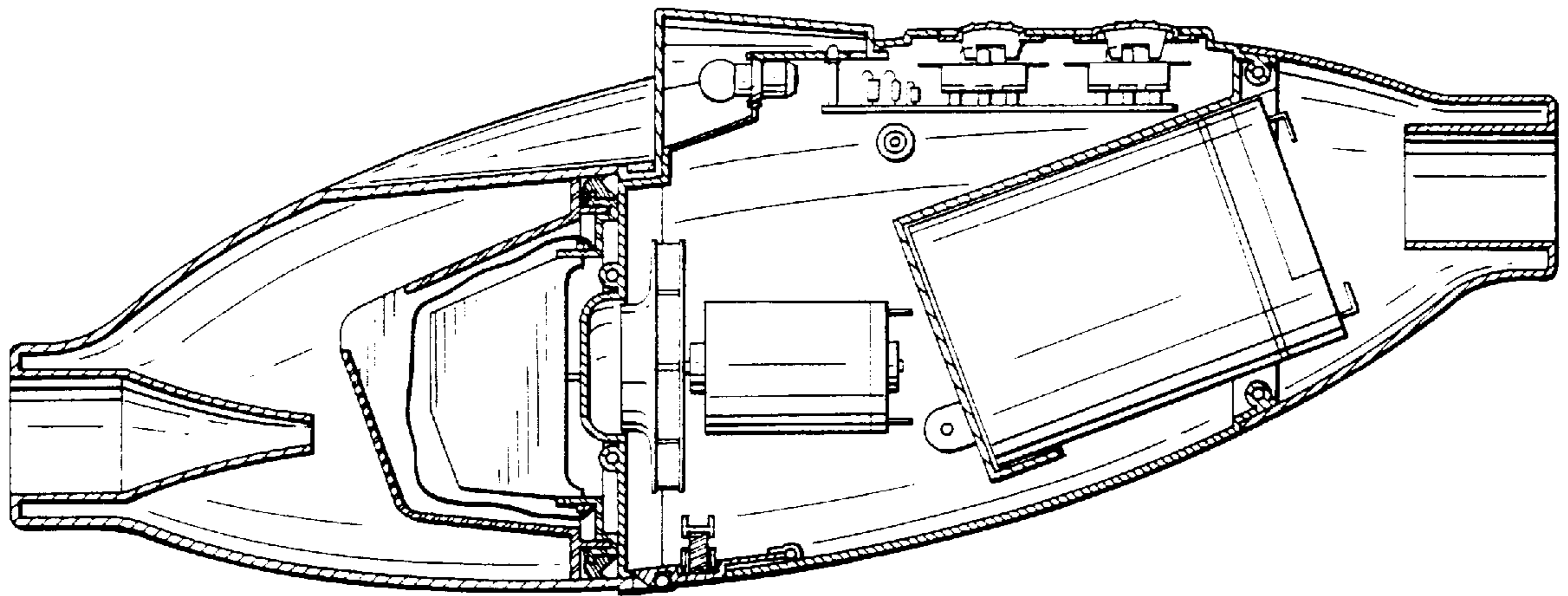
