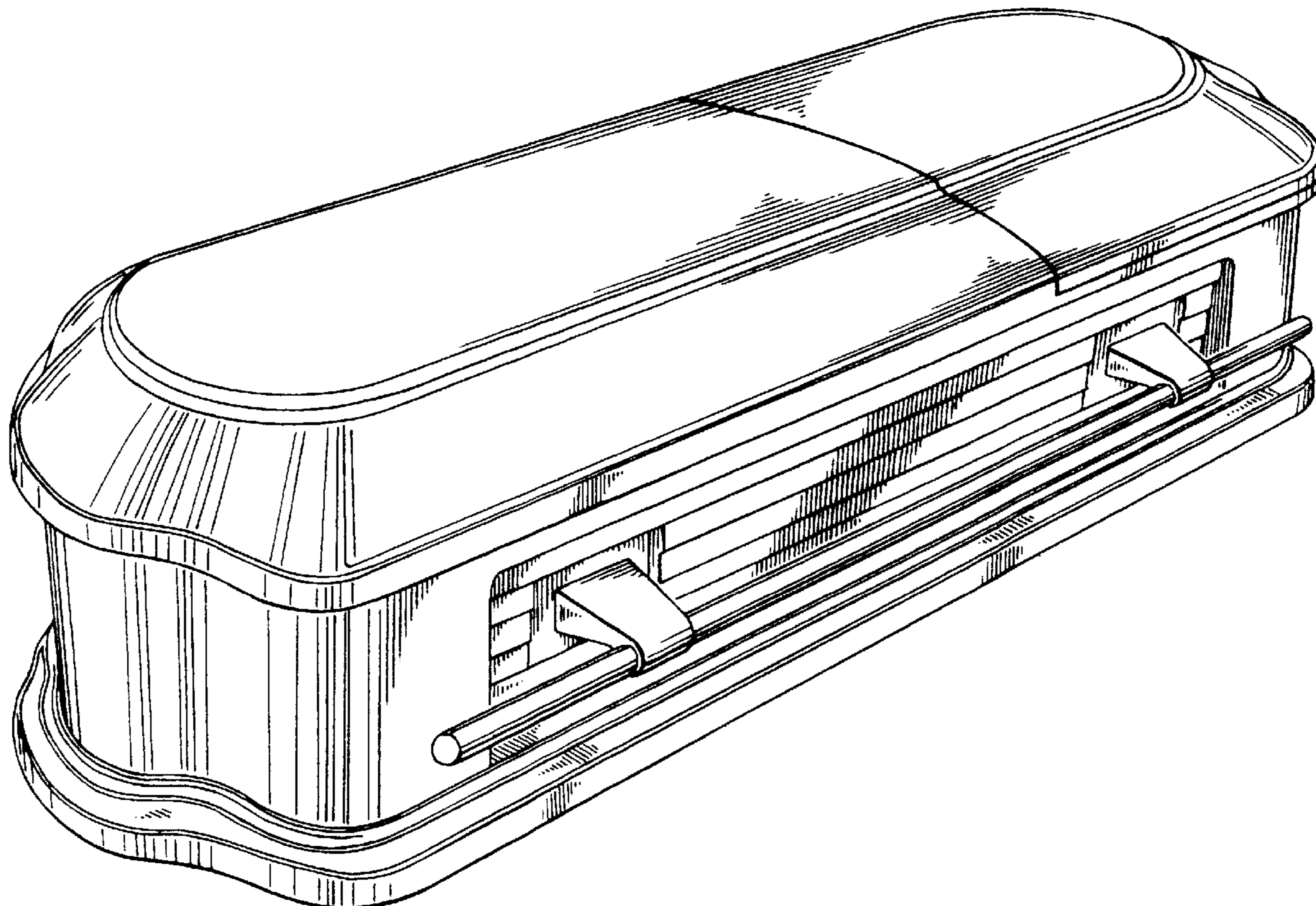
[57] CLAIM

I claim the ornamental design for a casket, as shown.

DESCRIPTION

FIG. 1 is a front perspective view taken from the left side showing my new design;
FIG. 2 is a top plan view of the design;

FIG. 5 is a rear elevation of the design;

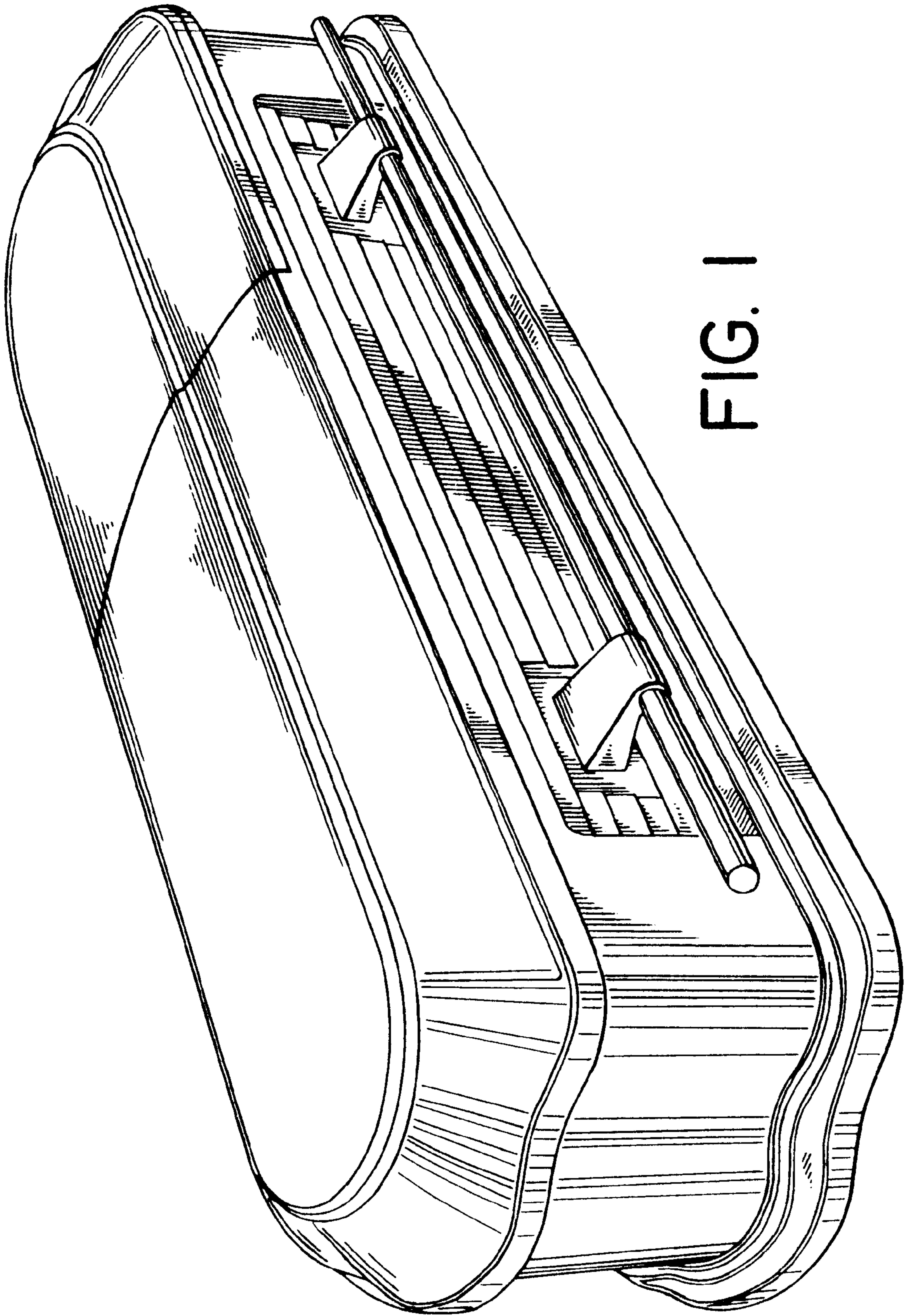
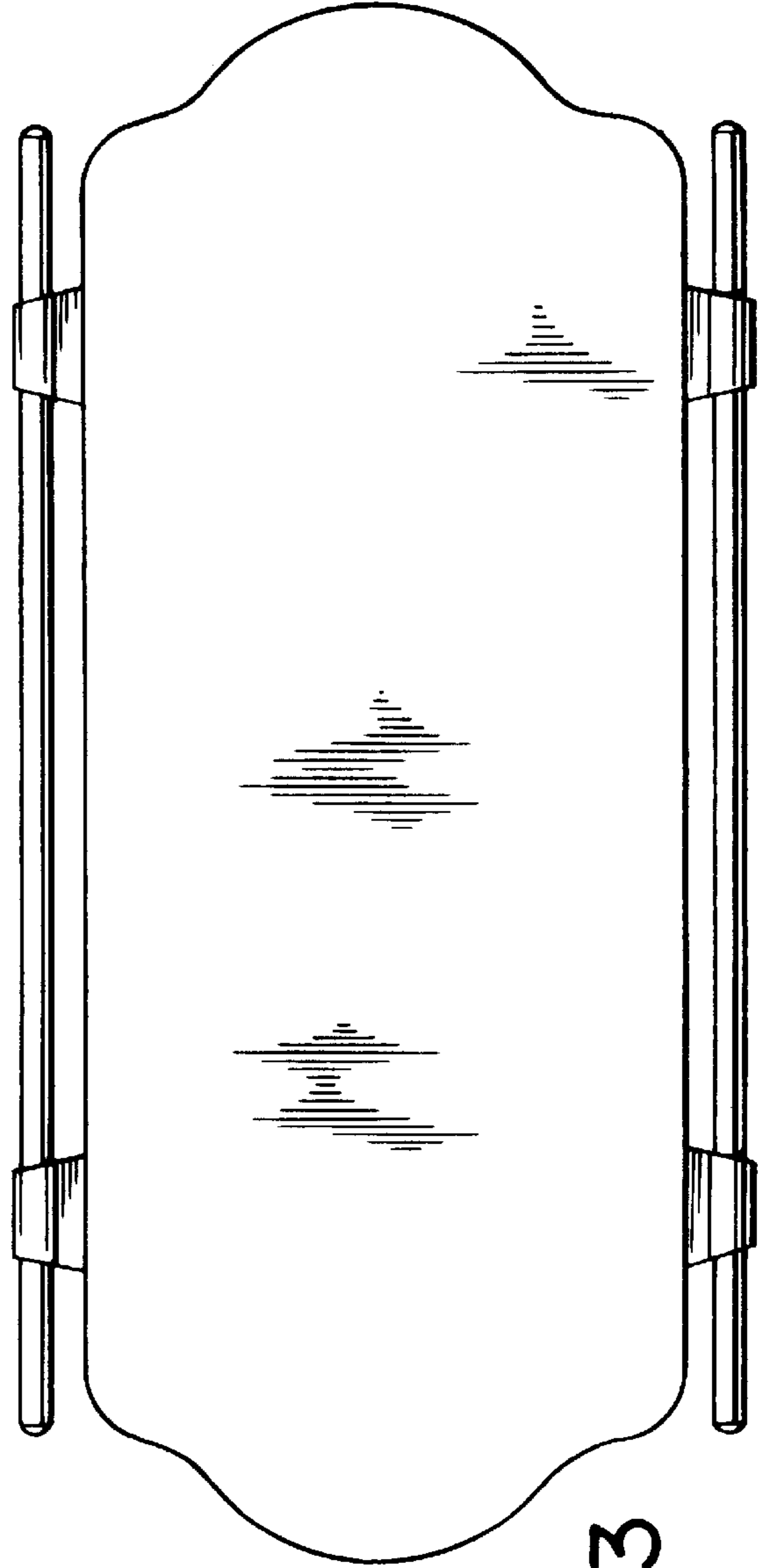
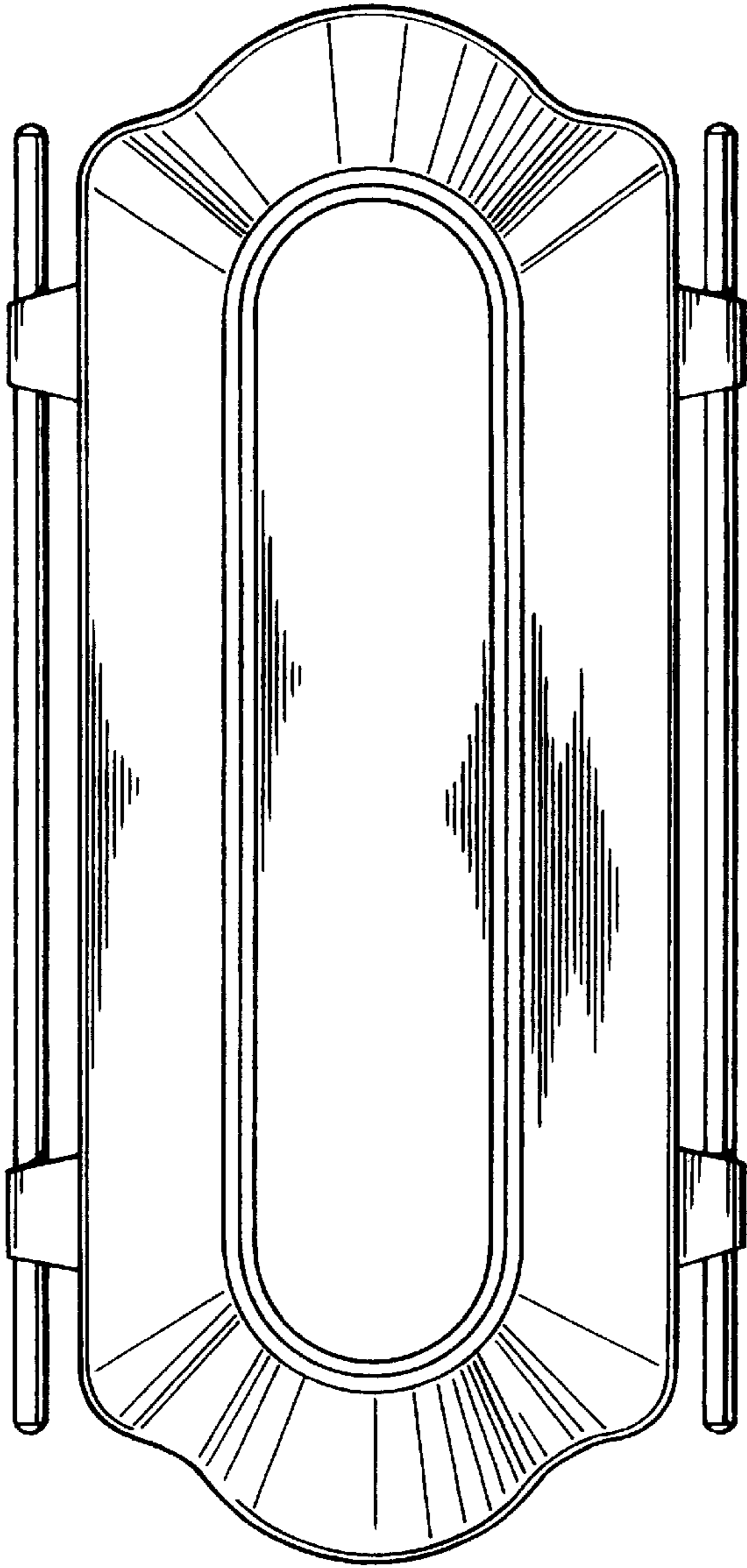

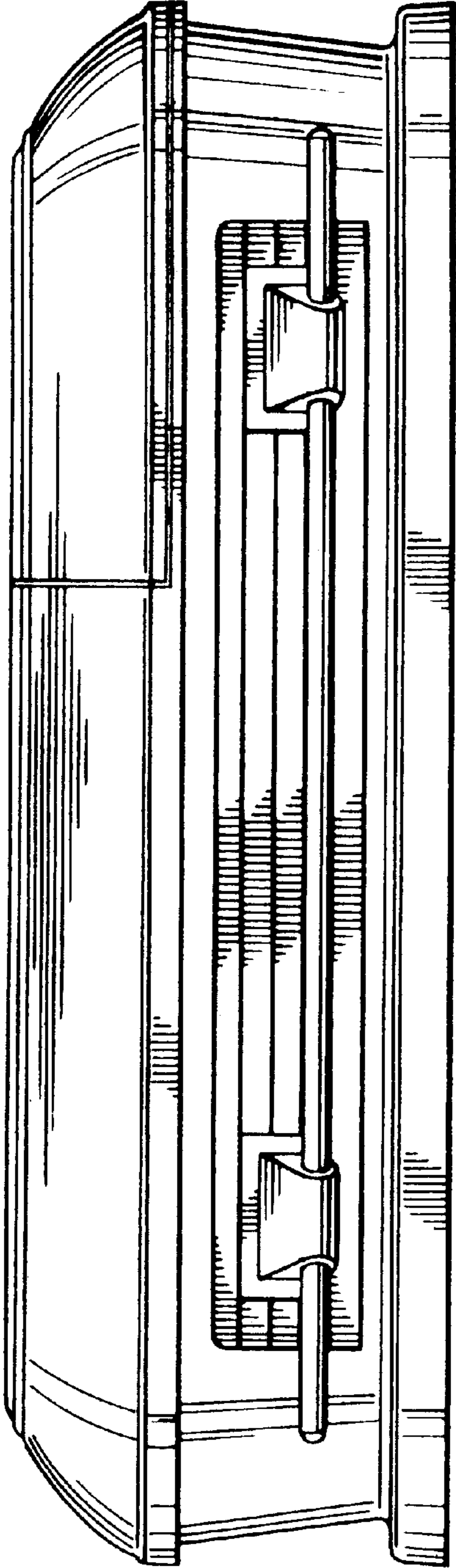

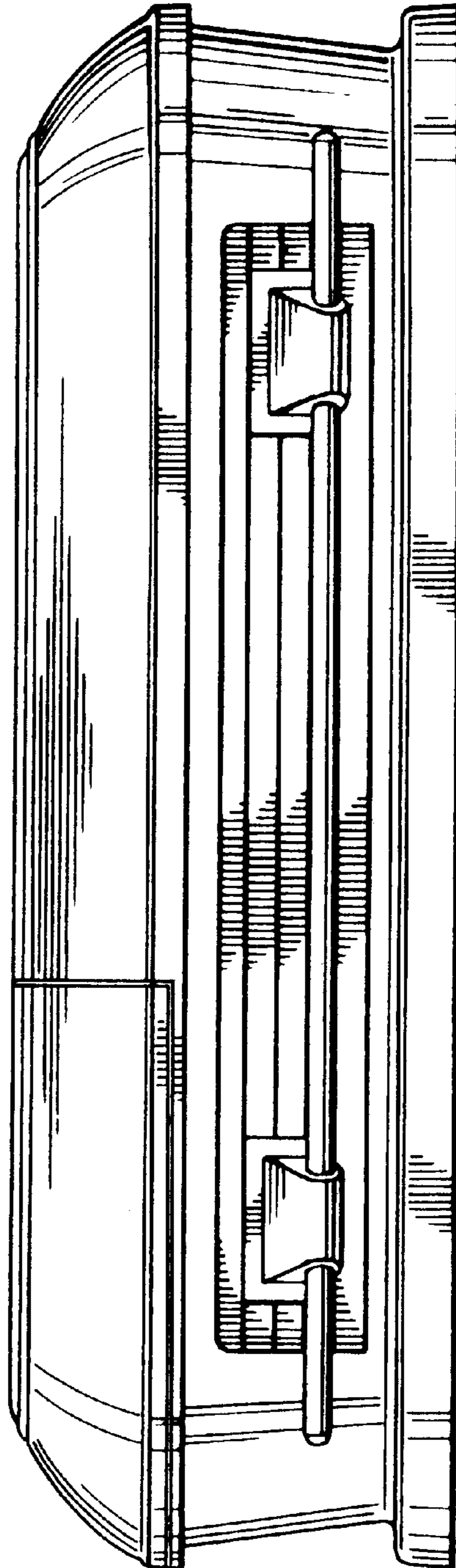

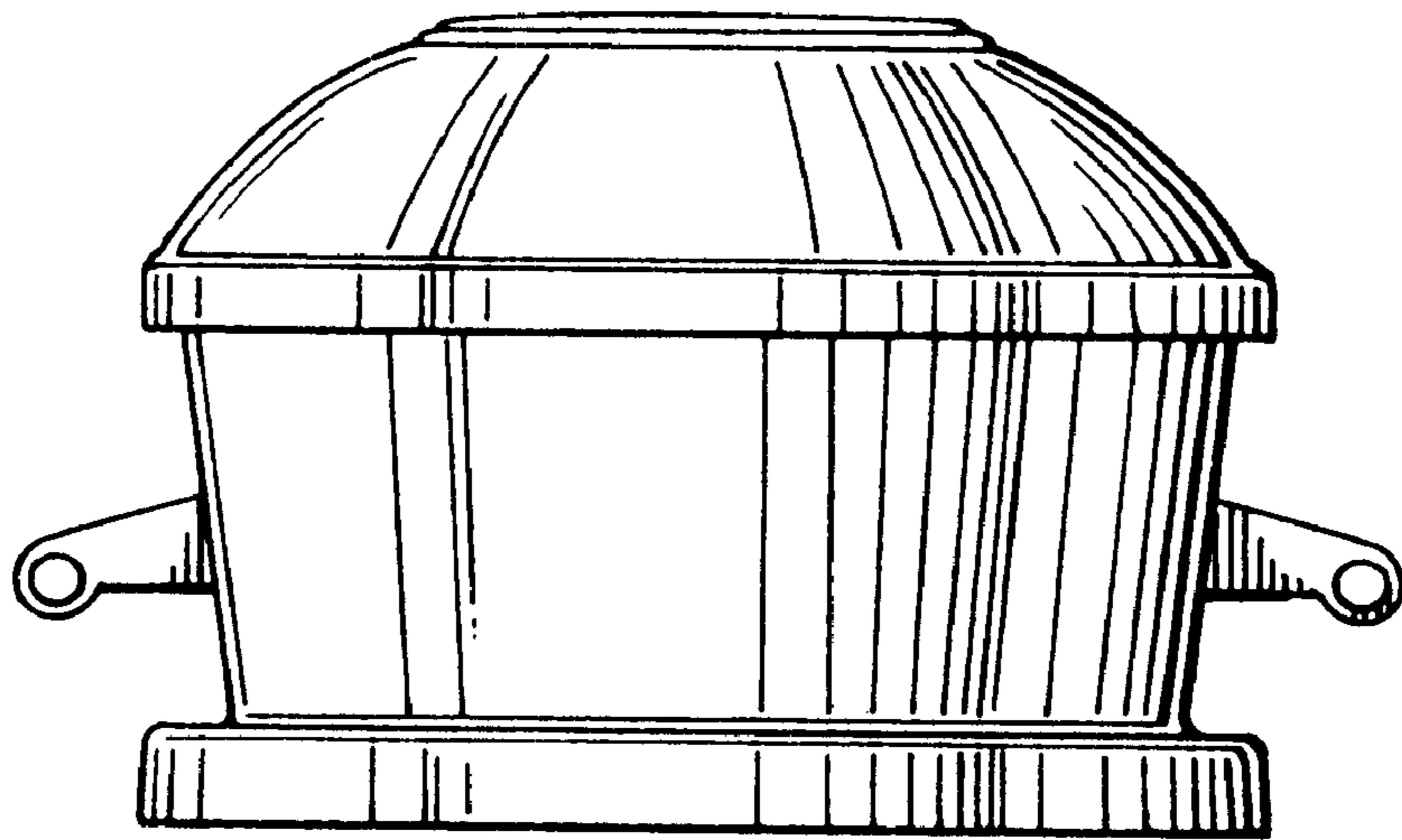

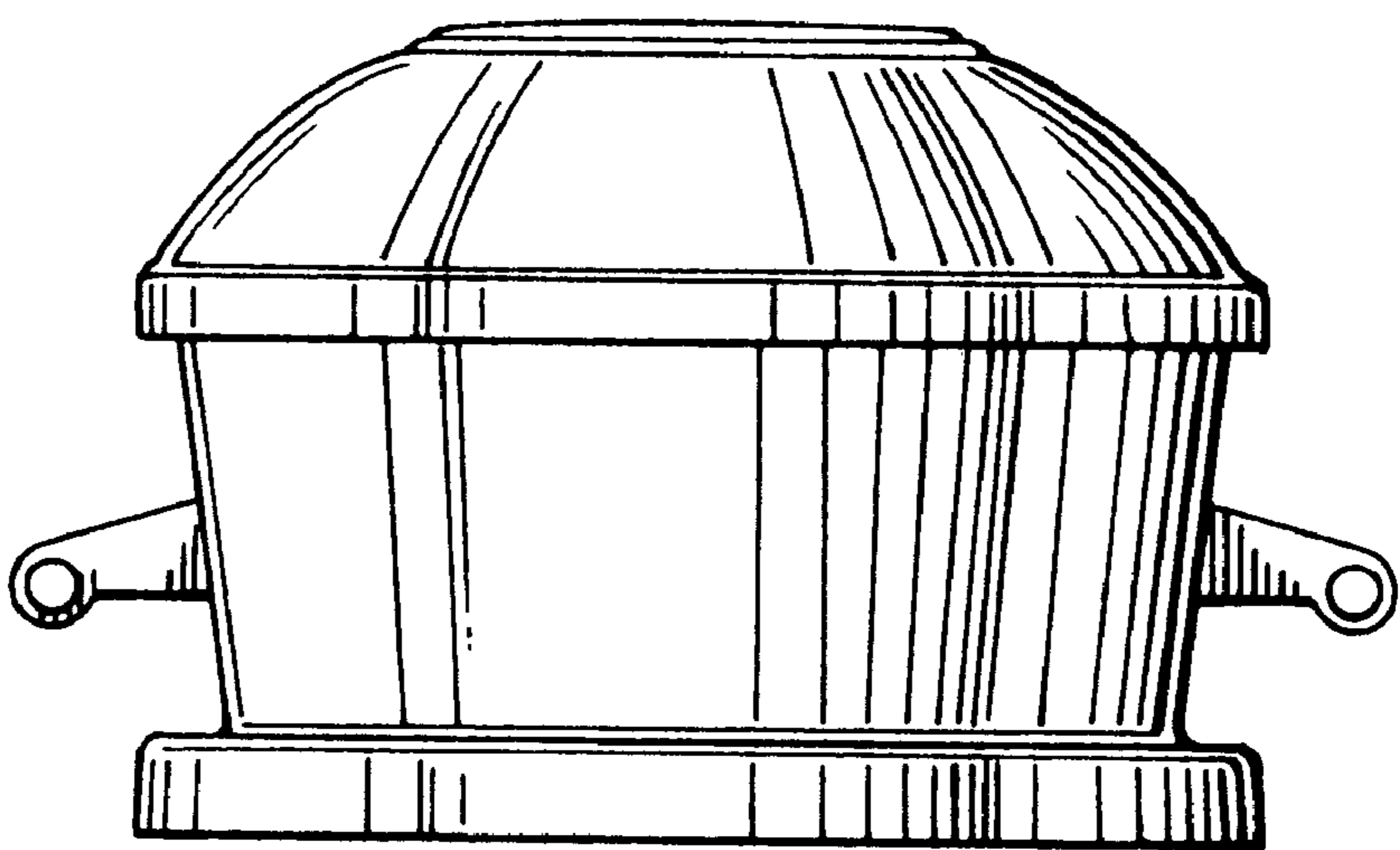
