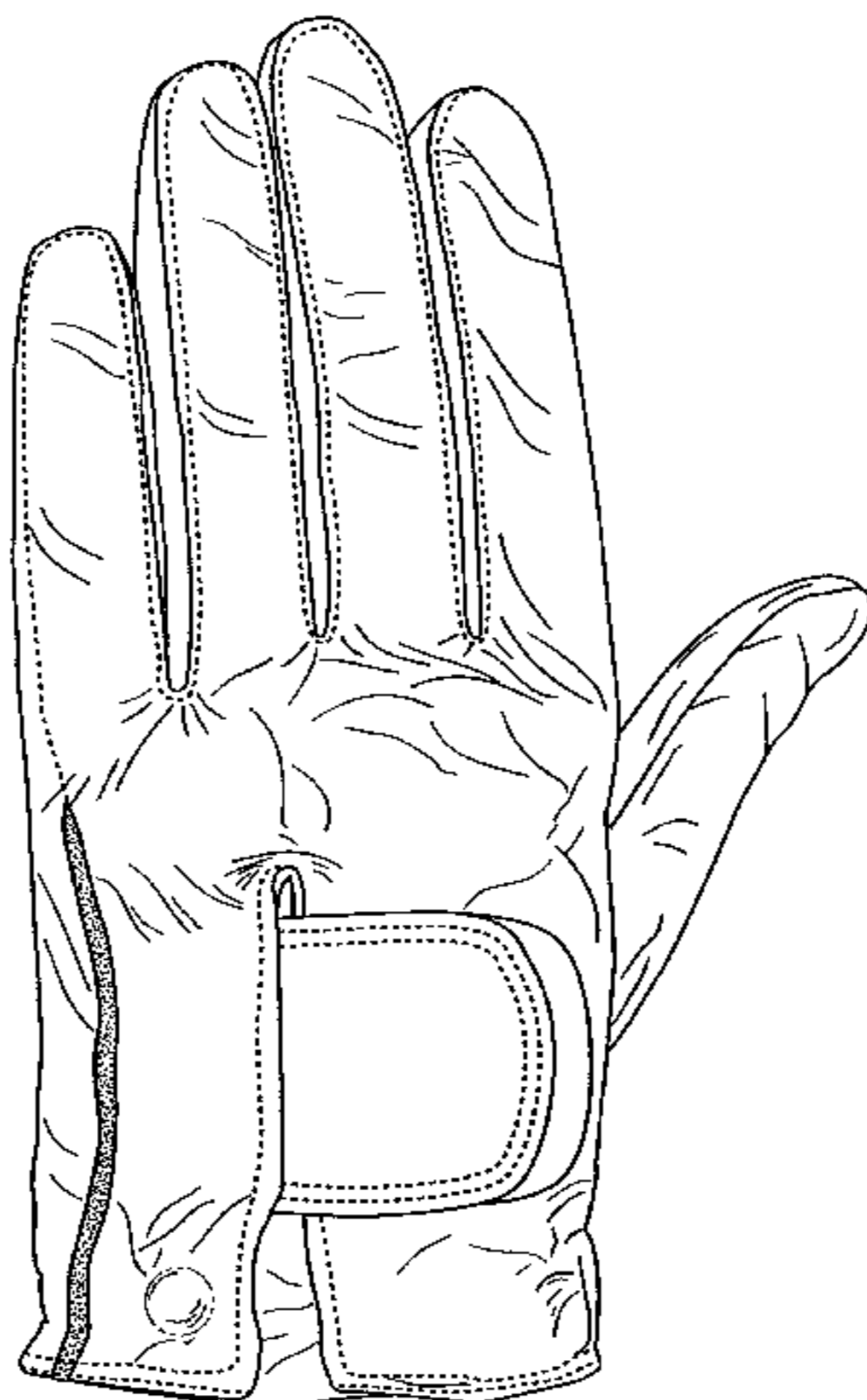

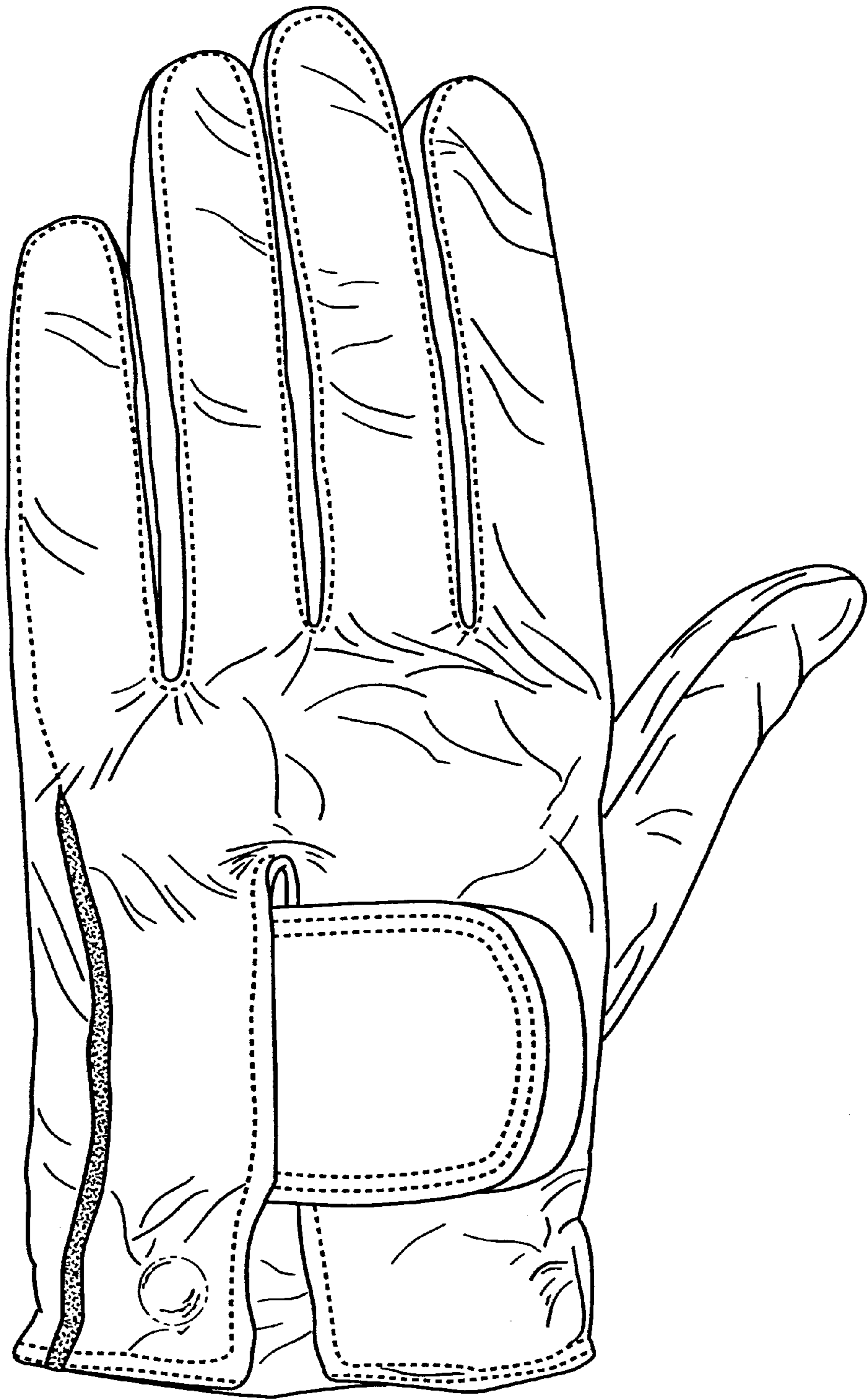
The ornamental design for a glove with an enhanced outside edge seam, as shown and described.

**DESCRIPTION**

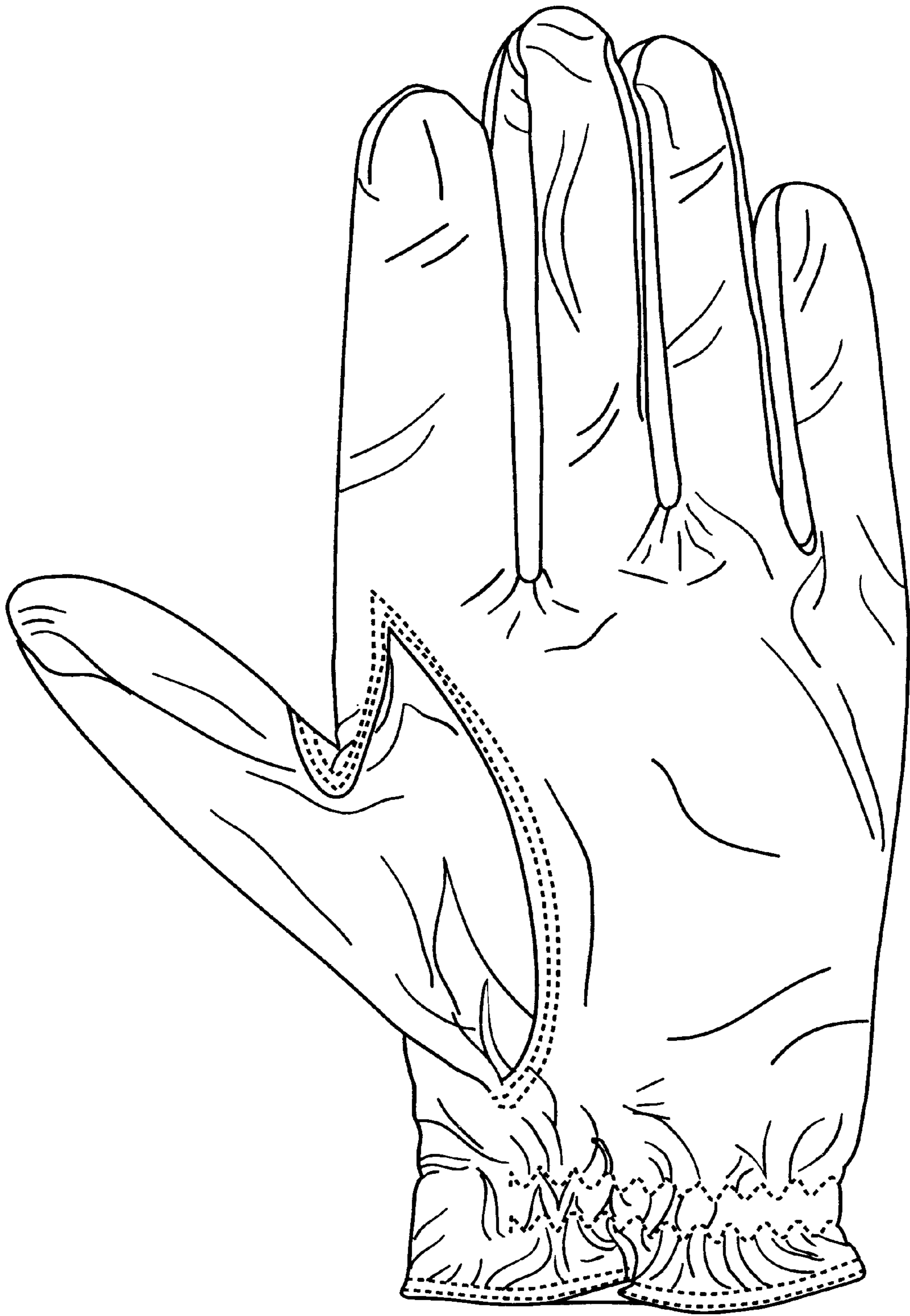
FIG. 1 is a top view of a glove with an enhanced outside edge seam showing our new design, the enhanced outside edge seam being of a different color from the glove; FIG. 2 is a bottom view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a front end view thereof; and, FIG. 6 is a back end view thereof. The broken lines showing of a snap and stitching on the overall surface of the glove are for illustrative purposes only and form no part of the claimed design.

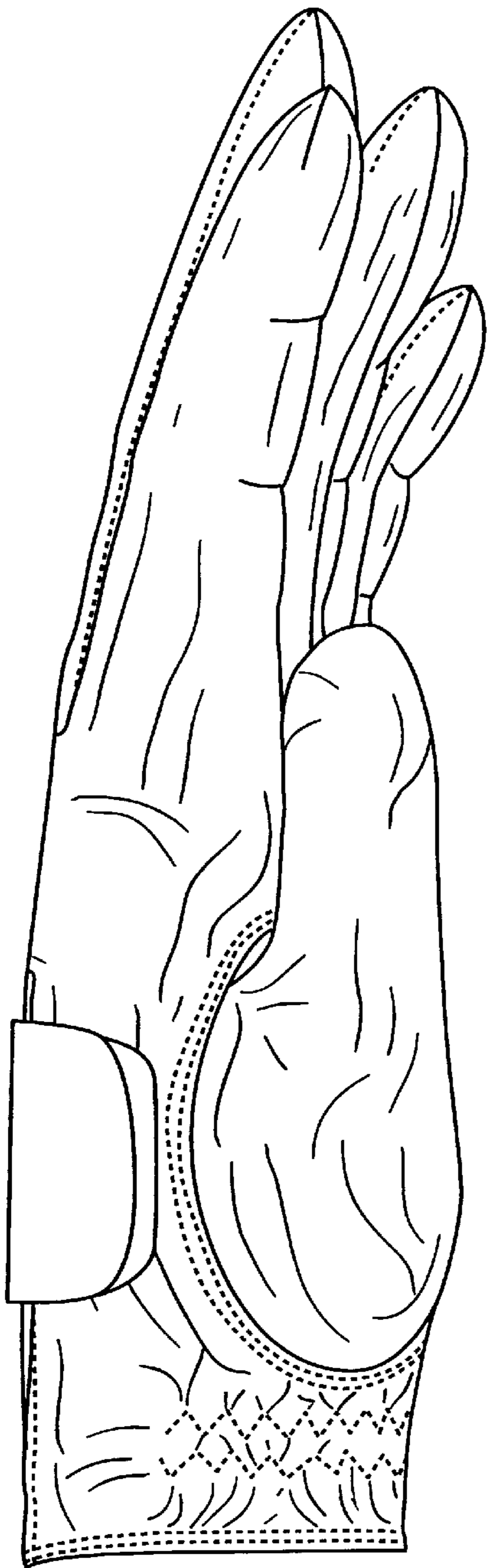




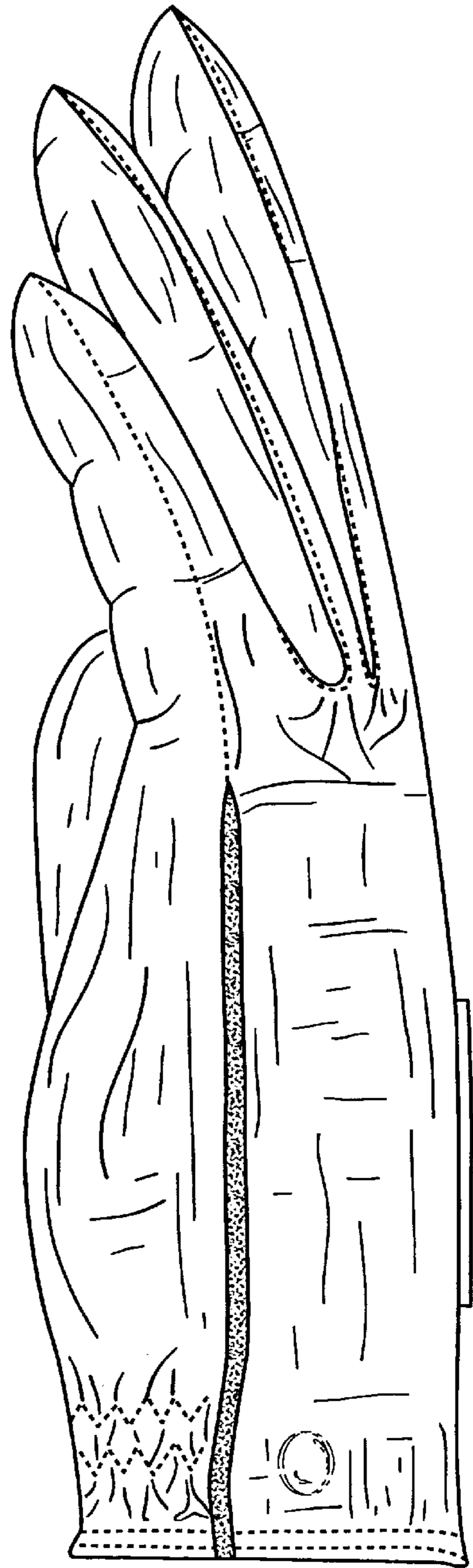

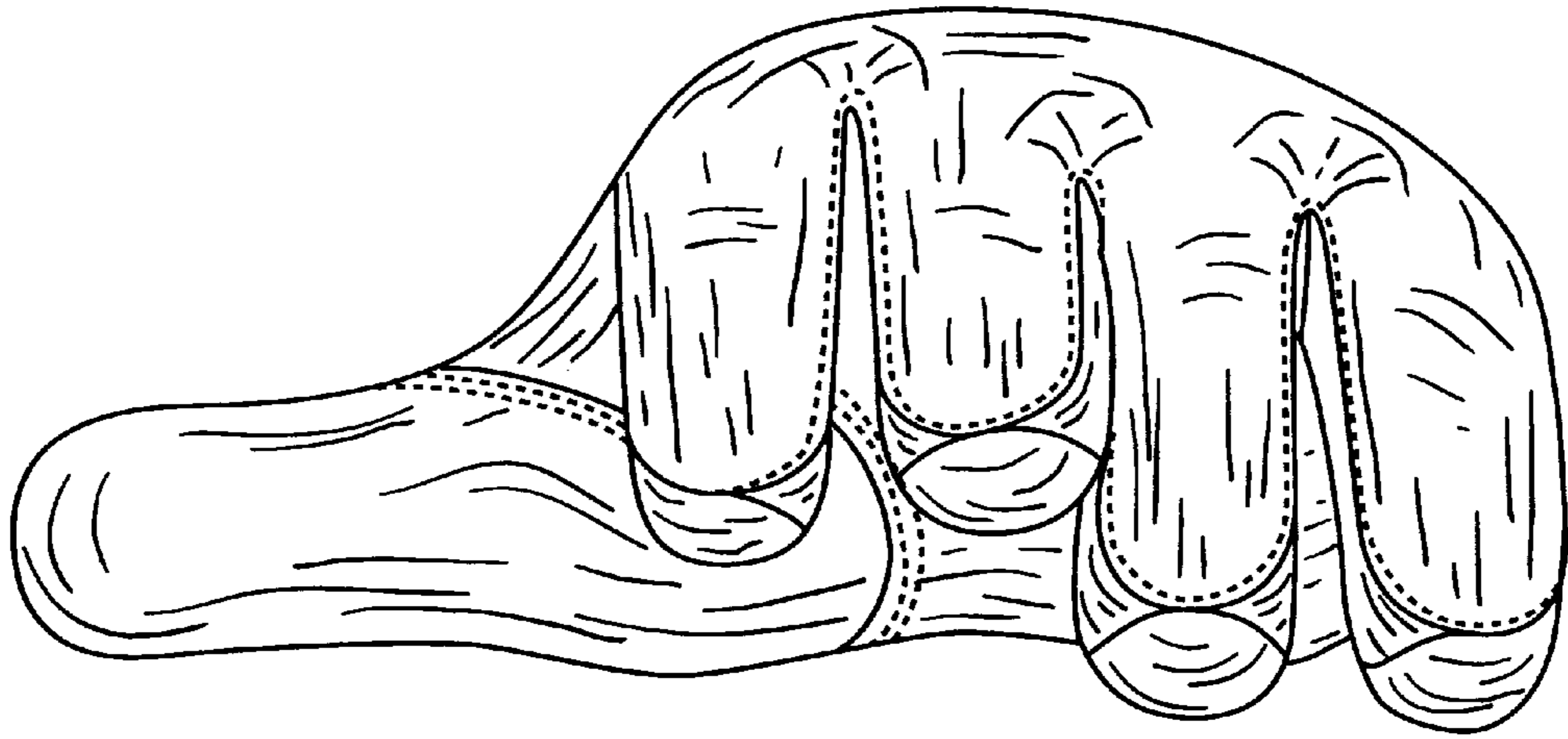

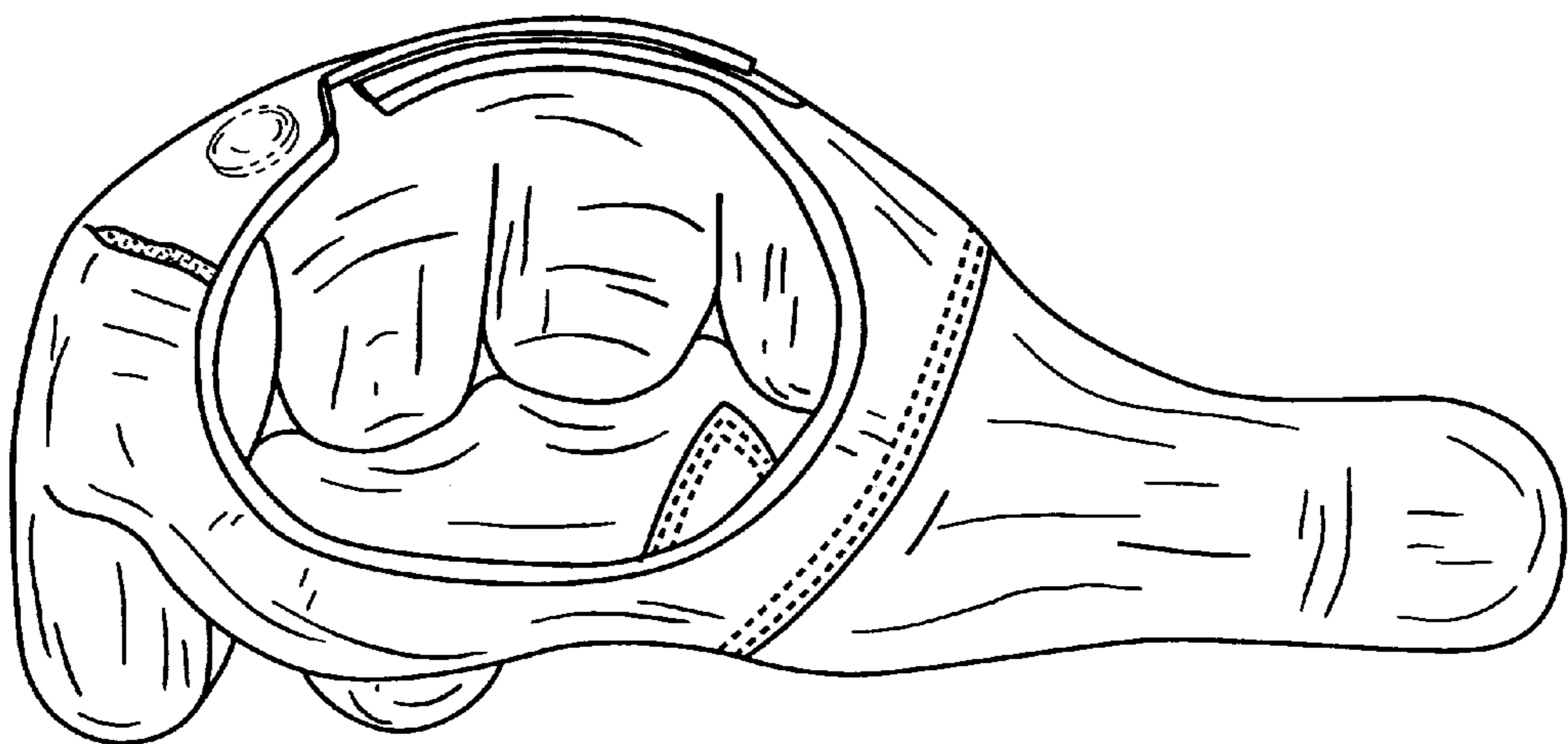
