DESCRIPTION

FIG. 1 is a top and left side perspective view of a clog type shoe embodying our new design;
FIG. 2 is a right side and lengthwise cross-sectional view thereof taken along line 2—2 in FIG. 9;
FIG. 3 is a widthwise cross-sectional view thereof taken along line 3—3 in FIG. 9;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a top, front and right side perspective view thereof;
FIG. 8 is a top, front and left side perspective view thereof;
FIG. 9 is a top plan view thereof; and,
FIG. 10 is a bottom plan view thereof.

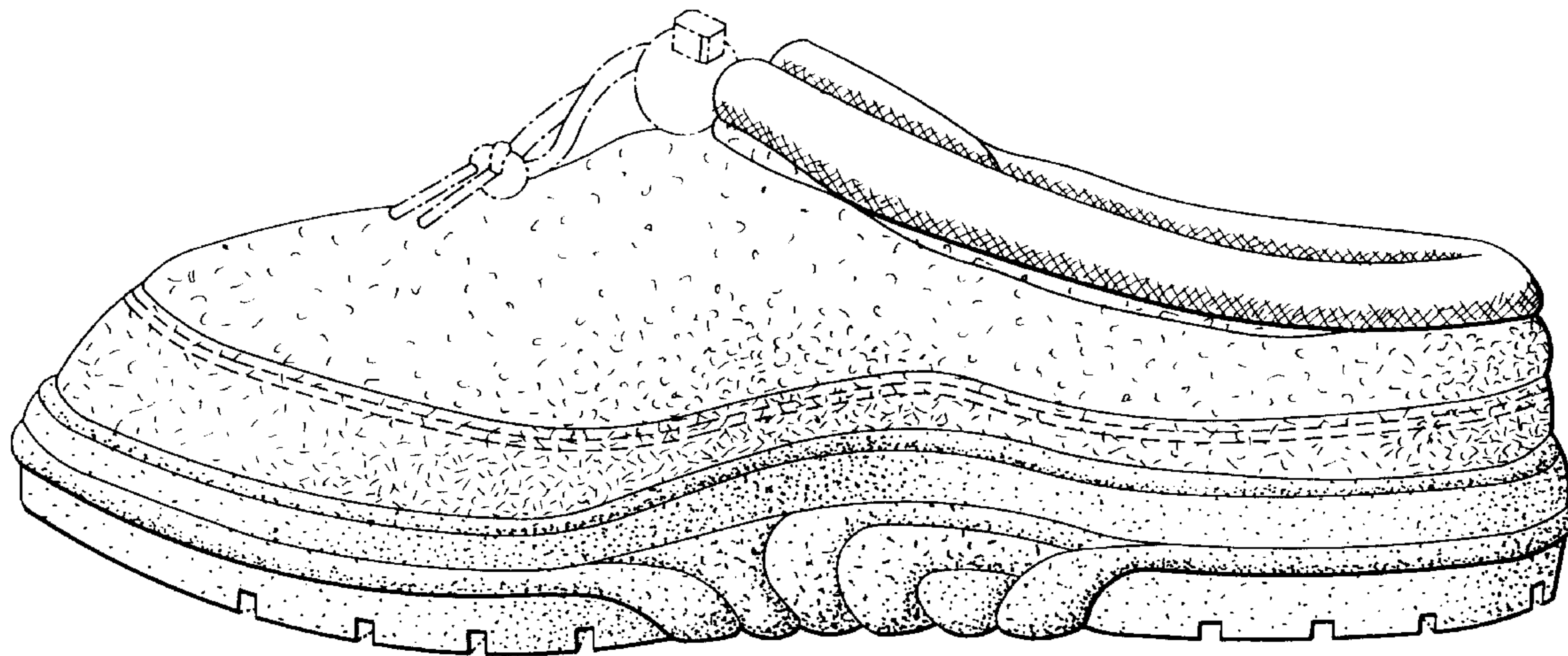

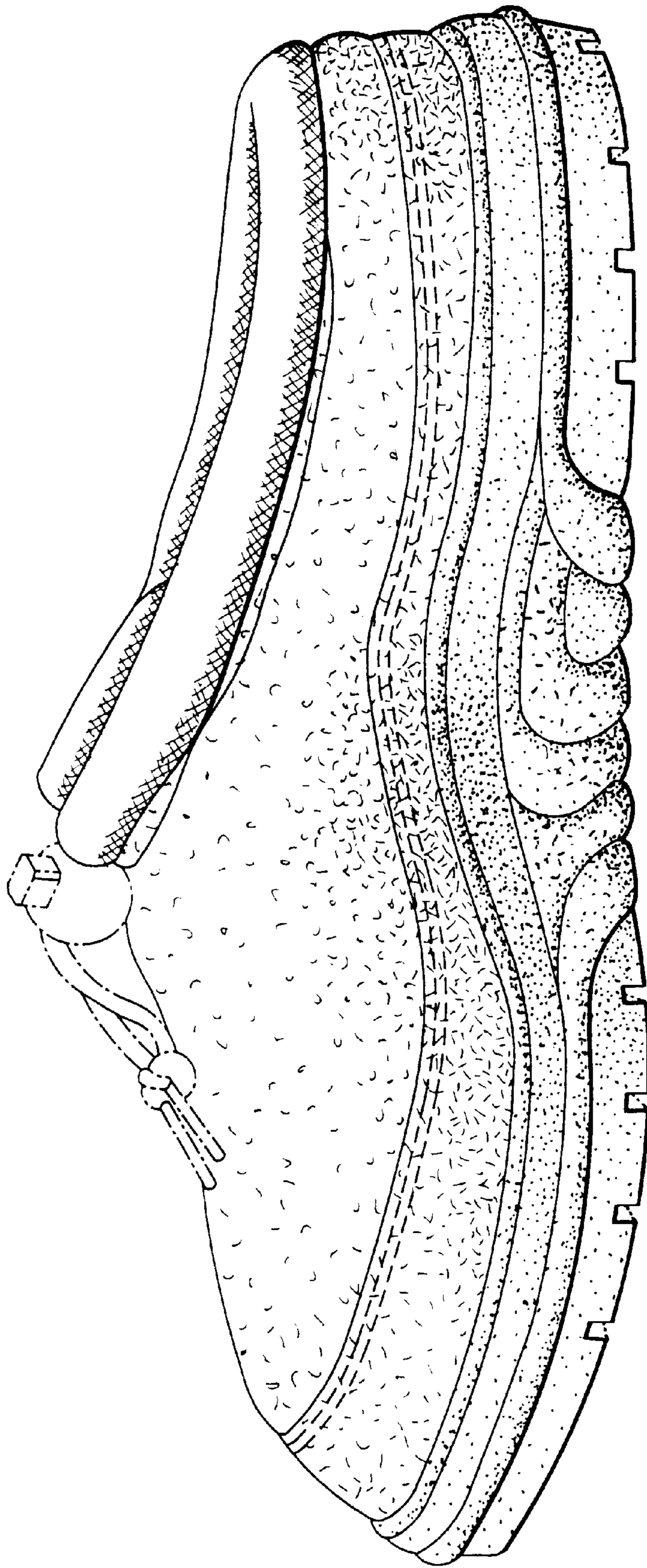

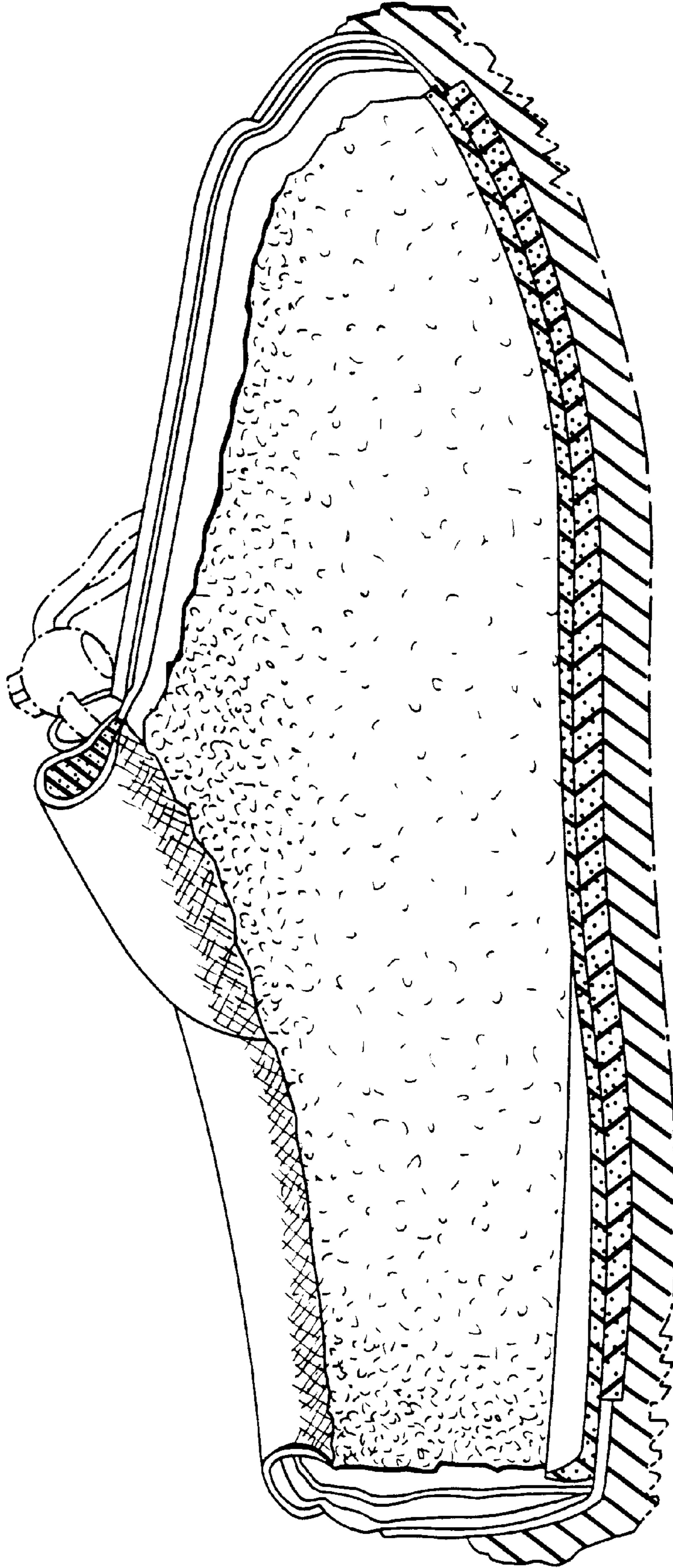

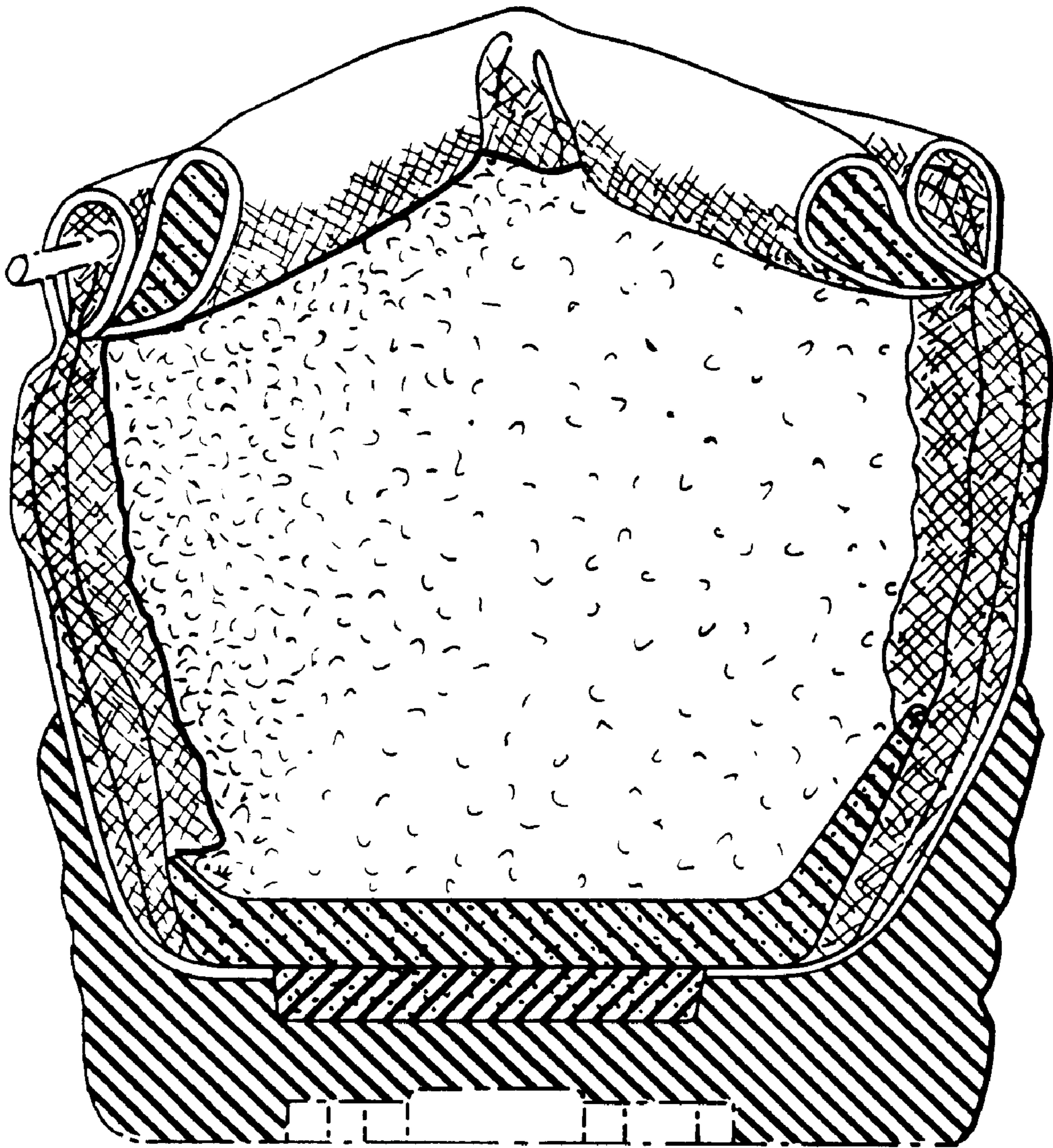

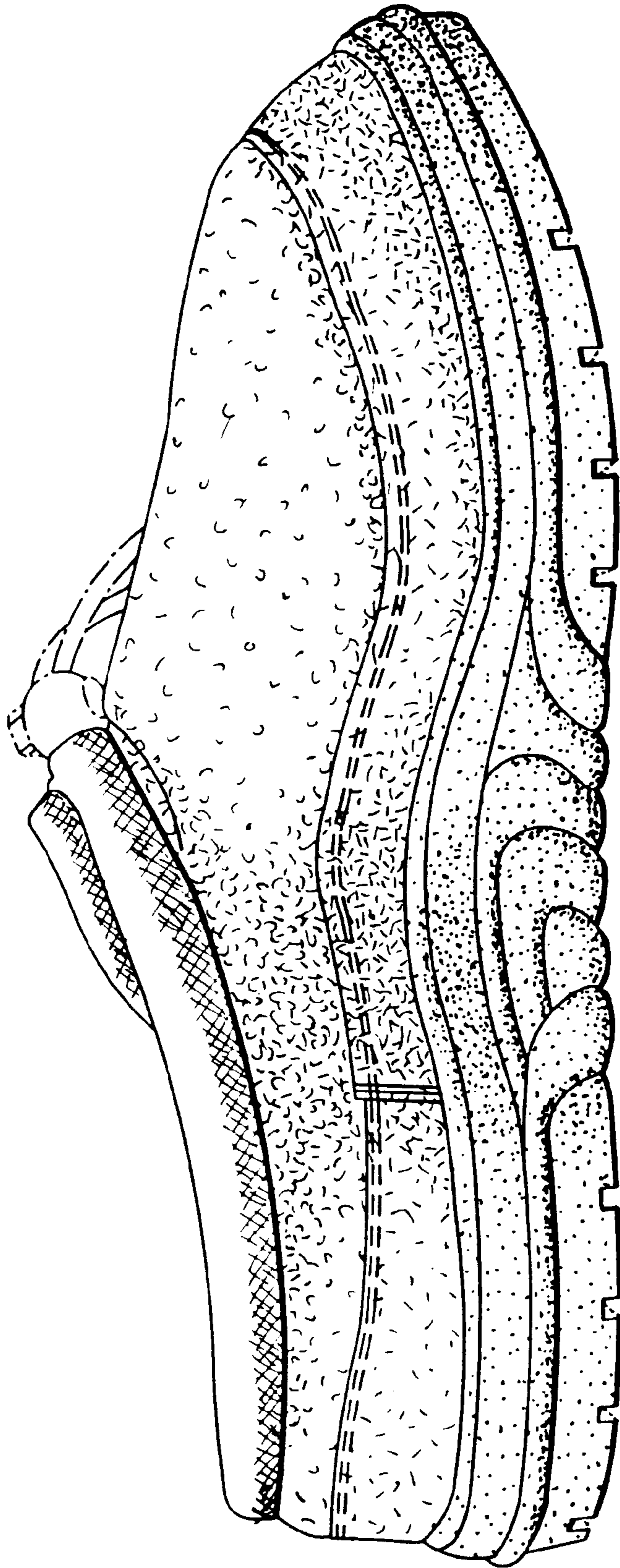

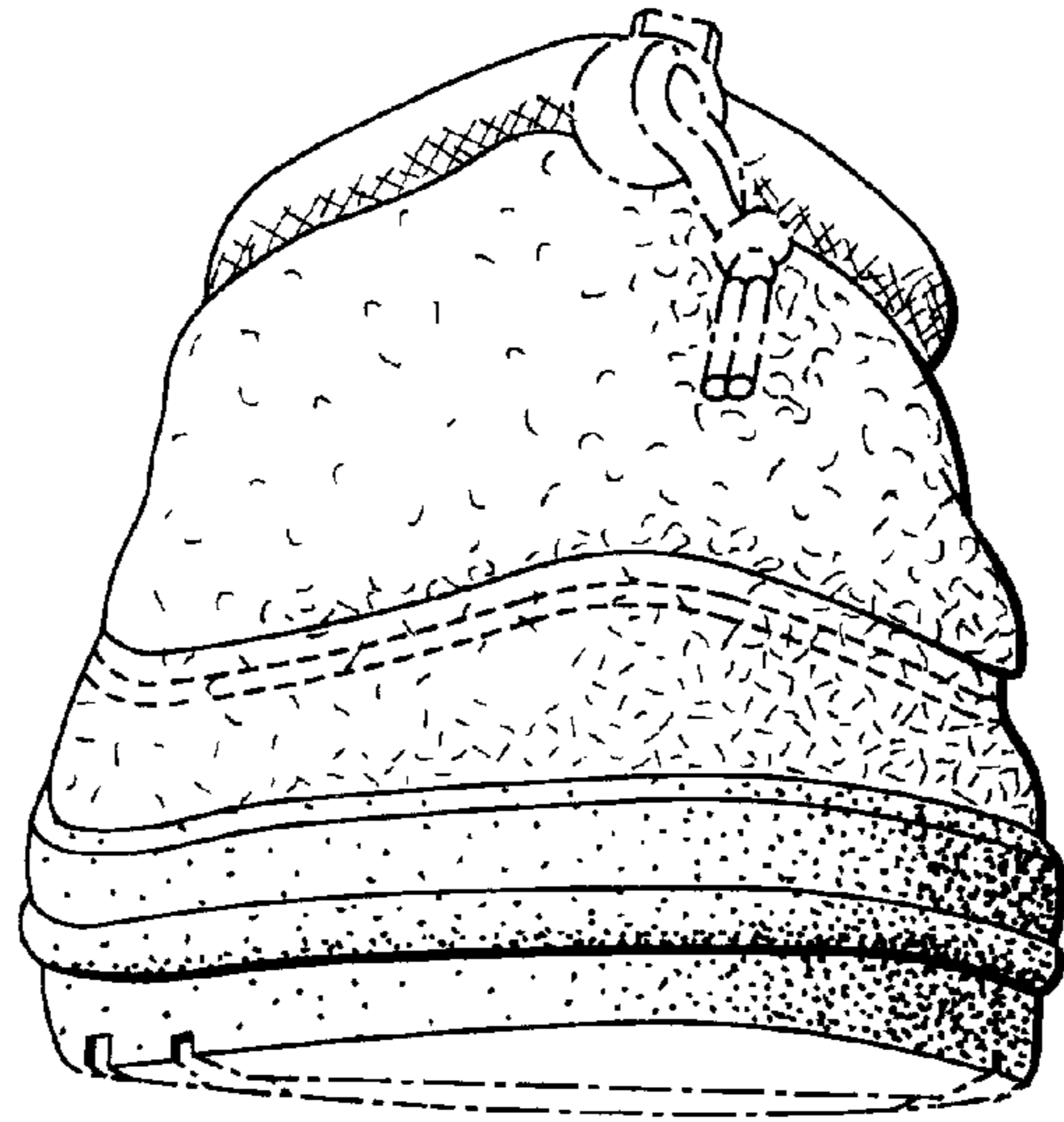

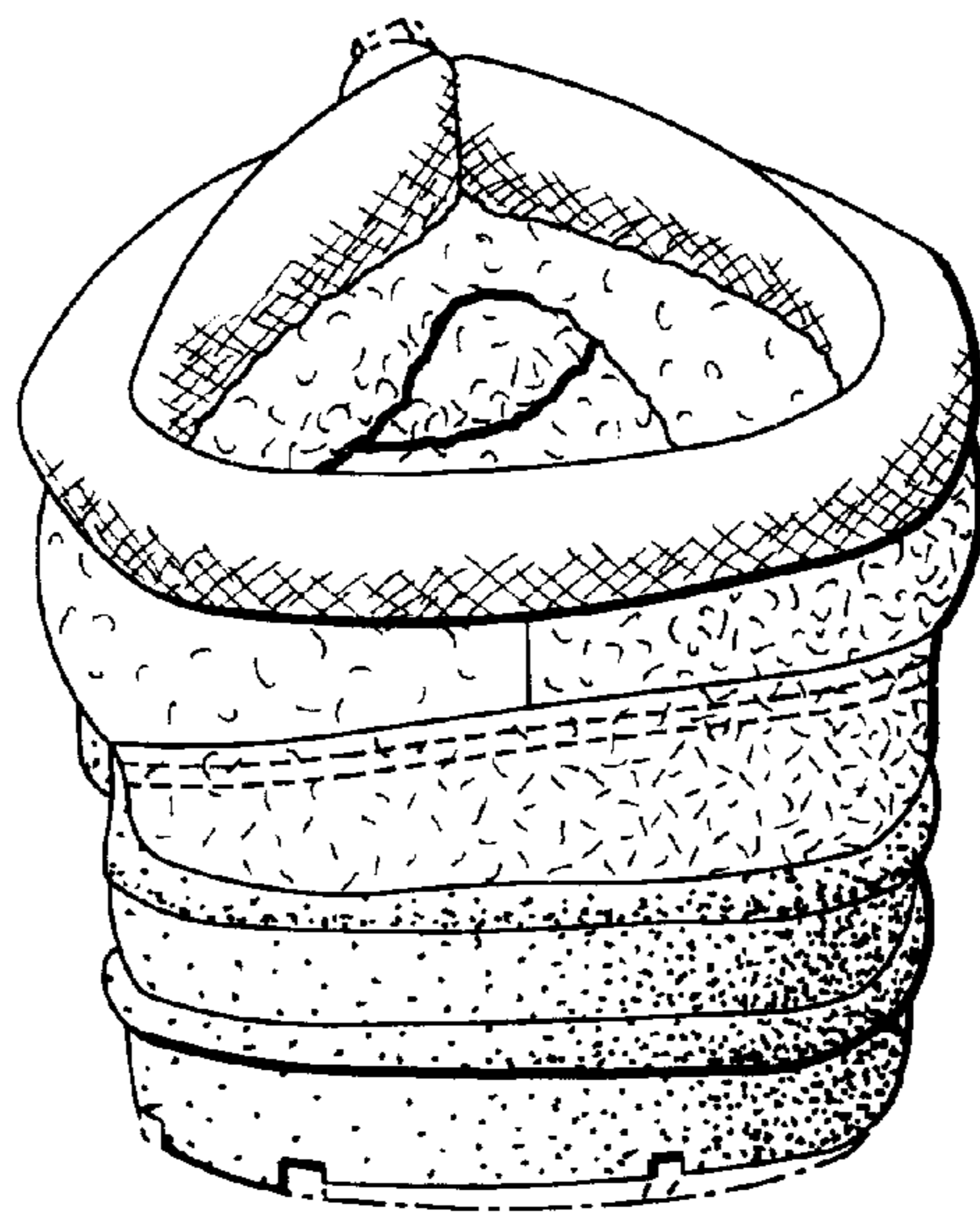

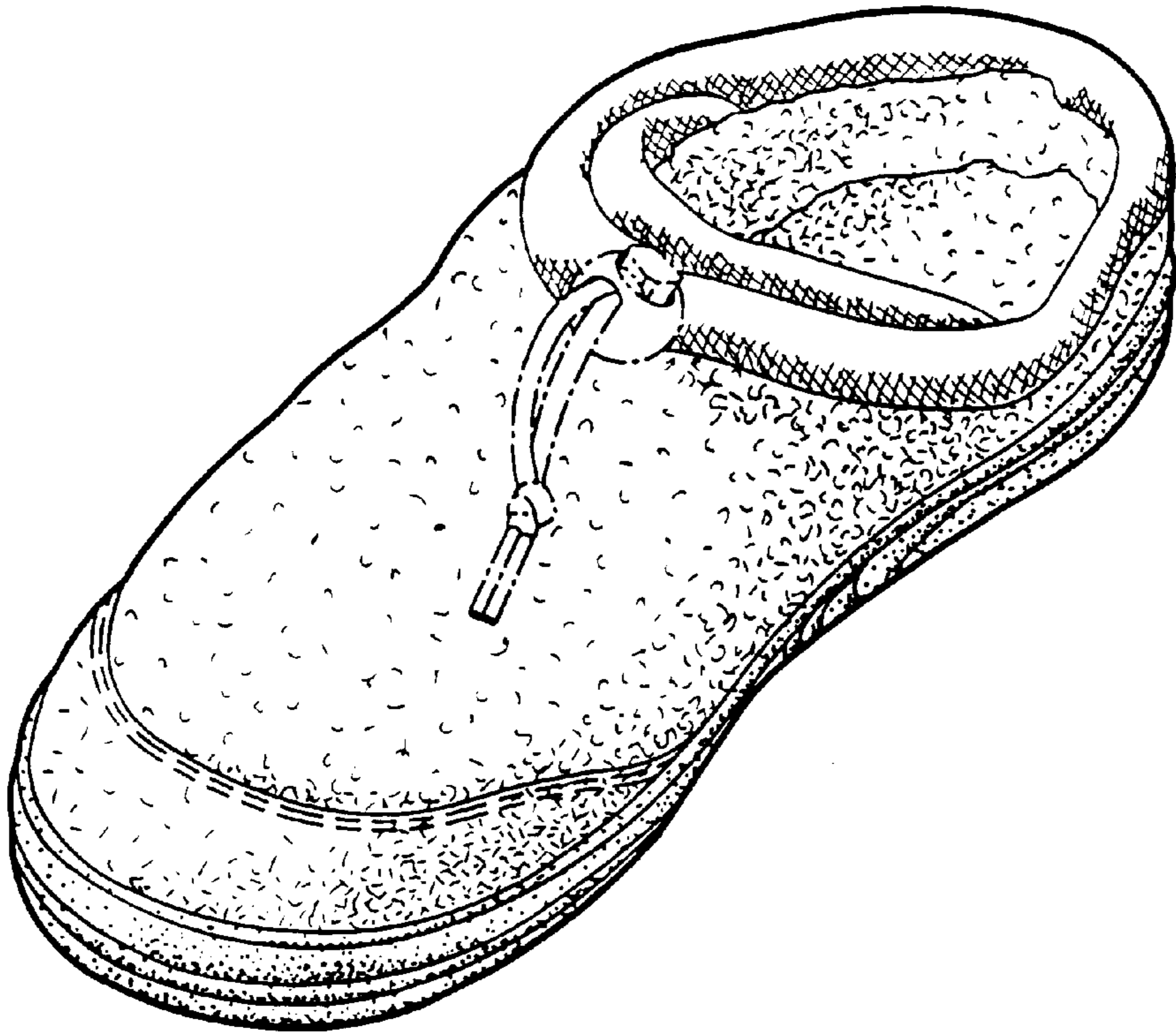

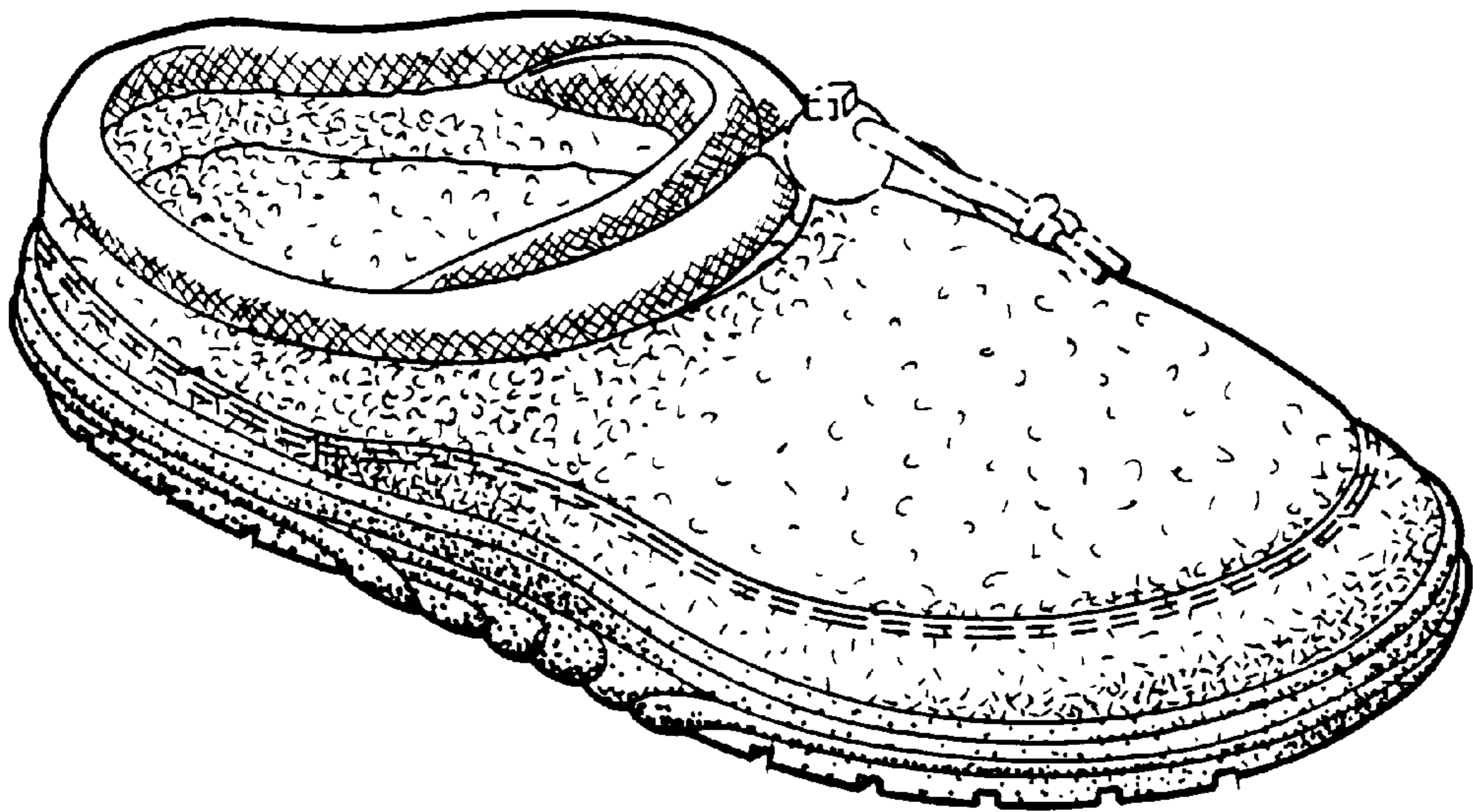

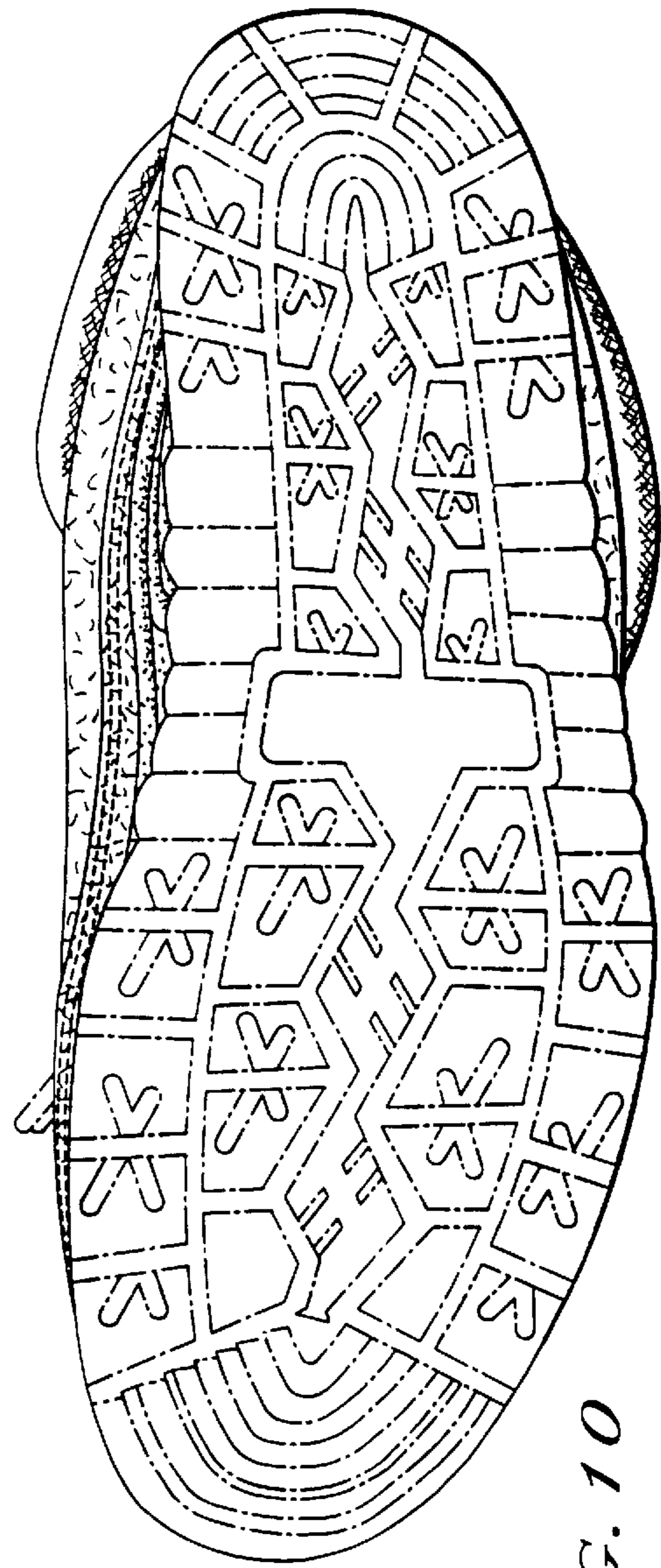
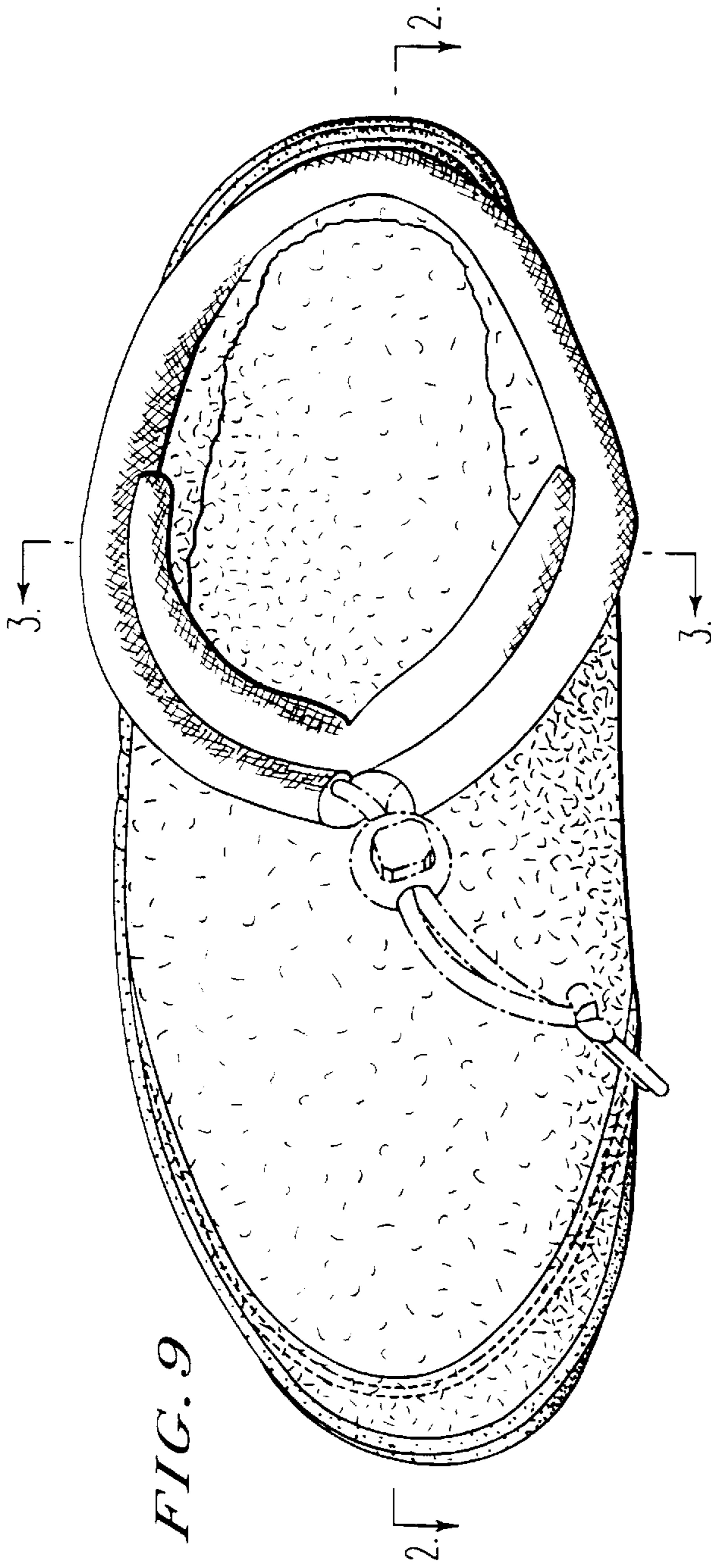
