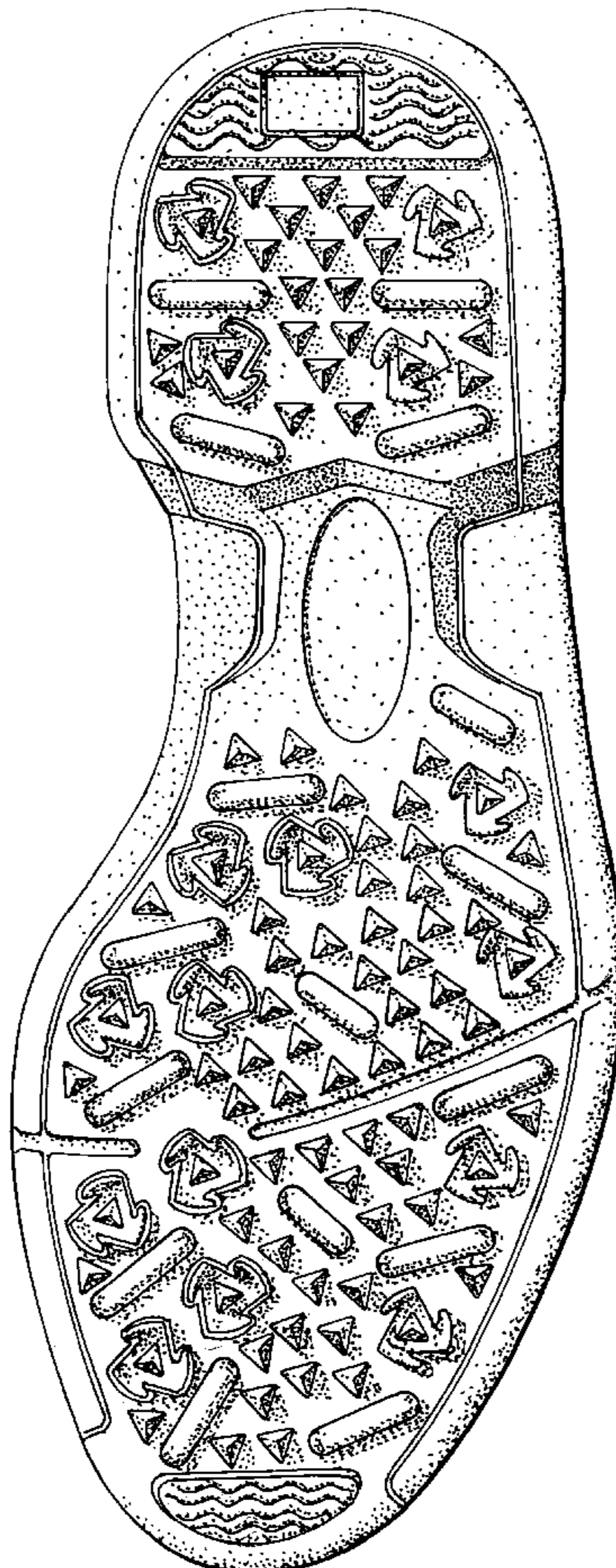
[57] **CLAIM**

The ornamental design for an outsole for golf shoe, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of an outsole for golf shoes showing my new design;
FIG. 2 is a right side elevational view thereof;
FIG. 3 is a left side elevational view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view thereof.

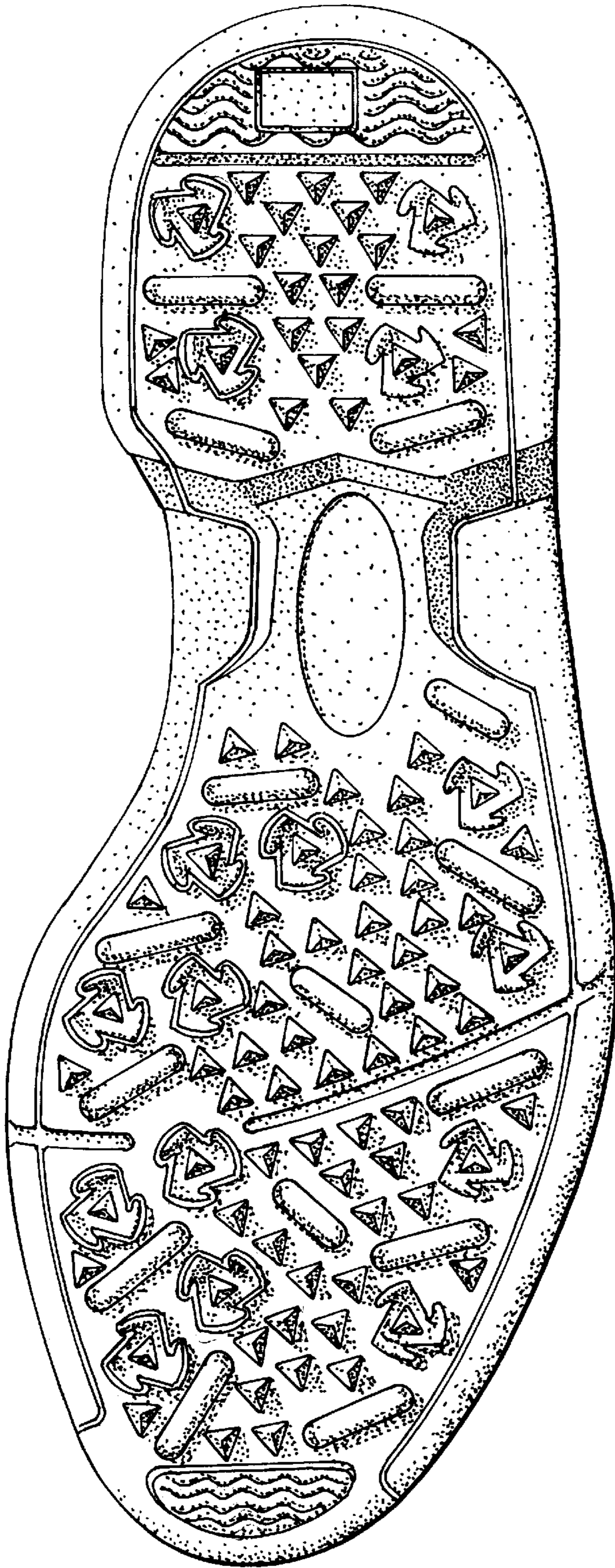

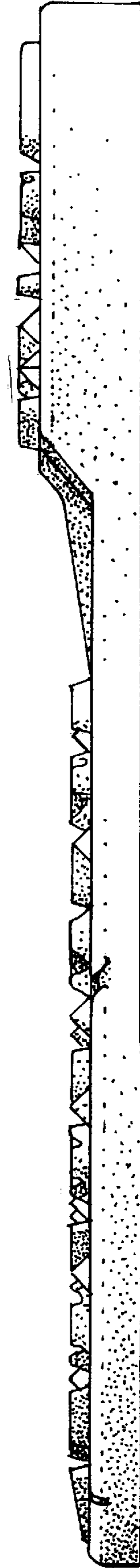

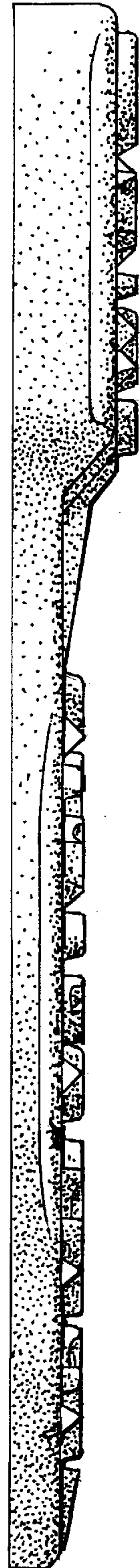

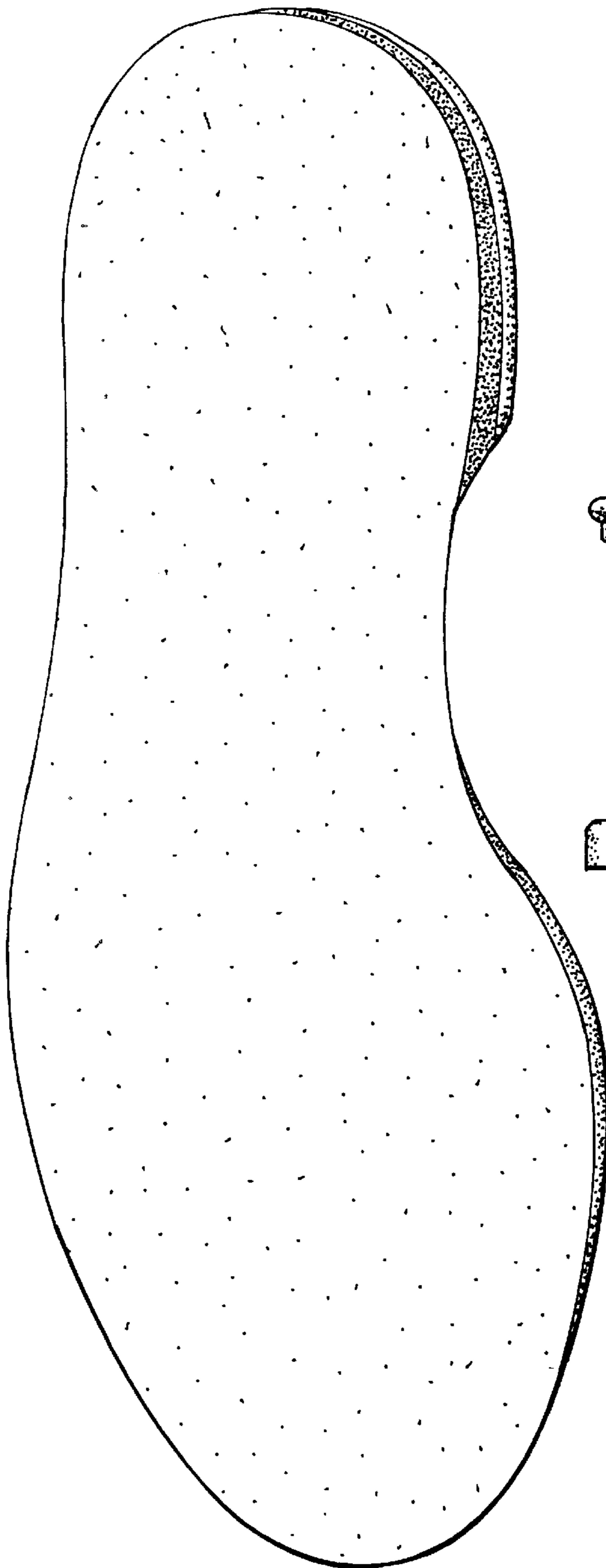
