## [57] **CLAIM**

The ornamental design for a lanyard buckle, as shown and described.

## **DESCRIPTION**

FIG. 1 is a front perspective view of a lanyard buckle showing my new design;

FIG. 2 is a top plan view;

FIG. 3 is a front elevational view;

FIG. 4 is a right side elevational view, the left side view being a mirror image;

FIG. 5 is a bottom plan view;

FIG. 6 is a perspective view of the male portion of the buckle, the female portion has been removed for ease of illustration;

FIG. 7 is a top plan view of FIG. 6;

FIG. 8 is a front elevational view of FIG. 6;

FIG. 9 is a right side elevational view of FIG. 6, the left side view being a mirror image;

FIG. 10 is a bottom plan view of FIG. 6;

FIG. 11 is a perspective view of the female portion of the buckle, the male portion being removed for ease of illustration;

FIG. 12 is a top plan view of FIG. 11;

FIG. 13 is a front elevational view of FIG. 11;

FIG. 14 is a right side elevational view of FIG. 11, the left side view being a mirror image; and,

FIG. 15 is a bottom plan view of FIG. 11.

The broken line showing of portions of the lanyard in FIGS. 1, 3, 4, 6, 8, 9, 11, 13 and 14 are for illustrative purposes only and form no part of the claimed design.

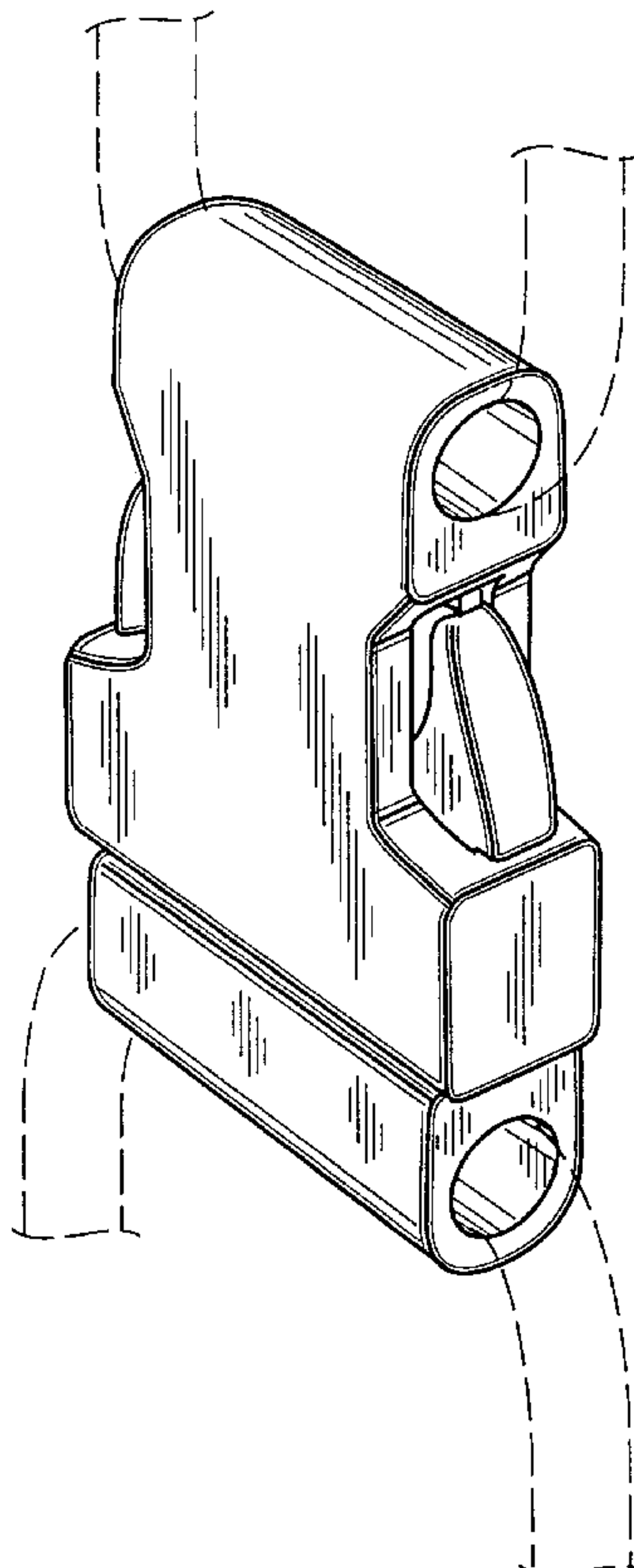

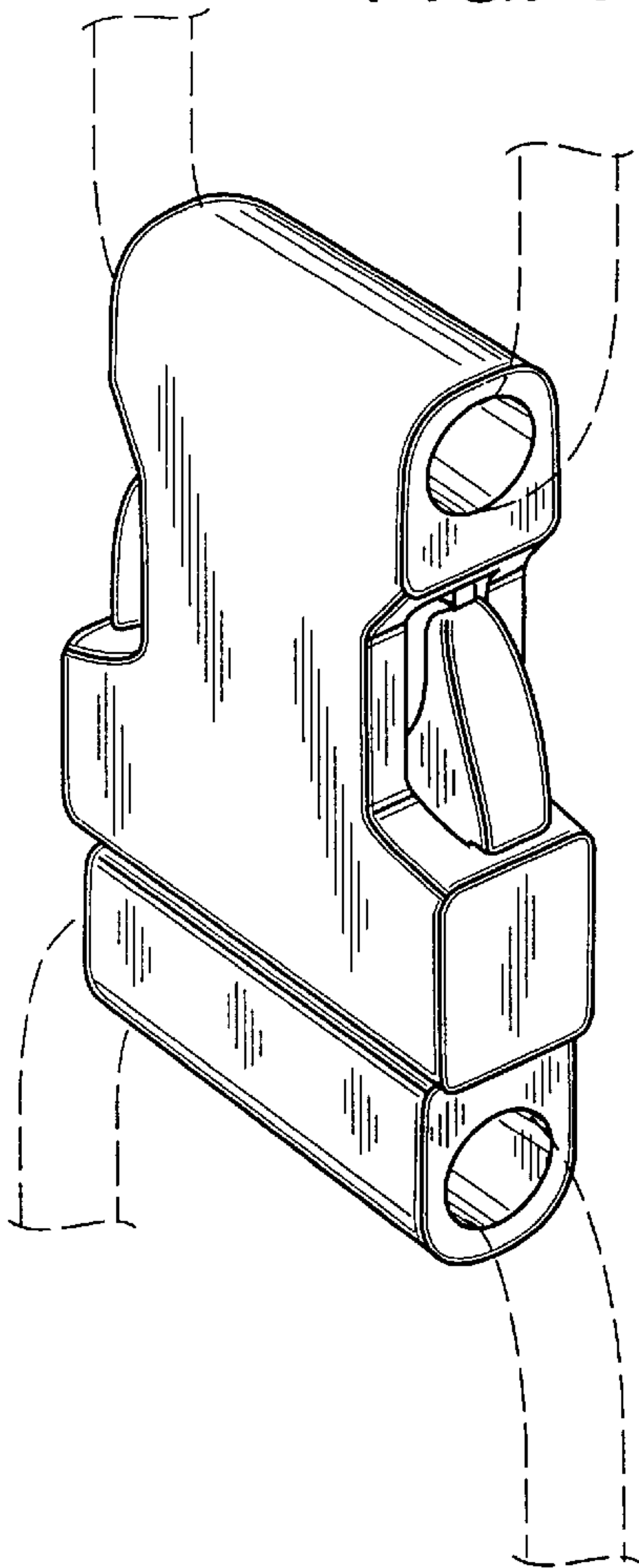

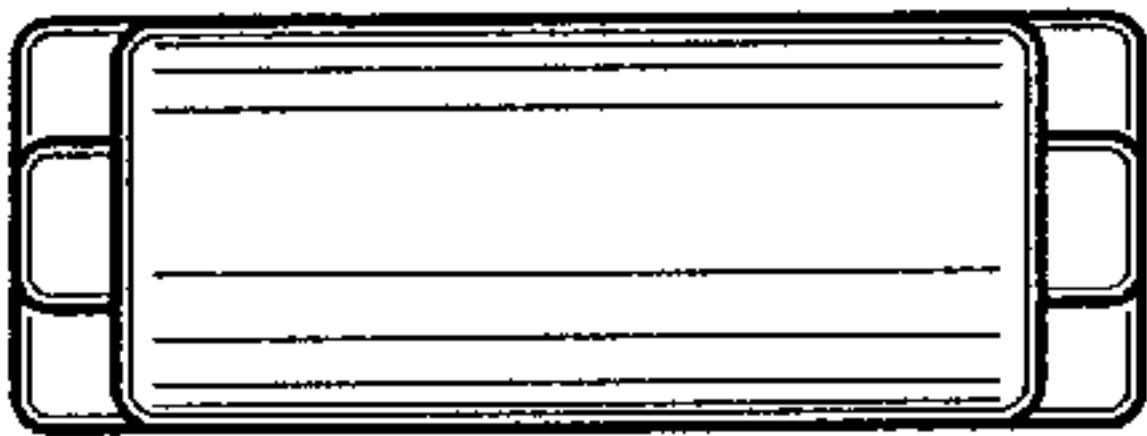

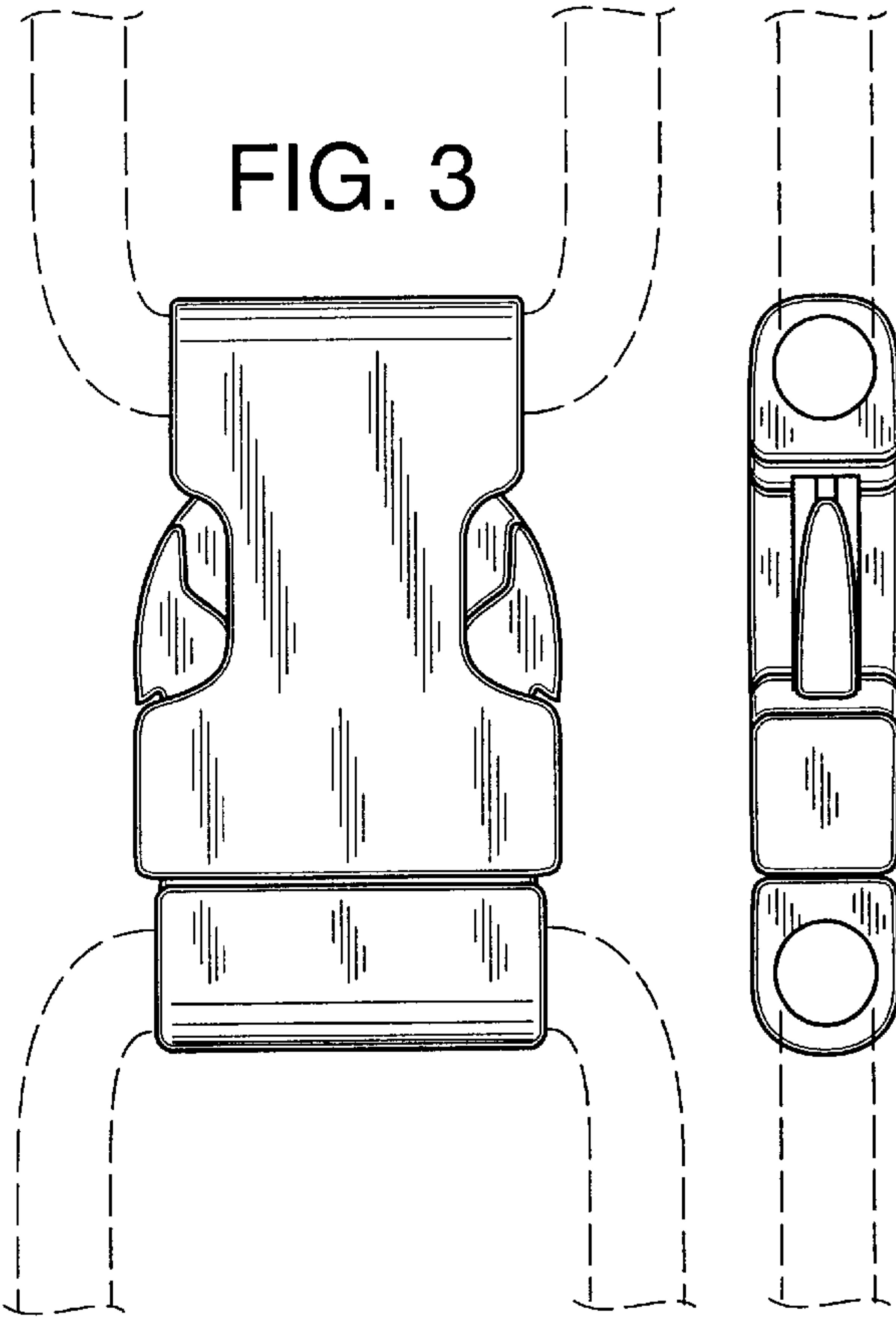

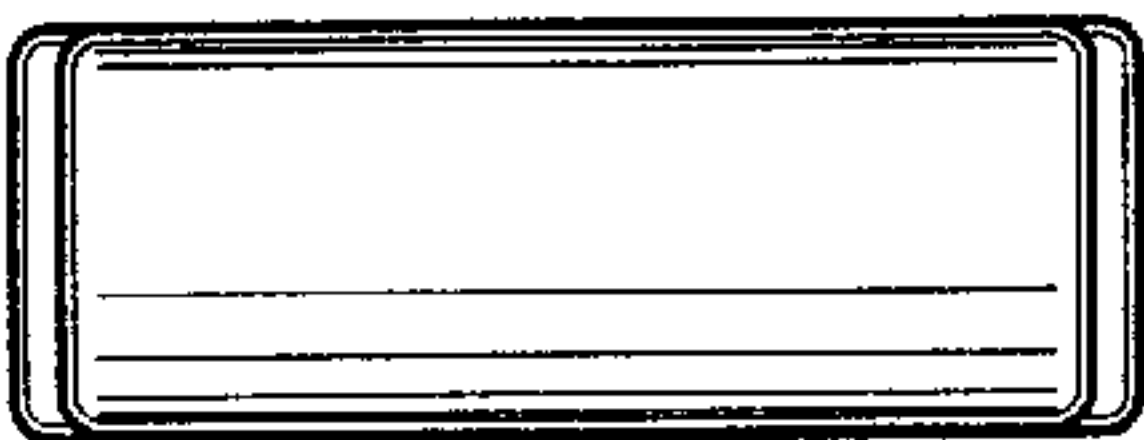

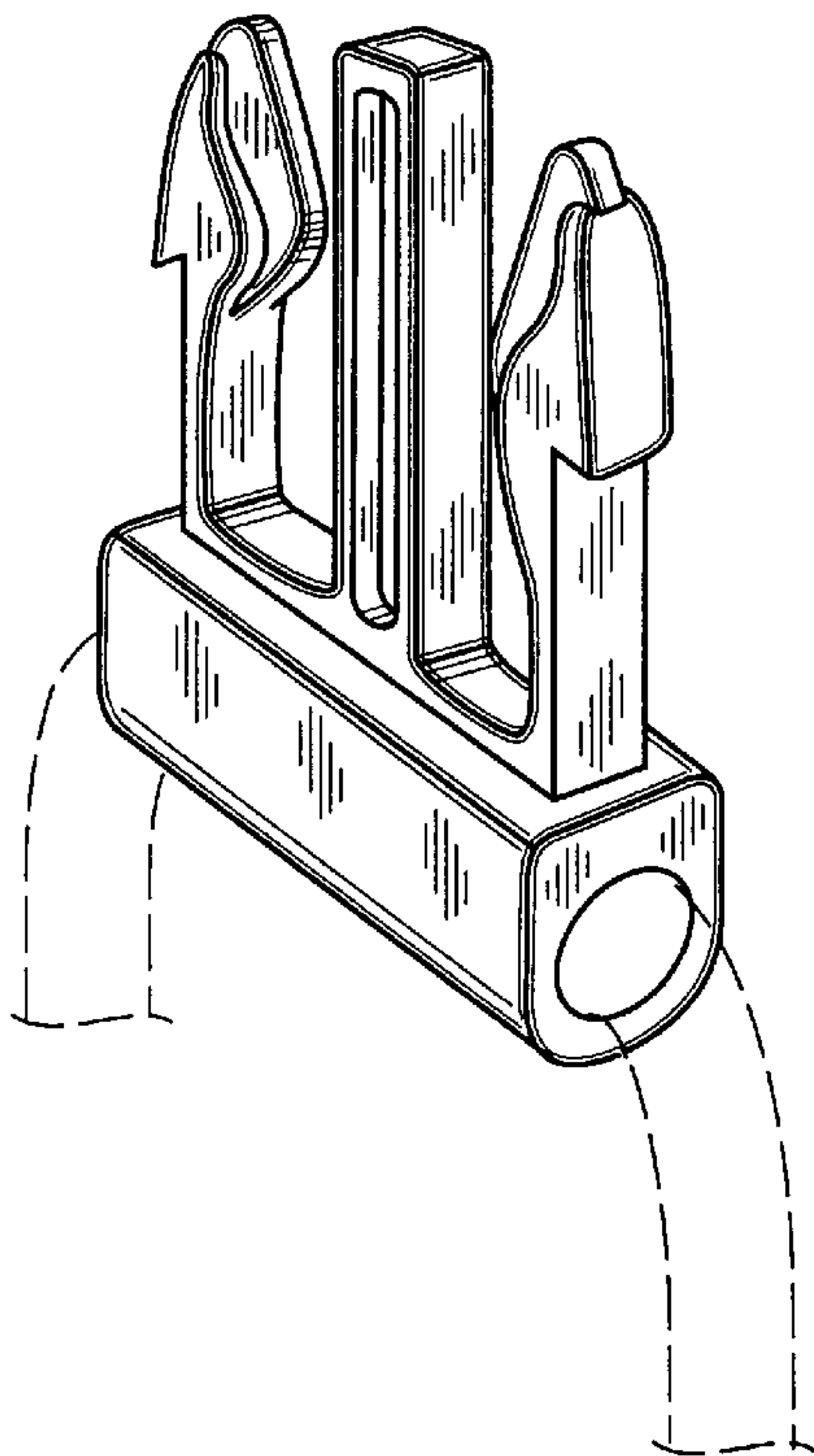

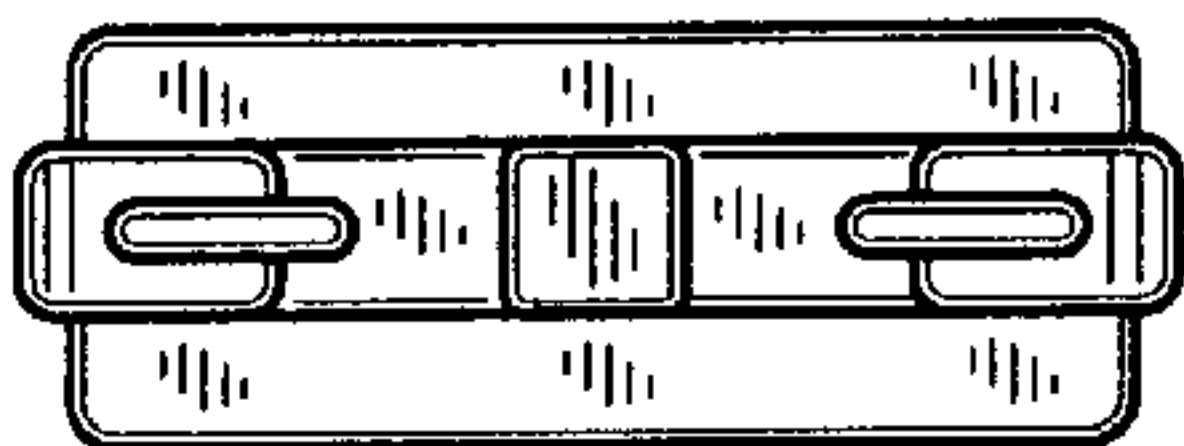

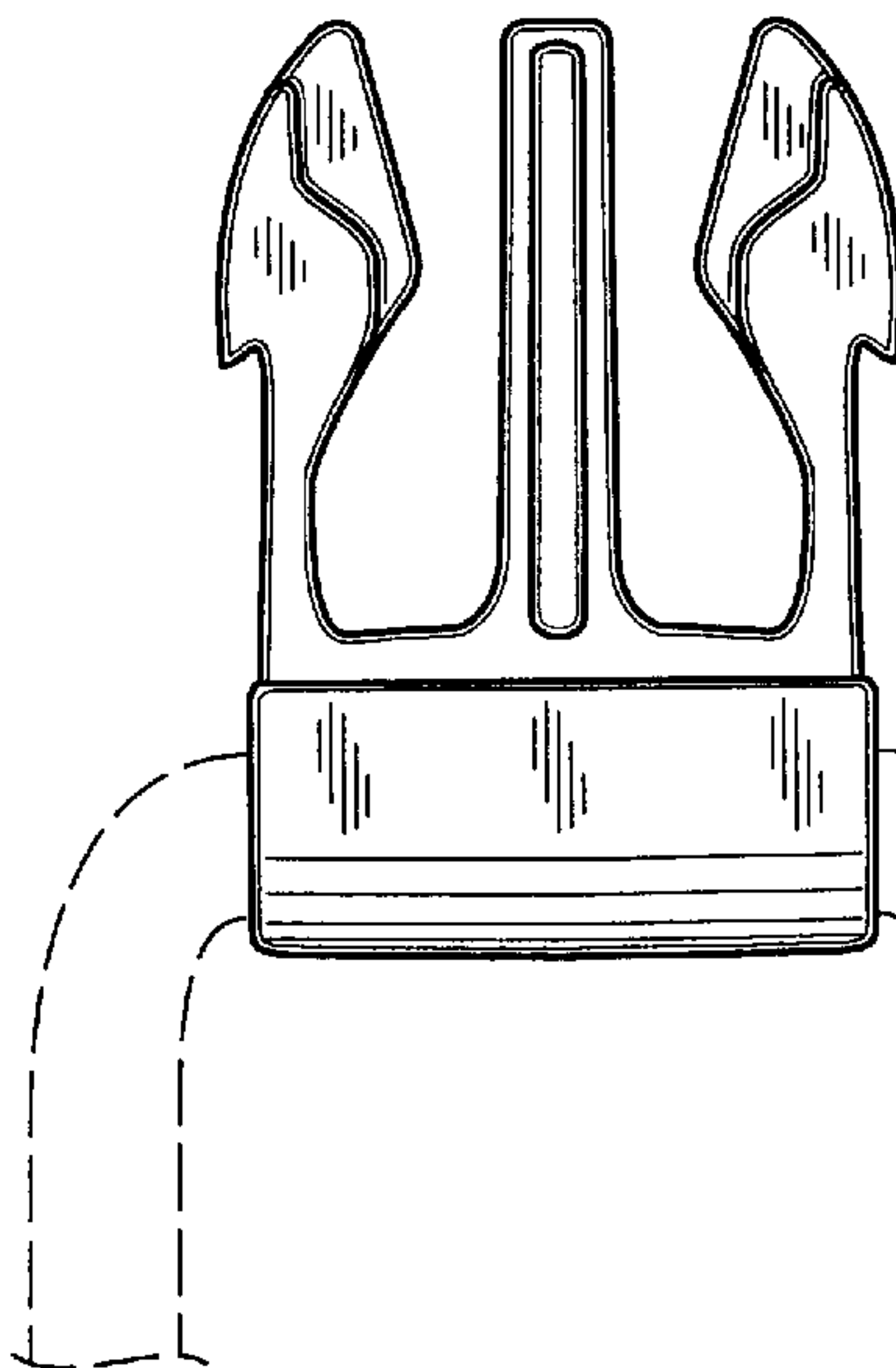

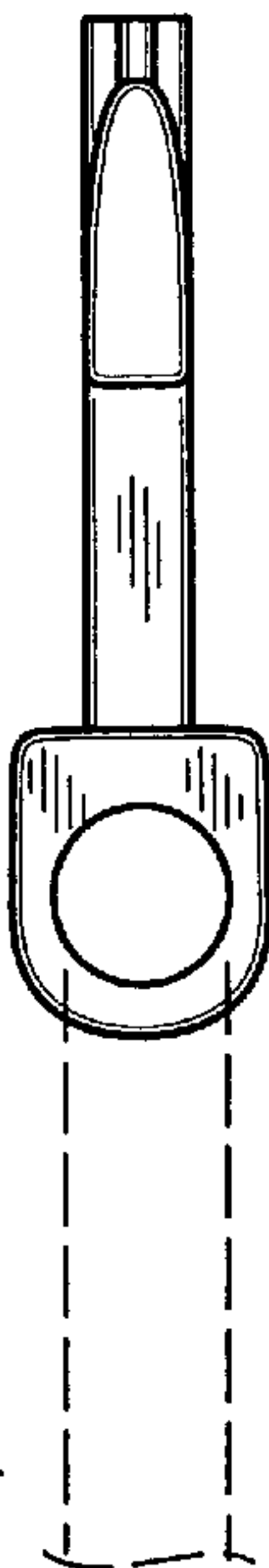

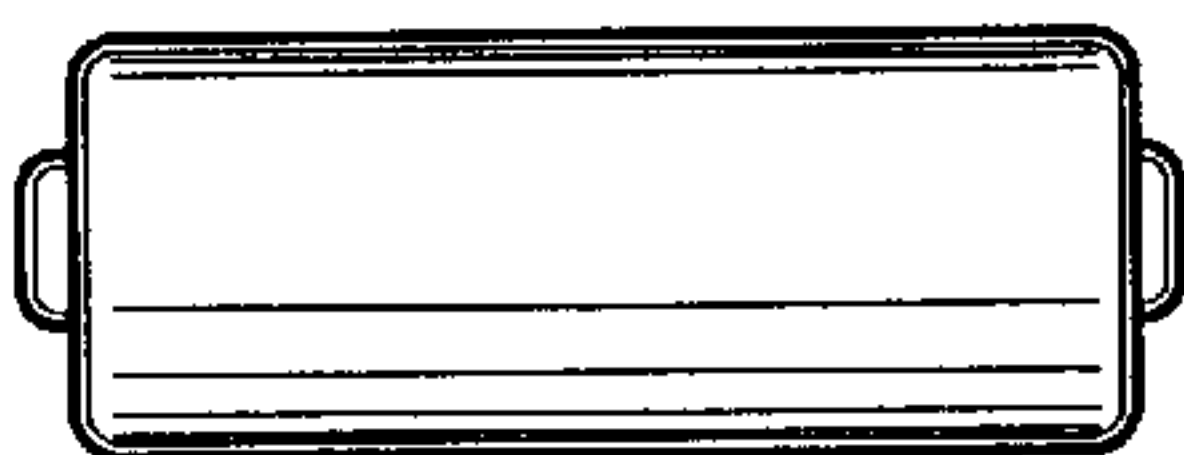

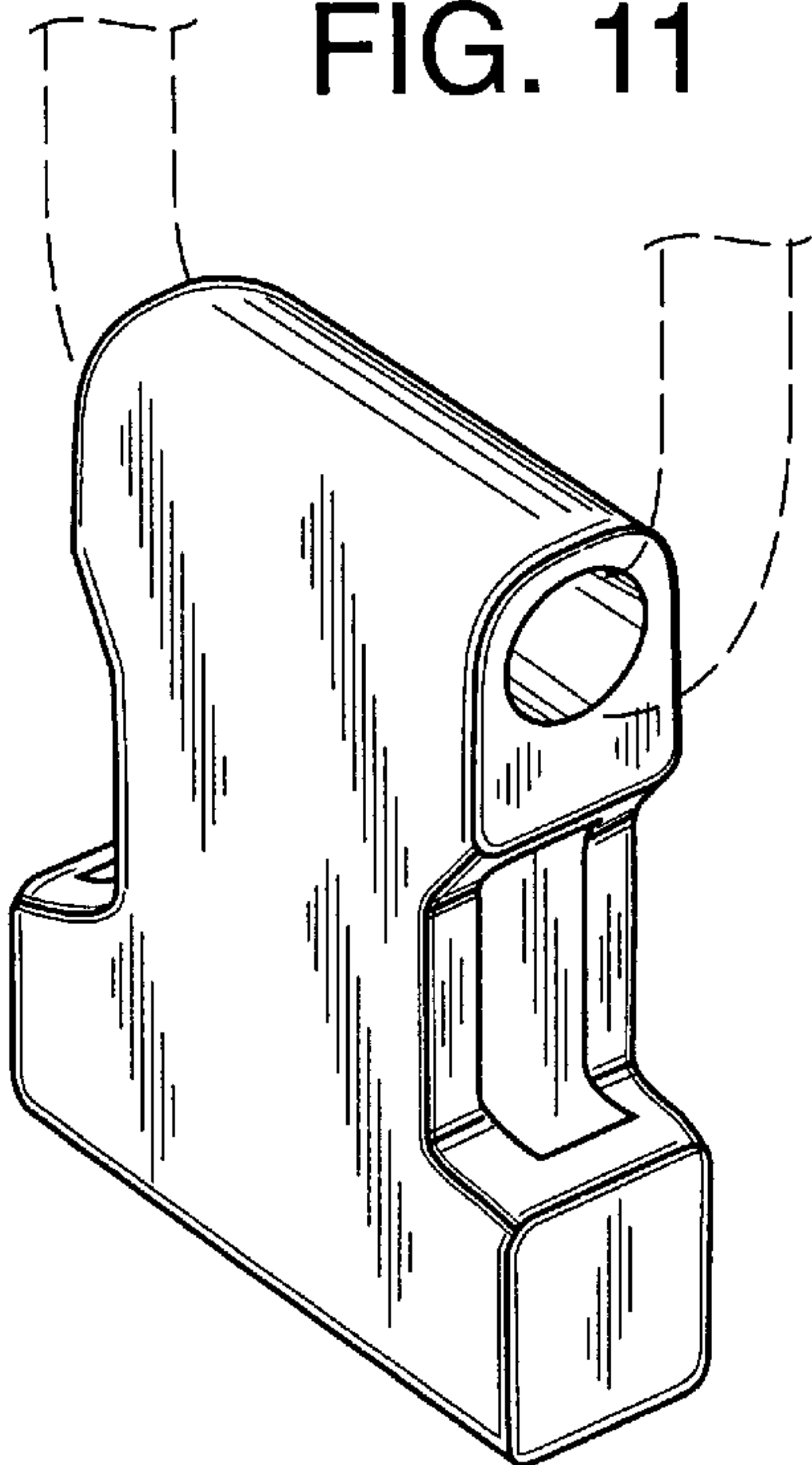

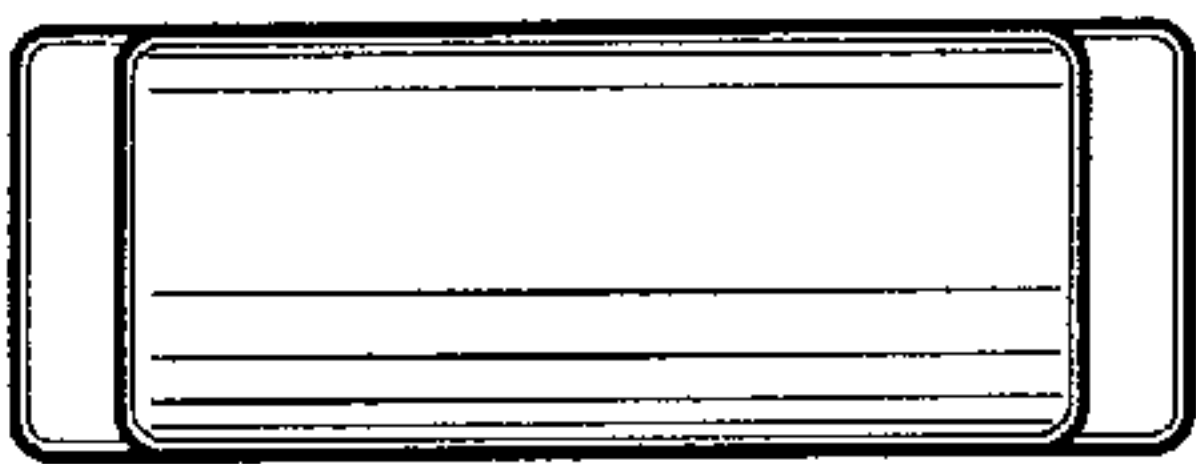

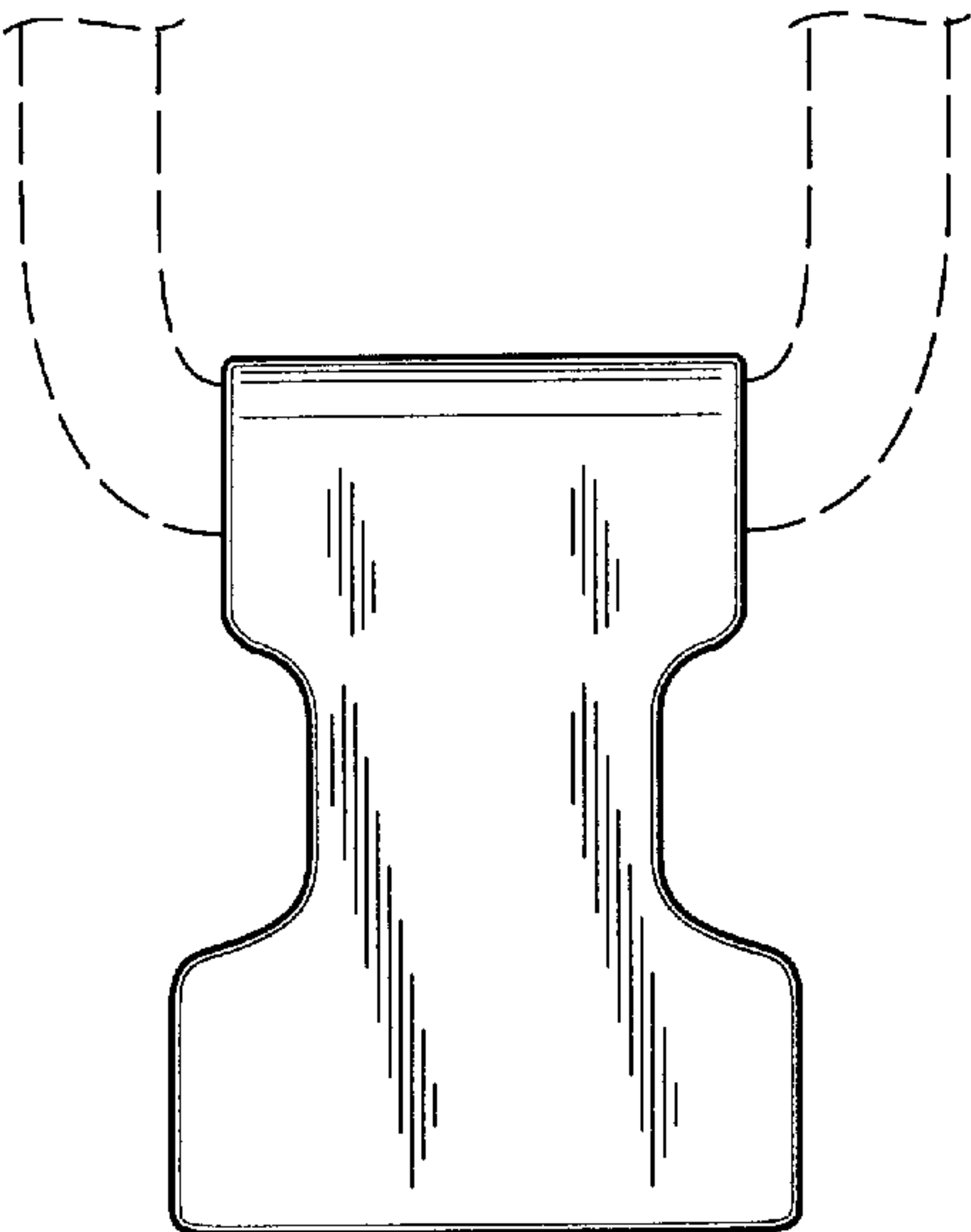

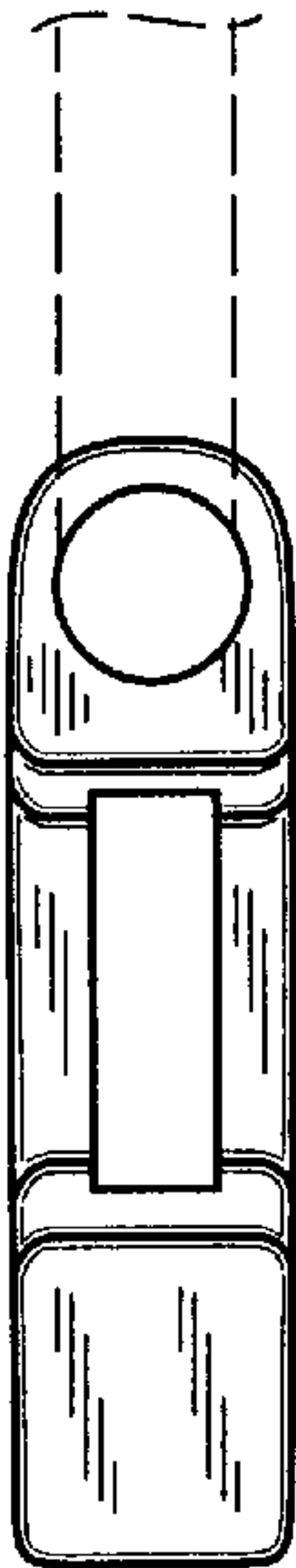
