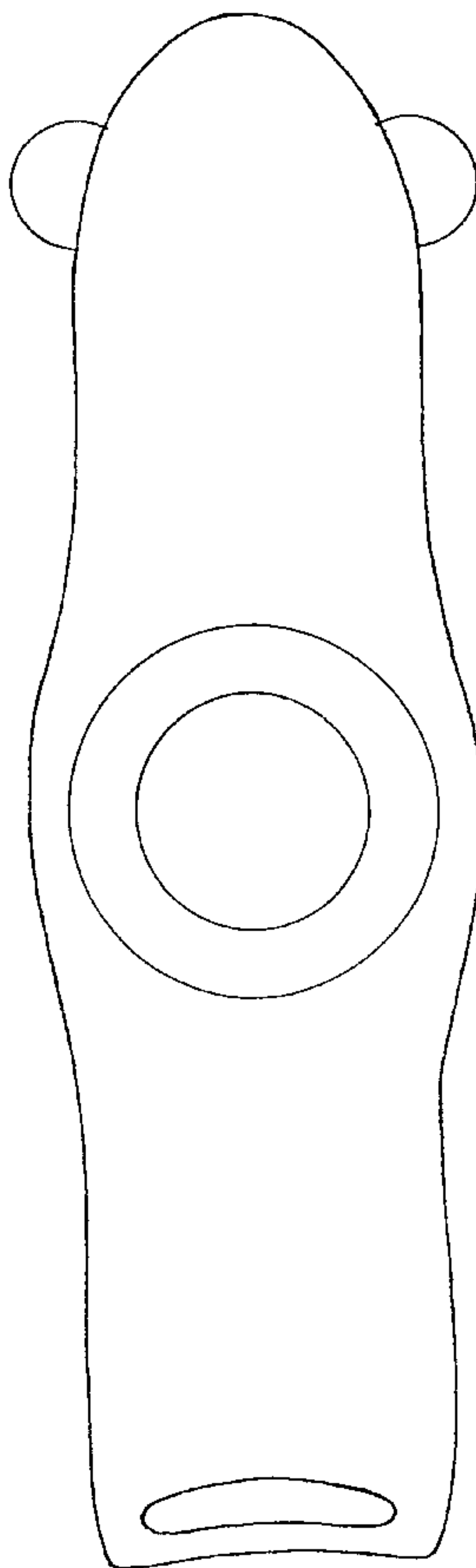

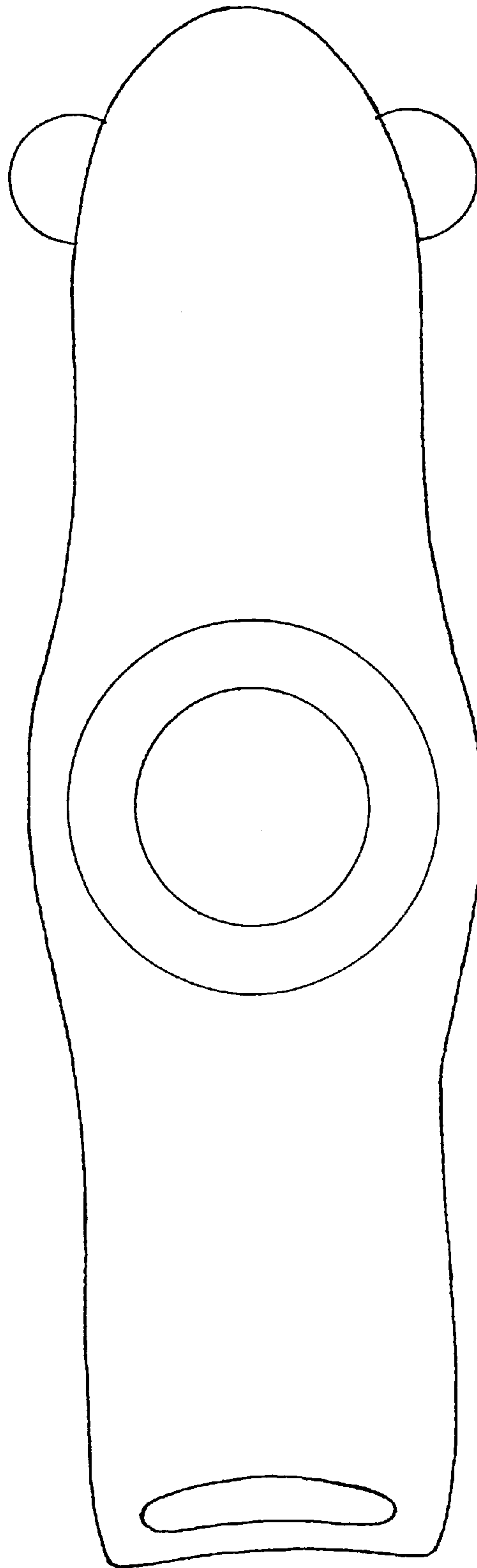
The ornamental design for a skateboard top, as shown and described.
