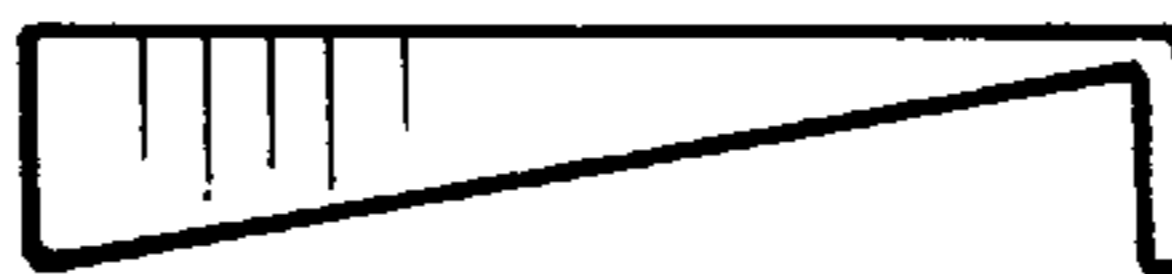
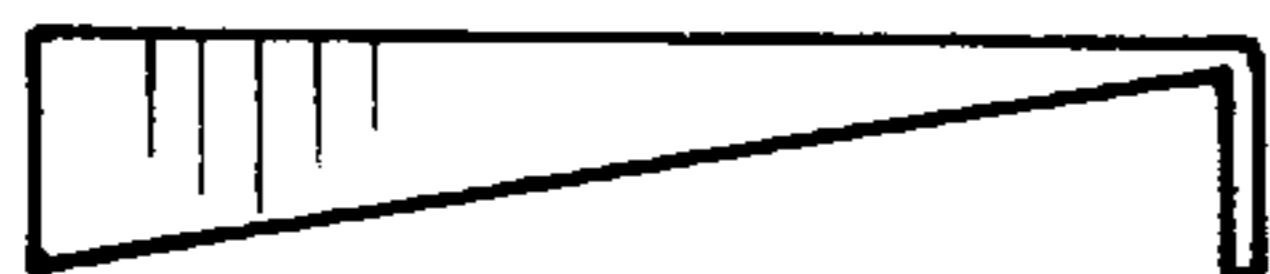
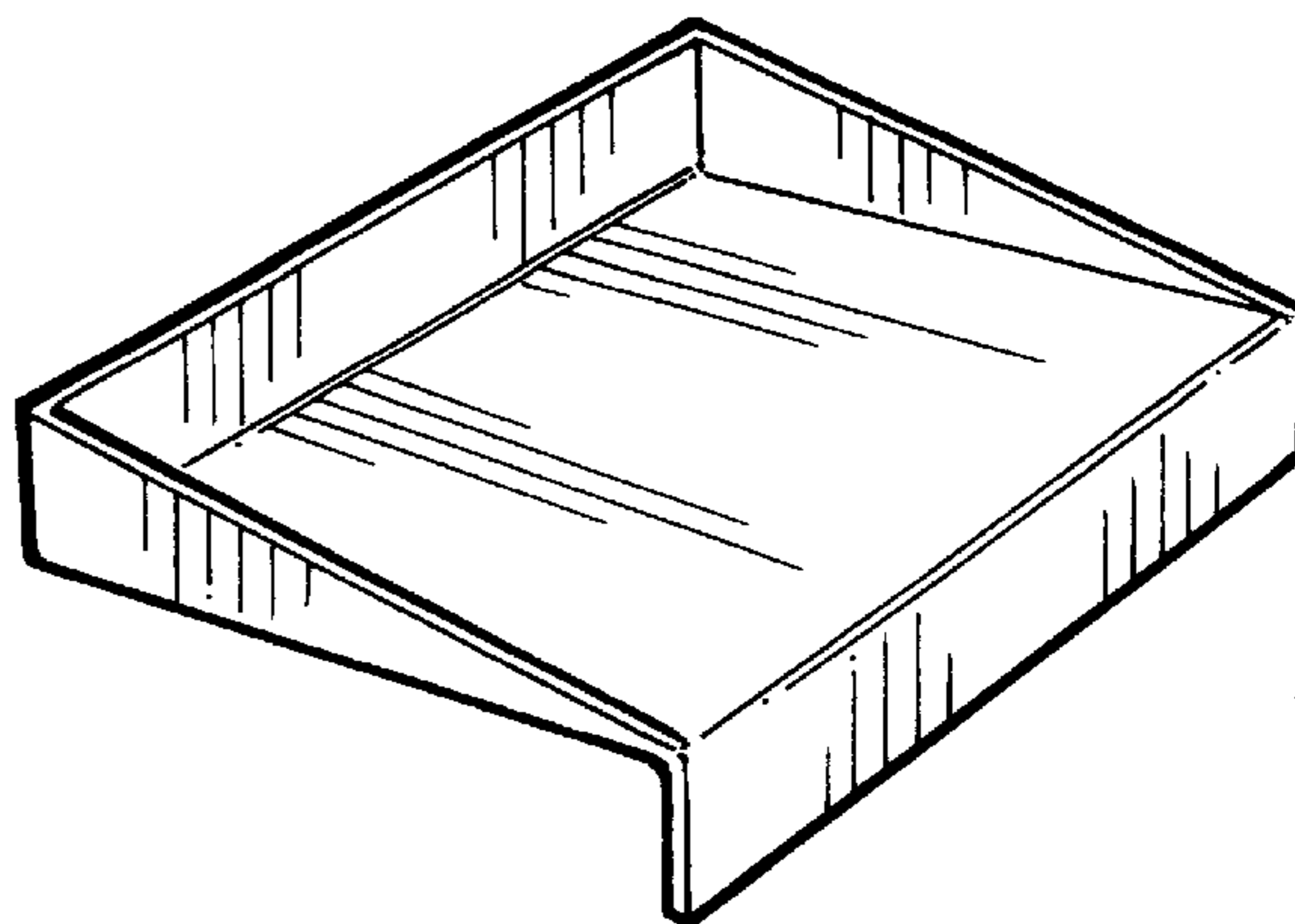
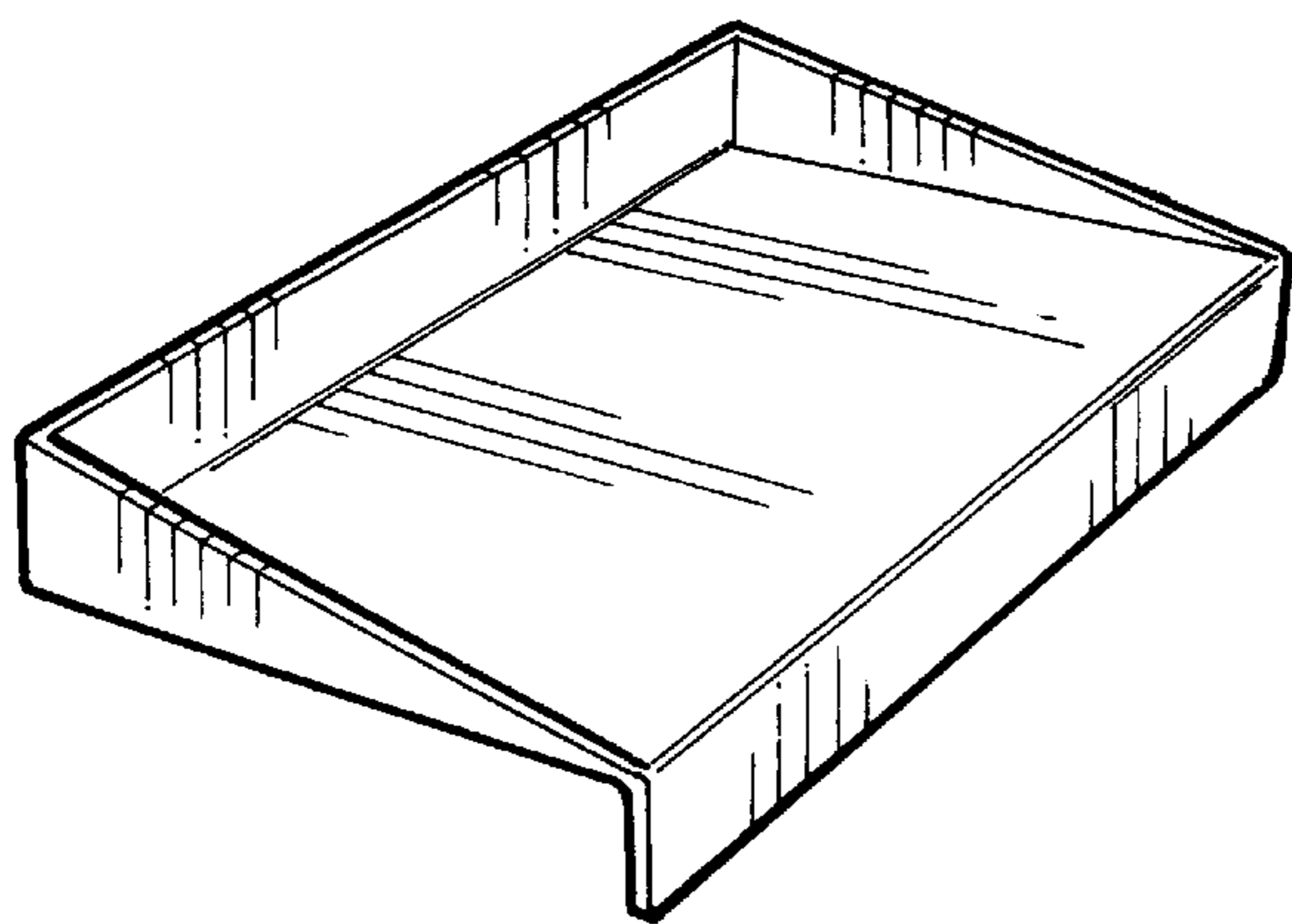
[57] CLAIM

The ornamental design for a barbecue griddle, as shown and described.

DESCRIPTION

FIG. 1 is a top and side perspective view of a barbecue griddle showing our new design;

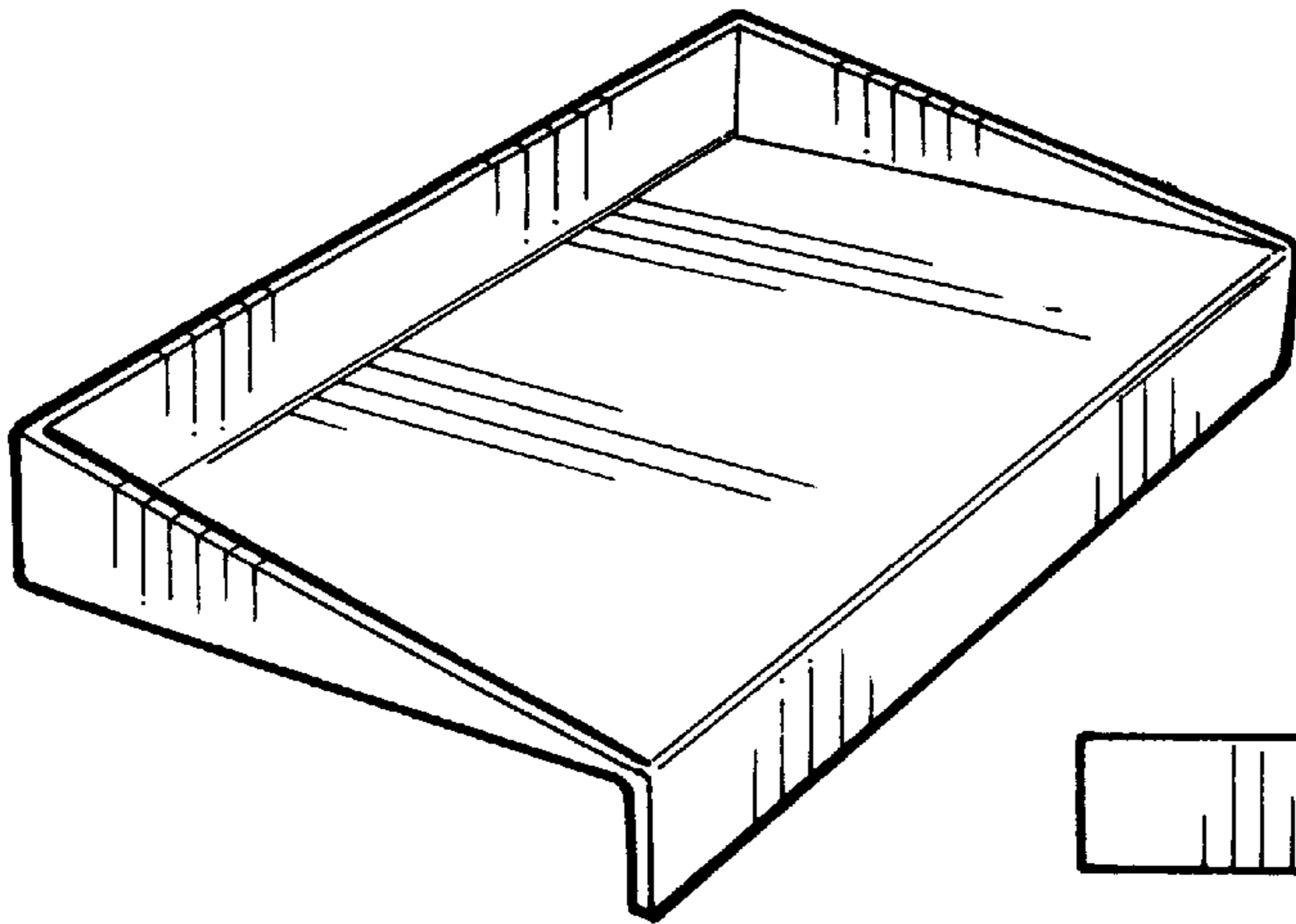

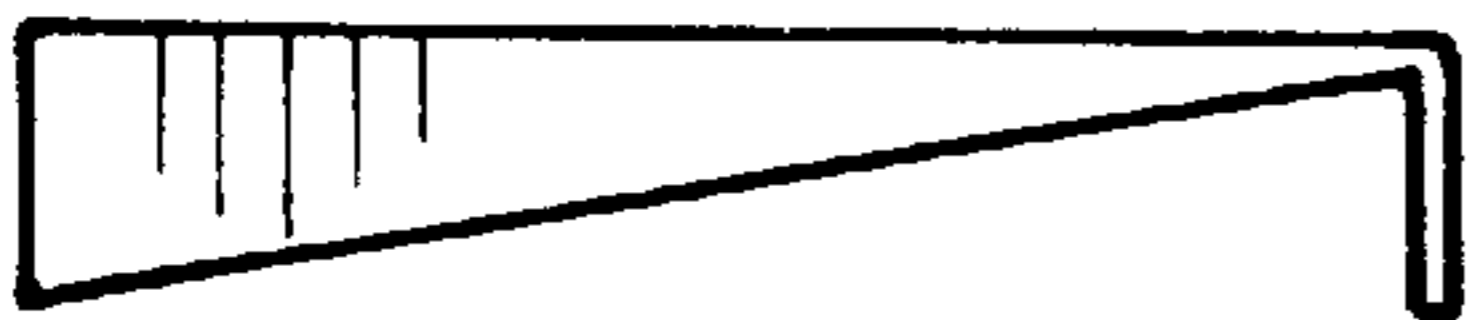

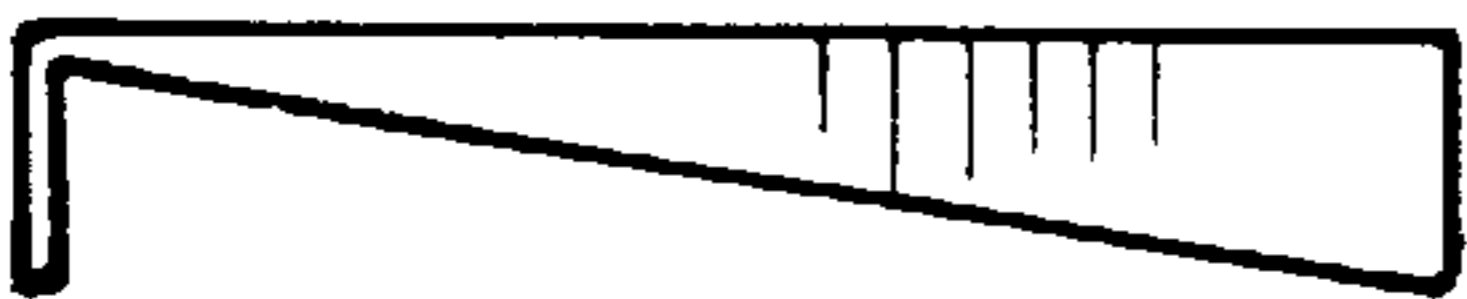

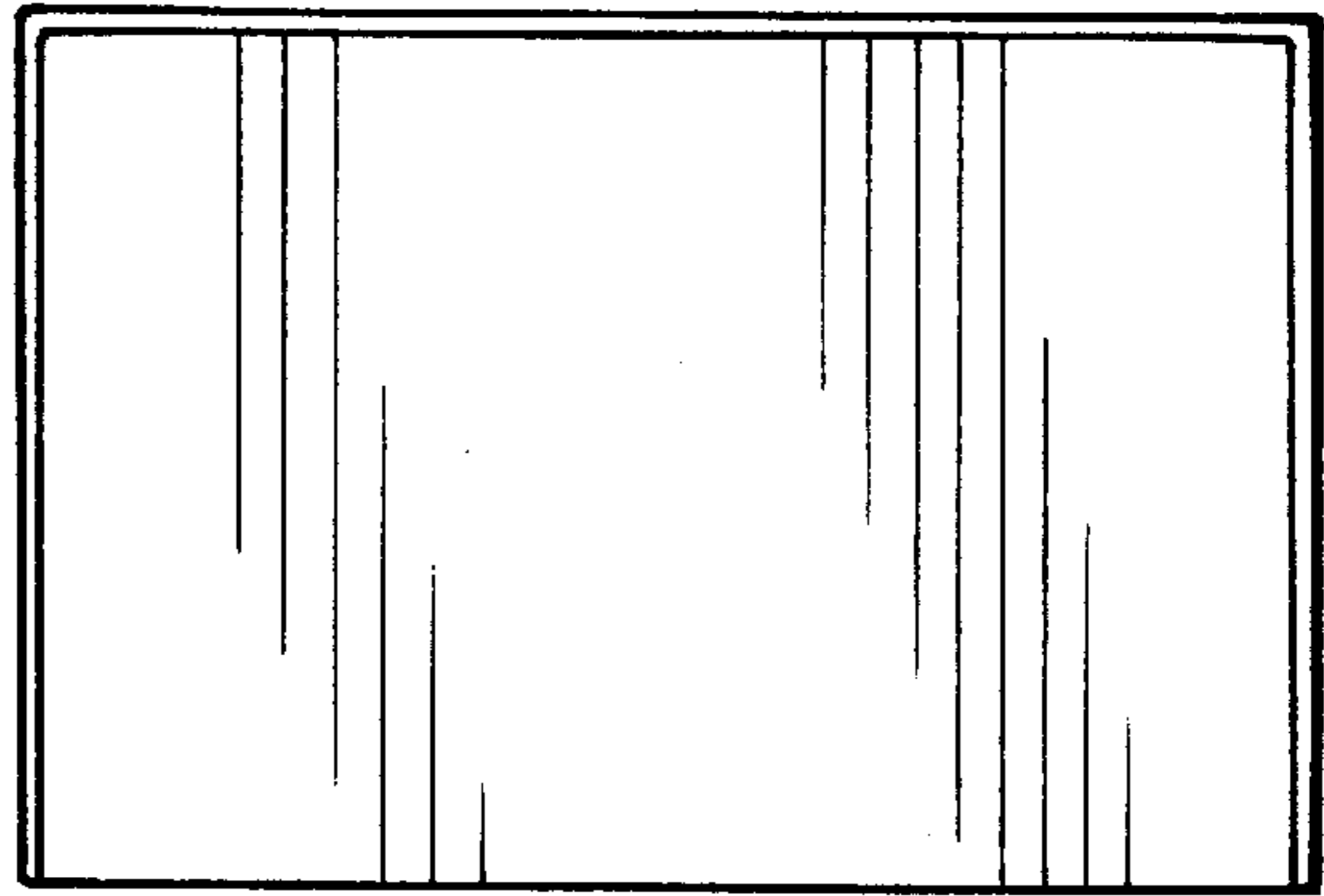

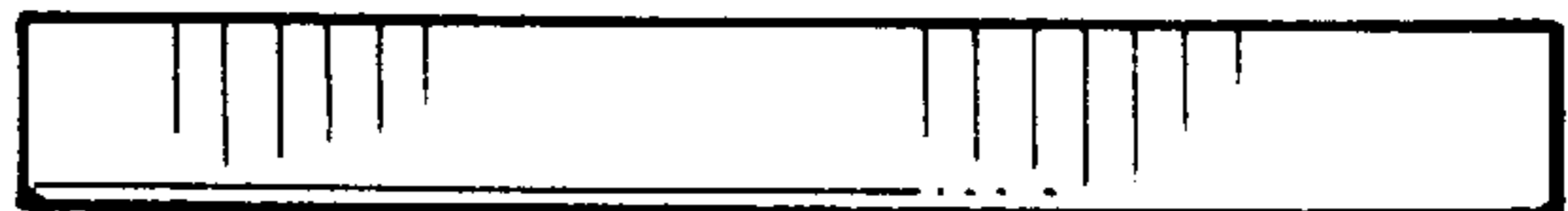

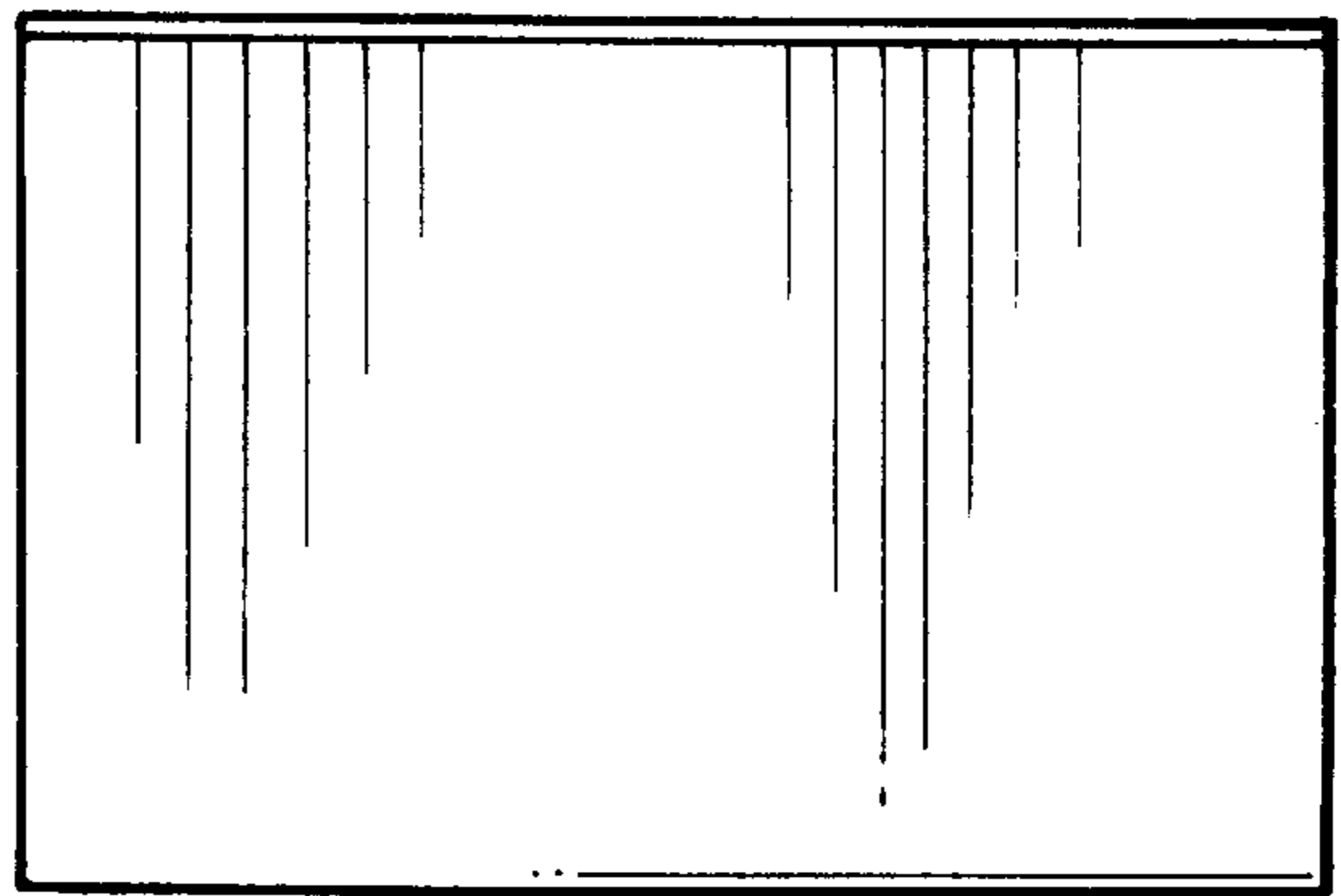

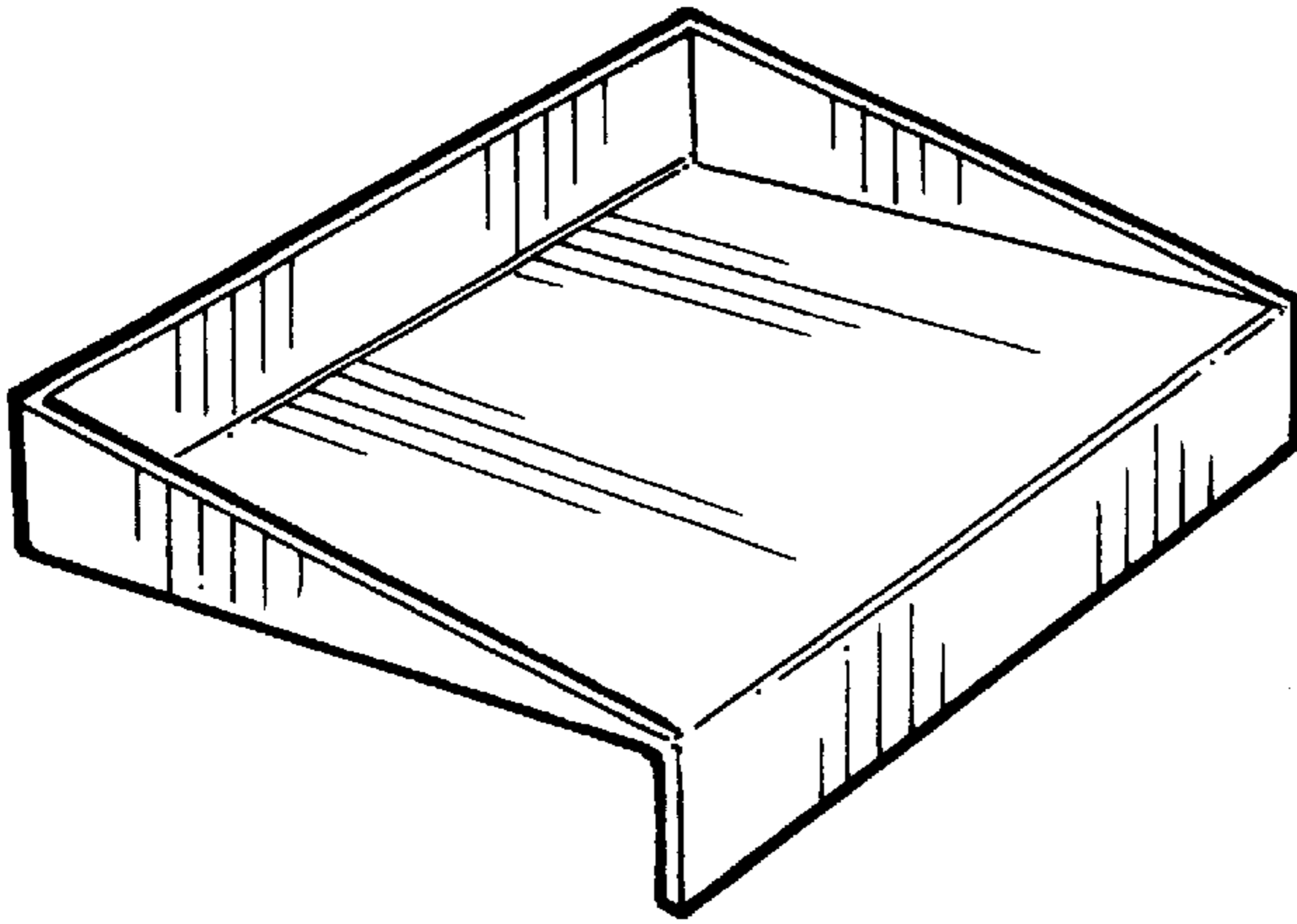

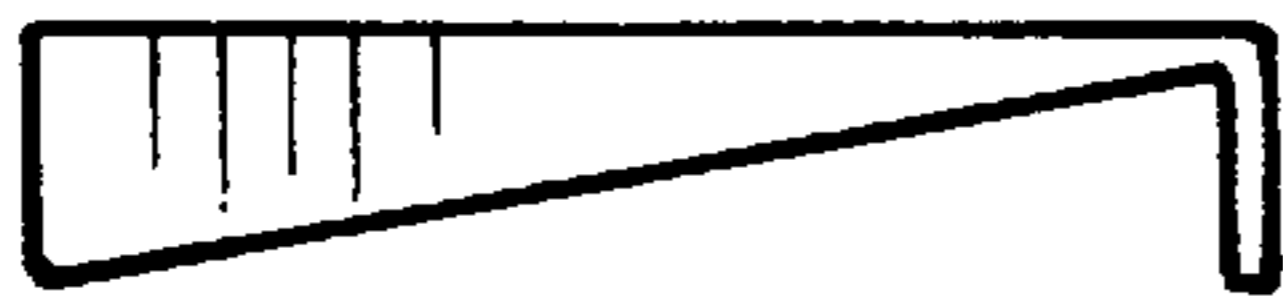

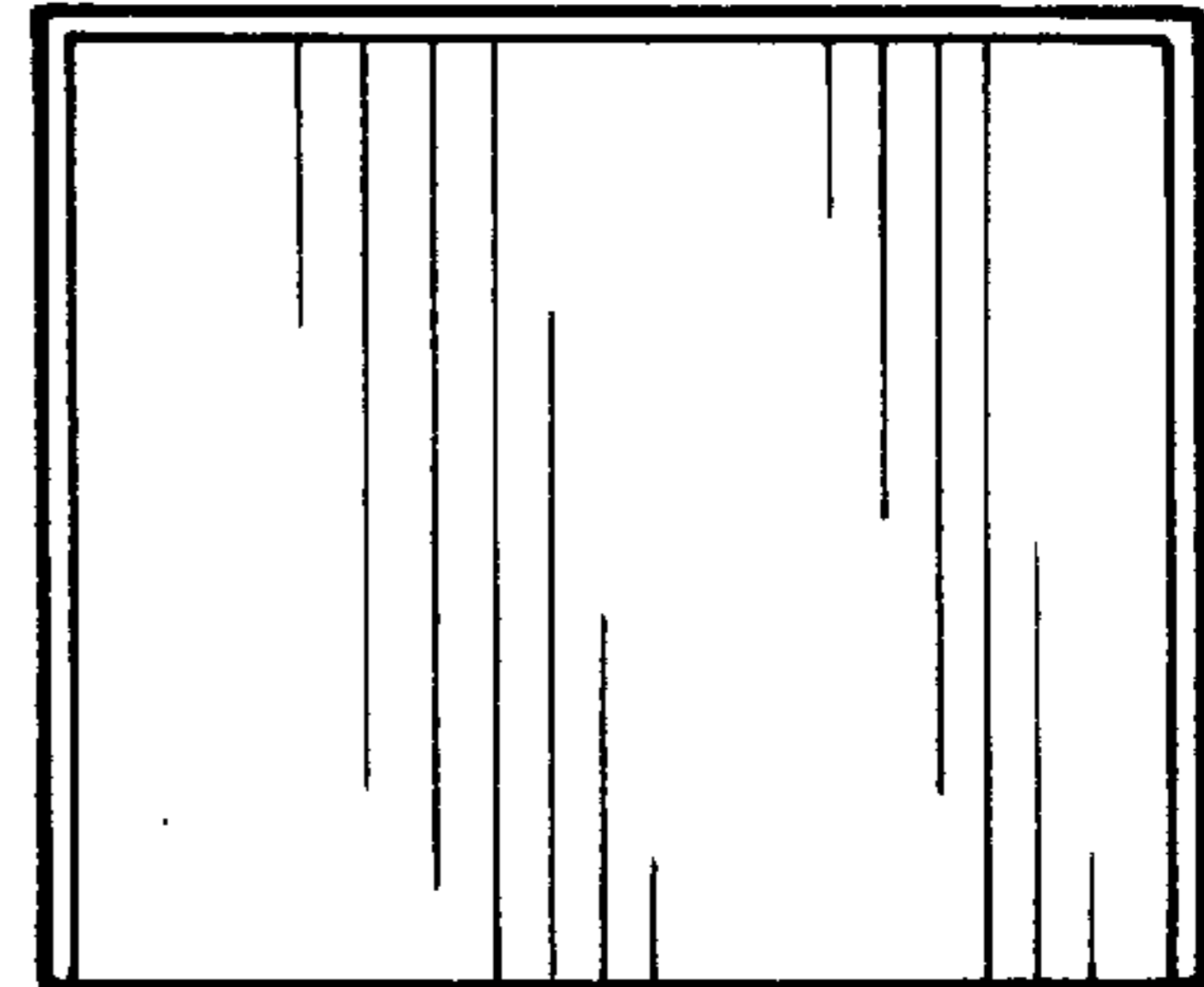

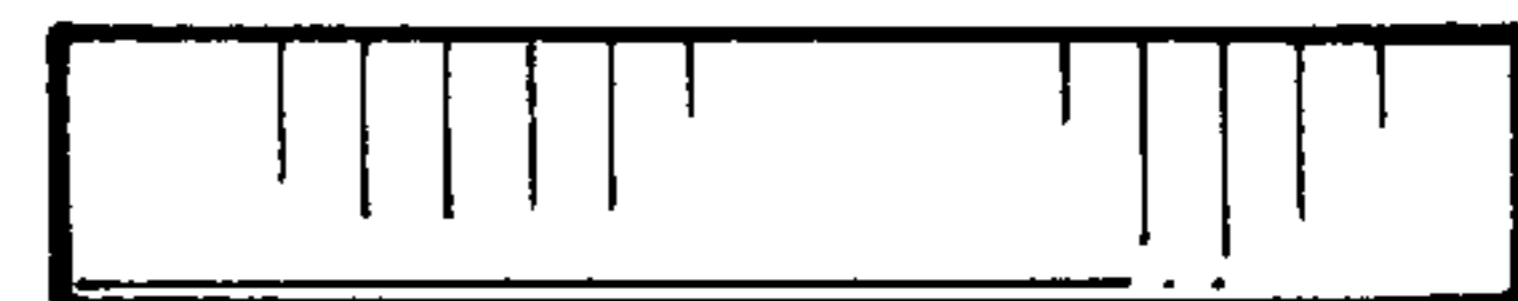

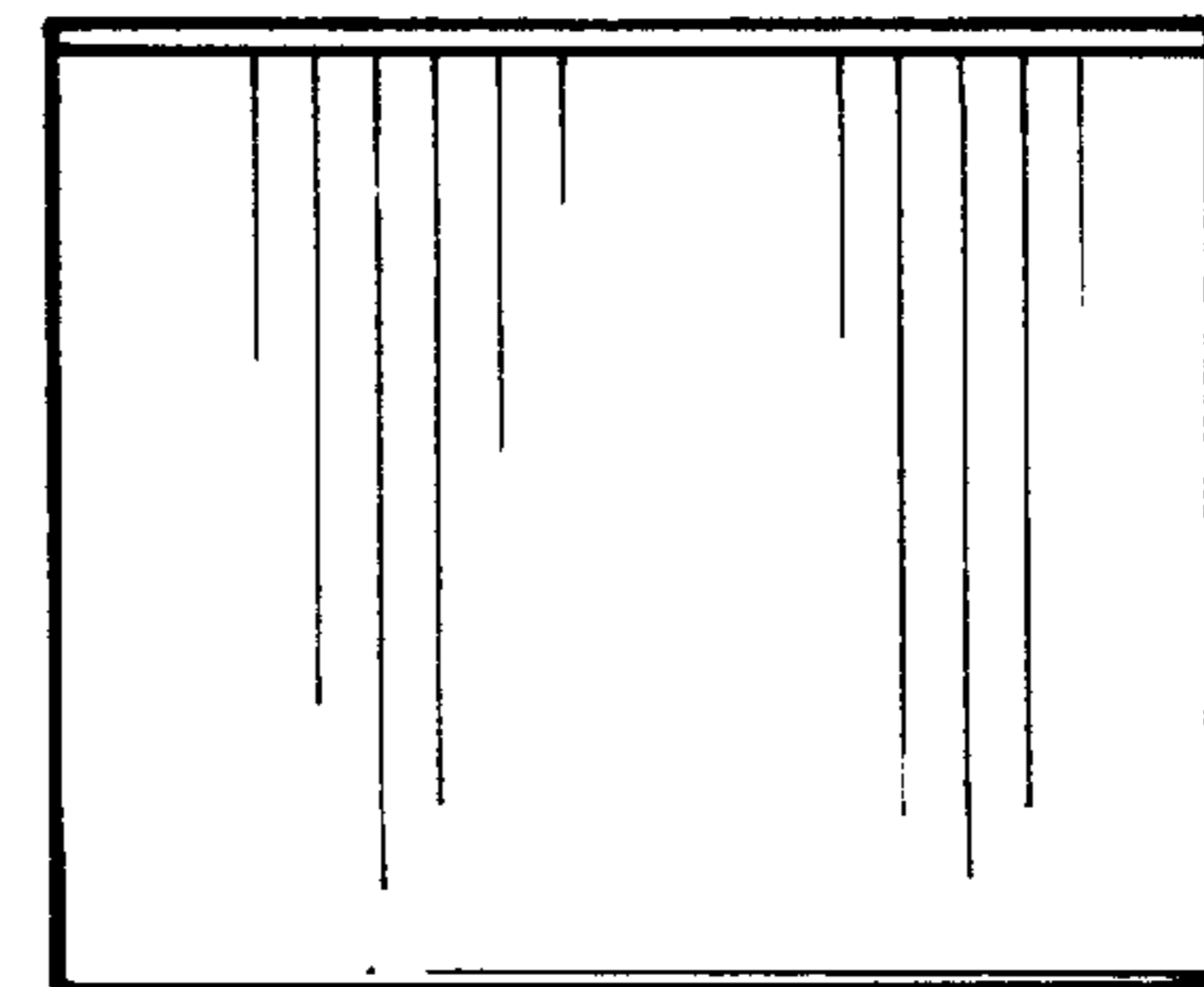
