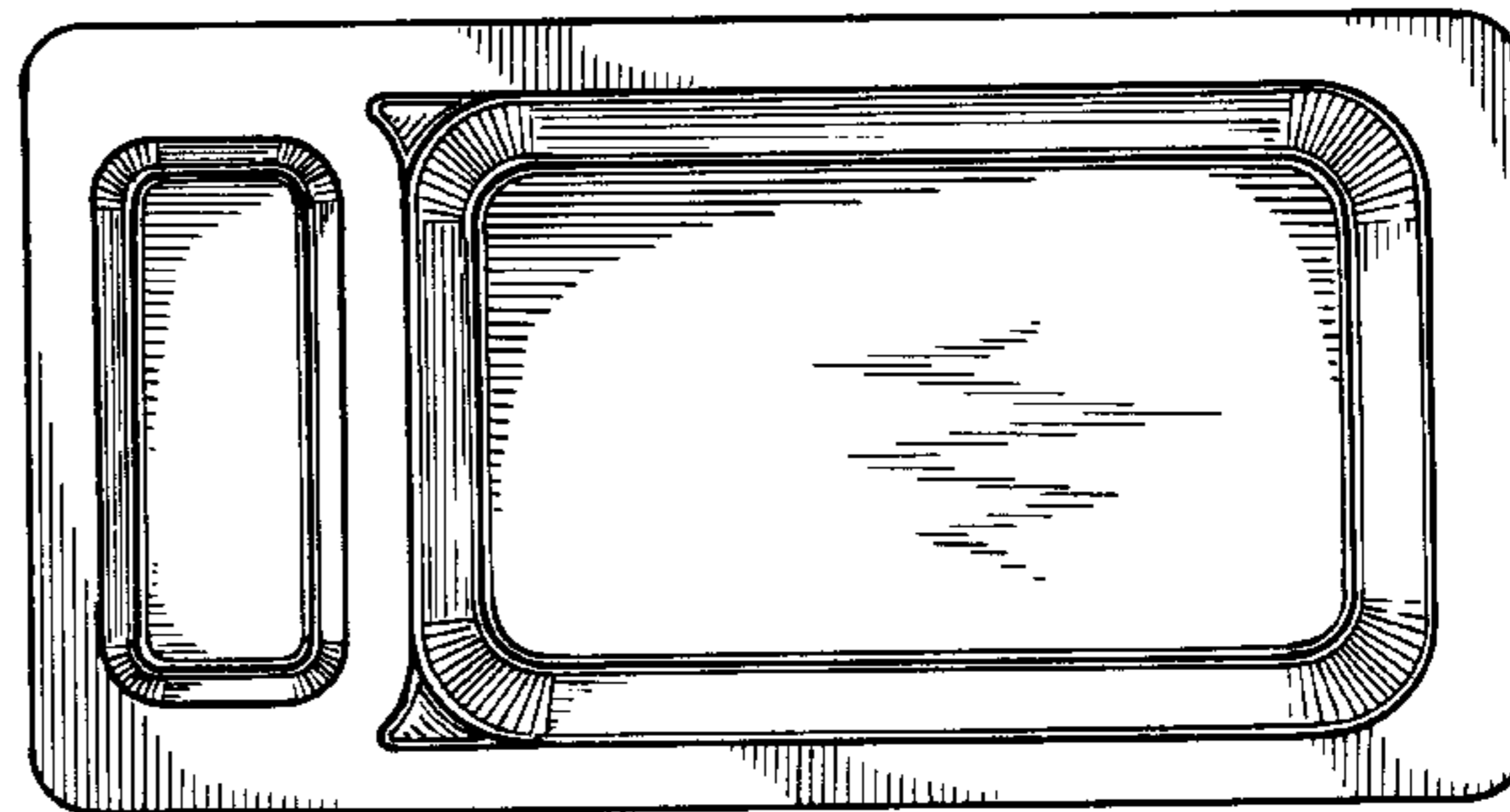
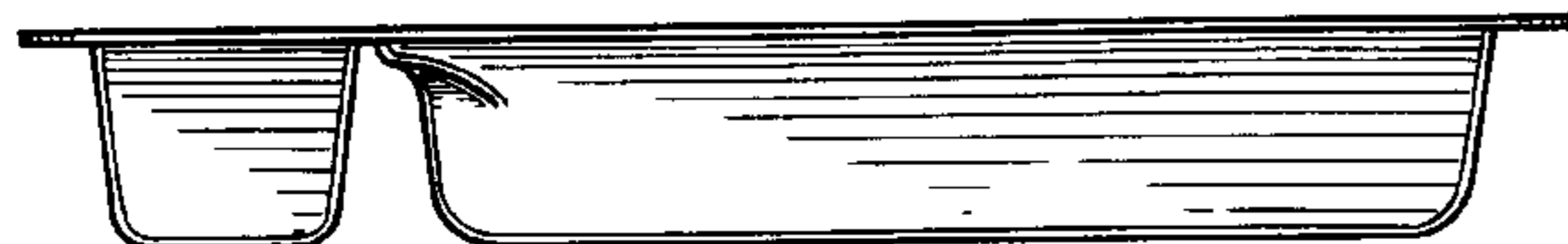
[57] **CLAIM**

The ornamental design for a two compartment tray, as shown and described.

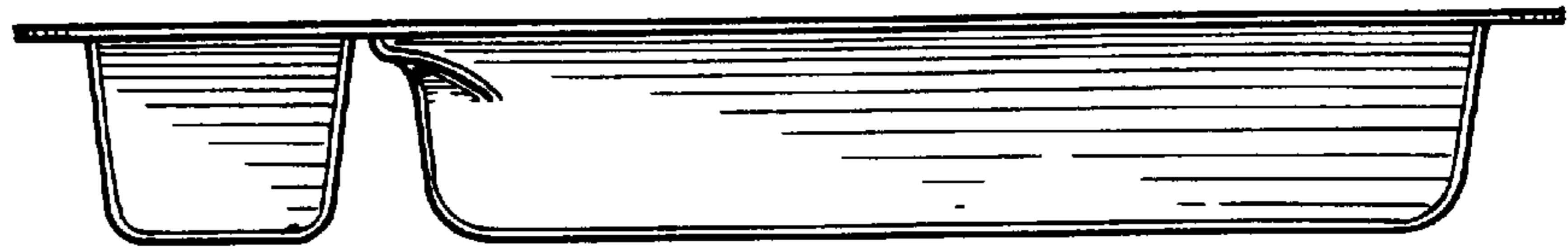
**DESCRIPTION**

FIG. 6 is a bottom view thereof.

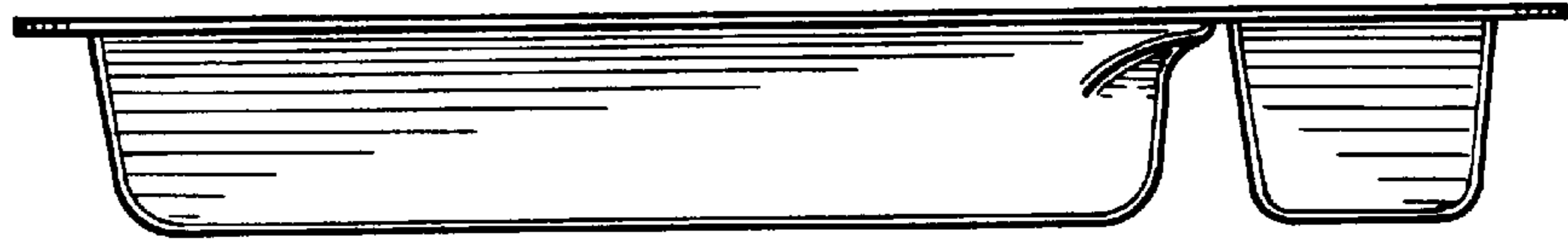

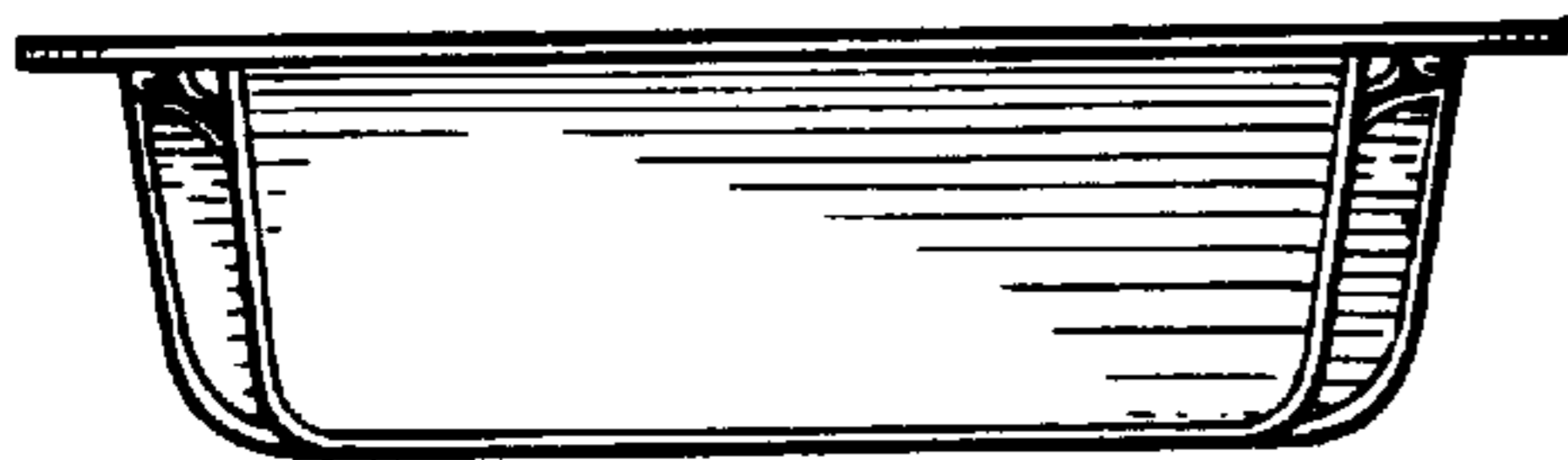

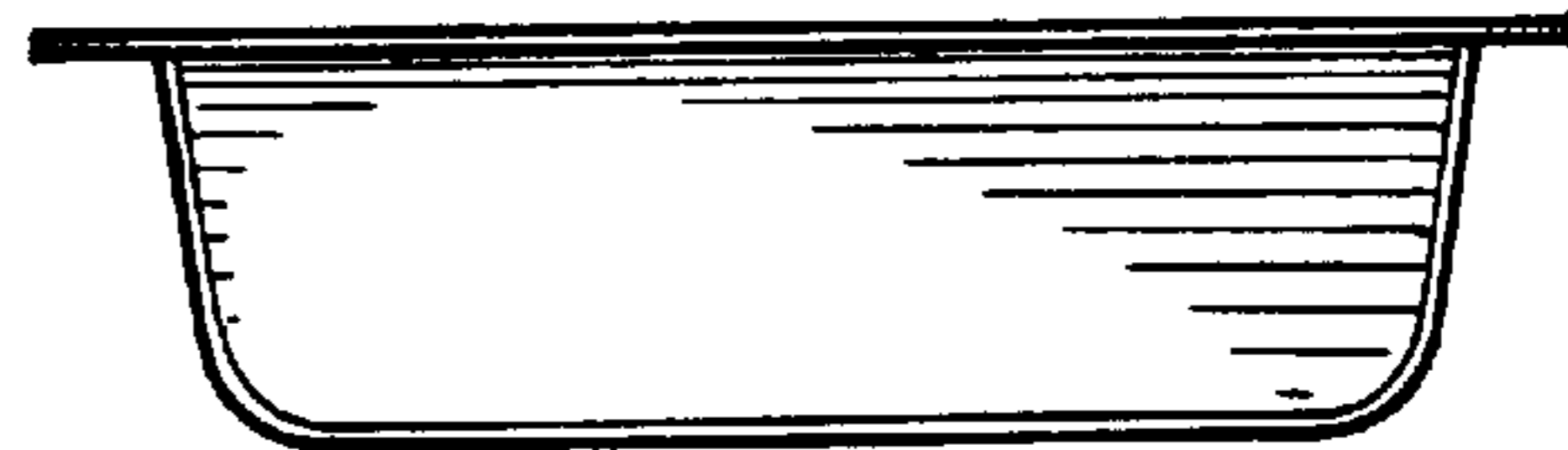

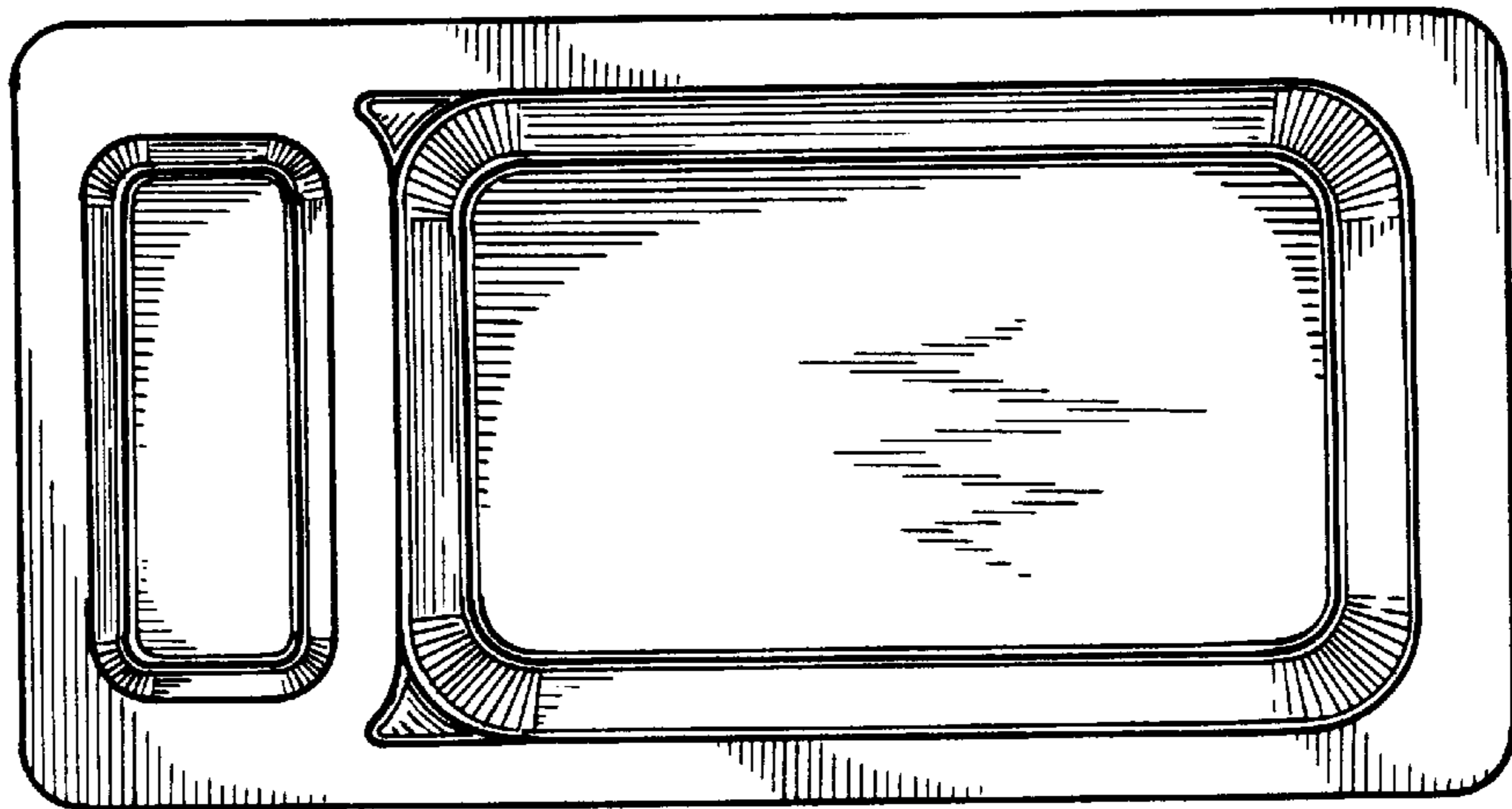
